

Siddaramaiah says he learnt of 2010 Kesare land deal only in 2013

Vatika Times MYSURU: The final report of the Lokayukta investigation into the Mysore Urban Development Authority (Muda) site allotment case has revealed that chief minister Siddaramaiah was not involved in the Kesare land transactions, and the 14 compensation sites allotted to his wife, BM Parvathi. Sources say the report, recently submitted to the Karnataka high court, states that the chief minister became aware of the disputed land only in mid-2013. Sleuths questioned over 100 officials from Muda, revenue, and land records departments, besides several politicians, but reportedly found no substantial evidence linking Siddaramaiah to the case.

During questioning, sources say Siddaramaiah said he was unaware that his brother-in-law, BM Mallikarjuna Swamy, had purchased de-notified land in 2005 or the subsequent transfer of three acres and 16 guntas to his wife in 2010. He said that he learnt about it only after the 2013 assembly elections and, as an elected representative, had declared it in his 2014 assets and liabilities report to the Lokayukta as per rules.

During an interrogation in early Nov, Siddaramaiah reportedly answered over two dozen queries. When asked about his election affidavit, he said, "I don't exactly remember the declaration of land and sites."Denying any influence Ashwini Upadhyay, now transactions, the Siddaramaiah said he had no acquaintance with Kesare landowner Devaraju .

In Supreme Court, govt. opposes life ban on convicted netas

NEW DELHI: Opposing the plea that the six-year disqualification for convicted persons from contesting polls be turned into a lifelong ban, Centre has told Supreme Court that the present law was constitutionally sound and it should be left to Parliament to decide on amending the law and the judiciary should refrain from passing direction.

In an affidavit filed in SC, the Centre argued that there was nothing wrong in time-bound imposing penalty as other grounds of disqualification - such as holding an office of profit, unsoundness of mind, insolvency and not being a citizen of India - were not permanent but time-bound and disqualification was tied to the existence of a supervening circumstance. According to Section 8 of Representation of the People Act, the period of disqualification kicks in six years from the date of conviction or in case of imprisonment, six years from the date of release.Challenging the provision, advocate with BJP, filed a petition seeking SC's direction to do away with time-bound penalty and bar a convicted



person for life from contesting MP/MLA election, forming political party or becoming office-bearer of a political party. Disputing the contention, the Centre said, "Disqualifications made under the impugned sections are limited by time as a matter of parliamentary policy and it would not be appropriate to substitute the petitioner's understanding of the issue and impose a lifetime ban. As a matter of judicial review, the court can declare the provisions to be unconstitutional and declare them to be inoperative, however, the relief that he is seeking amounts to rewriting of the provision as it effectively seeks to read 'lifelong' instead of 'six years' in all sub-sections of Section 8 of the Act.' lifetime ban would be appropriate or not was a question that was solely within the domain of Parliament. "Numerous laws provide for penalties limited by time, in the same manner as in the impugned Act. It is submitted that this is in line with well-established principles governing penal law. By confining the operation of the penalty to an appropriate length of time, deterrence is ensured while undue harshness is avoided," the affidavit said. "The issues raised by the petitioner have wide-ranging ramifications and clearly fall within the legislative policy of Parliament and the contours of judicial review would be suitably altered in such regard. SC has held that legislative choice over one option or the other cannot be questioned in courts over its efficacy or otherwise," it

Cabinet clears decks for tabling of Waqf bill

NEW DELHI: Cabinet has approved the proposed amendments to the Waqf (Amendment) Bill incorporating changes recently recommended by the Parliamentary panel, paving the way for it to be tabled for discussion and passage in the second half of the budget session. govt has incorporated most of the changes recommended the Joint **Parliamentary**

Committee (JPC) headed by Jagdambika Pal and the Cabinet cleared it last week along with the Indian Port Bill. The bill has been put in the priority list by the govt as part of its legislative business.The bill was referred to the JPC in August 2024 after it was introduced in the Lok Sabha by minority affairs minister Kiren Rijiju.The parliamentary panel adopted the report with majority vote while all 11 MPs from opposition parties in the panel

had objected to the report. They had also moved dissent notes.The 655-page report was submitted to both the Houses of Parliament earlier this month. The panel while doing away with the "Waqf by User" provision,

going forward, has allowed only existing "Registered Waqf by User" to be recognised as waqf.This will exclude the cases where the properties are under dispute or owned by the govt.

DOGE plans to replace of Education contract workers with AI chatbots

Trump DoE to replace President Trump's broadhuman workers with AI: The Department of Government Efficiency (DOGE), spearheaded by Elon Musk, is reportedly considering replacing contract workers in the Department of Education with AI chatbots.

Internal department documents reveal that Musk's allies within the Education Department are exploring the use of generative AI to manage student and parent inquiries, according to a

New York Times report. This initiative aligns with er efforts to shrink the federal workforce and modernize public services using artificial intelligence.Currently, 1,600 call center agents handle over 15,000 student loan inquiries daily, but the introduction of AI could drastically reduce the need for human workers. The chatbot system would replace or supplement existing services, such as Accenture's help desk contract, valued at over \$700 million.

Amid M K Stalin's LS seat-cut claims, Amit **Shah says Tamil Nadu tally to stay intact**

COIMBATORE: Union home minister Amit Shah said Wednesday that CM M K Stalin is misleading people of Tamil Nadu with his claims that the state would stand to lose a number of parliamentary constituencies after the delimitation exercise. Shah's assertion comes a day after Stalin called for an all-party meeting on March 5 to discuss the consequences of the exercise.Addressing BJP workers here. Shah said. "The PM has made it clear that no state will lose its Lok Sabha seats due to delimitation. Instead, Tamil Nadu and other southern states will only gain constituencies on a pro rata basis." Asking Stalin to explain the basis of his



claim that TN would lose Lok Sabha seats due to delimitation, Shah said, "It is condemnable to mislead the people."

Back of the envelope calculations using India's population as of March 2025 according to projections by the Census office show that if no major state is to suffer a decline in LS seats but their shares are to reflect population shares, the size of LS would have to expand to about 790.In such a scenario. Kerala's LS seats would remain at 20 while all other major states would see an addition to their seat tally. In terms of the share of LS seats, the southern states, however,

would suffer a significant loss. Presently, the five southern states amongst themselves have 129 of the 543 LS seats or about 24%. In an LS with 790 seats, they would have 152 seats or just over 19%. TN's present share of 7.2% in the LS would reduce to 5.4%.

In contrast, the Hindi belt states of UP, Bihar, Rajasthan, MP currently have 174 or 32% of LS seats. In the 790-member House, that number would jump to 300 or about 38% of the total. UP's tally alone would rise from the current 80 to 133 seats. Shah's visit to TN comes amidst an intense Centre-state tussle over alleged Hindi imposition and inadequate fund allocation.

Woman raped in bus at busy Pune station located opposite thana

PUNE: A 26-year-old preoperative counsellor with a Pune hospital was allegedly raped inside a parked bus at the city's Swargate terminus around 5.30am Tuesday. The accused is a criminal with past cases of theft and robbery. Police teams are combing through CCTV footage and local networks to track the fugitive suspect. The crime occurred at one of Pune's busiest transport hubs, which sees a daily footfall of 60,000 passengers and 600 bus movements. Swargate police station is located opposite the bus terminus, raising concerns over security lapses. "After the assault, the survivor was so traumatised that she couldn't raise an alarm," DCP Smartana Patil said. He said survivor was at Swargate depot to take a morning bus home when

"The suspect struck a casual conversation with her, asking about her destination," Patil said. "A little later, he told her that a bus parked nearby, where passengers usually board in advance. He led her to the bus, and when she entered to check for seats, he followed her inside, bolted the door from inside, and raped her."Transport minister Pratap Sarnaik ordered an inquiry into the lapses and 23 security personnel have been removed from service.The crime has sparked widespread outrage across the state. It can take a cue from Rahul Gandhi

"This time, I had anticipated that Bengal would give the CPI (M) at least three seats. And without a doubt, Bhattacharyya, our Srijan, would be among the winners. Workplace mental health: Time for sane Thinking

What defines the real wealth of a nation? Is it the towering skyscrapers that shape its skyline, the bustling industries that fuel its economy, or the global influence it commands? Perhaps it's something much deeper-the well-being of its people, their minds, and their hearts. In a rapidly transforming India, where the pace of professional life is accelerating, workplace mental health has emerged as a crucial but often overlooked concern. As organisations strive for efficiency and output, the mental wellbeing of employees is under increasing strain. According to a survey by the World Health Organisation (WHO), the global economy loses an estimated \$1 trillion per year due to depression and anxiety alone. A study by Deloitte (2022) reveals that nearly 80 per cent of the Indian workforce faces some degree of mental health issues, yet a mere 20 per cent seek professional help. This alarming gap is exacerbated by the stigma associated with mental illness, inadequate awareness, and limited access to mental health services in workplace settings. A recent tragedy in Noida has brought the issue of workplace mental health into sharp focus. A bank employee took her own life after enduring harassment from her colleagues. The deceased left behind a fivepage suicide note in which she revealed how her coworkers subjected her to derogatory slurs such as "bandariya" and "dimag se pagal". In the note, she named six of her colleagues, including two managers,



who allegedly contributed to her emotional breakdown.

Another incident from Pune: a 26-year-old chartered accountant from Kerala took her own life after enduring four months of immense work pressure. Her mother's powerful letter to EY India sheds light on the "callous attitude" towards employee well-being that, unfortunately, seems to be a growing concern in many workplaces today. These heartbreaking incidents highlight the toxic environments that many Indian employees silently endure, emphasising the urgent need to address mental health issues in the workplace. For many Indian professionals, the culture of overwork, coupled with societal expectations, creates immense pressure to perform. Long working hours, tight deadlines, job insecurity, and an absence of worklife balance contribute to heightened stress, anxiety, and burnout. In a society where mental health is still a taboo topic, employees often refrain from discussing their struggles, fearing judgement or negative career consequences. No job is worth a life, and it is time for a systemic change to ensure that every employee feels safe, valued, and heard. Government Policies and **Corporate Initiatives**

India has made strides in addressing mental health in the workplace, but much progress is still required. The Mental Healthcare Act, 2017, provides a legal framework ensuring individuals' rights to mental health care, including mandated insurance coverage for mental health treatments. However, its corporate implementation remains limited. The National Mental Health Policy (2014) advocates for workplace mental health awareness and encourages supportive environments, though widespread adoption yet to be seen. Nonetheless, companies like TCS and Wipro are pioneering employee wellness programs, offering counselling and stress management initiatives. The pandemic also spurred firms like Accenture, Google, and Microsoft to introduce teletherapy and burnout prevention strate-

gies. However, the government's 2024–25 Union Budget underscores a significant funding gap in addressing India's mental health challenges. Although the allocation for the National Tele Mental Health Programme has been increased to ?90 crore from the previous year's ?65 crore, this modest rise falls far short of the resources needed to meet the country's escalating mental health demands. A more comprehensive investment in workplace mental health remains critical for sustainable progress.

Role of Leadership

Corporate leadership plays a pivotal role in shaping workplace mental health. The tragic case of the Noida bank employee's suicide underscores the importance of leadership accountability in preventing workplace harassment. Had there been a proactive, supportive mancouraged workplace bullying and provided a safe space for employees to raise their concerns, the outcome might have been different. Leaders must take responsi-

bility for creating a healthy, inclusive work culture that discourages toxic behaviour. Creating a mental healthpositive workplace culture requires a top-down approach where leaders not only encourage open dialogue but also normalise seeking help for mental health issues. Human Resources departments need to adopt a proactive role in identifying mental health risks and offering solutions, wellness checkins, and mental health days. A Holistic Approach

While government policies and corporate initiatives are crucial, sustainable change requires a multi-faceted approach.

Increased Awareness and Training: Regular mental health awareness campaigns within organisations can help destigmatise mental health issues. Training managers and employees to recognise early signs of distress and offer support will create a safer environment for discussing mental health concerns. Mental Health Infrastructure: Companies need to invest in mental health infrastructure, including easily accessible counselling services, confidential helplines, and designated wellness officers. Telehealth platforms, which have seen increased use since the pandemic, can play a critical role in connecting employees with mental health professionals. Work-Life Balance: Flexible working hours, hybrid models, and vacation policies that prioritise rest over constant productivity can significantly reduce Encouraging burnout. employees to disconnect after working hours.

How Iran's pan-Islamic obsession pits it against Israel

hostilities between Israel and Iran was often feared during the last two decades. However, it was not until earlier this year that the Islamic Republic actually chose to hit Israel directly. Under Operation "True Promise", Iran fired a barrage of around 300 ballistic missiles, cruise missiles, and suicide drones upon Israeli targets the night of April 13-14, 2024, almost a fortnight after Israeli airstrikes on the Iranian consulate in Damascus, Syria (April 1) had killed 16 persons, half of whom were officers of the Islamic Revolutionary Guards Corps (IRGC). Who - And What - Will Fill The Vacuum In Iran's Resistance Axis?

The killing of Hezbollah chief Hassan Nasrallah in Israeli airstrikes on the Dahieh suburb of Beirut, a predominantly Shia stronghold, was a tectonic event both for the group and the region. Nasrallah had been the leader of Hezbollah for over three decades. The outfit itself was designated as a terror group by the US and others in 1997, two years before even Al Qaeda was labelled as such. In response to his death, Iran has launched a ballistic missile attack against Israel, upping the ante. The crisis today for Hezbollah, founded in 1982 from the ashes of the

Lebanese Civil War, is more existential in nature than ever before. Along with Nasrallah, a majority of the group's military and political hierarchy has also been eliminated. While Israel's offensives against Hezbollah's leadership are not new, the 2006 Israel-Lebanon war, where Israel failed to deliver a thumping defeat, was a focal moment in its strategic thinking. The 2008 assassination in Syria of the group's second in command and founder of the Lebanese Islamic Jihad Organisation, Imad Mughniyeh, was a turning point, one that ultimately culminated in Israeli operations inside Lebanon over the

Zakir Naik's Pakistan Visit Will Further Stoke Fire of Islamic Extremism

Controversial Islamic preacher Zakir Naik is currently on a visit to Pakistan, where he is scheduled to deliver a series of public lectures across major cities, including Karachi, Lahore, and Islamabad, from October 5 to October 20. His arrival at the invitation of the Pakistani government has ignited considerable concern regarding the potential ramifications of Naik's ideology on a nation already wrestling with escalating fundamentalism and sectarian violence. Born in 1965, Naik is infamous for his provocative and often divisive sermons that have gained a global audience. His lectures advocate a stringent interpretation of Islam and frequently challenge the beliefs of other religions, asserting a narrative of Islamic superiority. In 2016, he fled from India amidst allegations of inciting terrorism and hatred, subsequently finding refuge in Malaysia. Since then, he has continued to attract significant attention, both from supporters who view him as a visionary promoting interfaith dialogue, and critics who contend that his rhetoric often strays into incitement, fostering fundamentalist interpretations that may lead to radicalisation. One of the most concerning aspects of Naik's influence is its documented ties to extremist groups. In the past, multiple Bangladeshi militants have openly acknowledged being inspired by his teachings. Naik's presence is poised to intensify these tensions, further polarising an already divided Pakistani society. For decades, Pakistan's landscape has been deeply scarred by religious extremism. The emergence of fundamentalist groups has not only jeopardised the secular fabric of society but has also incited violence against religious minorities. Communities such as Ahmadis, Christians, Hindus and Shias have endured systemic discrimination, violence, and persecution, frequently rationalised by extremist interpretations of Islam. As the nation continues to grapple with its multifaceted identity, the influx of radical ideologies presents a significant threat to its minorities.

The Pakistani government has made no efforts to counter extremist narratives and hence the societal currents of fundamentalism remain robust. The minorities in Pakistanparticularly Ahmadis, Christians, Hindus and Shia Muslims—are surviving in a precarious situation. Ahmadis, for instance, are legally designated as non-Muslims and have to endure persecution, violence, and even murder. The blasphemy laws, frequently exploited to target these communities, have resulted in mob violence and wrongful imprisonments. Christians and Shia Muslims also face targeted assaults .from extremist factions.

Jaipur LPG tanker crash: Investigation finds fault on part of NHAI and tanker's owner and consigner

NEW DELHI: An investigation into the Jaipur LPG tanker crash that claimed 21 lives has pointed out faults on the part of NHAI and its agencies, and the owner and consigner of the tanker for non-compliance of safety standards as well as negligence of the deceased driver of the goods truck that hit the tanker. The findings of the crash investigation conducted by the Institute of Road Traffic Education (IRTE) with support from the Jaipur Police was presented at a mock court, chaired by former IPS Kiran Bedi, on Wednesday at the College of Traffic Management in Faridabad.

The probe report mentions that the tanker driver can be absolved of the offence of dangerous or negligent driving as he took the U-turn on the highway "cautiously". However, the FIR by the Jaipur Police, registered hours after the fatal crash, has accused the drivers of the LPG tanker and the goods truck of speeding and negligence, which, according to police, resulted in the accident. The FIR has not mentioned any other entity for the crash. Police are yet to file a chargesheet in the case. The crash happened on the Jaipur-Kishangarh highway in Rajasthan on Dec 20 last year. The goods-carrier truck collided with the BPCL tanker carrying LPG when the tanker was making the Uturn. There was an explosion due to gas leak from the tanker as its inlet-outlet nozzle had broken in the accident. The findings of another crash investigation carried out by SaveLife Foundation for the road transport ministry, which was presented to minister Nitin Gadkari recently, identified almost similar reasons behind the fatal accident.



Delhi has practically exhausted groundwater

Delhi: While Delhi is facing a water crisis and civic authorities endeavor to boost groundwater availability, the Central Ground Water Board (CGWB) reported that yearly recharge and groundwater for extraction had declined. The analysis anticipated Delhi's net annual groundwater recharge in at 0.38 billion cubic meters (bcm), 0.34 of which was accessible for extraction. Alarmingly, most groundwater has been removed. It means 99.1% of groundwater is extracted. The groundwater recharge was 0.41 bcm, with 0.37 bcm available for extraction and

0.36 bcm pulled out. The analysis showed Delhi's groundwater extraction rising from 98.16% in 2022 to 99.13% in 2023 despite a drop in recharging. While some places have made headway in maintaining safe groundwater levels, Delhi still struggles to properly manage its groundwater resources. With 15% of Delhi's assessment units categorized as "safe" for groundwater levels in 2023, up from 12% in 2022, the CGWB report was pleased. In stark contrast, important groundwater regions increased from 21% of the city in 2022 to 35% in 2023. CGWB assesses ground-

Out of 34 evaluation units, 13 (38%) were 'over-exploited', 12 (35%) were 'critical', four (12%) were semi-critical', and five (15%) were safe'. Improvements 2022 include an increase in safe zone tehsils from four to five, a decrease in semi-critical from eight to four, and a reduction in over-exploited areas from 15 to 13. Critical regions seven tehsils in 2022 to 12 in 2023. To address the groundwater alarm, **CGWB** recommends mandating rainwater harvesting in waterdepleted areas.

the proposal, the road transport and highways ministry on Tuesday (Feb 25) said the slogan can be painted or can be put in the form of a sticker. The ministry noted that the move to display such slogans was taken based on the receipt of submissions with respect to "promoting compassion

NEW DELHI: Former Tihar PRO Sunil Kumar Gupta made an explosive claim that air hostesses of Sahara Airlines used to come to Subrata Roy in jail and remain with him for hours. This was one of the many facilities provided to the late founder of Sahara Group when he was in jail. In an interview with ANI, Gupta claimed that Arvind Kejriwal, then-chief minister of Delhi, was aware of all that but did not take any action.

Recounting his experience with Subrata Roy when Roy was an inmate, Gupta said he was first kept in a regular jail. But he needed a facility with video conferencing so that he could negotiate with the buyers of his hotels following which he could pay the lenders back. "The Supreme Court's direction said that everything has to be done legally. But I saw that a lot of illegal things were happening...Before this, the Delhi High Court had called me and it said that there are several complaints of bribery and extortion at the jail," Gupta said. Gupta said he raised the issues at meetings chaired by DG Prisons but the DG thought Gupta was complaining against him. Then Gupta approached Kejriwal and informed him about the facilities that he thought were being extended to him illegally.

"Arvind Kejriwal asked me if I could shoot a video of it. I told him it wouldn't be right for me and he could come here and check it for himself. He then said that DG Prison is an IPS officer who comes under Central Govt and we do not know if we can do anything about him..." he said.

In a 1st in India, bird flu detected in domestic cats

PUNE: The first cases of avian influenza virus (H5N1) in domestic cats in India were reported from Chhindwara district in Madhya Pradesh, raising concerns about the bird flu pathogen mutating and infecting humans.

"H5N1 is classically an avian virus, but certain mutations allow it to replicate in mammalian hosts. This adaptability raises concerns because influenza viruses have the potential to trigger pandemics, as seen in past outbreaks like Covid-19," a scientist said. Scientists from ICAR-NIHSAD and Union govt's animal husbandry department have documented the cases this Jan in Chhindwara, which borders Nagpur - where several big cats died of bird flu in Dec last year.



2.3.2.1a lineage, a variant of H5N1 that has caused outbreaks in poultry across India. "These cases represent the first documented instances of this particular strain infecting domestic cats in India," the study says.

The scientific team identified It found that all infected cats the virus as belonging to the exhibited symptoms such as high fever, loss of appetite, and lethargy before succumbing to the illness within one to three days after sample collection. The study identified 27 mutations in the virus found in cats. Scientists called for enhanced surveillance in domestic poultry, wild birds, and mammals, including pets and humans, given the virus's ability to jump between species.

"Although human infections have been rare, we must anticipate the virus adapting to efficient transmission to and between humans. Human-tohuman transmission is still not efficient, but ongoing changes in the virus signal to us to stay vigilant and prepared even for a pandemic," virologist Jacob John said. On the virus's potential to cause a global outbreak, John cautioned: "H5N1 is new for humans. We do not have immunity against it. If humanto-human transmission becomes efficient, as an extension of the present pattern of mammalian transmission, it is

CHANDIGARH: The iconic Rock Garden in Chandigarh is facing the UT administration's bulldozers, and citizens are up in arms to stop them.

A portion of the outer wall of the Rock Garden is being demolished and trees on either side of it being cut following a directive by Punjab and Haryana high court. It is part of a road widening project for creation of additional parking space and traffic decongestion on the road near the high court abutting the Rock Garden.Outraged by the administration's move, citizens have started campaigns to save the legacy of Nek Chand - whose wasteto-art project has been part of the city's identity for decades.

"So sorry, Nek Chand Saini; your precious creation is being demolished in part to



make way for a road and parking of polluting vehicles. We, the people of Chandigarh and the administration, have let you down, that too in your birth centenary year," Manmohan Sarin, a lawyer and member of Chandigarh Heritage Conservation Committee, in a post on X on Feb 22.

The wall that is being razed is near the 'high court gate' or 'VIP gate' of the Rock Garden. "It is the same gate from which Nek Chand ji used to enter the Rock Garden when he lived in it for around three said

Chand's son Anuj Saini, adding, "The wall can be rebuilt, but the heritage value of the area will be lost.'

Citizens have been holding protests, and have initiated online petitions - 'Save Rock Garden, Chandigarh' 'Saving Chandigarh' to halt the demolition.

After hyperloop breakthrough, government eyes 50km commercial link

NEW DELHI: After the breakthrough in developing a hyperloop test track (422m) by IIT Madras with support from Indian Railways, the government is now planning development of a 50km corridor for commercial transport, said minister Ashwini Vaishnaw. It may be the longest hyperloop track in the world.

"The first tube will go a long way in developing technologies. The time has come when after the first two grants of \$1million each (nearly ?9cr), the third grant of \$1million will be given to IIT Madras for fur-



ther developing the hyperloop project in a nice way. And once we see the commercial or rather pre-commercial where the product is ready, then within the railway set-up we will start the first commercial project. We will decide a site, which can be used for good commercial transportation of 40km-50km and then we will go for it," Vaishnaw said while addressing the closing ceremony of Asia's first Global Hyperloop Competition by IIT Madras.Sources said the test track for commercial operation will help railways assess

viability of the technology. The hyperloop track can allow speeds of up to 1,200kmph. The successful development of the first test track, which was completed in Dec last year, will be the base for future development. There are 8 hyperloop projects around world Hyperloop systems are expected to dramatically reduce travel times between cities, offering an alternative to traditional rail and air travel. The hyperloop concept envisions high-speed, low-pressure pods travelling at speeds of up to

1,200 kmph.

Commercial LPG hike by Rs 16.5 per cylinder, jet fuel up 1.45%; household cooking gas remains unchanged

NEW DELHI: The cost of commercial LPG and aviation fuel prices surged on Sunday following the monthly revision aimed at aligning with trends in international oil prices. State-owned oil firms raised commercial LPG rates, used in hotels and restaurants by Rs 16.5 per to Rs 1818.50 per 19 kg cylinder. Aviation turbine fuel (ATF) prices in Delhi, which hosts one of India's most active airports, saw an increase of Rs 1,318.12 per kilo litre, marking a 1.45 per cent increment. The new rate stands at Rs 91,856.84 per kl, according to state-owned fuel retailers. The prices of ATF and LPG vary from state to state, depending on local taxes, including VAT. This marks the second consecutive monthly increase in jet fuel prices, which were previously raised by Rs 2,941.5 per kl, or 3.3 per cemt, on November 1. ATF prices were reduced by 6.3 per cent (Rs 5,883 per kl) on October 1 and by Rs 4,495.5 per kl, or 4.58 per cent, on September 1. In Mumbai, the ATF price increased to Rs 85,861.02 per kl on Sunday from Rs 84,642.91 previously. The price of commercial LPG have also increased for the seventh consecutive month. In the most recent review on November 1, commercial LPG prices were raised by Rs 62 per 19-kg cylinder. Over the course of five price hikes, commercial LPG prices have increased by Rs 172.5 per 19-kg cylinder, reaching their peak this year. Four monthly price reductions before the current cycle began in August were offset by the recent hikes. Prices for 19-kg cylinders were reduced by Rs 148 across the four rounds. Currently, commercial LPG costs Rs 1,980 in Chennai, Rs 1,927 in Kolkata, and Rs 1,771 in Mumbai for a 19-kg cylinder. However, the rate of cooking gas used in domestic households, however, remained unchanged at Rs 803 per 14.2-kg cylinder. State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise the prices of ATF and cooking gas on the first of each month.

Trump says Ukrainian leader Volodymyr Zelensky to sign minerals deal in US

If India adopts hybrid model

Delhi: The Pakistan Cricket Board (PCB) has softened its stance, saying they will accept the 'hybrid format' for the Champions Trophy if the ICC does the same for global events in India until 2031. India will host the 2026 T20 World Cup alongside Sri Lanka, the 2029 Champions Trophy, and the 2031 ODI World Cup with Bangladesh till 2031. The PCB had threatened to boycott the Champions Trophy if Pakistan was not handed full hosting rights, but this has eased its position. India will likely play in Dubai if the Champions Trophy is hybrid. "The current situation is that PCB Chairman Mohsin Naqvi has said that it will only accept hosting the Champions Trophy on a hybrid model if the board agrees that in the future all ICC events will be on the same system with Pakistan not going to India to play matches, "Pakistan also wants the ICC board to increase its financial cycle share of revenues from 5.75 percent and Nagvi is insistent on this but he has not sought any additional hosting fees," a source said. "People are saying that Nagyi has sought time to get back after talking to his government but we don't know if he went there with the backing of the government and had already sought their approval to make his stand in the ICC board's virtual meeting," he said. The standoff between India and Pakistan's cricket bodies threatens the eight-team Champions Trophy in Lahore, Rawalpindi, and Karachi. The BCCI has informed the ICC that it would not send its side to Pakistan for the February-March 2025 Champions Trophy. The PCB-BCCI dispute continues. The ICC Board Meeting failed to resolve the tournament's destiny. After the BCCI informed the ICC that India would not tour Pakistan, the PCB wrote to the ICC to ask why. Musk takes centrestage at Trump's first cabinet meet as prez backs layoff spree

Donald Trump's administration Wednesday laid the groundwork for more largescale layoffs, as downsizing czar Elon Musk pledged that he would move quickly to slash spending. At the first meeting of Trump's cabinet, Musk said he aims to cut the \$6.7 trillion budget by \$1 trillion this year, an ambitious target that could entail significant disruption of govt programmes. Trump reiterated his promise to refrain from cutting popular health and retirement benefits that account for nearly half of that total."We're not going to touch it," said Trump, whose unprecedented govt overhaul has so far fired more than



Delhi: To ensure transparent and seamless assessments, the Board of Secondary Education (BSE) will use Al-powered CCTV cameras and webcasting of the annual High School Certificate (HSC) exam 2024. Pauses, violations of rules, such as logistical issues in storing or distributing ques-

papers, cheating, malpractice, invigilator incompetence, or cell phone use in HSC exam centers, can now be identified quickly. The board has strategically placed AI-sup-



ported CCTV cameras and webcasting for realtime test hall surveillance. Advanced features in these cameras can detect strange behavior in the medical room. "The annual matric examination 2024 will be completely hi-tech and technologyenabled to make the process transparent and error-free," stated BSE secretary Nihar Ranjan Mohanty.

Over 5.5 lakh students will take the yearly HSC exam from February 20 to March 4, 2024. More than 2,990 centers will host the exam this year. Hypersensitive and sensitive test centers, strong rooms where question papers will be maintained, and district education officers will have Alenabled CCTV cameras. "We are working on identifying the centres based on the reports of DEOs," he said. The BSE sends a three-tier squad of 160 persons to examination centers to check for wrongdoing and ensure smooth board exams.

Supreme Court: No minimum age for witness; kid's evidence

NEW DELHI: Holding that the evidence of a child witness stands on the same footing as any other witness if the child is competent to testify, Supreme Court has convicted and sentenced a man to life imprisonment for killing his wife by relying upon the statement of the couple's seven-year-old daughter who witnessed the incident.
