According to the statement from RIL, the PM visited the wildlife hospital where he played with and fed various species, including Asiatic Lion cubs, White Lion cub, Clouded Leopard cub, which is a rare and

endangered species, and a Caracal cub among others.

"The White Lion cub, which was fed by PM Modi, was born at the Centre after his mother was rescued and brought to Vantara for care," the release said.

Vantara breeds caracals, a now-rare breed of cat, in captivity for their preservation, the statement said, adding they are released in the wild later.

"The PM visited the MRI room at the hospital and witnessed an Asiatic Lion undergoing an MRI. He also visited the Operation Theatre where a Leopard was going through a lifesaving surgery after being hit by a car on the highway and brought here after rescue," it said.

medical equipment from the hospital pharmacy. Therefore, such hospitals



A bench of Justice Survakant and NK Singh heard this. The central government said in its reply that patients are not forced to buy medicines from the hospital pharmacy.


### Free treatment for road accident victims from this month Government will bear expenses up to ₹1.5 lakh, pilot project successful in 6 states including Haryana-Punjab

accident victims will get free treatment up to Rs 1.5 lakh from this month i.e. March 2025. This rule will also be for private mandatory hospitals. This system will be implemented across the country. NHAI will work as the nodal agency for this.

According to the National Highway Authority (NHAI) official, Section 162 of the Motor Vehicles Act 1988 has already been amended for the scheme. Before fully implementing this scheme, a pilot project was run in six states including Puducherry, Assam, Haryana and Punjab



The NHAI officer said that as

for this. Whether the injured

have family members with them or not, the hospital will

take care of them. Both private and government hospitals will have to provide cashless treatment. Nitin Gadkari launched the cashless treatment scheme. The Ministry of Road Transport and Highways launched the pilot project Cashless Treatment Scheme on 14 March 2024 to provide

cashless treatment to road accident victims. After this, on 7 January 2025, Gadkari announced the official launch of the scheme across the country.

#### **BSE shares fall** due to SEBI's new proposal

Mumbai (Agency). SEBI has put pressure on Bombay Stock Exchange (BSE) shares due to market risk. Apart from this, a global brokerage firm has reduced the target price of BSE by about 14 percent due to this proposal, due to which a big fall was seen in the shares. Currently, BSE's share is trading 3.47 percent down at Rs 4,473.05, while in intraday it fell by 5.14 percent to reach the level of Rs 4,395.70. The brokerage firm says that due to SEBI's proposal, the industry's options premium will come down to 0.4 to 0.3 compared to cash equity turnover. Due to this, it will be difficult for the market share of the average daily premium traded on index options contract to cross 30 percent. This figure was 22 percent in February. In such a situation, the brokerage firm believes that the activity of proprietary traders may decrease and its impact may be seen on BSE shares because about 70 percent of the average daily turnover of BSE comes from them.

Mumbai (Agency): A significant surge in women seeking credit has been reported in the financial system, with a threefold increase in credit demand from women borrowers between 2019 and 2024. The number of women borrowers availing retail credit in India has increased at a compounded annual growth rate (CAGR) of 22 per cent in the last five years ended 2024, according to a report.

This growth reflects a significant shift in financial behaviour, with women increasingly leveraging credit to meet personal and professional goals. Significantly, around 60 per cent of women borrowers who availed credit are from semi-urban or rural areas, the report released by TransUnion Cibil and NITI Aayog said.

Women's share in business loans and gold loans has increased by 14 per cent and 6 per cent, respectively, since 2019. Interestingly, women under 30 account for only 27 per cent of retail credit uptake, compared to 40 per cent for men in the same age group. The number of women opening business loan accounts has grown fourfold over the past six years. By 2024, 42 per cent of loans availed by women were for personal finance, a slight increase from 39 per cent in 2019. While credit supply to women in business sectors has improved, the majority of loans availed by women continue to be against gold. In 2024, 36 per cent of all loans availed by women were gold loans, up from 19 per cent in 2019. The report, jointly published by TransUnion CIBIL, Women Entrepreneurship Platform (WEP) of NITI Aayog, and MicroSave Consulting (MSC), highlights the notable growth in women's participation in credit origination. Credit for financing business purpose (business loans, commercial vehicle & commercial equipment loans, loans against property) witnessed about 37 lakh new loan accounts opened by women, with disbursement totalling Rs 1.9 lakh crore. While the number of accounts opened for business purpose has grown 4.6 times since 2019, these loans constitute only 3 per cent of overall loans availed by women borrower in 2024, the report said. Credit for personal finance needs (personal loans. consumer durable loans, home ownership, vehicle loans) continues to be a major share of loans availed by women. As many as 4.3 crore such loans of value Rs 4.8 lakh crore were opened. These accounted for 42 per cent of all loans availed by women in 2024, according to the report.

### **IPO pipeline faces uncertainty as market** sentiment takes a big hit **Companies may potentially** delay, shelve planned IPOs

#### Mumbai (Agency): The Initial Public Offering (IPO) market is bracing for a slowdown as 26 companies, which have the Securities and Exchange Board of India (Sebi) approval to raise over Rs 43,000 crore between April and December 2024, are yet to launch their offerings. The prolonged delay is attributed to the prevailing market volatility, characterised by weakening investor confidence due to concerns over tariff wars and lacklustre corporate earnings with incessant selling by foreign investors adding to the market woes. Experts warn that the

domestic IPO activity is likely to be severely impacted by the current market sentiment, potentially delaying or even shelving these planned offerings According to data obtained from Prime Database, 26 domestic companies

received approval from the

decline in markets, the number of companies filing for IPOs continues to remain high. In January 2025, 29 companies filed offer documents with the market regulator to raise an approximate amount of Rs 22,667 crore. This is almost double the number of companies that had filed for IPO fund raising in January 2024. In February 2025, 13 players applied to Sebi for IPO, compared to 9 in the same period of 2024.

"In January, there were a record 29 filings. So the pipeline is getting even bigger. However, unless the market attains some stability, you would not see many IPO launches," Haldea said. In 2024, IPO fund raising surged to a record high, with 91 companies raising Rs 1.6 lakh crore. Even the number of small and medium enterprises (SME) IPO touched a high of 240 compared to 182 in 2023, according to Prime Database.

## EDITORIAL Yogi's rise

The recently concluded Maha Kumbh has not only reinforced Uttar Pradesh Chief Minister Yogi Adityanath's political dominance in the state but has also positioned him as a key contender in any post-Narendra Modi succession debate. As the massive gathering of devotees unfolded, it became clear that the event was being shaped into a grand spectacle of religious and administrative prowess ~ one that placed Mr Adityanath firmly at the centre of the BJP's future. The scale of the Maha Kum - bh, with its staggering claim of 66 crore attendees, provid - ed the UP CM with an unparalleled stage to solidify his image as a leader deeply embedded in Hindu religious sentiment. Unlike past Kumbh Melas, which were largely seen as spiritual gatherings, this edition bore the unmistakable imprint of a political project aimed at reinforcing the chief minister's brand. His near-daily presence ensured that devotees associated the seamless administration of the event with



his leadership, bolstering his image as a decisive ruler. This development is significant because it marks a departure from the BJP's traditional leadership dynamics. While the party has long

been defined by Mr Modi's towering presence, the question of succession will gather relevance in coming years. Mr Adityanath's growing stature makes him an inevitable factor in this conversation, particularly when contrasted with other potential contenders. Union Home Minister Amit Shah, often seen as Mr Modi's most trusted lieutenant, remains powerful within the party's organisational framework. However, his influence is largely derived from his proximity to Mr Modi rather than an independent mass base.

Unlike Mr Modi, who built his career as the unchallenged leader of Gujarat before stepping onto the national stage, Mr Shah does not command a state of his own. This distinction is crucial, as the BJP's rise has in recent times been driven by leaders who have proven their mettle through state-level governance before making the national leap. Mr Adit - yanath, on the other hand, has cultivated a personal following that extends beyond party structures. His aggr e - ssive governance style, emphasis on law and order and staunch Hindutva positioning, have made him a rallying figure for a section of the BJP's base. More importantly, his control over Uttar Pradesh ~ the state that sends the highest number of MPs to Parliament ~ gives him strategic leverage. While the Modi-Shah duo remains the fulcrum of the BJP's national leadership today, the emergence of a leader with an independent power base within the party could signal friction ahead. Mr Adityanath's rise suggests that the post-Modi BJP may not be as straightforward as a handover to a central leader. Instead, it could evolve into a contest where state-level heavyweights begin assering their influence, challenging the centralized command structure that has defined the party in recent years. The Maha Kumbh was not just a religious event ~ it was a political moment that reinforced this shift. Whether Mr Adityanath's ascent is fully embraced by the BJP's national leadership or leads to internal power struggles remains to be seen. What is certain, however, is that Mr Adityanath is now a formidable player in the BJP's national future.

## **Starmer's Test**

UK Prime Minister Keir Starmer's visit to Washington was important for transatlantic diplomacy. It was his first official engagement with President Donald Trump, a leader known for his forceful style and unpredictable rhetoric. The meeting highlighted the delicate balancing act Mr Starmer must perform ~ asserting British interests while navigating Mr Trump's transactional approach to international relations. One of the most striking moments came when Mr Starmer handed Mr Trump a letter from King Charles III, inviting him for a second UK state visit. The gesture was diplomatically as tute, signaling Britain's intent to maintain strong ties with Washington regardless of political shifts. It was also a pragmatic move, appealing to Mr Trump's appreciation for personal recognition and grandeur. In an era where soft diplomacy can be just as impactful as policy discussions, this invitation set the tone for a more cordial engagement. However, the meeting also underscored Mr Trump's characteristic dominance in diplomatic settings. He took control of the conversation, setting the agenda and choosing which reporters would ask questions. Mr Starmer, despite his composed demeanor, found himself adjusting to Mr Trump's style rather than leading the discourse. This dynamic is unsurprising, given Mr Trump's preference for positioning himself as the central figure in any interaction. Yet, Mr Starmer's willingness to engage and his ability to push forward key UK concerns ~ particularly on trade and security ~ showcased his diplomatic resilie - nce. Trade was a focal point, with Mr Starmer attempting to secure assurances that the UK would not face new tariffs under Mr Trump's administration. Mr Trump ackno - w ledged Mr Starmer as a "tough negotiator" but stopped short of concrete commitments, merely suggesting that a trade deal was possible. This reflects the broader uncertainty surrounding US-UK economic relations. While Mr Trump thrives on deal-making rhetoric, his unpredictability makes longterm agreements difficult to pin down. Mr Starmer will need to continue pressing for commitments to protect British economic interests. Beyond trade, the discussion touched on the UK's negotiations over the Chagos Islands, where the US maintains a key military base. Mr Trump signaled a willingness to support the UK's agreement with Mauritius, a potential shift from Republican opposition. While this may seem like a minor diplomatic win, it highlights the broader geopolitical considerations Britain must navigate under an America-first administration. Mr Starmer faced a challenge when the issue of free speech arose. US Vice President J.D. Vance had recently criticized the UK and Europe for allegedly curbing speech freedoms. Mr Starmer responded firmly, defending Britain's long history of upholding free expression. His direct rebuttal was a rare moment where he seized control of the conversation, underscoring his ability to push back when necessary. In the end, Mr Starmer's visit was less about securing deals and more about laying the groundwork for future engagement. His challenge will be to assert Britain's interests without being overshadowed by Mr Trump's forceful diplomacy.

## Blue Economy vision and ecological responsibility **Ramvilas Sharma**

India's ambitious Blue Economy vision is reshaping the way the country engages with its vast marine resources. At the heart of this transformation is Kerala, with the Quilon Fish Bank emerging as a crucial player in sustainable fisheries. However, recent concerns over large scale dredging, resource extraction, and the longterm impact on marine biodiversity have raised important questions about balancing economic growth with ecological stability.

The Quilon Fish Bank, known for its rich biodiversity and high productivity, is among India's most significant fishing grounds. Spread across Kollam and Alappuzha districts, this region is a vital breeding ground for numerous fish species and shrimp. Kerala's fisherfolk have long depended on these waters for their livelihood, making sustainable fisheries management crucial for the state's economy and food security. However, recent developments, such as the planned dredging of 242 square kilometers of the seabed in Kollam, have sparked widespread concern. Reports indicate that India's Geological Survey has identified 7.45 billion tonnes of sand in Kerala's coastal and offshore areas. While the government sees this as an opportunity for economic development, local communities fear it may lead to habitat destruction, loss of fish stocks, and increased coastal erosion. The controversial dredging project is part of a larger Blue Economy initiative aimed at tapping into the ocean's resources for economic growth. While this approach has potential, questions remain about its long-term sustainability and impact on Kerala's delicate marine ecosystem.

The Blue Economy concept emphasizes responsible and sustainable use of marine resources to drive economic progress. India, with its vast coastline and rich maritime heritage, has identified the Blue Economy as a critical driver of growth in the 21st century. The government's policy framework seeks to integrate economic growth with environmental conservation. While large-scale resource exthis vision, efforts are also being made to minimize ecological disruption. Scientific research, eco-friendly technologies, and strict regulations are being implemented to ensure sustainability. One of the key objectives of India's Blue Economy plan is to modernize the fisheries sector.

Additionally, advanced monitoring systems are being introduced to track fish migration patterns and regulate fishing activities, ensuring long-term marine health. India's approach to the Blue Economy is also being shaped by global collaborations. By align-

However, these efforts need stronger support from the Central government to ensure long-term effectiveness. The future of the Quilon Fish Bank and Kerala's fisheries sector hinges on finding a middle ground between economic growth and environmental sustainability. While resource extraction and development projects are necessary for progress, they must be undertaken with strict environmental safeguards.

A multistakeholder approach involving the government, local fishing communities, environmentalists, and global experts is essential. Policymakers must prioritize scientific research and ecological impact assessments before approving large scale marine projects. Empowering local communities with alternative livelihood options, enhancing conservation efforts, and enforcing stricter regulations on resource extraction can help ensure a sustainable future for Kerala's fisheries. India's Blue Economy vision holds immense promise, but its success will ultimately depend on how well it balances development with ecological responsibility. With continued investment in research, conservation, and community welfare, the Quilon Fish Bank can serve as a model for sustainable fisheries, ensuring that Kerala's fisherfolk have a bright and resilient future in India's evolving maritime economy.

Her face was burnt on one side in childhood. In the year 2021, she came in contact with Uzair, a resident of Agra, through Facebook. Uzair trapped Shahzadi in his trap by lying. Uzair called the princess to Agra to get her face fixed. After this, in the name of getting her treated, he sold her to a couple Faiz and Nadia living in Dubai in November 2021

### Indian shot dead

#### after 3 years of Russian invasion the global order, US President Donald Trump has cosied up to his Russian counterpart Vladimir Putin in recent days while berating the embattled Ukrainian President Volodymyr Zelenskyy. After a public spat last week, Trump claimed that Zelenskyy

was "not ready for peace". On February 12, Trump sent shockwaves throughout Europe, declaring that he had spoken to Putin and was ready to begin peace negotiations. The second blow came shortly after when the US Secretary of Defense Pete Hegseth told the Ukraine Defense Contact Group in Brussels to recognise that "returning to Ukraine's pre-2014 borders" was "unrealistic".

Critics argue that with such statements, the US had weakened Ukraine's bargaining position. According to the Institute for the Study of War (ISW), Russia controlled around 20 per cent of Ukrainian territory as of February 21. 2025. These include territories in the south and east, Crimea (which was captured in 2014) and some ground north of Kharkiv.

Ukraine declared independence from the Soviet Union in 1991. It shares its borders with Russia in the east, Belarus in the north, and Poland, Slovakia, Hungary,

As of March 3, 2025, Russia maintained control over southern and eastern Ukrainian territories. The ISW reported "significant fighting in the past 24 hours" near Donetsk, Luhansk, Zaporizhzhia and Kherson. There was also

fighting to the north of Kharkiv, which ISW has termed as "subordinate main effort" on Russia's part.

Ukraine, too, maintained its control over parts of the Kursk Oblast. On February 11, Zelenskyy told The Guardian that they would offer to "swap one territory for another" with Russia. However, he did not know which part of Russian-occupied land could Ukraine ask for in return for parts of Kursk. "All our territories are important, there is no priority," Zelenskyy said.

On Monday, Zelenskyy said that a deal to end the war "is still very, very far away". Trump called it the "worst statement that could have been made by Zelenskyy". "This guy doesn't want there to be Peace as long as he has America's backing," Trump posted on Truth Social.

"America will not put up with it for much longer," he added. Shortly after, the White House announced that the US had halted all military aid to Ukraine to assess if "it is contributing to a solution".

"The President has been clear that he is focused on peace. We need our partners to be committed to that goal as well," an official said. It remains to be seen how the move will impact Ukraine's defence

But even after this, the price of Rial continued to fall and after Bashar al-Assad lost power in Iran-backed Syria in December, its condition has been getting worse day by day. Iran's economy, which is facing sanctions from many countries led by the US, has been facing constant crises. After the US withdrew from the nuclear deal in 2018, this situation has gone from bad to worse.

While re-releasing films may mean much-delayed profits for some filmmakers or just some nostalgia for us as audiences, the larger









Wrestler Sushil Kumar gets bail New Delhi (Agency). The Delhi High Court has granted bail to Olympian wrestler Sushil Kumar. the main accused in the murder case of junior wrestler Sagar Dhankhar. Sushil will have to furnish a bail bond of Rs 50.000 and two sureties of the same amount. Sushil Kumar, along with others, is accused of attacking former junior national wrestling champion Sagar, a resident of Rohtak, Haryana, and his two friends Sonu and Amit Kumar over a property dispute in the parking lot of the Chhatrasal Stadium in the city on May 4, 2021. He has been in judicial custody since June 2, 2021 in this case. He has been granted interim bail to perform the last rites of his father and undergo ligament surgery. Sagar died in the attack by Sushil and his associates. After this incident, Sushil was absconding but was arrested by the police after 18 days. After his arrest, he was also suspended from his railway job. In October 2022, the trial court had framed charges against Sushil Kumar and 17 others, which led to the start of his trial. Charges were framed against Sushil Kumar and other accused under various sections of the Indian Penal Code, including sections related to murder, rioting and criminal conspiracy. ### **BRIEF NEWS Delhi Assembly Speaker** Vijender Gupta said that immediate action will be taken on CAG report and the culprits will be punished

Delhi (Agency): The proceedings of the first session of Delhi Assembly have been completed. Assembly Speaker Vijender Gupta said that this session lasted for 5 days and the proceedings of the House were conducted smoothly every day. During this time, the House worked for a total of 18 hours and 18 minutes and the MLAs expressed their views 126 times. The Assembly Speaker said that the previous government had to struggle a lot regarding the CAG report. He told that we kept knocking every door, went to the High Court as well, but did not get the report. Now when this responsibility has come on our shoulders, we have presented the CAG report. He assured that PAC (Public Accounts Committee) will give its report in three months and the government will not delay in punishing the culprits. He also told that the House has directed all the concerned departments to present the Action Taken Report (ATR) in a month. The Assembly Speaker said, "We will take action against the culprits without even a minute's delay. Vijender Gupta said that in the previous government, rules were disregarded during the proceedings of the Assembly, but now this will not happen. He clarified that the House will run completely according to the rules and the previous wrong traditions will be abolished. He told that LG V.K. Saxena sent a message to the House for the first time, which boosted the morale of the MLAs. But the opposition created a ruckus even on this. The Speaker said that the proceedings of the House will run according to the rules and there will be no compromise in this. He said that the attitude of the opposition is worrying. The opposition created a ruckus during the address, due to which the proceedings of the House had to be disrupted. The House received a total of 280 notices, out of which 42 issues were raised in the House and sent to the concerned departments. Vijender Gupta said that the participation of all the MLAs in the House is necessary. He told that an MLA had violated the rules in the House, for which he had to apologize. The Assembly Speaker said that the government can bring an ordinance if needed keeping in mind the public interest. This session of the Delhi Assembly went on as per the rules and an assurance was given to take action on the CAG report soon. Despite the uproar of the opposition, many important issues were discussed in the House and the government made it clear that strict action will be taken against corruption.

14 departments are lagging behind in getting funds under the joint schemes of the centre and state government

Out of this, Rs 37,652.74 crore was to be received as the share of the Center, while the state government had to spend Rs 17,336.37 crore as the state share.
