18 Naxals gunned down in Chhattisgarh by security forces

Raipur (Agency): Security forces dealt a major blow to Maoist insurgency Chhattisgarh's Bastar region, neutralizing 18 Maoists in a fierce encounter in Sukma district on Saturday. The joint operation, conducted by the District Reserve Guard (DRG) and the Central Reserve Police Force's (CRPF) elite CoBRA unit, took place in the Gogunda hills near Uppamapalli under Kerlapal police station limits. Two DRG personnel sustained minor injuries and are currently receiving medical treatment.

The anti-Maoist operation launched on March 28 following precise intelligence about the movement of armed cadres in the dense forest. As security personnel closed in on a suspected Maoist hideout early Saturday morning, they came under heavy



fire, prompting a prolonged gunfight. In the ensuing exchange, 17 Maoists were killed. Officials estimate that 30-40 insurgents were present, with some managing to escape.

AK 47, SLR, INSAS Rifle along with a large cache of arms and ammunition has been recovered from the encounter site, and verification of the exact quantity is underway.

The encounter marks the second major success for security forces within ten days. On March 20, an operation along the Bijapur-Dantewada border led to the elimination of 30

Maoists. One DRG jawan lost as another crucial step toward his life in that mission, while a achieving this objective. In the substantial stockpile of weapons, including AK-47 rifles and grenades, was seized. The latest operation further consolidates the security forces' control over the region and reinforces the government's intenified efforts to eradicate leftextremism from Chhattisgarh. It is noteworthy that Union Home Minister Amit Shah recently reiterated the government's commitment to wiping out Maoist insurgency. Following the March 20 operation, he stated, "India will be Maoist-free before March 31 next year," underscoring the Centre's dual approach of aggressive counter-insurgency measures and rehabilitation policies for surrendering cadres. The

aftermath of the encounter, additional security reinforcements have been dispatched to the area, and aerial surveillance has been intensified.

Search operations have been expanded within a five-kilometer radius to track down any remaining insurgents. A high alert has been issued across the Bastar division to prevent possible retaliatory Maoist attacks. Forensic teams have been deployed to analyze evidence collected from the encounter site. The crackdown comes just ahead of Prime Minister Narendra Modi's scheduled visit to Chhattisgarh in April, where he is expected to review security measures and highlight the government's development initiatives in Maoist-affected regions.



The PESB has asked the Department of Telecommunications (DoT) to decide a

future course of action for the selection. The candidates who were shortlisted included senior officials from BSNL and DoT. Current BSNL CMD, Robert Jerard Ravi, is expected to continue in his position. Ravi, deputy director general in the telecom department, was initially given the additional charge as CMD of BSNL and Mahanagar Telephone Nigam Limited (MTNL) in July 2024, following the rejection of his predecessor PK Purwar's extension. In January 2025, Ravi's tenure at the position was extended for three more months, until April 14. The PESB had started advertising for the post starting December last year. The development comes as BSNL looks at introducing 4G services in the country. BSNL, struggling with poor infrastructure, has been battered by intense competition from Jio, the wireless arm of Reliance Industries, Bharti Airtel and Vodafone Idea which have rolled out 4G and 5G services at low prices. India's e-retail market overtakes US with \$60 billion size but growth halves in 2024: Here's why



New Delhi (Agency): Even as India has emerged as a key market for e-commerce, with the sector surging to approximately \$60 billion in gross merchandise value (GMV), boasting the world's second-largest online shopper base, growth in this segment last year halved to 10-12 per cent compared to historical growth rates of 20 per cent, according to a report by Flipkart and Bain & Company. The reason? Higher inflation and a stagnation of real wages, as per the report.

However, despite near-term macroeconomic headwinds, the long-term prospects remain strong, the report said. Three key disruptions, quick commerce, trend-first commerce (especially in fashion), and hyper-value commerce, will define the next chapter of growth, it added. India's consumption and discretionary spending have faced headwinds in recent years, with private consumption growth slowing from 11 per cent in the pre-Covid (2017-19) period to around 8 per cent post-Covid (2022–24), the report said.

"This decline is driven by higher inflation and a stagnation of real wages. The stress in consumption is evident in eretail growth in 2024 being 10-12 per cent, compared to historical growth rates of over 20 per cent," it added.

However, the recent fiscal and monetary policy interventions are expected to drive a rebound in e-retail growth, especially from the festive period of 2025, on account of revival in the consumption cycle, the report said. The e-retail market is expected to scale to \$170-190 billion by 2030, growing at over 18 per cent annually. Nearly 1 in 10 retail dollars is projected to be spent on eretail by 2030, fueled by an uptick in discretionary spending as India's GDP per capita crosses the crucial \$3,500-4,000 threshold, a key tipping point observed in eretail spending globally, the report said.

High-frequency categories such as grocery, lifestyle, and general merchandise will drive e-retail growth accounting for two out of every three dollars spent on eretail by 2030. These categories are set to see a two- to four-fold increase in e-retail penetration over this period, per the report. There has also been a change in the online shopping landscape in India. "User adoption is already spreading from Tier-2 to Tier-3 cities, with three in five new shoppers since 2020 coming from cities designated

Parliamentary panel flags issues faced by MSMEs, exporters under GST; suggests easier compliance, fast tracking refunds

Public parliamentary Accounts Committee (PAC) has flagged the issues being faced by Micro, Small and (MSMEs) and exporters under the indirect tax regime of Goods and Services Tax (GST), asking the Ministry of Finance to implement a simplified compliance for framework smaller businesses, to fast track and automate return filing, refund processing that includes reducing the frequency of return filings and a more straightforward online reporting process. In its report presented to Parliament on Wednesday, the Committee also underlined the need for a dedicated fast-track refund processing system exporters, ensuring that input

to exports are prioritised and processed within a specified timeframe. The Committee also pointed out that the existing mechanisms for filing are still inadequate, resulting in prolonged waiting periods for refunds and potential cash challenges flow businesses. The Committee has recommended to the Ministry of Finance to implement a more efficient and transparent refund processing system with clear timelines for processing claims and regular updates to taxpayers on the status of their refunds. Suggesting use of AI tools for data analytics for accurate revenue projections, the Committee said the share of indirect taxes in total revenue receipts declined to 36.92 per cent in FY20 from 38.76 per cent in

observed in subsequent years. The Ministry of Finance in its response to the Committee attributed the decline to macroeconomic factors such as import volumes, global



economic conditions, and changes in tax policy, including reductions in duty rates on imports under free trade agreements. Committee, however, pointed out that the Ministry has not provided a comprehensive strategy to mitigate these influences for a steady growth in indirect tax revenue. "The Committee observed that the Ministry should develop a

proactive strategy that ensures timely assessments of the impact of macroeconomic factors on tax collection and provides an accurate projection of the revenue to be collected, with the help of state of the art data analytics and AI tools," it said. On the issue of multiple registrations required by businesses across states, the Committee raised concerns that the lack of correct procedural validations has led instances of non-

compliance and administrative burdens for businesses. "...these issues not only create confusion for taxpayers but also hinder effective tax administration and the Ministry needs to ensure that taxes due are collected on time. To address this issue, the Committee recommended that the Ministry consider enhancing

the functionality of the GST portal to facilitate easier management of multiple registrations by the same users/companies permissible under Act/Rules, allowing taxpayers to view and manage their registrations in a user-friendly manner," it said.

The parliamentary panel also suggested that regular consultations should be held with industry stakeholders to gather feedback on the challenges faced in managing multiple registrations to enable the Ministry to make informed adjustments to the system as needed. It recommended creating a unique business ID for enabling simultaneous tracking of multiple registrations by the same business entity in different

Dhaka's focus

Bangladesh leader Muhammad Yunus' visit to China this week marks a critical moment in South Asian geopolitics. The interim leader, who came to power after former Prime Minister Sheikh Hasina's forced exit, is signalling a potential shift away from India's traditional influence in Dhaka. China, quick to seize strategic opportunities, is rolling out the red carpet. The stakes are high ~ not just for Bangladesh but for the entire region. China's deepening ties with Bangladesh are not new. It has long been Dhaka's largest trading partner, its biggest arms supplier, and a key infrastructure investor under the Belt and Road Initiative. However, the current political upheaval of f ers Beijing a fresh opening. By positioning itself as Bangladesh's go-to partner, China can further entrench its influence in the Bay of Bengal, a crucial maritime region where India, the US, and Japan have strategic interests. For China, the benefits are twofold. First, a pro-China Bangladeshi leadership could dilute



India's strategic depth in the neighbourhood Secondly, by strengthening security ties, Beijing can gain access to ports and logistical hubs, boosting its represence. gional Bangladesh, with its geostrategic location, is a vital piece in China's Indo-Pacific puzzle. The

Yunus administration's tilt toward China appears to be driven by political and economic considerations. The new leadership, comprising non-Awami League factions, seeks to recalibrate foreign relations after years of India-centric policies under Sheikh Hasina. However, the timing and nature of this shift raise questions about whether it is a pragmatic diversification strategy or a reac - tio nary move to distance itself from India. Bangladesh's economic realities also play a role. With rising infrastructure debts and an urgent need for foreign investments, Dha ka may find China's financial promises attractive.

The Belt and Road Initiative's renewed push and potential security cooperation agreements could offer short-term economic relief. But the long-term implications ~ especially the risk of debt dependence ~ must not be overlooked. Mr Yunus' China visit will likely accelerate regional recalibrations. If Bangladesh formalises security agreements with Beijing, it will trigger concerns in New Delhi. India's historical, cultural, and economic ties with Bangladesh are deep, but geopolitics is driven by realpolitik. A shift in Dhaka's stance could push India to rethink its neighbourhood strategy, strengthening partnerships with Japan, the US, and other Indo-Pacific allies to counterbalance Chi na's inroads. The broader question is whether Bangladesh is truly securing an independent strategic space or merely becoming a pawn in China's expansionist playbook. As Beijing deepens people-to-people exchanges and economic engagements Dhaka's leaders must carefully navigate this newfound proximity. Sovereignty and strategic autonomy must remain paramount, lest Bangladesh find itself in a geopolitical bind from which exit options are limited. For India, the lesson is clear: complacency is not an option. A more proactive and flexible approach is needed to counter balance China's influence in the region. The Dhaka-Beijing equation is evolving, and New Delhi must be prepared to recalibrate its own playbook accordingly.

Lapse Exposed

The accidental inclusion of journalist Jeffrey Goldberg in a high-level online group chat involving top US officials has raised critical concerns about the handling of sensitive national security communications. The chat, set up by National Security Advisor Mike Waltz, reportedly included discussions on military operations and intelligence matters before the US strike on Yemen. While some have brushed it off as a minor technical mistake, the incident exposes deeper vulnerabilities in how the administration safeguards classified conversations. Despite the potential implications, President Donald Trump has downplayed the mishap, calling it a "glitch" and reaffirming his confidence in Mr Waltz. However, this nonchalant response does little to address the real issue: how such a serious oversight occurred in the first place. CIA Director John Ratcliffe and Director of National Intelligence Tulsi Gabbard assured lawmakers during a Senate Intelligence Committee hearing that no classified information was compromised, but their reassurances did not entirely quell concerns. Key senators, particularly Michael Bennet and Jon Ossoff, criticized the incident as symptomatic of poor operational security within the administration. Mr Ossoff went further, calling it an example of "sloppiness" that should never happen at the highest levels of government. Their concerns are justified. While the particular app used offers end-to-end encryption, it is still a commercial platform not specifically designed for handling highly classified government discussions. The very fact that a journalist could inadvertently be included in such a group chat suggests a troubling lack of internal safe guards. This episode also raises broader questions about how modern communication tools are integrated into government operations. The increasing use of encrypted messaging apps by officials may be convenient, but it also brings risks if not properly regulated.

The administration must ask itself whether its current approach to digital security is robust enough or if it is relying too heavily on platforms that are not designed for secure government use. The consequences of such lapses can be severe. Even if no classified information was leaked, the incident serves as a warning. Unauthorised access to sensitive discussions ~ especially those involving national security ~ could have far-reaching implications. The US government must take immediate steps to review and reinforce its communication protocols, ensuring that similar breaches do not happen again. The incident also raises serious concerns about internal security protocols within intelligence agencies. The revelation demands a broader review of cyber-security measures and internal oversight mechanisms to prevent such lapses. This is not just about a single mistake by an official or a minor technical error. It is about the credibility and security of the administration's national defence apparatus. National Security Advisor Mike Waltz may have taken responsibility, but that alone is not enough. A comprehensive review, stricter enforcement of communication protocols, and a shift toward more secure, government-approved platforms are necessary. Anything less would leave the door open for another mistake


Rajasthan's Coaching Centre Bill lets down the very students it claims to protect

devastating history of student suicides in coaching centres, questions have been raised about clauses that were initially proposed and then dropped by the government.

Coaching Centres (Control and Regulation) Bill, 2025, recently tabled in the state assembly has led to much debate and caused valid concern. Intended to rein in the coaching industry and its exploitative practices, the Bill was projected to be a welfare measure for students. However, given devastating history of student suicides in coaching centres, questions have been raised about clauses that were initially proposed and then dropped by the government. These concerned the age limit of 16 years and a mandatory admission test to see if the candidate had the basic knowledge, aptitude and interest required for entrance examinations in medicine. engineering or law.

One recalls the surreal photograph of a "safety net" cast over the open terrace of a coaching centre when, two years ago, a public outcry had led to demands to make the buildings "suicide proof". This Bill seems to be framing and tackling the "problem" through mechanical solutions, uncaring similar complacence. Measures like mandating registration, limiting classes to five hours a day, no tests on Sundays, "remedial" classes for those who lag behind, provisions for counselling, allowing refunds if students leave midway, and penalties for violations may sound reasonable, but can these change the toxic ecosystem of the industry? Is it not unreasonable to assume that a few rules can transform the experience of being trapped in a cut-throat environment to that of flourishing in a nurturing nest? Indeed, it is a cruel gamble, when children know that their families have mortgaged their land and a future, without even knowing if they can or wish to undergo unrelenting drilling required for the NEET or JEE. They are deprived of a friendly environment, where peer support — which is known to help children learn better and deeper, through discussion, explorations and creative curiosity — is missing. Students confess that

regimented confines, where they are advised not to waste time building friendships with those who are competitors. They are burdened with the moral and economic responsibility of not letting their parents' aspirations and investment go down the drain. When they do not qualify in the first go, they feel obliged to work harder the next year, spending still more money. But the coaching and extracting carries knowing well that the students' chances of making it are indeed minuscule. No one shares with the students the probabilities of getting admission to a public university or college for medicine or engineering. Incidentally, after the NEET results fiasco last year, it was publicly discussed how half the NEET seats are in private institutes and are virtually "reserved" for a very small percentage of those who qualify (even with very low marks) and can pay lakhs, or even crores, as fees. Many strongly students had protested about serious test

questions, which do not assess students' understanding but promote test-drilling by a commercialised coaching industry. More worryingly, this ecosystem devalues the process of schooling itself, with no cognisance of performance in schoolleaving examinations. It has also led to a huge shadow industry of "dummy" schools linked to coaching institutes, which are paid to provide false attendance records of young children, for when they later take the board examinations. However, the government continues to push for centralisation — it has mandated the Common University Entrance Test (CUET) for admission to Central and other universities, exacerbates commercialisation, privileges those from schools affiliated with the Central Board of Secondary Education (CBSE), and disadvantages students from state boards. It also disadvantages girls and those without digital devices,

being sent to coaching institutes. They are trained to "crack" (an unfortunately violent goal!) professional entrance tests — with a narrow and early focus on science mathematics. They deprived of learning the humanities, social sciences and the arts, along with other curricular activities. Ironically, in a recent television discussion on the Rajasthan Bill, representative of coaching industry justified it on the grounds of the child's right to be coached! No age limit should be set at 16 years; according to him, younger children with schooling, inadequate parents who are not educated or are busy working, need a coaching institute for board examinations

Social expectations and opinions are shaped by frontpage advertisements and social media narratives, whereby children become pawns in mega gambles, and are made to feel solely responsible for winning or losing the game, with lifelong repercussions. Moreover,

governments are not only supporting the coaching industry and absolving themselves of the duty to ensure the rights of children and their constitutional role providing inclusive education to all. They also accord legitimacy to coaching institutes and draw on their employees, instead of investing in and developing professionally trained teachers. Last year, the Bihar government put out a Request For Proposal for "Empanelment of Professional Educational Institutes for Academic Support" for 9,000 senior secondary schools.

A walk for the cause of water conservation

The initiative of Jal Sahelis or water volunteers in Central India has won widespread appreciation in India. Several of them have received awards for their inspirational work. When last year the Prime Minister also expressed his admiration for these efforts, this further encouraged Jal Sahelis who decided to take up a significant project at a wider level. This initiative has been mobilized by the Parmarth voluntary organization mainly in the

Bundelkhand region, under its director Sanjay

So far, the presence of Jal Sahelis had been seen and admired for village-level initiatives. Perhaps a time had come now for realizing their wider collective strength to strengthen water conservation efforts and programmes. After considerable discussion, senior members of the Parmarth team like Sanjay Singh and Gaurav Pandey came up with the idea of a foot march that would bring together a large number of Jal Sahelis to be together for a number of days, reaching village after village to know about water-related problems there and suggest solutions on the basis of the inspirational work they had been carrying out in their own villages for some years.

This, it was hoped, would also strengthen their own sense of solidarity and empower them in terms of the realization of their unity and co-operation. Bundelkhand region, comprising 14 districts of Uttar Pradesh and Madhya Pradesh, has often been in the news due to water scarcity but at the same time it

should be emphasised that this region has important assets and strengths which if tapped properly can end this scarcity. However the solutions must be based on several specific features of the region and a lot can be learnt from traditional wisdom of conserving water and collecting water, particularly in tanks.

A significant number of such tanks go back about a thousand years to the times of Chandela kings. It has been learnt that the restoration of several of these damaged and depleted water sources provides one of the best ways of meeting the water needs of the Bundelkhand region. Another good option is to revive and rejuvenate several small rivers which used to be the lifeline for many remote villages but have been harmed to the extent of almost vanishing due to over-exploitation, excessive sand-mining, encroachments and other factors. Parmarth is a leading voluntary organization of the region which has worked in cooperation with the gov-

ernment and local communities to improve water conservation in initiatives. In the process information about the local water sources about 100 villages, helping to renovate about 100 tanks, apart from taking up the rejuvenation of six small rivers. An important plank of this work has been the mobilization of Jal Sahelis, recognized by their sky blue dress, who have been involved in important initiatives of river rejuvenation and tank restoration, apart from improv-



ing water supply and sanitation. Once the idea of a march was born, there were several discussions on its planning in the course of which the idea continued to get bigger and finally a foot-march of about 300 km was planned. Finally this march of Jal Sahelis, called a Jal Sarankshan Yatra or water conservation march, took place recently from Orchha to Jaishankar Dhaam, covering about a 300-km distance in five districts - Niwari, Tikamgarh and Chhatarpur in Madhya Pradesh, and Jhansi and Lalitpur in Uttar Pradesh. While about 100 Jal Sahelis covered the entire distance, about 200 joined them for shorter intervals.

In addition many local people including women joined from one village to another or for longer stretches. At various places along the route Jal chaupals or water dialogues were organized in which various aspects of water conservation were discussed. The Jal Sahelis shared about their own work and also learnt about local

was also collected along with suggestions regarding the improvement efforts that were needed.

Such detailed information collected on the basis of interactions with local people can be very useful for improvement or restoration work. What is more, whenever time permitted, some work was also

> taken up for cleaning up or for preventing wastage of water. The response of villagers, including village leaders, panchayat representatives, women and youth, along the route was very encouraging. They made arrangements for food and organized ceremonies for paying their respect to marchers.

> Frequently they showered flower petals on the marchers. All this attracted a lot of attention and support for the cause of water conservation and renovation of traditional water sources and protection of rivers. A big achievement of the march was that in the course of this march nearly 400 more women came forward in the villages covered by the march to enlist themselves as Jal Sahelis of the near future. As the tasks of water conservation have been identified and as future water volunteers have also been identified, it is likely that solutions to water-related problems in these villages will be found soon.

> As a follow-up measure, dialogues with water authorities in the states of Uttar Pradesh and Madhya Pradesh for resolving many of these problems are also being taken up. The morale of the women marchers remained at a high level throughout the march, despite the very tiring schedule. In

the evenings, on most days, a review meeting was also held to resolve any problems seen during the day, or to make further improvements. The director of Parmarth Sanjay Singh and several other members also walked with the marchers almost right through

These marches can be a very good way of taking the message of water conservation to people in remote villages and also to spread inspirational information regarding some of the remarkably successful efforts of villagers and particularly village women in the recent past. These can lead to more such efforts by other people. It is really a remarkable achievement that these women not only contributed voluntary work earlier but in addition have also found the time and the energy to come out for a much longer period, despite many farm and family responsibilities, for a wider social cause. Such efforts should be widely encouraged.

The fire in South Korea's forest is not stopping, 26 dead, 30 burnt

Seoul (Agency). The fire in South Korea's southeastern province North Gyeongsang is getting out of control. Now 26 people have died here while 30 people have been badly burnt. Firefighters are using helicopters. According to government data, the forest fire in the region since last Friday has caused massive destruction and about 36,000 hectares of forest has been burnt to ashes. This fire is affecting about 13,000 hectares more area than the forest fire on the east coast in 2000. 23,794 hectares of forest was burnt in the fire at that time. According to reports, forest officials started sending helicopters, fire engines and firefighters at 6:30 am on Saturday to control the fire in Uiseong County, about 180 km southeast of Seoul. The fire spread quickly due to strong winds. According to weather officials, about 5 mm of rain is expected in North Gyeongsang Province. The fire in the province is estimated to have killed 21 people, of which four died in Andong and eight in Yeongdeok

NATO alliance reversed its own decision, Ukraine suffered a setback

Kiev (Agency). Member countries of the NATO alliance, including European countries, are reportedly withdrawing from their plan, under which military aid was planned to be given to Ukraine. Trump confident on India trade deal, hails Modi as 'very smart' man

Australian Prime Minister Anthony Albanese touted his Labor party's credentials on affordable healthcare on Saturday, the first full day of campaigning for a general election expected to focus on the cost of living. Albanese on Friday called the election for May 3 as his centre-left Labor runs neck-and-neck in opinion polls with the Liberal-National opposition, led by Peter Dutton. Dutton has centered his campaign on a housing crisis, arguing that home ownership is becoming unattainable.

After enjoying a strong lead for much of his term, Albanese's personal approval ratings have now narrowed, bringing him close to Dutton, a former police officer and defense minister in last conservative government. Labor, which pledged an additional A\$8.5 billion (\$5.3 billion) for Medicare in February. emphasizes its commitment to Australia's universal healthcare system as a key point of difference from the Liberal-National coalition. The



opposition, on the other hand, argues it is better suited to manage the economy and border security. "At this election, this little card here, your Medicare card, is what is at stake," Albanese said while campaigning in Brisbane, the capital of Queensland, in Dutton's electorate. Medicare, established by Labor in 1984, provides Australians and some overseas visitors with access to a range of health and hospital services at low or no cost.

Meanwhile, Dutton, also campaigning in Brisbane, stated, "I want to make sure that it's easier, not harder, for Australians, and this election really is about who can manage the economy."

US Securities and Exchange Commission beginning to onboard DOGE staff, email says

Washington (Agency): The US Securities and Exchange Commission is beginning to onboard officials with billionaire Elon Musk's Department of Government Efficiency, according to an email sent on Friday to department staff.

SEC staff were informed that the DOGE task force had contacted the regulator, and that they would be treated as staff for the purposes of network, system and data access. The SEC is establishing a liaison team with the "intent to partner" with DOGE, the email said. The email was first reported by Reuters.

"Our intent will be to partner with the DOGE representatives and cooperate with their request following normal processes for ethics requirements, IT security or system training, and establishing their need to know before granting access restricted systems and data," the staff email stated. spokesperson for the SEC confirmed that it was beginning to onboard DOGE members. A spokesperson for the DOGE task force did not immediately respond to a request for comment. The SEC did not immediately respond



comment on what role, if any, Musk would play at the agency as part of DOGE. Musk did not immediately respond to a request

for comment. As the nation's top markets regulator, the SEC is privy to swaths of nonpublic data from banks, public companies, private funds and others, including confidential information about initial public offerings and supervisory examination records.

DOGE officials were expected to primarily work through the SEC's liaison team, but staff may be contacted directly, the email stated. In those events, staff were told to "respond courteously" and gather information about any DOGE requests, but "please do not provide any substantive information" without first consulting the SEC's liaison

Black Bag movie review: Michael Fassbender,

Cate Blanchett salvage Steven Soderbergh film

As long as you keep your eyes on the film's talented cast, and are in step with its subtle unseriousness, you may be able to forgive

Black Bag's underwhelming ambitions and almost dull action.

Infidelity is a big deal in Black Bag – and that's not the only departure from James Bond in this cloak-and-few-daggers spy movie that is based geographically just a few blocks down from 007.

The other is its stars – not one, but two – Fassbender and Blanchett, lean, immaculate conceptions on whose sharp cheekbones alone one could hang a film. George (Fassbender) and Kathryn (Blanchett) are married to each other and work together in the spy business. It's hard to trust either – and anyone else – as Soderbergh and his frequent collaborator, screenwriter David Koepp, establish early on, during a thrilling dinner where one is not sure whose head will be served

on a platter. Soderbergh is a director with a unique, intimate perspective all his own, particularly when it comes to relationships. Black Bag is no different, even though the film must – as a spy film must – conjure up a world threat. The spy game in this case is about a device called

Severus which, if it fell into the wrong hands, could cause the wrong nuclear

reactor in the wrong country to melt. And so, of course, Severus does get passed around a lot of wrong hands. The intrigue lies in who in the spy business is complicit and how. George is told early on that Kathryn is among the suspects, and he goes on to tell her very, very meaningfully that "I will do anything for you... even kill."

As long as you keep your eyes on Fassbender and Blanchett - not a hard task at all - and the film's talented supporting cast, and are in step with its subtle un-seriousness, you may be able to forgive its underwhelming ambitions and almost dull action. Russia, though, gets its usual beating over the man-who-isnot-named (Putin) who provoked a warthat-is-senseless (Ukraine).

The other actors here include James Bond veterans Pierce Brosnan and Naomie Harris, and Marisa Abela who carries the same unmistakable sexiness and knowing confidence that made her a standout in the series Industry. Tom Burke and Rege Jean Page make up the other members of the spy group who may know "the perfect" George and Kathryn as well as they think they do - or may not.



Holland movie review: Horrid but not horrific, new Nicole Kidman film has little to say about anything

fter breaking out with the horror-thriller Fresh a few years ago - this was the movie in which Daisy Edgar-Jones played a young woman on a blind date with a man who turns out to be a cannibal director Mimi Cave stays firmly in her comfort zone with her sophomore project, this week's Holland. The cast is bigger, as is the budget and the scale. Fresh was mostly restricted to one large house, where the predatory male protagonist would lure his female prey and then, literally feast on them. An entire suburban town serves as Cave's playground this time around; and at least one of its citizens

is a killer of women. Nicole Kidman plays Nancy, a seemingly mild-mannered woman who works at the local school and dotes on her husband, Fred, played by Matthew Macfadyen. The one-time heartthrob — he played Mr Darcy in 2005's Pride & Prejudice adaptation — seems to have been typecast as weaselly villains following his memorable performance as Tom Wambsgans in HBO's Succession. Fred works as an optometrist; he's the sort of guy that everybody seems to be

friendly with, but crucially, not friends with. Nancy becomes suspicious when he starts going on

weekly work trips, often using the flimsiest excuses. It is not clear if Fred has always been like this, but the movie suggests that this is a new hurdle that Nancy has experienced in their marriage. She enlists her work buddy Dave, played by Gael García Bernal, to uncover evidence to support her suspicions. In their attempts to prove Fred's infidelity, Nancy finds herself dabbling in a bit of adultery herself. It is around this stage in the narrative — say, the end of the first act — when you begin to wonder what the movie even wants to say. Fresh was a 'yes all men' movie, the sort that claimed that every man, regardless of their perceived progressiveness, was a creep deep down. You can't really blame it, can you? But when Nancy engages in a full-blown affair with Dave, Holland comes across as a rallying cry for male rights activists.

Although Cave begins to lose control of the story fairly early on, she doesn't seem like the sort of filmmaker who'd follow up her staunchly feminist debut with something that would make Sandeep Reddy Vanga proud. Holland's idea of suburban utopia brings to mind those North Korea travel vlogs that you occasionally come across on YouTube. These videos present a deeply unsettling society where everybody behaves like an NPC, and those that don't have a vaguely threatening smile plastered on their face. They're all maintaining a facade. But so is everybody, Cave seems to be saying.



Delhi (Agency): The accused who had hatched a conspiracy to trap his enemies in the firing case in Sangam Vihar has been arrested by the police along with his two accomplices. The police have recovered a pistol and a bike from them. The main accused had his accomplices fire at his house to trap his enemies. Deputy Commissioner of Police Ankit Chauhan said that the accused have been identified as Dinesh alias Amit, Shahrukh alias Gahiya and Nasir, residents of Sangam Vihar. The Deputy Commissioner of Police said that on March 21, information was received about firing in Sangam Vihar I Block. On this, a police team was sent to the spot. Here the complainant Nasir told the police that two unknown boys came to his house and fired two rounds. They also threatened to kill him and his family and fled. The police registered a case on the basis of the complaint and started investigation. The police searched the footage of CCTV cameras to trace the miscreants. It was found that two youths had come on a bike. The police also found two shells from the spot. In the footage, the faces of both the accused were covered with clothes. Then the police saw the footage from other places. During this, it was found that the accused changed their clothes to escape from the police. The pol traced the number of the bike used in the crime. It was found registered in the name of Nasir. Then the police arrested Dinesh and Shahrukh on the basis of the informer. Both the accused told that the complainant Nasir had fired bullets at his own house to trap his enemies. Earlier, three cases have been registered against Dinesh, one against Shahrukh and two against Nasir. Police interrogation revealed that in April 2024, Nasir's brother Azruddin alias Ajju and his associates Javed, Amit Thakur, Waris, Manish, Arif. Shahrukh and the other side Sohail alias Jisan, Rahul, Irsad and Sahil had a fight. A cross case was registered by both the sides in this. To take revenge for this, Nasir had fired bullets at his own house, so that he could trap his enemies.

Energy Minister Ashish Sood rejected Arvind **Kejriwal's allegations**

Delhi (Agency): The Aam Aadmi Party and the Bharatiya Janata Party government have come face to face over power cuts in Delhi.
