

#### Actor's arrest in gold case sparks BJP-Congress slugfest

**Vatika Times** BENGALURU: Kannada actress Ranya Rao's alleged involvement in the gold smuggling case has triggered a political slugfest in Karnataka with Congress and BJP trading charges of favouritism and cover-up. Harshavardhini Ranya alias Ranya Rao was arrested a week ago for allegedly smuggling gold worth Rs 12 crore from Dubai. While BJP alleged the involvement of an influential minister in shielding the actress. Congress countered the charge by accusing BJP of allotting 12 acres to Rao to set up a TMT steel bar factory. Karnataka minister M B Patil clarified that the land allotment did not materialise as Rao's company failed to make the prescribed payment. In a post on 'X', BJP Karnataka chief B Y Vijayendra said, "Media reports about involvement of a prominent minister in Siddaramaiah's govt in one of the biggest gold heists come as no surprise — especially given this govt's track record of churning out scandals in increasingly "innovative" ways! (sic)" The MLA said the blatant violation of govt proto-

## **Opposition demands discussion** on 'voter list discrepancies'

NEW DELHI: Led by Congress and Trinamool Congress, opposition parties Monday demanded a discussion in Parliament on alleged discrepancies in voter lists, with Rahul Gandhi raising the issue in Lok Sabha.

Bringing up the matter during zero hour. Rahul said several states had found discrepancies in voter lists. 'Voter lists are being questioned across country and the entire opposition has been demanding a discussion on the matter. Questions have been raised by opposition in one voice in every state, including Maharashtra," he said. Congress, however, failed to bring it up in Rajya Sabha when party president Mallikarjun Kharge was not allowed to raise the matter. Later, Kharge posted on X, "The abrupt and unwarranted deletion of voters, presence of duplicate EPIC numbers, and other such integrity of our electoral process require urgent attention and discussion in Parliament." SP, AAP and RJD too said it was an extremely serious matter and Parliament needed to take it up.TMC's Saugata Roy demanded a thorough



revision of voter lists, particularly ahead of assembly elections in Bengal and Assam next year. "There are some serious flaws. This has been pointed out with respect to Maharashtra, which had inflated voter lists. This was pointed out in Haryana. They are now trying to jump into Bengal and Assam where elections are due next year," Roy claimed.Party MP Kalyan Banerjee sought action against EC and said the poll body had "failed" to conduct fair and transparent elections over the past few years. He said the West Bengal CM had already drawn the EC's attention to numerous instances of "duplicate" voter cards.

gathered that Chaitanya is also the recipient of proceeds of crime generated from the liquor scam, wherein the total proceeds of crime are around Rs 2,161 crore, siphoned off through various schemes," ED said.The agency said searches were carried out at Baghel's Bhilai residence since Chaitanya stays with his father and he's suspected to be linked with the alleged liquor scam that ED says caused "massive loss.

#### **Foreigners entering Myanmar** via Mizoram to train rebels: CM

Mizoram CM Lalduhoma AIZAWAL: Foreigners, including those from the US and the UK, are crossing into Myanmar via Mizoram to impart arms training to insurgents there, CM Lalduhoma informed Mizoram assembly on Monday. The CM said while nearly 2,000 foreigners visited Aizawl between June and Dec last year, they were never seen in the streets, alluding to the fears that their main intention had been to

cross into Myanmar to interfere in its internal affairs. Centre has been closely watching the situation in the border areas after China and the US involved themselves in Myanmar conflict. The recent visit of Mizoram by the US ambassador to India without any prior intimation also came as a surprise, he said.

Union home ministry reimposed the protected area regime in Manipur, Nagaland and Mizoram to monitor the movement of foreigners.

#### ED searches in Rajasthan, Noida, Mumbai

NEW DELHI: ED searched 16 locations in Jaipur, Ajmer, Udaipur, Noida and Mumbai on Friday in connection alleged money laundering involving illegal foreign remittances of more than Rs 400 crore. ## **Opposition MP Bob Blackman raises** Jaishankar 'attack' in UK Parliament

**NEW DELHI:** Britain's Opposition Conservative lawmaker Blackman on Thursday raised the issue of the "attack" on External Affairs Minister S Jaishankar in London by "Khalistani thugs" in the House of During a Commons. Business of the House session, the Chair of the Backbench **Business** Committee described the breach security Wednesday evening as an affront to democracy and called on Home Secretary Yvette Cooper to make a statement in Parliament on the issue of safety of Indian visitors to the UK.

#### Muslim literacy, participation of women in workforce up: Rijiju

Monday told Parliament that the literacy rate among Muslims as well as the share of women from the community in the labour force had increased in recent years.In a written reply in Rajya Sabha, minority affairs minister Kiren Rijiju said that Periodic Labour Force Survey data for 2023-24 estimated literacy among Muslims (aged seven years or more) at 79.5%,

although it was lower

than the 80.9%-level for



all religions groups. In Census 2001, the literacy rate among Muslims was pegged at 59.1% as compared to the all-India literacy rate of 64.8%. The literacy rate among Muslims was 68.5% in 2011 as compared to the all-India rate of 73%. "Thus, the

literacy rate among Muslims has increased by 9.4 percentage points in Census 2011 as compared to Census 2001," Rijiju said.

Replying to another question, he pointed to PLFS data on minorities to show that between 2021-22 and 2023-24, the percentage of women workers among Muslims in the labour force reflected a significant increase of over six percentage points from 15% in 2021-22 to 21.4% in 2023-24. In fact, it had dropped to 14.2% in 2022-23.

#### Nancy meets Lama as shows eagerness to engage India on Tibet


**For Tibet** watchers, the past few weeks have been special; one does not know which side to turn one's attention to. Apart from the 'courtesy calls' to the Dalai Lama by some of the candidates during the campaign for the legislative elections, an announcement about renaming some places in Tibet has been making the rounds (this, however, remains irrelevant as nobody has seen the new names yet). More important was the news from Washington that the US Congress has passed the 'Resolve Tibet Act', now waiting for President Joe Biden's signature to become law. Among other things, the Act mentions that the "claims made by officials of the People's Republic of China and the Chinese Communist Party that Tibet has been a part of China since ancient times are historically inaccurate". It has serious implications for India's northern border, which for millennia had been with Tibet; unfortunately, after Tibet's invasion in the early 1950s, it ended up being the Line of Actual Control (LAC) with China. The Act also speaks of Beijing's current policies, which "are systematically suppressing the ability of the Tibetan people to preserve their religion, culture, language, history, way of life, and environment". Since 1959, when the Dalai Lama crossed the Indian border into Arunachal Pradesh (then the North East Frontier Agency), successive governments in Delhi have supported the Dalai Lama and his followers in this regard and ensured that India was their second home. Today, projects such as the Nalanda University in Bihar could further strengthen the relations between Tibet, where the 'Nalanda Tradition' was practiced for centuries, and India. Then, the Act says that Beijing "is failing to meet the expectations of the United States to engage in meaningful dialogue with the Dalai Lama or his representatives or to reach a negotiated resolution that includes the aspirations of the Tibetan people". It is doubtful that concrete progress will be seen in this regard in the near future for the single reason that Beijing is today not in a mood to listen to any 'advice' from the US (or India). Perhaps more meaningful is the following point: "The US public diplomacy efforts should counter disinformation about Tibet from [Beijing], including disinformation about the history of Tibet, the Tibetan people, and Tibetan institutions, including that of the Dalai Lama." Apart from the new law, the visit to India (and Dharamsala) of former United States House Speaker Nancy Pelosi, along with other members of a Congressional delegation and their audience with the Dalai Lama, needs to be looked into as it raises several questions. Why did the US delegation visit Dharamsala just a few days before the Dalai Lama leaves for the US for knee surgery? Could not the delegation have met the religious leader in the US? But perhaps Washington was keen to involve India in the Tibetan issue? That Delhi agreed to this is clear, as the same delegation was received in Delhi by Prime Minister Narendra Modi and External Affairs Minister Jaishankar on its return from Dharamsala. The media missed another visit, which was certainly not a coincidence. Xinhua News Agency reported that on June 18, the day the US delegation arrived in Dharamsala, President Xi Jinping con-ducted an 'investigation' at

# Key concepts in Sanatan Dharma

Sanatan Dharma is 'maya'. Nothing is what it seems. This illusory nature of maya leads us into delusion and prevents us from understanding the true nature of things. In the material world, for instance, that which appears 'spontaneous', 'coincidental', 'unrelated' at first glance might have an underlying connection that eludes the naked eye. Take for example, foreign interference in Indian elections, or the illegitimate intrusion of international lobbies in Indian domestic politics. Foreign interference is a serious issue that compromises the sovereignty and integrity of a nation. Chinese manoeuvring in Australian domestic politics led the bilateral relationship almost to a point of no return. The US Senate formed a high-powered intelligence committee to probe allegations of Russian efforts to influence 2016 presidential elections. Despite a restive debate in India that has led the external affairs minister and even the prime minister to comment on the topic bang in the middle of general elections, it is difficult to pinpoint the nature of the meddling, the source, and the way public discourse is being subtly remodelled to build and suit narratives by influence operations.

There is no fixed template for foreign interference. Given its amorphous nature, it becomes even



more difficult to combat such information warfare in an open society like India that has a democratic political system, a complex, rambunctious polity and a discursive tradition of argumentation and debate. Swirling allegations in India of western interference have always been met with layers of incredulity and plausible deniability.

If we can't pinpoint the players in this murky game of shadows, if we can't access their motives, mitigating the challenges becomes nearly impossible. We often hear about Western 'Deep State' and foreign lobbies that are opposed to the so-called 'Hindu nationalist' regime in India, working to subvert the democratically elected government, or even trying to shape electoral outcomes. What is this 'Deep State'? How does it operate? What is its motive? Is it a signifier for the shapeshifting aggregation of western intelligence agencies, perma-bureaucracy, academia, major foundations, multinational corporates, civil society, political activists, 'human rights' organizations, 'democracy rating' agencies, media outlets and think tanks that further each other's interests and all curiously end up advancing the major goals of American foreign policy, neoliberals and globalists? It all sounds very farfetched and fantastic, and therein lies its effectiveness. Diffusion is an instrument of statecraft. Tracing the source of influence operations led by the Deep State could be a bit like tracing hackers who keep their IPs bouncing around the globe. And if you can't trace it, you have no case. The omnipotence and omniscience of this ambiguous clique of vested interests paint a mayajaal (an illusory network) of narratives in a way that not only pushes and establishes preset western notions/ interpretations, but also make the viewpoints and perspectives seem 'organic' and even indigenous. It also makes targeted action difficult and

open to criticism. If a foreign journalist's visa is not renewed by the Indian govssernment, the focus is likely to be on the controversy. The government will inevitably be painted as a 'thin-skinned bully' and the fact that a foreign national working in India may have wilfully blurred the line between 'journalism' and 'political activism' will be silently glossed over. It'll invite even more charges of 'democratic backsliding' and 'repression', no matter how ill-placed and misleading those charges are. There have been allegations that the major narrative weapons Opposition's armoury, such as 'caste census', in the just concluded general elections where the Narendra Modiled BJP saw an erosion in power, were provided by shadowy figures of this nebulous foreign adversary. In 2019, during the UN Climate Action Summit in New York, leaders from industrialised nations delivered impassioned speeches about the urgency of addressing climate change. Yet, behind closed doors, they continued to approve new fossil fuel projects and delay meaningful climate finance commitments. This dichotomy highlights a fundamental hypocrisy in global climate politics: The West often preaches sustainability but falls short in practice, prioritising economic interests over environmental imperatives. As the countsummit in Azerbaijan this November continues, the Bonn Climate Change Conference in Germany concluded in a stalemate last week. Nations disagreed on the size and scope of loss and damage financing, representing a significant setback in global climate negotiations. The Bonn talks did not achieve meaningful progress on climate financing, underscoring a persistent issue: industrialised nations, which bear the greatest responsibility for the current climate crisis, resisted calls from Global South countries to compensate those who suftributed the least to greenhouse gas emissions. Over a decade ago, developed nations pledged to mobilise \$100 billion annually by 2020 to support climate action in developing countries. Copenhagen Accord in 2009 and reiterated in the Paris Agreement, has not been met. The Organization for Economic Co-operation and Development (OECD) reported that climate finance reached only \$79.6 billion in

## 'Attempting to avoid extradition': Vanuatu PM orders cancellation of Lalit passport

**NEW DELHI: Vanuatu** Prime Minister Jotham Napat on Monday ordered the cancellation of the Vanuatu passport issued to fugitive businessman Lalit Modi after recent media international reports.

"I have instructed the citizenship commission to immediately begin proceedings to cancel Lalit Modi's Vanuatu passport," Napat said. "While all standard background checks, Interpol including screenings, conducted during his application showed no criminal convictions, I have been made aware in the past 24 hours that Interpol twice rejected authorities'



requests to issue an alert notice on Lalit Modi due to lack of substantive judicial evidence. Any such alert would have triggered an automatic rejection of Lalit Modi's citizenship application," he added.

Republic of Vanuatu The Vanuatu PM specified that holding a Vanuatu passport is a privilege, not a right, and that applicants must have legitimate reasons for seeking citizenship.

"None of those reasons legitimate include attempting to avoid extradition, which the recent facts

brought to light clearly indicate was Lalit Modi's intention," he added.

Meanwhile, former IPL chairman has previously submitted an application to surrender his

Indian passport at the Indian Commission in London after acquiring citizenship of the Pacific island nation. The ministry of external affairs stated that his request would be reviewed under "extant rules and procedures."

"We are also given to understand that Lalit Modi has acquired the citizenship of Vanuatu. We continue to pursue the case against him as required under law," an MEA spokesperson had said earlier.

India has repeatedly sought assistance from the UK in extraditing Lalit Modi, who has been facing legal proceedings related to financial irregularities.

#### **CAG-itated politics: How** audit reports upend political fortunes

**NEW DELHI: Political parties and CAG reports** have shared a hot and cold relationship in Indian politics over the decades. Interestingly, the two become quite inseparable when the elections approach. Delhi witnessed this recently when audit report of exorbitant spending on CM's official residence, injected into public consciousness as 'sheeshmahal' scam, was one of the key reasons that helped the Bharatiya Janata Party seal the fate of Aam Aadmi Party.

A simple look at the CAG website and the number of reports released in a year shows a drop by almost half, relatively during poll years, exception being 2014. This indicates how the ruling parties have done their best to keep the report away from the public glare, while the opposition has ensured it puts a spotlight on it. So, while several reports were used to shape the collective consciousness of the public towards parties like the Congress and the AAP, many other reports were carefully brushed under the carpet.

Any discussion on CAG report and politics would perhaps be incomplete without a mention of the 2G scam and the coal block scam that played a key role in the downfall of Manmohan Singh-led UPA government in 2014.

#### The scam that wasn't

The 2G spectrum "scam" that led to the loss of Rs 1.76 lakh crores to the exchequer did not turn out to be a scam after the Supreme Court acquitted everyone. The apex court even pulled up the CBI saying that "the prosecution miserably failed to prove any charge against any of the accused, made in its well choreographed chargesheet."

No matter the verdict, the "scam" did what it was supposed to -- put a final lock on the UPA government's fate -- paving way for the "Modi wave"

'Conscience' shaking scam The coal scam that led to the downfall of UPA government was much talked about. Referring to this, the NDA government last year dubbed it as the scam that "shook the conscience of the nation in 2014", with a loss of Rs 1.86 lakh crore to the exchequer. "These actions were scrutinised by investigation agencies, and in 2014, the Hon'ble Supreme Court of India cancelled the allocation of 204 coal mines/blocks allocated since 1993," the central government said and rightly so. After BJP came to power in 2014, it had introduced a revamped coal auction and allocation system, facilitating the distribution of those 204 coal blocks. However, in doing so, it ignored warnings from its own leaders who said that it would lead to corruptions and scams. An investigation by The Reporters' Collective revealed that the Union government had received early warnings in 2015 that its new coal auction system was vulnerable to corruption. However, no action was taken upon those warnings and the government went ahead with the new coal auction regime.



#### Tata Electronics will build 2 additional Dholera fabs

Delhi: Dholera, India's first semiconductor fab, would start making chips in 2026 with Tata's Rs 91,000-crore plant in cooperation with Taiwan's Powerchip Semiconductor Manufacturing Corporation (PSMC). However, the second and third fab partnerships and timetables are still being determined. Next-generation fabs are planned to start production in five to seven years at the same scale as the first. "The nodes and technology will be decided once the first fab is at full capacity and will depend on the global demand and technology development within the semiconductor industry," a source said. A top government official said the first semiconductor fabrication plant is being built. Dholera Special Investment Region development commenced in March by Tata Electronics. The company is evaluating the installation capacity needed to test equipment and start a pilot production line before commercial manufacturing. A senior official said that since the fab will produce chips at several nodes, certain infrastructure could be created by all three fabs during the initial phase. Thus, while future phases will require enormous investment, it is unlikely to match the multi-billion-dollar first fab. Tata is negotiating with buyers for first-fab chips.

## The Union government wants 100% FDI in insurance

Delhi: The Union Finance Ministry proposed raising the insurance sector's FDI ceiling from 74% to 100% in a consultation paper. The insurance FDI limit was raised from 49% to 74% in February 2021. The government said the proposal to alter insurance legislation will make insurance more affordable, grow the insurance industry, and streamline corporate operations.

An office memorandum dated November 26 proposed lifting the FDI ceiling in Indian insurance businesses from 74% to 100% and



allowing insurers to conduct one or more kinds of insurance business and associated or incidental operations. The suggestion also cut foreign reinsurers' Net Owned Funds from Rs 5,000 crore to Rs 1,000 crore. IRDAI can also set lesser entry capital (Rs 50 crore) for underserved or unserved regions on

a case-by-case basis. The sector regulator is trying to increase capital in this capital-intensive industry. The Chairman of IRDAI suggests that the insurance market requires 50,000 crore yearly to double penetration in the country. Insurance penetration is the ratio of annual premiums issued to GDP.

#### Four flash sales in a day! China, world's second largest economy, hit by deflation - here's why economists are worried

Delhi: Rising prices or inflation is a common headache for economies around the world. But what about falling prices? Believe it or not, a sustained fall in prices, commonly known as deflation, is just as big a concern for governments, as is inflation. And, that's the issue that the world's second largest economy, China, is grappling with! Recent data indicates China's consumer price index declined by 0.7% year-on-year in February, falling short of projections, whilst producer prices decreased by 2.2%, continuing a downward trend since September 2022.

China's expanding industrial capacity has contributed to export growth, yet it is simultaneously creating deflationary pressures domestically. According to a Reuters report, February's consumer price index recorded its steepest decline in 13 months, alongside persistent producer price deflation. This downturn reflects reduced seasonal demand and consumer hesitancy in spending, influenced by employment and income uncertainties Following Beijing's recent pledge to enhance consumption amidst escalating US trade tensions, analysts anticipate continued deflationary pressures in China's economy, the report said. What is deflation and why are economists worried?Deflation occurs when prices of goods and services decrease across the board. During such periods, currency value increases with time. For many years, economists have expressed concerns about deflation. Whilst deflation appears advantageous for consumers, who can buy more with their income over time, the effects of falling prices are not universally beneficial. Economists worry about how price decreases affect different economic sectors. China's deepening deflationary concerns may continue beyond temporary seasonal variations, unless governmental action addresses the surplus production capacity that's affecting price levels.

## Fund-raise for startups touches four-year low

MUMBAI: The size of funds collectively raised by investors for allocating to Indian startups dropped to a four-year-low of \$2.7 billion in 2024 as big players like SoftBank and Tiger Global refrained from making big bets, largely issuing smaller follow-on cheques for portfolio companies and remained cautious on overall deployment of

company statement.

In 2023, investors had raised \$4 billion, about 33% higher, a report by Bain & Company and Indian Venture and Alternate Capital Association (IVCA) showed.

A global tech downturn, which had gripped markets in parts of 2022 and 2023 nudged venture capital (VC) and growth funds to go slow on investments — this basically meant that they could not deploy all the funds raised earlier and are still sitting on sig-



nificant capital, readjusting their new fund targets. Local family offices lead invest-

ment

"Leading VC funds had sizeable fundraises in 2022 and 2023 and deployments were measured in H2 (second half) of 2022 and 2023. Most of the top VCs did not see the need to raise another big fund," Prabhav Kashyap, partner at Bain & Company told. In fact, the number of \$100 million plus funds raised shrunk to four last year from 10 in 2023. VC firm Accel was an outlier though, having closed a \$650 million fund to back local startups. "Fund-raising declined as top investors

(barring Accel) tempered activity....crossover funds remain subdued. Tiger Global maintained its focus on backing existing portfolio companies without making new bets. SoftBank marked its return to Indian startups after an 18month hiatus by exclusively funding existing investments," analysts at Bain said. Tiger Global's last venture capital fund closed in early 2024 and raised \$2.2 billion, short of its initial target of \$6 billion and lower than its previous \$12.7 billion fund raised in 2022. "From a value creation and returns perspective, funds want to focus on topline growth and margin expansion, and not multiple expansion. In India, the valuation multiples are still elevated compared to most other markets despite a correction," said Kashyap.

China retaliated President against Donald Trump's tariffs with an additional 15% tax on key American farm products, including chicken, pork, soybeans and beef. The escalating trade

The Chinese tariffs, announced last week, were a response to Trump's decision to double the levy on Chinese imports to 20% on March 4. By this time, the aircraft was overflying the Atlantic, leaving points in Europe as potential cities to divert to. However, due to restrictions on night operations at most of the European airports, it was decided to back divert Chicago," the statement added. "The decision to divert was taken entirely in the interest of passenger comfort and safety. #### Court rejects Rashid's plea for parole to attend House

The Mughal-era structure shot into national spotlight after four deaths in unrest on Nov 24, 2024 over a survey on a local court's orders.

On Monday, Justice Rohit Ranjan Agarwal directed



that in case there was need for further examining the structure for whitewashing and other related works, ASI was free to send its team there. The court directed UP advocate-general

Kumar Misra to seek a copy of an agreement alleged to been executed between mutawallis (keepers) of Jama Masjid and the state on Jan 19, 1927. The reportedly agreement

defines the roles of various agencies in the upkeep of the structure.

Mosque committee senior advocate SFA Naqvi contended that ASI had not specified clearly that it was opposed to whitewashing along with extra lighting. No painting is required in the inner part of the site, Naqvi

ASI's counsel Manoj Kumar Singh pointed out though there was some flaking on the outer portion of the monument, a final call could only be taken after a proper survey by archaeologists and experts. Even so, there is no need for whitewashing, Singh argued. The HC then pointed out that this position was not clearly spelt out in ASI's affidavits.

"Joint outreach by financial advisors to ACT and 7&i to potential buyers has begun," the parent firm said in a statement. The company, which has fully owned 7-Eleven,



the world's largest convenience store brand, since 2005, is now taking steps to determine if a deal could be structured in a way that satisfies regulators.ACT has agreed to work with Seven & i to outline a divestiture plan, which includes defining the operational, management, and financial aspects of the stores that could be sold, as well as identifying potential buyers.

"This would provide some insight into the prospects of success along terms that had a reasonable likelihood of satisfying US antitrust regulators," the company added.Seven & i believes these discussions will help determine whether a "credible and actionable remedy and divestiture package can be achieved

that would allow a realistic assessment of ACT's proposal."Earlier, the company announced a major share buyback and plans to list its US unit on the stock market, another development in an ongoing procedure that began last year when it rejected ACT's initial \$40 billion buyout offer.

Seven & i dismissed the bid in September, arguing that it undervalued the business majorly and would likely face regulatory obstacles. If the deal were to go ahead, it would mark the biggestever foreign takeover of a Japanese firm, bringing together the 7-Eleven and Circle K brands to create a global convenience store giant.

#### 12 years after life term, SC acquits Tamil Nadu man of burning wife to death

**NEW DELHI:** Twelve years after being convicted and sentenced to life imprisonment for allegedly burning his wife to death in Tamil Nadu, apex court has acquitted the man after noting that there was inconsistency in dying declarations of the deceased and also there was no other evidence to prove his culpability.

A bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said that conviction could not happen if there were major contradictions in the dying declaration of the deceased and there was no other substantial evidence against the accused. "If a dying declaration is surrounded by doubt or there are inconsistent dying declarations by the deceased, then courts must look for corroborative evidence to find out which dying declaration is to be believed. This will depend upon the facts of the case and courts are required to act cautiously in such cases. The matter at hand is one such case. In the present case, the deceased had given two statements which are totally different from her subsequent statements including the statement made before judicial magistrate, which has been considered a dying declaration based on which the appellant has been convicted," the bench said. In this case, the deceased, in her first statement did not blame her husband and said she caught fire while cooking but later on told the magistrate that her husband had poured kerosene on her and set her on fire. After examining statements of other witnesses including the doctors who examined her, the court said there was no smell of kerosene emanating from her body.
