JAMMU: Lawmakers in J&K pressed for a CBI probe into the unexplained deaths of 17 villagers at Budhal in division's Jammu Rajouri district, after lab tests revealed traces of multiple toxins in their bodies and food samples.During question hour in the assembly, Budhal MLA Javed Iqbal Choudhary alleged that the deaths were part of a larger conspiracy to destabilise the region. "Different toxins have been found in the samples. It seems they were poisoned with a truckload of toxins," he said. The deaths were reported between last year and Jan 19. Villagers linked the fatalities to a wedding feast on Dec 2. Since then, Budhal has faced a string of funerals, with the deceased belonging.

# IAS, corporates, nor the media benefit from economic deceleration

## Query regarding flying "cattle class" to Kerala

Power is in the words. Language has mystical powers. I enjoy playing with words. Those words are hot. You can be moved to tears by words. You can find humor in words. Moreover, there are few things that can convey the planet and all its inhabitants as vividly and comprehensively as words. During the 2009 austerity drive of the Congress-led UPA administration, Tharoor was embroiled in controversy for his response to a query regarding flying "cattle class" to Kerala. His statement, "Absolutely, in cattle class out of solidarity with all our holy cows!" caused a political storm following his response. Tharoor, an accomplished writer of numerous best-selling books on Indian society and politics, was forced to clarify that he did not want to offend economy class passengers after the Congress party swiftly censured him. After 16 years, Tharoor is now again in trouble for comments he made in an interview. In response to a Malayalam report that he had claimed, "We have many leaders, but many feel that there are no ordinary workers," Tharoor clarified that he had really said, "several workers feel there is an absence of a leader in Kerala's Congress." "You should not think that I have no option to spend my time. I have options," Tharoor added earlier in the interview. I have speeches, books, and invitations to speak all around the globe. Some saw his comments as a covert signal to the highest levels of Congress that he was thinking about other political paths. Amidst the upcoming Assembly elections in the state next year, Tharoor is now facing accusations of "crossing the line" from the top leaders of the Congress's faction-ridden Kerala unit, putting him in the center of a maelstrom. Because of this, Shashi Tharoor has been named this week's ThePrint Newsmaker. Actually, Tharoor's essay praising the new industrial policies of the Left-led Kerala government had already been a hot topic before the interview controversy erupted. Tharoor had stated that, during the course of 18 months last year, Kerala's startup ecosystem was valued at an astounding \$1.7 billion, which is five times higher than the worldwide average for the same time period. While the fact that this change has started happening under an LDF government run by communists is shocking, it is not totally unexpected. "The path to growth and prosperity for their people lies in capitalism, entrepreneurship, and initiative, not in red flags, strikes, and agitations," he said in the post, comparing the Communists in Kerala to their West Bengali counterparts at the turn of the century. While he disagrees that the state's industrial climate has changed generally, Tharoor defended himself by saying that "when something good emerges, even if only in one area, it is petty not to acknowledge it" in response to attacks from Kerala Congress officials over the piece. Tharoor, a former UN diplomat, has had a tumultuous political career with the Congress since his 2009 victory in the Lok Sabha elections from the Thiruvananthapuram constituency. Mostly because he had a habit of saying things that went against the party line. However, he consistently gets himself into problems by more than simply his words. In 2009, as the UPA was implementing its austerity measures, Tharoor and then-External Affairs Minister SM Krishna came under fire from the government for allegedly residing in a five-star hotel in Delhi while their official quarters were still being prepared. Tharoor lost his position in the Manmohan Singh government's council of ministers in 2010 due to the scandal surrounding the sweat equity provided to Sunanda Pushkar, his then-girlfriend and later-wife, by a consortium that owned the Kochi club of the Indian Premier League. His ordination as a junior minister was renewed in 2012. Tharoor was thrust into his gravest professional crisis in January 2014, when Pushkar was discovered dead in a luxurious Delhi

Taking a cue from Viceroy George Curzon, pro-establishment all papers-from the Civil and Military Gazette of Lahore to The Pioneer of Lucknow, The Statesman of Calcutta (now Kolkata), and The Times of India of Bombay (now Mumbai)-concurred that Tsarist Russia posed a real threat to the jewel in Britain's crown. A hundred and twenty years later, histo-



hue and cry about the Deep State similar to the Great Game? Whether or not it exists, whether it operates in all countries, and whether the 'deep state' of one country is connected with others through the dark web or entrenched corporate interests remains unclear, as the discourse is more ideological than empirical. Sometimes, those who claim to be part of the deep state ascribe to themselves a larger-than-life role in state affairs-for example, AS Dulat and Asad Durrani in their 2018 book The Spy Chronicles: RAW, ISI and the Illusion of Peace. Their claim to be arbiters of one of the most tense and difficult relationships in the region has been widely critiqued by reviewers. The term first gained wide currency in the context of Türkiye as derin devlet, which literally translates to "deep state" in English. In Türkiye, it refers to a non-elected military elite dominating elected governments, especially when they attempt to dismantle the secular foundations of the Republic, established by Mustafa Kemal Pasha after the abolition of the caliphate in 1923. In Pakistan, "deep state" refers to a government controlled by powerful military leaders, as documented by Stephen Cohen in similar scenario, with Left

The Idea of Pakistan and Ishtiaq Ahmed in Pakistan: The Garrison State. Elected governments in Pakistan have rarely exercised real control over defense and foreign policy.In the US, Democrats and Republicans accuse each other of controlling the 'deep state.' Democrats claim the pro-Republican arms lobby and military-industrial complex constitute the deep state, while Republicans argue that Ivy League universities promote 'wokeism' and diversity, equity, and inclusion narratives that, according to Donald Trump, undermine America's greatness. Trump has accused the deep state within the Democratic regime of election interference, citing the Freedom Medal awarded to George Soros as evidence. However, skeptics argue that if the deep state were so powerful, how could Daksh Patel dismantle it simply by firing 'interns and associates' whose tenure is co-terminus with that of President Biden? Ultimately, the deep state serves as a convenient scapegoat for anything that goes wrong or for political parties losing popular support.If Republicans and Democrats are battling it out in Washington, India faces a

liberals and Right nationalists accusing each other of leveraging the 'deep state' to gain or retain power. Publications like The Caravan and Organiser Weekly lead these respective narratives. Left liberals claim the RSS is India's deep state, while Right nationalists accuse the Ford Foundation and George Open Society Soros' Foundations of attempting to discredit the democratically elected Modi government. Left liberals find support in the speeches of Leader of Opposition Rahul Gandhi, while Right nationalists, led by Vice President Dhankhar, minister Kiren Rijiju, and BJP spokespersons like Sambit Patra, vehemently counter these claims.In a pre-budget article for The Indian Express, economist Surjit Bhalla, a former member of the PM's Economic Advisory Council, alleged that India's deep state comprises "major industrialists, senior IAS babus, and their friendly influencers in the media", slowing down economic growth. This claim was firmly repudiated, point by point, by Vivek Kaul in Newslaundry, who questioned the logic behind such allegations. Kaul argued that neither the IAS, corporates, nor the media benefit from econom-

ic deceleration. Instead, he pointed out that the real cause of economic slowdown is the compulsion of all parties—BJP, political Congress, and AAP—to allocate budgetary resources to freebies rather than longterm investments in social and physical infrastructure, which are crucial for sustained economic growth.Journalist Josy Joseph, in his book The Silent denied by the US Embassy.

Coup: A History of India's Deep State, argues that the deep state is actually led by the IPS. He claims that in the name of combating terrorism in Punjab, Jammu and Kashmir, and the Northeast, as well as 'Left-wing extremism' (LWE) in Chhattisgarh, Maharashtra, Jharkhand, and Andhra Pradesh, the triumvirate of the NIA, CBI, and ED have consolidated unchecked power, with neither the legislature nor the judiciary exercising adequate oversight. A completely contrarian view is presented by Sandhya Ravishankar, news editor at NDTV Profit. She argues that global NGOs and foreign funding agencies have attempted to damage India's international reputation by supporting anti-CAA protests and farmers' agitations against the farm laws. Quoting the French publication Mediapart, she alleges that the Organized Crime and Corruption Reporting Project (OCCRP) received \$47 million from the US Deep State to produce investigative reports targeting governments opposed by Washington—a charge firmly

## 'Peacemaker' US President Donald Trump unleashes trade war

Washington:

Americans are bracing to cough up higher prices for food, cars, electronics, home appliances, toys, and footwear among a host of other products after US President Donald Trump, while presenting himself as a peacemaker between Russia and Ukraine, plunged the country into a trade war, with punitive tariffs on imports from its three largest trading partners China, Canada, and Mexico.All three countries retaliated hours after Trump pressed ahead on Tuesday midnight with the 20 to 25 per cent tariffs that he had previously announced, ostensibly to staunch the flow of the opioid fentanyl that is killing thousands of Americans each year, but also to level the playing field in trade that the US President has complained is lop-

sided.Washington has racked up a record trade deficit of \$1.2 trillion, importing for consumptionits addicted people more than it exports to the world. Trump wants major trading partners to either buy more American goods and products or return to the US the manufacturing mojo it has lost over the years. India, a relatively minor US trading partner, has so far escaped being singled out for additional tariffs although Trump has said the US would impose reciprocal duty on every country. 

Delhi: Gaming zones, nighttime entertainment, water leisure, and retail will replace turbines, coal conveyor belts, and soot-lined chimneys. Delhi Development Authority will turn the Rajghat thermal power station, which closed years ago, into a unique recreational destination. The agency is employing an expert to turn the power plant's ruins into an entertainment hotspot in a public-private collaboration. Besides a 5D museum of thermal power plant operations, the new complex will contain shops, food and beverage, gaming, nightlife, children's activities, and water-based amusement. ## 'EC covering up voter list fraud': TMC's fresh charge

NEW **DELHI: Trinamool Congress** (TMC) leader Saket Gokhale on Tuesday countered the Commission of India (ECI)'s claims, accusing the poll body of "covering up" the alleged voter list fraud instead of accepting it.

The TMC leader, in point-bypoint rebuttal to the ECI, voiced concern over duplication of Voter IDs, or EPIC. The EPIC (Electors Photo



Identity Card) number is a unique identification number assigned to every registered voter in India by the ECI. It is printed on the Voter ID card and serves as proof of identity during elections. Gokhle, in a post on X, questioned the ECI's claim that EPIC with the same numbers were issued to multiple voters due to certain states using the same alphanumeric series. Citing the poll body's handbook, the TMC leader said Functional Unique Serial Number (FUSN) are different for every assembly constituency and that it

was impossible for voters in two different constituencies, even in the same state, to have the same first three letters in their EPIC.

"EPIC card numbers are an alphanumeric sequence of 3 letters & 7 digits. The ECI handbook CLEARLY states that the 3 letters, known as a Functional Unique Serial Number (FUSN) are different for EVERY Assembly constituency. Therefore, it is IMPOSSIBLE for voters in 2 different assembly constituencies (even in the same state) to have the SAME first 3 letters on their EPIC.



### Manufacturing activity slows to a 14month low in February

NEW DELHI: Activity in the country's manufacturing sector grew at its slowest pace in 14 months as production and new orders moderated but it still remained robust, a survey showed . The HSBC India Manufacturing Purchasing Managers' Index (PMI) registered a reading of 56.3 in Feb, down from 57.7 in Jan, but still indicative of further improvement in the health of the sector. The 50-point mark separates from contraction in the survey, which is compiled from responses to questionnaires sent to 400 manufacturing firms.

#### NGT requests DPCC report after plea says unlawful dyeing units continue.

Delhi: The applicant, an environmental activist, told the National Green Tribunal that more illegal dyeing facilities were operating in Khyala and Meethapur village in Delhi after the authorities alerted them of their actions. The tribunal ordered the Delhi Pollution Control Committee to act and report in four weeks.
