

26 killed, over a dozen injured after terrorists attack tourists

Pahalgam/New Delhi, (HS): Terrorists opened fire on a popular meadow near Pahalgam in Kashmir on Tuesday afternoon, killing 26 people, mostly tourists, and injuring over a dozen, in the deadliest attack in the region since the 2019 Pulwama strike. Among the victims is Manjunath, a realestate businessman from Shivamogga, who had gone to Kashmir to celebrate his son scoring 96% in the PUC-II exams. MP BY Raghavendra, quoting Manjunath's wife Pallavi, said the terrorists had opened fire after asking him which community he belonged to.

Another of the deceased has been identified as a man from Balasore, Odisha, who worked at CIPET. A third victim was an Intelligence Bureau official from Telangana. The victims also included two foreign nationals and two local residents, according to a senior official, who did not provide further details. The toll is still being ascertained, Jammu and Kashmir Chief Minister Omar Abdullah said while describing the terror attack as "much larger than anything we've seen directed at civilians in recent years." The incident happened in



Pahalgam's Baisaran valley at around 2.30 pm. The Baisaran valley is a famous tourist spot, popularly known as 'mini Switzerland' because of its long lush green meadows. A purported video of the attack site emerged showing several people bleeding and lying motionless on the ground while women tourists were wailing and frantically looking for their near and dear ones. "My husband was shot in the head while seven others were also injured in the attack," a

as saying. The woman did not identify herself but pleaded for help in evacuating the injured to the hospital. Security forces and medical teams rushed to the spot immediately after the incident.

Hours after the attack. Prime Minister Narendra Modi, who is currenty in Jeddah, Saudi Arabia, reportedly spoke to Union Home Minister Amit Shah and asked him to visit the site. PM Modi also condemned the attack and stressed that the BJP-led Centre's "resolve to fight terrorism is woman survivor was quoted by unshakable." "I strongly condemn

However, the local police have no information about Satpathy's wife and 11year-old son, who accompanied him on the trip. The body of Prasant Satpathy is with the police in Jammu. After the terror attack, Anantnag police issued a helpline number and established a 24/7 help desk. The police control room in Anantnag has been set up to assist tourists requiring assistance or

IMD issues severe heat wave warning for Odisha district for five days

Bhubaneswar, (DMC) : Severe heatwave has gripped several parts of Odisha, with Jharsuguda breaking its all-time record for April with a scorching temperature of 46.2 degrees Celsius. This record-breaking temperature surpasses the previous high of 46.1°C recorded on April 20, 2010, since 1953.

Other districts in Odisha have also reported high temperatures, with Hirakud recording 44.7°C, Sambalpur 44.6°C, Rourkela 42.8°C, Kendujhar 39.9°C, Chandbali 38.7°C, Bhubaneswar 36.7°C, and Baleswar 35.5°C. The heatwave conditions are expected to continue, with the weather department closely monitoring the situation. The Meteorological Centre, Bhubaneswar had predicted that maximum day



temprature is likely to rise by 2-4 degrees C during next three days. Maximum temperature is likely to hover above 43 degrees C in Angul, Jharsuguda, Sambalpur, Sundergarh, and Kalahandi, Bolangir, Sonepur, Boudh, Bargarh, Nuapada district. Day-1 (22nd April 2025):



Hindus in Bangladesh

Ever since Sheikh Hasina was overthrown in Dhaka, India has raised its concerns with Bangladesh about the safety of minorities in that country. Hasina fled to India on the evening of August 5 last year, and the following day, in an all-party meeting, External Affairs Minister S Jaishankar flagged the issue. Delhi has continued to express concern over instability in Bangladesh, and in particular, the toll it takes on the safety of minorities. During a recent meeting on the sidelines of BIMSTEC, Prime Minister Narendra Modi urged the Chief Advisor to the interim government, Muhammad Yunus, to ensure that the state addresses the issue with urgency. Despite assurances, however, Dhaka has been prone to dismissing the incidents of the Hindu minority being targeted as isolated manifestations of public anger against the previous regime. Following the kidnapping and killing of Bhabesh Chandra Roy, a prominent leader, however, the Yunus government cannot continue to be in denial. Minister of State for External Affairs Kirti Vardhan Singh told Parliament in February, "Since August, reports have cited the deaths of 23 Hindus and 152 incidents of attacks on Hindu temples in Bangladesh." The interim government must acknowledge the insecurity faced by Bangladeshi Hindus and take immediate steps to ensure their safety. A culture of impunity will only exacerbate the situation and also contribute to tensions between Dhaka and Delhi.

India has been a friend to Bangladesh since the Liberation War of 1971. However, the interim government's foreign policy has sent mixed signals. Yunus' recent visit to China, during which he made a provocative statement about India's Northeast region, and the high-level diplomacy over the weekend between Bangladesh and Pakistan, signal Dhaka's attempts to align with Delhi's regional rivals. Despite Bangladesh's demand for reparations and a public apology from Pakistan for the atrocities committed by the Yahya Khan regime during the 1971 Liberation War, both countries appear to be on the path towards rapprochement - a significant reversal of Hasina's foreign policy. Bangladesh must recognise Dhaka's longterm interests are better served if it acknowledges the regional realities and understands what Delhi can offer: A stable economic and defence partnership. In turn, India should remain resolute in its demands for the protection of minorities in Bangladesh, while keeping the door open for talks with the interim government on issues ranging from border security to trade, connectivity and counter-terrorism. Delhi must also broaden its outreach. Given Bangladesh's uncertain domestic situation and the impending elections, Delhi must engage a broader swathe of forces and institutions in the country to better understand its changing domestic dynamics and guard against any nasty surprises ahead.

Economic Diary

Crime is coexisting with human being since time immemorial. Chanakya listed assault, rape, homicide, state corruption, animal cruelty and deforestation as crime and he prescribed an elaborate system for administration of justice. He prescribed civil law and criminal law to deal with cases appropriately. As per Chanakya, severe punishment becomes repulsive to the people; while mild punishment becomes contemptible, but right punishment is respectable. In the modern era, crime has been converted in to a sophisticated industry and the state machinery has to spend a huge amount of money and resources to control crime giving rising to the issue of economics of crime.

Globally, organized crime is a multi trillion dollar industry. An organisation named Global Financial Integrity published in its report in 2017 that the value of transactional crimes is about USD 1.6-2.2 trillion per annum. This includes trafficking in drugs, arms, human trafficking, human organs, counterfeiting, illegal wildlife crime, illegal mining and crude oil theft. Some of the major crimes for which values had been assigned by them were counterfeiting (USD 1 trillion), drug trafficking (USD 500 bn) and human trafficking (USD 150 bn). But all crimes do not have economic values: some are committed for vengeance, prestige

beyond the permissible speed limit etc. Some crimes are committed for ideological reasons or under peer pressure or social conditioning. Experts believe that in case of economic crimes, a criminal decides to commit a crime if the expected benefits from committing a crime exceed the expected costs or the crime is essential for a livelihood. The costs of crime depend on the crime and individual committing the crime. The costs normally include direct material costs such as the cost of the instruments like gun, bullet, psychic costs (feel of guilt), opportunity costs, legal cost to fight a legal battle and expected punishment costs. One important item of cost of crime is the opportunity cost of time at the disposal of the criminal or the usage of the equipment. A person will evaluate whether by using his vehicle for legal transport or for illegal transport he is earning more and if the chances of getting caught are less, he may indulge in transporting illegal or banned goods to earn more. Many a times the person committing a crime is not able to calculate the cost and benefits with reasonable degree of accuracy, but goes by the numbers given by a close associate or a partner in crime. Shop lifting is a common crime

in many countries including advanced countries. Experts believe that some rich individuals commit the crime for thrill and others do it to get an economic benefit. It has been seen that as the economy weakens and passes through a lean phase, the shop owners employ less employees to supervise which increases scope for shoplifting. Shoplifters are reported to be taking everything from electronic items and baby foods to designer clothing. While shoplifters are normally arrested, most often, shoplifters are banned from stores

rather than arrested. Most of the incidence of shoplifting is done by first time offenders who take the decision in a moment without putting much thought to the consequences. Some of the organized crime gangs also do shop lifting and sell the stolen goods over internet. In USA, it is reported that more than \$35 million in merchandise is stolen each day and about one in 11 people in America have shoplifted, according to a nonprofit organisation called National Association for Shoplifting Prevention. "Repeat offenders are found to be doing it because of drug addiction," said an assistant district attorney who has the experience of handling the shoplifting cases for 13 years. Security experts in USA also found that some regular fraudsters pretending as shoppers paste fraudulent bar codes prepared by them at home over the existing bar codes on goods in the store and check out with a lower price tag. Crime rates are influenced by several factors like poverty, unemployment and law enforcement strictness. While criminologist believe that bad economic condition results in increase in crime, economists believe that crime rate increases when economy is in upswing as a economy of a country. High crime growing economy opens up many rates compel the authorities to avenues of crime including

smuggling and property crime. These approaches look appealing but empirical studies have shown that GDP growth rate has no relationship with the crime rate in a country. Similarly while punishment is considered as a deterrent to crime rate in a country, in practice it is not visible. Countries like Venezuela, Papua New Guinea and South Africa have high rates of crime due to prevailing corruption in the country, economic and social challenges faced by the people. Low crime rates in countries like Switzerland and Japan are attributed to effective law enforcement and restriction on usage of gun. Overall crime rate in a country is measured by a Crime Index. While several organisations have published country wise crime index, one of the popular indices is prepared by taking the total number of reported crimes per one lakh population. The recent report puts Venezuela at the top of the list with maximum crimes and UAE with least crimes. India is placed at 81 in the list out of 147 countries. A large chunk of the people committing crime are young persons. A study in USA found that 72% of the people arrested were between 13-34 years age. Crimes has a cost to the

spend more money on prevention of crime. Citizens and organisations also spend more money in creating electric fencing, installing CCTV, appointing security guard and using hi-tech vans with police security for movement of treasure. Organisations spend money in creating more digital fire walls and appointing IT experts to prevent cyber crime. In South Africa, electric fencing around households is very common and a normal single household spends around USD 5000 on installation of electric fencing. According to available data, the world spends an estimated \$1 trillion or more annually for preventing crime, with a significant portion dedicated to cyber security measures alone, as cybercrime is projected to cost the world up to \$10.5 trillion annually by 2025. Cybercrime is emerging as one of the major crimes in the recent era which is a challenge to the authorities to control and punish the culprits. In future the financial value of cyber crime will surpass all other crimes and authorities will be forced to spend more to control this. Efforts to combat money laundering and other financial crimes also contribute significantly to the overall cost of crime prevention.


In addition to measures for prevention of crime, countries spend substantial amounts of money on criminal justice system. As per available data, the world spends an estimated \$360 billion on the criminal justice system, which includes expenditure on public policing, courts, prosecution, and prisons. Prison population indicates the effectiveness of the police and justice system or the degree of criminality in the society. US has the largest number of people in prison. In 2022 US had 1.8 million people in prison, followed by China at 1.69 million, Brazil at 0.85 million and India at 0.57 million.

By the late 1960s, the synchronized system had eroded, resulting in staggered elections that have since characterized India's electoral landscape. The rekindled interest in ONOE seeks to restore this synchronization, drawing on historical precedent while addressing contemporary challenges. Simultaneous elections could significantly reduce the financial burden of conducting elections. The cost of Lok Sabha elections has escalated from Rs 10.5 crore in 1951-52 to Rs 50,000 crore in 2019, reflecting the growing scale and complexity of the electoral process. By consolidating elections, resources such as security personnel, polling staff, and election materials could be optimized, lowering operational costs for the Election Commission of India (ECI). Additionally, the ECI's seizure of Rs 10,000 crore during the 18th Lok Sabha elections highlights the potential to curb the influx of black money through fewer election cycles. Frequent elections often lead to "policy paralysis" due to enforcing the Model Code of Conduct, which restricts major policy decisions during election periods. ONOE would reduce these interruptions, allowing governments to focus on long-term policy implementation rather than short-term electoral strategies. This continuity could also alleviate resource strain, minimize constant campaigning, and reduce corruption associated with electoral funding. Staggered elections disrupt public life, with educational institutions frequently requisitioned as polling stations and teachers diverted to election duties. Simultaneous elections would minimize these disruptions, enabling schools and government officials to focus on their primary responsibilities.

prioritize governance over election the premature dissolution of state governments. This could result in prolonged periods of President's Rule, leading to governance gaps and inadequate representation. Frequent elections ensure accountability by offering regular avenues for voters to express dissatisfaction; under ONOE, less frequent polls may lead to complacency among elected representatives. The Election Commission of India (ECI) would face immense logistical pressure to ensure free and fair elections nationwide, and any failure could undermine democratic credibility. The Kovind Committee proposed phased implementation of ONOE, beginning with synchronizing Lok Sabha and State Assembly elections, followed by local body elections within 100 days. This would require two constitutional amendment bills, introducing provisions like Articles 82A and 324A and a Single Electoral Roll through Article 325(2). Despite the Parliamentary Standing Committee (2015) and the Law Commission (2018) supporting ONOE, they emphasized constitutional, financial, and administrative challenges. A phased rollout with pilot programs, extensive consultations with stakeholders, and legal clarity is crucial. Strengthening the ECI, safeguarding regional representation, and public awareness campaigns are essential. Lessons from global practices and investment in infrastructure and training can the ensure effective implementation of ONOE while upholding India's federal and democratic ethos.

Around the world, there are many other dates on which World Book Day takes place. The UK, Sweden, and Ireland all celebrate World Book Day on different dates.

 $\mathbf{T}_{ ext{he concept of "One}}$ Nation, One Election" (ONOE) has re-emerged as a significant proposal in India's political discourse following the approval of a proposal for simultaneous elections nationwide and the submission of a report by a highlevel committee chaired by former President Ram Nath Kovind. This initiative aims to synchronize elections for the Lok Sabha, State Assemblies, and local bodies to enhance governance efficiency, reduce costs, and promote stability. However, the proposal has sparked intense debate, with critics raising concerns about its impact on federalism, regional representation, and logistical feasibility. This essay explores the historical context, advantages, challenges, committee recommendations, and the way forward for ONOE, providing a balanced perspective on its implications for India's democracy.

India conducted synchronized elections from 1951 to 1967, with Lok Sabha and most State Assembly elections held simultaneously. This practice ensured a cohesive electoral cycle, minimizing disruptions to governance. However, political instability, premature dissolutions of assemblies, and

This could enhance administrative efficiency and improve service delivery.

Supporters argue that simultaneous elections could combat "election fatigue," potentially increasing voter turnout. Concentrating electoral events may motivate voters to participate, enhancing democratic engagement.Concentrated campaign efforts could benefit political parties, particularly smaller ones, by levelling the playing field against larger parties with greater resources. Streamlined campaigns could also reduce the pressure on businesses for political donations, fostering a more transparent electoral process. The Kovind Committee report projects that simultaneous elections could boost India's real GDP growth by 1.5% in the following polls compared to the previous year. Additionally, a 1.28% increase in fiscal deficit and a 17.67% rise in public spending could stimulate economic activity. Fewer elections might also reduce the circulation of black money, further stabilizing the economy. The concentrated nature of simultaneous elections could facilitate better monitoring by the ECI, ensuring greater transparency. By reducing governance downtime and freeing up security resources, ONOE could enhance administrative efficiency, allowing officials to

overshadowing local issues, as national narratives may dominate electoral discourse. This could marginalize regional parties, which often champion statespecific concerns, favouring national parties with more significant resources. Smaller parties may struggle to compete, potentially reducing political diversity and undermining India's federal structure. Simultaneous voting could confuse less informed or first-time voters, leading to uninformed choices and invalid votes, weakening democratic outcomes. Organizing simultaneous elections across India's diverse regions would strain the ECI and security forces immensely. The Parliamentary Standing Committee (2015) estimated that Rs 9,284.15 crore would be required to procure additional Electronic Voting Machines (EVMs) and Voter Verifiable Paper Audit Trail (VVPAT) machines. Logistical challenges, such as coordinating personnel and ensuring accessibility in remote areas, could compromise the integrity of electoral process. the Implementing ONOE would require significant amendments to the Constitution and the Representation of People Act of 1951. Some amendments, particularly those affecting state powers, would need ratification by more than half of India's states under Article 368. These changes could alter the balance of power between the central government, states, and institutions like the President and state governors, raising questions about preserving India's parliamentary democracy. The VP, who faced flak in some quarters for recently using strong words against the judiciary for brining the President's functions under review, reminded all constitutional functionaries about their limits. In a veiled manner, he said all organs of a democracy have an obligation towards respecting the citizens, their elected representatives and Parliament. He also questioned some constitutional experts who described the President as a titular head or a ceremonial Constitutional functionary in their effort to justify the three-month deadline set for deciding on Bills. 'Please save my husband': Terror turns Pahalgam into a scene of blood and desperate cries



Sri Nagar/New Delhi, (HS) : It was around 2:30 pm when the calm of Baisaran meadows, a scenic stretch in Pahalgam's south Kashmir hills, known as 'mini Switzerland', was shattered by the rat-a-tat of guns. Moments later, cries for help echoed through the valley as terrified families rushed towards loved ones lying still, many of them drenched in blood. What had been a peaceful afternoon had quickly turned into one of the darkest days for civilians in Jammu and Kashmir in recent years.

Heavily-armed terrorists walked out of the woods of Baisaran, a meadow atop a hill, and surrounded a group of around 40 tourists. The terrorists started firing on the tourists indiscriminately, leaving multiple people dead and injuring at least 28. Eyewitnesses claimed that as soon as the bullets started flying, the handful of locals who earn a livelihood from tourism ran for safety, leaving the tourists as sitting ducks. "My husband was shot in the head... he was shot for not being a Muslim." a woman survivor told PTI over phone. The woman, who did not identify herself, pleaded for help in evacuating the injured to the hospital. "Bhaiyya please mere husband ko bacha lo (Brother, please save my husband),"

Actor Lalit Manchanda dies by suicide in Meerut



Meerut, (HS) : Actor Lalit anchanda, who played key roles in TV shows like Taarak Mehta Ka Ooltah Chashmah and Crime Patrol, was found dead at his house in Meerut, Uttar Pradesh, on Monday. A report states that the police have confirmed his cause of death as suicide. The report states that Lalit was found dead at his home on April 21. Local law enforcement responded promptly after receiving a report about the incident. His body was reportedly found hanging. After being taken into custody, his body was transferred to a local facility for postmortem examination. No suicide note was found at the scene. And preliminary findings suggested there was no evidence of foul play or third-party involvement. Police have reportedly begun speaking to Lalit's family and close friends as part of the investigation. They are also examining the circumstances surrounding the death. With no suicide note found, the police are looking into mental health and recent events in Lalit's life, the report states. Those close to him have reportedly claimed that Lalit was dealing with mental stress and personal challenges in the last few months. Further details are awaited. On Tuesday, the official Instagram account of CINTAA shared a post confirming Lalit's death: "CINTAA expresses its condolences on the demise of Lalit Manchanda (member since 2012)." Report states that Lalit has starred in several Bollywood films and TV shows in supporting roles. He was also recently working on a web series. He had a role in the long-running comedy series Taarak Mehta Ka Ooltah Chashmah and was known for portraying the role of a father in DD National channel's Sevanchal Ki Premkatha. He also played key roles in TV shows like India's Most Wanted, Crime Patrol and Yeh Rishta Kya Kehlata Hai, among others.

the woman pleaded frantically.

A video of the Pahalgam attack site emerged showing several people bleeding and lying motionless on the ground while women tourists were wailing and looking for their near and dear ones. Some were too stunned to react and were being helped by locals. As soon as the news of the attack broke out, the roads and streets of Pahalgam wore a deserted look as other tourists fled the resort town to safer places. As the famed meadows are only accessible by foot or on ponies, authorities had to summon choppers for the evacuation of the injured. However, before the helicopters arrived at the scene, some of the injured were brought down by local people on their ponies. The local tourist guides and ponywallahs consoled the survivors even as they summoned more people to evacuate the injured tourists on their shoulders to the nearest motorable point. Jammu and Kashmir Chief Minister Omar Abdullah wrote on X saying that the death toll is still being ascertained. "This attack is much larger than anything we've seen directed at civilians in recent years," he wrote. "I'm shocked beyond belief. This attack on our visitors is an abomination. The perpetrators of this attack are animals, inhuman and worthy of contempt. No words of condemnation are enough. I send my sympathies to the families of the deceased," CM Abdullah said. In 2000, more than 30 persons had been killed and 60 others injured in a terror attack on Amarnath base camp in Pahalgam. A year later, 13 persons were killed and 15 others injured in an attack on Amarnath pilgrims at Sheshnag while 11 persons were killed in another attack in 2002 in the Pahalgam area.


Eight pilgrims were killed in a terror attack in 2017 as they were on the way home from Amarnath shrine. A tourist couple from Rajasthan was injured in a firing incident by terrorists at Yannar in Pahalgam in May last year. The incident comes when Kashmir is witnessing a surge in tourist arrivals after reeling under militancy for years. Also, the 38-day Amarnath pilgrimage is scheduled to begin on July 3. Lakhs of pilgrims from across the country travel to the Amarnath cave shrine from the twin routes -- the traditional 48-km Pahalgam route in south Kashmir's Anantnag district and the 14km shorter but steep Baltal route in Ganderbal district. Baisaran is a major tourist place in Pahalgam besides being a campsite for trekkers who want to move further up to Tulian Lake.

I've spoken to my colleague, Sakina Itoo & she has moved to the hospital to oversee arrangements for the injured. I'll be flying back to Srinagar immediately," the J&K CM wrote on X. 


Sri Nagar/New Delhi, (HS): Over 28 people, mostly tourists were killed on Tuesday in a terrorist attack in the Baisaran Valley, a scenic area in Pahalgam, Anantnag district of Jammu and Kashmir. Gunshots were reported in the region-often dubbed "mini-Switzerland" for its natural beauty-prompting swift deployment of security forces. The remote, high-altitude location is accessible only by foot or horseback, complicating rescue operations. Authorities deployed a helicopter for evacuation, while locals used ponies to help bring the injured down from the meadows. At least 12 tourists were admitted to Pahalgam hospital, with doctors confirming that all were in stable condition. In response to the incident, Prime Minister Narendra Modi, currently on a visit to Saudi Arabia, spoke with Union home minister Amit Shah and directed him to ensure all necessary measures are taken. The PM also asked Shah to visit the attack site to oversee the situation firsthand. "Usha and I extend our condolences to the victims of the devastating terrorist attack in Pahalgam, India. Over the past few days, we have been overcome with the beauty of this country and its people. Our thoughts and prayers are with them as they mourn this horrific attack," he said. "The attack on tourists in Kashmir's Pahalgam that has reportedly claimed the lives of at least 26 people and injured many more once again highlights the challenges faced by security forces in J&K. This was a clear case of targeted killing aimed at spreading fear in the beginning of the tourist season. With tourism being a traditional source of revenue in Kashmir and heavily tied to govt's normalisation efforts, the terrorists wanted to send the message that J&K remains on the boil," writes Rudroneel Ghosh . "The heinious act of terror attack on tourist in Pahalgam of Jammu & Kashmir is highly condemnable and heart wrenching. We pay homage to deceased and pray for early recovery of the injured in this attack. This is an attack on the unity and integrity of our nation. All political parties and associations should rise above their differences and condemn this terror act. Government should ensure all required relief and assistance to the affected families and ensure appropriate punishment for the people responsible for this attack," Dattatreya Hosabale said.

TN Governor Judgment Would Not Cover Kerala's Case, Centre Tells SC 7

New Delhi, (HS) : The Union government on Tuesday told the Supreme Court that its recent judgement setting timelines for both the President and Governors to act on Bills would not cover the dispute between Kerala's Governor and Assembly. The top court was dealing with a plea filed by the Kerala government against "inaction" on the part of the Governor in giving assent to the bills passed by the Assembly. Appearing on behalf of the Kerala

government, senior advocate K.K. Venugopal submitted before a bench of Justices P.S. Narasimha and Joymalya Bagchi that its case would be squarely covered by the recent SC judgment in Tamil Nadu's Governor case. On the other hand, Attorney General for India R Venkataramani and Solicitor General Tushar Mehta, the two topmost law officers of the Centre, said that Kerala's case is factually different and would not be covered by the latest judgment on interpretation of Article 200. "The Tamil Nadu judgment does not cover certain issues of this case on the facts. We would like to show those differences. I will put in a note," said Attorney General Venkataramani. After hearing the



submissions, the Justice Narasimha-led

be dealt with "as soon as possible". The writ petition said that the words "as soon as possible" occurring in Article 200 of the Constitution necessarily mean that not only should pending bills be disposed of within a reasonable time, but that these Bills have to be dealt with urgently and expeditiously without any avoidable delay. Earlier this month, the top court, using its inherent powers under Article 142 of the Constitution, resolved a standoff between the Tamil Nadu government and Governor R.N. Ravi over the delay in granting assent to Bills passed by the Assembly. It ruled that Governor Ravi's refusal to approve 10 bills in Tamil Nadu was both "illegal and arbitrary" and set a three-month deadline for Presidential and gubernatorial approval of bills passed by the legislature for a second time. "The President is required to take a decision on the Bills reserved for his consideration by the Governor within a period of three months from the date on which such reference is received," said a bench of Justices J.B. Pardiwala and R. Mahadevan. If there is no decision within this time frame, states are entitled to file writ petitions seeking a writ of

mandamus against the President, the Justice Pardiwala-led Bench clarified.

The apex court used the powers for the purpose of declaring the 10 withheld Bills as deemed to have been assented to on the date when they were presented to the Governor after being reconsidered by the state legislature. The top court held that once a Bill is returned, repassed by the legislature, and presented again to the Governor, it is not open for the Governor to reserve it for the President's consideration. Additionally, the President is now under an obligation to provide reasons for their decision, which must be communicated to the state government. Further, it suggested that the President should consult the Supreme Court on Bills involving Constitutional issues. The judgment, apparently, brought Presidential actions under judicial review by favouring a three-month deadline for granting assent to Bills. The issue took a new twist after Vice-President Jagdeep Dhankhar used strong words against the judiciary, comparing Article 142 to a 'nuclear missile' available to the judiciary against democratic forces.

74-year-old woman who tested positive for Covid-19 dies in Indore

Indore, (HS) : A 74-year-old woman who had tested positive for Covid-19 died while undergoing treatment in Madhya Pradesh's Indore district, an official said on Tuesday. The woman, a resident of Indore, was admitted to Aurobindo Hospital on April 19 after suffering from cold-cough and fever for the last 20-25 days. She succumbed in the early hours of Tuesday at around 2 am, he added. Chief Medical and Health Officer (CMHO), Dr B S Setia told ANI, "Two patients have tested positive for Covid-19 at Aurobindo hospital on Monday evening, which includes a 74-year-old woman who was admitted here on April 19. She was suffering from cold-cough and fever for the last 20-25 days, and she died while undergoing treatment at around 2 am. Another patient, a resident of Dewas district, has also tested positive, and his health condition is stable. The patient who died due to multi-organ failure and septicemia." Currently, only two patients have tested positive for COVID-19 here in the district, he added. Meanwhile, Indore Collector Ashish Singh said that there was no need to panic and all the situations were under control. "Two patients tested positive for Covid-19, of which one patient who was suffering from other diseases too died due to multi-organ failure. Though she was tested positive, there is no need to panic at all. All the contacts of both patients have also been tested and instructed to be isolated. If required, then we will hospitalise them. All the situation is under control and there is no need to panic," he said.

Accused Mushtaq Ali killed in police encounter while trying to escape in Jammu district

Jammu, (HS) : A man identified as Mushtaq Ali alias Bacchu Don, wanted in multiple criminal cases, died after sustaining injuries during an escape attempt while in police custody. The incident occurred as a police team was returning from Amritsar to Jammu after arresting the accused, the Jammu and Kashmir Police said on Tuesday. According to an official statement, a police party from Jammu was sent to Baba Batala in Amritsar, Punjab, on Monday to apprehend two wanted individuals with the assistance of the Punjab Police. The two accused, including Mushtaq Ali, son of Mohammad Sadiq and resident of Kikri Morh, Bari Brahmana, were arrested. Both were wanted in multiple criminal cases within the Jammu-Kathua-Samba range.

While returning from Amritsar, the accused reportedly asked the police to halt the vehicle, citing a nature's call. During the stop, both accused allegedly attacked the police personnel, attempted to snatch their weapons, and tried to escape, said the Jammu and Kashmir police. The police party managed to bring the situation under control, but Mushtaq Ali, in an attempt to flee, fell on the road and sustained grievous injuries. He was immediately shifted to the Government Medical College (GMC) Hospital in Jammu, where doctors declared him dead. Four police personnel received minor injuries during the incident, and further investigation is underway, according to the police. Following the incident, a case has been registered under FIR No. 33/2025 at the Police Station Bishnah, under the relevant sections of the law. Legal formalities have been initiated. The police have also requested the District Magistrate of Jammu to constitute a board of doctors for conducting the postmortem of the deceased and initiate a necessary inquiry into the matter.

'Will soon expose conspirators': Mamata on
Murshidabad violence; to visit site in MayTrainer aircraft crashes in
Gujarat's Amreli, one killed



KOLKATA, **(HS)**: West Bengal Chief Minister Mamata Banerjee on Tuesday asserted that "outsiders" were responsible for the violence that erupted in parts of Murshidabad district over the Waqf Act recently, and said she would visit the troubled areas in the first week of May to evaluate the situation. Banerjee also said her government would soon expose the conspirators" behind the riots that took place in two wards of Dhulian in the district. "The violence was unfortunate. We do not want riots. Some outsiders orchestrated it, but we will expose them and their conspiracy," she said at an administrative programme in Midnapore. "I have promised the families of those killed in the violence to give a compensation of Rs 10 lakh each. We will also rebuild their houses under the 'Banglar Bari' scheme... I will be going there in the first week of May and evaluate the situation," Banerjee said. The CM also said that the state government could take responsibility for the education of the children of those killed in the violence. "We are surveying the damages faced by the shopkeepers there," she said. Governor C V Ananda Bose had on April 19 met family members of a man and his son, who were killed after protests against the Waqf (Amendment) Act turned violent in Murshidabad district, and assured them of all possible support. At least three people died and over 280 have been arrested in connection with the violence earlier this month.

AHMEDABAD, (HS) : A deadly crash jolted Amreli as a trainer aircraft from a private aviation academy plunged into a residential area near Giria Road, killing a trainee pilot on April 22. The incident has sent shockwaves through the local community, raising fresh concerns over flight safety in training operations. Eyewitnesses reported that three people were injured in the chaos that followed the plane crash. "An aircraft crash-landed into a residential area in the Giriya Road area of Amreli town around 12:30 pm for unknown reasons," said Amreli Superintendent of Police Sanjay Kharat. "There is a flying institute in the Amreli police

station area that offers pilot training. Our investigation has revealed that a training aircraft from the institute crashed during a session, resulting in the death of a trainee pilot. No one else was injured in the accident," he said.

"A case has been registered at the local police station, and further investigation is underway," he added. "This was a trainer aircraft with permission for solo flying," Amreli Collector Ajay Dahiya told local media.

"There is no damage in the surrounding area. The plane struck a tree and caught fire. We have received information about the incident and informed the DGCA. DGCA will carry out the investigation," Ajay added.

Iran Ready For Deal With US If National **Interests Respected: President Pezeshkian**

Tehran, (H.S): Iranian President Masoud Pezeshkian said that Iran is open to reaching an agreement with the US in ongoing indirect talks, provided that the country's national interests are preserved. "In the negotiations with the United States, we are ready for an agreement within a defined framework and while ensuring our national interests,' Pezeshkian said on Monday during a meeting in Tehran."

However, if they (US representatives) refrain from negotiating with us on equal terms, we will continue on our own path," the Iranian president warned.He added that, as previously stated by Supreme Leader Ayatollah Ali Khamenei, Iran remains "neither optimistic nor pessimistic" about the negotiations, Xinhua news agency reported.

Pezeshkian also reiterated that Tehran does not seek conflict but would resist any attempt at coercion. "We do not want confrontation with anyone, but we will not tolerate pressure or bullying," he said. His comments followed the second round of indirect talks between Iran and the United States, held in Rome on



Saturday with mediation from Oman. The first round took place in Muscat on April 12, and a third session is scheduled to be held in the Omani capital again this coming Saturday.At a weekly news conference in Tehran, Iranian Foreign Ministry spokesman Esmaeil Baghaei said the removal of US sanctions remained Iran's principal demand in the negotiations.

Meanwhile, US President Donald Trump described the recent talks as "very good." Speaking to reporters over the weekend, Trump said, "We had very good meetings actually on Iran," adding, "The next step is we need a little time."The discussions came in the wake of a letter sent by Trump to Iran's

proposing talks on Tehran's nuclear programme. Trump later warned of military action should Iran reject his offer for talks.Iran signed the Joint Comprehensive Plan of Action with six world powers - Britain, China, France, Germany, Russia, and the United States in 2015.

migrants living in Canada, including Indians, are losing their work permits due to long delays in the paperwork renewal process, as growing backlogs and changing rules hinder efforts to maintain legal status. Despite paying taxes, migrants in Canada can't work legally or access medical care and other services if they lose their legal status.Among those who lost their permit is Devi Acharya, who moved to Canada from India with her husband and son in October 2022. Acharya miscarried in March because she did not go to a hospital, as she could not afford another medical bill.

She does not have health coverage for the same reason she cannot work -- her work permit expired while she waited for a labour market impact assessment, and if she sought medical care, she could be handed a hefty bill. "If I got medical attention on time, maybe we could have saved the baby," she told Reuters. Acharya was working in housekeeping at Prince Rupert's Highliner Hotel in British Columbia before she lost her job. she liked the work and recently bought a house with her husband. They applied for new labour market impact assessments in September, her



immigration consultant told Reuters. They have received no response, and their work permits have expired. They are in Canada legally but cannot work. Their son, Navdev, now five years old, cannot go to school."Two years before we were dreaming of making Canada home," she said, "and now it's shattering."Canada has long blamed migrants for straining services and resources amid housing shortages and rising rents

Ottawa is trying to reduce the number of migrants and is reportedly relying on people to leave voluntarily to meet its targets. Living undocumented in Canada is rare in part because it is so difficult to access services without status. The labour market impact assessment processing time for temporary workers hoping to become permanent residents in Canada has been increasing since at least

fall 2022. It has almost tripled from 58 business days in September 2023 to 165 business days in March 2025. Quoting an email from Service Canada-- which processes these applications--Reuters reported that as of April 1, 2025, the department was still processing labour market impact assessment applications submitted a year earlier."

We are seeing a backlog now of more than a year. ... It's the first time we are seeing such a delay," said immigration consultant Kanwar Sierah. It is not known exactly how many people have lost their work permits due to delays so far, but Reuters spoke to at least four families who are in this distress. According to immigration Canada's department, migrants can keep working as long as they get a labour market impact assessment needed to maintain their status within 60 days of applying to

renew their work permit. But the department does not have guidelines for people who lost status because of long waits. The department has attributed the lengthier waits, in part, to an influx of applications, but would not provide the number of applications pending by month. The number of people applying for work permits within the country has grown compared to last year, as has the share of those applications that Canada is refusing, data from Canada's immigration department shows.

Experts say changing rules, as well as more applicants, may be contributing to the growing backlog."People are losing their immigration status", Sierah said, and added that some people are working under the table for exploitative employers or falling victim to "unscrupulous actors" who give them bad advice, for example, by urging them to apply for asylum when they may not have a strong case. Canada's Liberal government pledged to give undocumented people status but then backtracked and said it would provide it on a small scale for people working in certain sectors. Prime Minister Mark Carney, who leads polls ahead of an April 28 election, promises to cap immigration for now.

FBI Chief On Arrest Of Terrorist Harpreet Singh In US Sharp Escalation In Trump vs Harvard, Lawsuit Flags Serious Violations

New York, (H.S): Harvard sued US President Donald Trump's administration Monday in a sharp escalation of the fight between the prestigious university and the Republican, who has threatened its funding and sought to impose outside political supervision. Trump has sought to bring several prestigious universities to heel over claims they tolerated anti-Semitism, campus threatening their budgets, taxexempt status and the enrolment of foreign students, but Harvard has refused to bow.'

This case involves the Government's efforts to use the withholding of federal funding as leverage to gain control of academic decision making at Harvard," the Ivy League university said in a lawsuit filed in a Massachusetts federal court that named several other institutions targeted by Trump. The Government's actions flout not just the First Amendment, but also federal laws and regulations,' said the complaint, which called Trump's actions "arbitrary and capricious." Trump is furious at Harvard for rejecting government supervision of its admissions, hiring practices and political slant and last week ordered the freezing of \$2.2 billion in federal funding to the storied institution. The



lawsuit calls for the freezing of funds and conditions imposed on federal grants to be declared unlawful, as well as for the Trump administration to pay Harvard's costs.Trump and his White House team have publicly justified their campaign against universities as a reaction to what they say is uncontrolled "anti-Semitism" and a need to reverse diversity programs aimed at addressing historical oppression minorities. The administration claims protests against Israel's war in Gaza that swept across US college campuses last year were rife with anti-Semitism. Many US universities, including Harvard, cracked down on the protests over the allegations at the time, with the Cambridge-based institution placing 23 students on probation and denying degrees to 12 others, according to protest organizers.

Homeland Security has also threatened Harvard's ability to enroll international students unless it turns over records on visa-holders' "illegal and violent activities."International students made up 27.2 percent of Harvard's enrollment this academic year, according to its website."Make no mistake: Harvard rejects anti-Semitism and discrimination in all of its "Harvard can no longer be forms and is actively making considered even a decent place of structural reforms to eradicate learning, and should not be anti-Semitism on campus," said considered on any list of the Monday's lawsuit."

Russia Welcomes US Proposal To Keep Ukraine Away From NATO

Moscow, (H.S): Russia welcomes the United States statements that Ukraine's potential NATO membership is off the table, Russian Presidential Spokesman Dmitry Peskov said on Monday. "We have heard statements made at various levels in Washington that Ukraine's NATO membership is ruled out. This is something that brings us satisfaction and aligns with our stance," Russian state-run news agency TASS quoted Peskov as saying.US President Donald Trump stated earlier in the month that, despite Ukrainian President Volodymyr Zelensky's desire for Ukraine to join



NATO, it would never happen. Trump also suggested that the Ukrainian conflict could have been triggered by Kyiv's ambitions to join the alliance.Meanwhile, Trump said that he

Russian troops strictly complied with the ceasefire during the Easter truce and stayed at their lines and positions, Russia's Defence Ministry reported on Monday."In compliance with the order by the supreme commander-in-chief of the Russian Armed Forces, all the battlegroups strictly observed the ceasefire and stayed at their lines and positions in the special military operation area during the specified time," the ministry said in a statement. However despite the declared Easter truce, Ukrainian armed formations kept delivering artillery fire and strikes by unmanned aerial vehicles on the positions of Russian troops and civilian facilities in the border areas of the Belgorod, Bryansk and Kursk Regions and the Republic of Crimea, the ministry stated.

began in Australia's general election on Tuesday, with about half of the country's 18 million registered voters expected to cast their ballots before election day on May 3.Hundreds of early voting centres across Australia opened their doors from 8:30 a.m. local time as the election campaign entered its final stretch.The proportion of Australians choosing to vote early, either in person or by post, has steadily increased at recent federal elections from under 20 per cent in 2004 to almost 50 per cent in 2022.

Voting in elections is mandatory for over 18 million citizens aged 18 and over who are enrolled to do so with the Australian Electoral Commission (AEC). According to the AEC, eligible voter enrollment for the May 3 election is a record-high 98.2 per cent, Xinhua news agency reported.Although millions of votes will be cast early, AEC staff cannot start counting any ballots until polls close at 6 p.m. local time on May 3.Jill Sheppard, a senior lecturer in politics and international relations at the Australian

National University, said that the rise in early voting could be attributed to the convenience of pre-polling as well as growing disengagement among voters with political parties and campaigns. Earlier on April 21, Australian Prime Minister Anthony Albanese said that the country's upcoming general election was still "up for grabs" despite polls showing his Labour Party was on track to win a second term in government. The campaign restart came one day before early voting opened across the country on Tuesday - offering millions of Australians the opportunity to avoid long queues to cast their mandatory votes - and after several new opinion polls showed that Labour had increased its lead over the Coalition among

voters. The latest edition of Newspoll, published by News Corp Australia on Sunday, reported a 52-48 lead for Labour over the Coalition on a two-party preferred basis.A separate poll published by the Australian branch of UK firm YouGov on Friday put Labour ahead 53-47, marking the government's strongest two-party result in the firm's poll in 18 months, Xinhua news agency reported.Labour had won the 2022 general election 52.13-47.87 over the Coalition on a two-party basis. When asked on Monday if Labour was in pole position to win the election, Albanese pointed to lessons the party had learned from 2019, when polls had widely forecast a Labour victory only for the Coalition to win a third term in

power in a result hailed by then-PM Scott Morrison on election night as a "miracle." "There's no complacency from my camp," Albanese told reporters in the state of New South Wales. "This election is certainly up for grabs." Some electorates had as many as 13 candidates running in the election. The Newspoll published on Sunday found that 34 per cent of respondents intended to vote for their Labour candidate as their first preference - the highest since January 2024 - and 35 per cent for the Coalition, while the YouGov poll had both major parties tied at 33 per cent.Labour traditionally received fewer first preference votes than the Coalition but performed better on preferences. Labour received 32.5 per cent of first preference votes in 2022, compared to 35.7 per cent for the Coalition, but benefited from over 85 per cent of votes for the Greens, Australia's thirdlargest party, flowing its way.

Nifty Turns 29: From 1,000 In 1996 To Over 26,000, A Look At Its Journey So Far

Mumbai, (H.S): Over nearly three decades, the Nifty index has evolved into a key barometer of the Indian equity market, growing from a base value of 1,000 to over 26,000.On Tuesday, the Nifty marked its 29th anniversary, continuing to serve as a reflection of India's economic growth, investor confidence, and market sentiment.

Launched by the National Stock Exchange (NSE) on April 22, 1996, the Nifty was introduced just two years after the exchange began operations. The index was created with a base date of November 3, 1995, and a base value of 1,000. Today, it tracks the performance of 50 of the most traded and largest companies in India across 15 sectors and represents about 55.48 per cent of the NSE's total free-float market capitalisation as of March 28, 2025. Since its inception, the index has witnessed phenomenal growth. It crossed 1,000 points in 1999, 5,000 by 2007, and 10,000 in 2017.Its rise accelerated after 2020, with the index breaching 15,000 in February 2021 and surpassing 26,000 in September 2024.The highest closing level so far was 26,216.05 on September 26, 2024, with an all-time intra-day high of 26,277.35 recorded the following

day. This remarkable rally was supported by strong corporate earnings, high levels of participation from retail and institutional investors, and steady macroeconomic performance. However, the journey hasn't been without challenges. The index has weathered multiple global and domestic shocks, including the 2008 financial crisis, the COVID-19 pandemic, and the recent

uncertainty over a US recession triggered by reciprocal tariffs announced by US President Donald Trump.Despite these disruptions, the index has consistently shown resilience, bouncing back with strength and continuing its upward trajectory. The index has also played a pivotal role in developing India's derivatives market.

Futures and options trading on the Nifty began on June 12, 2000, and it remains one of the most actively traded instruments on the exchange. Meanwhile, the NSE is preparing for its own market debut. In March 2025, the exchange submitted a detailed response to the Securities and Exchange Board of India (SEBI), addressing queries regarding its IPO plans and seeking approval to file its draft red herring prospectus (DRHP). **New Delhi, (PIB):** Gold prices reached a historic milestone on Tuesday as the rate of 24-carat gold touched Rs 1,00,000 per 10 grams for the first time ever.According to the India Bullion and Jewellers Association (IBJA), the price of 24-carat gold rose sharply from Rs 96,670 to Rs 1,00,000 per 10 grams - a jump of Rs 3,300 within 24 hours.

Mumbai, (H.S): The RBI has issued new Liquidity Coverage Ratio (LCR) guidelines which will require a bank to assign additional run-off rates of 2.5 per cent to internet and mobile bankingenabled retail and small business customer deposits with effect from April 1, 2026. Banks will also have to adjust the market value of Government Securities (Level 1 HQLA) with haircuts in line with margin requirements under the Liquidity Adjustment Facility (LAF) and Marginal Standing Facility (MSF).

In addition, the final guidelines also rationalise the composition of wholesale funding from "other legal entities". Consequently, funding from nonfinancial entities like trusts (educational, charitable and religious), partnerships, LLPs, etc., shall attract a lower run-off rate of 40 per cent as against 100 per cent currently."To give the banks adequate time to transition their systems to the new standards for LCR computation, the revised instructions shall become applicable with effect from April 1, 2026," the RBI statement said.The Reserve Bank has undertaken an impact analysis of the above measures based on data submitted by banks, as on December 31, 2024.

It is estimated that the net impact of these measures will improve the LCR of banks, at the aggregate level, by around 6 percentage points as on that date. Further, all the banks would continue to meet the minimum regulatory LCR requirements comfortably. The RBI is sanguine that these measures will enhance the liquidity resilience of banks in India, and further align the guidelines with the global standards in a non-disruptive manner, according to an RBI statement. The Reserve Bank had issued a draft circular on July 25, 2024, on "Basel III Framework on Liquidity Standards -Liquidity Coverage Ratio (LCR) - Review of Haircuts on High Quality Liquid Assets (HQLA) and Run-off Rates on Certain Categories of Deposits".

The draft circular proposed certain amendments to the LCR framework and invited comments from banks and stakeholders. The final LCR guidelines have been issued after carefully examining this feedback, the RBI statement added.The Liquidity Coverage Ratio is a regulatory standard developed by the Basel Committee on Banking Supervision. It requires banks to hold a buffer of High Quality Liquid Assets (HQLA) that can cover expected net cash outflows over a 30-day stress scenario.

which provides substantial freight savings, and the planned infrastructure expansion under the Rail Sagar Corridor to enhance port connectivity. Going forward, adequate rake supply and robust rail infrastructure connecting mines to ports will be crucial responsibilities of the Ministry of Railways. The Ministry of Ports, Shipping and Waterways (MoPSW) will play a vital role by optimizing shipping and port handling charges and developing dedicated coal berths.

KKR captain Ajinkya Rahane also put the blame on batters after the 39-run loss to GT."When you are chasing a big target, you expect a good start with your opening batters. That's what we are looking to get better as a batting unit. No complaints with our bowlers, I thought bowlers are doing a really good job. Game by game, they are improving a lot," said Rahane."We know these conditions really well, but we need to bat properly, we need to bat well in the middle overs, that's what we are struggling with as a batting unit," he added.

Current IPL agreements stipulate that the Rajasthan Sports Council oversees IPL match hosting in Jaipur this season. The franchise has emphasised cooperation with both the Council and the BCCI, under state government oversight, to ensure a successful tournament.

Harsha, Simon Removed from IPL Commentary at Eden Gardens

New Delhi, (HS) : Taking a strong exception to pubic criticism of their curator by Harsha Bhogle and Simon Doull, the Cricket Association of Bengal (CAB) has red flagged the two cricket experts and requested the BCCI not to assign them commentary duty for Kolkata Knight Riders home matches. Bhogle and Doull got embroiled in the controversy when the former New Zealand cricketer opined that KKR should relocate their franchisee if the curator was not paying any heed to team's request for spin-friendly tracks while Bhogle said the team should get the home advantage.

This was during a panel discussion on a popular website after KKR lost two of their first three home games. Infuriated by their comments, CAB secretary Naresh Ojha wrote to the BCCI nearly 10 days ago, requesting the removal of Bhogle and Doull from the commentary panel for their home games. Interestingly, during Monday's game between KKR and Gujarat Titans neither Bhogle nor



Doull was on commentary duty. However, sources close to Bhogle said the renowned commentator was not slotted for any KKR game. It could not be confirmed if the commentary roster was set before or after CAB's formal complaint. "Bhogle and Doull are no longer part of the IPL commentary team for KKR's home matches. However, the situation might change when Eden hosts the Qualifier 2 and the Final on May 23 and 25," a CAB official told. Ojha and CAB president Snehasish Ganguly were not available for a comment. Both KKR captain Ajinkya Rahane and head coach Chandrakant Pandit had expressed disappointment over not getting the expected spin-friendly conditions.

Following KKR's defeat to Lucknow Super Giants in a highscoring game, where LSG posted 238/3 and restricted KKR to 234/ 7, Rahane appeared frustrated when asked about the pitch at the post-match press conference. "There was no help for the spinners, let me make that clear," he said, adding that further remarks

from him could create a "bawal' (controversy). During an expert panel discussion, Doull suggested that the franchise consider relocation if their requests regarding the pitch were not met. "If he (the curator) is not taking heed of what the home team wants... they are paying the stadium fees, they are paying for what's going on in the IPL. If he's still not listening, then just move the franchise away. His job is not to pass an opinion on the game. That's not what he's paid for," Doull had said. Bhogle echoed similar sentiments: "If they are playing at home, they should get the kind of tracks that suit their bowlers. I saw something about what the KKR curator has said." The CAB, however, stood firmly behind its curator Sujan Mukherjee, maintaining that he has followed the BCCI guidelines, which state that no franchise can influence or dictate the nature of the pitch at a venue. The KKR think-tank had reportedly requested a more spin-friendly surface to support the likes of Varun Chakravarthy, Sunil Narine and Moeen Ali.
