




Delhi, (HS) Waqf Defending the Amendment Act, 2025, as a valid, lawful exercise of legislative power, the Centre on Friday filed its reply in the Supreme Court and requested it to dismiss the batch of petitions challenging the act's constitutional validity. "It is a settled position in law that constitutional courts would not stay a statutory provision, either directly or indirectly, and will decide the matter finally," said the Centre, in its reply filed before the top court. The Centre filed the reply after complying with the top court's order asking it to do so.

A three-judge bench of the apex court, led by the Chief Justice of India (CJI) Sanjiv Khanna and including Justices Sanjay Kumar and K V Viswanathan, is scheduled to hear the batch of pleas challenging the Waqf Amendment Act on May 5. The Centre said that after 2013, there was an addition of over 20 lakh hectares (precisely 20,92,072.536) in waqf land. "For the last 100 years, waqf by user is recognised only upon registration and not by word of mouth. Hence, the amendment was in sync with consistent practice. There will be maximum of two non-Muslims among 22 members in the Waqf Council and Aukaf Boards, a measure that is representative of inclusiveness and not intrusive of the administration of waqfs," the Centre said. The affidavit added that the identification of government land deliberately or wrongly mentioned as waqf properties is to set the revenue records right and that government land cannot be treated as land belonging to any religious community. The Centre, in its 1,332-page preliminary counter affidavit, submitted that there cannot be a "blanket stay" on the law as there was a "presumption of its constitutionality". The government also said it would oppose any attempt by the Supreme Court to order **Continued P-4** 

# 'Won't allow a single drop of water into Pakistan': Jal Shakti minister CR Paatil



New Delhi, (HS) : Jal Shakti minister CR Paatil on Friday said that India would not allow a "single drop" of water to flow into Pakistan as a retaliation for its alleged role in the terrorist attack on tourists in Jammu and Kashmir's Pahalgam, killing 26 innocent people. "We will ensure that not a single drop of water flows into Pakistan from India," CR Paatil said.

The minister made the comments after attending a meeting chaired by home minister

Amit Shah to discuss the future course of action following India's decision to suspend the Indus Waters Treaty of 1960 with Pakistan. Besides Paatil, senior officials from several ministries reportedly attended the highstakes meeting. Paatil also said that Prime Minister Narendra Modi has issued a slew of directives, and the meeting was held to follow up on them. Shah also made several suggestions to ensure the effective implementation of the Centre's

decision. Paatil later posted on X, "The Modi government's historic decision on the Indus Waters Treaty is lawful and in national interest. We will ensure that not a single drop of Indus water flows into Pakistan." The BJP leader also said India has sent a "strong message" to Pakistan that it will not tolerate terrorism at all. Sources told news agency PTI that the government is developing a long-term strategy to ensure its effective implementation.

Earlier on Friday, Jammu and Kashmir chief minister Omar Abdullah called the nowsuspended treaty the "most unfair document" for the people of the union territory, saying it never had their support. "The Government of India has taken some steps. As far as Jammu and Kashmir is concerned, let's be honest, we have never been in favour of the Indus Waters Treaty. Now, what the medium to long-term implications of this are, that is something we have to wait to see," Abdullah said. In the Cabinet Committee on Security meeting, chaired by Prime Minister Narendra Modi, in the presence of Home Minister Amit Shah, India decided to hold the Indus Waters Treaty of 1960 in abeyance until Pakistan credibly and irrevocably abjures its support for cross-border terrorism and has closed the integrated Attari Check Post.

India has also declared the officials of the Pakistani High Commission persona non grata and ordered them to leave India within a week. The country further decided to cancel any

# 12 Pakistanis in Odisha on long-term visas; begins to serve exit notices

Bhubaneswar, (DMC) : The process of issuing notices to 12 Pakistani nationals residing in Odisha on long-term visas (LTVs) has been initiated following a directive from the Ministry of Home Affairs (MHA), Government of India. These individuals, who have been living in the state for extended periods, will soon be formally asked to leave the country, officials confirmed. According to reliable sources, the decision follows a nationwide reassessment of foreign nationals residing in India, particularly those holding long-term visas issued on humanitarian grounds or under special circumstances.

Earlier in the day, Union Home Minister Amit Shah dialled Chief Ministers of all the states and asked them to ensure that no



Pakistani stays in India beyond the deadline set for leaving the country, sources said. India on Thursday announced revoking all

visas issued to Pakistani nationals from April 27 and advised Indian nationals residing in Pakistan to return home at the

earliest, as tensions between the two countries escalated over the Pahalgam terror attack that killed 26 people, mostly tourists, on

Tuesday. Amit Shah personally called up the Chief Ministers of all the states and asked them to ensure that no Pakistani stays in India beyond the deadline, sources said. The Chief Ministers were also told to identify the Pakistani nationals staying in their respective areas and ensure their deportation, the sources said. The MHA has instructed State governments to review the status of such individuals and begin procedures to ensure compliance with national security protocols and immigration laws.

In compliance with this central directive, the Odisha government has started the formal process to serve exit notices to the 12 Pakistani citizens currently residing in different parts of the state. Authorities are **Continued P-4**



# Vance Visit

Vance's four-day tour, which began on Monday, comes as the Modi government desperately tries to duck US tariffs. These "reciprocal" tariffs - including a 26 percent levy on Indian exports to the US - are currently on pause for 90 days, until July 8, for all countries except China. India, like all other countries, however, is currently being tariffed at 10 percent. The US is India's largest trading partner and the biggest buyer of its exports. Officials from the two countries have been engaged in intense negotiations to lock down a bilateral trade agreement that would allow them to avoid a tariff battle.But those negotiations have prompted concerns among Indian farmers: The country has long used tariffs to shield agriculture from being swamped by products from other countries. Now, farmers critical of Modi fear that the Indian government may weaken those protections as part of a trade deal with Trump.As Vance prepared to vacation with his family at India's famed Taj Mahal and historic forts, dozens of farmers protesting in several villages across India burned his effigies on Monday and raised slogans: "Go back, Vance. India is not for sale!" This visit, along with Vance's speech in Jaipur on Tuesday, must be viewed in the context of growing apprehensions about the trade policies implemented by the Donald Trump administration, the reassessment of the United States' position on the world stage, and the tightening of immigration regulations. Against this backdrop, the images of the Vance family sight-seeing, the play on the Indian connection through Second Lady Usha Vance, and the photogenic warmth of the meeting with PM Narendra Modi, with the couple's three children participating, have led to a perceptible softening. The tenor of the trip has been in stark contrast to the hard and stark stance taken by the V-P in Europe during the Munich conference earlier this year. His speech in Jaipur only underlined this. The US V-P announced that the Terms of Reference (ToR) for a bilateral trade agreement have been finalised. He spoke of deepening defence cooperation and about offering the latest defence equipment, notably the F-35 fighter jet. He also made a case for exporting US hydrocarbons to India, and partnering in energy exploration as well as emerging technologies, including AI. The Trump administration remains consistent in its approach to the Indo-Pacific - there has been clarity on the China challenge from Trump's first term through to the Biden administration. Vance's welcoming of India's leadership of the Quad is important in this context.

Vance has sought to frame bilateral ties in terms of a convergence of interests, free from what he sees as the shibboleths of a defunct ideology. Vance's visit, which took place just over two months after the Modi-Trump summit in Washington, revealed a crucial insight: India appears to possess increased flexibility during this time of disruption and rebalancing. The pressing challenge now is to leverage this momentum effectively, especially given the turmoil in the global economic and strategic environment, which threatens to create prolonged periods of uncertainty.

In today's complex economy, the connotation of debt has been many and still the huge increase in debt speaks that the world is not feeling comfortable, under the burden of burgeoning debt.

Global debt, as per the list released by UN trade and development report of 2024, has reached a whooping US dollar 97 trillion in 2023. The public debt in the developing countries reached less than one third of the total-US dollar 29 trillions and since 2010 it has grown as fast as developed economies. It speaks,

growing cost of developing countries are higher than those of underdeveloped ones. There is a stark contrast among the developing regions across the world. In the new international financial architecture, the debt has created more inequality, a burden of this too heavy, with major countries almost are gasping under the burden, with exacerbated cost of immense mental and social problems. Debt servicing is defaulted and the Greek debt crisis and Sri Lanka's debt default are disturbing developments Debt servicing has been costly and in 2022 it has reached 6.3% of export revenues. The United States, which occupies the first position with a staggering 34.80 trillions, as per some report. Is quite substantial. US dollar debt is still ballooning, and tleads the list of debt trapped countries. It is alarming. Twice, last year itself, there was no money to run the government and the ensuing deadlock, until, the debt ceiling was raised. It is believed that most in US believe that the government can not pay the debt, which is alarming and if US defaults then the whole finance system may collapse. The world debt is increasing in galloping speed are there do not appear any checks and balances to arrest the North bound curve. It becomes more challenging, in the aftermath of Trump's tariff war, China's retaliatory trade war and the small, low income countries suffocate under a trade war. Let us try to understand how

it happen. In 2001 the US de fiction was 10 trillion and now it has become 34.80 trillions The budgetary deficits of all the countries in the world expanded on account of The deadly COVID Pandemic, that made the state exchequer blank, throughout the world. This, therefore, prompted the countless countries across the globe to go for borrowing, from the public of their countries, and from external sources. This happens without increasing the source of the revenues and therefore, the debt burden even increases. So much so that in 2023, a 26% increase was there compared to 2021 and in 2023,a record 54 countries equivalent to 38% of the total, allocated 10% or more of government revenues to interest payment. Interestingly, 3.3 billion people, out of those who live in the world, spend more on servicing interest than education and health, combined together. Even interest payments outweighs climate related investment or other activities. Thus, climate adaptation and mitigation receives a jolt. Under the circumstances, leaders and thinkers including economist feel that the international financial architecture needs urgent reform, including debt restructuring of low income groups. So the

question arises, which is pertinent again, regarding sustainable developments and the summit of the future policy to be redesigned. Some of the interesting statistics of the report of UNTD says US dollar 29 trillion was the extent of public debt in 2023, 47 billion was the developing countries net interest payments, So. This matters, as public debt has to be utilised for development, But the debt is developing of a fast pace and deepening with astronomical figures of public debt. An example of the painful crisis that enveloped like a gathering storm in Sri Lanka, that is a grim reminder to all concerned to keep the finances in order. US public intellectual, Martin Wolf speaks of the looming disaster, and how an it is unfolding as an imminent disaster. Debt to gdp ratio has reached unsustainable limit, inflation loom large and a default of the debt can not be ignored. World growth will be squeezed. Therefore, the leaders of the country have to make painful choices like cutting unnecessary unproductive expenditure. Some even are of the opinion that countries must stop mindless unproductive expenditure, populist programme, when the government trying for raising public debt, then there is crowding effect within the country and this stalls the investment process. The rise in he rate of global interest rate because of the urgency of foreign debt is another blow. Even world bank and IMF, are putting strict conditionalities,

currency, strict debt restructuring and debt repayment norms. It appears, in the very near future ,world may have to grapple with a major threat. In the latest world outlook, the IMF reported that around 56% of low income countries and 25% of the emerging markets are in debt crisis. The important point is how to make debt sustainable. The lender countries are also turning sceptical to extend a helping hand in apprehension of a debt default. There has to be a rejig of the debt portfolio and the outcome of the budgetary support must go for sustainable purposes and productive social expenditure, to bring a semblance of realism. So the need of the hour is that the government must operate in a business like framework, pursue positive and creative economic policies. If debt servicing falter, under the burden of astronomical debt, then sooner or latter it is a bubble going to burst. As the debt service coverage ratio and interest service coverage ratio becomes unsustainably high then the rich nations have to reschedule it, with haircuts, so that the poorer countries can manage their debt service obligation and have a smoother passage to come out of a debt trap.

Economist Tphanie keltron, in her book " The Deficit Myth", elaborated regarding how to build a better economy, paying out for health care, creating new job opportunities, and spending for arresting the climate crisis, advises practical solutions. Prudent expenditure policy. she says as to how the limited resources to be spent reasonably. With global trade war becoming murkier, without any solution at sight, things may be worsening. Tariffs and trade war will break many more countries, deepen their poverty, and increase their suffering under the debt trap.It seems to be a Herculean task ,including India. The future of the world economy and the stability will be more decided on the outcome of the trade war, which needs to be stopped at any cost, with a reviving of international financial architecture. It seems the war for financial autonomy and development would be either own or lost in the battlefield of prudent debt management.

The Head of the Department of Orthopaedics, Dr. Bishnu Prasad Patro, explained that robotic knee replacement surgery offers several advantages, including minimized risks of human error and improved surgical outcomes. The robotic system provides real-time feedback, enabling surgeons to execute complex steps with greater precision and accuracy. This landmark procedure marks a significant advancement in orthopedic care at AIIMS Bhubaneswar.Traditional knee replacement procedures involved

the use of jigs and cutting blocks, which, while effective, carried a potential for human error, particularly in complex cases involving severe deformities, previous surgeries, or advanced arthritis. However, robotic technology takes this to the next level by providing real-time feedback to the surgeon, finetuning the procedure, and ensuring greater precision. Additionally, the robot can carry out certain steps independently using navigation and artificial intelligence, offering a higher level of accuracy and consistency throughout the operation.

Bhubaneswar, (DMC): The Odisha government has made extensive preparations for purchase of paddy from farmers in the current Rabi season from May 1 to June 30. from May 1 to June 30. It was decided in the meeting to target procurement of 14 lakh metric tonnes of paddy in the current season. For this, about 3 lakh 37 thousand farmers have registered. This year, procurement will be made in 20 districts including newly added three districts of Kandhamal, Sundargarh and Bhadrak.

A total of 965 primary agricultural cooperative societies and 200 SHGs have also joined this process. Chief Secretary Manoj Ahuja has directed the concerned Collectors to ensure that eligible farmers are not deprived of paddy procurement. He also commended over the

token being provided to farmers by validating paddy crop growing areas through satellite imagery technology by ORSAC. He also directed to immediately deploy nodal officers and supervisors for mandis. Similarly, it was discussed in the meeting that all facilities will be available for farmers at mandis. Like Kharif season, Rs 3100

per quintal including Rs 2300 as MSP and Rs 800 as input assistance will be directly disbursed to the farmer's account within 48 hours of paddy procurement. In addition, complaints can be made through toll free No 1967 regarding paddy purchase.Each mandis will be

equipped with CCTV along with each vehicle carrying paddy from Mandi to Mill must have Vehicle Tracking System. District Collectors have been instructed to make special arrangements in view of the unseasonal rains and heatwave to protect paddy and ensuring lifting of paddy on the same day.Similarly, special squads will be deployed at bordering districts to keep eye on outside vehicles carrying paddy during procurement.

# Pahalgam attack and the gathering of war clouds over South Asia

New Delhi, (HS): There have been incipient signs of late that all is not quiet on the western front, as India and Pakistan marked the anniversary of the ceasefire understanding of February 25, 2021 on the Line of Control (LoC) and other parts of the international border. True, the ceasefire never really meant any fundamental shift in Pakistan's state policy of sponsoring and waging a proxy war against India. Delhi, nonetheless, has been a stakeholder in the ceasefire agreement for as long as possible, even as its focus was on the Line of Actual Control with China. Pakistan, too, had its hands full, faced with a looming default crisis, internal security issues, and the deepening political instability that followed the overthrow of the Imran Khan government, which was masterminded by the military.

At any rate, the first major breach of the ceasefire agreement came on April 1, when Pakistan Army intruded into Indian territory and opened fire along the LoC in Jammu and Kashmir's Poonch district and our troops "responded effectively in a controlled and calibrated manner" while reaffirming commitment to the ceasefire agreement. That was a deliberate attempt to undermine the remarkable stability that was achieved in the Kashmir zone since 2019 after the abrogation of Article 370 and reorganisation of Jammu and Kashmir. The surge in terrorist activities has been "an issue of concern" for some time, to quote army chief General Manoj Pande. The south of the Pir Panjal range, which connects Kashmir Valley with Rajouri and Poonch via Mughal Road, has historically been a hotbed of militancy between 1997 and 2003. Hilly features, tough terrain, dense foliage and the prevalence of natural caves on Pir Panjal (where the army's footprint is

Intelligence gathering is a big challenge, as the terrorists, mostly foreigners, avoid making contact with civilians and stick to guerrilla tactics, making it difficult for security forces to gather information about their movement. Possibly, the deployment of troops out of the region to Ladakh following the tensions with China emboldened the terrorists to move in. The hill station of Gulmarg lies in the Pir Panjal range. That said, there is also the 'big picture' to be weighed in. The incursion on April 1 in Poonch sector, which was indeed a grave provocation by the Pakistani military, came in the downstream of the US administration's green-lighting of the extradition of Tahawwur Rana, a key plotter of the 26/11 Mumbai terror attacks, to India. It was on February 13, during a joint press conference with PM Narendra Modi, that President Donald Trump personally announced Rana's extradition to India. Can it be a coincidence that the terrorist strike on Pahalgam on April 22

coincided with the visit by Vice President J D Vance to India?

It must be a matter of exceptional concern to the General Headquarters of Pakistan Army in Rawalpindi that Delhi's policy of 'zero tolerance' toward terrorism is getting unprecedented support today under the stewardship of the FBI by Kash Patel and Director of National Intelligence Tulsi Gabbard. Pakistan has put on a brave face and washed its hands of Rana, a Canadian citizen. But things are not as simple as that once he begins to narrate how the terror ecosystem operates in Pakistan under the direct supervision of the military leadership. These are early days. Although the extradition treaty of 1997 stipulates India must ensure that Rana will not be tortured, will be provided adequate protection in prison, and will only be tried for the offences for which he has been extraditedlimiting India's legal options-the fact remains that he has been under US detention for the past 16 years alongside David Headley. A second aspect of immense relevance here collaterally is the belligerent outburst, out of the blue, by Pakistan's army chief General Asim Munir on April 17 during a diaspora event in Islamabad. At the meeting that was attended by Prime Minister Shehbaz Sharif, senior ministers and Pakistani elites living abroad, Munir described Kashmir as Pakistan's 'jugular vein' and exhorted overseas Pakistanis to pass on the country's story to their children, emphasising their forefathers believed that Hindus and Muslims were different in every aspect of life. Can it be a coincidence that Munir's inflammatory rhetoric came against the backdrop of the current dissonance within India over the Waqf (Amendment) Act 2025, which is putting the spotlight on properties donated by Indian Muslims over centuries? Third, it is both symbolic and consequential that the Kashmir issue figured in the talks between the foreign secretaries of Pakistan and Bangladesh in Dhaka on April 18, marking the resumption of such consultation after 15 years. According to the readout in Islamabad, Pakistan Foreign Secretary Amna Baloch took the initiative to brief the Bangladeshi side "on the situation in India's illegally occupied Jammu and Kashmir, emphasising the need for an early resolution of the dispute in accordance with UN Security Council resolutions and the aspirations of the Kashmiri people". Pakistan's Deputy PM and Foreign Minister, Muhammad Ishaq Dar, is due to visit Dhaka shortly. All indications are that a highly motivated axis is shaping up in the geopolitics of the region hostile towards India for the first time since the creation of Bangladesh. Interestingly, the Pakistani readout messaged that 'a shared commitment to a forward-looking partnership emerged' during the talks.

## Lashkar Chief Hafiz Saeed's Role Revealed in Pahalgam Terror Attack

New Delhi, (HS): The terrorist attack in Baisaran valley near Pahalgam, which ended in 26 people dying, has brought a long-active terror group operating in Jammu and Kashmir to the forefront. This terror attack, one of the deadliest since the scrapping of Article 370 in 2019, has triggered high-level diplomatic and security responses from the government against Pakistan, which has been accused of harbouring the handlers and backers of this terrorist group. The attack was carried out by a group affiliated with the proscribed Lashkar-e-Taiba (LeT) terror organisation, comprising mostly foreign terrorists, with support from local militants, overground workers from the Valley and under the control of 26/11 attacks mastermind and Lashkar chief Hafiz Saeed. According to sources, this particular module has been active in the Kashmir Valley for a long time. Security agencies believe it has been behind several high-profile attacks across the region, including in Sonamarg, Boota Pathri, and Ganderbal. In October 2024, four individuals, including two Indian Army personnel, were killed in a terror strike at Boota Pathri. That same month, Sonamarg witnessed a deadly assault on tunnel construction workers in which six labourers and a doctor were gunned down. Hashim Musa, one of the main accused in the Pahalgam massacre, is believed to a suspect in this attack. Following the Sonamarg massacre, a key figure in the module, Junaid Ahmed Bhatt, an A+ category Lashkar terrorist from Kulgam, was neutralised in an encounter in Dachigam in December 2024. Other members of the group managed to escape, dispersing into nearby forested regions. After a major attack, these terrorists typically go underground, hiding in dense forest hideouts until receiving fresh orders from their handlers in Pakistan. The module is reportedly controlled directly by Lashkar chief Hafiz Saeed and his deputy Saifullah, both believed to be operating from Pakistan. Indian intelligence agencies maintain that the module receives not only ideological but also logistical and tactical guidance from Pakistan's military and its intelligence agency, the Inter-Services Intelligence (ISI).

## 'Most unfair document': Omar Abdullah backs Centre's move to suspend Indus Waters Treaty

Srinagar/New Delhi, (HS) : Jammu and Kashmir chief minister Omar Abdullah, on Friday, called the nowsuspended Indus Waters Treaty with Pakistan the "most unfair document" for the people of the union territory, saying it never had their support. India on Wednesday suspended the World Bank brokered 1960 treaty on water sharing with Pakistan in response to the terrorist attack in Jammu and Kashmir's Pahalgam that killed 26 people. Abdullah spoke about the Centre's move after a meeting with various tourism, trade, and industry bodies amid reports of a tourist exodus from the union territory. "The Government of India has taken some steps. As far as Jammu and Kashmir is concerned, let's be honest, we have never been in favour of the Indus Waters Treaty. Now, what the



comes after India formally notified Pakistan in writing about the treaty's suspension. The decision was made during a meeting of the Cabinet Committee on Security (CCS) on April 23, chaired by Prime Minister Narendra Modi. Pakistan has said that any move to suspend water sharing by India will be treated as an "act of war." "India's reckless suspension of the Indus Waters Treaty is an act of water warfare; a cowardly, illegal move," Pakistan's power minister Awais Lekhari said in a post on X late on Wednesday night. Brokered by the World Bank, which is also a signatory, the treaty sets out a mechanism for water sharing and information exchange between the two nuclear-armed neighbours regarding the use of the Indus River water and its five tributaries: Sutlej, Beas, Ravi, Jhelum, and Chenab.

#### Houses of two LeT terrorists linked to Pahalgam attack destroyed in blast

SRINAGAR, (HS) :Houses of two Lashkar-e-Taiba (LeT) terrorists allegedly involved in the Pahalgam attack were destroyed in Jammu and Kashmir, officials said on Friday. The houses were destroyed in a blast on Thursday night. The officials said security forces were conducting searches inside the houses of two LeT terrorists Adil Hussain Thokar and Asif Sheikh when the explosives already kept inside the houses went off. The explosives caused destruction of the houses, they added. Thokar, a resident of south Kashmir's Anantnag district, is one of the key accused in Tuesday's Pahal massacre, while Sheikh, resident of Tral in Pulwama district, is suspected to be involved in the conspiracy of the attack. Thokar has been declared the most wanted, and the Anantnag Police have offered a reward of Rs 20 lakh for any specific information leading to his arrest. Two Pakistani nationals were also declared most wanted in the case. Adil had illegally travelled to Pakistan in 2018, where he reportedly received terror training before returning to Jammu and Kashmir last year.

New Delhi, (HS) : The Supreme Court on Friday issued a notice to the Chief Secretary of the Haryana government, summoning his personal appearance within four weeks to explain the alleged non-compliance with the court's earlier directions regarding a representation filed by Asha - the widow of a sewer worker who died in 2022 while cleaning a sewer. The bench noted on record that it appeared the State of Haryana had neither acted on the

Supreme Court's 3 January order nor considered the representation submitted by the petitioner. "Issue notice, returnable on May 9. The Chief Secretary, Government of Haryana, Chandigarh, is to personally remain present on the next date of hearing so as to make us understand why our order has not been considered and in what manner the representation of January 6 (received by the government on January 9) has been looked into," the bench said

in its order dated 25 April. Asha alleged that, despite submitting multiple representations in 2023 and 2024 seeking statutory compensation of ?30 lakh-in line with the Supreme Court's judgment in the Balram Singh case-she had received no payment. She subsequently filed a writ petition before the Supreme Court through her counsel, Pawan Reley and others. On 3 January 2025, the court directed the Haryana government to take a decision on the matter. Following the order, Asha submitted a fresh representation to the Chief Secretary on 6 January, which was delivered on 9 January.

## Amit Shah calls meeting to discuss future action on Indus Waters Treaty abeyance

New Delhi, (HS) : Union Home Minister Amit Shah will hold a key meeting on Friday to discuss the future course of action on the Indus Waters Treaty of 1960 with Pakistan, which has been kept in abeyance, sources said. Union Jal Shakti Minister C R Paatil and senior officials of several ministries will take part in the meeting, sources said. The meeting is expected to discuss the future course of action and how to implement the decision of keeping the treaty in abeyance, they said. India has already informed Pakistan of its decision to keep the Indus Waters Treaty in abeyance with immediate effect, saying Pakistan has breached its conditions. India's Water Resources Secretary Debashree Mukherjee said in a letter addressed to her Pakistani counterpart, Sved Ali Murtaza, that sustained crossborder terrorism by Pakistan targeting Jammu and Kashmir impedes India's rights under the Indus Waters Treaty. "The obligation to honour a treaty in good faith is fundamental to a treaty. However, what we have seen instead is sustained cross-border terrorism by



Pakistan targeting the Indian Union Territory of Jammu and Kashmir," the letter read. India's decision to suspend the decades-old treaty follows the killing of 26 people, mostly tourists, in a terror attack in Jammu and Kashmir's Pahalgam on Tuesday. "The resulting security uncertainties have directly impeded India's full utilisation of its rights under the treaty," the letter read. The communication to Pakistan also highlighted "significantly altered population demographics, the need to accelerate the development of clean energy, and other changes" as reasons necessitating a re-assessment of the treaty's obligations. To give effect to the decision, the government has also formally issued a notification to suspend the Indus Water Treaty. The treaty brokered by the World Bank has governed the distribution and use of the Indus river and its tributaries between India and Pakistan since 1960. The Indus river system comprises the main river, the Indus, and its tributaries. The Ravi, Beas, Sutlej, Jhelum and Chenab are its left-bank tributaries, while the Kabul river, a right-bank tributary, does not flow through Indian territory. The Ravi, Beas and Sutlej are collectively referred to as the eastern rivers, while the Indus, Jhelum and Chenab are known as the western rivers. The water of this river system are crucial to both India and Pakistan. At the time of Independence, the boundary demarcation between the two newly-formed nations - India and Pakistan - cut through the Indus Basin, leaving India as the upper riparian and Pakistan as the lower riparian state. Two key irrigation works - one at Madhopur on the Ravi and another at Ferozepur on the Sutlej - on which Punjab on Pakistan's side was entirely dependent, ended up within the Indian territory.

## **Police Aircraft Crashes in Thailand, Killing Six**



Bangkok, (H.S): A small police plane crashed near the shore of Thailand's resort town of Hua Hin on Friday morning, killing six people, the Thai police said. The Thai national police said on its social media page that the aircraft of the police aviation division crashed into the sea off Cha-am District, Phetchaburi Province shortly after taking off from the nearby Hua Hin airport, with all six on board killed.

The police said the accident took place when the plane was conducting a test flight for parachute training. All six people on board were police officers. Five died at the scene and one died later at a hospital, Xinhua news agency reported. Video footage showed the plane nosedive into the sea. Initial investigations suggest that the engine malfunctioned shortly after takeoff. The police said the cause of the accident will be investigated.The police emergency centre of Phetchaburi province said that it received notifications of a plane plunging into the sea just near a local resort at about 8:15 a.m.

Pol Lt Gen Archayon Kraithong, spokesman for the Royal Thai Police, said the incident happened during a test flight operation in preparation for a parachute training drill in Hua Hin. The victims were identified as Pol Col Prathan Khiewkham, Pol Lt Col Panthep Maneewachirangkul and Pol Capt Chaturawong Wattanapaisarn,

along with aircraft engineer Pol Lt Thanawat Mekprasert and mechanics Pol L/Cpl Jeerawat Maksakha and Pol Sgt Maj Prawat Pholhongsa, the Bangkok Post reported. Authorities have not confirmed the aircraft model, but images from the scene suggest it was a Viking DHC-6 Twin Otter. The crash occurred in the Hua Hin district, with the aircraft landing in the sea roughly 100 metres from shore. Photos reveal the plane partially submerged and broken in two.

The test flight was part of preparations for a parachute training exercise in the area. Officials from the public relations department of Prachuab Kiri Khan province confirmed the location of the crash. Further details about the cause of the accident and the condition of the crew were not immediately released. Emergency responders and investigators are on-site assessing the situation and collecting evidence to determine the cause of the crash.

Beirut, (H.S): Iranian Ambassador to Lebanon Mojtaba Amani was summoned to the Lebanese Foreign Ministry over remarks criticising efforts to disarm Hezbollah. According to the National News Agency on Thursday, the Ministry's Secretary-General, Hani Chmeitli, met with the Iranian ambassador and emphasised "the necessity of adhering to the diplomatic principles outlined in international agreements concerning the sovereignty of states and non-interference in their internal affairs, foremost among them the Vienna Convention".

The Iranian embassy in Lebanon announced in a statement that during the visit, the ambassador provided clarifications to the Lebanese side regarding the tweet he had recently posted, Xinhua news agency reported.In his X post on April 18, the ambassador said that "the disarmament project is



a clear conspiracy against nations ... Once these countries surrender to the demands of disarmament, they become vulnerable to attack and occupation, as was the case in Iraq, Libya, and Syria".He noted that its content was general and comprehensive, applying to all countries without exception, including Iran.

He added that this visit came as a precaution to avoid any misunderstanding misinterpretation between the two countries regarding the content of his post. Amani also emphasised "the need to prevent

#### **EPFO** Launches New Form 13 Functionality To Speed Up Transfer Claim Process



New Delhi, (PIB): The EPFO has further simplified the process for transfer of PF account on change of jobs by launching a revamped Form 13 software functionality that will speed up the transfer of funds to the new account, according to an official statement issued on Friday.

Henceforth, once the transfer claim gets approved at the transferor (source) office, the previous account will automatically get transferred to the present account of the member at the transferee (destination) office instantly, furthering the aim of "Ease of Living" for members of the EPFO. Till now, the transfer of PF accumulations used to happen with the involvement of two EPF offices. One, from which the PF accumulation is transferred

(source office) and the second being the EPF office to which the transfer is actually credited (destination office).Now, with an aim to further simplify the process, the EPFO has removed the requirement of approval of all transfer claims at the destination office by launching a revamped Form 13 software functionality, the statement said.

The move is expected to benefit more than 1.25 crore members, facilitating the transfer of around Rs 90,000 crore that takes place every year, as the entire transfer process will be speeded up. This revamped Form 13 functionality also provides the bifurcation of taxable and nontaxable components of PF accumulations to facilitate the accurate calculation of TDS on taxable PF interest. In January this

year, the EPFO made the transfer process easier by removing the requirement of approval from an employer in a majority of the cases of job change in jobs to make things easier for its members. The EPFO has also launched a facility for bulk generation of UAN by employers without Aadhaar seeding to facilitate the ease of doing business.

With a view to further Ease of Doing Business and to address the grievances being raised with respect to proper accounting of the past accumulations that had been remitted to the EPFO by the Exempted PF Trusts consequent to the surrender/cancellation of exemption and also in other cases involving remittance of past period contributions consequent to quasi-judicial/recovery proceedings, it has been decided

by the EPFO to relax the requirement of Aadhaar for generation of UAN/credit of past accumulations for such members, the official statement said.Also, a facility for bulk generation of UANs based on the Member ID & other member information available on record, so as to enable prompt crediting of funds in the accounts of such members has been provided.

To that effect, a software functionality has already been deployed and made available to the field offices in the FO Interface for bulk generation of UANs in the above said cases and also account for the past accumulations without the requirement of Aadhaar in EPFO Application, the statement said.

However, as a measure of risk mitigation to protect the PF accumulations, all such UANs would be kept in a frozen state and subsequently made operational only after the seeding of Aadhaar, the statement said.All these measures are expected to significantly improve services to members and reduce longstanding grievances, including further streamlining of validations for auto settlement of eligible claims, the statement added.

## **RBI** cancels licence of Jalandharbased Imperial Urban Co-op Bank



New Delhi, (H.S): The Reserve Bank of India on Friday said it has cancelled the licence of Jalandhar-based Imperial Urban Co-operative Bank as the lender does not have adequate capital and earning prospects. The Registrar of Cooperative Societies, Government of Punjab has also been requested to issue an order for winding up of the bank and appoint a liquidator for the bank. On liquidation, every depositor would be entitled to receive deposit insurance claim amount of his/her deposits up to Rs 5 lakh from Deposit Insurance and Credit Guarantee Corporation (DICGC). As per the data submitted by the bank, RBI said 97.79 per cent of the depositors are entitled to receive the full amount of their deposits from DICGC. As on January 31, 2025 DICGC has already paid Rs 5.41 crore of the total insured deposits. Giving reasons for cancellation of the licence of Imperial Urban Co-operative Bank, the RBI said the continuance of the bank is prejudicial to the interests of its depositors.

Transfer of Ownership of M2M SIMsIn this regard, TRAI, on 24.06.2024, issued a consultation paper on 'the Issues Related to Critical Services in the M2M Sector, and Transfer of Ownership of M2M SIMs' for

soliciting comments and counter comments from stakeholders. In response, TRAI received 16 comments and one countercomment from stakeholders. An open house discussion on the consultation paper was held on 24.10.2024 through virtual mode.Based on the comments received from stakeholders and on its own analysis, TRAI has finalized its recommendations on 'the Issues Related to Critical Services in the M2M Sector, and Transfer of Ownership of M2M

SIMs'.Machine to Machine (M2M) communication can enable applications and services across a broad range of vertical markets such as automotive, utilities, healthcare, safety & surveillance, financial, public safety, smart city and agriculture. At present, the M2M ecosystem is at an early stage of growth of its lifecycle. As the M2M ecosystem matures, and thereby gains user confidence, more and more services will be delivered to individuals, enterprises and

public institutions by using Internet of Things (IoT). Many of such services would be critical IoT services, requiring ultrareliable, low latency M2M connectivity with very high availability. As critical IoT will be used for delivering services of critical importance, the identification of services as critical IoT service requires to be done well in advance. The identification of a service as a critical IoT service would enable user agencies to enter into suitable service level

agreements (SLAs) with telecom service providers. Through the SLAs, telecom service providers may be held accountable for ensuring that the M2M connectivity provided by them meets the requisite telecommunication service performance parameters (such as latency, reliability, and availability) which are sacrosanct for the successful operation of the concerned critical IoT service. Through these recommendations, TRAI has recommended a broad guiding framework for classifying a

service as a 'critical IoT service'. TRAI has recommended that a service should be classified as a 'critical IoT service', if it passes the following twin tests:Whether the service (application) demands ultrareliable low-latency M2M connectivity with very high availability? Whether any disruption of the M2M connectivity used for delivering the service (application) will have a debilitating impact on national security, economy, public health, or public safety?

# Hina Reacts to Pahalgam Terrorist Attack: "Heartbroken as an Indian"

Hina Khan has broken her silence on the devastating terrorist attack in Pahalgam, Jammu & Kashmir. On Thursday (April 24), the actress shared a lengthy note on Instagram, condemning the heinous incident. Hina Khan wrote, "Condolences. Dark Day. Teary Eyes. Condemnation. Calls of Compassion. Nothing means anything if we fail to accept reality. If we don't accept what really happened, especially as Muslims, everything else is just talk. Simple talk. A couple of tweets and that's it.'

The actress added that the tragic incident left her heartbroken, affecting her mental health. She said, "The way this attack was conducted by heartless, inhuman, brainwashed terrorists who claim to be Muslims is beyond appalling. I can't imagine if a Muslim was forced to revoke his religion at gunpoint and was killed anyway. It breaks my heart." Hina Khan added, "As a Muslim, I want to apologise to all my fellow Hindus and my fellow Indians. People who lost their lives. Heartbroken as an Indian. Heartbroken as a Muslim. I can't get over what happened in Pahalgam." "It has affected me and my mental health. But it's not about me, and it's not my pain. It's the pain of everyone who has lost their loved ones. It's the pain every Indian is feeling. I am praying for their strength and peace. I am praying for the souls whom we lost. And we must not mince words. I condemn it. I reject it. And I hate those who did it. Wholeheartedly, absolutely, unconditionally," she wrote. Additionally, Hina Khan asserted that she stands in solidarity with the nation. She said, "Those who did this can follow any religion. They are not human beings to me. As embarrassed as I am by the acts of some Muslims, I pray to my

fellow Indians not to alienate all of us. All of us who call India our home and our motherland. If we end up fighting each other, we would be doing what they want us to do, to divide us, to keep us fighting and we must not let that happen as Indians." "As an Indian, I stand with my nation, our security forces, and I support our country. As an Indian, I believe all religions are safe and the same in my beautiful country. I will support my country's resolve to avenge this unconditionally. No excuses. No questions," the note read. Hina Khan also requested everyone to "bring back our brothers and sisters from the Kashmiri Pandit community", emphasising her belief in coexistence. On a concluding note, Hina Khan prayed for "justice as an Indian, as a Muslim and as a human being.



## Jewel Thief - The Heist Begins Review: Saif & Jaideep Star in Stylish Snoozefest



Unscrupulous art collector Rajan Aulakh (Jaideep Ahlawat) hits a momentary rough patch. He pins his hopes on the Red Sun to bail him out of the tight spot he is in. He blackmails Rehan Roy (Saif Ali Khan) into agreeing to rob the priceless diamond from a museum in Mumbai. Rehan has a dad somewhere in his backstory. The two do not see eye to eye. Rajan has a blood fetish (more on that later) that leads him into heinous deeds and dangerous deals. An agreement with an Istanbul crime lord Moosa (Laitongbam Dorendra Singh), a man he has a history of violence with, forces him to turn to Rehan. As Rajan and Rehan engage in a battle of attrition, it isn't the coveted stone alone that has Rehan's attention. Rajan's comely but unhappy wife Farah (Nikita Dutta), too, is in his sight. "The cricket fraternity is deeply shocked by the tragic

events in Pahalgam," he said, extending condolences to affected families and offering prayers for those lost.
