





#### Over dozen active terrorists in Kashmir Valley identified as suspects in Pahalgam attack



New Delhi, (HS) : The National Investigation Agency (NIA), continuing its investigation into the Pahalgam terror attack, has identified over a dozen Over-Ground Workers. Eight of them are from Lashkar-e-Taiba (LeT), and three each belong to Jaishe-Mohammad (JeM) and Hizbul Mujahideen (HM). They are suspected of aiding the terrorists in executing the attack, sources said on Monday. Sources said, based on intelligence inputs, nearly 60 terrorists are active in the Kashmir Valley. However, the NIA has zeroed in on over a dozen of them, and they are now under the agency's radar as the investigation into the Pahalgam terror case progresses. The NIA has identified them from among the list shared by the Intelligence Bureau following recording of the statements of survivors of the terror attack, which claimed 26 lives and left several others injured, in their respective home states. Of the 14 active terrorists on the NIA's suspect list, most are in their 20s and joined Pakistan-based terror outfits after 2022. They are active in various districts, with five in Shopian, four in Pulwama, two in Anantnag, and one each in Sopore, Awantipora, and Kulgam. According to sources, Ahsan Sheikh of LeT is suspected of being involved in the Pahalgam attack, along with four others. His house has already been destroyed by security forces. The house of another suspect, Shahid Kutay, who is also associated with LeT, has also been razed. Another terrorist JeM's Asif Sheikh's name has also figured in the Pahalgam terror attack and this meant that it was possible that JeM helped LeT in the killings on the directions of Pakistan's spy agency ISI, the sources said. Sheikh's residence in Tral was also demolished by security forces on Friday. It is to be noted that the Jammu and Kashmir Police has already released sketches of three terrorists including two Pakistanis - Ali Bhai alias Talha Bhai and Hashim Musa alias Suleiman and local operative Adil Hussain Thoker and announced Rs 20-lakh bounty each on their heads.

# Four Odisha Receive Padma Shri from President





### Odisha Intensifies Crackdown on Bangladeshi, Pakistani Infiltrators

Bhubaneswar, (DMC) : Odisha's Panchayati Raj Minister Rabi Narayan Naik on Monday announced that the state government is actively identifying Bangladeshi and Pakistani infiltrators at the panchayat level. A preliminary list of suspected foreign nationals has already been prepared, detailing their locations, activities, and places of residence across villages and towns.In response to recent terrorist attack at Pahalgam, the Odisha government has accelerated efforts to detect and act against unauthorized residents.



Individuals living without valid visas or overstaying their permitted duration are undergoing thorough scrutiny. Authorities are cross-verifying identity documents such as Aadhaar cards and voter IDs to detect fraud or illegal infiltration. To strengthen the verification

process, local elected representatives and community members are being consulted for inputs and suggestions. Minister Naik assured that a comprehensive list of identified infiltrators will soon be submitted to the Home Department for further action.

# "Most Dishonourable Act Known As Honour Killing, Must Be Punished": Top Court

New Delhi, (HS) : Honour killing must get a strong measure of punishment, the Supreme Court on Monday said and upheld the conviction of 11 accused for the "dastardly murder" of a young couple in Tamil Nadu in July 2003. A bench of Justices Sudhanshu Dhulia and Prashant Kumar Mishra refused to interfere with the Madras High Court's June 2022 verdict that upheld the conviction and sentence of the accused persons, including two police officers. The bench said the victims --Murugesan and Kannagi -- who were in their early twenties were killed by administering poison in full view of a large number of villagers. The masterminds and the main perpetrators of this "macabre act" were none other than the father and brother of the woman, it added.

The top court observed the reason behind the murder was that Kannagi belonged to the "Vanniyar" community whereas Murugesan was a Dalit from the same village in Cuddalore district. The couple secretly married in May 2003. "So, at the root of this crime is the deeply entrenched hierarchical caste system in India, and ironically, this most dishonourable act goes by the name of honour-killing," the bench said in its 73-page verdict. Advocate Priyadharshni

Rahul appeared for Murugesan's family. "A crime is an act against the state. But a wicked and odious crime, as the one we have just dealt with, is the ugly reality of our deeply entrenched caste structure. Honour-killing, as these are called, must get a strong measure of punishment," it said. The bench awarded a compensation of Rs 5 lakh to Murugesan's family and said the amount was liable to be paid by Tamil Nadu government. The amount was stated to be over and above the amount directed to be paid as compensation by the sessions court and the high court. On the role of the police officers, the bench said both committed

the offences under Section 217 of IPC and the Scheduled Castes/ Scheduled Tribes (Prevention of Atrocities) Act, 1989 as they neglected their duties and disobeyed the law by not registering the FIR at the first instance with the intention to save the culprits. Section 2017 of the erstwhile IPC dealt with public servant disobeying direction of law with intent to save person from punishment, or property from forfeiture. The bench said Murugesan's family moved the high court, which in April 2004 directed hand over of the probe to CBI. Though the incident took place in July 2003, the trial was concluded only in September

2021, it added. "The long and inordinate delay which has been caused in this case, right from the lodging of the FIR, speaks volumes about the gross inefficiency at the hands of the prosecution on the one hand and dilatory tactics employed by the defence on the other hand, which together led to a slow trial," the verdict said.

Witnesses turning hostile was underlined to be one of the key events in the case. "This phenomenon is not new, in fact it is sadly a common occurrence in our criminal courts today, much to the despair and frustration of the prosecution," the bench said. "But then the

purpose of a trial court is to go to the truth of the matter. Whatever evidence is there before the court must be examined, tested, corroborated (whenever necessary), before a verdict can be finally given," it said. The bench noted one of the many reasons for witnesses turning hostile was the long delay usually caused in a trial. "This is again unfortunate but true in our country," it said, "and it took 18 years to pronounce verdict in the case by the trial court".

The court underscored the presence of "enough material" placed by the prosecution in the trial court turning sufficient to prove the guilt of the accused

beyond a reasonable doubt. The bench directed those on bail in the case to surrender within two weeks to undergo their remaining sentence. Of the total 15 accused who faced trial in the case, 13 were convicted. Of the 13, 11 were punished for murder and one of the convicts was awarded death sentence by the trial court whereas the rest were sentenced to life imprisonment. It came on record that the high court acquitted two accused. The two police officers were also convicted by the trial court and both were sentenced to life term.

The bench noted the high court commuted the death

# **Environmental Change**

The time snow remains on the ground during the winter months in the Himalayan Hindu Kush Region (HKH) has been coming down drastically in recent years. Four of the five winters between 2020-21 and 2024-25 saw below-normal snow persistence. According to a report by the International Centre for Integrated Mountain Development (ICIMOD), released on Monday, the snow level plummeted to a record 23.6 per cent low in the winter of 2024-2025. When it melts in summer, the snow from the mountains contributes about a fourth of the run-off of the 12 major rivers in the region, including the Ganga, Indus, Brahmaputra, Mekong and Amu Darya. The winter season anomalies could, therefore, lead to reduced snow melt and, in turn, affect the water security of more than two billion people across these river basins, the ICIMOD report warns. The fall in river run-offs could have spinoffs on water availability for drinking, irrigation, and hydroelectricity generation. Low snow persistence is a classic fallout of climate change. The Himalayan region, for instance, is particularly vulnerable to high temperatures. Studies have shown that the rise in temperature in the Himalayas has exceeded the global average for at least four decades. An ICIMOD report of 2019 had warned that even if the global temperature rise is limited to the Paris climate pact's threshold of 1.5 degrees Celsius, the HKW region will witness a warming of 0.3 degrees Celsius. Local developments like changes in the land system — the transformation of farmlands into urban areas - have combined with broader climatic changes to drive the temperature rise. Extratropical storms from the Mediterranean, for instance, are known to contribute to winter precipitation in the Himalayas. But weaker western disturbances in recent years seem to have disrupted the timing of seasonal precipitation, leading to shifts in snowfall patterns. In the coming months and years, policymakers will need a two-pronged approach to climate change. Even as they plan a transition towards greener forms of development, planners will need to find ways to shield people from the adverse effects of global warming. The ICIMOD report should occasion investments in better water management, drought-proofing agriculture, improvements in warning systems and greater regional cooperation on rivers and natural resources. The countries in the Subcontinent and China usually collaborate in global climate forums. However, riparian issues are amongst the most contentious in the region, and ecosystem-based approaches are often hostage to politics. Establishing comprehensive datasharing systems for managing river flows, along with effective flood and drought alert mechanisms, can significantly reduce the vulnerabilities faced by individuals due to the impacts of melting glaciers and diminishing snowfall.

Additionally, creating a unified renewable energy grid will enhance resilience against these environmental changes, ensuring that communities are better prepared for the challenges posed by climate change. By integrating these systems, we can foster a more sustainable approach to resource management and improve the overall safety and well-being of affected populations.

The World Wildlife Fund's 'Living Planet Report 2024' had made a shocking and alarming revelation a few months ago that between 1970 and 2020, there was a

catastrophic decline of 73 percent in the population of wildlife, including mammals, birds, amphibians, reptiles, etc. This decline in freshwater ecosystems has been 85 percent. Published every two years, this report shows how wildlife populations are being affected around the world. To protect wildlife from extinction, the 'Wild Elephant Protection Act' was first enacted in the country in 1872 during the British rule. After this, the 'Indian Forest Act' came into existence in 1927, making hunting of wildlife and illegal logging of forests a crime, under which punishment has been prescribed. After the country's independence, the 'Indian Forest Act' was passed in 1956 and in 1972, the 'Wildlife (Protection) Act 1972' was enacted with the aim of providing protection to wildlife in the country and controlling hunting,

smuggling and illegal trade.

In the year 1983, the 'National Wildlife Scheme' was launched for the conservation of wildlife, under which national parks and wildlife parks were created to keep wildlife away from human encroachment and protect them. In January 2003, the Wildlife Protection Act was amended and the fines and punishments for offences under the Act were made stricter. However, it is very important for everyone to understand that the conservation of wildlife is a big responsibility of all of us because the diversity of wildlife is the natural beauty of the earth, therefore, protecting many species of endangered plants, animals along with their natural habitat is extremely important for environmental balance.

The father gets angry and in disgust at his interference shouts that he is going to give the son away to Yama, the god of death. The son rresolves that the words uttered by the father should not be untrue, so he proceeds to the residence of Yama to offer himself up as a ritualistic gift. The body spends three nights waiting to see the god. When Yama discovers his presence, he feels sorry that the boy had to wait so long, so he decides to grant him three boons, one for each night he waited. Nachikethas asks first that when he returns home, his father will have shed anger and gained mental equanimity

secret of the absence of hunger and fear of death in the heaven worlds. Yama gladly grants these boons and further initiates his new disciple into the details of special ritual ceremony. Yama sees the reverence, intelligence, and eagerness of his new pupil and is much pleased with him. Nachikethas then asks for his third boon. He tells his new teacher.

"Sopme say that death is not the end; that there is an entity called the Atma which survives the body and senses. Teach me that secret of the Atma." Yama at first resists and decides to test him to see it he is deserving of this unique knowledge. He offers him many other attractive boons involving worldly prosperity and happiness. But Nachikethas firmly declines these ephemeral favors. The alternative boons you hold before me can not assure me the everlasting benefit that Atmajnana (Atmic Knowledge) alone can bestow. Yama is again pleased with his pupil and decides he is fit to receive the highest wisdom. The remainder of the Upanishad contains his teachings to Nachikethas. The young disciple grasped the teaching immediately and thoroughly and putting them into practice, he attained to Brahman.

### 12 Pakistani Nationals Identified In **Odisha, 1 Left For Pak: DGP Khurania**



Bhubaneswar. (DMC): A total of 12 Pakistani nationals have been identified in Odisha with 'quit-India' notices being issued to them, as confirmed by the Director General of Police (DGP) Yogesh Bahadur Khurania, on Monday. In a statement to the media, DGP

Khurania revealed that one of the Pakistani nationals has already departed from Bhubaneswar and returned to Pakistan."We have identified 12 Pakistani nationals residing in the state and 'quit-India' notices have been served to them. We are closely monitoring the situation and one

person has already left the state. We are awaiting further instructions regarding those residing on long-term visas or whose visa applications are still under consideration," stated DGP Khurania. This action follows a directive issued by Union Home Minister Amit Shah on April 24, urging Chief Minister Mohan Charan Majhi to identify all Pakistani nationals in Odisha and facilitate their return to Pakistan by April 27.

The departure of the individual comes amid rising tensions following the recent terror attack in Pahalgam, Jammu and Kashmir, where 26 people, including both civilians and tourists, lost their lives.

# **Odisha Crime Branch Arrests 7 In Multi-Crore Pilgrim Accommodation Fraud**

Bhubaneswar, (DMC): The Cyber Crime Unit of the CID, Crime Branch Odisha, has successfully apprehended seven persons, including the prime accused, who allegedly created a fraudulent website for 'Niladree Bhakta Nivas' in an attempt to defraud unsuspecting pilgrims seeking accommodation. The arrested persons have been identified as Anshuman Sharma (24), the prime accused; Aravind Kumar (35) and Akash Kesharwani (33) from Uttar Pradesh; and Hiteshbhai Patra (39), Parth Parmar (25), Thakkar Karsanji Sobhaji (48), and Kureshi Mohammed Aslam (31) from Gujarat. According to an official press release, the case was initiated following a written complaint from the Chief Administrator of the Shree Jagannath Temple in Puri.The complaint sought action against fake website. the www.neeladribhaktanivas.in,



Cyber Crime Unit used technical tools to trace the hosting company of the fake website.It was discovered that Anshuman Sharma had created the website on May 22, 2024. The fraudulent site was swiftly taken down once the complaint was recorded. Another accomplice, Aravind Kumar, whose bank account was used for the illicit transactions, was also identified during the investigation. Authorities have seized several items from the arrested suspects, including a laptop, mobile phones, SIM cards, details related to the Niladri Bhakta Nivas website, Aadhar cards, PAN cards, GoDaddy hosting information, and the registered SIM card used for the creation of website.In further the developments, two investigative teams have been dispatched to Gujarat (Ahmedabad, Anand District, Surat) and Uttar Pradesh to continue probing the case

under CID CB Cyber-Crime P.S. Cases No: 50/2024, 60/2024, 57/ 2024, and 03/2025. Akash Kesharwani (33) from Prayagraj, Uttar Pradesh, was arrested after Rs 3.7 lakh was transferred to his account. Seized items included mobile phones, Aadhar cards, and PAN cards. Further investigation revealed the involvement of additional current accounts in similar fraudulent activities.' Investigation into the case is ongoing. Our team will uncover other accomplices in this crime, its trans-India ramifications, and the money trail," the notification stated.The Crime Branch police also urged citizens to be cautious of unsolicited investment offers on social media and messaging apps.They advised always verifying before investing to avoid falling victim to cyber fraud and to report such incidents at the 1930 Cyber Helpline or at the nearest police station.

### No error in Allahabad HC order impleading Centre and ASI in Shahi Idgah mosque case, says SC

New Delhi, (HS) : The Supreme Court on Monday said that the order passed by the Allahabad High Court in the Shahi Idgah case, allowing the Hindu side's plea to amend their plaint and add the Archeological Survey of India (ASI) as a party, is prima facie correct. The high court on March 5 allowed an amendment application filed by the Hindu side (plaintiffs) permitting them to incorporate new facts into the suit and add the Union of India and ASI as defendants.

Challenging this HC order, the Muslim side had moved the top court and sought quashing of it. The Muslim side, in the top court, opposed the Hindu parties application to amend the suit. They said it was a way to get around their defence, which was based on the Places of Worship Act. During the course of the hearing, the two-judge bench of the top court, led by Chief Justice of India (CJI) Sanjiv Khanna and including Justice PV Sanjay Kumar, refused to entertain the appeal of the Muslim side. #### New Pahalgam Attack Video Emerges, Shows Tourists Hiding Behind Kiosk

New Delhi, (HS) : A new video showing the helpless tourists at Pahalgam during the massive terror attack is being widely circulated online. Terrorists belonging to an offshoot of Lashkar e Taiba had mowed down 26 people -- only one of them a local -- during the attack on April 22. The video shows a number of men, women and children huddling around a kiosk of Kashmiri outfits in the middle of the picturesque Baisaran Valley. The sound of gunfire can be heard in the distance. The terrorists had targeted a group of tourists and had shot down the men. Some of the survivors claimed that they had deliberately killed the Hindus after confirming their religion. Since then, multiple videos of the massacre and the mayhem have emerged, documenting the terror and helplessness of the tourists and the courage and heroism of locals, who managed to save many lives, often at a great risk to themselves. The Kashmiri local who died was a pony handler, who had tried to save the lives of tourists on his ponies. He was shot by the terrorists when he was trying to shield a tourist with his body.

High Court's decision to allow the Hindu plaintiffs to do so was wrong," the court said. This order of the top court necessarily means that the Hindu plaintiffs have to be allowed to implead the ASI and the Union in the main suits filed on behalf of the deity. The apex court on Monday granted time to the Muslim side to file their reply and deferred the hearing to April 8. The complex is located adjacent to the Krishna Janmabhoomi temple, a site of significant religious importance for Hindus.

The mosque committee, in its appeal filed in the apex court, said the lawsuits filed by Hindu litigants over the dispute violated the Places of Worship (Special Provisions) Act, were therefore and not maintainable. It is to be noted that Allahabad High Court judge Justice Mayank Jain had on August 1, dismissed the plea filed by the Shahi Idgah Masjid Committee challenging the maintainability of the suits filed by the Hindu parties seeking restoration of the Lord Krishna temple at the location where the mosque exists. The Hindu parties claimed in the HC that Sri Krishna's birthplace lies beneath the mosque and that there were many signs which established that the mosque was indeed a Hindu temple. On the other hand, the UP Sunni Central Waqf Board sought dismissal of the plea filed by the Hindu side. It argued in the HC that the suits of the Hindu side were barred under the Places of Worship (Special Provisions) Act, 1991 ('Places of Worship Act') that prohibited changing the status of any place of worship from what it was on the day of the country's Independence.

# J&K CM as Assembly moves resolution denouncing Pahalgam attack

SRINAGAR, (HS) : Jammu & Kashmir Assembly on Monday passed a unanimous resolution strongly condemning the terror attack at Baisaran meadow in J&K's Pahalgam in which 25 tourists and a local resident were killed. The resolution was moved by Deputy Chief Minister Surinder Choudhary at the beginning of the special session of the Assembly today. The resolution described the attack as a heinous,

barbaric, inhumane and cowardly act, and was unanimously adopted by the House after a three-hour-long discussion. "This House unequivocally condemns the heinous, cowardly act that resulted in the loss of innocent lives. Such acts of terror are a direct assault on the ethos of Kashmiriyat, the values enshrined in our Constitution, and the spirit of unity, peace, and harmony that have long characterised Jammu & Kashmir and our nation," read the resolution. On April 22,



a group of three Lashkar militants attacked tourists at Baisaran meadow, which is also called mini Switzerland, killing 25 tourists and a local resident, Syed Adil Shah, who attempted to snatch the weapon from the militants to save the lives of tourists. The House expressed its solidarity with the victims and their families. "We extend our deepest condolences to those who have suffered irreparable loss and affirm our collective resolve to share in their grief and support them in their hour of need," reads the resolution. The resolution also remembered the valiant efforts by Syed Adil Shah, the horse rider, to save tourists during the terror attack. "This House salutes the supreme sacrifice of Shaheed Syed Adil Hussain Shah, who, while bravely attempting to save tourists, laid down his life. His courage and selflessness embody the true spirit of Kashmir and shall serve as an enduring inspiration for future

generations," it reads. The resolution praised the efforts of people in J&K in the aftermath of attack. "This House commends the people of Jammu & Kashmir for their extraordinary display of unity, compassion, and resilience in the aftermath of the attack. The peaceful demonstrations across towns and villages, and the spontaneous outpouring of moral and material support towards tourists, reaffirm the people's steadfast commitment to peace, communal harmony, and the rule of law," the resolution states.

#### Parliamentary Standing Committee on defence to meet today afternoon

New Delhi, (HS) : The Parliamentary Standing Committee on Defence will meet on Monday afternoon at 3:00 PM in the Parliament House Annexe. This development comes as Defence Minister Rajnath Singh met Prime Minister Narendra Modi at 7, Lok Kalyan Marg. The meeting comes a day after Chief of Defence Staff Anil Chauhan briefed the Defence Minister on the key decisions taken to counter Pakistan following the deadly Pahalgam terror attack in Jammu and Kashmir. Today's meeting also comes three days after the all-party meet held in Parliament premises on the Pahalgam terror attack, which the Defence Minister chaired. The attack, which occurred on April 22, 26 individuals, mostly tourists, including one Nepalese national, were brutally gunned down. The incident happened around 2 pm at Baisaran meadow. It was one of the deadliest attacks in the region since the 2019 Pulwama strike, which claimed the lives of 40 Central Reserve Police Force (CRPF) jawans.

# SC Drops Bail Cancellation Proceedings against Senthil Balaji After He Resigns as TN Minister

New Delhi, (HS) : The Supreme Court on Monday disposed of an application seeking recall of its decision which had enlarged DMK leader and former Tamil Nadu minister Senthil Balaji on bail in connection with a money laundering case linked to an alleged cashfor-jobs scam. A Raj Bhavan communique accepting the resignation of Balaji, who was Minister for Electricity, Prohibition and Excise in Tamil Nadu government, was placed before a bench of Justices Abhay S. Oka and A.G. Masih. The Justice Oka-led Bench on April 23 told the senior DMK leader to choose between his ministerial post and bail in the money laundering case, as it dealt with an application claiming that Balaji may influence the case witnesses in his capacity as a minister. It had cautioned Balaji that if he did not step down from his minister post, it would recall its bail order, noting that the top court had made a mistake by ignoring the previous judgments against him. "We are giving him a choice. Freedom or post? [T]he judgment of the Madras High Court

# Siddaramaiah's Slap Gesture at Cop after He Loses Cool on Stage

**Belagavi, (HS) :** Karnataka Chief Minister Siddaramaiah snapped at a police officer during a Congress rally today. The Chief Minister lost his cool and nearly slapped the Additional Superintendent of Police (SP) after he was shown black flags allegedly by BJP workers at the rally in Belagavi.

Standing on a stage, flanked by Congress leaders and workers, Siddaramaiah was seen calling the officer. The furious leader asked him how people were allowed to protest and wave black flags inside the rally venue. "Hey, come here, who's the SP? What are you guys doing?" the veteran Congress leader was heard saying before the audio became unclear. He even raised his hand, which seemed like a slap gesture, at Dharwad Additional SP Narayana Baramani. The police officer was seen swiftly stepping back. Siddaramaiah's action has drawn a lot of ire from his political opponents. "Power is not permanent," warned Janata Dal Secular or JDS, in a post on X. "Raising your hand to hit the police officer does not bring any glory to your position or dignity. Your term of office is only 5 years. But a government officer serves till the age of 60. Power is not permanent



for anyone. Correct your misconduct," read the post. Karnataka BJP spokesperson Vijay Prasad said, "Your act of raising your hand against a police officer is a disgrace of the highest order. Your arrogance has crossed all imaginable limits. This is an unforgivable display of contempt for the very institutions you are sworn to uphold."

"You must immediately and unconditionally apologise to the officer you sought to humiliate. Your insatiable lust for power is corrupting your judgment and dragging your office into shameful depths. Such despicable behaviour is utterly unbecoming of any leader, let alone one occupying the highest seat of the state," she added. Former Union Minister and BJP MLA Basanagouda R Patil termed Siddaramaiah's behaviour as "unexpected" and sought an "unconditional apology" for the "insensitive behaviour". "The Chief Minister is demoralising not only the Police officers but also the entire Police Department. Such a mentality of harassing and manhandling Police Officers for lapses and loopholes deserves the harshest condemnation. I urge the Chief Minister to offer an unconditional apology for his insensitive behaviour," he posted on X. Siddaramaiah's deputy and Congress leader DK Shivakumar, meanwhile, has warned the BJP over the black flags at the party rally. I am warning you (BJP). You have to set things right and advise your party workers against such acts. If not, I will not let any event of yours happen in Karnataka. We are ready for any type of protest. Let this be a warning. I am not requesting, I am warning you, that's all I want to say." This comes just a day after the BJP seized on the Chief Minister's "no need for war" with Pakistan comments. Siddaramaiah clarified his stand after the Pakistani media picked up his comments, and said that he did not say "complete no to war", but meant there should be war only if it is inevitable

His remark came in the wake of a terrorist attack in Jammu and Kashmir's Pahalgam that killed 26 civilians, mostly tourists. India has blamed Pakistan for the attack and taken several diplomatic measures against the country, including the suspension of the Indus Waters Treaty.

So in that situation, some strategic decisions have to be taken, so those decisions have been taken," Defence Minister Khawaja Muhammad Asif told Reuters in an interview at his office in Islamabad. Asif said Pakistan's military had briefed the government on the possibility of an Indian attack. He did not go into further details on his reasons for thinking an incursion was imminent. He said Pakistan was on high alert and that it would only use its arsenal of nuclear weapons if "there is a direct threat to our existence". The attack sparked a huge manhunt for the terrorists and India has identified two of them as Pakistani. Islamabad has denied any role and called for a neutral investigation. Since the attack, India has downgraded diplomatic ties with Pakistan, suspended the Indus Waters Treaty, announced the closure of the main land border crossing and withdrawn visas for Pakistan nationals.

Mirroring New Delhi's steps, Islamabad ordered the expulsion of Indian diplomats and military advisers, cancelled visas for Indian nationals and barred its airspace to Indian airplanes. Earlier today, the Indian government banned more than a dozen Pakistani YouTube channels over their "provocative" content. The banned platforms include the YouTube channels of Pakistani news outlets Dawn, Samaa TV, ARY News, Bol News, Raftar, Geo News and Suno News.

### South Korea: Lee Jae-Myung Tapped Presidential Candidate For Democratic Party



**Seoul, (H.S):** Lee Jae-myung, former leader of South Korea's Democratic Party, who is the front-runner in opinion polls for the upcoming presidential election, won the party's presidential nomination on Sunday.The human rights lawyer-turned-politician won 89.77 per cent of all votes cast in the party's primary, securing a majority of the votes needed to



avoid a runoff. Lee has put economic recovery as his top priority and voiced openness for talks with North Korea, reports Yonhap news agency.This marks the highest figure ever recorded in a presidential primary among DP-affiliated candidates since South Korea's democratisation in 1987.Gyeonggi Province Gov. Kim Dong-yeon came in second with 6.87 per cent, while Kim

Kyung-soo, a former South Gyeongsang Province governor, won 3.36 per cent."I will humbly fulfil the responsibility of achieving national unity, which is both the mission of politics and the president's top priority," Lee said in his acceptance speech.In 2022, Lee lost to former President Yoon Suk Yeol by just 0.73 percentage points. The presidential election is scheduled for June 3.

Additionally, the minor opposition Rebuilding Korea Party (RKP) also officially declared its support for Lee Jae-myung." We declare that Lee is not only the DP's candidate but also the candidate supported by our party. We will dedicate all our efforts to ensure Lee's overwhelming victory," the RKP's acting leader, Kim Sun-min, said in a release. Wellington, (H.S): The New Zealand government is stepping up preparations for the possible arrival of the H5N1 strain of avian influenza, emphasising the importance of a collaborative approach to tackling high pathogenic avian influenza (HPAI).

Tracing did not detect any HPAI-infected chickens beyond the farm where the disease originated," Hoggard noted. He credited the swift containment and eradication of the disease to a focused response and strong support and expertise from the wider poultry industry.New Zealand's robust biosecurity system and its relative freedom from pests and diseases continue to be key advantages for the country's farmers, he said. Hoggard added that the work undertaken to prepare for a potential H5N1 outbreak, a strain responsible for millions of bird deaths overseas, helped New Zealand respond effectively to the less severe H7N6 case, Xinhua news agency reported."

Our geographic isolation has protected us from H5N1 to date, but we can't afford to be complacent," he warned. According to the World Health Organization, Avian influenza A(H5N1) is a subtype of influenza virus that infects birds and mammals, including humans in rare instances. The goose/ Guangdong-lineage of H5N1

avian influenza viruses first emerged in 1996 and have been causing outbreaks in birds since then.Since 2020, a variant of these viruses belonging to the H5 clade 2.3.4.4b has led to an unprecedented number of deaths in wild birds and poultry in many countries in Africa, Asia and Europe. In 2021, the virus spread to North America, and in 2022, to Central and South America.

Infections in humans can cause severe disease with a high mortality rate. The human cases detected thus far are mostly linked to close contact with infected birds and other animals and contaminated environments. This virus does not appear to transmit easily from person to person, and sustained human-to-human transmission has not been reported.

Since March 2, Israel has kept Gaza's crossings closed to food, medical, and humanitarian aid, deepening the humanitarian catastrophe, according to government, human rights, and international reports."

This is the longest closure the Gaza Strip has ever faced, exacerbating already fragile markets and food systems," it said, adding: "People are running out of ways to cope, and the fragile gains made during the short ceasefire have unravelled."

## Afghan Interim Govt Expresses Sympathy With Iran Over Port Explosion2024 Global Military Spending Hit \$2.7 Trillion In Record Surge

Authorities have declared a public health emergency in the region due to the release of toxic chemicals into the air, advising residents to stay indoors and take precautionary measures.

**Gaza**, (**H.S**): Amid changing geopolitical relations, wars and rising tensions, the year 2024 saw the steepest rise in worldwide military expenditure since the end of the Cold War, reaching \$2.7 trillion, researchers said Monday. The military spending increased



amounts to 43 per cent of Russia's spending. At 34 per cent of GDP, Ukraine had the largest military burden of any country in 2024."Ukraine currently allocates all of its tax revenues to its military...In such a tight fiscal space, it will be challenging for Ukraine to keep increasing its military spending," SIPRI said. Germany's spending also increased by 28 per cent, reaching \$88.5 billion, overtaking India as the fourth largest in the world. With this, Germany has become the biggest spender in Central and Western Europe for the first time since its reunification. While some of the increases have been a result of European military aid to Ukraine, it has also been fuelled by concerns of potential US disengagement with the alliance."There has really been a shift in European defence policies, where we will see largescale procurement plans into the arms industry in the years to come," Xiao Liang, a researcher with the SIPRI, told AFP.

Over 100 countries around the world raised their military spending in 2024," SIPRI said, according to a Reuters report." As governments increasingly prioritise military security, often at the expense of other budget areas, the economic and social trade-offs could have significant effects on societies for years to come," it added. In real terms, the expenditure rose by 9.4 per cent globally compared to 2023, with 2024 marking the 10th year of consecutive spending increases. The data showed that many

European countries (including Russia) saw an "unprecedented" rise in their military spending amid war in Ukraine and doubts over U.S. commitment to the NATO alliance. With a 17 per cent hike, European military spending has reached beyond the level recorded at the end of the Cold War, the data showed.Russia's military expenditure reached an estimated \$149 billion in 2024, a 38 per cent increase from 2023 and double the level in 2015.

This represented 7.1 per cent of Russia's GDP and 19% of all government spending. Ukraine's total military expenditure grew by 2.9 per cent to reach \$64.7 billion, which

# Lynched For Belief: The Systemic Persecution of Ahmadi Muslims In Pakistan

New Delhi, (H.S): On April 18 this year, a 47-year-old car workshop owner was brutally killed with sticks and bricks as a mob of hundreds stormed his place of worship, while numerous others had to be rescued by police in the city of Karachi, Pakistan. This horrific incident, which should provoke national outrage and deep sorrow, failed to elicit a strong response from civil society or a decisive intervention from the state.

The reason lies in the fact that both the victim and the worship site belonged to the Ahmadi Muslim minority- a community that routinely faces violent persecution, systemic political and bureaucratic discrimination, and institutionalised oppression within Pakistan.Each year, reports by governmental bodies, international human rights organisations, and community advocates document the persistent assaults on Ahmadi Muslims in Pakistan by Islamist factions or radicalised mobs, with no meaningful intervention by the state. In some instances, the state appears overtly complicit in such actions- for example, in March of this year, a 120-year-old Ahmadi place of worship was demolished by police following pressure and complaints from Islamist groups claiming the structure resembled a mosque. To offer a glimpse into the societal persecution faced by this community:

Ahmadi Muslim graves are frequently defiled and vandalised, while individuals endure constant harassment, targeted assassinations, mob violence, unofficial commercial boycotts, employment discrimination, and abuse on digital platforms. This is compounded by the alarming frequency of blasphemy accusations levelled against Ahmadi Muslims, for reasons such as possessing the Quran, inscribing Prophet Muhammad's



name on a wedding invitation, or engaging in prayer using language or gestures considered distinctly Islamic.While opposition to the Ahmadiyya community has existed since its inception in the late 19th century by Mirza Ghulam Ahmad of Qadian in Punjab, the most critical blow to Ahmadi Muslims in Pakistan was delivered through the 1974 constitutional amendment, which officially declared them non-Muslims. Despite sharing the majority of beliefs and practices with mainstream Muslims, Ahmadis diverge in their recognition of Mirza Ahmad as the Mahdi or Messiah, a belief that conflicts with the Islamic doctrine of Khatam-e-Nubuwwat (the finality of the Prophet Muhammad).Subsequently, in 1984, General Zia-ul-Haq issued an ordinance prohibiting Ahmadi Muslims from performing Islamic rites or displaying religious symbols associated with Islam, such as erecting domes or minarets on their places of worship. In 1985, he also introduced segregated voter lists

based on religious identity, effectively requiring Ahmadi Muslims to renounce their beliefs in order to vote. This marked the onset of a formalised system of legal disenfranchisement and persecution, which continues today. Although the practice of separate electoral rolls was ended in 2002, Ahmadi Muslims were excluded from this reform.

The requirement to repudiate their faith has since permeated various aspects of governance, barring them from essential state services such as obtaining a passport. Notably, in October 2022, Punjab's provincial government mandated the inclusion of a declaration affirming the finality of the Prophet Muhammad within the marriage registration form.The emergence of the far-right Tehreek-e-Labbaik Pakistan (TLP), the group whose supporters were involved in the recent attack and killing of an

Ahmadi Muslim man in Karachi, has significantly deepened the climate of fear and marginalisation experienced by the community. The TLP rose to national attention in 2017 when it staged a three-week blockade of a major highway in Islamabad to protest a minor amendment to the electoral oath, which the group perceived as a dilution of the state's stance against Ahmadi Muslims.

The government ultimately conceded to their demand by reinstating the original wording, resulting in the resignation of Law Minister Zahid Hamid. Such is the influence of far-right sentiment that, in 2018, the Imran Khan-led PTI government succumbed to pressure from extremist groups and requested that Princeton professor Atif Mian resign from his role as Economic Adviser solely on account of his Ahmadi Muslim identity. While the systemic exclusion of Ahmadi Muslims in Pakistan was initiated and continues to be upheld by the state, the deep-seated societal animosity it has fostered has now grown beyond the state's control. Decades of intentional state policy targeting the community for political gain have inflicted lasting damage on the nation, fostering a society deeply afflicted by radicalism, self-destructive impulses, and toxic intolerance.

According to data compiled by the Ahmadiyya community, at least 264 Ahmadi Muslims were killed in targeted attacks, mob violence, and bombings between 1984 and 2018. It is important to note that even Pakistan's first and only Nobel Laureate, Abdus Salam, was not spared from the effects of this pervasive hostility- his gravestone was defaced to erase the word 'Muslim' due to his Ahmadi Muslim identity.

# Adding 50 GW renewable energy yearly can end coal imports by 2029, save India \$66 bn IRFC Shares In Red Ahead of Q4 Results Announcement Today

New Selhi, (H.S): If India adds 50 gigawatts of renewable energy every year, it could completely stop importing thermal coal by 2029 and save about USD 66 billion in foreign exchange between 2025 and 2029, according to a new report published on Monday. The total savings could be at least USD 173 billion from 2025 to 2034, the report prepared by think tank Climate Risks Horizon said.

The climate and energy think tank said the country's electricity sector remains heavily dependent on coal imports, with around 20 per cent or 206 million tonnes of thermal coal imported in 2023-24 at a cost of USD 21 billion.

Thermal coal imports have risen by 58 per cent between 2013 and 2023, but the value of these imports has increased by 124 per cent due to volatile global prices and a weakening rupee .. it added. The report said imports surge during the summer months, when cooling demand pushes up electricity



consumption. To achieve this, the government plans to add 50 gigawatts of renewable energy every year until 2027-28. Currently, India has about 151 gigawatts of renewable energy from solar and wind and around 200 gigawatts if hydro, smallhydro and biogas is included. To meet the 2030 goal, the country needs to add 50 gigawatts of renewable energy every year.In 2024-25, India added 24 gigawatts, the highest amount added in a single year so far.

India's Index of industrial production records growth of 3% in March 2025

**New Selhi, (PIB):** As per the revised calendar, the Quick Estimate of Index of Industrial Production (IIP) will now be released on 28th of every month (or next working day if 28th is a holiday).

The index is compiled with data received from source agencies, which in turn receive the data from the producing factories/ establishments. These Quick Estimates will undergo revision in subsequent releases as per the revision policy of IIP. The IIP growth rate for the month of March 2025 is 3.0 percent which was 2.9 percent (Quick Estimate) in the month of February 2025. The growth rates of the three sectors, Mining, Manufacturing and Electricity for the month of March 2025 are 0.4 percent, 3.0 percent and 6.3 percent respectively.

The Quick Estimates of IIP stands at 164.8 against 160.0 in March 2024. The Indices of Industrial Production for the Mining, Manufacturing and Electricity sectors for the month of March 2025 stand at 156.8, 160.9 and 217.1 respectively. Within the manufacturing sector,

13 out of 23 industry groups at NIC 2 digit-level have recorded a positive growth in March 2025 over March 2024. The top three positive contributors for the month of March 2025 are -"Manufacture of basic metals" (6.9%), "Manufacture of motor

h vehicles, trailers and semitrailers" (10.3%) and "Manufacture of electrical equipment" (15.7%). In the industry group "Manufacture of basic metals", item groups "Flat products of Alloy Steel ", "Pipes and tubes of Steel", "Bars and Rods of Mild steel" have shown significant contribution in growth.In the industry group "Manufacture of motor vehicles, trailers and semi-trailers", item groups "Auto components/ spares and accessories", "Axle", "Bodies of trucks, lorries and trailers" have shown significant contribution in growth.

In the industry group "Manufacture of electrical equipment" item groups "Electric heaters", "Transformers (Small)", "End facing connector for optical fibres and cables" have shown significant contribution in growth. As per the use base classification, the indices stand at 168.2 for Primary Goods, 134.8 for Capital Goods, 173.1 for Intermediate Goods and 212.3 for Infrastructure/ Construction Goods for the month of March 2025.

Further, the indices for Consumer durables and Consumer non-durables stand at 138.5 and 147.9 respectively. The corresponding growth rates of IIP as per Use-based classification in March 2025 over March 2024 are 3.1 percent in Primary goods, 2.4 percent in Capital goods, 2.3 percent in Intermediate goods, 8.8 percent in Infrastructure/ Construction Goods, 6.6 percent in Consumer durables and (-)4.7 percent in Consumer non-durables (Statement III). Based on use-based classification.

contributors to the growth of IIP for the month of March 2025 are - Infrastructure/ construction goods, Primary goods, Consumer durables. Monthly Indices and Growth Rate (in %) of IIP for the last 13 months. Along with the Quick Estimate of IIP for the month of March 2025, the indices for December 2024, January 2025 and February 2025 have undergone final revision in the light of the updated data received from the source agencies.

The Quick Estimate for March 2025, has been compiled at weighted response rate of 88 percent, whereas the weighted response rate for December 2024, January 2025 and February 2025 were 95 percent, 94 percent and 94 percent respectively. Release of the Index for April 2025 will be on Wednesday, 28th May 2025.

### SEBI Joins DigiLocker To Reduce Unclaimed Assets, Protect Nominees' Interests

Mumbai, (H.S): The Securities and Exchange Board of India (SEBI) on Sunday collaborated with DigiLocker to help reduce unclaimed assets and protect investors. The partnership was revealed in a post by the National Stock Exchange (NSE) on the social media platform X."SEBI has partnered with DigiLocker to reduce unclaimed assets in the securities market and protect nominees' interests," said the exchange."

A secure way to manage digital documents-built with investors in mind," the NSE added. To minimise unclaimed assets bought by investors in the capital markets, the capital markets regulator has taken several initiatives, such as mandating the submission of contact, to simplify the transmission process. SEBI initiatives for unclaimed assets are norms for inactive accounts and folios; mandatory contact and bank details submission, nomination requirement or opt-out mandate,



simplified process of transmission and centralised reporting of investor demise. Alarmed at frauds related to securities market on various social media platforms, capital markets regulator this month issued an advisory for investors to exercise caution and due diligence to verify the genuineness of social media handles of SEBI-registered entities while accessing them. SEBI noticed an increase in frauds related to securities market on various social media platforms such as YouTube, Facebook, Instagram, X (previously Twitter), WhatsApp, Telegram, Google Play Store and Apple Store, etc." With increasing adoption of digital communication platforms, it is observed that scamsters are enticing victims by giving trading calls in the name of providing education. They also provide misleading

or deceptive testimonials, promise or guarantee of assured or risk-free return etc. through various social media platforms," according to a SEBI statement. SEBI noticed unregistered investment advisory services being provided by entities that falsely claim to be registered intermediaries with SEBI or by showcasing fake certificates purportedly issued by the regulator.It also observed impersonation of SEBI-registered entities by fraudulent trading platforms, WhatsApp, Telegram channels which deceptively claim or suggest affiliation with SEBIregistered entity claiming to provide assured or risk-free return.

New Delhi, (H.S): Emerging markets have shown strong resilience through recent crises by building strong monetary policy frameworks and committing to inflation targeting, IMF chief economist Gita Gopinath said on Sunday.Clear and careful communication will be key for central banks to maintain credibility and anchor inflation expectations in uncertain times, she posted on X social media platform."Kudos to emerging markets. the emerging markets, India continues to remain the world's fastest-growing major economy and the only country expected to clock over 6 per cent growth in the next two years, according to an IMF report, which has trimmed the growth forecast for over 120 countries. According to the IMF chief economist, "Our 'April 2025 World Economic Outlook' projects significantly weaker global growth at 2.8 per cent for 2025 with growth downgrades for 127 countries making up 86 per cent of world GDP."The path forward requires clarity and predictability on trade policies. Countries should

address structural challenges to rebuild resilience and restore growth momentum, Gopinath added.The outlook report pegs the Indian economy to grow at 6.2 per cent in 2025 and 6.3 per cent in 2026, which is over 2 percentage points above secondranked China's economic growth forecast at 4 per cent for 2025 and 4.6 per cent in 2026. According to Gopinath, "focusing on sound communication about committing to inflation, targeting on anchoring long-term inflation expectations - that's going to be very critical for the emerging markets". The RBI's Monetary

Policy Committee (MPC), in its 54th meeting and the first of the financial year 2025-26, unanimously decided to reduce the policy repo rate by 25 basis points, bringing it down to 6 per cent with immediate effect. The repo rate is the rate at which the RBI lends money to commercial banks, and a cut in this rate is aimed at boosting lending and investment. This decision comes at a time when global economic conditions are becoming increasingly uncertain. Trade tensions have resurfaced, leading to a decline in crude oil prices, weakening of the US dollar, softening bond yields, and corrections in equity markets. While central banks across the world are adjusting their policies to address domestic concerns, are doing so they cautiously.Within India, the outlook has shown signs of improvement. Inflation, particularly food inflation, has declined more than expected, offering some relief, though global and weather-related risks remain.

The Padma Shri was awarded to Arijit Singh and Ricky Kej. The award ceremony was streamed live on YouTube.



# **BCCI plans 94-match IPL season by 2028; franchises speak to BCCI**

New Delhi, (HS) : IPL chairman Arun Dhumal said the BCCI is seriously considering to expand the league to a 94-match home-and-away format from the next media rights cycle, which falls in 2028. The IPL currently has the 74-match format ever since Gujarat Titans (GT) and Lucknow Super Giants (LSG) entered the fray in 2022. "Definitely, that might be an opportunity. We've been discussing in ICC, we've been discussing in-house in BCCI. Given how the interest of the fan is changing with regard to bilateral and ICC events, in regard to franchise cricket and T20 cricket, we'll have to talk more seriously about it and see how we can create maximum value for the stakeholders of the game." "Ideally, we'd want a larger

window, or to maybe go on from 74 to 84 or 94 at some point... So that every team gets to play against every team home and away, for that, you need 94 games," Dhumal was quoted as saying by ESPNCricinfo on Monday. There was talk around growing IPL to 84 matches for the ongoing season, but it was delayed due to tight scheduling. "Given the window and the kind of commitments that we have



with regards to bilateral cricket and ICC events, that may not be possible in the short term. But given the landscape, how it is changing and evolving over the years, maybe at some point in time we would look and take that option.""There's been so much cricket: we came back from Australia from a Test series, we had this Champions Trophy, and on top of that we have this IPL.


