



Justice Bhushan Ramkrishna **Gavai appointed** next CJI





New Delhi, (HS) : President Droupadi Murmu appointed Justice Bhushan Ramkrishna Gavai as the next Chief Justice of Supreme Court of India with effect from May 14, 2025. Justice Bhushan Ramkrishna, who is due to retire on November 23, 2025, will take oath on May 14 and serve a tenure of six months and ten days as the Chief Justice of Supreme Court of India. He will succeed Justice Sanjiv Khanna, who had proposed his nave for the coveted post. "In exercise of the powers conferred by clause (2) of Article 124 of the Constitution of India, the President is pleased to appoint Shri Justice Bhushan Ramkrishna Gavai, Judge of the Supreme Court, to be the Chief Justice of India with effect from 14th May, 2025," read the notification issued by the Ministry of Law and Justice Department of Justice (Appointments Division).

Who is Justice Bhushan Ramkrishna Gavai? Justice Bhushan Ramkrishna Gavai was born on 24th November 1960 at Amravati. Joined Bar on 16th March 1985. Worked with late Bar. Raja S. Bhonsale, former Advocate General and Judge of High Court, till 1987. Practiced independently at Bombay High Court from 1987 to 1990. After 1990, practiced mainly before Nagpur Bench of Bombay High Court. Practiced in Constitutional Law and Administrative Law. Was Standing Counsel for Municipal Corporation of Nagpur, Amravati Municipal Corporation and Amravati University. Appeared regularly for various autonomous bodies and Corporations like SICOM, DCVL etc. and various Municipal Councils in Vidarbha region. Worked as Government Assistant Pleader and Additional Public Prosecutor in the High Court of Judicature at Bombay, Nagpur Bench, from August 1992 to July 1993. Was appointed as Government Pleader and Public Prosecutor for Nagpur Bench on 17th January 2000. Was elevated as Additional Judge of the High Court on 14th November 2003. Became a permanent Judge of the Bombay High Court on 12th November 2005. Presided over Benches having all types of assignments at the Principal Seat at Mumbai as well as Benches at Nagpur, Aurangabad and Panaji. Elevated as a Judge of the Supreme Court of India on 24th May 2019. In the last six years, was a part of around 700 Benches dealing with matters pertaining to variety of subjects including constitutional and administrative law, civil law,

2019. Sources said the Prime Minister 're-affirmed that it is our national resolve to deal a crushing blow to terrorism' and that he has 'complete faith and confidence' in the Indian military.Shortly after the meeting, Home Minister Amit

Shah and Mohan Bhagwat, chief of the Rashtriya Swayamsevak Sangh, the ruling BJP's ideological mentor, reached the Prime Minister's residence. The PM's message, sources explained, greenlights military action against the terrorists who killed 26 people, mostly civilians, in the worst such incident since the Pulwama attack in February Then India conducted

precision air strikes on terrorist camps in Balakot in Pakistan. The camps were run by banned terror group Jaish-e-Mohammed with help from the Pak Army. Fast-forward six years and it is another familiar banned Pakbased terror group - the Lashkare-Taiba - that has been linked with this attack. A proxy - The Resistance Front - has claimed responsibility. Meanwhile, security agencies have also said available evidence pointed to Pakistan again. Diplomats from the US, Russia, China, Japan, and some European nations have been briefed on this material. The government has already rolled out a series of diplomatic restrictions on Pakistan. In the first round of responses Delhi revoked visas for Pakistan nationals, except for Pak Hindus and those with longterm stay approvals. The government had also revoked medical visas. All notified visas

issued to Pak nationals expired on Sunday, April 27, leading to a long line of Pakistani citizens at border crossings, including the famous Attari-Wagah checkpoint. Since Thursday, when the revocation order was first issued, nearly 1,000 Pak nationals have left India, with Home Minister Amit Shah personally asking chief ministers to enforce the order. As part of further diplomatic restrictions on Pakistan, India had also suspended the Indus Waters Treaty, a critical water-sharing deal that gives Pak nearly 85 per cent of its supply. The suspension of the IWT, signed in 1960, was met with fury by Pakistan, which called it "an act of war". Islamabad has since also revoked all visas for Indian nationals and ejected hundreds.Pak also revoked visas and held other bilateral deals, like the Simla Agreement, in abeyance. In comments to Pakistani media outlet Geo News - YouTube broadcasts of which have been banned online in India - Defense Minister Khawaja Muhammad Asif described the next few days as crucial.

In one of his first public comments on the Pahalgam attack, the Prime Minister vowed vengeance and said his government would not allow


CM Majhi Reviews 'Jadu **Pedi' Kits To Boost Early Childhood Learning**

Bhubaneswar, (DMC) : In a significant move to enhance early education through play and joyful learning, Odisha Chief Minister Mohan Charan Majhi on Tuesday reviewed the innovative 'Jadu Pedi' (Magic Box) learning kits, designed for students of Shishu Vatika, Class 1, and Class 2. These kits have been developed by the National Council of Educational Research and Training (NCERT) in alignment with the National Education Policy (NEP) 2020. During a review meeting at Lok Seva Bhawan, the Chief Minister expressed satisfaction after examining the kits. "These learning toys will help young children learn through play, using materials familiar to their surroundings. This will make learning more engaging and enjoyable for them," he said. The initiative is being

implemented by the School and Mass Education Department. Commissioner-cum-Secretary Shalini Pandit briefed the Chief Minister on the contents and educational value of the kits. Each kit costs around Rs 20,000, and the State Government plans to distribute them to 45,000 schools across Odisha. The total project cost stands at Rs 90 crore. The programme aims to develop foundational skills in children by sparking curiosity and making the learning experience more joyful and interactive. The play-based learning programme, developed by the NCERT, targets children aged 3 to 8 years. It focusses on fostering cognitive growth, emotional well-being, and foundational skills in language and mathematics. In February **Continued P-4**





Srinagar/New Delhi, (HS) : Days after the tragic Pahalgam attack, Jammu and Kashmir authorities have transported 59 Pakistani nationals to Punjab for their repatriation to their country of origin, officials in Srinagar said. According to officials, the Pakistani nationals, who were living in the valley for decades and included the mother of Shaurya Chakra awardee Constable Mudasir Ahmad Sheikh, were collected from various districts and taken in buses to Punjab, where they will be handed over to the Pakistani authorities. Shameema Akhtar, the mother of Constable Mudasir Ahmad Sheikh, who died in May 2022 while fighting terrorists, was one of the deportees. However, she was later allowed to stay back. In a carefully worded clarification, Shameema's brother-in-law Mohammad Younus said Mudasir's mother has returned home as she was not taken for deportation. "We are thankful to the Government of India," Younus said.

Earlier, Mudasir's uncle had told reporters that his sister- in-law belonged to Pakistan-occupied Kashmir and, as such, she should not have been deported. "My sister-in-law is from Pakistanoccupied Kashmir. Only Pakistanis should have been deported," Younus said. After Mudasir's death, Union Home Minister Amit Shah visited the family, and so did the Lieutenant Governor, twice, he said. "My bhabhi was 20 years old when she came here and has been living here for 45 years now. My appeal to (PM Narendra) Modi and Amit Shah is that they should not do it," Younus said. Shameema had married Mohammad Maqsood, now a retired police officer, before the eruption of terrorism in Jammu and Kashmir in 1990. The main Baramulla town square

has been named Shaheed Mudasir Chowk in memory of the policeman.According to the citation for Sheikh, he was awarded the third-highest civilian award posthumously in 2022 for his role in thwarting a major terrorist plot targeting the Amarnath Yatra. On May 25, 2022, credible intelligence was received regarding the movement of three heavily armed foreign terrorists travelling in a vehicle, with a sinister intention of attacking the upcoming Amarnath Yatra. In response to this input, a joint operation was swiftly launched by security forces in Baramulla in North Kashmir. Constable Mudasir Ahmad Sheikh, a seasoned and alert member of the operation team, was quick to identify and challenge a suspicious vehicle. Recognising the imminent threat, the terrorists tried to drive away. Sheikh acted decisively by charging at the vehicle, completely disregarding his safety. In a display of raw bravery, he managed to physically drag one terrorist out of the vehicle. The brazen act triggered indiscriminate firing from the remaining terrorists, resulting in grievous injuries to Sheikh.

Despite bleeding profusely and battling excruciating pain, Sheikh remained undeterred and continued his hand-to-hand combat with the captured terrorist. He eventually neutralised him. Sheikh, however, died of his injuries while being evacuated. Shameema, accompanied by her husband, received the Shaurya Chakra from President Droupadi Murmu in Delhi in May 2023.In the aftermath of the Pahalgam terror attack last week, the Centre announced a slew of measures, including suspension of the Indus Waters Treaty, downgrading diplomatic relations **Continued P-4**

Hindu Minority

Ever since Sheikh Hasina was overthrown in Dhaka, India has raised its concerns with Bangladesh about the safety of minorities in that country. Hasina fled to India on the evening of August 5 last year, and the following day, in an all-party meeting, External Affairs Minister S Jaishankar flagged the issue. Delhi has continued to express concern over instability in Bangladesh, and in particular, the toll it takes on the safety of minorities. During a recent meeting on the sidelines of BIMSTEC, Prime Minister Narendra Modi urged the Chief Advisor to the interim government, Muhammad Yunus, to ensure that the state addresses the issue with urgency. Despite assurances, however, Dhaka has been prone to dismissing the incidents of the Hindu minority being targeted as isolated manifestations of public anger against the previous regime. Following the kidnapping and killing of Bhabesh Chandra Roy, a prominent leader, the Yunus government cannot continue to be in denial. Minister of State for External Affairs Kirti Vardhan Singh told Parliament in February, "Since August, reports have cited the deaths of 23 Hindus and 152 incidents of attacks on Hindu temples in Bangladesh." The interim government must acknowledge the insecurity faced by Bangladeshi Hindus and take immediate steps to ensure their safety. A culture of impunity will only exacerbate the situation and also contribute to tensions between Dhaka and Delhi.

India has been a friend to Bangladesh since the Liberation War of 1971. However, the interim government's foreign policy has sent mixed signals. Yunus' recent visit to China, during which he made a provocative statement about India's Northeast region, and the high-level diplomacy over the weekend between Bangladesh and Pakistan, signal Dhaka's attempts to align with Delhi's regional rivals. Despite Bangladesh's demand for reparations and a public apology from Pakistan for the atrocities committed by the Yahya Khan regime during the 1971 Liberation War, both countries appear to be on the path towards rapprochement - a significant reversal of Hasina's foreign policy.Bangladesh must recognise that Dhaka's long-term interests are better served if it acknowledges the regional realities and understands what Delhi can offer: A stable economic and defence partnership. In turn, India should remain resolute in its demands for the protection of minorities in Bangladesh, while keeping the door open for talks with the interim government on issues ranging from border security to trade, connectivity and counter-terrorism. Delhi must also broaden its outreach. Given Bangladesh's uncertain domestic situation and the impending elections, Delhi must engage a broader swathe of forces and institutions in the country to get a deeper understanding of its changing domestic dynamics and to guard against any nasty surprises ahead.

Digital Payment Without Internet

Not very Long ago, when TV came to our villages, we saw people fixing the TV antenna on coconut trees. The signal in villages used to be bad, but becomes better when the antenna sits on top of a coconut tree. We have a similar experience now with mobile phones in some villages. People climb up a tree to get better signals and after the talk is over they come down. But if you have to make a payment to a shopkeeper by using the mobile phone it becomes tricky. The signal may go off half way through the payment process resulting in the account getting debited but the shopkeeper not receiving the money. The availability of internet is equally bad in many countries. It is reported that the internet speed is one of the slowest in USA. The International Telecommunication Union (ITU) estimates that two-thirds of individuals in the world's least developed countries and about 2.6 billion people globally are still fully offline. In addition to nonavailability of access to internet, there is another issue that has warned even the most developed nations. Some of the global giants like Google and Amazon have faced power outage issues and the whole world has faced the non availability of services from Global giants. This has given rise to the need of making digital payment without internet which is also known as offline digital payment. In a normal online digital

payment an individual can make the payment by using his computer or the mobile phone or by making payment through his debit or credit card at the point of sale (POS) of the merchant establishment. There are several small payments one needs to make these days at various places like the grocery store, the vegetable vendor, the newspaper supplier and there is a possibility that net connection is unstable or is not very strong while making the payment. Further, making several small value online payments clogs the passbook with too many transactions. This problem is addressed by the offline payment method. RBI allowed offline digital payments in India by issuing guidelines in January 2022. Initially offline transaction was allowed for a maximum amount of Rs 200 per transaction. The instructions have been upgraded from time to time. Now, offline payments are permitted in proximity (face to face) mode; it can be made by using any channel like cards, wallets or mobile devices and transactions can be done without any additional factor of authentication. The upper limit of an offline payment transaction has been increased to Rs.500. The total limit for offline transactions on a payment instrument is set at Rs.2,000 at any point in time. UPI Lite is a facility given with all mobile payment apps like Google pay, Phonepe etc which can be activated for small value offline payments. In UPI Lite, the upper limits are Rs 1000 and Rs.5000 respectively. One has to transfer



the amount (Up to Rs 5000) from the bank account to the wallet and use the same for several transactions. No PIN will be required to make payment from the wallet with UPI Lite. When the person making payment does not have a net connectivity, but he still wants to make a payment, he can scan the QR code given by the shop keeper and make the payment. The information is stored in the mobile and completed when the phone is online. This increases convenience and only one transactions showing the amount of Rs 5000 transferred from the bank to the wallet will appear in the passbook. Prepaid cards used in metro stations or bus are also cards that store value and make payment when the holder touches the card on the machine installed in metro stations or busses. Offline digital payment can also be made through the credit card or debit card. In that case there is no wallet, but the card holder authorizes such payments by a PIN. Currently, this method of offline card payment is limited to a few cases wherein the PIN entered on a PoS terminal by cardholder is verified by the card chip itself and the transaction is stored on the PoS terminal and

settled with the bank subsequently. A flyer purchasing a coffee from the airline during a flight and making the payment by his card is an example of offline payment. Such offline payments accumulate in the devices and when they go online, the amounts are charged to the card holder. In India NPCI has started the offline UPI payments through the number 99#. A person with a smart phone can open the dialer on his phone and enter the offline UPI number *99# to initiate the call to connect to the offline UPI payment service. Among the several options presented on the screen, he has to select "1" for "Send Money". This will allow him to initiate a payment transaction. Thus, offline transactions are supported by the authorities to enable people benefit from the digital age payment products. This will also reduce pressure on demand for currency in the country. The offline payments that are

The offline payments that are more often done today in India are at best semi-offline payments in the form of wallet based payment. Globally, many countries have introduced offline digital payments for the convenience of people. In USA, this is allowed on Stripe platform, in India it is UPI Lite

and in Brazil, this is allowed on a platform called Matera. Sweden also offers an offline payment solution through a platform called Digital cash. China has done good progress in offline digital payment by using Near Field Communication technology through Wechat and Alipay platforms. A pure offline transaction requires periodic connection to the internet to complete the transaction. While offline payments provide convenience to people, it goes with some amount of risk. There is always a chance that the payment does not go to the payee and the payer has to make double payment. If the payment has been made to a shopkeeper and the payer has left the premises, in most of the cases, the loss will have to be taken by the shopkeeper. Secondly, offline payments from the wallet go through without PIN and are therefore prone to risk. Vulnerability of the software may open up opportunities to hackers to break in to the software and compromise its security. The user data of the payer or payee stored in the devices are at the risk of getting affected which compromises privacy. Offline digital payments systems locally store account balances and transaction histories on the user's device. If the device is lost, stolen, or fails, the user has limited recourse to the balance. In cases of loss or theft, a bank cannot reload a new device with the lost device's balance. Finally, failure of transactions and loss of data and privacy can open up reputational risk issues for the payer and the payee. Despite these issues offline payments ecosystem offers another option to the people and obviates the need for cash and therefore in course of time it is expected to be popular.

Odisha Gears Up For Heatwave : Health Department Implements New Measures

Bhubaneswar, (DMC): With the onset of the heatwave season, the Health and Family Welfare Department of Odisha has ramped up its strategies to ensure the safety and well-being of the public amid rising temperatures.Under the direction of Health and Family Welfare Minister Mukesh Mahaling, a crucial review meeting was convened by Dr. Nilakantha Mishra, Director of Public Health (DPH).

The meeting aimed to assess and streamline operational and logistical measures necessary to protect the citizens of Odisha during the heatwave. Dr. Mishra emphasized the need for a comprehensive approach to managing the public health impact of extreme heat. He highlighted that the department is working to ensure the availability of essential medical supplies, such as intravenous fluids, Oral Rehydration Solutions (ORS), medicines, air coolers, and power backup systems, to mitigate the



effects of the heatwave. Additionally, all 30 districts have been instructed to ensure the readiness of medical facilities, with sufficient beds prepared for heatwave-related cases. The department has also expanded its training program for healthcare workers, focusing on managing heat-related illnesses. Dr. Mishra stressed that the training would not only involve healthcare professionals but also extend to grassroots-level teams in the districts, enabling local health workers to respond quickly and effectively to emerging heatrelated health issues.Special

efforts of attention has been given to mining regions and areas prone to medical assistance, extreme heat, where vulnerable

Bhadrak Youth Held For Blackmailing Ex-Girlfriend With Morphed Obscene Photos

However, the relationship ended after the victim accused him of harassment and

emotional abuse towards her and her family.In retaliation to the breakup, Sumit allegedly morphed her private photographs into obscene images. He then used these manipulated photos to blackmail the girl, demanding Rs10 lakh. Later, he shared these images across multiple social media platforms, causing significant distress to the victim.The victim, upon discovering that her morphed images had been shared online, filed a formal complaint at the Cyber Police Station in Bhubaneswar on April 10, 2025. In her complaint, she requested

immediate action against the accused. The police took swift action and tracked the accused to Bhadrak, where he was arrested. He was forwarded to court on Monday night."Upon receiving the complaint, we initiated immediate action. The accused had edited the victim's photographs in an obscene manner and shared them widely on social media. He also demanded money. Orphaned daughter seeks help from CM for father's purification work

Keonihar, (DMC): Two sisters from Oria village in Telkoi block, who lost their father and mother, have written a petition to the Chief Minister seeking help to perform the purification work of their father Duttikrushna Nayak (50), who died on the 23rd.After the death of Mother Indira Nayak at the age 45 in Cancer in the year 2024 and father Duttikrushna Nayak died at the age 50 in the year 2025 after prolonged lung diseases, the two sisters became orphans. They are identified as Sima Nayak and Rakhi Nayak. The two minor girls are now living in financial distress after losing their mother and father and are worried about

how they will perform the purification work of their father after five days. Duttikrushna, who lives below the poverty line, used to live happily with his two daughters and wife by working as a farmer and doing daily wage work. Then, the family was saddened after his wife Indira Nayak was diagnosed with cancer.In the expensive medical treatment era, despite spending a lot of money for his treatment and losing everything, he used to work and support his two daughters and wife. Duttikrushna himself is a respiratory patient. Therefore, he could not work hard. However, he did not give up and continued to support his

family. In February 2024, Indira passed away while undergoing treatment. Amidst the mountain of grief, Duttukrishna performed Indira's last rites with great difficulty. After mother's illness, the elder daughter shouldered the heavy responsibility of serving her mother and running the house.Due to his mother's ill health, the elder daughter Sima's education ended in the 10th standard. Similarly, while the younger daughter was studying in Telkoi College, she was left halfway through her studies due to domestic problems. After the death of his wife, Duttukrishna, who was devastated by the future of his two daughters and the

worries of running the family as he himself was suffering from lung disease, became even more ill. Finally, on the 23rd of this month, he left his two daughters and went to Paradham. At an age when it was time to play and study, the two daughters, who had witnessed the story of struggle, were devastated by the loss of their only hope, their father. The hope of the villagers and relatives is their only support. Due to lack of money, the father's purification is now worrying them. Therefore, they have written to Chief Minister Mohan Majhi for financial help. Rina said that "they have not received anything from the government except a

ration card. If they get financial help then they could perform the purification of their father". Locals say that they have not received any help from the poverty alleviation scheme for tribal development scheme. Narayan Rath, a human rights defender, said that " In a welfare state, everyone has the right to live well. Therefore, the government has made various assistance schemes for this. Therefore, the local administration must take steps to make arrangements for the rehabilitation of the two sisters who are homeless and have lost their parents and complete the purification of the father".

India brands Pakistan 'rogue state' at UN, citing its defence minister's 'open confession' to backing terror groups

New Delhi, (HS) : India has branded Pakistan a "rogue state" at the United Nations, citing Pakistani Defence Minister Khwaja Asif's "open confession" to funding and supporting terrorist groups. The strong rebuke came just days after the Pahalgam terror attack in Jammu & Kashmir, which claimed 26 lives - the highest civilian toll in a single attack since the 2008 Mumbai attacks. India's Deputy Permanent Representative to the UN Yojna Patel,

responded firmly. "It is unfortunate that one particular delegation has chosen to misuse and undermine this forum to indulge in propaganda and make baseless allegations against India. The whole world has heard Pakistan's defence minister Khwaja Asif admitting and confessing Pakistan's history of supporting, training and funding terrorist organisations in a recent television interview," she said. "This open confession surprises no one and exposes Pakistan as a rogue state fuelling global terrorism and destabilising the region. The world can no longer turn a blind eye," Patel added.

India's Right of Reply on baseless allegations made by Pakistan. In a televised interview with Sky News, Asif openly admitted that Pakistan had long supported militant groups and said: "We have been doing this dirty work for the United States for about three decades and for the West, including Britain.. That was a mistake, and we suffered for that... If we had not joined the war against the Soviet Union and later on the war after 9/11, Pakistan's track record was unimpeachable." Speaking at the launch of the Victims of Terrorism Associations Network (VoTAN), Patel described the Pahalgam attack as a grave tragedy. "The Pahalgam terrorist attack represents the largest number of civilian casualties since the horrific 26/11 Mumbai attacks in 2008. Having been a victim of cross-border terrorism for decades, India fully understands the long-lasting impact such acts have on victims, their families and society." She also acknowledged international support in the aftermath of the Pahalgam attack, saying: "India appreciates and values the strong, unequivocal support and solidarity extended by leaders and governments across the world. This is a testimony to the international community's zero tolerance for terrorism." Highlighting the role of the newly launched VoTAN initiative, Patel said, "We reiterate that terrorism in all its forms must be condemned unequivocally.

New Delhi, (HS) : Hearing a batch of pleas on the Pegasus row, the Supreme Court on Tuesday said there's nothing wrong in a country using spyware for security purposes, but members of civil society have a right to privacy that is protected by the Constitution.

"What's wrong if a country is using spyware? To have spyware is not wrong, but against whom you are using it is the question. You can't sacrifice the security of the nation," a two-judge bench of Justices Surya Kant and N Kotiswar Singh said. The apex court was hearing a number of petitions seeking a detailed probe into allegations that the government used Israeli software Pegasus for snooping against journalists, judges, activists, politicians and others. One of the lawyers of the petitioners told the bench that the basic issue in the case was whether the government had the Pegasus spyware



and was using it.Solicitor General of India, Tushar Mehta, representing the Centre, said, "Terrorists cannot claim privacy rights." Hearing this, the bench said, "A civil individual who has the right to privacy will be protected under the Constitution." Several pleas were filed before the top court in the snooping row by senior journalists N Ram and Sashi

Over 70 Pakistani women with NORI certificates return to India

CHANDIGARH, (HS) : More than 70 Pakistani women married to Indian nationals who were having NORI (No obligation to return to India) certificate issued along with LTV (longterm visa) crossed over to India through the Integrated Check Post (ICP) at Attari border. The Union Government had revoked all visas issued to Pakistanis after the Pahalgam terror attack, which killed 26 tourists. The Pakistani women who went to meet their parents in Pakistan were not allowed to come back to India and were stopped by Pakistani immigration despite holding valid documents. However, today immigration authorities of Pakistan allowed those having Pakistani passports and married to Indian nationals with NORI certificates and long-term visas to cross over to India, said sources. It is learnt that following discussions, an exception was made. In total, 240 people from Pakistan, including more than 70 NORI visa holders, entered India. Meanwhile, 140 others from India returned to Pakistan via the Attari border. Dr Vikram Udasi from Jalgaon, Maharashtra, who



had been waiting at the Attari border since April 25 to receive his wife Priya, a Pakistani national and four-year-old child Ahan, who had gone to meet her family in Pakistan, finally re-united with his wife and child.

"Finally, I have met my wife and child after the long wait and now we are leaving back for our home town, thank god," he said and added that they got married in 2017. "She has been on a Long Term Visa (LTV) for the past eight years, which is valid until 2026," he said. Another Indian national, Rishi Kumar from Kolhapur in Maharashtra, has also been stranded at the ICP Attari for the

The victim whose identity is yet to be ascertained, was allegedly assaulted with sticks, resulting in multiple injuries that led to internal bleeding and shock. He was declared dead at the hospital, police said.

Following the terror attack in Pahalgam that killed 26 people, the Central government announced several diplomatic measures, such as closing the Integrated Check Post (ICP) at Attari, suspending the SAARC Visa Exemption Scheme (SVES) for Pakistani nationals, giving them 40 hours to return to their country, and reducing the number of officers in the High Commissions on both sides. India also halted the Indus Waters Treaty signed in 1960 in the wake of the Pahalgam attack. Prime Minister Narendra Modi also assured the country that the terrorists responsible for this attack, along with those who conspired it, will face punishment beyond their imagination, The Prime Minister asserted that the time has come to eliminate the remaining strongholds of terrorism and that the willpower of 140 crore Indians will now break the backbone of the perpetrators of terror.

Anupam Agarwal said, "Initially, the police registered a case of unnatural death and launched an investigation after the body was found near the temple grounds. A post-mortem conducted on April 28 confirmed that the death was due to multiple blunt force injuries and lack of medical attention." A case has been registered under Section 103(2) of the Bharatiya Nyaya Sanhita, 2023, which pertains to murder by a group of five or more persons, at the Mangaluru Rural Police Station, based on a complaint lodged by a resident, he said. So far, 15 accused have been arrested, and the police are on the lookout for at least 10 more individuals, he added. "The main accused, identified as Sachin, a resident of Kudupu, is already in our custody. The section invoked in this case is very stringent-if proved, the accused, either individually or as a group, can face life imprisonment or even the death penalty.

SC Refuses to Entertain Fresh Plea Against Waqf (Amendment) Act

New Delhi, (HS) : The Supreme Court on Monday refused to entertain a fresh petition challenging the recent amendments to the Waqf Act, 1995. A bench, headed by CJI Sanjiv Khanna, told the petitioner that it cannot deal with hundreds of petitions on the same issue and that the petitioner may choose to file an intervention application in the petitions challenging the Waqf (Amendment) Act, 2025, if so advised. The CJI Khanna-led Bench, on April 17, the previous date of hearing, decided to treat five writ petitions as lead cases and said that other pleas will be treated as intervention applications. Further, it ordered the apex court registry to rename the cause titles of the proceedings as "In Re: The Waqf (Amendment) Act, 2025".

The Bench, also comprising Justices Sanjay Kumar and K.V. Viswanathan, granted a week's time to the Centre and state governments and the Waqf Boards to file their preliminary reply. During the course of the hearing, the Union government assured the Supreme Court that it would not de-notify provisions related to 'waqf by user' or include non-Muslim members in the Waqf Board. Posting the matter for further hearing on May 5, the apex court said that the hearing fixed on the next date will be a preliminary hearing and, if required, interim orders will be passed. In its preliminary affidavit, the Centre said that it brought amendments to prevent abuse of waqf legislation, which resulted in the encroachment of government properties, apart from ensuring that the Waqf Boards in the country are properly administered and function with transparency. "It is submitted that there have been reported misuse of waqf provisions to encroach on private properties and government properties. It is really shocking to know that after the amendment brought in the year 2013, there is a 116 per cent rise in augaf area." the Union Ministry of Minority Affairs said. The Centre, in its reply document filed before the top court, said that it was found that most of the Waqf Boards have been functioning in the "most nontransparent manner" and have either not uploaded the details in public domain or have uploaded partial details. The Union government said that under the old regime, due to the absence of adequate safeguards, government properties and even private properties were declared as waqf properties. "The provisions of Sections 3A, 3B and 3C take care of the said situation which has been prevailing since several decades. It is submitted that there are startling examples whereby the government lands or even the private lands were declared as waqf properties," it said in the affidavit.

The Union government said that the Waqf (Amendment) Act, 2025, was passed with the objective of modernising the management of waqf properties in India through transparent, efficient and inclusive measures. It argued that the reforms introduced are directed solely at the secular and administrative aspects of waqf institutions - such as property management, record-keeping, and governance structures - without impinging upon any essential religious practices or tenets of the Islamic faith.

The preliminary reply document filed by the Union government said that before introducing the Waqf (Amendment) Act, 2025, there has been a detailed executive level and Parliamentary level exercise in order to understand the problems plaguing the previous statutory regime, the consequences, and the appropriate measures that were required to remedy the same. The Centre contended that the "primary religious right being the right to make a dedication is not interfered with, and neither is the administration of any specific waqf interfered with as the same continues to be vested with the mutawalli as per the purpose behind such waqf".

Beijing, (H.S): A devastating fire tore through a restaurant in Liaoyang City, located in northeast China's Liaoning Province, on Tuesday afternoon, claiming the lives of 22 people and leaving three others injured, according to state media. The cause of the blaze has not vet been disclosed as authorities continue investigations into the tragedy. The fire reportedly broke out at 12:25 p.m. local time in a restaurant situated within a residential area, state broadcaster CCTV said.

Chinese President Xi Jinping called for "all-out efforts" to ensure that the injured receive the best possible medical care and instructed officials to strengthen fire safety measures nationwide, Xinhua news agency reports. This marks the second major fire tragedy in China this month.On April 9, 20 elderly residents were killed in a blaze that swept through a nursing home in Longhua county of Chengde city, in north China's Hebei province. A total of 39



people were inside the building when the fire started.China has witnessed several fatal accidents in recent years, often attributed to gas leaks, outdated infrastructure, or poor safety enforcement.In March last year, an explosion linked to a gas leak at a restaurant in Hebei province killed two people and injured 26. In September, another gas-related blast in a high-rise building in Shenzhen claimed one life. Accidents like these are often exacerbated by illegally stored chemicals, lack of fire exits, and poor enforcement of building

codes - issues sometimes fueled by corruption and negligence.In this latest incident, according to some media reports, the fire started in the kitchen. It suggests that it may be linked to the traditional use of open flames for cooking, such as braising dishes in large iron woks or preparing popular meals like hot pot, where ingredients are cooked directly at the table over live flames. Liaoyang, where Tuesday's fire occurred, is part of China's industrial "rust belt" - a region known for its declining factories and population exodus.

Missing Indian Student In Canada Found Dead Under Mysterious Circumstances

We are in close contact with the bereaved kin and local community associations to provide all possible assistance," the High Commission of India in Canada posted on a social media platform 'X'.Vanshika went missing on April 25, the day she left her house to check out a room,


First Batch of Indian Haj Pilgrims Arrives In Saudi Arabia Failure To Observe Safety Principles Caused Port Explosion: Iran

Eskandar Momeni blamed "negligence" as the cause of the powerful explosion and the inferno in the provincial capital Bandar Abbas, where the port and the country's largest maritime hub is located. However, some media reports also suggest that the explosion was caused by missile fuel ingredients imported from China. In January, after Tehran's supplies ran low following its

conflict with Israel, China was to send a ship carrying sodium perchlorate, a common missile fuel component, to Iran. Following this, the port took in a shipment of "sodium perchlorate rocket fuel," in March, the reports said, adding that the port explosion on Saturday was due to the mishandling of this very fuel.

Reports further suggested that eyewitnesses of the incident and videos doing the rounds showed chemicals in an area of shipping containers caught fire and led to a massive explosion. Meanwhile, the officials stated on Monday that the death toll from the blast and the subsequent inferno rose to 70, and the fire at the port was extinguished.

Pak Exposed As Rogue State Fuelling Global Terrorism: India At UN

New Delhi, (H.S): India has strongly raised the Pahalgam terror attack at the United Nations and also flagged a Pakistani minister's "confession" to training and funding terrorists. The horrific terror attack on April 22 left 26 people, including 25 tourists and one local, dead, representing the largest number of civilian casualties since the 26/11 Mumbai attacks in 2008.

Ambassador Yojna Patel, India's Deputy Permanent Representative at the UN, on Monday flagged a Pakistani minister's "open confession" to training and funding terrorists at the UN.Pakistan Defence Minister Khwaja Asif had said in a recent TV interview that his country has backed terrorism over the decades. This confession was not surprising, and it exposed Pakistan as a "rogue state" that has been fuelling global terrorism, said Ambassador Yojna Patel at the UN."

The whole world has heard Pakistan's Defence Minister Khwaja Asif admitting and confessing Pakistan's history of supporting, training and funding terrorist organisations in a recent television interview. This open confession surprises no one and exposes Pakistan as a rogue state fuelling global terrorism and destabilising the region. The world can no longer turn a blind eye," she said. Khwaja Asif, in a TV interview soon after the Pahalgam



terror attack, was asked by a journalist about Pakistan's role in

backing terrorist organisations. "We have been doing this dirty work for

The move is also expected to prop up bond prices, which had declined due to a selloff by foreign banks and primary dealers after the uncertainty triggered by the Pahalgam attack.

The RBI's open market operations (OMO) to purchase government bonds will be carried out in four tranches between May 6 and May 19. The decision was taken after a review of current and evolving liquidity conditions, according to an RBI statement. The move comes close on the heels of the RBI's announcement on April 1 to buy government bonds worth Rs 80,000 crore, which was followed by another



Rs 40,000 crore purchase announced on April 11.RBI Governor Sanjay Malhotra has stated that the central bank will continue to monitor evolving liquidity and market conditions and take measures as appropriate to ensure orderly liquidity conditions. The bond purchases are in continuation of the RBI's recent measures to inject liquidity into the system. In March, it conducted OMO purchases of government securities worth Rs

1 lakh crore in two tranches of Rs 50,000 crore each. The central bank also held a dollar-rupee buy/sell swap auction of \$10 billion for 36 months. Besides, the central bank this week reduced borrowing costs by cutting the benchmark repo rate by 25 basis points and changing its neutral stance to accommodative.

The steps were taken as part of the soft money policy to spur economic growth, as the inflation rate has come down.According to financial analysts, the fresh liquidity infusion is also expected to help fetch a better price for the new benchmark bond, which would be auctioned on May 2. The RBI announced the new bond after the old benchmark bond completed the outstanding amount of Rs 1.84 lakh crore.

NPCI Directs Banks To Limit 'Check Transaction' API Usage To Avoid UPI Outage Gold Shines on Akshaya Tritiya: Prices Up By Over 30 Pc In A Year

New Delhi, (H.S): Gold has continued to shine bright for investors, delivering a return of over 30 per cent since last year's Akshaya Tritiya, according to brokerage firm Ventura. As the festival approaches this Wednesday, the price of 24-carat gold has surged from Rs 73,240 per 10 grams in 2024 to nearly Rs 94,000-Rs 95,000 per 10 grams this year.

Akshaya Tritiya is considered one of the most auspicious days to buy gold. It is believed that purchases made on this day invite prosperity and good fortune.With this belief deeply rooted in tradition, millions across the country turn to gold not just for adornment but also as a time-tested investment especially during uncertain times. Over a longer horizon, gold has delivered even more impressive returns. In the past six years, gold prices have more than tripled. On

Akshaya Tritiya in 2019, 24-carat gold was priced at Rs 31,729 per 10 grams, the firm said. The surge in gold prices is largely attributed to rising global uncertainties, which have prompted many investors to turn to the yellow metal as a safe-

haven asset. On April 22 this year, gold prices hit a historic milestone, breaching Rs 1,00,000 per 10 grams for the first time.Ventura also highlighted regional trends, noting that the highest demand for gold during Akshaya Tritiya comes from South India, contributing nearly 40

per cent to total sales. The western region accounts for about 25 per cent, the eastern region for 20 per cent, and the northern region for

around 10 per cent. Interestingly, while Akshaya Tritiya is significant in South India, consumers in North India place greater importance on purchasing gold during the Dhanteras festival. The brokerage firm further mentioned that while high gold prices could dampen sales volume this year, the overall revenue for the industry is expected to remain stable as compared to last year.



New Delhi, (H.S): In the wake of the mega unified payments interface (UPI) outage earlier this month, the National Payments Corporation of India (NPCI) has asked banks to ensure that all the API requests (traffic) sent to UPI is monitored and moderated in terms of appropriate usage.The relentless transaction status checks by banks resulted in the massive UPI outage on April 12, leaving millions stranded.In a notification, the NPCI has said

that banks will initiate the first check transaction status API after 90 seconds from the initiation/ authentication of the original transaction."After the timers are changed, members may initiate the same after 45 to 60 seconds of the initiation/authentication of original transaction, after NPCI revised communication," said the agency. Banks may initiate maximum of three check transaction status APls, preferably within two hours from

the initiation/authentication of the original transaction, it added. Payment service provider banks will ensure that all the API requests (traffic) sent to UPI is monitored and moderated in terms of appropriate usage - for restricting high number of repeat APIs for same transactions or older transactions, etc.

According to the notification, payment service provider banks will audit their systems by "Certin empanelled auditor on an immediate basis, to review the API usage and existing systems behaviour, and annually hereafter"."PSP banks/Acquiring Banks shall ensure that there is no batch processing (by processing file and converting to online request at high TPS) of any of the non-financial APIs sent to UPI Online systems," read the notification.Subsequently, in case of U48 error (Transaction ID not

present or not found in UPI System) within first two 2 hours from initiation of the original transaction, then banks will refer the NPCI settlement files (available to Payee, Payer or PSP banks) after the settlement cycle is completed.'

Alternatively, members may initiate a maximum of one check transaction status API on UDIR (Unified Dispute and Issue Resolution) which, in turn, checks URCS (UPI Backoffice) to fetch the final settlement status of the transaction," according to the NPCI.On April 12, digital payments via UPI suffered a nationwide outage affecting millions of users, hindering local shopping, bill payments and business transactions. Major banking apps from SBI, ICICI, and HDFC were also affected, pointing to a broader issue within the UPI network infrastructure.

India's Private Corporate Sector Bullish On Capex Despite Global Uncertainties: Govt Survey

New Delhi, (H.S): Despite challenges like weak demand, geopolitical tensions, and high borrowing costs, about 30 per cent of firms in the private corporate sector planned to invest in upgradation in FY 2024-25, supporting the sharp increase in capital expenditure (capex) last fiscal, a government survey showed on Tuesday

cent growth.The estimated capex per enterprise for the years 2021-22, 2022-23, and 2023-24 was Rs 109.2 crore, Rs 148.8 crore and Rs 107.6 crore, respectively. Moreover, the estimated provisional capital expenditure per enterprise for purchasing new assets in 2024-25 is Rs 172.2 crore.

There has been an overall increase of 66.3 per cent in aggregate capex (unweighted) over the fouryear period from 2021-22 to 2024-25. The strategy of 40.3 per cent of enterprises is to undertake capex on core assets during 2024-25, followed by 28.4 per cent to invest in value addition to existing assets, according to the survey.In 2022-23, the Parliamentary Standing Committee recommended that the Ministry of Statistics develop a comprehensive methodology to capture capex data from the private sector. The primary objective of the capex survey is to estimate the capex trends of private corporate sector enterprises from the past three financial years (2021-22, 2022-23 and 2023-24), along with anticipated capital expenditure for the current year (2024-25) and

Need To Target 1 Billion UPI Transactions A Day In 2-3 Years: FM Sitharaman

New Delhi, (H.S): Finance Minister Nirmala Sitharaman on Monday underscored the need to target one billion Unified Payments Interface (UPI) transactions per day within the next 2-

The slightly lower intended capex for FY2025-26, though still above the 2023-24 levels, reflects cautious planning after a strong 2024-25. Overall, the trend indicates growing corporate confidence and a judicious approach to investment amid improving economic certainty, according to the survey data released by the Ministry of estimates, nearly 40.3 per cent of enterprises plan to undertake capex on core assets during 2024-25. Additionally, 28.4 per cent intend to invest in value addition to existing assets, while around 11.5 per cent focus on opportunistic assets, and 2.7 per cent on debt strategies. The strategy of investing in distressed assets and non-performing loans was adopted by less than one-half Meanwhile, about 16.9 per cent allocated their capex towards other diverse investment strategies. According to the findings, the average gross fixed assets per enterprise in the private corporate sector increased from Rs 3,151.9 crore in 2021-22 to Rs 3,279.4 crore in 2022-23 (4 per cent growth), and further to Rs 4,183.3 crore in 2023-24, reflecting a significant 27.5 per upcoming financial years (2025-26).

A total of 2,172 enterprises submitted complete information for all five years of the reference period, forming a fixed panel. From FY 2019-20 to FY 2024-25, UPI transactions registered a compound annual growth rate (CAGR) of 72 per cent.NPCI officials also informed Finance Minister that between FY 2021-22 and FY 2024-25, around 26 crore new users and 5.5 crore new merchants have been successfully onboarded onto the UPI platform. UPI now has approximately 45 crore annually active users.

In FY 2024-25, UPI transactions amounted to Rs 261 lakh crore - a 30 per cent YoY growth. Similarly, in terms of volume, 18,586 crore transactions took place in FY 2024-25 - a 42 per cent annual growth.The UPI saw a 13.59 per cent increase (on-month) in transaction volume at 18.3 billion in the month of March, from 16.11 billion in February, as per the latest NPCI data. The month of March saw a record Rs 24.77 lakh crore worth UPI-based transactions, up 12.79 per cent from 21.96 lakh crore in February. On a daily basis, the UPI network recorded more than 590 million average transactions at 79,910 crore daily transaction count, according to the NPCI data.

fully automated APM Terminals at Maasvlakte II, provided insights into Rotterdam's stateof-the-art infrastructure and operational efficiencies.He highlighted the potential for collaboration in modernising Indian ports, aligning with India's Maritime Vision 2030, which aims to enhance port capacity and logistics efficiency. The visit laid the groundwork for setting up a Green and Digital Corridor between the Port of Rotterdam and Indian ports like the Deendayal Port Authority Kandla, and export of Green Hydrogen and carriers like Ammonia and Methanol from India to Europe, with the Port of Rotterdam acting as a gateway to Europe.

Later, Barthwal travelled to Veldhoven to visit the headquarters of ASML, a global leader in photolithography systems for the semiconductor industry. In a productive meeting with ASML CEO Christophe Fouquet, the Commerce Secretary discussed deepening India-Netherlands cooperation in the semiconductor sector. The discussions focused on leveraging ASML's expertise to support India's ambitions to become a global semiconductor

manufacturing hub, as outlined in the India Semiconductor Mission. The Commerce Secretary also visited the Republic of Croatia from April 22-23, where he held bilateral discussions with Zdenko Lucic, State Secretary for Foreign Trade and Development, Ministry of Foreign and European Affairs, and Ivo Milatic, State Secretary, Ministry of Economy. The meetings focused on advancing India-Croatia trade and investment relations, promoting sectoral collaboration, and reinforcing India's engagement with the Central European region.

During the meeting with Zdenko Lucic, discussions centred around taking forward the EU-India Free Trade Agreement (FTA) and enhancing bilateral trade cooperation. The Commerce Secretary mentioned the areas of collaboration between the two countries, like Railways, Global Capability Centres, Electric Vehicles and IT.The Croatian side apprised about their interest in investment in the Defence sector (about flagship products of India), solar cells production, food processing technology, automobiles, knowledge sharing amongst other sectors, the official statement added.

Pahalgam Attack: India's Boycott Means for Pakistan Cricket & Its Board

New Delhi, (HS) : In the wake of the dastardly terrorist attack in Pahalgam, the Indian government has taken some political standpoint but also from a sporting perspective, with the aim being to cut all possible ties with the country. While India has not been playing bilateral cricket with Pakistan since the 2012-2013 series, the Board of Control for Cricket in India (BCCI) has asked the International Cricket Council (ICC) not to put the two teams in the same groups in global events going forward. Pakistan's cricketing revenue has significant dependence on India, be it directly or indirectly. But, with the Indian government and the BCCI deciding to toughen their stance in the wake of the Pahalgam attack, Pakistan is set to face a huge financial impact.

No Indo-Pak cricket in ICC events: If India and Pakistan aren't put in the same group of ICC events like the World Cup and, Champions Trophy, the chances of the two teams facing



each other reduce massively. When it comes to global cricketing events, the organisers deliberately put India and Pakistan in the same group in order to maximise revenue. But, with the BCCI asking the ICC to not do that again, the revenue is bound to take a hit. As per the Federation of Indian Chambers of Commerce and Industry (FICCI), India vs Pakistan cricket matches have generated an estimated Rs 10,000 crore (\$1.3 billion) in the last two decades.

Advertisers even agree to shell out extravagant prices for 10second ads during India vs Pakistan matches. The PCB depends a lot on the revenue it earns from the ICC but India's boycott could result into the apex body's revenue taking a hit, which would directly impact Pakistan's income too. With Pakistan struggling to even cross group stages of ICC events in current times, entire tournament could conclude without a single Indo-Pak match being witnessed.

British Board of Film Classification rates HIT 3, Retro 'strong' for violence

Sailesh Kolanu's Telugu Nani-starrer HIT: The Third Case and Karthik Subbaraj's Tamil Suriya-starrer Retro are both slated for release worldwide on May 1. The British Board of Film Classification (BBFC) rated both films strong for violence and revealed further details of the kind of language and horror used in the films.

HIT 3's synopsis on the BBFC website reads, "In this Telugu-language crime thriller, a maverick police officer is drawn into the disturbing world of a series of gruesome murders he is investigating." It has been rated strongly for 'violence' and 'injury detail' while 'threat and horror', 'language' and 'suicide and selfharm' received high ratings too. For context, the ratings are almost similar to Unni Mukundan's 2024 Malayalam film Marco, which is touted to be the 'most violent

Indian film'. The additional info reveals that there are 'prolonged scenes' involving stabbing, shooting, dismemberment and other bodily harm. The film also has some 'strong language' in one instance, accompanied by 'milder terms' in other scenes. Much like the trailer hinted, the website confirms that scenes depicting trafficking, sex work, harassment and critical danger to a child are

part of the film. Retro's synopsis on the BBFC website reads, "A former gangster who once swore to give up his violent ways must break his vow in order to defeat his enemies and protect his estranged wife in this Tamillanguage action thriller." It has been rated high for 'violence', 'threat and horror', 'language' and moderately for 'drugs', 'sex' and 'sexual violence'.



BCCI slaps notice on 'illegal' use of IPL 2025 content

New Delhi, (HS) : The Board of Control for Cricket in India (BCCI) has cracked down on The Grade Cricketer, a top Australian cricket podcast, forcing its hosts to delete hundreds of IPL 2025-related videos from social media platforms. The move follows a legal notice accusing the podcast

of using tournament images and logos for commercial purposes without authorisation.

Hosts Sam Perry and Ian Higgins stated receiving a "polite legal letter" from the BCCI and IPL authorities over the weekend, demanding the removal of content across YouTube, Instagram, Facebook, and X (formerly Twitter). The notice claimed the podcast used IPL photography and branding beyond 'editorial' limits, specifically for commercial gain. To avoid account suspensions, the duo proactively deleted all IPL 2025 content, including their daily show 'The Big IPL Breakfast', which they are planning to rename as 'The Big Cricket Tournament Breakfast'. The podcast, followed by over a million fans globally, had partnered with Indian grocery platform



As soon as this post went viral, the X decided to take an action and cautioned the other

> BigBasket, a detail the BCCI reportedly cited as evidence of commercial intent. Perry clarified in a YouTube update that the removal was voluntary: "This is something we've done ourselves, it hasn't been done to us, we have removed these videos." Despite this, the hosts confirmed they will continue covering the IPL

with the same frequency, even as they prepare for live shows in India this week. The BCCI's action aligns with IPL media advisories, which restrict the use of official audio, video, or images on social media. Notably, press conference materials are permitted only on news websites or apps for editorial purposes. Uploading such content to platforms like YouTube or Instagram violates IPL's copyright terms.

While the podcast adjusts its approach, Perry emphasised their commitment to IPL coverage: It's very important to note we're going to continue to post coverage of the tournament, at the same cadence that we do." The hosts will also drop 'IPL' from their show title to avoid further disputes.
