26 dead, several injured in terror attack on tourists in J&K's Pahalgam

Srinagar (Agency): At least 26 people were killed and several others injured in a terrorist attack in south Kashmir's Pahalgam on Tuesday. Police sources said that at least two of the injured are in critical condition.

According to sources, terrorists opened fired at tourists in Baisaran, an offthe-road meadow Pahalgam. The injured have been rushed to hospital.

"Our reports say that two-

three militants appeared and opened indiscriminate fire at the tourists at Baisaran," "The initial reports we have suggest that eight tourists were injured in the attack. A few of them are in critical condition," the officer said. Baisaran, which is accessible only by foot, is a popular tourist destination and is crowded during the tourist

Immediately after the incident, a police team rushed to the spot, along with Army and paramilitary forces, to evacuate the tourists and launch a search operation to trace the militants behind the attack. This is the first terrorist attack on tourists this year. The last time militants attacked tourists was in May,

last year, when two tourists were injured. That incident also took place in Pahalgam. Prime Minister Narendra Modi condemned the attack and held a telephonic

conversation with Home

Minister Amit Shah from

Jeddah. Shah is shortly leaving for Srinagar. "I strongly condemn the terror attack in Pahalgam, Jammu and Kashmir. Condolences to those who have lost their loved ones. I pray that the injured recover at the earliest. All possible assistance is being provided to those affected. Those behind this heinous act will be brought to justice...they will not be spared! Their evil agenda will never succeed. Our resolve to fight terrorism is unshakable and it will get even stronger," Modi

PM Modi cuts short Saudi trip after J&K attack, to leave for India tonight



Prime Minister Narendra Modi is cutting short his visit to Saudi Arabia following the deadly terror attack on tourists in Jammu and Kashmir's Pahalgam, sources said Tuesday.

He is expected to leave Jeddah tonight and land India Wednesday morning, given the 2.5-hour time difference.

The decision comes amid national mourning, with at least 26 dead and several injured in what is being called deadliest such attack in the Valley this year. Within hours of the incident, Union Home

Minister Amit Shah also

left for Srinagar.

The attack comes just days after US extradited Tahawwur Rana, accused of plotting 26/11 Mumbai attacks, to India. 

8 Dead, 6 injured as SUV plunges off bridge in Madhya Pradesh

Damoh (Agency): Eight persons were killed, and six others sustained injuries after an SUV fell off a bridge onto a dry river bed in Madhya Pradesh's Damoh district on Tuesday, police said. The accident occurred near Simri village under the Nohata police station area around 11 am, an official said. Superintendent of Police (SP) Shrut Kirti Somwanshi said the SUV driver lost control over the wheels, and the vehicle fell off the bridge onto the dry riverbed of the Sunar River. He said eight of the occupants died, and six others sustained injuries. The official



said the victims were part of a group of residents from Jabalpur district who were travelling in two SUVs from Ghat Pipariya village in

Damoh, and one of the vehicles met with an accident. He said the injured persons were sent to the district hospital for treatment.

Student pushed from moving train by thieves, dies Bhagalpur (Agency): A 21-year-old student,

Kajal, died after falling from a moving train in Sabour, Bhagalpur, on Tuesday. She was chasing a thief who had snatched her bag. The police are accused of negligence as Kajal waited for an hour for an ambulance but received no help. Kajal, a resident of Khagaria, was travelling with her family on the Gaya-Kamakhya Express. They were returning from Kamakhya Temple in Assam and had to get off at Bhagalpur to catch another train to Khagaria. The train stopped at Sabour station, where the tragic incident occurred. Kajal's father, Sunil, explained that while gathering their belongings, a thief jumped off the train with Kajal's bag, which contained important items like her mobile and ATM card. Kajal tried to chase him but was pushed from behind by the thief's accomplice, causing her to fall onto the platform.

Trainee pilot dies in a crash in Gujarat's Amreli



New Delhi (Agency): A trainee pilot lost his life when a trainer aircraft crashed in a residential area of Amreli district, Gujarat, on Tuesday The Aircraft afternoon. Investigation (AAIB) Bureau has despatched a team from here for a probe. The trainee pilot, 22-year-old Aniket Mahajan, was a student of the Vision Flying Training Institute. He was carrying out a solo flight at the time of the accident.

The aircraft involved is a Tecnam P2008. Visuals showed rescue workers pulling out a charred body from the remains of the aircraft. The crash happened in a residential area at around 12.30 p.m. The aircraft fell on a tree before crashing into an open plot of land. The pilot was killed on the spot when the plane crashed and caught fire, Superintendent of Police, Sanjay Kharat, as saying.

US–China trade war: India imposes 12% safeguard duty on certain steel imports amid dumping fears remedy measures against consumption for long

New Delhi (Agency): Amid fears of dumping into India following steep US duties on Chinese goods, the government has imposed a 12 per cent safeguard duty on non-alloy and alloy steel flat products, a notification from the Ministry of Finance released on Monday showed. This follows an investigation by the Directorate General of Trade Remedies (DGTR),

under the Ministry of Commerce and Industry, which in its findings last month said that there was a "sudden and sharp" surge in imports that could "cause serious injury to the domestic

"The safeguard imposed under this notification shall be effective for a period of two hundred days (unless revoked, superseded or amended earlier) from the date of publication of

industry".

notification in the Official Gazette and shall be payable in Indian currency," the notification stated

Notably, several specialised steel items have been excluded from the scope of the measure, including Cold Grain Oriented Electrical Steel (CRGO), tinplate, stainless steel, rubber-coated steel, brasscoated steel, and aluminiumcoated steel, among others. The notification added that the safeguard duty will not apply to product categories priced above the import price on a Cost, Insurance and Freight (CIF) basis—set at \$675 per metric tonne (MT) for hot rolled coils, sheets and plates, and \$964 per MT for colour-coated coils and sheets, whether or not profiled.

Fearing a further surge, the Ministry of Steel had last year urged the Ministry of Commerce to impose a 25 per cent duty on steel products, citing an 80 per cent increase in steel imports from China—to 1.61 million tonnes between January and July 2024.

almost Rs 45-50 lakh crore for the banking system, this could free up the lendable resources by almost Rs 2.7-3 lakh crore and support the credit growth of the banks," he said. This headroom can be equivalent to 1.4-1.5 per cent of additional credit growth potential for the banking system.

Reserve Bank of India on Monday permitted banks to allow minors above the age of 10 years to open and operate savings and term deposit accounts independently. The banks are free to offer additional banking facilities like internet banking, ATM/ debit cards and cheque book facility to the minor account holders on the basis of their risk management policy, product suitability and customer appropriateness, the RBI said in a circular.

Earlier, while minors were allowed to open savings account only, now they can open both savings and term deposit accounts. The existing RBI rules do not mention about giving net banking, ATM/ debit card and

cheque facility to minors. The RBI also said minors of any

Mumbai (Agency): The age may be allowed to open and operate savings and term deposit accounts through his/ her natural or legal guardian. "They may also be allowed to open such accounts with mother as guardian," it said.

In a circular to banks, the RBI aid, "minors above such an age limit not less than 10 years and up to such amount and such terms as may be fixed by the banks keeping in view their risk management policy, may be allowed to open and operate savings/ term deposit accounts independently, if they so desire, and such terms shall be duly conveyed to the account holder." "On attaining the age of majority, fresh operating instructions and specimen signature of the account holder should be obtained and kept on record," the RBI said.

Caste consequences

The release of the Karnataka caste census has shifted the state's political terrain, triggering reactions that stretch far beyond its borders. By revealing that Scheduled Castes (SCs), Scheduled Tribes (STs), and Muslims together form over 50 per cent of the state's population, the report challenges long-held assumptions about social hierarchies ~ and with it, the distribution of power and policy. At the centre of this maelstrom is Congress Chief Minister Siddaramaiah. A long-time advocate of social justice and a leader who has built his politics around the welfare of backward classes, he now finds himself navigating a treacherous path. While the release of the report aligns with his ideological commitment to equity, it also risks alienating politically powerful communities like the Lingayats and Vokkaligas, who now find themselves statistically diminished. The report, based on a 2015 survey initiated during Mr Siddaramaiah's previous term, claims that SCs form 19.5 per cent, Muslims 16 per cent, and STs 7 percent of Karnataka'



population. Lingayats and Vokkaligas ~ historically considered dominant ~ stand at 13 per cent and 11 per cent respectively. These numbers challenge the very foundation of how political and administrative representation has been shaped in the state. The Congress, currently in power, is attempting to use the data to strengthen its pitch as the party of the marginalised. But this move comes with risks. The Vokkaligas, who have traditionally leaned towards the Janata Dal (Secular), and the Lingayats, a crucial vote bank for the Bharatiya Janata Party (BJP), may interpret the report as a threat to their standing. BJP leaders have already accused the Congress of trying to divide society for political gains, while JD(S) has raised questions about the census's methodology.

The real test lies in whether political parties can rise above electoral arithmetic to use the data for genuine policy reform, or whether it will merely sharpen caste-based polarisation. For Siddaramaiah, the bind is clear: acknowledge the data and push for a restructured reservation framework ~ which could invite political backlash from dominant communities ~ or delay action and face accusations of abandoning the cause of backward classes, especially the numerically significant Kuruba community to which he belongs. At the national level, this has triggered fresh demands for a nationwide caste census. The Congress has endorsed this call, while the BJP-led central government has so far resisted it, wary of opening a Pandora's box of competing claims that could disrupt its broad-based Hindutva coalition. The Karnataka caste census is more than just a dataset ~ it is a mirror held up to India's social structure. Whether it leads to a fairer redistribution of opportunity or becomes a tool of political brinkmanship depends on how leaders like Mi Siddaramaiah choose to wield it. The challenge is not just electoral but ethical: can data-driven governance coexist with the compulsions of identity politics?

Few answers

The election debate of Canada's national leaders was less a clash of ideas and more a careful political dance. The candidates delivered rehearsed messages, stayed mostly civil, and avoided any real gaffes ~ but they also left viewers with little clarity on the most pressing issue of the moment: how Canada intends to navigate a renewed economic standoff with the United States. With US tariffs once again targeting Canadian goods, including steel, aluminum, and autos, voters were looking for concrete answers. Instead, they got vague assurances and strategic dodges. The historic "dollar-for-dollar" tariff response has been abandoned, but what replaces it? New Prime Minister and Liberal leader Mark Carney spoke of "targeted tariffs" that would minimise pain for Canadians while hitting back at the US ~ a nice theory, but short on specifics. His opponents weren't much better. While critical of the government's handling of trade, none offered a plan detailed enough to inspire confidence. For an issue that could dramatically reshape Canada's economy, the lack of clarity was jarring. The ambiguity didn't stop at trade. Mr Carney faced the unenviable task of defending his party's decade-long record on affordability and housing ~ a record that has left many Canadians priced out of their own cities. His go-to defense was that he is "a very different person than his predecessor Justin Trudeau" and has only been in office a month. But can a fresh face erase 10 years of rising costs and shrinking middle-class security?

Opposition leaders were quick to say no. Conservative leader Pierre Poilievre spoke repeatedly of a "lost Liberal decade," hammering home failures on housing and inflation. His message was simple: nothing will change if Mr Carney wins. It was an effective line of attack, especially in a campaign where voters are frustrated by stagnant wages and soaring rents. Mr Carney, in response, remained composed and intellectually sound ~ but whether he distanced himself from his predecessor's baggage remains uncertain. Voters aren't merely judging a candidate ~ they're judging the entire political inheritance they represent. In that sense, Mr Carney's challenge is not just to campaign, but to account for a government he did not build but now must defend. In a landscape increasingly dominated by extremes, Mr Carney's nuanced messaging may appeal to centrist voters craving balance ~ those disillusioned by ideological rigidity but sceptical of populist quick fixes. Jagmeet Singh, leading the New Democrats, offered a vision of social expansion but was largely drowned out by the main event between Mr Carney and Mr Poilievre. Mr Singh tried to paint Mr Carney as more of the same, but he too failed to outline how his policies would be funded or implemented. The Bloc Québécois leader focused on Quebecspecific concerns, offering little to the national conversation. The debate confirmed what many suspected: this election will hinge not on personalities or performance, but on trust. Voters want answers ~ especially on trade, affordability, and leadership. What they got instead were careful words, polished delivery, and an open question: is this enough?

Protests against Waqf Act: Fear and polarisation

It is imperative that the budding movement protesting the Waqf Amendment Act, 2025 in West Bengal and elsewhere, shun violence and adhere to peaceful methods.

Waqf Amendment 2025. predictably triggered across districts of West Bengal — a enshrined state where Muslims account for over 27 per cent of the population. Murshidabad, a Muslimmajority district, angry protests have spilled over into violence leading to the tragic loss of lives and the deployment of central security forces following the direction of the Calcutta High Court. The sequence of events is reminiscent of violent protests against NRC Bengal, and CAA in Murshidabad following the enactment of the Citizenship Amendment Act in 2019. Political violence is not uncommon in West Bengal, but the

recurrence of large-scale communal violence at frequent intervals is a more recent phenomenon. This is a direct outcome of the polarisation strategies deployed both by the BJP and the Trinamool Congress in West Bengal since 2017-18, which has led to the radicalisation of significant sections within both the majority and minority communities. While this has yielded electoral dividends

Communalism fundamentalism, which till a decade ago remained at the fringe of the political and social mainstream, have now assumed centerstage.

The immediate concerns of restoring peace, providing relief to victims and reasserting the rule of law in the areas disturbed by communal violence in West Murshidabad district, should not distract us from addressing the root cause of such conflicts and violence. executive initiatives of the union government have drawn criticisms regarding contraventions of the secular principles in India's Constitution The abrogation of Article 370, construction of the Ram Mandir, the NRC in Assam, the enactment of the CAA 2019 and efforts to implement the Uniform Civil Code (UCC), initiated one after another, have adversely impacted India's more than 20 crore Muslim population. The Waqf Amendment Act has added salt to those injuries. However, in West

misunderstanding about the Waqf Act has furthered the tensions. To dispel the misconceptions, one first needs to focus on the fine print of the legislation.

Many provisions of the Bill seem to contravene the fundamental rights equality before the law, freedom of conscience and religion and the federal principle. While renaming the law as Unified Waqf Management, Empowerment, Efficiency and Development Act, the amendment legislation actually redefines what is "waqf" and brings about a drastic overhaul of the entire management system of waqf properties — which are religious and charitable endowments of a permanent nature under Muslim including mosques, madrasas, orphanages, graveyards, dargahs, Idgahs etc. Before the amendments, the Waqf Act of 1995 entrusted the management of waqf assets to state-level waqf boards, composed of elected representatives as well as representatives from the government and recognised Muslim organisations in each state. While waqf

claims, dispute resolution was undertaken by state-level waqf tribunals, their decisions justiciable only in the higher courts. The central waqf council played an advisory role and provided policy guidance. The previous version of the law also allowed any person to dedicate any movable or immovable property as waqf. However, the new act stipulates that a waqf endowment can only be made by a "person showing or demonstrating that he is practising Islam for at least five years, of any movable or immovable property, having ownership of such property and that there is no contrivance involved in the dedication of such property". How would a person demonstrate that she/he is practising Islam for at least five years? Who would issue or verify such certification? Moreover, how does a person demonstrate that there is no "contrivance" involved in the dedication of a property as waaf? The new waqf law has

nullified "waqf by user" and all claims of waqf boards on what is considered to be "government property". All waqf properties declared before commencement of the law would have to be delisted. Powers of inquiry and survey have been transferred from the survey commissioners and waqf boards to district collectors. Collectors, being civil servants, cannot be expected to be neutral players when there is a property dispute between the government and waqf boards. Taking away the powers of survey and inquiry strikes at the root of the autonomy of the waqf boards.

The new law also reconstitutes the central council and state waqf boards on the basis of nominated replacing elected members; and allows a significant increase in the number of non-Muslim members in the central waqf council and state waqf boards, including the CEOs

The RSS from the lens of a Christian layman

Growing up in a small Christian-majority village in Kerala's Kannur district, my world was defined by the church bells, catechism classes, and the vibrant festivals that marked our community's cultural calendar. But amid this deeply rooted Christian environment, a unique encounter during my childhood left an impression that has only deepened over time - an encounter with the Rashtriya Swayamsevak Sangh, better known as the RSS.

It was a man named Balakrishnan, a dedicated RSS pracharak, who first introduced me to this organization. For an impressionable child, his personality - calm, composed, disciplined - was striking. He was not a politician, nor a fiery speaker, but a man of gentle demeanor, deep conviction, and unparalleled punctuality. While the village was mostly Christian and naturally hesitant about anything remotely connected to 'Hindutva,' Balakrishnan was quietly winning hearts - not by words, but by example.

Years later, in college, I met Sudheesh T.T., a close friend and another admirer of the Sangh's ideals. Our conversations extended late into the night - not debates, but thoughtful discussions. Through him, I be-

gan to understand the ideological foundations of the RSS: a vision of cultural nationalism, of service to the nation, of a unified identity rooted in Bharat's civilizational values

It wasn't the kind of nationalism that screamed slogans or chased media headlines — it was a quiet, deep commitment to the motherland. As a Christian, I found no contradiction here. In fact, it reminded me of the message of universal love and sacrifice that Jesus Christ preached. As the RSS enters its centenary year, completing 100 years since its founding in 1925, I write this as an outsider - not a member, not a swayamsevak — but a keen observer, a Christian layman who has learned to appreciate and admire the Sangh from a distance.

At a time when ideological labels are easily weaponized and narratives often polarize, the RSS remains a subject of much scrutiny, suspicion, and sadly, caricature. But what gets missed in political debates is the deeper spirit of the organization — its ceaseless commitment to discipline, service, and nation-building. I have seen swayamsevaks quietly help flood victims before the state machinery arrived. I have seen RSS-affiliated organizations running blood donation camps, orphanages, relief work during the pandemic, and countless seva activities across villages and urban slums.

The Sangh is not just about ideology. It is a way of life. It is about waking up at dawn, doing physical training, engaging in intellectual discussion, and above all, offering oneself in service without expecting anything in return. That ideal - of selfless service - resonates across religions. In Christianity, it's called "agape," the unconditional love that serves without seeking reward. The RSS embodies this spirit through its countless pracharaks who live celibate lives, travel across the country with just a bag, and dedicate themselves to the cause of the nation. In my professional life, I have been fortunate to work under professors who embodied this same spirit. Prof.

Jaya Prasad and Prof. Santhisri Pandit - both of whom were closely familiar with the RSS worldview - showed me that nationalism is not a slogan but a form of ethical living. Their personal integrity, their commitment to truth, and their willingness to mentor students across ideological divides reflected the best of what the Sangh seeks to cultivate — character. This, to me, is the core

society — character formation. In a world increasingly driven by superficial achievements, consumerism, and identity politics, the RSS emphasizes inner strength, ethical clarity, and devotion to a higher cause. In a society that often forgets its village roots, the Sangh reminds us of the values of community, cooperation, and culture.

Some critics often argue that the RSS excludes religious minorities. As a Christian who has engaged with swayamsevaks for years, I can say with honesty that has not been my experience. Yes, the organization sees Bharat through the lens of cultural nationalism rooted in Hindu civilization. But Hinduism here is not a religion in the narrow sense; it is a civilizational identity that embraces diversity. The RSS does not ask Christians or Muslims to give up their faith. It simply asks all Indians to love their motherland, know its heritage, and live in harmony. Swami Vivekananda once said, "You will be nearer to Heaven through football than through the study of the Gita."

The RSS took that message literally. Its daily shakhas physical training sessions held in open fields — build brotherhood, fitness, and discipline.

There is no caste, no religion, no economic distinction in a shakha. Everyone wears the same dress, follows the same drill, and chants the same patriotic songs. That egalitarian spirit is something I wish many Christian parishes would emulate. The centenary of any organization is a time to reflect. The RSS, from its humble beginnings in Nagpur in 1925 under the leadership of Dr. K.B. Hedgewar, has grown into the world's largest voluntary organization. That did not happen through money or mar-

It happened because the idea of Bharat Mata touched millions. It happened because young men and women, inspired by a higher call, gave their lives to building the nation — not for fame, not for political power, but for the sheer joy of service. As a Christian layman, I cannot but admire this. I may go to church every Sunday, but I also salute those who wake up at 5 AM every day to build a better India. I may read the Bible, but I also respect the swayamsevak who reads the Gita and then serves in a tribal village for 10 years teaching poor children. I may believe in Jesus, but I also bow before the idea of Rashtra dharma — the duty to-

wards one's nation. There is a lot the Christian

community in India can learn from the Sangh. Its emphasis on character, discipline, simplicity, and service should be part of every religious upbringing. In fact, true ecumenism lies not in doctrinal debates but in shared service. The Sangh is not trying to convert anyone; it is trying to convert apathy into action, indifference into involvement. As we move into the next century, India needs more such organizations - rooted in culture, driven by values, and dedicated to the nation. Political parties will come and go. Governments will change. But civil society institutions like the RSS are what sustain the soul of a nation.

They form the moral backbone of democracy. Today, when I think of Balakrishnan, that simple pracharak who first taught me what RSS was, or Sudheesh, who patiently explained the idea of cultural nationalism over cups of tea, I feel a quiet sense of gratitude. They did not preach; they lived their ideals. And in doing so, they inspired others — like me. This is what the RSS does best. It inspires. Not by propaganda, but by personal example. Not by force, but by faith. And for that, as a Christian layman, I say with all honesty - I salute a hundred years of RSS.

Harvard sues Trump administration to stop the freeze of more than \$2 billion in grants

Boston (Agency): Harvard University announced Monday that it has filed suit to halt a federal freeze on more than \$2.2 billion in grants after the institution said it would defy the Trump administration's demands to limit activism on campus

In a letter to Harvard earlier this month, the Trump administration had called for broad government and leadership reforms at the university as well as changes to its admissions policies. It also demanded that the university audit views of diversity on campus, and stop recognizing some student clubs.

The Trump administration did not immediately respond to an email from The Associated Press requesting comment.

Trump's economic approval hits lowest since presidency, survey finds

NEW DELHI: US President Donald Trump is facing a significant dip in his economic approval ratings, with his performance on the economy registering the lowest numbers of his presidency. According to the latest CNBC All-America Economic Survey, discontent over issues like tariffs. inflation. and government spending contributed to this decline.

The surge of economic optimism that followed Trump's election in 2024 has all but disappeared, with more Americans now predicting that the economy will worsen, a stark shift from the hopeful outlook that marked earlier years. The survey revealed a sharp turn towards pessimism about the stock market as well, with many feeling uncertain about future economic prospects.

The survey, conducted from April 9 to 13 with a margin of error of +/- 3.1%, found that Trump's approval rating on the economy stands at 43%, while 55% of respondents disapprove. This marks the first time in any CNBC poll that Trump has had a net negative rating on the economy. For presidential approval, Trump stands at 44% approval versus 51% disapproval, which is slightly better than his final

approval rating when he left including independents and is Trump's approach to tariffs office in 2020. While Trump's Republican base



remains largely supportive of his economic policies, there has been a noticeable decline in support among key groups,




country stands with NATO. He said that seeing the Russian threat, they are working to keep their allies safe and for their national security. This mission

Teacher had sex with 17-year-old student, court released her on bail of Rs 25,000



Texas (Agency). Former Texas Riverbank High School teacher Karah Hernandez (31) has been arrested for having sex with a minor student. The incident dates back to 2022, when Hernande allegedly had sex with a 17-yearold student. Police arrested her from her home on February 14 after investigating the matter. She previously taught at Ronald Thornton Middle School and resigned in September 2024 after a former student filed a complaint against her. Media reports said Karah Hernandez has been charged with two criminal charges - improper relationship between student and teacher and obscenity related to sexual activity with a child. Hernandez is accused of intentionally having sex with a student around April 1, 2022, when she was teaching at a Houston-area school. Her bail amount has been set at US \$ 25,000 for each charge. Her next

appearance is on April 28. The school district said that during the investigation, the teacher resigned before being dismissed. Although according to a Facebook post on social media, Hernandez was an orchestra teacher, but this could not be independently confirmed in the media. Earlier this month, Dulce Flores (33), a Spanish teacher teaching at a high school in California, was also arrested on similar charges.

Riverbank High School since 2016, is accused of having a sexual relationship with a 17year-old student. She has been kept in Stanislaus County Jail where she has been kept on a bail of US \$20,000. These cases have once again raised serious questions about the safety of students in schools in America and the limits of teacher-student relationships.

In a statement, YRF described the film as "an intense love story that brings YRF and Mohit Suri together for the first time." Ananya also shared an Instagram Story, welcoming her brother to movies.

Ahaan Panday, son of Chikki Panday and nephew of veteran actor Chunky Panday, has long been in the spotlight as a potential Gen-Z star. Over the years, he has been personally trained and mentored by Aditya Chopra in preparation for his big-screen debut. Before making his acting debut, he had worked as an assistant director on YRF's widely watched series The Railway Men. His entry into the industry follows a similar path to other star-kid launches, echoing the moves of Aditya Chopra's contemporary Karan Johar, who has frequently launched star kids under Dharma Productions.

Earlier, Aditya Chopra also introduced Aamir Khan's son, Junaid Khan, in Maharaj, a Netflix original, based on the historic Maharaj Libel Case of 1862. The film became embroiled in controversy prior to its release, with the court issuing a stay on the grounds that it might hurt religious sentiments. However, after reviewing the film, the Gujarat High Court lifted the stay, stating it found nothing objectionable, and the film was allowed to release on Netflix. YRF has announced that Saiyaara will hit theatres on July 18, 2025.

He plays Preyamvadeshwar Pyare Chand, an ichchhadhari naag (a serpent with the power to transform into a human) embarking on a wild, supernatural adventure. Directed by Fukrey fame Mrighdeep Singh Lamba, Naagzilla marks the filmmaker's second collaboration with Dharma after Tu Meri, Main Tera. But what's perhaps more headline-worthy is the fact that this also marks the second official film team-up between Kartik Aaryan and Karan Johar, following their now-famous fallout over Dostana 2. That film, co-starring Janhvi Kapoor and Lakshya, was shelved after nearly a month of shooting, sparking a wave of speculation. Now, the two appear

The film's motion poster, shared by Karan Johar on Instagram, features Kartik in a snake-infested cave, cloaked in a serpentine green skin, gazing over a misty cityscape. Interestingly, while horror-comedies are the latest Bollywood trend, shapeshifting serpents — naags and naagins have long been television royalty. Ekta Kapoor's various renditions of Naagin, especially with Mouni Roy, have been TRP juggernauts, and Naagzilla looks like a big-screen evolution of that mythological madness.

"I apologize to all my supportive friends, my family, and that community for my way of speaking and for using inappropriate language. Going forward, I will work to ensure this does not happen again. I will work on my anger. And if I need to address an issue, I will use the right words. I hope you will forgive me," he added.

An FIR was registered against Kashyap in Jaipur for his remarks on Brahmins on X. The case was registered based on a complaint lodged by Anil Chaturvedi, a Barkat Nagar resident, on Saturday night. The complainant alleged that the director posted abusive words about Brahmins while replying to a social media user. Chanakya Sena leader Pandit Suresh Mishra also announced a cash reward of Rs 1 lakh for blackening Kashyap's face.

Kashyap was defending Ananth Mahadevan's historical drama Phule, based on the life of social reformer couple Jyotiba Phule and Savitribai Phule, slated to release on April 25, after it had courted controversy over its portrayal of caste. Kashyap had questioned the row surrounding the film and while replying to a social media user, the director made the contentious remark against the Brahmin community. After being widely trolled for the comment, Kashyap apologised on Saturday. In an Instagram post, he wrote, "This is my apology, not for my post but for that one line taken out of context and the brewing hatred.

Amendments approved for effective implementation of Mukhyamantri Kanya Vivah/Nikah Yojana

Bhopal (Agency): meeting of the Council of Ministers was held in the Ministry on Tuesday under the chairmanship of Chief Minister Dr. Mohan Yadav. The Council of Ministers approved amendments for effective implementation of the Chief Minister Kanya Vivah/Nikah Scheme. Under the scheme, the girl and the girl's parents should live below the poverty line, and their verification on the BPL portal will be mandatory.



Mass marriage/Nikah programs will be organized by issuing calendars division wise on an annual cyclical basis for Kanya Vivah and Nikah conferences.

The minimum number of couples participating in the mass marriage conference organized in division wise districts has been fixed at 11 and the maximum at 200 couples. In the scheme, scrutiny of applications received in mass marriage/nikah conferences will be done at the body level

as before. Aadhar e-KYC of the bride and groom will be mandatory eligible/ineligible Samagra portal. While trying to make the financial benefits provided by the government for mass marriage programs meaningful, the cooperation of the rich and capable persons of the society will be obtained by ensuring the participation of public representatives and other social organizations in the event. Scheme, out of the amount of Rs 55 thousand per girl, an account payee cheque of Rs 49 thousand will be given to the bride and the remaining Rs 6 thousand will be provided to the concerned body for organizing the mass marriage ceremony. The assistance amount of Rs 49 thousand will be given to the bride's account through Direct Benefit Transfer (DBT) and the remaining Rs 6 thousand will be provided for expenditure on the arrangements of the event.

In-principle approval of Rs 145 crore for development of buffer areas of Tiger Reserve

Increasing trend of filing rape cases against men of the family to put pressure on in-laws: Delhi Court

Delhi (Agency): The Special Court of Patiala House in Delhi acquitted 3 accused, including a 68-year-old man, of rape charges. The court admitted that the allegations leveled by the complainant woman against her father-in-law were false. The court said that in cases of marital disputes, the trend of filing rape cases against men of the family to put pressure on in-laws is increasing. The case was based on the allegations leveled by a daughter-in-law against her 68-year-old. Allegedly frustrated with her married life, the woman had accused her father-in-law of raping her. She also claimed that in an attempt to kill her, her father-in-law forcibly made her drink a chemical called 'All Out'. The court said in its decision that after a thorough investigation of the facts and evidence, the woman's testimony was found to be full of contradictions and inconsistencies. There were differences in her statements during the investigation and the trial, which has reduced her credibility. In the present circumstances, it would not be right to convict the accused only on the basis of the woman's uncorroborated testimony. During the trial, the accused's lawyer Ravi Dral argued in the court that the complainant woman has exaggerated the marital quarrel and turned it into a heinous crime. The lawyer said that it is beyond imagination that a physically disabled 68-year-old man could do such a thing to a woman 40 years younger than him. The lawyer also highlighted many contradictions in the woman's statements. The lawyer said that despite being educated, the complainant was unable to remember the exact date of the alleged incident. However, she gave detailed information about other incidents of the same time. This inconsistency cast doubt on the credibility of his claims.

Sensation spread in the area after a man was stabbed to death for refusing to give a bidi

Delhi (Agency): A young man was allegedly stabbed to death in Prahladpur area of south-east Delhi for refusing to give bidi to two people. Police gave this information on Tuesday. Police said that the elder brother of the young man and his friend were injured in this incident which took place on Monday night. Three people have been arrested in connection with the incident. Officials said that on Monday in a park, Soheb refused to give bidi to local residents Munna and Sunny, due to which both the youths slapped Soheb in anger. According to the police, Soheb went home and told his mother Sabukta about this. After this, Sabukta went to those two people along with Soheb and his elder brother Mohsin. Soheb also called his friend Akram to the spot. Police said the clash turned violent when Munna, 26, along with his brother Imtivaz, 30, and nephew Sunny, 20, attacked Soheb and his men with knives. Police said the injured were rushed to ESI Hospital, where doctors declared Soheb dead.

Central government and others asked to respond on illegal colonies in Sangam Vihar

Delhi (Agency): The National Green Tribunal has put the Central Government in the dock over the colonies illegally settled inside the forest area in Sangam Vihar area of South Delhi. Expressing displeasure over the open violation of environmental protection laws, NGT has asked the Center to file a detailed reply within a week. The tribunal has made it clear that it cannot give legal recognition to any construction that has been done by disregarding the Forest Protection Act and other environmental rules. According to the Delhi Jal Board, there are a total of 44 unauthorized colonies in Sangam Vihar area. Out of these, 22 colonies are located directly within the forest area, while the rest of the colonies are partially built on forest land.

Home Ministry cuts Atishi's security

Delhi (Agency): The Home Ministry has ordered a reduction in the security of former Delhi Chief Minister Atishi. The ministry has asked the Delhi Police to reduce Atishi's security category from Z to Y. An official said that this decision has been taken after a review of Atishi's threat assessment by central security agencies, which concluded that there is no new or significant threat that

requires continuation of Z category security. Police sources said that this directive was issued recently when the security unit of Delhi Police sought guidance from the Ministry of Home Affairs (MHA) regarding Atishi's security status. Earlier, she had also spoken up on Aam Aadmi Party (ÂAP) chief Arvind Kejriwal's Zplus category security and asked whether it should be continued? The official



said that although the ministry had initially advised not to make any changes in the security arrangements implemented for both Kejriwal and Atishi, it later directed the Delhi Police to reduce Atishi's security to Y category. Under the Y category security arrangement, Atishi will now be guarded by around 12 personnel, including two Delhi Police commandos. The reduction in security also means that some privileges, such as the pilot vehicle that used to accompany her convoy during her brief tenure as chief minister, will now be withdrawn. The official said that in March, the Delhi Police had proposed to withdraw the Y category security given to former Delhi Deputy Chief Minister Manish Sisodia, AAP MLA Ajay Dutt and former Delhi Speaker Ram Niwas Goel. Security to political leaders is given or changed based on the threat assessment done from time to time by central intelligence and security agencies on the instructions of the Home Ministry. Atishi was provided Z category security after assuming office as chief minister.
