## **IMD** predicts thunderstorm activity till May 18

Bhubaneswar, 15/5 MC): The India (**DMC**): Meteorological Department (IMD) on Thursday predicted that thunderstorm activity with lightning, gusty surface winds are very likely to occur across Odisha during 15th to 18th May 2025. Thunderstorm with lightning with gusty surface wind speed reaching 50-60 kmph very likely to occur in the afternoon/evening hours at one or two places over the districts of Angul, Keonjhar, Mayurbhanj, Balasore, Bhadrak, Ganjam, Gajapati, Nawarangpur, Koraput, Malkangiri, and Rayagada.

Thunderstorm lightning with gusty surface wind speed reaching 50- 60 kmph very likely to occur in the afternoon/evening hours at one or two places over the districts of Kendrapara, Jagatsinghpur, Sundargarh, and Kalahandi. ## 'Can timelines be imposed & manner of exercise be prescribed through judicial orders?' President Murmu asks Supreme Court on assent to Bills

New Delhi, 15/5 (H.S): With the Supreme Court setting timelines for the President and Governors to act on Bills sent by state assemblies, President Droupadi Murmu has sought the top court's opinion under Article 143(1) on whether their actions are justiciable and whether such timelines can be imposed on them in the absence of any such provision in the Constitution.

In April this year, the Supreme Court set a timeline for Governors to act on Bills, and for the first time, prescribed that the President should take a decision on the Bills reserved for consideration by the Governor within three months from the date on which such reference is received. Under Article 201 of the Constitution, no timeframe has been set for a presidential decision.

The top court said that "in case of any delay beyond this period, appropriate reasons would have to be recorded and conveyed" to the state concerned. The court, in a ruling, declared the action of Tamil Nadu Governor R N Ravi as illegal and erroneous in reserving 10 Bills for consideration of the President in November 2023 after they had already been reconsidered by the state Assembly. "Is the exercise of constitutional discretion by the Governor under Article 200 of the Constitution of India justiciable? Is Article 361 of the Constitution of India an absolute bar to judicial review in relation to the actions of a Governor under Article 200 of the Constitution of India? In the absence of a constitutionally prescribed time limit, and the manner of exercise of powers by the Governor, can timelines be imposed and the manner of exercise be prescribed through judicial orders for the exercise of all powers under Article 200 of the Constitution of India by the Governor?"

President Murmu asked. The reference also sought to know; whether "in light of the constitutional scheme governing the powers of the President, is the President required to seek advice of the Supreme Court by way of a reference under Article 143 of the Constitution of India and take the opinion of the Supreme Court when the Governor reserves a Bill for the President's assent or otherwise?" "Are the decisions of the Governor and the President under Article 200 and Article 201 of the

Constitution of India, respectively, justiciable at a stage anterior into the law coming into force? Is it permissible for the Courts to undertake judicial adjudication over the contents of a Bill, in any manner, before it becomes law?"and "can the exercise of constitutional powers and the orders of/by the President / Governor be substituted in any manner under Article 142 of the Constitution of India?"Some of the other questions referred to the SC are, "What are the constitutional options before a Governor when a Bill is presented to him under Article 200 of the Constitution of India?

Is the Governor bound by the aid & advice tendered by the Council of Ministers while exercising all the options available with him when a Bill is presented before him under Article 200 of the Constitution of India? President Murmu pointed out that Article 200 of the Constitution, which prescribes the powers of the Governor and the procedure to be followed while assenting to Bills, withholding assent to Bills and reserving a Bill for the consideration of the President, "does not stipulate any time frame upon the Governor for the exercise of constitutional options."

## 'Blocks Are The Mirror of Governance': CM Majhi Sets Agenda For Grassroots **Development**



Bhubaneswar, 15/5 (DMC): Stressing the pivotal role of grassroots administration, Chief Minister Mohan Charan Majhi on Thursday said that the government's success will be judged by the efficiency of its blocks and the extent to which citizens benefit from development schemes. Addressing a state-level conference of Chief Development Officers (CDOs) and Block Development Officers (BDOs) at the Convention Centre in Lok Seva Bhawan, Majhi declared, "Our blocks are the mirror of our administrative success. If the blocks function efficiently and people benefit from all schemes, it will be proof of the government's competence."He emphasized that the CDOs and BDOs act as the critical link between the government and the people. "You are the bridge. A strong and wide bridge ensures better communication and delivery. These schemes are not charity-they are the people's right. Never treat the public as objects of pity," he said. Asserting his commitment to public service, Majhi said, "Prime Minister Modi calls himself the Pradhan Sevak, and I too consider myself the Chief Servant of Odisha. You must work with the same mindset. Corruption and negligence will not be tolerated." He issued a clear warning that any dereliction of duty would result in strict action. The conference comes as the state seeks to enhance the delivery of key rural welfare schemes, including the Pradhan Mantri Awas Yojana, Antyodaya Griha Yojana, MGNREGS, Viksit Gaon Viksit Odisha, Subhadra, Vision 2036, and Vision 2047. # Odisha CM reaffirms support for steel industry growth



Bhubaneswar, (DMC): Odisha Chief Minister Mohan Charan Majhi on Thursday reiterated the state government's commitment to supporting the development of steel industries by ensuring the availability of raw materials and necessary infrastructure.

Speaking at a meeting with a delegation from the Indian Steel Association, led by industrialist Naveen Jindal, Majhi assured that the state would provide all necessary assistance within the framework of existing regulations, following proper consultations with stakeholders. The Chief Minister emphasized importance of scaling up steel production in Odisha and strengthening related infrastructure. Discussions during the meeting focused on increasing India's steel production capacity from the current 165 million tonnes per annum to 500 million tonnes by the year 2047.

Highlighting Odisha's strategic role in achieving this ambitious target, Majhi underscored the need to facilitate access to iron ore and other essential resources at competitive prices. He also addressed the issue of accelerating the operationalization of already auctioned mines and the upcoming auction of additional iron ore blocks-official sources revealed that approximately 30 mines are set to be auctioned this year. The possibility of providing iron ore to steel producers at favorable rates through the state-owned Odisha Mining Corporation (OMC) was also explored. Following the meeting, Naveen Jindal remarked, "A delegation from the Indian Steel Association met with the Chief Minister and senior officials today

We highlighted that India is now the second-largest steel producer globally, and Odisha has played a significant role in this achievement. The state has vast potential to further elevate its contribution to national steel output."Key officials present at the meeting included Chief Secretary Manoj Ahuja, Additional Chief Secretary of the Steel and Mines Department Surendra Kumar, Additional Chief Secretary of the Industries Department Hemant Sharma, and secretaries from other relevant departments.

# "Are Nukes Safe With Pak?" Rajnath Singh **Calls For International Supervision**



New Delhi, 15/5 (H.S): Defence Minister Rajnath Singh on Thursday questioned Pakistan's ability to handle nuclear weapons, days after Prime Minister Narendra Modi said India would not tolerate "nuclear blackmail" from Islamabad. The Defence Minister also called for international intervention to supervise Pakistan's nuclear weapons."The world knows that our army's aim is accurate and

when they hit the target, they leave the counting to the enemies. How strong is India's pledge against terrorism today...it can be known from the fact that we did not even care about their nuclear blackmail. The whole world has seen how irresponsibly Pakistan has threatened India. Today, from the land of Srinagar, I want to raise this question whether nuclear weapons are safe in the hands of such an irresponsible

and rogue nation," Mr Singh said.He added, "I believe that Pakistan's nuclear weapons should be taken under the supervision of the International Atomic Energy Agency (IAEA)". Follow India Pakistan News Live Updates HereRajnath Singh visited the Army's 15 Corps Headquarters in Srinagar and interacted with army personnel during his first visit to the Valley after India's Operation Sindoor, a military strike on terror targets in Pakistan and Pakistan-Occupied Kashmir to avenge the April 22 Pahalgam terror attack.

He also reviewed the overall security scenario and the combat readiness of the Indian Armed Forces and inspected the Pakistani shells that were dropped in the border areas. Mr Singh also visited the Army's 15 Corps Headquarters and interacted with the army personnel. The Defence Minister was accompanied by J&K Lieutenant Governor Manoj Sinha. # Awami League

In its best version, the Awami League (AL), Bangladesh's oldest political party, embodied the principles that underpinned the founding of the country. Going against the political grain of the time, Sheikh Mujibur Rahman attempted to separate religion from government and national identity. That changed under General H M Ershad, who declared Islam the state religion in 1988. While the AL, under Sheikh Hasina's leadership, retained Islam's status as the state religion, it also guaranteed equal rights for Hindus and other religious communities. Bengali linguistic nationalism and secularism, therefore, have had an uneasy coexistence with orthodox Islam. Following Hasina's overthrow in August last year, however, religious conservatism has increasingly taken centre stage. It is reflected in a series of troubling developments: Attacks on the Hindu minority, the vandalism of Mujibur Rahman's home. Another disquieting move is the Muhammad Yunus-led interim government's decision to invoke an anti-terrorism law to suspend all activities of the AL, effectively barring it from participating in the upcoming general elections.

The sweeping ban is expected to remain in effect until the International Crimes Tribunal concludes its investigation into the party. Freezing all political activities and denying the AL a chance to contest the election is a serious blow to democracy. The people of Bangladesh may well choose to punish the AL for its heavy-handedness during the student movement last year. But this must be the prerogative of the voters. By clamping down on political rivals and opponents, the current regime may end up scoring the same kind of self-goal that Hasina did. Ensuring legitimacy and stability should be the top priority for all stakeholders in a country in which politics is still in flux. The vision of a new republic cannot be realised without free and fair elections.

With the AL unlikely to return to power in the foreseeable future, New Delhi must recalibrate its approach by initiating outreach to the Bangladesh Nationalist Party and the newly formed National Citizen Party. India should also reinforce its border security and continue to collaborate with Bangladesh on critical areas such as trade, regional connectivity, and counterterrorism. Amid a fast-evolving geopolitical dynamic, it is essential that Delhi maintains an open and active diplomatic channel with Dhaka. And the interim government in Bangladesh must take concrete steps to protect the country's minorities.

# **International Day of Light**



International Day of Light is celebrated annually on May 16 to celebrate the contribution of light and light-based technologies to various fields and areas of life, including arts and culture, education, medicine, communications, science, and sustainable development. Did you know that in 1802 Humphrey Davy invented the world's first electric lamp? International Day of Light commemorates the anniversary of physicist and engineer Theodore Maiman's first successful laser operation in 1960. The day is observed by the United Nations and administered by UNESCO's International Basic Science Programme (I.B.S.P.). International Day of Light is celebrated around the world through events and forums organized by people both inside and outside the scientific community. Since antiquity, humans have used various materials to produce light, ranging from hollow rock, shells, or wood soaked in animal fat and oil lamps to candles and gas. The modern history of light began with the invention of the electric light bulb. Contrary to popular belief, the light bulb was invented long before Thomas Edison patented it. Edison only made it possible for the light bulb to be manufactured commercially. In 1802, Humphrey Davy invented the electric arc lamp, an early predecessor of the incandescent electric bulb, by connecting voltaic piles to charcoal electrodes. However, the arc lamp was not a practical source of lighting as it was too bright for domestic or work uses, and it burned out quickly. This invention led to the creation of the miner's safety lamp in 1815 and street lighting in several European cities, including Paris, during the 1800s. In 1850, Joseph Swan solved one of the problems that electric lamp inventors have encountered over the years: the cost-effectiveness of the lamp's filament. In place of platinum filaments, Swan used cheap carbonized paper filaments. In 1878, he patented his electric lamp in the United Kingdom and demonstrated it at a lecture in Newcastle, England. Swan's invention, like Davy's arc lamp, was impractical for everyday use due to the inefficiency of its vacuum pumps. When Edison discovered the flaw in Swan's electric lamp, he made improvements and presented his light bulb in December 1879. Swan copied these improvements and established an electrical lighting company in England. Edison filed a patent infringement case against Swan, but this failed. Edison and Swan later formed an alliance called Edison-Swan United, which grew to become the world's largest light bulb manufacturer. In the early 1960s, Nick Holonyak, an employee at General Electric, accidentally invented the red LED light and patented it for use as a light fixture. In the early 1990s, Japanese and American scientists Isamu Akasaki, Hiroshi Amano, and Shuji Nakamura created the blue LED and were awarded the 2014 Nobel Prize in Physics for it. Scientists were able to create white LEDs as a result of this. Lighting is becoming more advanced and sophisticated, with the ability to light up homes and streets wirelessly - using smartphones and AI voice commands. Incandescent light bulbs are also being phased out, with halogen, LED, and OLED alternatives taking their place.

# India Strikes Back: A New Era of Assertiveness

The tragic killing of innocent Indian tourists in Pahalgam on April 22 shocked the nation and once again highlighted the persistent threat of cross-border terrorism. India's response was swift and decisive. On May 7, the Indian Armed Forces launched Operation Sindoor, a targeted military strike on terrorist bases located in Pakistan and Pakistan-occupied Kashmir (Pok). These precision airstrikes signalled a new phase in India's counterterrorism strategy, reflecting its growing military and diplomatic assertiveness. The operation was not just symbolic. Backed by clear visual evidence, the strikes inflicted heavy damage on terrorist infrastructure. The Indian military's prompt release of footage helped establish the authenticity of the operation even as global media attention intensified. However, alongside the military confrontation, India found itself battling an information war. Misleading narratives and fake news-some even from reputed Western media-tried to question the effectiveness of India's action and undermine the credibility of its defence systems. Despite such attempts, international military experts recognised India's strategic maturity. Austrian historian Tom Cooper praised the Indian missile strikes, particularly pointing out the destruction of critical Pakistani military infrastructure, including airbases like Nur Khan and

He argued that Pakistan's inability to deliver a credible counterattack exposed India's military superiority. Equally significant was the role of India's indigenous defence systems. At a press briefing, the Director General of Air Operations confirmed a successful strike on a surface-to-air missile system in Karachi's Malir Cantonment, achieved with surgical precision.

U.S. Army veteran John Spencer, Chair of Urban Warfare Studies at the Modern War Institute, commended India's technological self-reliance, even comparing its systems favourably with those used by China. India's response extended beyond military action. In a bold diplomatic move, the government revoked the Indus Waters Treaty, a significant step indicating that India is willing to use all tools of

statecraft against terrorism. The decision, while carefully measured, was intended to increase pressure on Pakistan without escalating into full-scale war. Amid the ceasefire that followed, controversy erupted when then-U.S. President Donald Trump claimed that the United States had brokered the peace deal. Prime Minister Narendra Modi promptly dismissed the claim, reiterating India's consistent policy of no thirdparty mediation on bilateral issues, especially concerning Kashmir.

Modi also made it clear that future dialogues with Pakistan would focus solely on Pakistanoccupied Kashmir and terrorism, not on the status of Kashmir itself. India also declared that any future terrorist act would be treated as a state-sponsored act of war. The geopolitical fallout of these events exposed the complexities of India's foreign partnerships.

While traditional allies like Russia and Israel reaffirmed their support for India's right to selfdefence, certain challenges emerged. France, a key strategic partner and supplier of Rafale fighter jets, hesitated to share critical software codes and radar configurations. This raised concerns about India's reliance on foreign military technology and highlighted the urgent need for greater defence autonomy. The hypocrisy of the European Union and the West, too, stands exposed in this armed conflict.In

the global media space, bias became evident once again. Many Western outlets described Jammu and Kashmir as "India-occupied," presenting fake or inaccurate narratives. Meanwhile, countries such as Turkey, Azerbaijan, and China openly backed Pakistan. Turkey went further, supplying drone systems to aid Pakistan during the conflict. These actions drew sharp public backlash in India. Despite India's generous humanitarian assistance during Turkey's 2023 earthquake, including medical aid and disaster relief teams, Turkey's open support for Pakistan angered Indian citizens.

A massive "Boycott Turkey and Azerbaijan" campaign spread across social media. With over 300,000 Indian tourists visiting Turkey each year and tourism making up 12.5% of its GDP, many Indians began cancelling their travel plans. Indian traders also started reducing imports of Turkish goods like apples, sending a clear economic message.

Amid all this, India's economic rise and democratic dividend and digital technology have added to its strategic leverage. With a GDP of \$4.3 trillion, India is now the fifth-largest economy in the world and is expected to soon surpass Japan. Analysts believe India can leverage this economic strength to reshape its foreign policy, foster stronger trade relationships with other nations and expand its defence exportsThe government's focus on 'Make in India' and 'Atma

Nirbhar Bharat' (self-reliant India), especially in the defence sector, has become more important than ever. Reducing dependence on foreign military suppliers will allow India greater control over its strategic assets and improve long-term security. Today, India ranks among the top four military powers globally, surpassing even some NATO countries in manpower, strategic doctrine, and emerging technologies.

Defence self-reliance is no longer just a goal-it's a necessity. Diplomatically, India must continue its efforts to isolate Pakistan on global platforms and build international coalitions against terrorism. The events following the Pahalgam attack have sent a clear message. India is no longer willing to absorb terrorist attacks silently. It will defend its sovereignty through precise military action, strategic diplomacy, and economic power.

More importantly, it will do so from a position of strength.As global challenges grow more complex, national unity, strategic clarity, and technological selfreliance are essential. India's path to global leadership depends on its ability to remain firm, focused, and fearless. Now is the time to stand united, resolute and vigilant-as India charts a bold new course in global affairs. Nation comes first, every thing Next.

# Progressing from formal to pure devotion

Cultivated devotion is called vaedhi bhakti, formal devotion. With this, a person can approach Parama Purusha, Supreme Consciousness, but cannot become one with Him. To attain oneness, a sadhaka, requires raganuga bhakti or ragatmika bhakti, that is, ardent devotion that comes from within. Unless a sadhaka has ardent devotion for Parama Purusha, it is not possible to become one with Him.

When a sadhaka performs action, devotion awakens. This is the beginning of vaedhi bhakti. For example, some people pray, "O Parama Purusha, my neighbour's child has passed the school examination, but my child has failed. The teacher has made my child fail intentionally. Let that teacher be destroyed." This is tamasic, static bhakti. With this kind of bhakti you will attain

neither liberation nor salvation because you did not want either one. In rajasic devotion one does not think of harming anyone, but asks for a mundane favour for oneself. For example, one may pray to the Lord, "O Lord, please bless me so that I can score high marks in my exams and thereby procure a good job." To ask for worldly favours as a result of one's crude devotion to the Lord is not at all desirable.

The Lord may or may not fulfill your desires, but one thing is certain: you will never attain liberation or salvation because you did not desire it. All of this comes within the scope of vaedhi bhakti. There is a lack of genuine love for Parama Purusha in all these types of formal devotion. Shudda bhakti, pure devotion, is para bhakti, the highest devotion for the Lord. The first stage of shuddha bhakti is raganuga bhakti. Now the devotee

says, "I love Parama Purusha. This is nothing to hide, nor is it anything to brag and boast about. I love Him because it makes me happy." This is raganuga bhakti. "I don't ask for anything, not even liberation or salvation. I love Him because that brings me joy."In the highest stage of devotion, the ideation is, "I love Parama Purusha because it makes Him happy.

I meditate on Him thinking that my meditation will bring joy to Him. This is my sole intention." This is ragatmika bhakti. When a devotee moves towards Parama Purusha with intense yearning for Him, it is called radha bhava. When a devotee finally reaches Parama Purusha by virtue of this intense radha bhava, it is called the union between Radha and Krishna.

# What Does the SEBC Reservation of the Majhi Government Signify?

Bhubaneswar, (DMC): On Wednesday, the Odisha cabinet sanctioned a reservation of 11.25% specifically for students belonging to Socially and Economically Backward Classes (SEBC), also referred to as Other Backward Classes (OBCs) in other states, in higher educational institutions, starting from the academic session of 2025-26. The cabinet, led by Chief Minister Mohan Majhi, indicated that this initiative is intended to enhance access, equity, and inclusion in higher education, boost the Gross Enrolment Ratio, and provide greater opportunities for marginalized and disadvantaged communities in Odisha.

This reservation policy will be consistently applied across all state public universities and government-supported institutions across various departments, including School & Mass Education, Higher Education, Odia Language and Literature & Culture, and Sports & Youth Services. Through this decision, the state government has guaranteed that reservations will be allocated to students from various categories, including Scheduled Tribes (22.5%), Scheduled Castes (16.25%), and Socially and Economically Backward Classes (11.25%). This initiative raises Odisha's overall reservation quota in higher education to 50%, in accordance with the Supreme Court's limit

Currently, the state offers a 5% horizontal reservation for individuals with disabilities and a 1% horizontal reservation for the children of ex-servicemen and war veterans. In Odisha, the terms Socially and Economically Backward Classes (SEBCs) and Other Backward Classes (OBCs) are used interchangeably. While both the central government and all states provide reservations for OBCs in education following the Supreme Court ruling in 2008,

for vertical reservations.

Odisha was notably the only state that did not extend any reservation to SEBC/OBC for admission into educational institutions, despite granting them an 11.25% reservation in government employment. The emphasis on job reservations was a reaction to the political pressures from SEBC communities, who viewed employment as a crucial avenue for advancement.

Although educational quotas are significant, their urgency has only recently increased. Political analysts noted that for more than twenty years, Odisha's political scene, led by the Biju Janata Dal (BJD), has not prioritized educational quotas for SEBCs due to the competing interests of SC and ST communities, which constitute a substantial electoral constituency. The BJD concentrated on unifying tribal communities and Dalits through

the implementation of existing reservations and welfare programs, deliberately steering clear of the divisive topic of SEBC quotas. The call for educational reservations for SEBCs has only recently gained momentum, driven by advocacy groups for OBCs and a 2023 survey that revealed 39.31% of the state's population as socially educationally disadvantaged," stated esteemed political science professor SP

The SEBC reservation responds to the demands of OBC advocacy groups, who have campaigned for equality with the central government's 27% reservation for OBCs in employment and education. Although the proposed 11.25% quota falls short of the 27% sought, experts believe it represents a meaningful advancement towards fulfilling these demands, which could help alleviate social tensions and political pressures.

"Firstly, any terrorist attack on India will be met with a strong and resolute response. India will retaliate on its own terms, targeting terror hubs at their roots. Secondly, "India will not be intimidated by nuclear threats.

Any terrorist safe haven operating under this pretext will face precise and decisive strikes, and thirdly, India will no longer see terrorist leaders and the governments sheltering them as separate entities". Earlier this week, Prime Minister Narendra Modi visited Punjab's Adampur air base and interacted with soldiers. Adampur was among the air force stations that Pakistan attempted to attack on the intervening night of May 9 and 10 after India's "Operation Sindoor". Pakistan also claimed that its hypersonic missiles fired from JF-17 fighter jets destroyed India's S-400 air defence system in Adampur - a charge rejected by the Indian officials. PM Modi delivered a strong message from the tarmac at the Adampur Air Force base."

Our intent is clear...if there is another attack, India will respond. We saw this after the terror attack on an Army base in J&K's Uri in 2016 and Balakot airstrikes (after the 2019 Pulwama attack). 

## Sabarimala Temple Gold Lockets Worth Over 3 Crore Sold In A Week



Sabarimala, (H.S): The sale of gold lockets with the picture of Lord Ayyappa drew a tremendous response, with the Travancore Devasom Board (TDB) earning over Rs 3 crore in just one week. The gold lockets are blessed at the sanctum sanctorum of the famed temple on a hilltop in the Pathanamthitta district.

The TDB, which manages the temple affairs, pointed out that in a week, 56 sovereigns of gold were used to make 184 gold lockets, which come in three varieties. The two-gram gold locket found the maximum buyers, as 155 people purchased it, followed by the four-gram gold locket bought by 22 people, while seven people opted for the eightgram gold locket. The TDB

pointed out that orders can be made online through the ww. sabarimalaonline.org website or can be booked in the temple office. The two-gram locket costs Rs 19,300, the four-gram Rs 38,600, and the eight-gram costs Rs 77,200.Situated on the mountain ranges of the Western Ghats at an altitude of 3,000 feet above sea level.

the famed Sabarimala temple is a four km uphill trek from Pampa in the Pathanamthitta district, which is around 100 km from the Kerala capital. Currently, girls and women between the ages of 10 and 50 are not allowed entry into the hilltop shrine. The temple dedicated to Lord Ayyappa is accessible only on foot from the Pampa River.As

per practice, before setting off to the holy shrine, a pilgrim normally undertakes an intense 41-day penance where he/she does not wear footwear, dons a black dhoti/black top and sticks to strict vegetarian food.Every pilgrim carries 'lrumudi' on his/her head, which is a prayer kit that contains coconuts which are broken just before climbing the 18 steps to the shrine.

Without it, no one is allowed to step onto the holy 18 steps at the 'Sannidhanam'. Over the years, some traditions at the famed temple have changed. While for many years, this temple used to open only in the second half of November and close around the middle of January, it is now open for a few days at the beginning of every Malayalam month.

## **Govt's First Monthly Data Series Pegs Unemployment At 5.1 Pc In April**

New Delhi, (H.S): The government on Thursday said that Labour Force Participation Rate (LFPR) in current weekly status (CWS), an indicator of employment, among persons of age 15 years and above was 55.6 per cent during April, LFPR for rural areas was 58 per cent and LFPR in urban areas was 50.7 per cent during the month for persons of the same age group. The data also includes rural job figures, for the first time ever, to widen the coverage, according to new series based on monthly data, released by the Ministry of Statistics.The Unemployment Rate (UR) in CWS among persons of age 15 years and above was 5.1 per cent in April, The male UR was a tad higher at 5.2 per cent compared to the female UR of 5.0 per cent at the country level, the data showed. The unemployment rate (UR) in urban areas was 6.4 per

2024 of the old series which were compiled on a quarterly basis.LFPR in CWS for males of age 15 years and above in rural and urban areas were 79 per cent and 75.3 per cent, respectively, while LFPR among females of age 15 years and above for rural areas was 38.2 per cent during April.Worker Population Ratio (WPR) in CWS in rural areas among persons of age 15 years and above was 55.4 per cent. WPR in urban areas among persons of the same age group was 47.4 per cent with the overall WPR at the country level observed as 52.8 per cent during April, as per the data.WPR for female of age 15 years and above for rural and urban areas were 36.8 per cent and 23.5 per cent, respectively, during the month and the overall female WPR of the same age group at the country level was observed as 32.5 per cent. Considering the need for generation of high frequency labour force indicators with

enhanced coverage, the sampling methodology of Periodic Labour Force Survey (PLFS) has been revamped from January 2025. The revamped PLFS design is envisaged to estimate the key employment and unemployment indicators (Labour Force Participation Rate, Worker Population Ratio Unemployment Rate) on a monthly basis for rural and urban areas in the CWS at all India level. The monthly results are planned to be released in the form of monthly bulletins of PLFS. The present monthly bulletin is the first in the series for the month April 2025.A rotational panel sampling design has been adopted in PLFS for both rural and urban areas from January 2025. In this rotational panel is visited four times in four consecutive months - one with first visit schedule and other three with the revisit schedule.

## ED Seizes 32 Cr Assets In Raids On Builders, Officials In Maha's Vasai-Virar City Land Scam

Mumbai, (H.S): In a massive action against builders and their local henchmen, the ED on Thursday searched 13 different premises across Mumbai and Hyderabad, seizing cash and jewels worth nearly Rs 32 crore in a case related to illegal construction of homes and offices on government land in Vasai-Virar City.The accused duped home and office buyers by fabricating documents and carrying out construction on government and private land and selling these illegal properties to them, said an

ED official, adding that 41 such illegal buildings were pulled down by civic agencies in February. The case pertains to "illegal construction of residential cum commercial buildings on government and private land" under jurisdiction of "Vasai Virar Municipal Corporation (VVMC)" since 2009, said an ED official.

It has been found that the key perpetrators of the large-scale scam in the jurisdiction of Vasai Virar Municipal Corporation are Sitaram Gupta, Arun Gupta and others, including the civic agency's Deputy Director of Town Planning, Y.S. Reddy. During searches at Reddy's premises, Rs 8.6 crore and diamond-studded Jewellery and bullion worth Rs 23.25 crore were seized, said an official. Over



a period of time, 41 illegal buildings were constructed on the land reserved for "Sewage Treatment Plant" and "Dumping Ground" as per the approved development plan of Vasai Virar City, he said. The Directorate of Enforcement (ED), Mumbai Zonal Office, carried out the multi-city searches under the provisions of the Prevention of Money Laundering Act (PMLA), 2002, over two days, starting Wednesday.

Giving details of the seizure, the ED said investigators confiscated Rs 9.04 crore cash and Rs 23.25 crore worth of diamond-studded jewellery and bullion and a large number of incriminating documents. The ED initiated an investigation based on multiple FIRs registered by the Mira Bhayandar Police Commissionerate against builders, local henchmen and others. The accused builders and developers deceived he general public at large by constructing illegal buildings on government and private land and subsequently selling them to the general public by fabricating approval documents."Even with prior knowledge that these buildings were unauthorised and would eventually be demolished, the developers misled the people by selling rooms in these buildings, thereby committing serious fraud," said the ED in a statement. The federal agency said the Bombay High Court had on July 8, 2024, ordered the demolition of all 41 buildings.

Thereafter, an SLP was filed before the Supreme Court by the families residing in 41 illegal buildings, which was dismissed. The demolition of all 41 buildings was completed by VVMC on February 20, 2025. Maharashtra's fifth largest city, Vasai-Virar, is an agglomeration of four previously governed municipal councils: Vasai (Bassein), Virar, Nallasopara and Navghar-Manikpur, as well as a few towns to the east and west of the urban area. It lies in the Konkan division.

# Russia-Ukraine Conflict Can Be Solved Diplomatically; Marco Rubio

Istanbul, (H.S): US Secretary of State Marco Rubio on Thursday said that the conflict between Russia and Ukraine cannot be solved militarily.' There is no military solution to the Russia-Ukraine conflict. This war is going to end not through a military solution, but through a diplomatic one," said the top US diplomat as he arrived in Antalya for an informal meeting of NATO foreign ministers.

Rubio further stated that the US hopes that progress will soon be made in the negotiation process, noting the situation around the settlement of the Ukrainian conflict remains complicated. Speaking to reporters in the Kremlin in the early hours of May 11, Russian President Vladimir Putin proposed to the Kyiv authorities to resume direct talks suspended in 2022, without preconditions on Thursday in Istanbul.Russian Foreign Ministry Spokesperson Maria Zakharova on Thursday said that the Russian delegation has arrived in Istanbul for talks on Ukraine and is ready for



serious work."As we have already stated, the Russian side is ready to negotiate in earnest. The Russian delegation has arrived in Istanbul and is ready for serious work," Zakharova said, addressing a news briefing." The Russian President proposed restarting those direct talks in Istanbul on May 15 without delay or any preliminary conditions.

As the Russian President emphasised, the purpose of these talks is to, direct quote, eliminate the root causes of the conflict, to reach the establishment of a longterm lasting peace for a historical perspective," she added. The Russian delegation, headed by presidential aide Vladimir Medinsky, includes Deputy Foreign Minister Mikhail Galuzin, head of the Main Directorate of the General Staff of the Russian Armed Forces Igor Kostyukov, and Deputy Defence Minister Alexander Fomin. However, Putin has decided to skip the visit.

### Torrential Rains Claim 9 Lives, Affect 24,000 More In Somalia: UN

United Nations, (H.S): More torrential rains have hit Somalia, this time in Banadir, northeast of the capital Mogadishu, killing nine people and triggering deadly flooding 24,000 people being affected, UN humanitarians said."Key infrastructure was destroyed, and shelters in displacement sites were swept away," said the UN Office for the Coordination of Humanitarian Affairs (OCHA) on Wednesday. 'The federal government is

leading the response, and the UN and its partners are supporting and delivering food, shelter items, hygiene kits and cash."OCHA said the Banadir rain started on Friday, adding to the heavy seasonal downpours that began in mid-April, causing flash flooding that has claimed 17 lives and affected more than 84,000 people across Somalia, Xinhua news agency reported. Despite heavy rains in most areas of the country, dry and hot conditions persist in parts of northern regions. The office said the flooding came when severe funding cuts forced humanitarian



or even close critical programs. The \$1.4-billion Somalia Humanitarian Needs and Response Plan is 11 per cent funded, with only \$158 million received to date. OCHA said Somalia's humanitarian crisis is among the world's most complex, driven by cycles of internal conflict and climate shocks that drive displacement and undermine development efforts.

The cumulative effect of both violence and climate shocks continues to drive displacement and destroy livelihoods, leaving millions of people in urgent need of assistance.The humanitarians said these shocks' increased frequency and severity have left large population segments in

prolonged states of risk and vulnerability.Light to heavy Gu (April to June) seasonal rains have triggered localised flooding in several parts of the country since mid-April. The UN agency said the Somali government has formed a committee that includes federal ministers and regional officials to respond to the flooding crisis.

Somalia, a country where nearly two-thirds of the population depends on agriculture for their livelihoods, has experienced extreme climate shocks in the past, including prolonged dry seasons causing drought and heavy rains leading to flooding, media reported. Many communities, initially displaced by drought or conflict, have been displaced a second or third time by floods or renewed violence.

### **US Announces \$243.5 Bn Deals With Qatar**



Washington, (H.S): The US has announced deals totaling more than \$243.5 billion with Qatar, calling the series of agreements with the Gulf Arab country will generate an economic exchange worth at least \$1.2 trillion. The White House said in a press statement on Wednesday that Boeing and GE Aerospace secured a \$96 billion agreement to sell Qatar Airways up to 210 Boeing 787 Dreamliner and 777X aircraft powered by GE Aerospace

The White House noted it "Boeing's largest-ever widebody order and largestever 787 order". "The landmark deals celebrated today will drive innovation and prosperity for generations, bolster American manufacturing and technological leadership, and put America on the path to a new Golden Age," the White House said.Trump has focused much of his energy

on the trip in securing investment dollars, while praising Gulf states for seeking a deeper partnership with the US, Xinhua news agency reported. American multinational technologyfocused defence, intelligence, and infrastructure engineering firm Parson won 30 projects worth up to \$97 billion in Oatar, while energy services company McDermott secured seven active projects worth \$8.5 billion.

## South Korean Military Chief Inspects Naval Readiness, Calls For Deterrence Against North Korea

Seoul, (H.S): South Korea's top military officer inspected naval units and the submarine command on Thursday, urging firm naval readiness to deter any provocations by North Korea, the Joint Chiefs of Staff (JCS) said.JCS Chairman Adm. Kim Myung-soo made the call as he boarded the ROKS Jeongjo the Great destroyer and visited the submarine force command, the Jinhae Naval Base Command and the naval special warfare flotilla based in Jinhae, some 310 kilometres southeast of Seoul, according to the JCS.

Boarding the destroyer, Kim urged troops to familiarise themselves with the warship's combat system and equipment to preemptively deter and respond to the North's nuclear and missile threats. The 8,200-tonne Aegis destroyer, armed with an advanced missile interception platform, was delivered to the Navy in November last year and is expected to be deployed by



submarine force command, Kim instructed the command to maintain a firm readiness posture against the enemy's potential provocations, Yonhap news agency reported. As part of the visit, Kim also

conducted a command flight on the P-8A Poseidon maritime surveillance aircraft, the JCS said. The Navy completed its acquisition of six P-8As last year with an aim to deploy them this year. Dubbed the "submarine killer," the P-8A is capable of conducting an array of missions,

South Korea's spy agency earlier said it detected signs of North Korean troops deployed to Russia learning drone operations and tactics from Moscow.Last month, North Korea acknowledged for the first time that it had sent troops to Russia to fight against Ukrainian forces. # Indian Delegation At UN Presents Case For Declaring TRF A Terrorist Organisation

United Nations, (H.S): A delegation from India met with the top UN counter-terrorism officials on Wednesday for a wide-ranging discussion on cooperation in fighting terrorism in the aftermath of the Pahalgam terrorist attack by The Resistance Front.During their discussions with the Indian delegation, Under-Secretary-General Vladimir Voronkov of the UN Office of Counter-Terrorism (UNOCT) and Assistant Secretary-General Natalia Gherman of the Counter-Terrorism Committee Executive Directorate (CTED) focused on cooperation,

"particularly in support of implementing key Security Council counter-terrorism resolutions and the UN Global Counter-Terrorism Strategy," a readout of the meeting from UNOCT said. Voronkov and Gherman expressed their condolences for the victims of the terrorist attack last month in Pahalgam that killed 26 people. The delegation from India, which includes intelligence officials, was at the UN headquarters to present India's case for declaring The Resistance



Front (TRF), the perpetrator of the Pahalgam massacre, an international terrorist organisation and sanctioning it, according to sources at the UN. The TRF, an affiliate of the Pakistan-based Lashkar-e-Toiba (LeT), which has been listed as an international terrorist organisation by the UN.

The delegation was also meeting on Wednesday with the monitoring team of the Security Council panel known as the 1267 Committee that sanctions terrorist groups and those associated with them, the sources said. The team, the sources said, is presenting the committee with evidence of TRF carrying out Pahalgam attack and its other activities. The committee is named after Security Council Resolution

1267 that calls for action against the Islamic State or Da'esh, and Al-Qaida, and groups and people associated with them. The delegation was also meeting with diplomats from UN members to press for declaring TRF a terrorist organisation.

The readout from UNOCT of the meetings with the Indian delegation said that for India and the UN counter-terrorism agencies the "key areas of cooperation include UNOCT-led technical capacity-building initiatives supported by India such as cybersecurity, countering terrorist travel, supporting victims of terrorism, and countering the financing of terrorism". The delegation and the UN officials also "discussed efforts to counter the use of new

and emerging technologies for terrorist purposes," the readout said. These goals were set out in the 2022 Delhi Declaration adopted by the UN Security Council's Counter-Terrorism Committee chaired by India when it met in the Indian capital and paid special attention to emerging terrorist threats through use of emerging technologies.The declaration also called for the development of guiding principles to be prepared with CTED's support on threats posed by unmanned aircraft systems and the use of emerging financial technologies for terrorist

LeT was listed as an international terrorist organisation in 2005 and sanctioned. The sanctions list includes 27 names under which LeT operates, including Pasba-e-Kashmir, and variations of Jamaat-ud-Dawa. About a dozen individuals associated with it, including its leader Hafeez Mohammed Saeed, have also been sanctioned along with three organisations linked to it, including Jaish-e-Mohammed and Harkat-ul-Mujahideen. The sanctions include freezing of their assets and travel ban.

### Hezbollah Member Killed In Israeli Airstrike on Southern Lebanon

Beirut, (H.S): An Israeli drone strike killed a Hezbollah member in southern Lebanon on Wednesday, targetting a vehicle near Qaaqaait al-Jisr in the Wadi al-Hujayr area, Lebanese security and official sources said. Lebanon's state-run National News Agency (NNA) reported that "an enemy drone targeted a car at the entrance of Wadi al-Hujayr near Qaaqaait al-Jisr in the Nabatieh district this morning."

The Lebanese Ministry of Health's Public Health **Emergency Operations Center** confirmed one fatality in the strike. Civil Defence officials said the vehicle caught fire, and the body was transported to a hospital in Nabatieh.A Lebanese security source told Xinhua that the deceased was identified as Hussein Nehmeh Milhem

a Hezbollah member from Qaaqaait al-Jisr.Also on Wednesday, the Israeli military said it had carried out the strike, describing the target as a senior Hezbollah figure."Israeli Defense Forces aircraft carried out an attack in the area of Qaaqaait al-



Jisr in southern Lebanon, eliminating a member of the Hezbollah terrorist organization who held the position of commander of the Qabrikha compound," Israeli army spokesperson Avichay Adraee said on social media platform X.

In a separate incident, the NNA reported that an Israeli drone crashed due to a technical malfunction and exploded inside a home in the town of Shebaa, in the Hasbaya district. No casualties were reported, though material damage was sustained. The cross-border strikes come despite a ceasefire agreement reached on November

27, 2024, intended to halt more than a year of hostilities tied to the war in Gaza. The truce, mediated by the US and France, had largely held, though sporadic flare-ups have continued. Israel has said its strikes are intended to neutralize Hezbollah threats.

However, the Lebanese government and several Arab states have accused Israel of repeatedly violating the ceasefire agreement. Despite the truce's provision requiring a full Israeli withdrawal, Israeli forces continue to hold several strategically important positions in southern Lebanon.

### Gold Prices Drop Sharply By 2,375 Per 10 Grams; Silver Also Falls



New Delhi, (H.S): Gold buyers in India have a reason to cheer as prices of the yellow metal saw a significant drop Thursday. The price of 24-carat gold fell by Rs 2,375 per 10 grams, bringing it down to Rs 91,484 from Rs 93,859, according to the India Bullion and Jewellers Association (IBJA). The decline wasn't limited to just 24-carat gold. The price of 22-carat gold also dropped, now standing at Rs 83,799 per 10 grams, down from Rs 85,975.Similarly, 18-carat gold saw its price fall to Rs

68,613 from Rs 70,394 per 10 grams. This marks a sharp turnaround from just a few weeks ago, when on April 22, the price of 24-carat gold had surged close to the Rs 1 lakh mark. Silver too mirrored the downtrend that was being faced by the yellow metal. Prices for one kilogram of silver declined by Rs 2,297 to Rs 94,103 from Rs 96,400 per kg. The decline in precious metal prices extended to the futures market in the country as well.On the Multi Commodity Exchange (MCX), gold futures for June 5, fell 1 per cent to Rs 91,325, while silver futures for July 4, dropped by a similar margin to Rs 94,458 per kg.Market analysts attribute this fall in gold prices to easing tensions in global trade, particularly between the United States and China, which had earlier set the prices of the yellow and silver metals skyrocketing. As geopolitical uncertainty decreases, the appeal of safehaven assets like gold tends to

In international markets, gold has dropped to its lowest level in a month. On COMEX, gold was trading down by 1.1 per cent at \$3,141.35 per ounce. This is a steep drop from its recent peak of around \$3,500 per ounce seen on April 22. The sudden drop in gold and silver prices could spur demand in the domestic market, especially with the wedding season ongoing and Akshaya Tritiya just past - both traditionally strong periods for gold purchases.

# India's wholesale inflation rate hits one-year low of 0.85% in April; a quick look at kitchen prices

New Delhi, (H.S): India's wholesale inflation eased further to 0.85% in April on an annual basis as against a four-month low of 2.05% in March, the government data showed on Wednesday. "Positive rate of inflation in April, 2025 is primarily due to increase in prices of manufacture of food products, other manufacturing, chemicals and chemical products, manufacture of other transport equipment and manufacture of machinery and equipment etc," the press release

On a sequential basis, the wholesale price index-based inflation rate contracted 0.19%. The inflation rate for manufactured products, which accounts for over 60% of this inflation basket, stood at 2.62% in April. Primary articles inflation in April contracted to 1.44% from a growth of 0.76% in March. Inflation rate for fuel and power contracted 2.18% in April as against a growth of



0.20% in March. With inflation rate coming down, here's a look at India's kitchen:Inflation rate for vegetable prices contracted 18.26% in April as against -15.88% in the previous month.

Onion inflation in the month of April eased to 0.20% as compared to 26.65% in March, while potato inflation stood at (-)6.77 per cent from 27.54 per cent during the same period. Inflation rate for pulses fell to 5.57% as against (-)2.98% last month. Cereal prices in April stood at 3.81%. Meanwhile, India's retail inflation dropped to a 69-month low of 3.16% in April, down from 3.34% in March. The Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) in April said that the inflation has declined, supported by a favourable outlook on food and is expected to moderate in FY26.

# SEBI Warns Investors As Strata Gives Up SM REIT Licence

Mumbai, (H.S): The Securities and Exchange Board of India (Sebi) has issued a warning to investors regarding Strata, a commercial real estate platform founded by Sudarshan Lodha and Priyanka Rathore, after the company surrendered its licence as a small and medium real estate investment trust (SM REIT) due to a legal controversy."Pursuant to certain news reports and review of certain legal proceedings against the promoter of SM REIT.

SEBI engaged with Strata SM REIT, its independent director, compliance and other officers and the trustee. After the engagement and discussions, Strata SM REIT has surrendered its certificate of registration as an SM REIT and will not hold out or represent itself as a SEBIregulated intermediary," SEBI said in a statement."This communication is being issued in the interest of investors advising



them to exercise caution while dealing with the entity," SEBI said.Strata had registered as a Small and Medium Real Estate Investment Trust (SM REIT), a new framework introduced by Sebi for fractional ownership platforms to offer real estate investment products. However, following certain concerns and discussions with Sebi, Strata has surrendered its registration.Strata received Sebi approval in January

and had planned to launch six schemes during the current financial year. So far, it has not yet launched any SM REIT schemes nor migrated any preexisting fractional real estate entities to the SM REIT framework, the SEBI statement added. The legal dispute involving SM REIT arose with a Tamil Nadu-based real estate firm engaged in acquiring and developing land for industrial and

warehousing projects. According to the anticipatory bail order of the Madras High Court, a case was filed against Lodha for allegedly seeking information by impersonating as a SEBI official and creating a fake email ID under her name. However, Lodha's counsels denied the allegations and argued that as the complainant did not succeed in arbitration and other civil proceedings, it filed a 'false complaint' in order to 'arm-twist and give a criminal colour to the dispute."

In light of the ongoing matter, we have voluntarily surrendered our SM Reit licence without admitting or denying any wrongdoing, as a measure of abundant caution. Upon conclusion of the current litigation, we intend to apply for a fresh licence at a future date. This matter does not affect the existing investments with Everstrat," Strata said in a statement on Wednesday.

### **DPIIT Clears 187 Startups For Tax Relief Under Revised Section 80-IAC Framework**

New Delhi, (PIB): In a significant boost to India's startup ecosystem, the Department for Promotion of Industry and Internal Trade (DPIIT) has approved 187 startups for income tax exemption under the revamped Section 80-IAC of the Income Tax Act. Notably, the decision came during the 80th meeting of the Inter-Ministerial Board (IMB), held on 30th April 2025

According spokesperson of DPIIT, the tax benefit allows eligible startups a 100% income tax deduction on profits for any three consecutive years within a tenyear window from the date of incorporation. The scheme is designed to support emerging businesses in their formative years, encouraging innovation, job creation, and wealth

generation. Of the total approvals, 75 startups were cleared during the 79th IMB meeting and 112 during 80th such meeting. With this, over 3,700 startups have now been granted exemptions since the scheme's inception.In a key announcement during the Union Budget 2025-26, the government extended the eligibility window for startups to claim benefits under Section 80-IAC.

Startups incorporated before 1st April 2030 are now eligible to apply, giving more time and opportunity to new ventures to benefit from this financial relief. Pertinently, the revised evaluation framework introduced by DPIIT has made the application process more structured and transparent. Complete applications are now reviewed within 120 days,

ensuring faster decision-making and reducing procedural delays. Startups that were not approved in the latest round have been encouraged to reassess and refine their applications. The DPIIT has advised applicants to focus on demonstrating technological innovation, market potential, scalability, and a clear contribution to employment and economic growth.

The government's continued support underlines its commitment to fostering a robust, future-ready startup environment aligned with the vision of a self-reliant and innovation-led India.Further information on the tax exemption process, eligibility criteria, and application details is available on the official Startup India portal, the spokesperson added.

## New Delhi, (H.S): Talks over an India-United States trade deal are

ongoing, External Affairs Minister S Jaishankar said Thursday, labelling them 'complicated' and warning "nothing is decided till everything is...""Any trade deal has to be mutually beneficial; it has to work for both countries. That would be our expectation from any trade deal. Until that is done, any judgement will be premature, Mr Jaishankar told reporters

this evening at the opening of the Honduras' new embassy in New Delhi.A confirmed India-US trade deal would be a major event at any time, but more so since Donald Trump returned to power in Washington, D.C., bringing with him a slew of tariffs to counter duties other countries including India, whom he decried as 'a very big abuser' - impose on the import of US goods. Trump imposed 'reciprocal tariffs' on India - worth around 27 per cent - in April. These tariffs were later suspended, as they were for many other nations in a similar

situation, till July 9. However, the 10 per cent baseline tariff imposed on all countries on April 2 remains in effect, in addition to the 25 per cent taxes on steel, aluminium, and auto components.India reacted by lowering tariffs on some American goods, including motorcycles and bourbon whiskey, but the government later delinked the revision of duties and Trump's tariff threats. More pertinently, India also

said it would not retaliate to the US' tariffs, as others had, opting instead to reinforce the messaging to Washington, that 'Delhi wants to remain a trusted trading partner...'Since then the two countries have been working to expedite an agreement that Trump and Prime Minister Narendra Modi believe will push bilateral trade to over \$500 billion by 2030. The biggest step in that direction was in April; US Vice President JD Vance was in India and met the Prime Minister, after which he said terms of reference had been finalised. Days later



Trump indicated a deal - as part of which India may give the US 'forward most-favoured nation' status - was imminent."I think we'll have a deal with India... they want to make a deal," he declared. The deal, when it is struck, is expected to cover 24 categories of goods traded between India and the US, which include farm products like soybeans and corn, and military equipment.In return, Delhi has asked for favourable tariffs for labour-intensive sectors like textiles, toys, leather goods, furniture, gems and jewellery, and

automotive Meanwhile, talks over the deal are also playing out over India and Pakistan's 100-hour war last week - the fallout of the April 22 Pahalgam terror attack and Delhi's military response, Operation Sindoor.The conflict, which was heading towards a full-blown war, settled into a ceasefire for which Trump (repeatedly and falsely) claimed credit, including the use of trade to force both sides to stand down.New Delhi has announced a Free Trade Agreement with the United Kingdom.Under the deal, India

Britain has agreed to reduce tariffs too, which will leave around 99 per cent of Indian exports facing zero duties. One of the Indian industries that will benefit most is the textile industry that employs millions. In addition, Delhi has also signed a \$100 billion deal with the European Free Trade Association, which is a group of four European countries that are not part of the European Union. These nations are Iceland, Liechtenstein, Norway, and Switzerland. The EU and India are working on a free trade deal too.

Television star Rupali Ganguly has become the first Indian celebrity to publicly call for a boycott of Turkey, urging fellow celebrities, influencers, and travelers to cancel their bookings to the country. Taking to social media, the Anupamaa actress made a strong appeal, stating that this is the least that can be done as Indians in response to ongoing rising tensions between India and Pakistan. Rupali wrote on her

X handle, "Can we please cancel our bookings for Turkey. This is my request to all Indian Celebs/Influencers/ Travellers. This is the least we can do as Indians. #BoycottTurkey."Her post quickly sparked conversations online, with many applauding her for taking a bold stand. One user commented on Ganguly's post, "Absolutely! If we're serious about standing against terror, Indigo and all Indian airlines must

immediately suspend flights to Turkey. We can't let our hard-earned money fund those who support attacks on our soldiers. #BoycottTurkey — let's make it loud and clear." On May 9, Television actor Kushal Tandon's parents showed their support for the growing calls to boycott Turkey, following the country's stance in favor of Pakistan after India's Operation Sindoor. His mother, Sandhya Tandon, decided to cancel her planned trip to Turkey with friends, despite the financial loss involved due to nonrefundable bookings.The actor wrote on his Instagram, "My mom and her friends were planning to go next month, and now they have cancelled their whole trip, even with no refunds getting back from the hotels and airlines. Remember, do your bits."Turkey and Azerbaijan issued statements on May 8 in which both nations

expressed support for Pakistan and criticized India's airstrikes targeting terror camps. Turkey's Ministry of Foreign Affairs described the operation as a "provocative step," while Azerbaijan's Foreign Ministry extended sympathies to the families reportedly affected by the strikes. The statements drew sharp criticism across Indian social media platforms, intensifying public anger and fueling a growing call to boycott Turkey.

# Shafali Makes Comeback Into India's T20I Team For England Tour, Sayali Added To Both Squads

Mumbai, (HS): Big-hitting opener Shafali Verma has made a comeback into India's T20I team for the upcoming tour of England, starting on June 28. India will play five T20Is and three ODIs against England, who have a new captain and head coach in Nat Sciver-Brunt and Charlotte Edwards respectively. Though Shafali is only named for the T20I leg of the tour, pacer Sayali Satghare has made it to both squads, adding some heft to India's fast bowling stocks, depleted due to Renuka Singh Thakur and Titas Sadhu still nursing injuries. Shafali had been out of the national set-up after last year's T20 World Cup in the UAE, where India failed to enter the semi-finals. After strong showings in the domestic 20-over and 50-over matches, Shafali amassed 304 runs from nine innings with a strike rate of 152.76 for Delhi Capitals (DC) in WPL 2025, and finished at fourth place in the run-scorers' charts. That strong showing in



this year's WPL has propelled the Neetu David-led selection committee to bring back Shafali into the shortest format scheme of things. Apart from Shafali and Sayali, Sree Charani, Shuchi Upadhyay, and Kranti Goud are the newbies in the T20I team while Sneh Rana, Harleen Deol and Amanjot Kaur also find spots in the side after varying gaps. For the ODIs, barring

Sayali's addition, the selectors have chosen to retain the side which won the recent tri-series in Sri Lanka, which featured South Africa as the third team. The three ODIs against England provide ample chances for India to fine-tune their combinations ahead of this year's ODI World Cup, to be held on their home soil in September-October.
