

### CJI says 'everybody wants name in newspapers' against Waqf Act



New Delhi, (HS) : The Supreme Court on Friday refused to entertain a couple of fresh petitions challenging the constitutional validity of the Waqf (Amendment) Act, 2025, with Chief Justice of India B.R. Gavai remarking, "Everybody wants his name to be in the newspapers." A bench comprising CJI Gavai and Justice Augustine George Masih said it would take up the matter already listed for hearing on May 20. When one of the fresh petitions was mentioned, Solicitor General Tushar Mehta, appearing for the Centre, objected to it, saying there could not be an "endless stream" of pleas challenging the Act.

The counsel for the petitioner submitted that he had filed the petition on 8 April and had removed the defects pointed out by the apex court registry on 15 April, but the plea had not yet been listed for hearing. "Everybody wants his name to be in the newspapers," the CJI observed. When the lawyer requested that his plea be tagged along with the pending petitions, the bench said, "We will decide that matter." The bench promptly dismissed the petition. Another similar plea brought up later was also summarily rejected with the remark, "Dismissed." When the petitioner's counsel sought permission to intervene in the pending matters, CJI Gavai responded: "We already have too many intervenors." On 17 April, the apex court had decided to hear only five of the total number of petitions filed before it. The bench said it would consider arguments on 20 May to pass interim directions on three key issues: the power to denotify properties declared as waqf by courts, waqf-by-user or waqf by deed. The second issue raised by the petitioners pertains to the composition of state waqf boards and the Central Waqf Council. The petitioners contend that only Muslims should be members, excluding ex-officio positions. The third issue concerns a provision which states that a waqf property will not be

# **Operation Sindoor: Delegations to Launch India's Global Diplomatic Blitz From May 22**

New Delhi, (HS) : In a massive diplomatic push, the government led by Prime Minister Narendra Modi has decided to dispatch multi-party MP delegations to key world capitals to expose Pakistan's hand in the recent Pahalgam terror attack and to build global support against cross-border terrorism.

The 48-member cross-party delegation will present India's evidence against Pakistan and New Delhi's stance to foreign governments and institutions while travelling to various countries from May 22 to June 1. According to sources, the delegation will be led by Minister of Parliamentary and Minority Affairs Kiren Rijiju and will be divided into eight groups, consisting of six members each. It is expected to include several big names from the BJP-led government and the Opposition parties, including Congress MPs Shashi Tharoor, Manish Tewari, Member of Parliament from Punjab Vikramjit Singh Sahney,



Asaduddin Owaisi, etc. Sources say the move to send the delegation of MPs comes amid increasing attempts by Pakistan - and notably, remarks from US President Donald Trump - to internationalise the Kashmir issue, which India insists remains a bilateral matter. The initiative marks the first time the Modi government has deployed elected representatives from across the political spectrum as diplomatic envoys to counter Pakistan's propaganda on a global stage. The focus will be two-fold: To brief nations on the devastating Pahalgam attack in which 26 people were killed, and to clarify that India's 'Operation Sindoor' specifically targetted terror infrastructure - not civilians within Pakistan-occupied regions. "The aim is to break the narrative being spun by Pakistan and its sympathisers," said a

senior official involved in the planning. The Ministry of External Affairs, in collaboration with Intelligence and Defence agencies, is also preparing detailed dossiers and talking points. The Indian embassies in respective countries will amplify the MPs' efforts by coordinating meetings and providing strategic ground support. The MPs are expected to spotlight how Pakistan has, for decades, used terror as a state policy to destabilise India, citing specific Intelligence on terror camps, recruitment networks, and evidence of ISI involvement.

The delegations will also underscore how Pakistan's retaliatory actions after 'Operation Sindoor' only further confirm its active role in sheltering and promoting terror groups. The global diplomatic blitz is aimed not just at isolating Pakistan diplomatically, but also at strengthening India's position ahead of key international forums and bilateral engagements. ## Renovation Work of Ratna Bhandar to Resume from June 28

Bhubaneswar, (DMC): The renovation work of the Ratna Bhandar and sanctum sanctorum of the Puri Jagannath Temple is set to resume from June 28 to July 6. During this period, the focus will be on repairing the outer Ratna Bhandar. The renovation work of the inner Ratna Bhandar is almost complete, with only the flooring work remaining. The temple administration has decided to complete the remaining work, including laying stainless steel beams in the outer Ratna Bhandar and replacing damaged stones. Earlier, 9 stainless steel beams were installed in the inner Ratna Bhandar, and a total of 277 stones were replaced, with 148 of them being used in the inner Ratna Bhandar. The decision to resume work was taken in a meeting held at the office of Shree Jagannath Temple Administration, chaired by the Chief Administrator of SJTA, Arabinda Padhee. The meeting was attended by technical core committee member N.C. Paul, Superintendent Archaeologist, and other officials. ## CM Launches Dubuna Mine on OMC's 70th Anniversary

Bhubaneswar, (DMC) : Odisha, a state rich in mineral resources, holds a leading position in India, with over 41.9% of the country's total mineral reserves. For over 60 years, the Odisha Mining Corporation (OMC) has been responsibly exploring and extracting mineral resources from nature's reserves. ### Lightning Claims 11 Lives Across State

Bhubaneswar, (DMC) : Kalabaisakhi storms wreaked havoc across Odisha on Friday, leaving 11 people dead in different districts including Koraput, Ganjam, Jajpur, Dhenkanal, Balasore, and Mayurbhanj. Among the deceased were five women and three minors. The storm's destructive impact led many to refer to the day as "Black Friday."

According to reports, in Koraput district, four people lost their lives in separate lightning incidents. Das Jani, a 32-year-old resident of Khalpadi village under Charangul panchayat in

Semiliguda block, was killed by lightning while fishing near Lenziguda village. In another tragic event in Paradiguda village under Odiapentha gram panchavat of Laxmipur block. Budri Mandinga (60), her granddaughter Kasa Mandinga (16), and Ambika Kashi (35) were struck by lightning while taking shelter in a hut near their paddy field. All three died on the spot and five others were injured. In Ganjam district, Rita Goud (30) from Kebiri Brahmapur under Belaguntha police station was struck by lightning while **Continued P-4**

Lambasting Pakistan for nurturing terror factories on its soil, the Defence Minister said that the rogue nation was forced to realise the power of BrahMos missile

habitual offender or a criminal with past antecedents is kept under watch, we have put Pakistan under probation. The ceasefire is not a cessation of action. If Pakistan doesn't mend its ways and engages in misadventures again, our forces will teach it a firm lesson. Again!" he said. Minister Singh's direct warning to Pakistan came while he visited the airbase along with Air Chief Marshal AP Singh and congratulated the forces for the successful execution of Operation Sindoor. "There is an old saying in our country, 'Din mein taare dekhna'. Made in India BrahMos missile showed 'raat ke andhere mein din ka ujala' to Pakistan...," he roared, while



forces shouted in support. "Just 23 minutes were enough for the Indian Air Force to crush terrorism being nurtured in Pakistan. What you did during Operation Sindoor made us all proud," the Defence Minister told the warriors. Notably, the IMF had released the second tranche of \$1.023 billion to Pakistan, which has been largely relying on the bailout package for survival.

Data released over the past couple of days shows that the inflation rate, both at the wholesale and retail consumer levels, has moderated in April. The wholesale inflation rate - measured by the Wholesale Price Index grew by just 0.9 per cent last month, which is a 14-month low. But wholesale price inflation hasn't really been the problematic bit for India in recent years. Over the past 24 months, it has either been negative (which means wholesale prices were falling) or fairly low. The more significant news is on the retail inflation front, which is the rate that policymakers target and consumers worry about. Retail inflation - measured by the Consumer Price Index - came in at 3.2 per cent in April, the lowest level in six years.

To be sure, retail inflation has been moderating lately it was 3.3 per cent in March. Yet this is the variable that has tested the Reserve Bank of India's "comfort zone" (of 2 per cent to 6 per cent) in the past few years. Since the end of 2019, there have been several months and even quarters when retail inflation was above 6 per cent and even above 7 per cent - thanks to repeated supply shocks either due to unseasonal weather at home (like rain), the Covid pandemic or disruptions due to the Russia-Ukraine war. The last financial year's retail inflation was pegged at 4.6 per cent - much closer to the RBI's target of 4 per cent, and the lowest it has been since 2018-19. Some estimates suggest that India's inflation is likely to moderate further in the current financial year; analysts at ICICI Securities, for instance, peg FY26 inflation at 3.5 per cent - a sharp fall from the 6 per cent level that sustained right through FY21to FY23. This benign outlook is primarily based on assumptions of a moderation in crude oil prices, which, in turn, brings down costs across sectors, and an "above normal" monsoon, which boosts farm output. Given the stress on prices in the recent past, the sustained moderation in the inflation rate since the start of the 2025 calendar year is not just a welcome relief for consumers but also opens up policy space. On the fiscal side, the government has already hiked excise duties on petrol and diesel by Rs 2 per litre in April to shore up an additional Rs 300 billion in revenues as crude oil prices moderated. On the monetary policy front, these readings suggest that consumers can expect the RBI to cut another 50 basis points over the next two policy reviews slated for June and August.

# Inflation Data Decreasing Greenery, Increasing Hazards



Recently, a forest harvesting spread over about four hundred acres in the Kancha Gachibowli area of Telangana drew the attention of the entire country to its attention and attention. The Supreme Court took suo moto cognizance of this sensitive issue. A bench of Justices BR Gavin and Justice Agustin George Christ made a sharp note in the matter asking the state government a number of stern questions and banned any kind of activity in the area until the next hearing. The court clearly asked what emergency was finally created due to which the forest had to start in such a hurry? Was the Environmental Impact Assessment (EIA) certificate taken for this project and whether the deforestation was duly taken permission from the Forest Department ? The case came to light when the registrar of the Telangana High Court sent some pictures related to this harvesting to the Supreme Court, which clearly saw the cutting and ground levelling activities of trees through heavy machines. Those photographs also clarified that this work was being carried out at night. The location is the Hyderabad University Pass, where the Telangana government

was planning a construction plan of a grand iti park, but the same area is also the natural habitat of many types of wildlife, including peacocks, deer and other protected species. A heartbroken video on social media came into the spotlight, with dark bulldozers moving and hearing fearful sounds of the morons around. It shocked the conscience of the common masses. The video was getting clear that not only the trees, but the entire ecosystem is being brutally murdered. This forest was not merely a group of green trees but a shelter of thousands of organisms. Even in another case over the wildest felling of trees illegally by a temple management, the Supreme Court made strict remarks in the past, saying that no one allows cutting of trees like this. It is not only wrong from the environmental point of view but also unacceptable in religious terms. Even in that case, the 16194 Supreme Court. Had asked why there is so much compulsion to cut trees and whether the state has obtained environmental impact assessment certificate? Just a few days ago, the apex court took a strong stand for each tree

carrying a fine of Rs. one lakh for each tree, even over hundreds of trees illegally cut around the Taj Mahal in Agra. The court said that cutting large numbers of trees is worse than killing a human being, so no mercy should be shown on those who harm the environment. The apex court had admitted to the rampage of the Central Empowered Committee (CEC) in that case, saying that 454 trees were cut in Dalmia Farm, Mathura-Vrindavan, which is a serious environmental crime. The committee had recommended a fine of Rs. one lakh per tree (total



observations of the Supreme Court of the country on the harvesting of trees illegally at large put forth the protection and environmental responsibilities of trees across the country. The Supreme Court initiative has expected that such destructive efforts will be held strongly and will curb the tendency to sacrifice nature in the name of development. The court has made a clear message from these decisions of itself that the felling of trees should not be taken lightly. These court decisions are also messages for areas in the country where trees are being indiscriminately harvested. Pollution situation in Delhi has become critical due to the felling of trees.

According to environmental experts, we must plant so many trees around us so that at least for our family, we can fulfill oxygen ourselves. A person needs a considerable amount of oxygen throughout the day, that's why environmentalists say plantation tax is necessary to produce oxygen for ourselves otherwise just as we drink water by buying a water bottle today, our coming generation will be constrained to buy pure air bottles in the coming time. If there will be no oxygen in the atmosphere, life will end on the earth, so it is a great demand for time to emphasize more and more plantation." According to a rapt, a healthy tree leaves so much oxygen every day, giving sixseven people an oxygen, but in the absence of enough trees, the same tree now has to give oxygen to about 20 people. In fact, the amount of oxygen used to be in the atmosphere earlier has come down to ten percent in the absence of trees. As a result, the lungs have started causing infection problems with asthma and heart disease due to not getting enough oxygen. Large shady trees like neem, banyan and peepal, who are 50 years old or older, get up to 140 kg of oxygen daily. According to environmental experts, trees of about two hundred years old peepal, neem, banyan, etc. secrete enough oxygen daily. In such a situation, it is not hard to

why such shady trees have been the ancient Indian tradition of planting in their surroundings. Neem, Banyan and Tulsi, etc., leave oxygen for more than 20 hours a day, while Peepal then secretes oxygen for more than 22 hours a day. Bamboo trees produce 30% more oxygen than any other tree. Depending on the price of oxygen found from a healthy tree, the tree costs several lakh rupees annually. Lack of clean air In people are trapped in the trap of diseases, their fertility is bearing. Functionality is also affecting cancer, heart disease, asthma, bronchitis, lung infection, pneumonia and number of paralysis patients are increasing rapidly. Many of us use the words 'morals' and 'ethics' interchangeably. But the two are not the same, and when we confuse one with the other we may create a lot of problems. I learnt the distinction between morals and ethics from an unlikely source: a popular television drama serial. One of the characters – a professor of theology - explained the difference succinctly. Morals, he said, are the codes of behaviour that we can, and, indeed, must, apply to ourselves. Our codes of behaviour are conditioned by many things: what is appropriate, or inappropriate, in the faith system we subscribe to, and in our social and familial environment. Morals are what Sartre might call the 'facticity' of our individual situation: who and what i deem myself to be in terms of my religious beliefs, or lack of them, my social obligations, and the choices i make in my personal life.

World Hypertension Day is observed annually on May 17 to raise awareness of hypertension and encourage hypertension prevention, detection, and control. Hypertension affects more than one billion people around the globe and over 30% of the adult population in the world. It is the primary risk factor for cardiovascular diseases, particularly coronary artery disease and stroke. Besides, hypertension is also a risk factor for chronic kidney disease, heart failure, arrhythmia, and dementia. That's why sharing information about this condition is essential.

World Hypertension Day was initiated by the World Hypertension League (W.H.L.). W.H.L. is a non-profit international organization founded on January 4, 1984, dedicated to preventing and controlling hypertension at the population level. World Hypertension Day was first launched on May 14, 2005. Since 2006, W.H.L. has been observing May 17 of every year as World Hypertension Day. The day is aimed at increasing awareness of hypertension due to the lack of appropriate knowledge among patients with hypertension. Hypertension, also known as high blood pressure, is a medical condition when the blood pressure in the blood vessels is continuously elevated. The more blood your heart pumps and the narrower your blood vessels are, the higher your blood pressure becomes. High blood pressure typically does not cause symptoms, but long-term high blood pressure can result in coronary artery disease, stroke, chronic kidney disease, heart failure, arrhythmia, and dementia. Since there are usually no symptoms, you need to have a screening to identify your blood pressure.

Hypertension has two types: primary (essential) hypertension and secondary hypertension. Primary hypertension does not have an identifiable cause, while secondary hypertension does, including obstructive sleep apnea, kidney disease, and certain medications such as birth control pills or some prescription drugs. Some methods for the primary prevention of hypertension include: maintaining body weight for adults; engaging in regular aerobic physical activity, such as brisk walking; reducing dietary sodium intake; consuming a diet rich in fruit and vegetables; and limiting alcohol consumption.

Ethics are the codes of conduct and behaviour that we apply to all societies, in general, including those which are totally foreign and unfamiliar to us. In many cases, the two codes, of morals and ethics, coincide. For instance, to take the life of another human being is deemed to be wrong, both morally and ethically.

form of violence, your personal code of moral behaviour could be at variance with an objective code of ethics. Much of the confrontation taking place in the world today is caused when individuals and societies seek to project their moral codes and make them the ethical obligations of others. My moral code, based on my religious beliefs, may prohibit me from eating certain foods. That's fine. But do i have the right to impose my code of dietary morality on others whose social environment and religious convictions might be totally different from mine? Much the same holds true

for other moral codes, such as appropriate, or inappropriate, form of dress in public, gender relations, rights of inheritance, among other social customs. What is morally right,

according to one individual or community, might not be so for another. But if i try to make my moral code your ethical obligation i am transgressing against you. And that's just one of the crossroads we face when it comes to the often different directions our morals and ethics might have to choose between. The rightwing academic Alan Bloom decried what he called 'moral relativism' which he believed had undermined the Protestant values of American civilisation. By asserting the moral hegemony of American values over all others, couldn't Bloom be accused of 'ethical imperialism'? In the interplay between morals and ethics there are no right answers, only right questions.



New Delhi, (HS) : The Supreme Court has directed the West Bengal government to pay 25% DA (Dearness Allowance) to State government employees said reliable reports on Friday. According to reports, a bench of Justices Sanjay Karol and Sandeep Mehta issued an interim order directing the West Bengal government to make the payment within three months and posted the matter to be heard next in August. Earlier today, teachers protest outside Bikash Bhawan against the CM Mamata Banerjee-led State Government over 26,000 teachers losing their jobs in connection with the SSC recruitment case, following a Supreme Court judgment which held that the whole appointment process was tainted. Last night, several teachers were injured as a clash erupted between protesting SSC teachers and police personnel in front of Bikash Bhawan, after the Police resorted to lathi charge to disperse the massive crowd.

### J-K: Budgam Police arrests 3 terrorists associates affiliated with Lashkar-e-Taiba

Budgam, (HS): In the ongoing efforts to dismantle terror networks, Budgam Police in Jammu and Kashmir have arrested three terrorist associates linked with the proscribed terrorist outfit Lashkar-e-Taiba (LeT), said an official press release from the Kashmir Police. The arrested individuals have been identified as Muzamil Ahmad, Ishfaq Pandit, both residents of Aglar Pattan and Muneer Ahmad, a resident of Meeripora Beerwah. The arrests were made in the Kawoosa Narbal area of Magam town of Budgam, the release stated. On their apprehension, arms and ammunition, including one pistol and one hand grenade, were recovered from their possession. In this regard, a case has been registered at Police Station Magam under relevant sections of the Unlawful Activities (Prevention) Act (UAPA), and further investigation has been taken up. During the investigation, it surfaced that the arrested individuals were in close contact with active LeT terrorist Aabid Qayoom Lone, son of Abdul Qayoom Lone, and a resident of Wussan Pattan, who had exfiltrated to Pakistan in 2020 and subsequently joined the LeT outfit. The said terrorist/ handler is currently operating from Pakistan and is involved in radicalising local youth, motivating them to join terrorist ranks, and directing them to carry out terror-related activities in the Narbal-Magam area of District Budgam. The arrested associates were acting on his directions and were tasked with executing terror activities in the area, as well as attempting to radicalise and lure other youth into terrorism. Further investigation is underway. This comes after heightened India-Pakistan tensions when India launched Operation Sindoor on May 7 in response to the April 22 Pahalgam terror attack in which 26 people were killed.

# **India's Defence Renaissance Under PM Modi**

Sabvasachi K. New Delhi, (HS): Pakistan launched a large-scale attack along India's western border, deploying 300 to 400 drones and missile-like systems across 36 locations from Ladakh to Kutch. The offensive, backed by artillery shelling and armed drones across the Line of Control, was intended to overwhelm India's air defence stems. While some Indian ca were reported, the response was swift, calculated, and importantly, powered by indigenous defence capabilities. India retaliated with precision using homegrown missile systems, artificial intelligenceenabled surveillance drones, and smart munitions. Enemy radar systems were destroyed, and significant losses were inflicted without breaching international borders. This strategic and restrained counterstrike highlighted a new chapter in India's defence narrative-marked by growing self-reliance and technological sophistication. At the heart of this transformation is the vision of Prime Minister Narendra Modi. For a country to be truly sovereign, it must be capable of defending itself with its own resources. For decades, India depended heavily on



considerable diplomatic pressure from the United States, India went ahead with the purchase of the Russian S-400 air defence system in a deal worth five billion dollars. Similarly, the acquisition of 36 Rafale fighter jets from France has bolstered India's air superiority, particularly with the inclusion of SCALP long-range missiles that allow deep precision strikes without violating enemy airspace. The results of these efforts are visible in the numbers. Currently, 60 percent of India's defence needs are met through domestic production, a remarkable jump from previous decades. Major private companies like Tata Group, Adani Defence, and Larsen & Toubro are now actively contributing to the manufacturing of advanced systems such as radars, artillery, and electronic warfare tools. According to the Stockholm International Peace Research Institute, India's arms imports grew by just 4.7 percent between 2014-2018 and 2019-2023, despite increasing defence requirements. A Nomura report estimates a massive opportunity of 138 billion dollars in defence procurement from FY24 to FY32. By FY30, defence

capital expenditure is projected to rise to 37 percent of the total budget.

Investor sentiment reflects this momentum. Shares of Hindustan Aeronautics Limited and Bharat Electronics Limited have seen dramatic growth-HAL now trades at Rs 4,500 and BEL at Rs 316-reflecting a 1,400 percent increase in value over five years. Defence exports have reached a record Rs 21,083 crore in FY 2023-24, marking a thirtyfold increase in a decade and reaching more than 100 countries. International observers have taken note. Austrian air warfare expert Tom Cooper called India's retaliation during Operation Sindoor a clear-cut victory, attributing it to India's superior firepower and layered air defence systems. He noted that Pakistan's call for a ceasefire stemmed directly from being outmatched. Under Prime Minister Modi, India's defence production has surged to Rs 1.27 lakh crore in 2023-24, a 174 percent increase since 2014-15. ### **Truck Rolls Back, Misses** Woman on Scooter by Inches



Kerala, (HS) : A Kerala woman had a near-death experience after a truck lost control on an incline and rolled backwards into her scooter on the road to Kozhikode Medical College. The incident reportedly occurred around 7:30 am on the uphill stretch between Peringalam town and the medical college, near CWRDM. The woman, identified as Ashwathi, a resident of Ozhayadi, was riding her red scooter behind a truck carrying hollow bricks when the mishap occurred. According to CCTV footage reviewed, the truck, which had halted on the slope, suddenly began sliding backwards. The woman, riding just behind it, tried to reverse but could not do so in time. The truck hit her scooter, throwing her onto the road. The vehicle then crushed the scooter and continued rolling until it came to a halt after hitting a roadside tree. She had a miraculous escape. The truck missed her by inches as she fell to the side. Locals, alarmed by the loud crash, rushed to the scene and quickly took her to a nearby hospital. She reportedly suffered minor injuries and is out of danger. Police are investigating the incident, and a case has been registered. Preliminary reports suggest a possible mechanical failure in the truck's braking system.

## **Covid Cases Spike in Hong Kong, Singapore as New Wave Spreads**

New Delhi, (HS): Health authorities in densely-populated Hong Kong and Singapore have warned that Covid-19 cases are spiking, as a resurgent wave spreads through Asia. The virus' activity in Hong Kong is now "quite high," Albert Au, head of the Communicable Disease Branch of the city's Center for Health Protection, told local media this week. The percentage of respiratory samples testing Covidpositive in Hong Kong recently reached its highest in a year. Severe cases including deaths - also reached its highest level in about a year to 31 in the week through May 3, the center's data shows. While the resurgence is yet to match the infection peaks seen in the past two years, rising viral load found in sewage water and Covid-related medical consultations and hospitalizations suggest the virus is actively spreading in the city of over 7 million people. Rival financial hub Singapore is also on Covid alert. The city-state's health ministry released its first update on infection numbers in



almost a year this month, as the estimated number of cases jumped 28% to 14,200 in the week through May 3 from the previous seven days while daily hospitalization rose around 30%. Singapore now only provides case updates when there is a noticeable spike.

While the increase in cases could be due to factors including waning population immunity, there is no indication that the circulating variants

are more transmissible - or cause more severe cases - than during the pandemic, Singapore's health ministry said. The surge in two of Asia's biggest cities comes as Covid has risen across the region in the past few months, with waves of the now-endemic disease swelling periodically. Health authorities have called on people to keep their vaccinations updated, reminding highrisk individuals to get booster shots.

Unlike other respiratory pathogens that tend to be more active during colder months, Covid's comeback just as much of the northern hemisphere enters into summer shows the virus can still sicken a large swath of the population even when the weather is hot. Hong Kong singer Eason Chan also came down with Covid and had to cancel his concerts in Kaohsiung, Taiwan originally scheduled for later this week, the concert's official account on Chinese social media Weibo said Thursday.

China is on track to see a Covid wave reach last year's summer peak, according to data from the Chinese Center for Disease Control and Prevention. The Covid test positivity rate more than doubled among patients seeking a diagnosis at hospitals across the mainland in the five weeks through May 4. Meanwhile, Thailand's Department of Disease Control has reported there have been two cluster outbreaks this year, with cases rising after April's annual Songkran festival, which brings together crowds.

## Pakistan Deputy PM Draws Flak After Citing Fake Image To Praise PAF In Parliament Death toll from Lassa fever rises to 138 in Nigeria

Islamabad, (H.S): Pakistan's Deputy Prime Minister and Foreign Minister Ishaq Dar has come under widespread criticism for citing a fake newspaper image praising Pakistan, circulated over social media platforms, falsely claiming it to be from the UKbased paper The Daily Telegraph.

Ishar Dar referred to the fake image describing Pakistan Airforce (PAF) as the 'undisputed king of the skies', during his speech in the Parliament session on Thursday. Dar, while praising the PAF for its success, stated "The Telegraph newspaper writes, 'Pakistan Airforce is the undisputed king of the skies.' Alhamdulillah," prompting thumping praise from the parliamentarians. However, many were quick to realise that Dar had cited and quoted a fake image, which had nothing to do with The Daily Telegraph.The



fake picture, which is AIgenerated, was shared across many social media platforms, and many Pakistani journalists had shared it, praising what they though was part of the global recognition of the country's PAF in its defence and counter-attack capabilities. However, it was revealed later that the picture was fake. It is pertinent to note that since the India-Pakistan tensions escalated and

both sides carried out major attacks against each other, social media was flooded with many images, news and claims, all of which later turned out to be fake. Though Dar has been called out for his mistake during his speech in Parliament, no clarification has been issued by him yet. It would not be wrong to maintain that during the recent conflict between Pakistan and India. Islamabad has relied on

social media posts as 'proof' to back many of its claims, including that of shooting down at least 5 Indian fighter jets, which now, have increased to six.Pakistan's Defence Minister Khawaja Asif was called out by many, after he relied on unverified social media posts to claim that at least five Indian jets were shot down.

When asked by a CNN news anchor about the proof of the claims, Asif said "the proof is all over social media". Pakistan's Prime Minister Shehbaz Sharif, during his speech at PAF airbase Kamra on Thursday, claimed that at least six Indian fighter jets were shot down by Pakistan. This includes 3 Rafales, 1 SU-30MKI, 1 Mirage 2000, and 1 MIF-29. However, this also remains a claim that needs proof to back it, something that is yet to be brought to public knowledge. Abuja, (H,S): The death toll from the Lassa fever outbreak in Nigeria, Africa's most populous country, has risen to 138 since the beginning of this year, public health authorities said.In a statement on its website, the Nigeria Centre for Disease Control and Prevention (NCDC) said that 717 confirmed cases have been recorded so far.

At least 18 out of the 36 states in the country have been affected by the viral haemorrhagic disease so far this year, with the southern states of Ondo and the northern states of Bauchi and Taraba the worst-hit, accounting for more than 71 per cent of the total confirmed cases, the NCDC said. This development, according to the public health agency, has "signalled persistent hotspots despite nationwide interventions". fatality rate has risen to 19.2 per cent, the NCDC said, noting that overall, this rise in the casualties figure remained alarming. The public health agency said young adults between the ages of 21 and 30 are the most affected, with the median age of infection reported at 30 years. It noted that more males than females had been affected, with a male-to-female ratio of 1:0.8.

The NCDC identified poor health-seeking behaviour, high treatment costs in some areas, and limited awareness in high-burden communities as major challenges. It has so far activated a multisectoral incident management system to coordinate nationwide response efforts.In 2024, Nigeria reported 214 deaths from Lassa fever, according to the NCDC, Xinhua news agency reported. According to the World Health Organisation, Lassa fever is an acute viral haemorrhagic illness caused by Lassa virus, a member of the arenavirus family of viruses. Humans usually become infected with the Lassa virus through exposure to food or household items contaminated with the urine or faeces of infected Mastomys rats. The disease is endemic in the rodent population in parts of West Africa.

Person-to-person infections and laboratory transmission can also occur, particularly in healthcare settings, in the absence of adequate infection prevention and control measures.Diagnosis and prompt treatment are essential. The overall casefatality rate is 1 per cent. Among patients who are hospitalised with severe clinical presentation of Lassa fever, case-fatality is estimated at around 15 per cent.

## Man Charged With Arson After Fire At British PM's Home New York State Senate Adopts Resolution Celebrating 75th Anniversary of Indian Constitution



London, (H.S): A 21-year-old man has been charged with arson with intent to cause a fire at British Prime Minister Keir Starmer's home, the Metropolitan Police said. According to the police statement released on Thursday, Roman Lavrynovych, a Ukrainian national, faces three counts of arson with intent to endanger life. The charges, authorised by the Crown Prosecution Service, relate to three incidents: a vehicle fire in NW5 on May 8, a fire at the entrance of a property in N7 on

May 11, and a fire at a residential address in NW5 in the early hours of May 12, Xinhua news agency reported.The suspect was arrested early Tuesday in connection with a series of suspected arson attacks. including the fire at a property owned by Starmer.The investigation has been led by the Met's Counter Terrorism Command due to its links to a high-profile figure.In the early hours of May 12, emergency services responded to a fire at the Kentish Town home where Starmer lived before becoming

Prime Minister and moving into 10 Downing Street.Police were alerted by the London Fire Brigade (LFB) to reports of a fire at the residential address at 1:35 British Standard Time.Damage was caused to the property's entrance but nobody was hurt.A car that PM Starmer had sold to a neighbour last year was set alight four days earlier on May 8 on the same street.

One person was helped to safety by firefighters wearing

breathing apparatus, LFB said. Bethan David, head of the Crown Prosecution Service counterterrorism division, said: "The Crown Prosecution Service reminds all concerned that criminal proceedings against this defendant are now active and that he has the right to a fair trial.""It is extremely important that there should be no reporting, commentary or sharing of information online which could in any way prejudice these proceedings." **United Nations, (H.S):** India remains the fastest-growing large economy and is expected to record a 6.3 per cent growth this fiscal year, while the global economy faces a "precarious moment," according to the UN."

India remains one of the fastest growing large economies driven by strong private consumption and public investment, even as growth projections have been lowered to 6.3 per cent in 2025" from the 6.6 per cent made in January, Ingo Pitterle, a senior economic affairs officer, said on Thursday. The UN's mid-year update of the World Economic Situation and Prospects (WESP) report said India's economy is projected to grow a tad faster next year at 6.4 per cent, even though it is also 0.3 per cent lower than the January projection."The world economy is at a precarious moment," the report warned." Heightened trade tensions, along



Inflation is projected to slow from 4.9 per cent in 2024 to 4.3 per cent in 2025, staying within the central bank's target range," it said."Unemployment remains largely stable amid steady economic conditions," it said, but added a note of caution that "persistent gender disparities in employment underscore the need

Ankara/Istanbul, (H.S): Ukrainian President Volodymyr Zelensky has said that a Ukrainian delegation would attend the upcoming peace talks in Istanbul with a commitment to ending the conflict with Russia, though he would not personally show up at the negotiating table.At the Ukrainian embassy in Ankara



Istanbul, the diplomat said that Russia views the fresh negotiations with Ukraine in Istanbul as a "continuation" of the peace process disrupted in 2022, claiming that his team's objective is to secure a lasting peace by "addressing the underlying causes of the conflict".

Also on Thursday, the two Presidents jointly unveiled an artificial intelligence campus in Abu Dhabi, the largest AI campus outside the US. Gaza, (H.S): At least 80 Palestinians were killed and dozens of others wounded in Israeli airstrikes across Gaza, said Palestinian medical sources. The Nasser Hospital in Khan Younis reported that 54 people, including women and children, were killed in strikes on the southern city, according to a press statement on Thursday.

According to Gaza-based health authorities, the Gaza European Hospital, the only hospital providing medical follow-up care to cancer patients in the enclave, was out of service due to recent Israeli attacks, Xinhua news agency reported.

The Israeli attacks "caused significant damage to infrastructure, such as sewage lines, damage to internal departments, and destruction of roads leading to the hospital," the authorities said in a press statement. Meanwhile, medical sources told Xinhua news agency that 26 others were

killed in Israeli airstrikes on Gaza City and other areas in northern Gaza. The airstrikes came after Israeli Prime Minister Benjamin Netanyahu warned on Tuesday that the Israeli military would enter Gaza "with full force" in the coming days to press forward with efforts to defeat Hamas.

Israel resumed large-scale military operations in Gaza on March 18, ending a two-month ceasefire.Since then, 2,876 Palestinians have been killed and more than 7,800 injured, according to health officials in Gaza.

The total Palestinian death toll since the war erupted on October 7, 2023, has reached 53,010, the officials said on Thursday.Israel is using a policy of "reducing space and emptying populated areas to pressure citizens," Mahmoud Basal, spokesperson for the Civil Defence in Gaza, told Xinhua on Thursday. He also claimed that thousands of people spent the night in the streets amid threats of strikes on schools and shelters housing the displaced, adding that Israeli forces were obstructing emergency teams from reaching victims and systematically destroying Civil Defence infrastructure.

Since October 2023, the Israeli Army has pursued a brutal offensive on the Gaza Strip, killing more than 53,000 Palestinians so far, most of them women and children. A USbacked humanitarian organisation will start work in Gaza by the end of May under an aid distribution plan, but has asked Israel to let the United Nations and others resume deliveries to Palestinians now until it is set up.No humanitarian assistance has been delivered to Gaza since March 2, and a global hunger monitor has warned that half a million people face starvation in Gaza.

### QCOs have earned industry support because they have helped Indian manufacturers access global markets: Shri Piyush Goyal

New Delhi, (PIB): Every QCO introduced so far has eventually earned the support of the sectors because they have not only improved product quality but also helped Indian manufacturers access larger markets. The Government is committed to building a system that ensures consumer safety and industry competitiveness. This was stated by Shri Piyush Goyal, while emphasizing on the importance of implementation of QCO for electrical appliances at the Stakeholder Meet convened by DPIIT in New Delhi yesterday.

The meet discussed the issues being faced by the Industry in the implementation of Horizontal QCO on "Safety of household, commercial and Similar Electrical Appliances" notified by DPIIT on 20th September, 2024. The industry presented their concerns and highlighted issues faced by them in the implementation of the Horizontal QCO on various electrical appliances on IS 302

(Part1): 2008 as revised vide IS 302 (Part1): 2024/ /IEC 60335-2020. Industry overwhelmingly supported the intent behind QCOs to ensure only high-quality products to be manufactured and sold in India. However, they requested for notifying QCOs on finished appliances included in the goods first followed by QCOs on components and raw materials. illustrative list; lack of considering the complexity of certification by domestic global supply chains. They also manufacturers as well as foreign recommended mapping domestic manufacturers: insufficient time manufacturing capacities and available for getting the BIS available technologies to align certification for domestic as well

compliance timelines. A phased rollout was also proposed. Major concerns raised by the Industry inter alia included the followingambiguity as regards to coverage of DC Supplied Appliances and Battery-Operated appliances; non-availability of product manuals and test labs all 85

as foreign manufacturers; addressing the issue of legacy stock and non-acceptance of non-BIS marked products on ecommerce platform. Hon'ble Commerce and Industry Minister acknowledged concerns raised by the industry and agreed to consider the request to extend the implementation timeline of the QCO, as well as the issue of legacy stock.

He requested industry to come up with the proposal for setting up more testing facilities with modern technology in public funded labs, labs in public sector enterprises and labs in State Government institution etc. so that that robust and accessible testing infrastructure will be made available for the industry pan India. Shri Jitin Prasada, Hon'ble Minister of State for Commerce and Industry mentioned that "the Ministry remains firmly committed to a consultative and collaborative approach in

implementing QCOs. Together, let us ensure that 'Made in India' globally stands for safety, quality, and trust". DPIIT is closely working with BIS to streamline the testing and certification ecosystem, making it more accessible, efficient, and affordable, particularly for MSMEs.

### India's Apparel Exports Clock Strong Growth In April Driven By US Market

New Delhi, (H.S): India's Textile & Apparel (T&A) exports have continued their upward trajectory, recording a growth of 7.45 per cent in April 2025 compared to the same month of the previous year. This positive trend was primarily driven by the strong performance of the apparel segment, which registered a robust 14.43 per cent growth year-on-year, an analysis of the data released by the Ministry of Commerce showed.Confederation of Indian Textile Industry (CITI) Chairman Rakesh Mehra said: "The current growth of 14.43 per cent in apparel exports seems to be mainly driven by increased shipments to the United States, following the announcement of reciprocal tariff measures by the U.S. administration."Mehra also welcomed the signing of the India-UK Free Trade Agreement (FTA), which is expected to provide further impetus to India's T&A exports by improving market access of Indian products in the UK market and expressed his optimism for increased T&A exports in the months to come.

During April 2025, Indian textile exports were about 2.61 per cent higher as compared to the same month last year, while apparel exports registered a growth of 14.43 per cent during the month to touch the \$ 1.37 billion mark compared with \$ 1.2 billion in April last year. ### **India's Current Sugar Season To End With 52** Lakh Tonnes Of Buffer Stock: ISMA

New Delhi, (H.S): India's 2024-25 sugar season is projected to conclude with a net sugar production of approximately 261 to 262 lakh tonnes which will leave a comfortable buffer stock of 52 lakh tonnes to meet domestic demand, the Indian Bio-energy & Sugar Manufacturers Association (ISMA) said on Friday. The production includes 257.44 lakh tonnes of sugar produced up to mid-May in the current season, along with an estimated 4 to 5 lakh tonnes anticipated from the special crushing season in Tamil Nadu and Karnataka, the ISMA statement explained."

The season commenced with an opening stock of 80 lakh tonnes. Considering the projected domestic consumption of 280 lakh tonnes and export estimates of up to 9 lakh tonnes, the closing stock is likely to be around 52 - 53 lakh tonnes. This reflects a comfortable buffer, ensuring that the country has a sufficient sugar stock to meet its domestic sugar demand," ISMA said. Approximately 27 lakh tonnes of sugar has been diverted for ethanol production up to April 30, 2025, during the current season. An additional 6 to 7 lakh tonnes are expected to be diverted over the remaining season, ISMA further stated. The latest figures show that as of May 15, 2025, sugar production in the ongoing 2024-25 sugar season has reached 257.44 lakh tonnes, with two sugar factories still continuing operations across the country. These two operational

factories are located in Tamil Nadu, where the main crushing season is still underway. To augment production, several factories in South Karnataka and Tamil Nadu are expected to resume operations during the special crushing season, which typically runs from June/July to September.Historically, the production in the special season in Karnataka and Tamil Nadu contributes approximately 4 to 5 lakh tonnes of sugar for the current

season. The industry body also said that the 2025-26 sugar season is shaping up to be promising, buoyed by several positive developments across key sugar-producing regions.In the southern states, particularly Maharashtra and Karnataka, sugarcane planting has shown significant improvement, thanks to a favourable southwest monsoon in 2024. Supported by strong cane availability, the stage is set for a timely start to the crushing season in October 2025, In the northern belt, including Uttar Pradesh, varietal replacement initiatives are expected to yield tangible benefits.

These efforts are expected to result in higher cane yields and improved sugar recovery rates. Adding to this positive momentum are climate forecasts from both the India Meteorological Department (IMD) and Skymet, which predict a normal southwest monsoon in 2025.

Mumbai, (H.S): Economists expect the Reserve Bank of India's (RBI) dividend to the government to surpass a record over Rs 2.5 lakh crore this year as the central bank earnings, through the sale of dollars to prop up the rupee as it sharply depreciated during 2024-25, are reported to have shot up. This higher profit will be transferred to the government as a dividend in 2025-26.

The previous record dividend transferred to the government stands at Rs 2.1 lakh crore during 2024-25 which helped to keep the fiscal deficit in check, while enabling the Finance Ministry to continue with its expenditure on big ticket infrastructure projects to spur growth and social welfare schemes to uplift the poor. This was a record jump from the Rs 87,416 crore transferred to the government in 2023-24 for the profit made in 2022-23. Similarly, the government is expected to get another booster shot through the RBI dividend in the current financial year as well." Among the RBI's earnings, forex transactions are expected to

be most significant in light of the in light of the central bank's measures to lower rupee volatility by strong dollar purchases earlier in fiscal 2025 and difference in the current versus historical exchange rate.

Add to this the interest income on government securities and earnings from funds extended to banks in midst of previous tight liquidity. "This transfer could amount to a record high at around Rs 2.5-2.7 lakh crore this year," said Radhika Rao, senior economist at DBS Bank.Earnings on forex transactions are expected to be substantial with gross dollar sales tracking at \$371.6 billion in fiscal 2025 till February compared to \$153 billion in fiscal

2024, according to Gaura Sengupta, chief economist at IDFC First bank. She estimates the RBI dividend to be between Rs 2.6 lakh crore to Rs 3 lakh crore, according to an NDTV Profit report.

The higher dividend creates fiscal space of 0.1 per cent to 0.2 per cent of GDP, estimates Sengupta. With support from the higher-than-budgeted RBI surplus and savings on a few expenditure heads, the central government is in a fairly strong position to counter the growth slowdown potential risks and any emergency spending requirements. Apart from helping to lower the fiscal deficit, the RBI dividend will be a significant

infusion to core liquidity in the banking system during the current financial year. This will help to keep interest rates low and allow banks to extend more loans to corporates and consumers to accelerate economic growth and create more jobs. The RBI board of directors met on Thursday to review the economic capital framework which is the basis for deciding the surplus transfer or amount of dividend to be given to the government.

The meeting comes ahead of deciding and approving the surplus transfer to the government. The transferable surplus is determined on the basis of the ECF adopted by the Reserve Bank on August 26, 2019, as per recommendations of the Bimal Jalan-headed Expert Committee to Review the extant Economic Capital Framework of the RBI.The Committee had recommended that the risk provisioning under the Contingent Risk Buffer (CRB) be maintained within a range of 6.5 to 5.5 per cent of the RBI's balance sheet.

## India's GDP Growth in Q4 of 2024-25 Expected At 6.8-7 Per Cent

India-UK FTA: Bilateral trade projected to surge by 15 pc annually until 2030



New Delhi, (H.S): The Indian economy is expected to grow at 6.8-7 per cent in the fourth quarter of the financial year 2024-25, driven by the agriculture sector, according to a Bank of Baroda report released on Friday.For the full financial year, the estimate has been pegged at 6.2-6.4 per cent with the report stating that India's economy continues to be better off than its global counterparts on the back of macroeconomic strong fundamentals.

Going ahead for FY26, growth will be at a similar level of 6.4-6.6 per cent with brighter prospects supported by monetary easing, lower inflation, sound domestic demand aided by a budgetary push and sustained capex spending, according to the report. However, any geopolitical conflict and global tariff imposition can have an adverse impact on this optimism, it points out. The report states that robust agriculture growth is expected at 7.7 per cent in Q4FY25.

This will be much higher growth compared with 0.9 per cent growth noted in Q4FY24. This has been on the back of the record foodgrain production as has been noted in the 2nd advance estimates which includes estimates for both kharif and rabi crops.Growth in Q4, though higher than Q3, is, however, uneven across sectors with a few of them registering better growth than others.On the industry side, the mining sector is expected to clock 1.5 per cent growth in Q4FY25 against 0.8 per cent growth registered for the same period last year. On the other hand, growth in the manufacturing sector is likely to soften down to 1.8 per cent from

11.3 per cent in Q4FY24.

This is partially attributable to an unfavourable base and also to weaker corporate earnings. Lower profit margins were visible in the corporate performance of industries such as iron and steel, capital goods, textiles, amongst others. The deceleration was noted despite softer commodity prices. Slower growth is also expected in the electricity sector at 5.5 per cent compared with 8.8 per cent in

Q4FY24. The construction sector is expected to grow at a solid pace on the back of the improvement in steel and cement output in Q4. Sustained thrust on government capex bodes well for this sector.For services, a mixed trend has been visible. Marriage season and Mahakumbh are expected to boost not only the hospitality sector, but also sectors such as

beverages, amongst others. The trade, hotels and transport sector is likely to expand by 6.4 per cent in Q4 from 6.2 per cent in Q4FY24. GST tax collections continue to grow at a steady pace. Financial sector growth (6.6 per cent from 9 per cent) is expected to grow at a slower pace amidst lower credit growth in the same period.Public administration and defence will register some acceleration amidst an uptick in net revenue expenditure.On the outlook ahead, the report states that rural demand in FY26 is likely to continue the upward momentum given the expectation of a favourable monsoon. Neutral ENSO conditions

are expected to prevail in the coming months (NOAA), which bodes well for agricultural growth. Consumption is also expected to pick up pace, as this will be supported by the higher disposable income amidst new tax incentives. Furthermore, continuity of easing cycle given lower inflation will provide a cushion to growth. Lower commodity prices are expected to offer further support."

Based on the above, we expect the Indian economy to clock 6.4-6.6 per cent growth in FY26. However, there are downside risks to these projections, especially for the external sector, emerging from the global stage, given the evolving global tariff challenge. Although any possible bilateral trade between the US and India will be positive. Additionally, any adverse geopolitical conflict or extreme weather condition is likely to act as a growth hindrance," the report said.

New Delhi, (H.S): The bilateral trade between India and the United Kingdom (UK) is expected to increase by around 15 per cent annually until 2030, factoring in the aspect that the free trade agreement (FTA) will come into effect in a year, a report showed on Friday.

The recently concluded free trade agreement (FTA) between India and Britain offers a strategic opportunity for Indian companies to expand their footprint in the UK market, stimulate domestic manufacturing and contribute to economic growth, according to the report by CareEdge Ratings." This landmark FTA also fosters investment, joint ventures, and collaboration in the service sector, thereby deepening economic ties. Going forward, this agreement marks a pivotal shift in India-UK economic relations, unlocking new opportunities for businesses, strengthening manufacturing, and enriching consumer markets," said D Naveen Kumar, Associate Director, CareEdge Ratings.

Currently, the trade value between the United Kingdom (UK) and India is approximately 2 per cent of India's total trade value, although it has been growing steadily at a compound annual growth rate (CAGR) of 11 per cent over the last decade. The UK and India entered into a free trade agreement (FTA) on May 6, following approximately three years of negotiations.Under the agreement, India will reduce tariffs on 90 per cent of British goods, with 85 per cent becoming completely duty-free over a period of 10 years. In return, Britain has agreed to lower its tariffs on certain products, resulting in 99 per cent of India's exports to the UK facing zero duties."

Some of the benefits of FTA for Indian exporters would include improved market access, stable supply chains, increased competitiveness, higher volumes and new avenues for growth," the report mentioned. The FTA is expected to boost India's exports by significantly reducing tariffs, easing trade barriers leading to improved market access and make Indian products more price competitive, thereby increasing their demand in the UK. Additionally, this has provided some relief to exporters who have been facing sluggish sales and

uncertainty about potential reciprocal tariffs from the US.In sectors such as kev automobiles, whisky, industrial machinery, and pharmaceuticals, significant gains are set to be made through steep tariff reductions and simplified regulations.

According to the report, the India-UK FTA is poised to create substantial opportunities for Indian gems and jewellery makers by tapping into the UK's affluent consumer base and welldeveloped luxury market.The tariffs range from 8 per cent to 14 per cent for various electrical and engineering goods. With their removal under the India-UK FTA, Indian manufacturers are poised to gain a clear competitive edge over other global suppliers, said the report.

### **Govt Approves 187 Startups For Tax Exemption To Boost Growth**

New Delhi, (H.S): In a significant boost to India's startup ecosystem, the Department for Promotion of Industry and Internal Trade (DPIIT) has approved 187 startups for income tax exemption under the revamped Section 80-IAC of the Income Tax Act, according to an official statement issued on Thursday. According to a DPIIT spokesperson, the tax benefit allows eligible startups a 100 per cent income tax deduction on profits for any three consecutive years within a 10-year window from the date of incorporation. The scheme is designed to support emerging businesses in their formative years, encouraging innovation, job creation, and wealth generation.Of the total approvals, 75 startups were cleared during the 79th Inter-



Ministerial Board (IMB) meeting and another 112 during the 80th such meeting held on April 30. With this, over 3,700 startups have now been granted exemptions since the scheme's inception.In a key announcement during the Union Budget 2025-26, the government extended the eligibility window for startups to claim benefits under Section 80-IAC. Startups incorporated

before 1st April 2030 are now eligible to apply for the exemption, giving more time and opportunity to new ventures to benefit from this financial relief.Pertinently, the revised evaluation framework introduced by DPIIT has made the application process more structured and transparent. Complete applications are now reviewed within 120 days,

ensuring faster decision-making and reducing procedural delays.Startups that were not approved in the latest round have been encouraged to reassess and refine their applications. The DPIIT has advised applicants to focus on demonstrating technological innovation, market potential, scalability, and a clear contribution to employment and growth."The economic government's continued support underlines its commitment to fostering a robust, future-ready startup environment aligned with the vision of a self-reliant and innovation-led New India," the spokesperson said.Further information on the tax exemption process, eligibility criteria, and application details is available on the official Startup India portal, the spokesperson added.

### **Virat Set for First Action** in IPL 2025 Restart

New Delhi, (HS) : After a 10-day pause triggered by military tensions between India and Pakistan, the Indian Premier League (IPL) 2025 is set to roar back to life this Saturday. And it does so with a blockbuster clash in Bengaluru - Royal Challengers Bengaluru (RCB) versus Kolkata Knight Riders (KKR) - where the spotlight will



undeniably shine brightest on one man: Virat Kohli. The former India captain, who stunned fans earlier this week by announcing his retirement from Test cricket, is expected to be the emotional centrepiece at the M. Chinnaswamy Stadium. Fans have responded in kind, planning to don white jerseys in tribute to Kohli's storied red-ball career. But if history is any indicator, Kohli will be focused more on runs than reverence. And with RCB poised for a playoff berth, the 36-year-old might be ready to pen a new chapter in his T20 legacy.

Before the break, RCB had surged to second in the standings with 16 points from 11 matches, riding on a four-match winning streak. A victory on Saturday could all but seal their place in the playoffs, and they appear well-equipped to resume from where they left off. The return of foreign stars such as Phil Salt, Tim David, Liam Livingstone, Romario Shepherd, and Lungi Ngidi has come as a massive boost. Skipper Rajat Patidar, who had suffered a finger injury against Chennai Super Kings (CSK), was seen batting fluently in the nets - a reassuring sign for the think tank. One concern remains: the absence of Devdutt Padikkal due to injury. Mayank Agarwal, who has been slotted in as his replacement, will have a big role to play at the top. Meanwhile, the status of Josh Hazlewood remains uncertain owing to a shoulder issue.

But even without a full-strength XI, RCB's core group is showing signs of cohesion and confidence. And with Kohli potentially inspired by his Test farewell, KKR could be in for a long evening.
