Minimum 3year legal practice mandatory to enter judicial services: SC



Supreme Court on Tuesday upheld that three years legal practice shall be mandatory for entry into judicial services. It further specified that direct recruitment of fresh law graduates as civil judges junior division shall be barred. According to reports, the Supreme Court has set clear conditions for entry into judicial service. A minimum of three years of practice as a lawyer is mandatory. A threejudge bench of the Supreme Court gave this important verdict. The Supreme Court further clarified that, if one has at least three years of experience as a lawyer then only one can apply for judicial service. However, this will not be applicable for the recruitment process that has already been started. This order will be applicable for the recruitment process that starts later than today. The decision was announced by the Supreme Court on Tuesday that is May 20, 2025. This judgment aims to appoint more experienced and competent people in the judiciary. According to this order of the Supreme Court, it is expected that candidates will gain real experience through legal practice and will be more capable to delivery of justice. It is further worth mentioning that, this rule will be implemented in all states.

Future of healthy world depends on inclusion, integrated vision: PM

New Delhi, (HS): Prime Minister Narendra Modi on Tuesday said that the future of a healthy world depends on inclusion, integrated vision and collaboration. Addressing the 78th World Health Assembly in Geneva, Modi said, "Inclusion is at the heart of India's health reforms; Ayushman Bharat, the world's largest health insurance scheme, covers 580 million people and provides free treatment in India." He announced that the scheme has recently been expanded to include all citizens above the age of 70. Additionally, he said, India has established a vast network of Health and Wellness Centres that offer screening for major conditions such as cancer, diabetes, and hypertension.

"Thousands of public pharmacies across the country also provide high-quality medicines at prices significantly lower than market rates, increasing access to essential drugs for all," he added. Highlighting that the theme of the Assembly "One World for Health" resonates with India's vision of global health, he stated



that "the future of a healthy world depends on inclusion, integrated vision and collaboration."He emphasised that technology is an important catalyst to improve health outcomes and highlighted India's achievements in this regard."We have a digital platform to track vaccination of pregnant women and children. Millions of people have a unique digital health identity. It is helping us integrate benefits, insurance, records and

information," he said.He also added that "with telemedicine, nobody is too far from a doctor. Our free telemedicine service has enabled over 340 million consultations." He further pointed out that because of these initiatives, the out-of-pocket expenditure as a percentage of total health expenditure has fallen significantly, while government health expenditure has gone up considerably. The prime minister underscored that the health of the

care about the most vulnerable, especially in the Global South who are particularly impacted by health challenges. Noting that India's approach presents replicable, scalable and sustainable models, he offered to share India's learnings and best practices with the world, especially the Global South.

Odisha Unveils Adventure Tourism Guidelines-2025



Bhubaneswar, (DMC): In a significant step toward promoting tourism, the State government finalized the Odisha Adventure Tourism Guidelines-2025 during a meeting chaired by Chief Minister Mohan Charan Majhi at Lok Seva Bhawan today. The initiative aims to position Odisha as a premier adventure tourism destination, aligning with the state's 'Think India, Think Odisha' vision. Chief Minister Majhi emphasized that adventure tourism will be developed to ensure Odisha is the first destination that comes to mind for tourists visiting India. The guidelines are part of a broader strategy to support Prime Minister Narendra Modi's Viksit Bharat-2047 vision, with tourism identified as a priority sector. The state plans to map and develop adventure tourism sites across all 30 districts, leveraging Odisha's natural beauty and thrilling landscapes. Key projects include rafting in Satkosia and hot air balloon tourism over Hirakud, with similar facilities planned for other locations. The guidelines also focus on creating employment opportunities for Odisha's youth by providing training and certification for adventure tourism activities on water, land, and air. The initiative is expected to generate significant job prospects while promoting private sector participation through the 'Go Adventure' portal. To attract investment, the state will offer incentives under the Odisha Tourism Policy-2022, aiming to establish Odisha as a globally competitive tourism hub. Chief Secretary Manoj Ahuja and Tourism Department Commissioner-cum-Secretary Balwant Singh were present at the meeting.

Plus-II Results To Be Announced Tomorrow



Bhubaneswar, (DMC): The Council of Higher Secondary Education (CHSE), Odisha, will announce the results for the Plus II examinations tomorrow. The results of all streams, including Arts, Science, and Commerce, will be announced simultaneously at 4 pm on Wednesday, the CHSE said. The results will be available on both the CBSE website and DigiLocker. Students can access their results and digital mark sheets through these platforms after the result declaration. Earlier, Minister of School and Mass Education, Nityananda Gond, mentioned that the results would be declared soon, within the next one or two days. Approximately 3.85 lakh students had appeared for the examinations in all streams. The examination had commenced on February 18. Due to the delay in publishing the results, the Higher Education Department has extended the deadline for admission into Plus 3 courses to June 1.

Heavy rain lashes Kerala, TN and Karnataka; eight killed in rain-related incidents

Kerala, (HS): Heavy rains lashed Chennai and neighbouring districts on Tuesday evening, as the India Meteorological Department (IMD) announced that conditions are favourable for onset of southwest monsoon over Kerala during next 4-5 days. A total of eight deaths in separate rain-related incidents have been recorded in Karnataka and Tamil Nadu so far. Meanwhile, the IMD, in the forecast bulletin issued on Tuesday at 4.30 pm, predicted widespread rainfall accompanied with thunderstorm, lightning and strong winds across Karnataka, Tamil Nadu, Kerala, Andhra Pradesh and Telangana over the next seven days. The

southwest monsoon, which typically arrives towards the end of May, has arrived about two weeks earlier than predicted. The early onset of southwest monsoon can be attributed to climate factors like stronger westerly winds and rising sea surface temperatures, experts told. Another change in the usual monsoon pattern is the northward tilt in rainfall distribution due to a lowpressure system forming near Karnataka's coast. IMD has issued a red alert for seven districts in Karnataka --which include Uttara Kannada, Udupi, Dakshina Kannada, Kodagu, Shivamogga, Chikkamagaluru and



Hassan-- and four districts in northern Kerala --which include Kasaragod, Kannur, Wayanad, and Kozhikode. Orange alert has been issued for parts of Kerala, Karnataka, Maharashtra and Andhra Pradesh.

dhra Pradesh. Various parts of Karnataka continued to receive heavy rainfall on Tuesday. Heavy rain, along with thunder and lightning, was reported in coastal districts. Traffic congestion due to flooding was reported in the arterial roads of Bengaluru. At least five people died in the state, including three

people --63-year-old Manmohan Kamath and 12-vear-old Dinesh-- died due to electrocution in Bengaluru's BTM layout on Monday while trying to use a motorised pump to clear water out of his house. Though they were rushed to a hospital soon after, they were declared dead on arrival by doctors. Another person, 35-year-old Shashikala, who worked as housekeeping staff at a software firm in Mahadevapura area, died after a wall in company premises collapsed on her. Additionally, two people died due to lightning in Raichur and Karwar regions. In the 24 hours ending on

Tuesday morning, the centres to receive heavy rainfall include, Guttal (dist Haveri) 11 cm. Kalasa (dist Chikkamagaluru) 10, Kolar Pwd (dist Kolar) 8, and T G Halli Hms (dist Bengaluru) 7. Chennai received moderate to heavy rains late Monday night and on Tuesday evening. Heavy to very heavy rainfall along with thunderstorms and strong winds were reported in several isolated places across the state. At least three people died in the state due to rains. Three people were killed in Madurai when a sunshade slab collapsed from the weight of water that stagnated in top. The three --65-year-old Ammapillai, her 10-year-old grandson

Veeramani, and her 55-year-old neighbour Venkadammal-- were pulled out of debris a while later. Venkadammal was declared dead by doctors upon admission, while the two others succumbed to their injuries later. The centres to record heavy rainfall in the 24 hours ending on Tuesday morning include, 12 cm in Hosur AWS (dist Krishnagiri), 6 cm in parts of Krishnagiri, Ranipet, Dharmapuri, Salem districts, and 5 cm in parts of Coimbatore, Vellore, Nilgiris.

Widespread waterlogging has been reported in several parts of north Kerala, disrupting daily life and transportation, officials

Environment Clearance

Environment clearances are guardrails that ensure developmental projects do not injure ecosystems, wildlife and natural resources and harm people's health. One of the defining elements of the Environmental Impact Assessment (EIA) Rules of 2006, these screenings were meant to enable policymakers to strike the right balance between the imperatives of development and sustainability. The precautionary principle behind this provision has, however, been substantially undermined in the past eight years. In 2017, the Ministry of Environment, Forest and Climate Change issued a notification that allowed developers to obtain an environmental clearance after beginning work on a project. The notification provided a one-time window to defaulters to comply with due procedure. However, in the process, it inaugurated a regime of post-facto clearances, which was consolidated in 2021 when the Centre issued an Office Memorandum (OM) to "identify" and "handle" violation cases. Now, the Supreme Court has called out the government for "going out of its way... to protect those who harm the environment". On May 16, a two-judge-bench struck down the 2017 notification and the 2021 OM. The verdict is not the first time that the SC has admonished the Centre for diluting the EIA. In Common Cause vs Union of India (2017), a twojudge-bench ruled that the government had committed "serious lapses" in allowing large-scale mining to be "carried on without forest and environmental clearances". Such "violations of laws and policy need to be prevented," it underlined. Three years later, in Alembic Pharmaceuticals vs Rohit Prajapati, the Court held that post-facto clearances go against the "fundamental principles of environmental jurisprudence", and that they were an "anathema to the EIA notification". Then, in January last year, the SC stayed the 2021 OM. However, as an analysis by this newspaper in February revealed, the regulatory laxity precipitated by the 2017 notification allowed more than 50 defaulting projects to go unpunished - coal, iron and bauxite mines, steel and iron factories, cement plants and limestone quarries were approved without proper scrutiny of their impacts on people's health and ecology.

The weakening of the EIA goes against the SC's environmental jurisprudence, where it has continuously expanded the scope of Article 21 to include the right to a healthy environment. In its latest verdict, too, the Court has drawn attention to urban India's pollution crisis and reaffirmed the links between regulatory diligence and the Right to Life. The problem, however, is that governments tend to view sustainability and development as binaries - their ease-of-doingbusiness drives very often pay short shrift to the imperatives of environmental protection. The Court has rightly questioned the tendency to see industry and ecology as locked in a zero-sum game. Its words - "conservation of the environment and its improvement is an essential part of the concept of development" - must resonate among policymakers and inform regulatory processes.

The profession of Terrorism

Perhaps one image the world etched in its memory is the aeroplanes hitting the World Trade Centre in New York and smoke billowing out of the towers. This type of terror act was unprecedented and the whole world looked at the picture in awe. At home we had the attack on Parliament, Mumbai attack (26/11) by Pakistani terrorists and thereafter several terrorist attacks in Kashmir. The Hamas led terrorist attack in Israel on 7th October 2023 resulted in death of 1200 people attending a music festival. The terrorists also took 250 people hostage. Acts of terror in Africa are regular affairs in some countries and terrorism has become a profession in the modern world. Most of the terrorists have nothing personal against the victims except religious fanaticism in most cases. Recently the murder of 26 innocent tourists by Pakistani terrorists in Pahalgam has shaken the patience of Indians and people demanded a counter attack on Pakistan for revenge.

Terrorism is not a modern phenomenon as it started in ancient times in the form of religious intolerance. After the onset of revolutionary politics and invention of dynamite and pistol in 19th century, terrorism took a modern and more violent shape. The first organizational terrorism started with the formation of the Irish Republican

Brotherhood in 1858. They deployed time bombs in various parts of London to generate fear in the minds of English people and gain political mileage. Several other organizations cropped up in Europe like Norodnaya Volya in Russia, mostly for political purpose. Today there are several terrorist organizations in middle east, Africa, Asia and Europe that operate like corporate entities by employing people. The workers work more for salary than for ideological reasons. They have a well laid down hierarchy and organizational structure with several departments working under one authority. Some of the large and well known terrorist organisations like Hamas, Hizbul Mujahideen and Houthi operating in middle east, Jaish E Mohammad and Laskar E Taiba in Pakistan, Boko Haram in Nigeria and Taliban ruling in Afghanistan have a succession plan to take care of the organisation after the death of the leader. Al Qaeda and Islamic state operate in many countries. Some of these organizations occupy and administer land mass like a state and have a well laid down military structure. While Taliban runs Afghanistan, Hamas occupies Gaza strip, Houthi occupies a part of Yemen and Hizbul Mujahideen occupies a part of Lebanon and some of its members are represented in the parliament of the country. The governments in these countries have bowed before the military prowess of the terrorist organizations. Syria is occupied by several groups and the current president of Syria is a former Al Qaeda man. When an organisation is formed to get independence of the country from foreign rulers, the members of such organisation are called freedom fighters by the local people and terrorists by the ruling class. But today terrorism is not limited to seeking independence; instead terrorists operate for



religious supremacy or against the local rulers who are deemed as dictatorial. One form of terrorism today aims to propagate communist ideology in its extreme form and wants to eliminate the traditional ruling order. We call them Maoists in India. A few terrorist organizations have been created and funded by the state governments to act as proxy for them and fight with enemy countries. Some of these organisations operate like private limited companies. A study done a decade back on terrorists operating in Kashmir has recorded that a terrorist gets a monthly payment of Rs.8000-12000. When a new person is enrolled in to the organisation, he gets an upfront payment (signing bonus) of Rs 25000-50000. At the end of his tenure he gets a separation payment of Rs 2 - 2.5 lakh. For every terror act committed he gets an additional payment of Rs 1-2 lakh. Another report indicated that if the terrorist is killed during his service tenure his family gets a house. A report also mentioned that Hamas paid about USD 350 million per annum to its army which had 20000-30000 fighters in 2020. Hizbullah has a much bigger army of 1-1.20 lakh people and it pays about USD 1000-1200 per month to every soldier. Since

of the organizations are blacklisted for opening accounts with banks, they maintain their own bank like structure for making payments and receiving funds and donations. The new recruits are trained and some of the organisations have prescribed schedule of training like any corporate. Initially they are taught religious matters to brain wash them and make them feel that they are unjustly deprived and they will be fighting for a noble cause. In subsequent phases, they are trained in use of armaments and electronic instruments, making of bombs, survival technique in adverse conditions and the best

of them are sent for missions. Some of the terrorist organizations were supported and nurtured in the initial stage by governments to act against an enemy country. In course of time the terrorist organisation becomes too big and demands more benefits from the supporting country. With change of governments and priority, the terrorist organisation may not remain relevant for the supporter country and it wants to get rid of it. At that stage the terrorist organisation hits back at the country that nurtured and supported it all through. Osama Bin Laden of Al Qaeda was

stage, but ultimately Bin Laden staged the attack on World Trade Centre in New York. Terrorism results in death of people, creation of a sense of fear among the local people, sometimes results in war between countries and affects the economy of the region and country. Terror activities affect the trade, the financial market, reduce tourism and usually affects road and rail transport in the area affecting the overall economic environment. As it increases the risk perception, insurance premium go up in the area. The Pahalgam act has suspended tourism in the region for some time which in turn has affected the livelihood of hotel owners and the people engaged in providing support to tourism like the shikara owners, taxi operators and horse operators in the region. One study estimated that in Basque region of Spain, GDP per capita declined by 10% during 1980-1990 due to terrorist activities. Two states in Turkiye experienced decline in GDP per capita by 14% over a period of 20 years due to terrorism. Developed economies experience a short term economic impact of terrorism as terror activities are usually infrequent. One study estimated the global economic impact of terrorism at USD 566 bn during 2010-2018. The study also recorded that between 2010 and 2018 globally 167,000 deaths took place due to terrorism and the most affected countries were Iraq, Afghanistan, Nigeria, Pakistan, Syria, Somalia and Central African Republic. The Institute for Economics and Peace publishes the Global terrorism Index which provides a comprehensive summary of the key global trends and patterns in terrorism. As per the Index, 66 countries were affected by terrorism; there were 3492 attacks and a total of 7555 people lost their lives in 2024. Islamic State and its allies remained the world's deadliest terror group.



312 cloth bags for 10,000 fine! BMC's two-pronged strategy to make Bhubaneswar polythene-free



Bhubaneswar, (DMC): In a bid to curb plastic pollution and move towards a polythene-free Bhubaneswar, the Bhubaneswar Municipal Corporation (BMC) has introduced an innovative approach that not only penalises violators of the single-use plastic ban but also empowers them to adopt eco-friendly alternatives. This two-pronged strategy,

combining enforcement with incentivisation, marks a shift from punitive to participatory environmental governance. According to a report by The Times of India, rather than simply collecting fines for violations of the single-use plastic ban, BMC has launched a unique model where vendors, who are fined for using or selling polythene carry bags, receive cotton cloth bags equal in value to the penalty imposed. For instance, if a vendor is fined Rs 10,000, he/she will be provided with 312 cloth bags by the BMC, each worth approximately Rs 36. The reports also stated that these bags would be sourced from empanelled vendors and carry BMC branding, promoting both compliance and sustainability. The aim is not just to penalise but provide a tangible and immediate solution to vendors, enabling them to stop using polythene altogether.

The one-time distribution will be documented, and vendors will be required to sign a declaration acknowledging the benefit.In a complementary move to boost operational efficiency and reduce logistical costs, the BMC is also planning to set up its own fuel station and garage near the Temporary Transit Station (TTS). The initiative is expected to streamline the management of over 500 municipal vehicles and machinery, which currently rely on external fuel suppliers and private garages. By internalising its fuel supply, the BMC hopes to reduce procurement delays, cut expenses and gain greater control over its fleet operations.

Moreover, if the fuel station is opened to public use under a commercial model, it could also become a revenue-generating asset for the corporation. Together, these initiatives show that Bhubaneswar is charting a new path toward becoming one of India's cleanest and most efficiently managed cities.

Cuttack Police Rescue Kidnap Victim Linked To Stock Trading Dispute; 7 Arrested

Cuttack, (DMC): In a swift and coordinated operation, the Cuttack Urban Police District (UPD) of Commissionerate Police successfully rescued a youth, Soumya Ranjan Behera, who was abducted from Baulakuda in Bayalish Mouja on the night of May 18. Seven suspects, including a juvenile, have been arrested in connection with the

Addressing the media on Tuesday, Cuttack Deputy Commissioner of Police (DCP) Khilari Rishikesh Dnyandeo said that the abduction was masterminded by gym trainer Rajesh Das, allegedly over a financial dispute involving an investment of ?60-?70 lakh in Behera's Bhubaneswar-based stock trading firm. Das and his associate Divyajyoti, along with other accomplices plotted the kidnapping after repeated attempts to recover their money failed, he added.DCP Dnyandeo



abductors who demanded repayment of the disputed investment. During the operation, police seized a car and three motorcycles used in the commission of the crime, he added. DCP Dnyandeo revealed that this was not the first instance of Behera being targeted. He had previously been abducted in 2022, also in connection with financial disputes. Further inquiries are underway to uncover more details about Behera's business dealings and possible links to other similar cases.

Two former Odisha government officials convicted in vigilance cases; Pension stoppage proceedings initiated

Bhubaneswar, (DMC): In a major development highlighting Odisha Vigilance's ongoing crackdown on corruption, two retired government officials were convicted today in separate vigilance cases by Special Vigilance Courts in Bolangir and

Both cases were chargesheeted earlier by the Odisha Vigilance and have culminated in rigorous imprisonment along with financial penalties. Following the convictions, the Vigilance Department will now move the competent authorities to initiate proceedings for the stoppage of their pensions. In the first case, Kalandi Charan Bhuyan, Former Junior Accountant-cum-Lease Clerk at the Office of the Divisional Forest Officer (Territorial), Bolangir, was convicted by the Hon'ble Special Judge, Vigilance, Bolangir.

He had been charge-sheeted in Sambalpur Vigilance PS Case No. 16 dated 27.06.2019 under Section 7 of the Prevention of Corruption (Amendment) Act, 2018. The case pertained to the demand and acceptance of a bribe

of ?10,000 from a complainant for granting permission to cut exempted trees standing on farmer-owned lands and to shift the felled timber for sawing purposes. The court sentenced Bhuyan to 3 years of rigorous imprisonment and imposed a fine of ?10,000.

In light of the conviction, Odisha Vigilance will move the competent authority for the stoppage of his pension.In the second case, Subash Chandra Mishra, Former Block Development Officer (BDO), OAS-I, of Lefripada Block in

Sundargarh district, was convicted by the Hon'ble Special Judge, Vigilance, Cuttack. He was charge-sheeted under Section 13(2) read with Section 13(1)(e) of the Prevention of Corruption Act, 1988, for possessing assets disproportionate to his known sources of income.

The court found him guilty and sentenced him to 2 years of rigorous imprisonment and imposed a fine of ?50,000. Odisha Vigilance will also initiate the process for the stoppage of pension benefits for Mishra following his conviction.

Illegal encroachment of government quarters in Bhubaneswar sparks concern Bhubaneswar, (DMC): While

renting a house in the state capital, Bhubaneswar, has become increasingly unaffordable for the common man, government quarters in VIP areas here are reportedly being illegally occupied or rented out, sparking serious concerns over misuse of public

In the heart of the town, several Odisha government quarters-meant for officialshave been taken over either forcibly or are being sublet illegally. A glaring example is a hotel operating on the Rajmahal to Master Canteen stretch, where government-provided space has been converted into a commercial shop. Shockingly, the quarters behind the shop



have also been encroached upon and turned into a kitchen."The government has provided a vending zone, but it does not have a water and drainage facility. As the quarters is lying vacant, we are using at as a kitchen," said the owner of the

Similarly, quarter number VA 25/3, for instance, has been turned into a private warehouse for construction materials like

cement and rods. Liquor bottles-both Indian and foreignare seen stacked inside. Sources say a powerful individual has allegedly set up a workshop inside the premises, manufacturing manhole covers and selling them back to the government."

Subas Babu is the supervisor of the unit. Though we know this property belongs to the government, we four

people are living here and working in the unit," said a worker.Similarly, quarter number VA 23/4, originally allocated to the Hind Mazdoor Sangh office, is now fully occupied by a woman who uses the space to sell leaf plates and other items. government quarters in the area, 250 lie vacant, and more than a hundred are under illegal occupation. Bhubaneswar Court sentenced five persons to life imprisonment in Sushant Nayak murder case

Bhubaneswar,,(DMC): The Bhubaneswar court on Monday sentenced five individuals to life imprisonment in connection with the brutal murder of Sushant Nayak in 2023. The verdict was delivered by Judge Bandana Kar of the Additional District Judge Court-2, Bhubaneswar. The five convicts - Vishal Nayak, Sujit Nayak, Ajit Nayak, Tikili Nayak, and Subash Nayak - were each fined ?25,000. In case of non-payment, they will have to serve an additional one-year jail term. Sushant Nayak, a housekeeping staff member at the Central Horticultural Experiment Station (CHES) in Aiginia, was hacked to death near GED Basti in Unit-III under the Capital Police Station limits during the early hours of May 24, 2023. According to police reports, the accused intercepted Sushant while he was returning home after dropping off his wife, who works with the Bhubaneswar Municipal Corporation (BMC). The attackers used swords and other sharp weapons to kill him. The incident was reportedly triggered by a molestation complaint filed by Sushant's family. In April 2023, Sujit Nayak's nephew, Vishal, was accused of molesting Sushant's niece. The complaint was lodged with the Capital Police Station on April 25, 2023. In a retaliatory act, Sujit and his relatives allegedly plotted and executed Sushant's murder. All five accused fled following the incident, but were later arrested during police operations in Cuttack, Nayagarh, and Khordha districts.



Genome Sequencing To Be Conducted If COVID Case Found In Odisha: Health Director

Bhubaneswar, (DMC): Amid reports of the deaths of two COVID-19-infected patients in Maharashtra, State Public Health Director Nilakantha Mishra said on Tuesday that no fresh coronavirus cases have been reported in the state. He added that if anyone is found to be positive for COVID-19, the patient's sample would be sent for genome sequencing to determine the virus variant.'

official notification read. Notice for Cabinet Meetings shall ordinarily be circulated, at least five days before the date fixed for the Cabinet meeting. However, in cases of urgency, such a timeline may be relaxed by the Chief Minister. In order to ensure adherence to the provision contained in Instruction No. 17 (i) of Part III, henceforth, the Parliamentary Affairs Department shall not accept any Cabinet Memorandum beyond 5.00 PM of three days prior to the Cabinet Meeting. (Here three days refers to three working days e.g. if the Cabinet meeting is scheduled on 7th of a month then memorandum should reach by 5.00 PM of the 4th of that month and in case the 4th of that month falls on a Government Holiday, it should reach by 5.00 PM of 3rd of that month). Considering urgency/ exigency of the matter, all concerned are to take appropriate action for obtaining required approvals from the competent authorities to ensure that the proposals are submitted to the Parliamentary Affairs Department within the stipulated timeline as indicated above. As per Instruction 21, when it has been decided to bring a case before the Cabinet, the Department to which the case belongs shall, unless the Chief Minister otherwise directs, prepare a memorandum indicating with sufficient precision the salient facts of the case and the points for decision. Such memorandum and such other papers as are necessary to enable the case to be disposed of shall he circulated to the Chief Minister, Minister of State (MoS)-in-charge of a Department, and the Secretary to the Cabinet. He emphasised that during India's counter-strikes, utmost care was taken to ensure only terrorist hideouts were hit, and no harm came to civilian areas. "Our soldiers made sure that while punishing the perpetrators, innocent lives were not affected," he said. Mr Singh also acknowledged the people of his constituency, Lucknow, saying, "When I accepted the invitation for this event last month, I wasn't sure I could attend due to the developing situation. But with Operation Sindoor concluded successfully, I am here to express my gratitude and admiration, both for our armed forces and for the spirit of the people."

"Hindus Targeted, Local Cops Inactive & Absent": Murshidabad Violence

Kolkata, (HS): A leader of Bengal's ruling Trinamool Congress was involved in the violence in Murshidabad that broke out last month, says the report by a probe committee constituted by the Calcutta High Court. The attacks, which took place during the passage of the Waqf Amendment bill and sparked a huge political row, were directed at Hindus and when the beleaguered people called for help, the police failed to respond, the report said. The report also highlighted indiscriminate arson and loot and relentless destruction of shops and malls. "The attacks were directed by the local councillor Mehboob Alam... the local police was completely inactive and absent," read the report, a copy of which was accessed.

The main attack occurred on Friday, April 11, after 2.30 pm, when "Local councillor Mehboob Alam came with miscreants". Residents of Samserganj, Hizaltala, Shiulitala, Digri came masking their face, the report said. "Amirul Islam came, saw which houses were not attacked, and then the attackers set them ablaze... The villagers of Betbona telephoned, but the West Bengal Police did not respond... The MLA was also



present. He saw the vandalism and went away," the report said. The attackers had cut off water connection so the fire could not be extinguished. 113 houses were the worst-affected in Betbona village, the report also said. The homes are destroyed and "would not be habitable without thorough reconstruction... the women of the village are afraid and have taken shelter with their relatives." the report said. On April 12, a man and his son from a Hindu family were killed by their Muslim neighbours, the report said. The violence that followed wiped out shops and markets in the area. Grocery shops, hardware shops, electrical and textile stores were destroyed. So were the temples - all this happened within a 300-metre radius of the local poice station. Twenty-nine shops were affected in Ghoshpara, Murshidabad. A shopping mall-style market was looted and closed, the report said.

The investigation team comprised members from the National Human Rights Commission, the state legal Services authority and the Judicial services. The report was submitted before a division bench of the high court today. The panel had visited the villages and spoke to the victims of violence.

Delhi HC Asks Accused in Security Breach Case

New Delhi, (HS): The Delhi High Court on Tuesday asked those arrested in the 2023 Parliament security breach case the reason for choosing a specific date and place for protests when they were aware of earmarked spots for protests in the capital. A bench of Justices Subramonium Prasad and Harish Vaidvanathan Shankar posed the query while hearing bail pleas of accused Neelam Azad and Mahesh Kumawat, who were arrested in the case. In a major security breach on the anniversary of the 2001 Parliament terror attack, accused Sagar Sharma and Manoranjan D allegedly jumped into the Lok Sabha chamber from the public gallery during Zero Hour, released yellow gas from canisters and sloganeered before they were overpowered by some MPs. Around the same time, two other accused -- Amol Shinde and Azad -allegedly sprayed coloured gas from canisters while shouting "tanashahi nahi chalegi (dictatorship won't work)" outside the Parliament premises. The court on Tuesday reserved its order on the pleas, but asked the accused, "Why did you choose that date (December 13. which is also the date of the 2001 Parliament attack) for your protest?

New Delhi, (HS): Pakistan and India have agreed to withdraw troop reinforcements deployed during their recent conflict back to their peacetime positions by the end of May, a senior Pakistani security official told AFP on Tuesday.

More than 70 people were killed in the four-day conflict, which was sparked by an attack on tourists by terrorists in Kashmir last month that New Delhi accused Islamabad of backing. The military confrontation involving intense tit-for-tat drone, missile, aerial combat and artillery exchanges came to an abrupt end after US President Donald Trump announced a surprise ceasefire, which is still holding.



Indian Army denies deployment of air defence guns at Golden Temple

Amritsar, (HS): The Indian Army on Monday dismissed media reports claiming the deployment of air defence (AD) guns at the Golden Temple, saying that no AD guns or related resources were deployed within the premises of Sri Darbar Sahib in Amritsar. Earlier, in an interview with the news agency ANI, Lieutenant General D'Cunha credited the head granthi, the chief priest of the holiest Sikh shrine worldwide, for enabling the army to deploy air defence guns within the Golden Temple premises.

He claimed that, for the first time in history, the Golden Temple's lights were switched off to enhance the detection and engagement of drones coming from Pakistan.



"It was very nice that the head granthi of the Golden Temple allowed us to deploy our guns. It is possibly for the first time in many years that they switched off the Golden Temple lights so that we could see the drone coming," Lt General D'Cunha said in the interview. "Fortunately, we visualised what they (Pakistan) were capable of doing. Realising that they would target it because they had no legitimate targets across the border. They were more interested in creating confusion, chaos internally, and hence, we visualised that they would target our civil population and our religious places of worship," D'Cunha added in the interview. However, on Tuesday, Golden Temple head granthi (priest) Giani Raghbir Singh refuted the statement made by Lieutenant General Sumer Ivan D'Cunha, the army's air defence in-charge, who claimed he had authorised the deployment of air defence guns within the shrine complex to counter potential drone and missile threats from Pakistan during Operation Sindoor.

Calling the statements "propaganda," Giani Raghbir Singh said, "I was not contacted by any army officer. There was no communication on any gun deployment, nor did any such incident occur at Sri Darbar Sahib. I was on leave in the US for 22 days. I went on April 24 and returned on May 14. The conflict started after I left and ended before I returned. The Shiromani Gurdwara Parbandhak Committee should probe the army's claims and take departmental action if any SGPC member is found involved in this matter.'

Ashoka University professor sent to 14day judicial custody

CHANDIGARH, (HS): Ashoka University associate professor Ali Khan Mahmudabad, arrested for his alleged remarks on Operation Sindoor, claimed that the Haryana Women's Commission had no jurisdiction over the matter and accused authorities of "a new form of censorship and harassment."He was sent to fourteen days' judicial custody by the district court in Sonepat on Monday, with the next hearing scheduled for May 27. Mahmudabad was arrested on May 18 after two First Information Reports (FIRs) were registered against him under stringent charges of "endangering India's sovereignty, unity and integrity." He was produced before the court by the Sonepat police following the end of a two-day police remand. While the police sought an extension of seven more days in remand, the court denied the request and instead sent the professor to judicial custody. Kapil Balyan, Mahmudabad's advocate, said that he was presented by the police this afternoon before the court. "The court has


Why Rahul's Criticism of EAM Jaishankar May be off Target

New Delhi, (HS): Rahul Gandhi's recent accusations against External Affairs Minister S. Jaishankar have stirred political controversy and strategic concern. Gandhi has alleged that the Modi government warned Pakistan ahead of Operation Sindoor, a military strike on terrorist bases, an accusation that, if true, would imply a major national security breach. More controversially, he has asked how many Indian fighter jets were lost because of this alleged tip-off, a claim the government flatly denies. But here's the problem: these

claims are not just unsubstantiatedthey've been officially rejected by both the Foreign Ministry and top military officials. The Ministry of External Affairs (MEA) issued a statement on May 17 clarifying that Jaishankar never said Pakistan was warned before the strike. Rather, communication happened only after the operation commenced, in accordance with poststrike diplomatic protocol. This protocol is standard to avoid misinterpretation by the adversary and to clarify that civilian or military



installations weren't targeted. Foreign Secretary Vikram Misri reinforced this in a briefing to Parliament's Standing Committee. He said that Pakistan was informed only during the early phase of the operation-not before. Similarly, Lt General Rajiv Ghai, DGMO of the Indian Army, explained that the Army tried to initiate contact with Pakistan after the strike began, not before. Pakistan rejected the communication and signaled it would retaliate-a response that underscores there was no advance warning.

This means Gandhi's assertion that

security doesn't hold up under scrutiny. What appears to be a routine poststrike communication is being framed by the Congress as a pre-strike alert, twisting facts for political narrative. Gandhi has also doubled down on his demand to know how many fighter jets India lost in the operation, including whether Rafales were among them. Air Marshal AK Bharti, when asked, responded with caution, saying that while combat losses are a reality, disclosing specifics during an ongoing operation would only help the adversary. He confirmed all pilots returned safely and emphasized that the mission's objectives were met. So why is the Congress pushing this line? Government sources suggest that Gandhi is attempting to revive the discredited Rafale controversy. The Supreme Court has already dismissed allegations of corruption in the Rafale deal, but by raising questions about fighter jet losses, Gandhi may be trying to reignite public suspicion. Adding fuel to the fire, the Congress recently held a press conference suggesting that Pakistan had time to let terrorists escape because of this supposed leak. They even cited former U.S. President Donald Trump's claim about trade threats to halt the conflict-another narrative the BJP says echoes Pakistan's line. This is where the politics turns dangerous. BJP leaders have accused Gandhi of mirroring Pakistan's propaganda, calling him a "new-age Mir Jafar." Even Pakistani media has taken note, with commentators suggesting that India's opposition is attacking its own government more harshly than they would expect of their own political

Critics argue that repeatedly questioning India's military strategy, aircraft performance, and diplomatic conduct not only demoralizes forces but also weakens the country's international posture. In a time of ongoing military operations, such public discourse risks strategic confusion and internal division. Rahul Gandhi's criticism, intended to score political points, might be undermining India's strategic messaging-and playing into the hands of its adversaries.

Delhi court acquits 11 accused in 2020 Northeast Delhi riots case

New Delhi, (HS): Delhi's Karkardooma Court recently acquitted 11 accused in a case related to rioting, arson, etc. in Northeast Delhi in 2020. The court acquitted the accused persons after finding no credible evidence against them. It discarded the testimony of two police officials who identified the accused persons in a video. The court also noted that the accused persons were identified at a belated stage after their arrest and the filing of a charge sheet. An FIR was filed at the Gokul Puri Police Station. Additional Sessions Judge (ASJ) Pulastya Pramachala acquitted all accused persons after considering the evidence and testimonies of the Prosecution witnesses. "Given my foregoing discussions, observations, and findings, I find that the charges levelled against the accused persons in this case are not proved beyond a reasonable doubt and the accused are entitled to the benefit of doubt.

Hence, all accused Ankit Chaudhary alias Fauzi, Sumit alias Badshah, Pappu, Vijay, Ashish Kumar, Sourabh Kaushik, Bhupender, Shakti Singh, Sachin Kumar alias Rancho, Rahul, and Yogesh, are acquitted of the charges levelled against them," ASJ Pramachala held on May 14. The court noted that the accused persons were identified by the two police officials who claimed to know them prior to the incident. The court noted, " However, both these officials were posted in the same police station, despite that their statement regarding identifying the accused persons was recorded at a much belated time."" Moreover, if these accused persons were already known to these two police officials, then there could not have been any need to identify them in any video or photographs," the court further noted. The court observed in the judgement, " It is worth noting here that by the time the Investigation Officer (IO) recorded the statement of these two police officials, all accused were already arrested and chargesheeted in this case.

Therefore, their identification of accused persons, at such a belated time, is not beyond controversy and doubt." The accused were chargesheeted by the police for offences punishable under Section 147, 148, 149, 380, 427, 436 IPC. On March 3, 2020, an FIR was registered at PS Gokalpuri according to receipt of a written complaint filed by one Mohammad Imran Sheikh.

78th World Health Assembly Opens In Geneva With Focus on 'One World For Health'

Geneva, (H.S): The 78th World Health Assembly (WHA) opened in Geneva, Switzerland, under the theme "One World Health." Addressing opening ceremony, WHO Director-General Tedros Adhanom Ghebreyesus said every WHA is significant, but this year's gathering is particularly historic as member states are expected to consider and potentially adopt the pandemic agreement, Xinhua news agency reported.

Tedros also called on member states to approve the next round of assessed contribution increases to help ensure the WHO's long-term financial sustainability and independence.Lei Haichao, head of China's National Health Commission and leader of the Chinese delegation, delivered a statement during the general debate Monday, highlighting

China's active engagement in global health cooperation.He also said that Taiwan is an inalienable part of China and the WHA has long made clear decisions not to include in its agenda a so-called proposal on Taiwan's participation in the annual assembly as an observer. The remarks made by a small number of countries concerning Taiwan disrupted the agenda and went against the will of the international community, he noted, adding that China urges these countries to stop interfering in its internal affairs.

A major focus of this year's assembly is the deliberation of much-anticipated pandemic agreement. The WHO announced on April 16 that, following more than three years of intensive negotiations, member states have reached a consensus on a draft of the agreement.Delegates will also review the 2024 results report and deliberate on around 75 agenda items covering a wide range of topics, including the health and care workforce, antimicrobial resistance, health emergencies, polio and climate change, among other issues.Sustainable financing is another key issue. The Assembly is expected to discuss the proposed program budget for 2026-2027, which may be reduced from \$5.3 billion to \$4.267 billion dollars, alongside efforts to refocus priorities, strengthen core functions, and enhance organisational efficiency.

The World Health Assembly is the WHO's highest decisionmaking body and is typically held every May in Geneva. Its main responsibilities include setting organisational policies and reviewing and approving the program budget. This year's Assembly is scheduled to conclude on May 27.

India Sends Humanitarian Aid To Afghan **Refugees As Pak Continues Mass Deportations**

Kabul, (H.S): As Pakistan intensifies its mass deportation of Afghan refugees, India has stepped in with humanitarian aid for thousands of affected families, reinforcing its long-standing commitment to supporting the Afghan people in times of crisis. The Taliban's Ministry of Refugees and Repatriation announced that the Government of India has delivered essential food aid to around 5,000 Afghan families who were recently expelled from

The aid package, consisting of

11 different food items, was distributed through the Kabul office of the Directorate of Refugees to families deemed most in need. India's assistance was formally acknowledged in a public message from Maulvi Abdul Kabir, the Taliban-appointed Minister for Refugees and Repatriation. The message, delivered by Zakirullah Zakir, head of the Prime Minister's Office's Coordination Department, was read during an official aid distribution ceremony in Kabul. Abdul Kabir expressed gratitude to



both the Government and people of India for their continued support and called on other countries and humanitarian organisations to step up their aid for displaced Afghans. "India's help has come at a time when our people are facing extreme hardship," he said.'

We welcome all returnees and assure them of their safety and dignity under the general amnesty declared in the country," he added. Kalim al-Rahman Fani, Deputy Minister of Finance and Administration, also acknowledged that returnees face numerous challenges, despite the Islamic Emirate's efforts to provide housing and services. He noted that 58 new townships are being planned across

31 provinces to accommodate the influx. Since April, Pakistan has expelled hundreds of thousands of Afghan migrants, citing national security concerns and ties between the Taliban and India, allegations that remain unproven and have not been addressed by the Taliban.

Amid these regional tensions, India's quiet but consistent humanitarian outreach stands in contrast to Islamabad's crackdown, drawing attention to New Delhi's people-centric approach to diplomacy in the region. India has long maintained that its assistance to Afghanistan is driven by humanitarian concerns and a desire to ensure regional stability.

Nepal: Leaders, Experts Call For 'Bigger Space' In Enhancing Ties With India

Kathmandu, (H.S): Nepal's political party leaders, lawmakers, and experts have urged that the Himalayan nation must push for a bigger space in its relationship with India, especially following the April 22 Pahlagam terror attack." We are so tempted that we should create a space in New Delhi out of the partnership that we have had till now, and particularly after the Pahalgam incident," said former minister and Nepali Congress leader, Minendra Rijal.

Speaking at an event in Kathmandu on Monday organised by the Institute for Public Policy and Partnership, the former minister said since India's ties with some of their neighbours are facing some difficulties, Nepal has to seize the opportunity.He called for a sincere and open dialogue with India on sensitive issues." No one can substitute Nepal-India relations. Since India is a big country, we definitely have complaints about it. Our relationship goes beyond the Roti-Beti cliche (sociocultural ties), and these relations don't fit in any single framework. But when



engaging with India, most of the time, our leaders only cared about their politics and how to secure their election tickets," Rijal further said, urging for dialogue with India. Additionally, the former foreign minister of Nepal, NP Saud, addressing the event, said that in diplomacy, achieving completely balanced relationships is not possible despite what some people suggest." We have to maintain our relations by keeping national interest at the core. We should be open while dealing with India. Non-alignment has become increasingly irrelevant, and multilateralism is becoming important to us. In this context, we need to fine-tune our relations

with India due to the emerging global and regional context," said Saud. Meanwhile, Vijaya Jolly, former in-charge of the BJP's foreign cell, sought increased support from Nepal in India's fight against terrorism, adding that India does not mind if Nepal conducts its independent foreign policy with any country.He highlighted the long-standing neighbourly relations between both nations and stated that there is no space for terrorism in South Asia."Saarc is dead, and terror and trade cannot go together. The frequent high-level visits and exchanges between the two nations have added momentum to the bilateral partnerships and helped the leadership to review at regular intervals the entire gamut of the relationship, the MEA mentioned.

India Gives Proof of TRF Terror To UNSC Sanctions Panel Monitoring Team: Sources

delegation from India has met with the monitoring team of the United Nations (UN) Security Council's panel that sanctions terrorists and provided it with evidence of The Resistance Front (TRF) carrying out the massacre in Pahalgam, according to sources. Pressing India's case for imposing sanctions on the front organisation of the Lashkar-e-Taiba (LeT),

the delegation from India shared documentary evidence with the monitors, the sources said on Monday. The Council's panel is known as the 1267 Committee after the resolution calling for action against the Islamic State or Da'esh and Al-Qaida, and groups and people associated with them. Its monitoring team of experts reports on terrorism and terrorists, and makes recommendations for additions to the terrorist list and for imposing sanctions. The sanctions include



freezing their assets and imposing travel bans on those associated with the groups. The 1267 Committee listed the LeT as an international terrorist organisation in 2005 and sanctioned three groups associated with it, including Pasba-e-Kashmir and Jamaat-ud-Dawa. The LeT operates under several names in attempts to evade sanctions, and the list includes 27 names under which it operates.It has sanctioned about a dozen individuals associated with LeT, including its leader, Hafeez Mohammed Saeed.A

source said that India had already reported the TRF's terrorist activities to the UN and the delegation in the meeting with the monitoring team "reinforced that documentary evidence." India's UN mission did not respond to requests for information about the delegation's push for declaring the TRF an international terrorist organisation. The media relations staff of the Council's current President, Greece, did not respond either on the monitoring team's meeting. As Council Committee as it does not have a chair because Pakistan wants to head it, and some other members oppose it. They had earlier listed an informal meeting of the 1267 Committee on the day's programme. The delegation from India, which included intelligence officials, met last week with the top UN counter-terrorism officials for a wide-ranging discussion on cooperation in fighting terrorism in the aftermath of the Pahalgam terror

Under-Secretary-General Vladimir Voronkov of the Office of Counter-Terrorism (UNOCT) and Assistant Secretary-General Natalia Gherman of the Counter-Terrorism Committee Executive Directorate (CTED) discussed with the Indian team cooperation, "particularly in support of implementing key Security Council counter-terrorism resolutions and the UN Global Counter-Terrorism Strategy," the UNOCT said.

Singapore reports 151 new HIV cases in 2024, over half diagnosed at late stage

Singapore, (H.S): Singapore reported 151 new human immunodeficiency virus (HIV) cases in 2024, with 78 of them diagnosed at a late stage of infection, according to the latest data released by the Communicable Diseases Agency

About 62 per cent of the newly reported cases were detected during medical care, with the majority already in the late stage of HIV infection. The fact that more than half of the new cases were diagnosed late is a cause for concern, Wong Chen Seong, head of the national programs for HIV, hepatitis C, and sexually transmitted infections under the CDA, told local media.He said that although both early- and late-stage patients can typically suppress the HIV viral load to undetectable levels after three to six months of treatment, those diagnosed at a late stage often already suffer from serious complications due to weakened



late-stage patients involves not only suppressing the virus to prevent further immune damage, but also managing these concurrent illnesses, Xinhua news agency reported. He added that once the immune system has been compromised, it can take longer to recover, with the duration varying depending on the patient's overall health, age, and baseline immune status. During this recovery period, individuals are also more vulnerable to other infections. As of end-2024, a total of 7,137 Singapore residents were known to be living with HIV. The annual number of new HIV cases in Singapore has been gradually declining over the years, from 300 to 500 cases annually between 2009 and 2019, to around 200 to 250 cases between 2020 and Health Organisation, HIV is a virus that attacks the body's immune system. Acquired immunodeficiency syndrome (AIDS) occurs at the most advanced stage of infection.HIV targets the body's white blood cells, weakening the immune system. This makes it easier to get sick with diseases like tuberculosis, infections, and some cancers.

HIV is spread from the body fluids of an infected person, including blood, breast milk, semen and vaginal fluids. It is not spread by kisses, hugs, or sharing food. It can also spread from a mother to her baby.HIV can be prevented and treated with antiretroviral therapy (ART). Untreated HIV can progress to AIDS, often after many years.WHO now defines Advanced HIV Disease (AHD) as a CD4 cell count less than 200 cells/mm3 or WHO stage 3 or 4 in adults and adolescents.

With Trump Very Productive Exchange; Putin on Talks

Moscow, (H.S): Russian President Vladimir Putin on Monday described his two-hourlong phone conversation with former US President Donald Trump as "substantive" and "productive," raising fresh hopes for a potential breakthrough in the prolonged Russia-Ukraine conflict.

The call, which focused on stalled reviving peace negotiations, marks a significant diplomatic development in the three-year-long war."This conversation has effectively taken place and lasted more than two hours. I would like to emphasise that it was both substantive and quite candid. Overall, I believe it

was a very productive exchange," Putin told the media following the conversation. The talks come amid renewed efforts by the United States to facilitate direct negotiations between Moscow and Kyiv.

While discussions between the Russian and Ukrainian sides were initially expected to resume through a high-level meeting between Putin and Ukrainian President Volodymyr Zelensky in Turkey last week, the Russian leader did not attend. Trump, who was on a tour of West Asia at the time, had signalled he might visit the summit but did not make the trip either.Putin expressed gratitude to Trump for the United



States' support in helping restart direct talks between Russia and Ukraine."The President of the United States shared his position on the cessation of hostilities and the prospects for a ceasefire. For my part, I noted that Russia also supports a peaceful settlement of the Ukraine crisis. What we need now is to identify the most effective ways towards achieving peace," he said.

The Russian President added that both leaders had agreed Russia would propose and engage with Ukraine on drafting a memorandum for a future peace agreement."This would include outlining a range of provisions, such as the principles for settlement, the timeframe for a possible peace deal, and other matters, including a potential temporary ceasefire, should the

necessary agreements be reached," Putin noted.He also noted that contact had resumed among participants of the Istanbul talks, providing some optimism that "we are on the right track overall."

Putin further reiterated Russia's stance - "eliminating the root causes of this crisis is what matters most to us."Describing the call as "highly constructive," Putin emphasised the importance of both sides demonstrating a firm commitment to peace and compromise."The key issue, of course, is now for the Russian side and the Ukrainian side to show their firm commitment to peace and to forge a compromise that would be acceptable to all parties,"

he said. Trump, in a lengthy post on his social media platform Truth Social, confirmed the details of the call, stating that ceasefire negotiations between Russia and Ukraine would begin immediately, and that the Vatican had offered to host the dialogue."

Just completed my two-hour call with President Vladimir Putin of Russia. I believe it went very well. Russia and Ukraine will immediately start negotiations toward a Ceasefire and, more importantly, an END to the War," Trump wrote.He also conveyed the results of the call to Ukrainian President Volodymyr Zelensky and various European leaders in separate communications.

Mumbai, (H.S): The Reserve Bank of India proposes to cap a single regulated entity's (RE) contribution to any Alternative Investment Funds (AIF) at 10 per cent of its corpus while collectively, a ceiling of 15 per cent will apply for investment by all REs in an AIF scheme, in the revised draft directions issued on Monday.

Regulated entities like banks, pension funds, and insurance companies often invest in AIFs for diversification. The RBI revised draft directions, aimed at tightening oversight and preventing potential misuse of the investment route, also stipulate that investments by an RE of up to five per cent of the corpus of an AIF scheme will be allowed without any restriction. However, if the investment by any RE exceeds five per cent of the corpus of the scheme, and if the scheme has a downstream debt investment in a debtor



company of the RE (excluding equity shares, compulsorily convertible preference shares, and compulsorily convertible debentures), then the RE will be required to make 100 per cent provisions to the extent of its proportionate exposure.

The proposals further state that the RBI may exempt certain AIFs, in consultation with the government, that have been set up for strategic purposes. The revised directions issued by the RBI will be applicable Existing prospectively. investments or commitments will follow the extant norms, according

to the official statement. Explaining the rationale for the new directions, the RBI said: "On a review, it is observed that the regulatory measures undertaken by the Reserve Bank earlier have brought financial discipline among the REs regarding their investment in

Besides, "SEBI has also issued guidelines requiring inter alia specific due diligence with respect to investors and investments of the AIFs, to prevent facilitation of circumvention of regulatory frameworks", the RBI statement added. The comments on the draft directions have been invited from the public/stakeholders till June 8, 2025. Comments may be submitted through the link under the 'Connect 2 Regulate' Section available on the RBI's website or may alternatively be forwarded to the Chief General Manager, Credit Risk Group of the RBI.

RBI Proposes 10 Per Cent Cap on RE Investments In AIFs India's Digital Economy Projected To Reach \$1 Trillion By 2025 End: DIPA

Govt Sees Coal Gasification As Big Step For Cleaner Fuels



New Delhi, (H.S): The Ministry of Coal has stepped up efforts to promote coal gasification as part of the government's policy to switch to cleaner fuels, greener technologies, and a long-term vision for sustainable and inclusive growth. "Coal gasification transforms solid coal into syngas - a mix of carbon monoxide, hydrogen, and carbon dioxide - unlocking cleaner fuels, chemicals like methanol and ammonia, and reducing emissions," the Coal Ministry said on Tuesday.

The Ministry sees coal gasification as "a step toward energy self-reliance and a cleaner industrial future" as it produces cleaner fuels, chemical feedstocks and lower emissions. Coal is one of the most abundant natural resources in the country. Coal gasification technology enables conversion of coal into syngas (synthetic gas), which can be used to produce downstream products like methanol, ammonium nitrate, synthetic natural gas (SNG) and fertilisers, etc. Coal gasification technology provides an alternative use of coal, promoting environmental

sustainability to align with the vision of developed India 2047, a senior official said. The government has approved an outlay of Rs 8,500 crore as financial incentive, for promotion of coal gasification projects for both government PSUs as well as private sector companies. Leading Maharatna public sector companies Coal India Limited and GAIL (India) Limited (GAIL) have signed a landmark joint venture agreement for setting up a Coal to Synthetic Natural Gas plant using surface coal gasification technology.

The plant to come up in the Raniganj area of Eastern Coalfields Limited in West Bengal is expected to produce 80,000 Nm3 per hour of SNG. The annual production is slated at 633.6 million Nm3 per hour, which will require 1.9 million tonnes (mts) of coal to be supplied by Coal India Ltd (CIL). The synergy and partnership of the two corporate giants is a big step towards achieving the goals of the National Coal Gasification Mission, which facilitates the utilisation of the chemical properties of coal. Earlier this

year, the Ministry of Coal announced that it has issued Letters of Award (LOAs) to applicants selected under Category II of the Rs 8,500 crore Coal Gasification Incentive Scheme aimed at reducing the country's carbon emissions and strengthening energy security. Jindal Steel and Power Limited's 2MMTPA coal gasification project at Angul in Odisha, has been awarded Rs 569.05 crore in financial incentives.

The Rs 3,793 crore project will convert coal into Direct Reduced Iron (DRI) through coal gasification while also setting up a carbon capture and utilisation plant designed to capture 30 TPD of CO2 for conversion into valuable products. New Era Cleantech Solution Private Limited has been given a financial incentive of Rs 1,000 crore for its coal gasification project in Bhadravati, Chandrapur, Maharashtra. Greta Energy Limited has also been awarded Rs 414.01 crore of financial incentive for its coal gasification project at Bhadravati with a total investment of Rs 2,763 crore.

and particular traders authorised New Delhi, (H.S): As part of an overall effort to bring in greater consistency between import tariffs and customs regulations, the government on Monday (May 19, 2025) allowed the import of certain types of unwrought, semimanufactured and powdered gold under particular conditions. On the other hand, it has imposed similar conditions on the import of some silver products that were earlier freely importable. According to the new restrictions, imports of these items will only be allowed through agencies nominated by either the

under the India-UAE free trade agreement. These new rules were notified by the Directorate General of Foreign Trade (DGFT) on Monday (May 19, 2025) as a modification of its import policy chapter pertaining to precious metals, stones, and pearls. When it comes to gold, several items that earlier faced a blanket restriction have now been allowed for imports under particular conditions. For example, the import of unwrought, semi-manufactured, or powdered gold containing 99.5 or more by weight of gold used to be restricted. Under the new rules, these items



can be imported by agencies nominated by the RBI, in the case of banks, or nominated by the DGFT, or by qualified jewellers as notified by the International Financial Services Centres Authority and only through the India International Bullion Exchange, or valid tariff rate quota (TRQ) holders under the India-UAE free trade agreement. On the

other hand, the import of unwrought, semi-manufactured, or powdered gold in bar form used to be freely importable. Now, the notification says the import would be "subject to RBI regulation". Govt. blames double-counting of SEZ shipments for overestimating Gold, Silver import bills According to a note by the Global Trade Research Initiative (GTRI), these changes "ensure consistency between customs duties and import regulations" and bring the rules into alignment with the changes made in Budget 2025 to enhance the transparency in the import of precious metals.

Notably, during her speech at the 16th Annual Day function of the Competition Commission of India, Ms. Sitharaman also highlighted the importance of a free and fair market in India and how this benefits the entire economy. customer-centric sectors such as aviation, telecommunications, and food delivery are either already in a duopoly structure or in danger of falling into one." In today's interconnected and fast-paced economy, delays in regulatory clearance can lead to uncertainty, disrupt commercial timelines and potentially erode the intended value of transactions and globally it has an impact, even as we negotiate

free trade agreements with different countries," Ms. Sitharaman said. "The ability, nimbleness and readiness of the regulators is very keenly watched by investors." "It is therefore imperative that regulatory frameworks, while maintaining rigorous oversight, also facilitate swift and seamless approvals for combinations that pose no harm to competition." The Finance Minister also spoke at length about the importance of fostering competition in India, with a key principle being that

"markets must work for the many and not just for the few". "A free and fair market ensures no single player can corner resources, suppress choice, or to distort price discovery," she noted. "Competition ensures the voice of consumers, that is the voice of the common people matters and therefore businesses are forced to listen."

Sitharaman's comments come at a time when several sectors are increasingly becoming dominated by just a few players. In aviation, for example, Indigo and the Air India Group together account for about 85-90% of the market share. In telecom, Reliance Jio and Bharti Airtel together make up about 77-80% of the Indian market. In food delivery, Zomato and Swiggy are the only two large players operating at a nation-wide level.

Launching a domestic Carbon Credit Market, inviting global collaboration.He also emphasized the role of the Global Biofuels Alliance in advancing cooperation in the biofuels sector and underscored India's commitment to energy efficiency through innovative programs such as the Energy Conservation Sustainable Buildings Code, rooftop solar initiatives, and efficient appliance standards.He underscored the vital role of fossil fuels in the global energy mixespecially for developing countries-and urged greater cooperation to promote their cleaner and efficient use through technologies such as coal gasification, carbon capture and storage, and green chemical innovations.

In conclusion, Sh. Manohar Lal extended an invitation to the BRICS nations to participate in the next BRICS Energy Gathering, scheduled for 2026 in India, reaffirming the country's commitment to leading the energy agenda for the Global South.The BRICS Energy Ministers reaffirmed their commitment to strengthening energy security and advancing UN Sustainable Development Goal 7 (SDG 7), focusing on universal electricity

access, clean cooking, and tackling energy poverty. They emphasized the need for just, inclusive, and balanced energy transitions in response to change.While climate acknowledging the continued role of fossil fuels-particularly in developing countries-they stressed the importance of reducing greenhouse gas emissions in alignment with SDG 7 and global climate targets guided by technological neutrality and the principle of common but differentiated responsibilities and respective capabilities (CBDR-RC). The Ministers called for

partnerships, supported open, fair, and nondiscriminatory international energy markets, and encouraged the use of local currencies in energy trade. They recognized the fundamental role of the BRICS Energy Research Cooperation Platform and welcomed the updated BRICS Roadmap for Energy Cooperation (2025-2030) as key to deeper collaboration. Affirming each country's right to determine its own energy transition path and pace, the

Ministers advocated efficient use of all energy sources and called for increased concessional and low-cost financing from developed to developing nations. They highlighted the role of the New Development Bank (NDB) in promoting sustainable infrastructure, especially through local currency financing.The Ministers advocated for adoption of fair, transparent, and consistent guidelines for assessing carbon intensity, energy classification, and mutual recognition of taxonomies and certifications.

Underscoring energy security as vital for socioeconomic development, they highlighted the importance of market stability, resilient infrastructure, diversified energy sources, and critical minerals for technologies. They clean reaffirmed the goal to double energy efficiency by 2030 and emphasized enhanced cooperation and knowledge sharing among BRICS nations. Lastly, they committed to elevating BRICS' global energy role and advancing shared priorities under India's Chairship in 2026.

UIDAI Shares Non-personal Aadhaar Dashboard Data To Promote Transparency

New Delhi, (H.S): The Unique Identification Authority of India (UIDAI) on Monday said it has begun sharing non-personal, anonymised data from the Aadhaar Dashboard on the open government data platform called data.gov.in. The move aims to further promote transparency, research, and datadriven policy making, said the Ministry of Electronics and IT in a statement. The datasets, released by Chief Data Officer (CDO) and Deputy Director General of UIDAI, include aggregated insights on Aadhaar enrolment, updates, and authentication patterns, categorised by geography, age-group and other

relevant parameters. According to the IT Ministry, by making these non-personal and anonymised datasets accessible, UIDAI aims to support academic research, innovation in digital services, and collaborative developments." This initiative opens new avenues for evidencebased policy-making and technological innovation, furthering UIDAI's commitment to transparency, public good, and secure data governance," it added. It also aligns with the broader government vision of fostering



evidence-based policy making and maximising the value of open data for the public good. It is expected to further boost digital inclusion and governance efficiency. Meanwhile, the total number of Aadhaar authentication transactions have crossed the 150 billion (15,011.82 crore) mark. Moreover, the total number of eKYC transactions (37.3 crore) carried out during April is 39.7 per cent more than the numbers during the same period last year. The cumulative number of e-KYC transactions has crossed 2,393 crore as on April 30, according to the Ministry of Electronics and IT. In April alone, almost 210 crore Aadhaar authentication transactions were carried out, nearly 8 per cent more than the same month in 2024, informed the ministry. More than 100 entities, both in the government and private sectors, are using face authentication for the smooth delivery of benefits and services.





The 29year-old, who competed at the Tokyo Olympics, is learnt to have returned positive for a anned substance when his urine sample taken out of competition earlier this year was tested. He was training at the NIS Patiala then. He has been provisionally suspended by the National Anti-Doping Agency (NADA). "Yes, he has tested positive for a banned substance. It's his second dope offence," a source privy to the development told on conditions of anonymity. The Appeal Panel, in January 2023, accepted his contention and reduced the ban period from four years to just one. He returned to action in April 2023 and won a bronze at the National Inter-State Championships in Bhubaneswar in June that year. He also won gold in the 2023 National Games in Goa.

The retirements of Rohit and Kohli leave the side without its most senior batters on the upcoming England tour, where India are scheduled to play a five-match

Test series starting on June 20. The 67-year-old former cricketer, who has coached current players like Shubman Gill and Abhishek Sharma besides his son Yuvrai Singh, added that Kohli still has more years to give to cricket.

"Rohit Sharma and Virat Kohli must return from retirement to save Indian Test cricket. This is not the time to think about themselves - it's about the nation,

the fans, and the deep emotions people have for the game. Virat still has at least ten years of cricket left in him. As for Rohit, if he comes to me, I will make sure he gets back in peak fitness," Yograj told IANS on Tuesday. The veteran cricketer said the Board of Control for Cricket in India (BCCI) must support players during their tough times so that players don't bow down to mounting pressure. "Back in 2011, players like Yuvrai Singh. Harbhajan Singh, and Virender Sehwag were dropped without any clear reason. When Yuvraj retired, I scolded him - I told him not to give in to pressure. He was, and still is, incredibly fit. Cricketers should fight for their place in the team instead of surrendering to external

Digvesh Suspended for 1 Match; Abhishek Fined for Code Breach

Lucknow, (HS):Lucknow Super Giants (LSG) player Digvesh has been fined 50% of his match fees and handed a one-match suspension for breaching the IPL Code of Conduct during the match against Sunrisers Hyderabad (SRH) at the Ekana Stadium. This marks Digvesh's third Level 1 offence under Article 2.5 this season. He received Two Demerit Points for Monday's breach, adding to the Three Demerit Points accumulated earlier - One against Punjab Kings on April 1 and Two against Mumbai Indians on April 4. Having reached a total of Five Demerit Points, Digvesh will be suspended for LSG's upcoming fixture against Gujarat Titans on May 22 in Ahmedabad. For Level 1 breaches, the Match Referee's decision is final and binding.

Hockey India Official Pakistan's Asia Cup **Participation to Follow Guidelines**



New Delhi, (HS): A top official of Indian hockey federation on Tuesday made it clear that it will follow government guidelines on Pakistan's participation in Asia Cup, which the country is hosting later this year, in the wake of the

recent military conflict between the two nations. A ceasefire was agreed upon between the two countries after days of intense cross-border hostilities in the wake of the Pahalgam terrorist attack that killed 26 people, following which the IPL too

remained suspended for a brief period.

When asked about Pakistan's participation in the upcoming tournament, Hockey India's (HI) secretary general Bholanath Singh said, "Whatever the government decides we will abide by it. Till now we didn't have talks with the government on this. "The country comes first for us. Asia Cup is happening in India, and whatever the government advises us, we will abide by that." The Asia Cup is scheduled to be held in Rajgir, Bihar from August 27 till September 7. Two days ago, a senior official in the Pakistan Hockey Federation (PHF) said it has asked the sport's

continental body to guarantee visas for its contingent to participate in the Asia Cup, which is a qualifying tournament for next year's men's FIH World Cup to be held in the Netherlands and Belgium.

Bholanath added, "I am AHF (Asian Hockey Federation) vicepresident, I am secretary general of Hockey India, but first I am a citizen of India. Whatever the country and the government decides, Hockey India will follow that. Posts are different, but country's honour comes first." Serious doubts though remain over Pakistan's participation in the Asia Cup because of the tensions between the two countries.
