SC Temporarily Halts **Deportation of** A Family to **Pakistan**



New Delhi, (HS): The Supreme Court on Friday came to the rescue of a family detained for deportation to Pakistan, after it claimed that they were holding Indian passports and Aadhaar cards. The Union government, in response to the deadly terror attack in Jammu and Kashmir's (J&K) Pahalgam, has revoked all valid visas issued by India to Pakistani nationals starting April 27 and had directed all states and Union Territories for their immediate removal. In the writ petition filed before the top court, the petitioners claimed that they are Indian nationals, and were residents of Mirpur till the year 1997 but later moved to the city of Srinagar in J&K. The family had received a notice on April 25 from the Foreign Registration Office (FRO) in Srinagar asking them to leave India on expiration of their visa on the premise that they are Pakistani nationals.Further, the lead petitioner, who obtained an MBA from IIM, Kerala and is presently working in Bengaluru, claimed that his father, mother, elder sister and younger sisters were arrested by the J&K Police illegally on April 29 at around 9 pm.The plea stated the family members were taken to the India-Pakistan Border on April 30 at around 12.20 pm and are at present being forced to leave India from the border. In an interim relief, a Bench of Justices Surya Kant and NK Singh ordered that no coercive measures be taken against the petitioners till verification of documents. "Since factual pleas raised require verification, including genuineness of documents, we dispose of the present writ petition at this

Odisha HSC Results Announced 94.93% Pass, 3,273 **Schools Score 100%**



Bhubaneswar, (DMC): The Board of Secondary Education (BSE), Odisha on Friday announced the results of the 2025 High School Certificate (HSC) examinations, with an impressive 3,273 high schools across the state achieving a 100% pass rate.

School and Mass Education Minister Nityananda Gond shared the results today, highlighting the strong performance of government schools in this year's matriculation exams. Of the 3,273 schools with perfect results, 1,802 are government high schools, 1,154 are government-aided, and 317 are unaided institutions. "Government schools have outperformed aided and unaided schools in terms of pass percentage, and notably, no school in the state recorded a zero percent result this year," Minister Gond stated.

A total of 5,02,417 students appeared for the 2025 HSC exams, with 4,84,863 successfully clearing the tests, resulting in an overall pass percentage of 94.93%. Out of them, 2,44,612 girls passed, while 2,40,291 boys passed. The pass percentage for girls

Odisha Govt Orders Inquiry Into Digha **Jagannath Temple Controversy**



Bhubaneswar, (DMC): The State Government has directed the Shree Jagannath Temple Administration (SJTA), Puri, to conduct an internal inquiry into the controversy surrounding the Digha Jagannath temple in West Bengal.

The idols of the trinity using surplus neem wood from the Nabakalebar ritual and its naming as "Jagannath Dham Digha" have sparked widespread debate and opposition. Law Minister Prithviraj Harichandan has instructed SJTA Chief Administrator Dr. Arabinda

Kumar Padhee to investigate the matter and bring the truth to light. The Minister stated that the controversy has hurt the sentiments of the Jagannathloving devotees andd the people of Odisha. The inquiry aims to identify those responsible for the incident and take necessary action, including punishment, with the permission of the state government. The government's decision comes amid growing concerns over the temple's construction and the involvement of servitors from Puri in the

UGC Constitutes Fact-Finding Committee to Investigate Student Suicides at KIIT

Bhubaneswar, (DMC): University Commission (UGC) has formed a Fact-Finding Committee to investigate the recent student suicides at Kalinga Institute of Industrial Technology (KIIT), Bhubaneswar. The committee, chaired by Prof. Nageshwar Rao, former Vice Chancellor of Indira Gandhi National Open University (IGNOU), will examine the circumstances surrounding the incidents and suggest measures to prevent such incidents in the future. The committee members include Prof. Shashikala Wanjari, Vice Chancellor, National Institute of Educational Planning and Administration (NIEPA), Prof. HCS Rathore, former Vice Chancellor, Central University of South Bihar, Dr. Sunita Siwach, Joint Secretary, University Grants Commission, as the coordinating officer. "In view of the two consecutive suicide



Industrial Technology (KIIT), Bhubaneswar on February 16, 2025 and May 1, 2025, the University Grants Commission (UGC), as the regulatory body, has decided to constitute a factfinding committee to examine the circumstances surrounding these incidents and ensure compliance with student welfare and safety regulations and further suggesting measures to prevent such incidents," read an order issued

The panel will also engage

The UGC has directed the committee to submit a detailed report with findings and recommendations within 10 days. The UGC's decision comes after two consecutive student suicides at KIIT, one on February 16, 2025, and another on May 1, 2025. Pahalgam attack planned by LeT with ISI, Pak Army help: NIA

New Delhi, (HS): The National Investigation Agency (NIA) has, in its preliminary report, confirmed the involvement of Pakistan-based terror group Lashkar-e-Taiba (LeT), the Inter-Services Intelligence (ISI), and the Pakistan Army in the April 22 Pahalgam terror attack that claimed 26 lives, sources said on Friday. The federal anti-terror agency has identified around 20 overground workers (OGWs) from the Kashmir Valley who allegedly provided logistical support to the attackers. These individuals are currently being interrogated, the sources added. The NIA is also preparing to

According to officials, the duo are known LeT associates and were earlier arrested for aiding terrorists involved in the 2023 attacks on Army convoys in Bhata Dhurian and Totagali. As per the NIA's findings, the Pahalgam attack was planned by the LeT with active support and direction from Pakistani state actors, including the ISI and the Army. Two prime suspects -Hashmi Musa alias Suleman and Ali Bhai alias Talha Bhai - have been identified as Pakistani nationals who were in constant



communication with handlers across the border, receiving

instructions on logistics, timing,



and execution. Investigations revealed that the attackers infiltrated weeks before the



assault and were supported by a network of local OGWs who provided them with shelter,

conducted reconnaissance, and facilitated movement. Sources said the terrorists reached Pahalgam around April 15 and surveyed four potential sites -Baisaran Valley, Aru Valley, Betaab Valley, and a local amusement park. They ultimately chose Baisaran due to a thin security presence. The NIA has recovered over 40 cartridges from the site, which have been sent for ballistic and chemical analysis. Investigators also conducted 3D mapping of the area and extracted tower dump data from nearby mobile towers.

A source said, "Satellite phone activity in the region

spiked in the days leading up to the attack. At least three satellite phones were operational in and around Baisaran and signals from two have been traced and analysed."So far, over 2,800 individuals have been questioned. More than 150 remain in custody, including suspected OGWs and persons linked to banned groups such as Jamaat-e-Islami and various Hurriyat factions. The agency is also reviewing CCTV footage from transit points and public locations in and around Pahalgam, as well as data from regional security checkpoints to track movement patterns.

When Justin Trudeau resigned as Prime Minister of Canada in January amid plummeting approval ratings, many considered the Liberal Party dead and buried ahead of general elections in that country. His replacement, Mark Carney, an unelected former central banker, faced the formidable task of rescuing a flailing economy and reviving a fractured party. Then came Donald Trump. As the US President began his second term, Canadian political discourse pivoted towards national pride in response to Trump's provocations, which included a suggestion to annex Canada as the 51st American state and a wave of new tariffs. These developments rallied Canadians and gave Carney a platform. Riding a wave of anti-Trump sentiment, he has led the Liberals to a surprising, albeit narrow, electoral victory.

Carney may have emerged as the face of the Liberal Party's resurrection, but his challenges are far from over. He must now confront serious economic headwinds and navigate an increasingly unpredictable global landscape shaped by Canada's southern neighbour. For India, a significant aspect of the election was the downfall of Jagmeet Singh, leader of the New Democratic Party (NDP), who lost the parliamentary seat he had held since 2019. The NDP supported Trudeau's minority government from 2021 to 2024, but this time failed to meet the 12-seat threshold required for official party status. With both Singh and Trudeau now relegated to a back seat, Carney's election offers a potential reset in India-Canada relations, which have been strained for oneand-a-half years after Trudeau's unsubstantiated allegations against India over the killing of Khalistani separatist Hardeep Singh Nijjar. Nearly two million people of Indian origin live in Canada, and over four lakh Indian students currently study there. Beyond strong people-to-people ties, key sectors of collaboration include pharmaceuticals, agri-tech, energy and climate change mitigation. Notably, trade between the two countries has remained largely unaffected by the diplomatic fallout. Canada has identified India as a critical regional partner in its Indo-Pacific Strategy, citing a shared interest in countering China's expanding influence. Carney's election, therefore, is an opportunity for renewed cooperation provided Canada is willing to address India's legitimate security concerns on the Khalistan issue. He has already signalled his intent to "rebuild" ties with India, calling the relationship "incredibly important". Whether his government can go beyond the diplomatic gridlock of the Trudeau era and forge a meaningful alliance remains to be seen.

Constitution Memorial Day



 \mathbf{T} here's no doubt that violence and war have taken away too much, and this is why we take a moment to ponder life during Japan's Constitution Memorial Day on May 3. Sociopolitical rifts cause too much loss, no matter what side of the conflict you're on. Japan's case is no different. Not only did the country inflict violence on other nations, but it also suffered gravely in return. Japan woke up one day to the loss of its cities, Hiroshima and Nagasaki - with many families torn apart, children orphaned, family members missing or (assumed) dead. The U.S. attacked the two cities with atomic bombs successively. Around 226,000 were killed, most of whom were mere civilians. After facing unprecedented losses, Japan surrendered in 1945, building a new constitution that would focus on civilian's welfare and peace.

Japan's Constitution Memorial Day is held every year on May 3. It is a national holiday and it is the second day in the Golden Week of Japan. Memorial Day is special because it celebrates the new constitution that was drafted and brought into legislation after Japan's emperor, Emperor Showa, surrendered to the Allied Forces, namely the U.S., in 1945. It took a period of two years for the new constitution to be finalized and ratified. Finally, on May 3, 1945, the new constitution replaced the older one, which was known as the Meiji Constitution. The Meiji Constitution put much emphasis on conquering other nations through violence and war. It did not have much regard for its civilians and their well-being. On the other hand, the newer constitution focused on upholding the sovereignty of its people, protecting them, and resolving any international conflicts without the use of weapons. The people of Japan also favored democracy as it would allow them to not only choose their own leaders but also choose those sets of principles that served them and their

future generations well. Originally, Constitution Memorial Day was meant to be commemorated on November 3 as that was the day when the new constitution was finalized. Many people lobbied for November 3 but it was not chosen because this was also the day when the war crime trials of imperial officers began. Thus, May 3 was finally chosen as it also happened to be the day on which the new constitution replaced the older one. As May 3 is a public holiday, many people also visit the constitution building to take pictures and experience the history. This is the only day when the building and the constitution documents are open to the public.

Demystifying the American bond market crisis

The world in the current phase is at the edge of chaos. It all happened With the onset of Covid Pandemic, then the Russia-Ukraine war, and thereafter the Israel-Palestine war and currently, the Trump's reciprocal tariff, and China's retaliatory tariff and a full blown trade war. Patiently observing the situation and examining them and reflecting on that leads to a conclusion that the international macroeconomics is entering into an age of turbulence and uncertainty, and has entered in to an interesting phase, in the post world war 2 period. At a time, when the benefits of the limited growth is growing unevenly across the globe, the trade war has pulled the curtain on globalisation, with uncertainty hovering around the corner. Emerging economies and markets are at a loss, and low income groups have lost hopes. It is a truism that in an interconnected world of anemic growth, this, may lead to the growth of terrorism, income inequality, rabid protectionism, and rampant isolationism.

The US treasury, like India's RBI, as the monetary authority in case of India, offers for sale of various securities of different maturities with different rates, to provide funds to the government coffers. This Is christened as the government's borrowing

the borrowing creates a debt burden on the government, and the same is administered by the RBIBefore entering into the dynamics of the American treasury and the bond market fiasco let us first try to understand the bond dynamics in an example. It is a well settled norm that when the bond prices goes down, the yield on bond increases. When bond prices goes up, the yield get reduced and it's an inverse equation. For example, all securities have a face value of Rs 100 and they carry a fixed coupon rate of interest. Suppose, rs 8.58 2030,a bond is issued at a coupon rate of interest of 8.58%. Where 2030 is the end of the term of payment and it applies an interest of 8.58%. If kept up to maturity, then the interest is paid. Suppose on behalf of the treasury, interest is paid on yearly basis and the last amount of interest and principal is paid in the last. Upon maturity, it happens that, presuming the fact that the one is kept till maturity. However the bond holder has the option to sell it at any point of time, depending upon his requirement. In the instant case, this security, the bond, is traded in the market, market conditions apply, with interest rising to 8.75% then the bond price will go down by 2 rupees that the bond value shall be Rs 98 instead of Rs 100.

US treasury bonds are one long term government debt securities issued by the US department of treasury to finance government spending. This works as a benchmark or reference point for many treasuries across the world. The type of treasury securities are treasury bills which are short term securities spanning between 4 weeks to 52 weeks. Medium Term securities are treasury notes with a term of 2,3,5,or 10 years. The bonds are long term securities with term ties of 20 to 30 years, and treasury



inflation protected securities are inflation indexed with maturities of 5,10,30 years, that is a protection against inflation. The beauty of the bonds are that they are low risk government securities. with promise of fixed income and there is an inbuilt liquidity attached to it. The US bond crisis arose after April 7th,, when Trump increased the tariff on liberation day, April second. There was a prompt knee jerk reaction and there was massive sell off in US bond market, which was faltering. Bond prices fell down with yield skyrocketing creating a pressure on government revenues. This led Trump to pause tariffs for a period of 90 days. It was not just about the falling bond market, but the bond market dynamics that became a decisive factor. The index fell bout 20% from February25. the bond yields was rising. The American treasury, sold some 58 billions 3 year bonds. with rising yields and falling bond prices, there was not enough buyer in the market and the government sinks and the fed had to absorb the remaining unsold amount. A crisis like the SPV crisis was looming large on the horizon. That means, American bond which was the darling of the world market and in particular the sovereign government could not generate enough interest to participate. This was a tremendous shift. Japan's the top holder of US bonds, amounting 1.08 trillions, then

China with 670 billions invested in US bonds.uK remains 2 nd with 740 billions. Bond prices rose on April 1st and yields fall just before the liberation day on 2nd April. Then the bond yields fell from 4.1% to 3.8%. From April 8th the bond prices started to fall. There is technical reason for the same as per the experts. The large hedge funds. There is a technical reason behind the same. The large hedge work with borrowed funds. When market plummeted fron April 1 to April 7 this funds get a margin call due to excessive volatility, leading to sell, as a result of which the bond prices fell with the yields rising. The Conspiracy theory also speaks that countries like China, who have substantial exposure to US bonds tried to put pressure on sellingUS one's, that would have further exacerbated the problem. Japan and other countries also sold US treasuries. With high yield inflation was raising its ugly head for which Jerome Powell, the fed chairman, remarked let us not meddle with treasury. It S corporate bonds, which are better priced than the sovereign bonds, also observed that the funds for the corporate market are drying up. There we're no buyers. If the bond market would have crashed, then there would have been an immediate impact on the American treasury, inflation, stock market and the world economy, when one analyses the larger picture, like the

SPV crisis There could have been a liquidity crisis of immense proportion as crisis was looming and confidence in the market economy was ebbing. Hence, Trump said that the bond market is very tricky and complex for which he had no alternative but to cautiously suspended the tariffs for a temporary period of 90 days, sans China. Even some experts said that if the bond market would have felled then that would have necessarily the end of dollar as a reserve currency. Dedollarization, it appeared was coming automatically. This led to pupressure in Trump's otherwise tempestuous stiff programme and consequent trade war. This deescalated the tension to some extent. Ernst and young speaks that there may be a 0.8% gdp growth this year. Indian rupee which continuously remained depreciated has shown some signs of resilience, as previously, the dollar was strengthening and now Rupee is strengthening.

This imperative for fulfilling human demands and improve social life. And that has been going on; people have said you must change, you must act, you must change your mind, your heart, you must be something totally different. This has been preached for thousands of years by men who were serious, very earnest, as well as by charlatans who were out to exploit people. And we have reached a point when we have no time at all. Please understand this. We haven't time to make this change gradually. Intellectuals throughout the world have realised this, that man is on the edge of a precipice, that he is going to destroy himself. No religions, no gods, no saviours, no masters and all the nonsense of gurus, are going to prevent it. Intellectuals say we must invent a new, golden drug that will bring about a complete chemical change; and scientists are probably going to find such a drug.

Now although the whole physical organism is a biochemical result, can a super drug make you love, make you kind, generous, gentle, nonviolent? I do not think so; a drug cannot make one human being love another. Love is not a product of thought. Love is not something which can be cultivated as you would cultivate a flower in a garden. Love cannot be bought in a drugstore and love is the only thing that is going to save man, not all the religious tricks, neither the rituals nor the army.

One may escape to concerts, museums, to various kinds of entertainment – all to no avail for man is now facing a tremendous problem; whether he can radically change, bring about a total mutation in his whole consciousness, not tomorrow, nor a few years hence, but now! That is the main issue; whether man, whatever country he inhabits, with all the beauty of the land, can bring about such a radical mutation within himself immediately. That is the problem, not your beliefs, ideologies, gods, saviours, priests and rituals; they no longer have any meaning. So, during these talks, if you are at all serious, we are going to try to find out if it is at all possible for man – that is you and I - tochange our whole way of thinking, our whole way of living, not verbally, not intellectually but actually, because life is relationship; and without relationship, there is no life. This applies even to the monk in his monastery, which is really a mode of escape; even he is related.

Relationship means life, and when there is conflict in that relationship, whether it be within yourself, or with your husband, your wife, your neighbour or with anybody, then life becomes a battlefield. Everybody is responsible for war because we are human beings and we have created wars; that's part of our life. And to say the Americans are dreadful people, violent people – well, so are you! You don't feel this responsibility at all!



Threat of Indian strike empties a scenic valley in Pakistan-**Occupied Kashmir of** summer tourists



MUZAFFARABAD, (HS): Neelum Valley in Pakistan-Occupied Kashmir attracts some 300,000 tourists each summer who marvel at its natural beauty. But the threat of war with India has emptied its hotels.Terrorists last week killed 26 tourists in the Indian resort town of Pahalgam, fueling tensions between the nuclear-armed nations after India blamed Pakistan for the attack, a charge Pakistan denies

Neelum Valley is less than 3 kilometers (1.8 miles) from the Line of Control, the de facto border that divides the two nations, making it vulnerable to any military activity. Hotel owner Rafaqat Hussain said Thursday the crisis has hit the tourism industry hard. "Most tourists have left and returned to their cities because there is a risk of war." Authorities in Jammu and Kashmir temporarily shuttered 48 tourist resorts following the attack as a precaution. No such order has come from Pakistani authorities. Bazaars in the Pakistani border town of Chakothi were open for business, although people were concerned. "First of all, our prayer is for peace, as war always affects civilians first," shop owner Bashir Mughal told The Associated Press, saying he would fight alongside the army in the event of conflict.

Pakistan used to help residents to build bunkers near their homes during periods of intense cross-border firing. But the population has grown and some homes lack shelters. "Local casualties could be devastating if war breaks out," Mughal warned. Saiqa Naseer, also from Chakothi, shuddered at the childhood memories of frequent firing across the border. "Now, as a mother, I find myself facing the same fears," she said. She remembered Indian shells striking the picturesque valley when the two countries came close to war in 2019. She has a bunker at her home. "If war comes, we will stay here. We won't run away," she said.

4 killed, 12 injured as pickup van overturns in MP's Vidisha

Vidisha, (HS): Four people died while 12 others sustained injuries after a pickup van carrying Baratis overturned in Madhya Pradesh's Vidisha district, an official said. The accident occurred near Aari Ghat under Lateri police station in the district at around 10 pm on Thursday. Sixteen people were travelling in the vehicle to attend a wedding ceremony in Sironj in the district of Indore from Mhow. While returning from here, the driver lost control and it overturned, the police added. Upon receiving the information about the incident, the police reached the spot and sent the injured to the hospital. Three people died on the spot,



and one more died on the way to the hospital. Additional Superintendent of Police (ASP), Prashant Chaubey said, "A pick up van carrying 16 people overturned near Aari Ghat, Lateri at around 10 pm on Thursday, in which four people died and 12 others sustained injuries. They came here in Sironj in the district as a part of a wedding procession from Indore's Mhow.

Assam: Voting starts for first phase of Panchayat polls

Guwahati, (HS): The voting has started for the first phase of panchayat polls in 14 districts of Assam on Friday. Long queues of voters were visible in most polling stations on Friday morning. The first phase of the panchayat elections is being held in 14 districts of the state: Sonitpur, Biswanath, Dhemaji, Lakhimpur, Tinsukia, Dibrugarh, Sivasagar, Charaideo, Jorhat, Majuli, Golaghat, Cachar, Hailakandi, and Sribhumi. The Assam State Election Commission has made all arrangements to conduct a free and fair election. Security personnel have been deployed in each polling station. The second phase of the polls will be held on May 7 in the remaining 13 districts, and the counting of votes will take place on May 11. More than 1.80 crore voters, including 90.71 lakh male voters, 89.65 lakh female voters and 408 other voters, will exercise their franchise in 25007 polling stations in both phases. The Bharatiya Janata Party (BJP)-led National Democratic Alliance (NDA) already secured 37 Zila Parishad seats - 35 by the BJP and two by Asom Gana Parishad (AGP). The NDA has also secured 288 Anchalik Panchayat seats (259 by BJP and 29 by AGP) unopposed. Earlier, Assam State Election Commissioner said that an adequate number of security personnel will be deployed, along with over 1.20 lakh polling personnel, to ensure the smooth conduct of the election. On April 18, Assam Chief Minister Himanta Biswa Sarma expressed confidence that the BJP-led National Democratic Alliance (NDA) is poised to sweep the upcoming panchayat polls in the state. "The NDA has already secured 37 Zila Parishad (35 BJP and 2 AGP) and 288 Anchalik Panchayat (259 BJP and 29 AGP) seats unopposed. This is a massive and unprecedented mandate in Assam's political history. It reflects the immense trust and overwhelming love that the people of Assam have for the NDA and for our Prime Minister, Narendra Modi," the Assam CM said

"Employee Has No Right to be Promoted, But Considered": SC

New Delhi, (HS): The Supreme Court on Friday said while an employee did not possess a right to promotion, they had the right to be considered for promotion unless disqualified. A bench of Justices Sudhanshu Dhulia and K Vinod Chandran was dealing with an appeal filed by a police constable in Tamil Nadu who was aggrieved by the denial of consideration of promotion for the sub-inspector's post. "It is trite that the employee has no right to be promoted but has a right to be considered, when selections for



promotions are carried out, unless disqualified; which right has been impinged, unjustly, in the above case," it said. The top court observed he had faced both departmental and criminal action for allegedly thrashing a colleague during their posting at a check post. While in the criminal case, the appellant was arrested but acquitted later, the government set aside the punishment stemming from the departmental proceedings in 2009, it noted.

However, the superintended of police said the appellant was not considered for promotion since he was disentitled in line with the rules for reason of a punishment of postponement of next increment for one year without cumulative effect, imposed in May 2005. The appellant's punishment, the bench said, was interfered with and was set aside in November 2009. "In such circumstances, the appellant could not have been disentitled from a consideration in the year 2019," the bench's verdict said. It added, "In the above circumstances we are of the opinion that the appellant must be considered for promotion, dehors any disentitlement due to his having become overaged." The consideration will be made and if found eligible, he shall be promoted from 2019 and consequential benefits shall also be paid to him, since it was not his fault that the authority denied his consideration for promotion based on a punishment which was already set aside, the bench said. The bench allowed the man's appeal challenging an order of the Madras High Court passed on October, 2023, dismissing his plea to consider him for promotion as an in-service candidate.

The top court said he was initially appointed in March 2002 and was eligible for consideration in 2019 when a notification was issued for considering eligible constables for in-service promotion in 20 percent departmental quota.

Manipur tightens security ahead of second anniversary of ethnic violence

GUWAHATI, (HS): Security has been heightened in Manipur on the eve of the second anniversary of the state's

Police have intensified the frisking of vehicles at key locations in the Imphal Valley, Churachandpur, and Kangpokpi districts in an effort to thwart any untoward incidents, officials said. Kuki-Zo organisations will observe May 3 as "Separation Day," while two student organisations from the community have called for a shutdown of all educational institutions, shops, and commercial establishments in Kuki areas on that day. In the Meitei-majority Imphal Valley, the Coordinating Committee on Manipur Integrity will organise a people's convention, where civil society leaders, scholars, eminent personalities, and internally displaced people will deliver speeches. A candlelight tribute will also be held to honour the victims of the conflict. Meanwhile, the Thadou Inpi Manipur, the apex body of the Thadou community, has appealed to the public to collectively observe May 3 as



different communities commemorating it in an antagonistic and communal manner. "As we observe May 3 this year and pray for peace, we honour the memory of those who have fallen victim to the tragic violence and extend our deepest empathy to the survivors and their families," the tribal organisation said in a statement. The ethnic violence erupted on May 3, 2023, following a

by tribals protesting the state government's alleged move to grant Scheduled Tribe status to the majority Meitei community. The violence left over 250 people dead and displaced around 60,000 others. A large number of the displaced remain in relief camps, as the state continues to be ethnically divided. Meiteis and Kuki-Zo tribals are still unable to enter each other's areas.

On March 8 this year, the Centre made an attempt to ensure "free movement," despite opposition from Kuki-Zo tribals. A state-run bus was operated, but protestors attacked it in Kangpokpi district, triggering violence that left one person dead and several others injured.

President's Rule was imposed in the state on February 13 this year after the BJP failed to reach a consensus on a successor for N. Biren Singh, who stepped down as Chief Minister on February 9 - a day before his government was scheduled to face a noconfidence motion and a floor test. Recently, 21 ruling NDA MLAs wrote to Prime Minister Narendra Modi and Union Home Minister Amit Shah, demanding the immediate installation of a "popular government" in the state. They said that while people initially welcomed President's Rule with high expectations, even after more than two and a half months, there have been no visible steps to restore peace and normalcy.

Delhi court issues notice to Sonia Gandhi, Rahul Gandhi

New Delhi, (HS): A Delhi court

on Friday issued notices to Congress leaders Sonia Gandhi and Rahul Gandhi in the National Herald money laundering case, marking a rare instance where the accused will be heard before the court considers taking cognisance of the charges. Special Judge (PC Act) Vishal Gogne of the Rouse Avenue Court also issued notices to senior Congress leader Sam Pitroda, Suman Dubey, Sunil Bhandari, and the companies Young Indian and Dotex Merchandise Pvt Ltd, all named in the Enforcement Directorate's (ED) prosecution complaint. The judge said that those named by the ED have the right to be heard before cognisance is taken. He described this right as a "crucial part of ensuring a fair trial." During the hearing, Additional Solicitor General SV Raju, appearing for the ED, cited a previous case in which no notice was issued before summons, resulting in the Supreme Court staying the proceedings. In contrast, he supported issuing notice in the current case in line with Section 223, as interpreted in the Tarsem Lal judgment.

lows after former prime minister Sheikh Hasina fled to India seeking asylum and India's concerns of allegedly targeted attacks against Hindu minorities in the country. Tensions also seemed to have

undergone a strain hen Muhammad Yunus commented on India's northeastern states during his visit to China in March. "The seven states of India, the eastern part of India, are called the seven sisters. They are a landlocked region of India. They have no way to reach out to the ocean," Yunus said. He called Bangladesh the "only guardian of the ocean" in the region and said this could be a massive opportunity, an extension of the Chinese economy.

The remark was condemned by several leaders from India's ruling party, the BJP. India's external affairs minister S Jaishankar's comment in April during a foreign minister's meeting of BIMSTEC seemed like a riposte to Yunus's suggestion.

SC Refuses to Entertain Fresh Plea Against Waqf (Amendment) Act

New Delhi, (HS): The Supreme Court on Monday refused to entertain a fresh petition challenging the recent amendments to the Waqf Act, 1995. A bench, headed by CJI Sanjiv Khanna, told the petitioner that it cannot deal with hundreds of petitions on the same issue and that the petitioner may choose to file an intervention application in the petitions challenging the Waqf (Amendment) Act, 2025, if so advised. The CJI Khanna-led Bench, on April 17, the previous date of hearing, decided to treat five writ petitions as lead cases and said that other pleas will be treated as intervention applications. Further, it ordered the apex court registry to rename the cause titles of the proceedings as "In Re: The Waqf (Amendment) Act, 2025"

The Bench, also comprising Justices Sanjay Kumar and K.V. Viswanathan, granted a week's time to the Centre and state governments and the Waqf Boards to file their preliminary reply. During the course of the hearing, the Union government assured the Supreme Court that it would not de-notify provisions related to 'waqf by user' or include non-Muslim members in the Waqf Board. Posting the matter for further hearing on May 5, the apex court said that the hearing fixed on the next date will be a preliminary hearing and, if required, interim orders will be passed. In its preliminary affidavit, the Centre said that it brought amendments to prevent abuse of waqf legislation, which resulted in the encroachment of government properties, apart from ensuring that the Waqf Boards in the country are properly administered and function with transparency. "It is submitted that there have been reported misuse of waqf

provisions to encroach on private properties and government properties. It is really shocking to know that after the amendment brought in the year 2013, there is a 116 per cent rise in auquaf area," the Union Ministry of Minority Affairs said. The Centre, in its reply document filed before the top court, said that it was found that most of the Waqf Boards have been functioning in the "most nontransparent manner" and have either not uploaded the details in public domain or have uploaded partial details. The Union government said that under the old regime, due to the absence of adequate safeguards, government properties and even private properties were declared as waqf properties. "The provisions of Sections 3A, 3B and 3C take care of the said situation which has been prevailing since several decades. It is submitted that there are startling examples whereby the government lands or even the private lands were declared as waqf properties," it said in the affidavit. The Union government said that the Waqf (Amendment) Act, 2025, was passed with the objective of modernising the management of waqf properties in India through transparent, efficient and inclusive measures. It argued that the reforms introduced are directed solely at the secular and administrative aspects of waqf institutions - such as property management, record-keeping, and

governance structures - without impinging upon any essential religious practices or tenets of the

The preliminary reply document filed by the Union government said that before introducing the Waqf (Amendment) Act, 2025, there has been a detailed executive level and Parliamentary level exercise in order to understand the problems plaguing the previous statutory regime, the consequences, and the appropriate measures that were required to remedy the same. The Centre contended that the "primary religious right being the right to make a dedication is not interfered with, and neither is the administration of any specific waqf interfered with as the same continues to be vested with the mutawalli as per the purpose behind such waqf".

Wagah Border To Remain Open For Our Citizens Returning From India: Pakistan Foreign Office

Islamabad, (H.S): Pakistan has announced to keep the Wagah Border crossing open for its citizens returning from India after New Delhi revoked their visas following the terror attack in Jammu and Kashmir's Pahalgam that claimed 26 lives. The decision comes after many Pakistani nationals in India were stranded on the Indian side of the border in Attari

stated the Pakistan Foreign Office." The Indian decision to revoke visas of Pakistani citizens is creating serious humanitarian challenges, the Foreign Office maintained.

India and Pakistan announced the cancellation of visas of each other's nationals, as part of a response after the Pahalgam terror attack and escalating tensions. After India cancelled all visas issued to Pakistani citizens with immediate effect and put a deadline of April 30 for them to return to Islamabad, the move was reciprocated, leaving hundreds of families on both sides in a rush to cut short their stays and pack up to leave the

Reports revealed that many Pakistani families, who had travelled to India for medical treatment, had to return in these circumstances, while many others are still stranded on the Indian side of the border.A Pakistani family that travelled to India for the heart treatment of their two children had to return without receiving the medical care, media reports said." My children are

innocent in this situation. We had to return to Pakistan without the medical treatment for my two sons, who need treatment urgently. I appeal to the Pakistan government to arrange the treatment in another country," said Shahid Ali, father of the two ailing sons."They have a heart condition, and their treatment was possible in New Delhi because of the advanced medical treatment facilities there.

But after the Pahalgam incident, we were told to return to Pakistan immediately," he added. Moreover, many Pakistani nationals who married in India are forced to be separated from their families. In many cases, one of the parents, who is a Pakistani national living in India, has to return without family due to the orders of both governments. As per reports, there are thousands of Pakistani nationals still present in India who are trying to return to Pakistan.

Bangladesh: ICT Issues Show Cause Notice To Hasina for genocide, crimes against

Dhaka, (H.S): The International Crimes Tribunal (ICT) of Bangladesh on Thursday issued a show-cause notice to former Prime Minister Sheikh Hasina and Shakil Alam Bulbul, a leader of Bangladesh Chhatra League (BCL) - the banned student wing of Awami League - in an alleged contempt of court case

Local media reported that ICT Prosecutor Gazi MH Tamim has instructed both individuals to respond to the show cause notice by May 15.The tribunal, headed by its Chairman Justice Golam Mortuza Mozumder, passed the order on the content of a viral audio clip leaked on social media that featured the former Prime Minister, through which she allegedly interfered in the judicial process and issued threats to the tribunal."The investigation agency conducted forensic tests and confirmed the voice belongs to Sheikh Hasina," the ICT prosecutor said. The Muhammad Yunus-led interim government has



issued several arrest warrants against the former PM, her family members, and the Awami League supporters after coming to power in August, last year.Last month, a tribunal of Bangladesh issued an arrest warrant against Hasina and four others, including former Inspector General of Police (IGP) Benazir Ahmed, for an alleged mass killing at Shapla Chattar in Dhaka in 2013.

In January, a special tribunal in Dhaka ordered an arrest warrant for former Prime Minister Hasina and 11 other people over incidents of enforced disappearances. Ironically, the tribunal was established by the government led by Sheikh Hasina under the International Crimes (Tribunals) Act to provide for the detection, prosecution and punishment of persons responsible

humanity, war crimes and other crimes under International Law committed by the Pakistani Army, with the help of their local collaborators, in the territory of Bangladesh during the 1971 Liberation War. Analysts reckon the developments as a major political vendetta being pursued by the interim government led by Yunus as several cases were filed against the former PM and her supporters on frivolous grounds immediately after her ouster in August 2024. A leading voice in the struggle

to restore democracy in the country, Hasina, the daughter of Bangladesh's founder Sheikh Mujibur Rahman, had to flee the country in an ignominious manner and seek refuge in India on August 5. While addressing the Awami League supporters online from India in February, the ousted Prime Minister accused the Yunus-led interim government of turning the nation into an alleged hub of "terrorism" and "lawlessness".

653 Survivors Saved By Rescuers in Myanmar Earthquake



Yangon, (H.S): A total of 653 survivors have been rescued by emergency teams following Myanmar's 7.7-magnitude earthquake, the state-owned daily Myanma Alinn reported on Friday. Both local and international rescue teams carried out search and rescue operations. They were also able to retrieve 779 bodies as of Thursday, the report added. A 7.7-magnitude earthquake struck Myanmar on

As of May 1, the disaster has claimed 3,835 lives and injured 5,105 people, with 105 others still unaccounted for, Xinhua news agency reported. Myanmar has experienced a total of 157 aftershocks following the devastating 7.7 magnitude earthquake on March 28.The aftershocks ranged from magnitude 2.8 to 7.5, the department said. More than 200,000 people have been displaced after a powerful 7.7 magnitude earthquake struck central Myanmar on March 28, according to the country's National Disaster Management Committee (NDMC). At the committee's third meeting of the year, held on Friday in Nay Pyi Taw, NDMC Chairman Vice Senior General Soe Win said the earthquake caused widespread destruction across 10 regions and states, including Nay Pyi Taw, Sagaing, Mandalay, Bago, Magway and Shan.The earthquake destroyed or damaged over 63,000 homes, 6,700 schools, 5,400 monasteries, 5,300 pagodas, and hundreds of other religious buildings, hospitals, bridges, roads, and dams, he said.

International medical teams, including 337 foreign personnel, have set up temporary hospitals in the worst-affected areas and are providing care alongside local health workers. Following a request for international assistance by the Myanmar government, 2,095 rescue workers from 26 countries and regions

have arrived in Myanmar, bringing over 3,800 tonnes of relief supplies using 147 planes, seven ships, and 23 vehicles, he added. Authorities are inspecting damaged buildings using a colourcoded system - blue, orange, and red - to assess structural damage and guide repairs. Temporary housing, including bashas and modular shelters, is being built for displaced staff and residents, while plans are underway to reconstruct homes using earthquake-resistant designs based on soil testing and faultline assessments.

Under 'Operation Brahma', India was the first responder to the earthquake-hit Myanmar and has provided relief supplies of over 750 MT including essential medicines, food grain, ready-to-eat meals, tents. blankets, gensets, rapidly deployable surgical and medical shelters, water sanitation and hygiene services, drinking water, essential clothing, prefabricated office/residential structures, etc.

US Judge Asks Government To Answer Questions on Indian Academic's Detention

New York, (H.S): A judge has given the US government a day's notice to come up with answers regarding the detention of an Indian academic whose deportation was temporarily blocked. Federal Judge Patricia Tolliver Giles on Thursday ordered government lawyers to explain why Badar Khan Suri was moved from a detention facility in Virginia, where he lives, to Louisiana and to Texas after his arrest in March.

Immigration authorities want to deport him because they allege that he has links to Hamas, which the US has declared is a Palestinian terrorist organisation. He is a postdoctoral fellow at Georgetown University in Washington. Giles, who had earlier stayed his deportation, was hearing an appeal by Suri's lawyers to bring him back to Virginia and stop his deportation. US V-P Vance Hopes Pakistan Will Cooperate With India on Probe in Pahalgam Terror Attack



Washington, (H.S): US Vice-President J.D. Vance has said that the US hopes that Pakistan would cooperate with India to hunt down the Pakistan-based terrorists responsible for the terror attack in Jammu and Kashmir's Pahalgam last month."Our hope here is that India responds to this terrorist attack in a way that doesn't lead to a broader regional conflict," Vance said on Thursday in an interview on Fox News' "Special Report with Bret Baier" show."

And we hope, frankly, that Pakistan, to the extent that they're responsible, cooperates with India to make sure that the terrorists sometimes operating in their territory are hunted down and dealt with," the Us Vice-President added.During the interview with Fox News, Vance made his public remark on the attack, which left 26 people dead. Vance and his family was in India on a four-day visit when

the carnage - the worst since the Pulwama attack on CRPF personnel in 2019 - took place.The Vice-President's remarks assume significance amid rising tensions between India and Pakistan in the aftermath of the Pahalgam attack. Vance, who was in India last month, had then condemned the attack and expressed solidarity with the victims and their families in a post

The Pahalgam attack, which claimed the lives of 25 tourists and one local, was one of the deadliest attacks on civilians in the Kashmir Valley in recent times. The terrorists had planned the attack on a scenic meadow which required hiking or using a pony service to get to the spot. US Secretary of State Marco Rubio spoke with External Affairs Minister S. Jaishankar and Pakistan Prime Minister Shehbaz Sharif on Wednesday, amid escalating tensions between the

two countries following the Pahalgam terror attack that claimed 26 lives.Rubio asked Pakistani officials to cooperate in the investigation and work to deescalate tensions between them.In his first public remarks on the attack, Home Minister Amit Shah on Thursday said that India will give a fitting and precise response to every act of terrorism. Sending a strong warning to terrorists. Amit Shah said, "If anyone thinks that a cowardly attack is their victory, they must remember this is Narendra Modi's India - and revenge will be taken, one by one."Prime Minister Narendra Modi has vowed to "pursue" the perpetrators and their backers "to the ends of the earth".

India downgraded its ties with Pakistan following the Pahalgam attack and took several diplomatic measures, including the pausing of the Indus Waters Treaty, expelling all Pakistani military attaches, closing its airspace to Pakistani airlines and the shutting down of the Attari-Wagah border. In response, Pakistan undertook titfor-tat measures and suspended the Simla Agreement. India on Thursday relaxed its deadline allowing Pakistani nationals to return to Pakistan via the Attari-Wagah border. But, Pakistan has not yet reciprocated with the same measure by allowing Indian nationals into the country.

Coal Production From Captive, Commercial Mines Shows Robust Growth In April

New Delhi, (PIB): Coal production from captive and commercial mines in the country stood at 14.01 million tonnes (MT) in April, while coal dispatch was recorded at 16.81 million tonnes (MT), reflecting a robust start to FY2025-26, the government data showed on Friday. This marks a notable yearon-year growth compared to April figures from FY 2023-24 and FY 2022-23, underlining the sector's upward trajectory.

The Coal Ministry attributed this success to continuous policy interventions, close monitoring, and handholding of stakeholders to fast-track operational clearances and enhance production capacity. One of the key contributors to this achievement commencement of operations in newly developed coal blocks. Kotre Basantpur Pachmo block of Central Coalfields Limited (CCL), with a Peak Rated Capacity (PRC) of 5 MT per annum (opencast), started operations on April 15, 2025. Naini coal block of Singareni Collieries Company Limited (SCCL), with a PRC of 10 MT annum (opencast), commenced operations on April

The overall coal production in India during April reached 81.57 million tonnes (MT), marking an increase of 3.63 per cent over the 78.71 MT produced in the corresponding period of the previous year.India's total coal dispatch during April reached 86.64 MT, demonstrating a steady increase from 85.11 MT recorded during April 2024 in

FY2025-26.As on April 30, the coal stock held by coal companies witnessed a notable surge, reaching 125.76 MT in FY 2025-26, as compared to 102.41 MT during the corresponding period of the previous year. India's coal imports during April to December 2024 declined by 8.4 per cent to 183.42 million tonnes (MT) from 200.19 MT in the same period of previous financial year due to the increase in domestic production.

Going forward, ministry reaffirms commitment to unlocking the full potential of captive and commercial coal mining in India. The focus remains on ensuring seamless production, minimising supply disruptions, and contributing significantly to the country's growing energy demand.

Record GST Collection Showcases Resilience of Indian Economy: FM Sitharaman

New Delhi, (H.S): The record GST collection in April showcases the resilience of the Indian economy and the effectiveness of cooperative federalism, Union Finance Minister Nirmala Sitharaman said on Thursday.Gross GST collections for April stood at Rs 2.36 lakh crore, marking a 12.6 per cent increase over the gross collection of Rs 2.10 lakh crore in April 2024.

Net GST collections for April 2025 reached Rs 2.09 lakh crore, reflecting a 9.1 per cent growth compared to the net collection of Rs 1.92 lakh crore in April 2024."Deepest gratitude to the taxpayers whose contributions and faith in the GST architecture drive the nation's progress. Their contributions reflect a shared commitment to building a Viksit Bharat," FM Sitharaman said in



a post on social media platform X."Congratulations and sincere regards to the dedicated efforts Finance Ministers of all states and state GST authorities, who remain equal partners in India's GST framework"

The Finance Minister also acknowledged the efforts of the field formations of the Central Board of Indirect Taxes and Customs (CBIC) for their sincere efforts. The increase in GST collections was driven by the higher level of economic activity and better compliance. GST collections from domestic transactions in April this year increased by 10.7 per cent to Rs 1.9 lakh crore, while revenue from imported goods shot up by

Refund issuance rose 48.3 per cent to Rs 27,341 crore during April.GST collections went up by 9.9 per cent to Rs 1.96 lakh crore during March this year compared to the same

20.8 per cent to Rs 46,913 crore.

GST collections in March.

India's Total Exports Rise 6 Per Cent To All-Time High of \$824.9 Billion: RBI

New Delhi, (H.S): India's total exports have touched an all-time high of \$824.9 billion in the financial year 2024-25, as per the latest data released by the Reserve Bank of India which includes the services trade for March 2025. This marks a growth of 6.01 per cent over the previous year's export figure of \$778.1 billion.Services exports continued to drive the growth momentum, reaching a historic high of \$387.5 billion in 2024-25, up 13.6 per cent from \$341.1 billion in the previous year.

For March 2025, services exports stood at \$35.6 billion, reflecting a year-on-year growth of 18.6 per cent compared to \$30.0 billion in March 2024, the latest RBI figures show.In 2024-25, merchandise exports excluding petroleum products rose to a record \$374.1 billion, registering a 6 per cent increase from \$352.9 billion in 2023-24 the highest ever annual nonpetroleum merchandise exports. Earlier figures released by the Commerce Ministry on April 15 estimated that India's total exports of goods and services increased by 5.5 per cent to a record \$820.93 billion during the



2025. However, the actual figures for services exports had not been compiled by the RBI at the time and an extrapolated estimate was used to calculate the exports. With the real figures now coming in, the total value has gone up. Meanwhile, going ahead while the hike in US tariffs announced by President Donald Trump is expected to hit world trade,

India and the US are at an advanced stage of reaching a bilateral trade agreement soon. As part of ongoing discussions, representatives of India's Department of Commerce and the Office of the US Trade Representative held fruitful discussions, at a meeting in Washington, from April 23-25, to conclude the first tranche of the Bilateral Trade Agreement by Fall earlier bilateral discussions held in March 2025 in New Delhi." During the meetings in Washington, D.C., the team had fruitful discussions on wideranging subjects covering tariff and non-tariff matters.

The team discussed the pathway for concluding the first tranche of the mutually beneficial, multi-sector Bilateral Trade Agreement by Fall of 2025, including through opportunities for early mutual wins," the statement said. While productive sectoral expert-level engagements have taken place through the virtual format, in-person sectoral engagements are planned from the end of May, according to an official statement.

Oil Firms Slash Commercial LPG, Jet Fuel Prices

New Delhi, (H.S): Public sector oil companies on Thursday slashed the price of commercial LPG by Rs 14.50 per 19-kg cylinder while the price of jet fuel for airlines was cut by 4.4 per cent. The price of Aviation Turbine Fuel (ATF) was reduced by around Rs 3,954.38 per kilolitre (1,000 litres) to Rs 85,486.80 per kl, which will come as a shot in the arm for commercial airlines such as Air India and IndiGo as fuel accounts for around 30 per cent of their operational costs.

The price cut follows a steep 6.15 per cent (Rs 5,870.54 per kl) reduction effected on April 1. These two reductions have effectively offset the price increases that occurred earlier this year. The reduction in fuel prices comes against the backdrop of crude oil prices having fallen to a four-year low in the global



market with the benchmark Brent crude hovering at around to \$63 a barrel, the lowest since April 2021.Oil prices have declined as demand has declined amid the global slowdown. Oil prices have slumped as demand has declined amid the global

Saudi Arabia, one of the world's biggest oil producers, has also indicated that it won't shore up oil prices with any more supply cuts as it is ready

to face a prolonged period of low prices. This is expected to come in the way of the OPEC oil cartel from influencing

The decline in oil prices augurs well for the Indian economy as the country imports around 85 per cent of its crude requirement, and any decline in oil prices leads to a reduction in the country's import bill. This, in turn leads to a lowering of the current account deficit (CAD) and strengthening of the rupee. India is currently the thirdlargest importer of oil. Apart from strengthening the external balance, a decline in oil prices also leads to lower prices of petrol, diesel and jet fuel in the domestic market, which eases inflation in the country. To raise more resources, the government had last month increased the excise duty on petrol and diesel, which is being borne by the public sector oil companies - Indian Oil, Bharat Petroleum, and Hindustan Petroleum.

Minister for Petroleum and Natural Gas Hardeep Singh Puri stated that the governmentowned oil marketing companies will absorb the increase in excise duty on petrol and diesel, as their input costs have come down due to the decline in crude oil prices in the global market.

New Delhi, (H.S): The rupee continued to strengthen against the US dollar, rising by 40 paise on Friday and breaching the 84mark. This is the first time in seven months that the rupee has traded below the 84-level against the greenback. The local currency opened at 84.09 and touched 83.90 during early trade. In the previous session, the rupee had closed at 84.49 against the dollar.Experts say the rupee's upward movement is supported by increased foreign investments in Indian debt and equity markets, along with positive updates on trade talks between India and the United States." Despite the dollar index remaining firm, the rupee strengthened on expectations that India could emerge as a key alternative to China in US trade flows, boosting confidence in

Indian markets," experts mentioned. The last time the rupee saw this level was on October 1, 2024, when it had touched 83.82 against the dollar. After a period of global market volatility, foreign institutional investors (FIIs) have returned strongly to Indian markets. In the last 11 trading sessions alone, FIIs have invested Rs 37,375 crore in Indian equities and bonds.

Adding to the rupee's strength is the weakness in the US dollar index, which has dropped below 100 and is hovering around 99. The dollar index reflects the performance of the US dollar against six major global currencies. Meanwhile, in a recent interview with American media, US trade negotiator Jamieson Greer said that India and the US are close to finalising a trade agreement, though it hasn't been concluded yet. 

ECB's decision came less than 24 hours after the Football Association (FA) took a similar resolution. A statement issued by ECB said that it is announcing a change to its regulations on the eligibility of transgender players after an "updated legal position" following the recent Supreme Court ruling. "With immediate effect, only those whose biological sex is female will be eligible to play in women's cricket and girls' cricket matches. Transgender women and girls can continue playing in open and mixed cricket," the ECB statement said. The ECB said while it was all for inclusivity in sports, the Supreme Court decision has prompted it to formulate new rules for women's and girls' cricket. "Our regulations for recreational cricket have always aimed at ensuring that cricket remains as inclusive a sport as possible. These included measures to manage disparities, irrespective of someone's gender, and safeguard the enjoyment of all players. "However, given the new advice received about the impact of the Supreme Court ruling, we believe the changes announced today are necessary."
