

Three new **Supreme Court judges** take oath



New Delhi, (HS): Three High Court judges - Justice NV Anjaria, Justice Vijay Bishnoi, and Justice AS Chandurkartook oath on Friday as the judges of the Supreme Court. The Supreme Court Collegium, in its meeting held on May 26, 2025, had recommended the elevation of three High Court judges to the apex court.

On May 29, the Centre had cleared the appointment of three judges.Justice NV Anjaria, Chief Justice of Karnataka High Court, Justice Vijay Bishnoi, Chief Justice of Gauhati High Court, and Justice AS Chandurkar, judge of Bombay High Court, were recommended for elevation as judges of the Supreme Court. The Collegium, headed by Chief Justice of India BR Gavai, decided to elevate the three judges to the apex court. Justice Anjaria began practising at the Gujarat High Court in August 1988 and was appointed as an Additional Judge of the Gujarat High Court on November 21, 2011, and became a permanent judge on September 6, 2013.

He took oath as Chief Justice of the Karnataka High Court on February 25, 2024. Justice Bishnoi was enrolled as an advocate on July 8, 1989, and practised at the Rajasthan High Court and the Central Administrative Tribunal in Jodhpur. He was appointed an Additional Judge of the Rajasthan High Court on January 8, 2013, and became a permanent judge on January 7, 2015. Justice Bishnoi took oath as Chief Justice of the Gauhati High Court on February 5, 2024. In July 1988, Justice Chandurkar was enrolled as a lawyer and began his legal practice in Mumbai. In 1992, Justice Chandurkar shifted his practice to Nagpur. He was appointed an Additional judge of the Bombay High Court on June 21, 2013. With this, the apex court has reached its full sanctioned strength of 34 judges.

PM's warning shot at Pak: '3 rules for terror, no fear of atom bomb bluff'

Kanpur/New Delhi, (HS) : Prime Minister Narendra Modi on Friday delivered a fiery address in Uttar Pradesh's Kanpur and said the world witnessed the raging power of India's indigenous BrahMos missile during a military confrontation with Pakistan.

"The world witnessed the

power of Make in India and its weapon through Operation Sindoor. Our Indian weapons (systems), including the BrahMos missile, entered the enemy territory and caused havoc. The explosions happened on target. We have received this power from our resolve for Aatmnirbhar Bharat," PM Modi said. Highlighting India's resolve to remain self-reliant, the Prime Minister recalled times when the country relied on other nations for its safety. He said that becoming Aatmanirbhar was crucial for the country's selfrespect. "There was a time when India depended on other countries for its safety. We have tried to change these circumstances. India becomes Aatmanirbhar, it is good for the economy, but it is also important for the country's self-respect," PM Modi said. Outlining India's new strategic doctrine, PM Modi laid down a three-rule framework for tackling terrorism. Every terror attack will be answered. The Armed Forces will decide



the nature and timing of the response. India will not be scared of hollow atom bomb threats. India will treat masters of terror and the government that patronises terrorists similarly. PM Modi was speaking at an event in Kanpur where he inaugurated and laid the foundation stone for 15 development projects costing 47,600 crores. He also flagged off Kanpur Metro's new corridor between Chunniganj and Nayaganj. PM Modi also targeted Pakistan directly and warned against "sponsoring" terrorism and said that India will

respond strongly to every terrorist attack. "If I say this straight in Kanpuriya: Dushman kahin bhi ho, honk diya jayega (Wherever the enemy is, they will be hit)," he said, drawing loud cheers from the audience. "India will not be scared of hollow threats of an atom bomb and won't take decisions on this basis (of such a threat). India will look at the 'aaka' of terrorism and its sponsoring government with only one view: Pakistan's state and non-state actors...this game will not work anymore," PM Modi

In a veiled attack on previous

governments, he said they had ignored the state's industrial needs. "The family-driven governments never thought of giving priority to industrial development and pushed the state out of the race of developing states," he said. Highlighting Uttar Pradesh's transformation into a logistics and industrial hub, Modi said, "The state already has an international airport, and with this year's budget, we've launched 'Mission Manufacturing' to further boost local business and industry." Covid-19: Two New Cases Reported in Cuttack In 24 Hours



Cuttack/Bhubaneswar, (DMC): The spectre of COVID-19 has returned to haunt Cuttack, following its resurgence in Bhubaneswar. On Friday, two individuals tested positive for the virus in the Millennium City, raising concerns among health authorities and residents alike.

The first case involves a 72year-old resident of Nua Rausapatna, who had been suffering from cold and fever. After testing, the individual was confirmed positive for COVID-19 and is currently undergoing treatment at a private hospital. Similarly, a 44-year-old person from Jhola Sahi was identified as infected on Friday morning, also

exhibiting symptoms of a cold and fever. This patient is likewise receiving care at a private facility. According to Cuttack's Chief District Medical Officer (CDMO), Prashant Hota, both patients have been quarantined following their positive test results. "No travel history has been reported for either individual," Hota stated, emphasising the need for vigilance. This development comes amid a broader resurgence of COVID-19 across India after a three-year lull. On May 8, 2025, an elderly man in Bhubaneswar tested positive and was admitted to a private

India will never give in to nuclear blackmail: Jaishankar



New Delhi, (HS): External Affairs Minister (EAM) S. Jaishankar on Friday reiterated that India will never give in to nuclear blackmail, asserting that those who sponsor, nurture and utilise terrorism must pay a high price.

Addressing the Parul University Convocation in Gujarat's Vadodara, EAM Jaishankar said that

sharpened India's awareness about terrorism. "In Pahalgam, what we saw was an attempt to devastate the tourism economy of Kashmir, as well as an evil design of sowing religious discord," he said. EAM Jaishankar emphasised that the barbarity of the killings required an exemplary response, which was delivered by destroying terrorist command centres, especially in Bahawalpur and Muridke. "It is imperative that those who sponsor, nurture and utilise terrorism for their ends are made to pay a high cost. That it warranted a forceful response even after the 26/11 attack in Mumbai in 2008 is widely acknowledged. But times have changed, and our resolve is much stronger now. Terrorism epicentres are no longer immune. India's zero tolerance for terrorism is manifest today through its actions. We Continued P-4

MSP Hike

With the southwest monsoon setting in over Kerala on May 24, eight days before schedule, it's just as well that the Narendra Modi government has approved the minimum support prices (MSP) for kharif crops. Unlike last year, when they were declared on June 19, the MSP announcement comes early enough this time for farmers to make informed planting decisions. Equally welcome is the MSP of paddy being hiked by only Rs 69 per quintal, as against Rs 117 and Rs 143 for the last and preceding year's crops. Ideally, given the record 63.1 million tonnes (mt) of rice in government godowns, the paddy MSP should have been frozen. The latest increase, the lowest in five years, is a secondbest solution to a problem that has both economic and environmental dimensions: India is producing too much rice (public stocks at over 4.6 times the required buffer, even after exports of 20.2 mt in 2024-25, is proof), which is a water-guzzler to boot. The MSPs of other crops have been raised significantly. These range from 5.4-6 per cent for urad (black gram) and arhar (pigeon-pea), to 7.1-8.3 per cent for groundnut, maize and cotton, and 8.9-13.9 per cent for soyabean, jowar (sorghum) and ragi. When compared to the mere 3 per cent higher MSP granted for paddy, these seem quite major and well-intentioned too. India should definitely be growing more pulses and oilseeds considering the value of their imports, touching \$5.5 billion and \$17.3 billion during 2024-25. The same goes for cotton (where India has turned a net importer) and maize (the domestic consumption of which, both as feed and fuel grain, is rising faster than production). Their nutritional advantages, apart from lower water requirement and climate hardiness, make millets similarly worthy of MSPs providing fair and remunerative returns over cultivation costs. But why would farmers grow crops where the MSPs are simply on paper? Take soyabean, which is currently selling in Maharashtra's Latur market at Rs 4,300 per quintal. That's below not only the just-announced MSP of Rs 5,328, but even last year's level of Rs 4,892.

The MSP system needs a reset. The government must procure grain that is sufficient to meet its requirements for the public distribution system and open market operations. This would mean capping the quantity of produce purchased - say, 100 quintals of paddy per farmer. Over time, it should move from crop-specific MSPs to flat per-acre income support. This will incentivise farmers to grow crops that the market wants and also produce these through cost-efficient use of water, nutrients, energy and other inputs. Poultry, dairy and vegetable farmers are already doing this. There's no reason those growing regular field crops can't - with some government direct income support.

World No Tobacco Day



Each year, the World Health Organization (WHO) holds World No Tobacco Day on May 31. Their goal is to spread awareness about the risks of tobacco use and how we can make the world tobacco free. Roughly 6 million people die from tobacco-related ailments every year. And that number is projected to rise to over 8 million by 2030. But this is by no means a guarantee. The Sustainable Development Agenda aims to reduce deaths from noninfectious diseases by a third. Diseases linked to tobacco are on the list, so if we hit the target, 2030 will be a year to celebrate (oh yea!)-not only for our health, but the size of our wallets. Your average smoker drops around \$4,000 on cigarettes annually. Imagine all of the other cool holidays you could enjoy with that money (we have a few suggestions, just saying). So let's use World No Tobacco Day as a launching pad to a brighter and less smokey future!

World No Tobacco Day is an initiative by the World Health Organization and is observed on May 31 every year. The campaign aims to spread awareness about the dangers of tobacco and its negative impact on health, as well as the exploitation of the nicotine industry that is geared towards the youth in particular. It also aims to reduce the diseases and deaths caused by tobacco consumption. The World No Tobacco Day theme for 2021 is "Commit to Quit." The Member States of the World Health Organization created World No Tobacco Day in 1987 as a response to the global tobacco crisis and the diseases and deaths caused by the epidemic. The World Health Assembly passed Resolution WHA40.38 in 1987, calling for April 7 to be "World No-Smoking Day." Next, Resolution WHA42.19 was passed in 1988, issuing May 31 as an annual observance of World No Tobacco Day.

The World Health Organization reports 8 million deaths every year due to the consumption of tobacco. Tobacco is the leading cause of respiratory disorders like chronic obstructive pulmonary disease, tuberculosis, and other lung diseases. In 2008, the WHO banned any kind of advertisement or promotion of tobacco. As the world's most populated country, China is the leader in the cigarette industry. More than 30% of the total cigarettes in the world were produced and consumed in China in 2014.

First give for free, then make slaves, then plunder".
"WhatsApp ban and digital slavery: Are we becoming bonded labourers for tech companies?"

Jio gave us a taste of cheap data and then made us addicted to it and emptied our pockets. Today WhatsApp is on the same path - "First give it for free, then make it a slave, then loot". It is time that we become not just users, but digital citizens - aware, organized and fighting for rights. Imagine that you wake up one morning and find that your WhatsApp account has been suspended. No information, no reason, no human

interaction. Just a cold text line "Your account has been suspended because it violates our guidelines."
Now imagine, all the contacts with whom you were dependent on for your livelihood, your relationships, have been cut off in one go. This is not a fantasy, it is becoming the reality of millions of Indian users today.

WhatsApp: Convenience or intrigue?

There was a time when WhatsApp was considered the messiah of the digital revolution. No ads, no fees, and no policy burden. But today the same app has started swallowing people's time, mental peace and social circle. Accounts of millions of people are being banned without any apparent reason. If you complain, the answer comes - "We cannot help you." And then you are suggested to switch to WhatsApp Business or Premium. The question is whether this is a technical policy or a well-planned "digital loot"? "Our app, our rules": Is this democracy or dictatorship? It is true that WhatsApp is a private company. But can any company, which is used by 50 crore Indians, take away someone's digital life at will? Can this be approved in a democratic country? Isn't this "digital sterilization"? Today, banning WhatsApp is like putting someone in jail without trial.

Repetition of Jio model: First free, then addiction, then loot: You must remember how Jio first gave free data to India, then twisted the entire market and made it expensive. After making people addicted to data, they gradually increased the prices and now every Indian is not a "customer" of Jio, but a "prisoner". Now WhatsApp is also running on the same model. First, provided free service. Then created a dependency. Now gradually the free users are being sidelined and pushed towards Premium. Isn't this "digital profiteering"? Impact on business, education and relationships. WhatsApp today is not just a chatting app: Small shopkeepers take orders from him. Teachers teach from him. The unemployed look for jobs from him. And common people maintain their relationships with him. When an account is banned, it affects not just one person but the entire social fabric.

Legal Silence: Is the Government Sleeping? The most dangerous thing is that our country does not have any strong "digital rights law" that can rein in these private tech companies. We can ask questions from the government through RTI, get justice from the court, but cannot ask WhatsApp "What was my fault?" Is this democracy? Are we just data, not humans? Governments seek votes from these companies and advertise with them, but when it comes to citizens, they maintain silence. The era of digital slavery: If you think about it, today's Indian has become a digital slave. He has a smartphone but no control over it. His data is not with him, it is with the companies. And these companies can make him a "digital untouchable" whenever they want. Just like the British government ruled India, today American tech companies rule our digital lives - and we are subjugated even though we are free.

What is the solution? A digital rights law needs to be made in which the process of account banning is fair and transparent. A Digital Ombudsman should be

appointed to hear complaints from users. The government should add accountability to the licensing conditions of such companies. Indigenous alternatives must be developed that are in the public interest, not in the interest of profits. The public will also have to unite and spread digital awareness.

Conclusion: "The technology is ours, but why should the control be theirs?" WhatsApp is not a god that we can neither stop nor control. It is a private company, and when its use has become linked to every aspect of common people's lives, its accountability should be fixed. We have to understand that if we do not raise our voice today, then in the coming future our digital existence will be reduced to "erasing it with the press of a button". Today the fight is not just for the ban on WhatsApp, but for digital respect and freedom. And this time we must not remain silent, because the price of silence is not "freedom" but "slavery".

To achieve this goal, it works to create an environment that promotes uptake of its products among the next generation, including lax regulation to ensure its products are available and affordable. The industry also

develops products and advertising tactics that appeal to children and adolescents, reaching them through social media and streaming platforms. The consequences of youth tobacco use are dire. Nicotine is highly addictive, and early exposure increases the likelihood of dependence in adulthood. This dependence can lead to a range of health problems, including: Respiratory illnesses: Tobacco use damages the lungs, increasing the risk of chronic obstructive pulmonary disease (COPD), asthma, and lung cancer. Cardiovascular disease: Tobacco use is a major risk factor for heart attacks, strokes, and other cardiovascular complications. Cancer: Tobacco use is not just linked to lung cancer but also increases the risk of cancers of the mouth, throat, esophagus, bladder, and pancreas. Doctors At AIIMS Bhubaneswar Remove India's Largest Kidney Mass



Bhubaneswar, (DMC): In a groundbreaking medical feat, doctors at the All India Institute of Medical Sciences (AIIMS) Bhubaneswar have accomplished a remarkable success by removing India's largest kidney mass, weighing an astonishing 8.7 kilograms. The patient, a 50-yearold man from Nayagarh district in Odisha, was suffering from Autosomal Dominant Polycystic Kidney Disease (ADPKD), a genetic condition that led to the development of massive cysts in his kidney. The patient had been experiencing severe abdominal pain and discomfort due to the enormous size of the cystic kidney, which significantly impacted his quality of life. After a thorough evaluation, a team of skilled doctors at AIIMS Bhubaneswar, led by Dr Manoj

Kumar Das, Associate Professor of Urology, decided to undertake the high-risk surgery to remove the massive kidney mass. Dr Das was assisted by Dr Sambit Tripathy, Assistant Professor, and a team of resident doctors, including Dr Saharsh, Dr Mithlesh, Dr Huzaifa, Dr Sabique, and Dr Sachin. 

CBI arrests ED Deputy **Director Chintan Raghuvanshi** in bribery case of Rs. 5 crore

Bhubaneswar, (DMC): The Central Bureau of Investigation (CBI) has arrested Enforcement Directorate ED Deputy Director Chintan Raghuvanshi (IRS) in Bhubaneswar on charges of corruption. According to sources, Raghuvanshi was caught red-handed while allegedly accepting the first instalment of a bribe amounting to Rs 20 lakh. The CBI had laid a trap following a complaint and apprehended him at the scene. Investigations revealed that the bribe demand was part of a larger sum initially pegged at Rs 5 crore, which was later negotiated and settled for Rs 2 crore. The illegal gratification was reportedly sought in exchange for 'settling' a case under the Prevention of Money Laundering Act (PMLA). CBI further stated that the bribe was routed through the ED deputy director's brother. The CBI has initiated further inquiry into the matter. In a separate incident, earlier, Odisha Vigilance intercepted Assistant Executive Engineer (AEE) Pabitra Mohan Panigrahi of Chitrakonda Block in Malkangiri district and seized cash exceeding Rs 15 lakh, suspected to be ill-got. Acting on credible intelligence inputs about alleged bribe collection from contractors, a team of Odisha Vigilance officials intercepted Panigrahi near Gobindapally Chowk while he was travelling from his government residence in Chitrakonda to Bhubaneswar in a WagonR car bearing registration number OD-30-E-3096. He was reportedly taking a lift at the time. Upon interception, officials recovered Rs 5.07 lakh in cash from Panigrahi's possession. A further search at his government quarters in Chitrakonda led to the recovery of Rs 10 lakh more in cash. As Panigrahi failed to provide a satisfactory explanation for the seized amount, the entire cash was confiscated by the Vigilance team. Subsequently, searches are underway at two additional premises linked to Panigrahi from a disproportionate assets (DA) angle. He is currently being questioned to determine the source of the recovered funds. Further investigation is in progress, and a detailed report is awaited.

Farmers Affected By Unseasonal Rains To **Get Compensation Soon: Revenue Minister**

Bhubaneswar, (DMC): A virtual review meeting was held at the office of the Special Relief Commissioner to assess the damage to crops and properties caused by unseasonal rainfall triggered by a low-pressure system between May 27 and May 30, 2025. The meeting focused on evaluating the extent of the damage and planning compensation for affected individuals. 84 New COVID-19 **Cases Reported in** Maharashtra

Mumbai, (HS): As many as 84 new COVID-19 cases were reported in Maharashtra on Friday, taking the tally of cases registered since the start of the year to 681, the state public health department said. Most of the patients have mild symptoms and people should not panic, it said in a release here.

Of the new cases, 32 were detected in Mumbai, two in Thane district, 14 in Thane Municipal Corporation limits, one in Navi Mumbai, one in Kalyan-Dombivli Municipal Corporation, two in Raigad district, one in Panvel, one in Nashik city, one in Pune district, 19 in Pune Municipal Corporation, three in Pimpri Chinchwad Municipal Corporation, two in Satara, one in Kolhapur district, one in Kolhapur Municipal Corporation, and three in Sangli Municipal Corporation limits, the department said. There are 467 active cases in the state, while the number of cases in Mumbai since January 2025 stood at 411. All diagnosed cases are of mild nature, the release said. The number of COVID-19 tests conducted since January was 10,324, of which 681 came out positive.

Since January 1, seven COVID-19 patients, including six with co-morbidities and 1 with other diseases, have died in the state. Adequate coronavirus testing and treatment facilities are available in the state and the people should not panic, the health department said.

Haryana Civil Secretariat building in Chandigarh evacuated after bomb threat

Chandigarh, (HS): Visuals from the spot showed security personnel making announcements loudspeakers, urging people to evacuate the premises as a precautionary measure. The Haryana Civil Secretariat premises were vacated on Friday following an email warning of a bomb threat, officials said. Visuals from the spot showed security personnel making announcements via loudspeakers, urging people to evacuate the premises as a precautionary measure. This incident comes days after a similar scare on May 22, when the Punjab and Haryana High Court also received a bomb threat. The court premises were evacuated, and proceedings were suspended. "We received a bomb threat. The lawyers and staff were asked to vacate the High Court. The court's work has been suspended until 2 pm," Gagandeep Jammu, Secretary of the Punjab & Haryana High

New Delhi, (HS): In a significant order, the Supreme Court on Friday issued directions that the post-graduate medical entrance exam scheduled on June 15 be conducted in a single shift, saying holding it in two shifts "creates

A bench headed by Justice Vikram Nath directed the authorities to make arrangements for holding NEET-PG 2025 exam in one shift and to ensure that complete transparency is maintained and secured centres are identified. "Any two question papers can never be said to be having an identical level of difficulty or ease," said the bench, also comprising Justices Sanjay Kumar and N V Anjaria. It said normalisation may be applied in exceptional cases but not in a routine manner year after year. The bench passed the order on pleas challenging a notification on holding the National Eligibility-cum-Entrance Test-Post Graduate (NEET-PG) 2025 examination in two shifts. The top court said the total number of candidates who have applied for the examination is 2.42.678 and the test is held all over the country and not in one city. "We are not ready to accept



that in the entire country and considering the technological advancement in the

country, the examining body could not find enough centres to hold the examination in one shift," the bench said.

"Holding examinations in two shifts creates arbitrariness and also does not keep all the candidates, who take the examination, at the same level," it observed. It said the examination is scheduled for June 15 and there was still more than two weeks for the examining body to identify further centres to hold it in one shift. "We accordingly direct the respondents to make further arrangements for holding the examination in one shift and also ensure that complete transparency is maintained and secured centres are identified," the bench said.

One of the pleas was filed through advocate Sukriti Bhatnagar. Several lawyers, including advocate Tanvi Dubey, appeared in the matter. The counsel appearing for the respondents, including the National Board of Examinations in Medical Sciences (NBEMS), said even if efforts were made to identify more centres, it might need more time which might result into delay in holding the examinations.

BJP hails Salman Khurshid's Article 370 remarks, asks 'will Congress turn on him like Tharoor'

New Delhi, (HS): The BJP praised Salman Khurshid for accepting that the abrogation of Article 370 was the right decision. The Bharatiya Janata Party (BJP) on Friday appreciated comments made by Congress leader Salman Khurshid who had stated that the abrogation of article 370 had made positive changes in Jammu and Kashmir.

While BJP's Shehzad Poonawala said Salman Khurshid also accepts how 'Pakistan-parasti' was increasing, Amit Malviya asked if the Congress will "now turn on him for speaking an inconvenient truth, just as they did with Shashi Tharoor." Ankita Murder: Ex-Minister's Son, 2 Others Get Life Term

Dehradun, (HS): An Uttarakhand court on Friday sentenced the three convicts to life imprisonment in the sensational Ankita Bhandari murder case in Pauri district in 2022. Additional District and Session Judge, Kotdwar, Reena Negi held Pulkit Arya, resort owner and son of a former BJP leader, and his two associates. Saurabh Bhaskar and Ankit Gupta, guilty of murdering Ankita, who worked as a receptionist at Vanantra Resort located in Yamkeshwar.

The court held the trio guilty under penal provisions dealing with murder (IPC Section 302), offence committed by an



enforcing authority (Section 210b) and causing disappearance of evidence (Section 201). According to the police, Ankita,19, was killed on September 18, 2022 and her body was dumped in Chilla canal in Rishikesh, from where it was retrieved about six days after she

went missing. According to the prosecution, Ankita and Pulkit Arya had a dispute over something, after which the man, along with Bhaskar and Gupta, allegedly pushed the woman into the canal. Resort owner Pulkit is the son of former BJP leader Vinod Arya who was a minister in the Uttarakhand government till 2021. The case had made national headlines after the local people came out and protested over the murder as the law enforcement agencies were dragging their feet on the probe into the murder. On Friday, the court resembled a fortress due to heightened security, with only lawyers and family members of the victim and convicts

'Final extension': DGCA lets IndiGo fly 2 Turkish planes for 3 more months



New Delhi, (HS): The Directorate General of Civil Aviation (DGCA) on Friday said that it granted a three-month extension to budget carrier IndiGo to operate two B777-300ER aircraft on a damp lease from Turkish Airlines. The aviation regulator said the decision was taken to avoid passenger inconvenience on the

condition that this will be the last extension and the IndiGo will end the lease arrangement with Turkish Airlines within this duration. "...Indigo has been granted a one-time last and final extension of three months upto 31.08.2025 for these dampleased aircraft, based on the undertaking from the airline that, they will terminate the damp lease with Turkish Airline within this extension period, and shall not seek any further extension for these operations," DGCA said.

The regulator said the airline had sought an extension of six months. There have been calls to revisit business ties with Turkey after Ankara supported Pakistan during the military confrontation with India after New Delhi carried out retaliatory strikes in Pakistan and Pakistan-occupied Kashmir. Friday's decision comes weeks after the government revoked the security clearance of Turkish ground handling service firm Celebi, citing national security. In its order, DGCA said, "Indigo is currently operating two B777-300ER aircraft under damp lease from Turkish Airline, which was permitted upto 31.05.2025. Indigo requested for a further extension of the same for another six months, which was not agreed to". IndiGo operates direct flights to Istanbul using the two wide-bodied aircraft leased from Turkish Airlines, and offers codeshare connections to Europe and the US through its partnership with the Turkish carrier.

Had Indian Navy Been Fully Unleashed, Pakistan Would Have Been Split Into Four: Rajnath

Panaji, (HS): Defence Minister Rajnath Singh on Friday asserted that had the Indian Navy been fully deployed during 'Operation Sindoor', Pakistan could have been split into four parts. Speaking onboard INS Vikrant, India's first indigenouslybuilt aircraft carrier, off the coast of Goa, the Defence Minister said, "The events of 1971 are proof that when the Indian Navy enters the battlefield, the course of history changes. If the Navy had gone into full action during 'Operation Sindoor', Pakistan would not just have been divided into two - it might have broken into four parts."

He added that 'Operation Sindoor' was not over, but merely a "pause and a warning.""If Pakistan repeats its mistake, India's response will be even harsher. And this time, Pakistan won't get a chance to recover," he said. The Defence Minister described 'Operation Sindoor' not merely as a military action, but as "India's direct assault on terrorism." "We will employ every method Pakistan can imagine, and even those it cannot,' Singh said. He lauded the deployment of the INS Vikrant Carrier Battle Group as a clear demonstration of India's maritime strength and strategic intent. "Your mere preparation broke the enemy's spirit. Pakistan did not need to see action - your readiness alone stunned them," he told naval personnel. Referring to the 2008 Mumbai attacks, Singh said, "Hafiz Saeed is the mastermind of the Mumbai carnage. Justice must be done for that heinous crime committed through the sea route. But justice cannot be delivered in Pakistan." He noted that India has recently secured the extradition of Tahawwur Rana, another accused in the Mumbai attacks. "Pakistan keeps



offering dialogue - their Prime Minister reiterated it yesterday - but we've made it clear - talks will only be about terrorism and Pakistan-occupied-Kashmir. If Pakistan is serious, it must hand over terrorists like Hafiz Saeed and Masood Azhar," Singh stated. Highlighting the operational capabilities of INS Vikrant, the Minister said the carrier can accommodate more than 30 aircraft, including fighter jets and helicopters. "Standing on Vikrant, the pride of India's maritime power, fills me with happiness, pride, and confidence. As long as India's maritime borders are in your capable hands, no one can dare challenge us," Singh declared. "Within 96 hours, our Western Fleet executed multiple successful firings of surface-to-surface and surface-to-air missiles and torpedoes from both eastern and

"We Were Ready to Act after Prayers, But India Launched Brahmos": Pak PM

New Delhi, (HS): Pakistan Prime Minister Shehbaz Sharif, once again, publicly admitted that Indian missiles struck many targets inside Pakistan on the intervening night of May 9 and 10 with his army being caught off-guard. The Pakistani PM claimed that they were planning to attack India at 4:30 am - just after their Fajr prayers - but before that, India launched BrahMos missiles targeting many provinces in Pakistan, including the airport in Rawalpindi.

"On the night of May 9-10, we decided to respond in a measured fashion to Indian aggression. Our armed forces were prepared to act at 4.30 in the morning after Fajr prayers to teach a lesson. But before that hour even arrived, India once again launched a missile attack using BrahMos, and hit various provinces of Pakistan, including the airport in Rawalpindi," Mr Sharif said during a speech in Azerbaijan. The Indian strikes were carried out under Operation Sindoor - a targeted military attack on terror infrastructures in Pakistan and Pakistan-Occupied Kashmir (PoK) in response to the April 22 Pahalgam terror attack in which 26 people died. This is not the first time that Mr Sharif has admitted that Operation Sindoor caused severe damage in Pakistan. Earlier this month, he confirmed that Indian missiles struck the



Nur Khan Airbase and other targets inside Pakistan during the early hours of May 10. Speaking at a ceremony in Islamabad, Mr Sharif recounted a 2:30 AM call from the Chief of Army Staff, General Syed Asim Munir, informing him of the missile attacks launched by India. "In the intervening night of May 9-10, around 2:30 AM, General Asif Munir called me through a secure phone and told me India has launched its missiles. One has landed at the Nur Khan airbase and some at other areas," he said. According to government sources, Indian strikes eliminated around 100 terrorists affiliated with terror groups

such as Jaish-e-Mohammed, Lashkare-Taiba, and Hizbul Mujahideen. The Indian Armed Forces carried out the missile strikes on nine terrorist facilities - four in Pakistan (Bhawalpur, Muridke, Sarjal, and Mehmoona Joya), and five in PoK (Sawai Nala, Syedna Bilal, Gulpur, Barnala, and Abbas).

Pakistan then escalated the situation by attacking civilian areas in India with drones. In response, India hit selected military targets deep inside Pakistani territory, such as radar installations, command and control centres, and ammunition depots in Rafiqui, Chaklala, Rahim Yar Khan, Sukkur, and Sialkot, all firing and military action on land, air, and sea, with immediate effect. Pakistan, however, violated the agreement within hours of it coming into effect. Days later, the Indian military confirmed that the two countries will continue the ceasefire with "no expiration date". Earlier this week, Mr Sharif said that the country is ready to talk with India "to find solutions" to "longstanding problems", including Kashmir, watersharing, and trade. However, India has made it clear that talks with Pakistan can only happen if it stops cross-border terrorism. "We would like to reiterate that terrorism and talks cannot go together," External Affairs Ministry Spokesperson Randhir Jaiswal said at his weekly media briefing. He added, "As far as our engagement with Pakistan is concerned, our stand has been clear. Any engagement has to be bilateral. They need to hand over to India, noted terrorists, whose records and list we submitted to them some years ago. Talks on J&K will be held only on the vacating of PoK and when Pakistan hands over the territory to us. As far as the Indus Water Treaty is concerned, it will remain in abeyance till the time Pakistan credibly and irrevocably abjures its support to cross-border terrorism.'

New Delhi, (HS): In the viral audio between two doctors, one senior doctor can be heard saying, "Don't allow anyone to go inside, just kill that Dayami woman." Maharashtra police have registered an FIR against a senior government doctor for allegedly instructing another medic to "kill" a Covid-19 patient during the second wave of the crisis in 2021. The accused, Dr Shashikant Deshpande, who was the additional district surgeon at Udgir Government Hospital during the second wave of the pandemic, was caught in an audio clip, which surfaced online earlier this month, according to news agency PTI. The clip, which went viral on social media, allegedly captured a conversation between Dr Deshpande and Dr Shashikant Dange. In the audio, the doctor can be heard saying, "Don't allow anyone to go inside, just kill that Dayami woman."The patient in question, Kausar Fatima, was admitted with Covid-19 symptoms on April 15, 2021, and later recovered after a 10-day stay. Kausar survived. Her husband, Dayami Ajimoddin Gaussoddin, has now

registered a formal police complaint, saying he was present when the alleged conversation took place.

As per the FIR, Gaussoddin said he overheard the call while sitting beside Dr Dange, who had placed the phone on speaker while eating lunch. Deshpande allegedly not only made the shocking "kill" comment but also used caste-based slurs, which Gaussoddin said caused him deep emotional and religious hurt.

Latur police, who have begun a probe into the matter, have seized Dr Deshpande's mobile phone and issued a notice to him. His statement is currently being recorded, Inspector Dilip Gade told PTI. He added that the authenticity of the audio clip is under forensic examination. "Dr Dange is out of the district and will come tomorrow. After that, we will collect his mobile phone and conduct an inquiry," Gade said.

The case has been filed under sections pertaining to deliberate and malicious acts intended to outrage religious feelings, among other serious charges.

Rajasthan police detains govt employee for alleged spying amid Indo-Pak tensions

Rajasthan, (HS): Several people have been detained for questioning, and action has been taken against those found to be sending sensitive information across the border. Rajasthan Police on Friday detained a government employee, Shakur Khan, on the allegations of spying, in Jaisalmer. According to Jaisalmer Superintendent of Police (SP) Sudhir Chaudhary, Khan is undergoing interrogation. Speaking to ANI, SP Sudhir Chaudhary said, "Shakur Khan, who is a government employee, has been detained and interrogation is being done..." The police had previously appealed to the public for information regarding suspicious individuals in the area. Several people have been detained for questioning, and action has been taken against those found to be sending sensitive information across the border. "We had appealed to the public to give us information regarding the presence of any suspicious person. We have already detained many persons for interrogation, and action has been taken against those who were sending important information across the border..," said Sudhir Chaudhary.

Russia Has Provided North Korea with Pantsir Air Defence System, Jammers Since Troop Deployment

Seoul, (H.S): Russia has provided North Korea with its air defence system, electronic warfare jamming devices and other military support since late last year, in blatant violations of UN sanctions amid their deepening ties, an international monitoring report released by Seoul's Foreign Ministry showed on Thursday.Since November 2024, Moscow has transferred at least one Pantsir mobile air defence system and one Pantsirclass combat vehicle to Pyongyang, the Multilateral Sanctions Monitoring Team (MSMT) said in its first report on the sanctions enforcement.

The MSMT was established in October last year with the initiative of South Korea and the United States as an alternative framework to the UN Panel of Experts on North Korean sanctions monitoring. The panel was disbanded in March of the same year due to Russia's veto. Besides South Korea and the US, nine other countries have joined the mechanism - Australia, Britain, Canada, France, Germany, Italy, Japan, the and Netherlands,



Zealand. The inaugural report, specifically focusing on the illegal military cooperation between Russia and the North, is the MSMT's first assessment on the sanctions enforcement since its launch. The findings were based on the intelligence and other information provided by the participating countries and data

from private research institutes. The Pantsir missile system is made up of self-propelled, medium-range surface-to-air missiles and anti-aircraft artillery systems. A South Korean lawmaker has recently mentioned the weapons systems unveiled on the North's new Choe Hyon destroyer as bearing a marked

resemblance to the Russian Pantsir system. The report also found that North Korea has supplied Russia with more than 20,000 containers worth of military supplies since September 2023.

The shipments include approximately 9 million rounds of artillery and multiple rocket launcher ammunition, more than 100 ballistic missiles and over 200 heavy artillery pieces, as well as anti-tank guided missiles and rockets, Yonhap news agency reported. These transfers make up enough supplies to equip three full brigades, the report said. Russian transport aircraft were used for the arms transfers

between November and December 2023. They include three IL-76 and three AN-124 military planes belonging to the Russian Transport Aviation Command, the report said. Russia has also provided the North with missile performance data and technical support to enhance Pyongyang's missile guidance capabilities, in a clear violation of UN Security Council (UNSC) resolutions against Pyongyang, which Russia itself voted for as a permanent UNSC member.The report stated that North Korea sent over 11,000 troops to Russia in 2024, with an additional 3,000 soldiers dispatched recently.

Those soldiers were trained by the Russian military on artillery drone countermeasures and basic infantry operations. The report said that the two countries have engaged in highlevel exchanges between top military officials, suggesting the deepening ties following the signing of a bilateral defence treaty between Russian President Vladimir Putin and North Korean leader Kim Jong-un at their June summit last year.Russia provided

the North with more than 1 million barrels of fuel between March and October last year, the report said. The UNSC sanctions cap North Korea's annual imports of refined petroleum at 500,000 barrels. About 8,000 North Korean workers have been sent to Russia to work in construction, IT and other sectors, also a breach of the sanctions banning the hiring of North Koreans

The report also found that financial transactions between the two countries are being made through North Koreaowned ruble-denominated bank accounts set up in South Ossetia, a Russia-backed autonomous state in Georgia. The report is a "product of our efforts to address the monitoring gap arising from the disbandment" of the UN panel, a joint statement released by the foreign ministry read." We underscore once again our shared determination to fully implement relevant UN Security Council resolutions ... and continue our efforts to monitor the implementation," the statement said.

Hamas Says US Ceasefire Proposal Under Review, Does Not Meet Palestinian Demands

Gaza, (H.S): A senior Hamas official said that a US proposal for a ceasefire in the Gaza Strip remains under review, even though it does not meet the core demands of the movement and the Palestinian people. Basem Naim, a member of Hamas's political bureau, said in a statement, on Thursday, that the movement had received the Israeli response to the US proposal brokered last week by US Special Envoy to the Middle East Steve Witkoff, Xinhua news agency reported. According to Naim, the Israeli position fails to address key Palestinian demands, including a complete cessation of hostilities and the lifting of the long-standing blockade on Gaza. He said the proposal would allow for the continuation of "the occupation" and humanitarian suffering, even during any

Nevertheless, the movement's leadership is evaluating the proposal with a sense of national responsibility, particularly in light of the ongoing violence and humanitarian crisis facing the Palestinian people," Naim said. Hamas stated earlier that it had received the updated ceasefire proposal through mediators and was assessing it in a way that reflects the interests of the Palestinian people and aims to achieve lasting peace and relief for Gaza residents. Hamas had previously said it had agreed with Mr Witkoff on a "general framework" of an agreement that would lead to a lasting ceasefire, a full Israeli withdrawal from Gaza, an influx of aid, and a transfer of power from the militant group to a politically independent committee of Palestinians.



Russia To Renovate Lenin's Tomb in Red Square

Moscow, (H.S): Lenin's Mausoleum, the iconic structure from whose rostrum generations of Soviet and Russian leaders have inspected parades on the sprawling Red Square, is set to get a \$250,000 makeover as several parts of the building require urgent repair, reports said. Russia's Ministry of Culture has signed a 20 million rubles (approx \$250,000) contract to restore the mausoleum.

where Soviet leader Vladimir Lenin's embalmed body is on display, as an inspection reported several parts are crumbling and some have mould building up due to inadequate ventilation, RT reported, citing the tender records. The restoration will address structural damage and update the site for modern use, as per the project documents. Work is expected to be completed by mid-2027. One of the most recognisable landmarks in Russia,



the red granite and black labradorite structure, which was built in 1929-30, has undergone regular maintenance and has been closed on several occasions in recent years, including for public events. As per RT, Lenin remains a divisive figure in Russian history. While some view him as a visionary who led the 1917 October Revolution to establish a fairer society, others regard him as a tyrant responsible for mass repression and death.The revolution sparked a civil war, after which Lenin's Bolsheviks

of the Tsarist Russian Empire. These territories were united in 1922 to form the Soviet Union. Lenin died two years later, in 1924, and his body has remained on public display since then. United Nations, (H.S): Brigadier Amitabh Jha and Havildar Sanjay Singh, who died while serving in peacekeeping missions, were honoured with the Dag Hammarskjold medals.India's Permanent Representative P Harish received the medals on Thursday (US time) from Secretary-General Antonio Guterres at a ceremony honouring the peacekeepers who died in the service of the UN.Jha was the acting force commander of the UN Disengagement Observer Force (UNDOF) that is deployed in the Golan Heights to monitor the ceasefire between Israel and Syria after the 1973 war.Guterres said, "Jha served as acting Force Commander of UNDOF in complex circumstances, following the fall of the Assad Government in Syria.

He will be remembered for his leadership and unwavering commitment to United Nations peacekeeping, including in the United Nations Organisation Stabilisation Mission in the Democratic Republic of the Congo (MONUSCO) as a military observer from 2005 to 2006. Jha "played a pivotal role in managing a critical security situation which evolved during the Syrian crisis in December 2024", a citation from India said. That month, the Damascus government of Bashar al-Assad collapsed, and the border area supervised by the UNDOF came under pressure from both Israel and disparate Syrian groups." Jha was a man who stood his ground - as was evident from the way he handled affairs of UNDOF as the acting force commander. He will be admired by his friends and detractors," the citation said.

Singh served with MONUSCO when he died. Waibhav Anil Kale, a retired Indian Army colonel, also died last year while serving the UN in a civilian capacity in Gaza, the citation from India noted. India To Remain Fastest-Growing Economy, Trade Talks With US on Track: Piyush Goyala

New Delhi, (H.S): India is an attractive investment destination and has the potential to remain the fastest-growing large economy in the world for the next 30 years, Union Minister for Commerce and Industry, Piyush Goyal, has said.Goyal said the country has maintained sustained growth of 6-7 per cent and hopes to push it to 8 per cent at constant prices. Speaking at the CII 'Annual Business Summit 2025 here, the minister said that even amid international upheavals,

"we are among the betterperforming emerging markets". "Today, India holds the 4th largest foreign exchange reserves in the world at about \$690 billion. Our inflation has remained below 4 per cent for the last three months. The Reserve Bank has done a commendable job balancing liquidity and currency management," he told the gathering. Goyal highlighted India as an attractive investment destination. "Over the past 20-



25 years, Indian companies have delivered nearly 20 per cent CAGR returns, making India a compulsive investment destination. FDI inflows are consistently breaking records. We are back on track on the growth trajectory, working through international trading relations," he added. The minister cited progress on various Free Trade Agreements (FTAs), including those with the UAE, Australia, the UK, the four EFTA countries (Iceland, Liechtenstein, Norway, and Switzerland), and the ongoing

bilateral trade agreement negotiations with the US."We are well on track with our bilateral trade agreement with the USA and making fast progress with the European Union's 27-nation bloc. We have also launched negotiations with New Zealand," he stated. The EFTA countries have committed \$100 billion in foreign direct investment (FDI) to India over the next 15 years. This is expected to crystallise into a total investment of \$500 billion.Furthermore, the large

ecosystem that will be created

around this investment has the potential to attract an additional \$500 billion. "We are not aiming small," said Goyal, emphasising that this figure does not include investments from the Norwegian Pension Fund and represents pure FDI.He further highlighted that this is the first Free Trade Agreement (FTA) in the world to include such a forwardlooking investment clause.

Goyal expressed pride at India's continued economic progress and stated that the IMF has projected that by 2027, India will be the world's third largest GDP. He added that despite global volatility, uncertainty and complexity, India remains the fastest-growing economy and continues to power global growth through growth in India. The minister underlined that growth through trade, resilient supply chains and innovation would remain incomplete without inclusive growth.

India Clocks 6.5 Pc GDP Growth In 2024-25, Q4 Growth Surges To 7.4 Pc

New Delhi, (H.S): India's GDP growth accelerated to a robust 7.4 per cent in the fourth quarter of 2024-25, as result of which the growth rate for the full financial year works out to 6.5 per cent on the back of a strong performance of the agriculture, construction, and services sectors, official data released on Friday showed.

The agriculture sector recorded a 4.6 per cent growth rate during 2024-25, up from 2.7 per cent in 2023-24 when an erratic monsoon had damaged crops. During Q4, FY 2024-25, the growth rate of the agriculture sector jumped to 5 per cent compared to 0.8 per cent in Q4 of the previous financial year, figures compiled by the Ministry of Statistics showed. The construction' sector is estimated to have registered an impressive growth rate of 9.4 per cent in FY 2024-25, followed by 8.9 per cent growth rate in the 'Public Administration, Defence & Other Services' sector while the



'Financial, Real Estate & Professional Services' sector posted a 7.2 per cent growth for the financial year. During O4 of FY 2024-25, the construction sector recorded a double-digit growth of 10.8 per cent, followed by an 8.7 per cent growth rate in the 'public administration, defence & other services' sector. The 'financial, real estate & professional services' sector registered a growth of 7.8 per cent in the fourth quarter.Reflecting the strong demand in the economy, private final consumption expenditure recorded a 7.2 per cent growth rate in FY 2024-25 as compared to a 5.6 per cent growth rate in the previous financial year. This was driven in

large measure by rural demand for goods and services shooting up due to higher incomes in the agriculture sector. Apart from the strong performance of the agriculture sector, the massive investments by the government in big ticket infrastructure projects such the highways, railways, ports and airports have helped to drive up the growth rate as India continues to be the fastest growing economy amid the global slowdown. The IMF has forecast India to be the only economy that is expected to clock an over 6 per cent growth rate in 2025-26, as the US tariff turmoil is expected to disrupt world trade and slow down the growth of the global economy.

Finance Ministry Urges RBI To Exclude Small **Borrowers From New Gold Loan Norms**

New Delhi, (H.S): The Finance Ministry said on Friday it has suggested that the Reserve Bank of India (RBI) should exclude small borrowers of up to Rs 2 lakh from the provisions of its draft directions on lending against gold collateral. The Finance Ministry has also suggested that the implementation of the guidelines be postponed to next year."The draft directions on lending against gold collateral issued by the RBI have been examined by the Department of Financial Services (DFS) under the guidance of Finance Minister Nirmala Sitharaman.

The DFS has given suggestions to the RBI to ensure that the requirements of the small gold loan borrowers are not adversely affected," the Finance Ministry said in a statement on X. DFS has also stated that such guidelines will need time to implement at the field level and hence may be suitable for implementation from January 1, 2026 only, the statement said. Further, DFS has suggested that borrowers below Rs 2 lakh may excluded from the requirements of these proposed



directions to ensure timely and speedy disbursement of loans for such small ticket borrowers, the statement explained."RBI is reviewing the feedback received on the Draft guidelines. It is expected that concerns raised by various stakeholders, as well as the feedback received from the public, will be duly considered by the RBI before finalising the directions on the same.

The draft guidelines are now intended to harmonise norms across different types of lenders, while also reflecting their respective risk-bearing capacities.

India's Household Savings May Surge To 22 Lakh Crore In FY25



Mumbai, (H.S): Net financial savings of India's household sector may reach Rs 22 lakh crore or 6.5 per cent of gross national disposable income (GNDI) in FY25 based on the current trends, according to an SBI report released on Friday. With the latest RBI annual report indicating that the household sector showed strong financial resilience,

with net savings rising to 5.1 per cent of gross national disposable income (GNDI) in FY24, the SBI report says this growing capital pool remains crucial for funding government and corporate deficits and supporting macroeconomic stability. Further, as against the increase in household liabilities to 6.1 per cent of GNDI, the gross financial savings of households increased to 11.2 per cent of GNDI in 2023-24 from 10.7 per cent in the previous year. As per the central bank report, the RBI's balance sheet expanded by 8.19 per cent in FY25, less than the

nominal GDP growth of 9.9 per cent. Despite contractions in traditional income, streams such as domestic interest and LAF earnings, strategic management of foreign exchange and efforts to mitigate rupee volatility materially enhanced surplus generation. A Rs 44,861.7 crore provision to the Contingency Fund kept realised equity healthy at 7.5 per cent of the balance sheet, enabling record Rs 2.69 lakh crore surplus transfers to the government and enhancing the fiscal space.

Further, total gold holdings were at 879.58 metric tonnes, reflecting an increase of 57.48 metric tonnes of gold during FY25. The share of gold in NFA increased to 12.0 per cent as at end-March 2025 from 8.3 per cent as at end-March 2024 due to appreciation in gold prices. Currency in circulation expanded steadily in FY25, with banknotes in circulation rising by 6 per cent in value and 5.6 per cent in

volume. Rs 500 notes dominated both value and volume. Withdrawal of Rs 2,000 notes progressed well, reclaiming 98.2 per cent of those in circulation. Increased issuance of durable Rs 10 coins alongside reduced Rs 10 notes marks a costeffective currency shift. Counterfeit note detections fell overall by 2.4 per cent to 2.17 lakh pieces but rose for the Rs 200 and Rs 500 denominations, necessitating ongoing advancements in anticounterfeiting technologies and enforcement mechanisms.In the digital domain,

the RBI's retail digital currency pilot, encompassing 17 banks and 60 million users, witnessed the value of the digital currency in circulation soaring by an impressive 334 per cent in FY25. The introduction of offline functionality and programmable features, coupled with the inclusion of non-bank wallet providers, augments financial inclusion and signals a transformative evolution in India's payments ecosystem.

UPI Share Surges To 83.7% In Digital Transactions For FY25

Mumbai, (H.S): The Unified Payments Interface (UPI) has strengthened its dominance in India's digital payments system with its share in the total transaction volume rising to 83.7 per cent in 2024-25 from 79.7 per cent in the previous financial year. The RBI's annual report shows that UPI facilitated 185.8 billion transactions during 2024-25, which represents a 41 per cent year-on-year increase. In value terms, UPI transactions rose to Rs 261 lakh crore from Rs 200 lakh crore in FY24. "The success of UPI placed India in a leadership position with a share of 48.5 per



cent in global real-time payments by volume," the RBI said. Total digital payments in the country, including transactions through payment systems, card networks prepaid payment

instruments (PPIs), grew 35 per cent to 221.9 billion in FY25, from 164.4 billion transactions in FY24. In value terms, total digital payments surged 17.97 per cent to Rs 2,862 lakh crore. Credit card transactions increased to 4.7 billion in FY25 from 3.5 billion in FY24, while debit card usage saw a sharp 29.5 per cent decline, falling to 1.6 billion transactions. The share of digital transactions in the total volume of non-cash retail payments stood at 99.9 per cent in FY25 compared with 99.8 per cent in FY24. The RBI also said it remains committed to extending UPI to 20 countries by

2028-29. Acceptance of Indian UPI apps via QR codes has already been enabled in Bhutan, France, Mauritius, Nepal, Singapore, Sri Lanka, and the UAE, allowing Indian tourists, students, and business travellers to make merchant payments using their domestic UPI apps. The RBI also said that the total incidence of fraud cases declined, but fraud amounts tripled to Rs 36,014 crore, mainly due to surging advances related to fraud. In contrast, card and internet fraud volume diminished significantly from 29,802 in FY24 to 13,516 in FY25.

Vipin filed a complaint against Unni in FEFKA and AMMA. Both film bodies are trying to resolve the issue.

On Monday evening, Vipin filed a police complaint against Unni, alleging that he was beaten up by the actor in the parking lot of his Kochi apartment. He claimed an altercation broke out between them over a post praising Tovino Thomas' latest release Narivetta. Unni has since admitted to breaking Vipin's sunglasses but denied physical assault. He also claimed the fight between them was over rumours being spread by Vipin, claiming that his friendship with Tovino hasn't been affected by this.

Delhi Court Compounds Defamation Case Against Wrestler Bajrang Punia

New Delhi, (HS): A Delhi court has compounded a criminal defamation complaint against wrestler Bajrang Punia after he tendered an unconditional apology to coach and complainant Naresh Dahiya. The Haryana teen, whose father is a construction worker, has been doing well at the continental level, having earlier collected a gold at the Asian Under-23 Championships in 2023.

In the women's high jump, Pooja clinched a gold medal with a season-best effort of 1.89m. In the process, she also broke her own Under-20 national record. Moreover, the 18-year-old became the second Indian to win a medal in the high jump at the Asian Championships after

Bobby Aloysius, who won gold in 2000 and silver in 2002. Nandini Agasara then added the third gold to the day's tally after winning the women's

heptathlon with 5941 points. Earlier in the day, Parul Chaudhary won silver in the women's 3000m steeplechase, clocked 9:12.46 and set a new national record. She also held the previous record of 9:13.39, set at the 2025 Doha Diamond League. Meanwhile, Animesh Kujur stormed into the final of the men's 200m event after finishing second in the semifinal, clocking 20.81s. India are currently second in the medal tally with 18 medals, including eight gold, seven silver and three bronze, behind China's tally of 24 medals (15 gold, eight silver

and three bronze).
