#### **Supreme** Court Judge's Big Remark



New Delhi, (HS): Caste-based reservation in the country has become like a train compartment and people who get into this compartment don't want to let others in, a Supreme Court judge said today. Justice Surva Kant, who will take over as Chief Justice later this year, made the observations while hearing a case related to reservations for Other Backward Classes (OBCs) in local body polls in Maharashtra. Local body polls in Maharashtra were last held in 2016-2017. The key reason for the delay in holding posts in the legal fight over quota for candidates from Other Backward Classes (OBCs). In 2021, the Supreme Court struck down a Maharashtra government ordinance to implement a 27 per cent quota for OBCs. The court laid down a three-fold test: (1) setting up a dedicated commission to conduct contemporaneous rigorous empirical inquiry into the nature and implications of backwardness in local bodies of the state, (2) specifying proportion of reservation required to be provisioned in local body wise in the light of recommendations of the Commission, (3) total reservation for SCs/STs/OBCs shall not exceed 50 per cent. Since then, delays in data collection and litigation have stalled attempts to hold the

local body polls in the state. Advocate Indira Jaising, appearing for the petitioner, told the court that despite the identification of OBCs during delimitation, Maharashtra was not using the data for the local body election. She stressed the need to hold elections for local bodies soon and alleged that the state government was running local bodies unilaterally through handpicked officials. Advocate Gopal Sankaranarayanan, appearing for a petitioner in the same matter, told the court that within the OBCs, politically backward and socially backward classes should be identified for the purpose of reservations.

### 'India's water used to go outside, it'll now...': PM on Indus Waters Treaty

from India's rivers will now be used for the country's interests, Prime Minister Narendra Modi said on Tuesday evening, speaking on the government's intention to curb the flow of water to Pakistan amid escalating tensions between New Delhi and Islamabad. "India's water earlier used to go outside; it will now be used for India's interests and will be utilised for the country," PM Modi said without naming Pakistan in the course of his address at a conclave organised by ABP network.

"Bharat ka paani, Bharat ke haq mein bahe ga (India's water will now flow for India)," he said.PM Modi's statement comes against the backdrop of the government taking steps to cut off water flow to Pakistan from the Baglihar dam on the Chenab river and preparations to taper down runoffs from the Kishanganga project on the Jhelum.India has paused the sixdecade-old Indus Waters Treaty with Pakistan, already strained by long-running disputes, after terrorists killed dozens of tourists in Kashmir's Pahalgam on April



22.Ever since, government officials have said earlier, the government had been exploring ways to use the river waters for the benefit of Indians. The Indus treaty, mediated by the World Bank allocates water from six rivers - the Indus, Jhelum, Chenab, Ravi, Beas, and Sutlej between India and Pakistan. The prime minister also said that the government in the last 10 years has taken several tough decisions that were in the national interest

but were not implemented by previous governments due to a lack of political will. "To take big decisions, to achieve our goals, it is important that we put the country's interests at the top...Unfortunately, for decades, the thought process was otherwise, and the country suffered a lot. There was a time when, before taking any big decision, before taking any big step, it used to be said what will the world think. For various

politics, et cetera, big reforms and big decisions were put on hold. No country can progress this way," he said. The prime minister said a country moves forward when decisions are only based on one parameter - the nation first. "In the last one decade, India has followed this policy of nation first and today we are seeing the results. In the last 10-11 years, the government has taken big decisions one after the other that had been put on hold," he said. Asserting that "democracy

can deliver", he reiterated in the last one decade, 25 crore people have been pulled out of poverty and the whole world got the message that democracy can deliver. The attack has brought the international community rallying behind India. The matter has resonated in the United Nations as well, which has taken Pakistan to task. The country is now preparing for an unprecedented civil defence security drill tomorrow to "train civilians and students for effective civil defence in the event of a hostile attack".

"In view of this, I request the Government of West Bengal to reconsider the usage of the name 'Jagannath Dham' in relation to the Jagannath temple recently established at Digha and refrain from using the term 'Jagannath Dham' in its official naming, communication, and promotional materials. I sincerely hope that the Government of West Bengal will uphold the spirit of inter-state respect and cultural sensitivity in this matter and take necessary steps to address our concerns,' the letter stated.

### Monsoon arrival in Andaman And Nicobar Islands likely by May 13

New Delhi, (HS): The Southwest Monsoon has advanced and is likely to hit parts of Andaman and Nicobar Islands and the Andaman Sea on May 13, the India Meteorological Department (IMD) estimated.The monsoon normally advances around June 1 to Kerala and further heads northwards, usually in surges, and covers the entire country by around July 15, this is the usual trend. But this year it appears that the monsoon shall arrive earlier than expected.

It is estimated that the monsoon shall arrive in Kerala shores by May 25, as estimated by the IMD, this shall be earlier than the usual date of June 1. However, the IMD maintains



that past data suggests that there is no direct association of the date of monsoon advance over Andaman Sea either with the date of monsoon onset over Kerala or with the seasonal monsoon rainfall over the country. The IMD forecast said that, in view strengthening southwesterlies in the lower tropospheric levels, there would

be fairly widespread to widespread rainfall activity and persistent clouds over various areas. The IMD has issued a press release in this regard which reads as follows: "Southwest Monsoon is very likely to advance into South Andaman Sea, some parts of Southeast Bay of Bengal and Nicobar Islands around 13th May, 2025."

#### Heatwave Scorches Odisha: Titilagarh Hits 39.5°C, Bhubaneswar at 36.7°C (38.0°C), and Malkangiri

Bhubaneswar, (DMC): The sweltering heatwave conditions continue to grip Odisha, with several towns recording high daytime temperatures on Tuesday. Titilagarh remained the hottest place in the state, registering a maximum temperature of 39.5°C, according to the Regional Meteorological Centre in Bhubaneswar. Bhubaneswar recorded 36.7°C, while neighbouring Cuttack reported 35.6°C.Other towns witnessing extreme heat included Balangir (38.7°C), Jharsuguda and Sambalpur (38.6°C each), Bhawanipatna (38.5°C), Paralakhemundi (38.4°C), Boudh

(37.6°C).

Hirakud and Sundargarh recorded 37.2°C, Nayagarh 37.4°C, Khordha 37.5°C, and Sonepur 36.9°C. Talcher, Angul, and Rourkela also saw temperatures exceeding 36°C. "Odisha will continue to witness similar temperature levels for the next two days," said Dr. Sanjeev Dwivedi, weather scientist at the Regional Meteorological Centre. "After that, a gradual rise of 2 to 4 degrees Celsius in maximum temperatures is likely across many districts."

Other notable temperatures included Baripada (36.0°C),

### Pakistan asked 'tough questions' by UNSC members over Pahalgam attack

New York/New Delhi, (HS): The United Nations Security Council members raised tough questions for Pakistan at its informal closed-door session on Monday, sources in New York told ANI. The 15-nation Security Council held deliberations on Monday afternoon amid growing tensions between India and Pakistan.

There was no statement published by the UN body following the "closed consultations" that were requested by Pakistan, a nonpermanent member of the Council whose presidency for May is currently held by Greece. Sources told ANI that UN Security Council members raised



tough questions for Pakistan at its informal closed-door session. The members refused to accept the "false flag" narrative planted by the Pakistani side and asked whether the Lashkar-e-Taiba, a proscribed terror organisation with deep ties to Pakistan, was likely to be involved in the terror attack. Sources said there was broad condemnation of the terrorist attack and recognition of the need for accountability. Some members specifically brought up the targeting of tourists based on their religious faith. Many members expressed concern that Pakistan's missile tests and nuclear rhetoric were escalatory factors. Pakistan on Monday

### **CRRR** Infra

The swift urban development of Bhubaneswar and its neighboring city, Cuttack, has created an urgent demand for a contemporary transportation infrastructure. Traffic congestion has long characterized these urban centers, with major thoroughfares often experiencing significant delays, especially during peak traffic times. The busy NH-16 corridor in Bhubaneswar and the narrow roads in Cuttack frequently struggle to handle the growing number of vehicles, leading to extended traffic jams and increased air pollution. In response to this escalating issue, the Central Government has initiated discussions within the Cabinet regarding the Capital Region Ring Road (CRRR), which is intended to transform the transportation framework of Odisha's major urban areas, as highlighted by Union Minister Nitin Gadkari during his recent visit to the state. The CRRR initiative, estimated to cost Rs 7000 crore, plans to construct a 111-kilometer, six-lane expressway encircling Bhubaneswar. This project will be designed and implemented by the National Highways Authority of India (NHAI) under the Bharatmala Pariyojana scheme, with the goal of efficiently connecting the cities of Cuttack, Bhubaneswar, Khordah, and Choudwar while alleviating congestion on internal city roads. The proposed route for the CRRR will begin at Tangi in Cuttack, passing through Barapada, Rajabati, Govindpur, Shankarpur, Banki, Bandhahat, and Haldia, before ending at Rameswar in KhurdaThe CRRR's initial scale and complexity are impressive. The roadway will include nine strategically placed flyovers to ensure smooth traffic flow over major intersections, along with twenty-nine underpasses for vehicles to enable local traffic to navigate without disrupting high-speed highway operations.

Additionally, three pedestrian overbridges will be constructed to enhance safety for pedestrians in semi-urban areas. A significant bridge spanning the Mahanadi River will connect essential transit locations and further enhance intercity connectivity. Service lanes will be established on both sides of the road to provide safer access points for local traffic and minimize abrupt slowdowns on the main highway. The CRRR is set to significantly alleviate congestion on Bhubaneswar's central arterial routes, particularly along NH-16, which currently handles a substantial volume of interstate freight and intra-city travel. Heavy vehicles, such as trucks and long-distance buses, will be rerouted to the outer ring, thereby clearing essential urban roads for local traffic. This realignment is projected to reduce travel times through Bhubaneswar and Cuttack by as much as 40% during peak traffic hours, based on preliminary project assessments. The Capital Region Ring Road (CRRR) will establish a high-speed transit corridor that connects major hubs such as Bhubaneswar, Cuttack, Khordha, and surrounding towns, bypassing inner city routes. This development is anticipated to significantly enhance logistics operations, facilitate interstate goods transportation, and improve emergency services by alleviating traffic congestion and reducing transit times. Furthermore, the ring road is poised to act not only as a means of decongestion but also as a catalyst for the establishment of new economic zones, industrial parks, and residential developments along its route. Improved connectivity is expected to attract investments in peripheral regions, promoting balanced regional growth. Ultimately, the CRRR will represent a pivotal advancement in Odisha's infrastructure landscape, signifying a major milestone for the capital region of the state.

### Trade Imbalance of USA

common man and a horror drama for the economists. Historically, US was running

trade surplus against rest of the world prior to 1960. When the second world war ended, USA was the only large country that remained financially strong and had a large market. Therefore, when the Bretton Woods agreements were made and several international institutions were created, US had the dominant voice in the matter. While the headquarters of UNO, IMF and World Bank were set up in USA, US dollar was linked to gold and became the reserve currency of the world. In 1971 USA discontinued linkage to gold and allowed USD to float. In 1960s and 1970s US was running trade deficit in some years and surplus in some years and the quantum of deficit or surplus were relatively small. In 1975, US had the last surplus trade balance. But after 1980s, it started running deficit continuously and slowly the quantum of deficit started rising. In 1985 it had started a trend of rising trade deficit with China. In 1990s it increased further and US had trade deficit with many Asian countries as well. After 2000, the trade deficit exceeded 2% of the GDP and in 2024 the deficit was USD 918 billion representing 3.1% of its GDP. The trade imbalance of USA is mainly due to higher level of consumer demand, gap between savings and investment and tariff and trade barriers imposed by some countries. Country-wise, US had large trade deficits against China (\$270bn), Mexico (\$157bn), Vietnam (\$113 bn), Ireland (\$80bn), Germany (\$76 bn), Taiwan, Japan, South Korea and Canada in 2024. US had a trade deficit of \$235 bn against EU and a much smaller deficit of \$41 bn against India. The trade deficit against China has been rising year after year as it has gone up from an average of \$ 35 bn per annum in 1990s to the present level



entered in to a high export regime due to demand for semi conductors, solar energy cells and electric vehicles. Since the trade deficit of USA has been rising, one section of Americans felt that America can reverse the trend by increasing tariff on goods imported from other countries. This will make imported goods more expensive and encourage local companies to manufacture goods which are otherwise imported now. Local manufacturing will help the economy and generate employment for Americans. Further, import of certain electronic goods from China has been seen as a threat to national security. Some law makers also believed that China has used unfair practices such as currency manipulation, wage suppression and government subsidies to promote exports. Therefore, the republicans in USA came to the conclusion that a higher tariff on all goods imported by USA should set right the wrong done to USA in all these years.

But the issue is whether American industries can produce the goods at a much cheaper rate than the imported cost. Though labour cost is one of the deciding factor in cost of production, it is not the sole deciding factor any more due to mechanization of most of the manufacturing operations. In fact, the labour cost in China is much higher than many other countries in Asia and South America. But China has

been able to reduce the manufacturing cost due to superior infrastructure, skilled and disciplined work force and economy of scale of operation. The federal minimum wage in USA is \$ 7.50 per hour whereas the actual wage of skilled workers is around \$ 20 per hour. As against this, the minimum wage in china is about \$1.8-3.00 per hour. Since the labour cost in USA is one of the highest in the world, US companies like Apple had to shift their operations to China and India. Secondly, considering the large market size and consumer base in China and India and availability of skilled work force, some of the other mobile makers have also set up factories in China and India. Further, wherever manual input is required to a larger extent like garments, footwear etc, it is wiser to get the manufacturing done where the labour is cheap. Manufacturing has been a major economic activity in USA after second world war. After China, USA is the largest manufacturer in the world. US manufacturing employs more than 12 million people. But manufacturing contributes only 10% to its GDP, agriculture about 6% and the remaining comes from the services sector. Due to higher cost of production, it is focusing on high value goods for manufacturing in USA and outsourcing lower value goods from relatively cheaper destinations. To shift back the

to USA will be a time consuming process. Further, unless the process is fully mechanized, manufacturing low value items may not be economically viable in USA. In the meantime, raising the tariff on imported goods will raise the price of such goods in USA and the US consumers will have to pay for it which will raise inflation. Further, though USA is a mineral rich country it still has deficit in aluminium and steel and it has to import these raw materials. Imposing a higher tariff on such metals will increase the cost of the final products and make them uncompetitive.

While some economists argue that holding a continuous trade deficit will harm the US economy and all other countries are enjoying at the cost of USA, some other arguments are put forward for US maintaining a deficit position. It is argued that since USD is the primary reserve currency of the world, the Rest of the World (ROW) can hold USD reserves if they have a surplus against USA. This allows USA to borrow the surplus money of the ROW at a much cheaper rate through bonds route. Some of the surplus money of the ROW also support the equity market in USA. Despite all the arguments for and against, what caused turmoil in the global market is the upswing and downswing in the tariff rates dished out by USA unilaterally. Creation of enemies out of long term allies and the threat to acquire Greenland and Panama canal by force and ignoring democratic institutions like judiciary, deporting people out of USA without following a process of law and going against universities to have a control of them passed on shock waves across the globe. This gave an impression that the US has deviated from its democratic principles and turned in to an imperialistic and autocratic country which has caused immense damage to the image of USA. It will take lot of time and effort for USA to regain confidence of the international community.

Spirituality is the science of understanding and managing the human mind. Bhagwad Gita, the essence of all Upanishads, has dealt with the human mind vividly. Krishna says, 'Yogah Karmasu Kaushalam' - One who has acquired skills to manage his mind is capable of executing any other worldly activity in a most efficient manner. In chapter six, verse 34 of the Gita, Arjuna expresses his doubt to Krishna about mind control. He says the mind is so restless and powerful that it is impossible to control it. However, in the very next verse, Krishna explains that while it is definitely difficult to control the mind, one can achieve control through abhyasa, continuous practice, and with a sense of

vairagya, detachment. Mind is perceived as a continuous flow of thoughts. Reportedly, an average of 80,000 thoughts are generated in a day. Depending on the

outcome, we become angry in case of failure, and become fearful of losing acquisitions in case of success. These emotions, emanating from desires, create turbulence and agitation in our mind, and consequently, we lose mental peace.

The Gita recommends the practice of Karma Sanvasa, an attitude of selfless, dedicated actions without desire for the fruits of these actions, which will eventually help the practitioner to achieve an expansive state of mind. Mind works like a pendulum, oscillating between two extremes of dualities. Consequently, our life experiences also oscillate between dualities of happinesssorrow; love-hate, etc. While we do have little control over the external happenings, we can definitely control our emotional outcomes due to the external triggers, provided we have control over our mind. When our mind becomes subordinate to us, we achieve a state of middle path or Sthitapragnya, which has been explained by Krishna in 2:56 of Bhagwad Gita. The mind is a tool to achieve higher levels of consciousness, wisdom and bliss. But, the mind is also a double-edged sword, which could lead to low levels of human suffering, if not used properly. Hence, there is a need to understand the functioning of mind, the process to control it and make it subservient. A person who succeeds in controlling the mind and creating a state of inner silence gets access to Sat-Chit-Anand, the field of universal truth, wisdom and bliss.

### Odisha's Go-Palan Yojana Gains Momentum With High-Yielding Cattle Induction

being actively promoted at the highest level, with approval letters issued by the Minister of Fisheries & Animal Resources Development, Gokulananda Mallick, and Principal Secretary Suresh Kumar Vashishth during the recently held Matsya-Pranee Samavesh Odisha (MPSO)-2025. With highquality cows now reaching remote areas, the program is gaining traction as a potential game-changer for Odisha's dairy

economy. The Go-Palan Yojana is not only registering a high rate of cow induction but is also witnessing faster subsidy disbursal, with district authorities releasing subsidies within 7-10 days of project completion. This swift execution is encouraging youth, cattle keepers, and livestock farming enthusiasts across the state to adopt dairy farming with greater confidence.One standout

example is Kandhamal district, which has become the first to successfully implement GPY projects for three beneficiarieseach of them women dairy farmers. The milestone highlights the scheme's inclusive vision, focusing on both economic development and gender equity. With high-yielding cows now reaching even remote areas, the Go-Palan Yojana is being seen as a potential game-changer in transforming Odisha's rural economy.

### Health Secy Reviews Fire Safety In Govt Hospitals, **Directs Measures To Ensure Patient Safety**

Bhubaneswar, (DMC): Health Secretary Aswathy S chaired a high-level meeting at Lok Seva Bhawan to review fire safety measures in government hospitals, ranging from Community Health Centres to medical colleges and hospitals, emphasising the importance of ensuring patient and staff safety.

During the review meeting, the Health Secretary, Aswathy S directed hospitals to prioritise fire safety in high-risk areas, including Operation Theatres, ICUs, SNCUs, and installations like CT scan and MRI machines. She emphasised safe electrical



connections, particularly with generators, to prevent short circuits. To enhance safety, it was decided that fire safety structures would be integrated into hospital building plans from the outset, eliminating the need for retrofitting later.Joint committees comprising fire officers, electrical inspectors,

engineers, and chief medical officers were tasked with inspecting government health facilities to identify fire safety gaps. They were directed to submit a detailed report with corrective measures and estimated plans within 15 days.

Districts were instructed to

implement necessary corrective

actions to obtain electrical and fire safety certificates. The state government has allocated approximately Rs. 300 crore to enhance fire safety in government health institutions. Secretary Ms. Aswathy assured districts that funds would be provided based on their corrective plans, emphasising completion.

To ensure ongoing safety, districts were directed to conduct regular mock fire drills with local fire officers, hold review meetings, and maintain electrical and fire safety

equipment. A state-level joint team will monitor progress through field visits. Mission Director Dr D Brundha, Managing Director Odisha State Medical Corporation Dr Pooma Tudu, Director Medical Education and Training Dr Santosh Kumar Mishra along with senior officers from Fire Service,

Roads and Buildings, Ph.D, WATCO participated in deliberations. Special Secretary and Director Health Services Bijaya Kumar Mohapatra outlined the issues and updates for discussion.

The public hearing held under the chairmanship of Additional District Magistrate Ravindra Kumar Pradhan and Regional officer (RO), Odisha State Pollution Control Board (OSPCB), Keonjhar Prashant Kumar Kar present and heard the consent of the affected villagers. In this, the villagers expressed their opinion and support the projects with placing some conditions and demands with the authorities. Among those, the main demands were to provide employment to local people



giving priority, education in the area, health, transportation, and street lighting in the villages. "In this plant, high-quality iron ore will be produced using new technology. The company has informed that 250 employees will be employed in this" said Debasish Manas Ranjan Sethy,

Mines manager Unchabali iron and Manganese mines. Company sources said that this mine, measuring 106.1127 hectares, was leased to M/s Indrani Patnaik in the year 1999 for 30 years. However, as per the new mining policy amendment, its lease period has been extended till 2049.As now, low-grade iron ore is being extracted from this mine, which has no demand in the market. The company has made efforts to make the mine reuse with extracting suitable iron ore fines using morden technology and magnetic separation.

As a result, many people depending on this mine are facing the loss of their livelihood, company sources added. "The public hearing was held peacefully. Opinion of the public took" said Prashant Kumar Kar, RO, OSPCB.

Defence Districts nationwide. This nationwide drill aims to evaluate and enhance the country's preparedness in responding to potential threats. In Odisha, the exercise will be conducted at 12 key locations, ensuring a thorough assessment of emergency response systems and protocols. The 12 locations in Odisha where the mock drill will be held include Balasore, Koraput, Bhubaneswar, Gopalpur, Hirakud, Paradip, Rourkela, Bhadrak, Dhenkanal, Jagatsinghpur, Kendrapara and Talcher. The decision is part of a nationwide Civil Defence Mock Drill initiative announced by the Union Ministry of Home Affairs. The letter sent to all State and UT authorities directed that on 7th May 2025, a full-scale civil defence rehearsal be conducted in all 244 categorised Civil Defence Districts across India. The aim, as stated, is to enhance readiness and coordination at all administrative levels, down to the village. The Ministry specified that the drills are being held to assess and enhance operational efficacy, communication links with the Indian Air Force, civilian training, and response to hostile threats, particularly air raids. Odisha's drills are expected to closely mirror this national agenda. The announcement follows the April 22 attack in Pahalgam, Jammu and Kashmir, where 26 were killed in a terrorist ambush in which Pakistan-based terror outfits claimed responsibility for the assault. In response, India has given its armed forces a free hand, and civil defence mechanisms are being activated across the nation.

#### **India & Pakistan Have Done to Hurt Each** Other Since Kashmir Terror Attack



New Delhi, (HS): The already-frosty ties between neighbouring India and Pakistan have nosedived to a new low after the religiously-targeted terror attack in Jammu and Kashmir's Pahalgam, in which 26 tourists, including one foreign national were shot dead last month. INDIA'S WARNING - After one of the worst terror attacks on civilians in Jammu and Kashmir in decades, India has taken a slew of measures, mostly diplomatic and administrative so far. New Delhi has also pledged to "hunt down" terrorists and their backers to the "ends of the Earth" and punish them "beyond imagination", suggesting a likely covert, kinetic, or military response to follow at a "time and place of choosing". To this, Pakistan, which has been practicing "cross-border terror" and has a history of financing and fostering terrorists in the country, as well as regions under its illegal occupation, has responded with whatever Islamabad and Rawalpindi (military headquarters) could muster up. The terror attack in Kashmir, in which 26 civilians were killed after being asked to prove their allegiance to Islam, came days after an inflammatory and communal speech by Pakistan Army Chief Asim Munir. The terror attack was claimed by The Resistance Front, a shadow arm of the globally banned Pakistani terror outfit Lashkar-e-Taiba or LeT. WATER - India's first announcement after the attack with stern diplomatic measures against Pakistan was to put the 1960 Indus Waters Treaty in "abeyance" till such time that "Pakistan credibly and irrevocably abjures its support for crossborder terrorism." India's decision to suspend the over six-decade-old water-sharing treaty, which has survived three wars - 1965, 1971, and 1999 - reflects the depths of New Delhi's frustration with Islamabad over Pakistan's use of terrorism as an "instrument of state policy". Under the agreement, waters of the Indus river and its tributaries - Sutlej, Beas, Ravi, Chenab, and Jhelum are to be shared between India and Pakistan, wherein water from the eastern three rivers would be used by India, while waters of the western three rivers would be shared with Pakistan. Technically, India being the upper riparian State, has rights over all six rivers, but on friendly terms, India had agreed to share the waters with Pakistan, where the natural resource is scarce. That is now put on hold indefinitely. Pakistan, which is heavily dependent on the water for its hydropower and irrigation, has said any attempt to stop or divert its flow will be considered an "act of war".

#### Gaganyaan Mission to be Held in First Quarter of 2027: **ISRO Chief**

New Delhi, (HS): The launch of India's maiden human space flight --Gaganyaan -- has been pushed to the first quarter of 2027, nearly five years later than the original schedule as it races to ace technologies for such complex projects. The first uncrewed mission of the Gaganyaan project is expected to be launched later this year, which will be followed by two more similar missions in 2026, Indian Space Research Organisation (ISRO) Chairman V Narayanan said at a press conference. "The first crewed mission is targeted for the first quarter of 2027," V Narayanan said and added ISRO would send a half-humanoid robot --Vyommitra -- as part of the uncrewed mission before sending astronauts to low-Earth orbit. Prime Minister Narendra Modi announced the Gaganyaan project during his Independence Day address in 2018 and set a target of 2022 for achieving India's maiden human space flight. The project has run into several delays, partly due to the Covid pandemic that affected the training of astronauts, and complexities of mastering the crucial technologies required for the mission.

### **India rejects OIC statement on** Pahalgam terror attack as 'absurd'



New (HS): India on Tuesday hit out at the Organisation of Islamic Cooperation (OIC) for refusing to recognise crossborder linkages to the Pahalgam terror attack. The Ministry of External Affairs (MEA) described the

Delhi.

OIC's statement on the attack as "absurd" and said it was made at Pakistan's behest. "The OIC statement, issued at the behest of Pakistan, is absurd in refusing to recognise the facts of the Pahalgam terrorist attack and its cross-border linkages," MEA spokesperson Randhir Jaiswal said. "This is yet another attempt by Pakistan, a country that has long engaged in cross-border terrorism, to manipulate and misguide the OIC group to issue a self-serving statement," he said. "We reject the OIC's interference on matters that are internal to India." Jaiswal added. According to the state-run Anadolu Agency of Turkey, which is part of the OIC since its establishment, the statement also said that India's "unfounded allegations against the Islamic Republic of Pakistan" were the factor behind escalating tensions between New Delhi and Islamabad. OIC further stated that the accusations by India risk exacerbating an already volatile situation, and reiterated its "principled position against, and condemnation of terrorism in all its forms and manifestations, committed by whomsoever and wherever." attempts to associate any country, race, religion, culture or nationality with terrorism." The tension between India and Pakistan rose following the April 22 terror attack in Jammu and Kashmir's Pahalgam, which killed 26 people, including tourists. Following the Pahalgam attack, India has taken strong countermeasures against Pakistan for its support of cross-border terrorism. ## MHA conducts key review meeting ahead of massive mock drill

# Identifies 19 'top priority' sites out of 250 districts

New Delhi, (HS): The government has identified over 250 specially designated 'civil defence districts' across the country having sensitive installations like nuclear plants, military bases, refineries and hydroelectric dams, for the nationwide mock drill planned for Wednesday.

Union Home Secretary Govind Mohan on Tuesday chaired a key review meeting through video conferencing with chief secretaries of the states and the Union Territories (UTs) to finalise protocols for the massive mock drill conducted amid escalating tensions with Pakistan in the aftermath of the April 22 Pahalgam terror attack.

The meeting was attended by chief secretaries and heads of civil defence from across the states besides officials from key Central forces and agencies including Directors General of Civil Defence and the National Disaster Response Force (NDRF). Officials said during the meeting, the participants identified "loopholes" in the defence "We reviewed mechanism. preparedness. Loopholes have been identified," a senior official of the National Disaster Management Authority (NDMA) told. The state officials have been asked to involve students of educational institutions, employees of government and private organisations, hospital staff, railway and metro officials, besides uniformed personnel of the police, paramilitary and defence forces, while conducting the mock drills, the sources said. According to sources, officials have been informed that the areas having a cantonment, refinery or a nuclear plant should be



given special consideration as 'civil defence districts' depending on the requirement and exigency. A senior official said, "Such districts are designated by the respective state authorities, and we believe, the mock drills will be carried out in over 250 such civil defence districts across the country." The MHA had on Monday issued an advisory directing all states and UTs to conduct coordinated civil defence exercises on May 7. These drills will cover all of India's over 250 designated civil defence districts, many of which have been identified as vulnerable to various threats, including potential wartime scenarios. According to sources, out of the 250 sites, 19 have been identified as to be given 'top priority' in Wednesday's drill. The main objective of the exercise is to evaluate and enhance the preparedness of civil defence machinery in the face of any potential hostile attacks or emergencies. The mock drill will simulate a war-like situation and is expected to include the

operationalisation of air raid warning systems, including the sounding of sirens, coordinated responses from local emergency services, and public safety drills. "The idea is to prepare the nation and its administrative framework for contingencies that could arise in a hostile environment. The civil defence drill will be the first of its kind in decades and will test both infrastructure and human response across multiple regions simultaneously," an official said. This is the first such exercise since 1971. Notably, no such national-level civil defence drills were carried out even during the 1999 Kargil conflict (Operation Vijay). Officials stressed the importance of public cooperation, with local authorities expected to issue detailed advisories on how residents in vulnerable zones should respond during the drill. State disaster response forces, health departments, local police, and district administrations will all participate in the exercise. The backdrop to this drill - growing tension on the

western border - underscores the urgency. The April 22 attack in Pahalgam, in which several security personnel and civilians were killed, has intensified concerns over cross-border terrorism and the possibility of further

While the government has not made any official link between the mock drill and the current geopolitical climate, the timing of the exercise has raised eyebrows among analysts and defence observers."This is a clear message that India is not taking any threat lightly. While it's a routine preparedness measure on paper, the scale and timing of the drill are clearly in response to the deteriorating regional security scenario," a senior retired military officer noted. As India prepares for the May 7 drill, authorities are urging citizens not to panic, assuring them that the exercises are strictly precautionary and designed to improve national resilience.

#### Police baton-charge TRE-3 aspirants protesting near CM's residence in Patna over delay in results

PATNA, (HS): Police on Tuesday used baton charge to disperse a group of job aspirants protesting outside Bihar Chief Minister Nitish Kumar's official residence, demanding the release of supplementary results for the Teacher Recruitment Examination (TRE-3). Several protestors claimed they were injured in the police lathi-charge and warned of intensifying their agitation if the government failed to meet their demands. The TRE-3 aspirants said they had been protesting for the past four months, but had yet to receive a positive response from the authorities. The situation escalated when the protestors, holding placards and banners, allegedly refused to vacate the prohibited area near the Chief Minister's residence despite repeated instructions from police officials. They instead raised slogans against the state government and the Bihar Public Service Commission (BPSC), which conducted the examination. Some protestors reportedly advanced towards the main gate of the Chief Minister's residence, prompting security personnel to intervene and disperse them. Police later used force to clear the crowd, leading to brief chaos in the prohibited zone. The situation was brought under control following the police action. Deepa Singh, a protestor from Siwan, criticised the state government for not releasing the supplementary results of TRE-3. "We are being treated like anti-social elements. We were holding a peaceful sitin outside the CM's residence, but the police used force, injuring many," she told reporters. Madan Prasad, a resident of Vaishali district, said they had been protesting at the Gardanibagh dharna site for over three months. He claimed that a delegation had earlier met Education Minister Sunil Kumar, who promised to consider their demands, but no action followed. "The TRE-3 aspirants acted out of sheer desperation," he said.

#### **Train compartment** those inside don't want others to come in: SC

New Delhi, (HS): The Supreme Court on Tuesday compared reservation in the country with a train and said those who enter the compartment "don't want others to come in." A bench of Justices Surya Kant and N Kotiswar Singh made the remarks while hearing a plea opposing the other Backwards Class (OBC) reservation in Maharashtra local body elections. Senior advocate Gopal Sankaranarayanan, appearing for petitioner Mangesh Shankar Sasane, submitted that Maharashtra government's Jayant Kumar Banthia-led commission gave 27 per cent reservation to OBCs in the local body elections without actually ascertaining if they were politically backward. Justice Kant turned to Sankaranarayanan, "The thing is, in this country, the reservation business has become like a railway. Those who have entered the compartment they don't want anyone else to enter. This is the whole game. That is precisely the game of the petitioner also." Sankaranarayanan said compartments were being "added at the back also" and submitted political backwardness was distinct from social and educational backwardness, and the OBCs couldn't be automatically presumed to be politically backward. "Within the OBCs, politically backward and socially backward classes should be identified for the purpose of reservations," he said. Justice Kant said when one follows the principle of inclusivity, states were bound to identify more classes. "There will be social backward class, politically backwards class, and economically backward classes. Why should they be deprived of the benefit? Why should it be confined to one particular family or group?" he added.

## From Blackouts to Taking Shelter: How War Prep Impacts Life of Civilians

**New Delhi, (HS) :** The country is preparing for an unprecedented civil defence security drill tomorrow to "train civilians and students for effective civil defence in the event of a hostile attack." The order came at a time when tensions between India and Pakistan are at their peak following the Pahalgam terror attack in which 26 civilians were shot

The last such drill took place in 1971 when India and Pakistan went to war. and the latter was split into two, and Bangladesh was formed. The armies of the two countries faced each other again in Kargil in 1999 and during Operation Parakram in 2001-2002, when India mobilised its troops toward the International Border and the LoC after the Parliament attack planned by terrorists operating out of Pakistan. When a threat of war looms over a country, the impact is felt not just by the security forces but also by civilians. There cannot be a knee-jerk reaction to an enemy attack. The Centre has outlined measures for civil defence in India, detailing how people should be trained to respond to an attack. A 2003 document published by the Directorate General Civil Defence outlines general principles of civil defence - A concept that started in 1962 during the India-China war. During the 1971 drill, civilians

were trained to protect themselves from air raids - a threat that seemed imminent because in 1965 Pakistan attacked Indian Forward Operating Bases (FOBs) like Pathankot, Ambala, Agra, Adampur, and Halwara. People were trained to take shelter in bunkers, how to dig trenches. and find a secure, fortified location to protect themselves from enemy bombing. A threat to water supply, public health, sanitation, and essentials is imminent, especially in areas near the conflict zones. The document calls for "Maintenance or restoration of a safe water supply and temporary measures of rendering water safe for drinking purposes and other essential uses." A possibility of water shortage is likely primarily due to damage to supply lines and their use in firefighting operations. "Adequate food inspection during an emergency, especially the inspection of emergency kitchens and canteens. Prevention of epidemics by mass inoculation.'

When a threat of war looms over civilian areas, there's an impact on the movement of traffic, with restrictions on the use of lights in the evening. During the 1962 Indo-China war, 1965 and 1971 India-Pakistan war, there was a complete blackout in big cities like Delhi, Mumbai, Kolkata, Chennai and border cities. The 2003 document details



how lights on cars and other vehicles must be covered to aid in the blackout. "All lights capable of throwing a beam. carried on a motor vehicle, shall be screened," it says and lays down three methods. The first is by passing dry brown paper over the glass, one thickness on the lower half, and two thicknesses on the upper half -- this means a faint light will be emitted from the lower part of the headlamp." Before the start of the Second World War, Britain started preparing civilians for war from the 1930s, when Hitler came to power in Germany. German bombing raids were inevitable, poisonous gas could have been used against civilians

and between 1938 and 1939, over 44 million gas masks were distributed to people. From 1 September 1939, 'Blackout' was enforced. Curtains, cardboard and paint were used to prevent light escaping from houses, offices, factories or shops, which might be used by enemy bombers to locate their targets. Householders could be fined if they did not comply. In Israel, the 1951 Civil Defence Law mandates the construction of bomb shelters in every home, apartment complex. For decades, Israelis have been trained to quickly respond to air raid sirens. During the Lebanon War of 1982, thousands of Israelis spent a long time in shelters.

Even in Ukraine, civil defence, despite its impact on regular movement, access to healthcare, water and other essentials, the Ukrainian government has ensured that digitalisation of public services has allowed the authorities and other providers of critical services to function adequately throughout the war. This has helped people access financial institutions like banks and ATMs to buy essentials, and the continuation of services like healthcare, education, etc.

Civil defence is essentially the defence of citizens by citizens, but a threat of an attack has a psychological impact on the population. During the 1971 war, Bombay was a strategic and tactical target for Pakistan and also the headquarters of the Western Naval Command. In an article for Deccan Herald, Michael Patrao, who was in primary school in 1971, writes, "There used to be mock drills in my school, St Anthony's High School, Santacruz, located not very far from the airport, a potential target. We were instructed to rush into the church when the siren (schoolbell) was sounded...On hearing the mock drill siren, we used to rush to the church." A video of an air raid drill from Mumbai showed people getting off a BEST bus and covering their heads when an air raid siren was sounded. Many took shelter in nearby structures.

M R Narayan Swamy, a veteran journalist, writes, "In 1971, L-shaped trenches had been dug outside our tworoom government flats in Netaji Nagar, in south Delhi, so that people could take shelter in the event of a Pakistani air attack." The threat triggers an increased rate of anxiety and uncertainty. In Israel, at least two generations of citizens have grown up experiencing war and hiding in bunkers. Even for the Palestinians, since 1948, they have faced the brunt of war. Since 2023, thousands of Gazans have died and may have been displaced due to Israel's operation to finish Hamas. A report by the Council on Foreign Relations, "One in five people living in active or recent war zones has depression, anxiety, posttraumatic stress disorder (PTSD), bipolar disorder, or schizophrenia. Trauma-induced mental health problems can even be passed down generations."In Ferozepur, Punjab, a blackout drill in the cantonment area was conducted last Sunday, reminding people of the 1971 war when the district was under attack by Pakistan. The drill is planned across 244 civil defence districts, and the focus will be on border districts and strategic locations. The security drill will help people prepare to act quickly and effectively during real emergencies.

#### UNSC Holds Closed Consultation on India, Pak Situation; President Sekeris Calls It Productive

United Nations, (H.S): The Security Council met in a closed session on the tension between India and Pakistan, and its President Evangelos Sekeris described it afterwards as a "productive meeting". As he left the meeting on Monday, he told reporters, "The Security Council is always helpful in such efforts" to de-escalate. "It is the responsibility of the Council".

"It was a productive meeting and helpful", he said. Since the meeting was a closed consultation, its proceedings are secret without official records. Assistant Secretary-General Mohamed Khaled Khiari, who briefed the meeting, said on his way out that all want deescalation. Asked how he viewed it, he said, "Situation is volatile", and would not elaborate. Russia's Deputy Permanent Representative Anna

Evstigneeva, who attended the

meeting, said, "We hope for de-

escalation". Sekeris convened the

meeting at the request of Pakistan's Permanent Representative Asim Iftikhar Ahmad. Ahmad called for a closed consultation because countries that are not members of the Council are not allowed to participate in it under Council procedures. That effectively shut out India, while Pakistan, as a current elected member, attended. Before the meeting, Secretary-

General Antonio Guterres said the

situation was at a "boiling point" and asked the two countries to "step back from the brink". "It is also essential - especially at this critical hour - to avoid a military confrontation that could easily spin out of control", he said. Condemning "strongly" the terrorist massacre of 26 people in Pahalgam last month, he said, "I understand the raw feelings following the awful terror attack". The Resistance Front, an affiliate

of the Pakistan-based Lashkar-e-Tayiba, owned responsibility for the terrorist attack. Speaking to reporters after the consultation, Ahmad "categorically" denied India's charge that Pakistan was involved in the attack. He vacillated between militancy and conciliation. He referred to Kashmir as a disputed territory welling with mass discontent that is at the root of the problem with India, rather than terrorism, while also offering cooperation with India."

We are fully prepared to defend our sovereignty", he said." We reiterate our commitment to peaceful cooperative relations with all our neighbours, including India, [and] we remain open to dialogue", he added."In view of the gravity of the situation, the calls of dialogue and de-escalation and peaceful resolution of disputes as we also heard from the Council members today are most pertinent", Ahmad said.

### **Gabonese President Appoints New Government**

Libreville, (H.S): Gabonese President Brice Clotaire Oligui Nguema has appointed a new 30member government headed by Alexandre Barro Chambrier, Vice-President of the government. According to the presidential decree by the Secretary-General of the Presidency, Guy Rossatanga Rignault, the new government has three ministers of state.Henri Claude Oyima, who leads the BGFIBANK group, has been appointed minister of state in charge of the economy, the budget, public accounts, debt and the fight against the high cost of living, reports Xinhua news agency.

#### Three Dead, Nine Missing After Suspected Smuggling Boat Capsizes Off US San Diego Coast

Los Angeles, (H.S): At least three people were confirmed dead and nine others remain missing after a suspected smuggling boat capsized and washed ashore near San Diego, California according to authorities. Multiple agencies, including the US Coast Guard (USCG), responded on Monday morning to reports of an overturned vessel off the coast of Del Mar, Xinhua news agency reported. The panga-style boat - a small, open, outboard-powered fishing vessel - was found just north of Torrey Pines

State Beach and is believed to have been used in a human smuggling operation, according to media reports. The vessel was carrying at least 16 people, including at least two children, according to the USCG. A survivor informed first responders that nine individuals, possibly including one or two children, were still missing. Three bodies were found on the beach, according to a spokesperson from California State Parks. Authorities said four other people received cardiopulmonary resuscitation at the

scene, and three were transported to a hospital. The Encinitas Fire Department reported that three of the injured sustained mild to moderate injuries, while one person was in critical condition. Search and rescue operations are ongoing off the coast of Del Mar. The USCG is coordinating with multiple agencies, with the involvement of San Diego Fire-Rescue helicopters, a 45-foot Coast Guard response boat, and lifeguards using rescue boats and personal watercraft.

#### 2 Killed, 42 Injured in Israeli Retaliatory Airstrikes on Yemen's Port City: Health Authorities

Sanaa, (H.S): Israeli warplanes conducted dozens of airstrikes on Yemen's Hodeidah province, killing at least two people and wounding 42 others, according to health authorities run by the Houthi militant group. The strikes caused significant damage to infrastructure, including a port, airport, and factories, escalating regional tensions a day after the militant group claimed a missile attack near Tel Aviv's Ben Gurion Airport, which resulted in eight injuries, Xinhua news agency reported.

Houthi-controlled Al-Masirah TV reported 48 airstrikes targeted the Red Sea province, striking the port city of Hodeidah, its airport, a cement factory, and military sites northeast of the city. Health officials linked to the Houthis said the casualties included workers at the factory and residents in the adjacent Bajil district. Local residents told Xinhua that the strikes severely damaged infrastructure at the



port, including cargo-handling facilities, and several private factories were also hit. Plumes of smoke were seen rising over the city, and residents described the attack as paralysing daily life.In a statement, the Israel Defense Forces (IDF) confirmed the operation, saying approximately 20 warplanes struck Houthi targets along Yemen's western coast using 50 precision-guided munitions.

The targets, the IDF said, included what it called the "infrastructure of the Houthi terror regime." The mission was conducted about 1,700 km from Israel. The Houthi group claimed the attacks on Hodeidah were carried out jointly by the US and Israel. The IDF statement made

no mention of US involvement. The IDF said the strikes were "in response to repeated assaults by the Houthi regime against the State of Israel," referencing recent missile and drone attacks. The strikes on Hodeidah directly impacted the port, which serves as a critical lifeline for goods, medicine, and fuel to millions of people living in Houthicontrolled areas.

These attacks threaten to further disrupt the already fragile humanitarian situation in Yemen. Separately, Al-Masirah and local sources reported at least 20 US airstrikes on Monday targeting Houthi-controlled sites in the capital Sanaa, as well as in the northern provinces of Marib and Al-Jawf. There was no immediate

comment from US Central Command. The escalation follows a Houthi-claimed missile strike on Sunday near Ben Gurion Airport, outside Tel Aviv. Eight people were wounded, and airport operations were briefly halted. Israeli officials acknowledged that missile defense systems had failed to intercept the projectile despite multiple attempts.

The Houthis said the strike was retaliation for Israel's military campaign in Gaza. Israeli Prime Minister Benjamin Netanyahu pledged a forceful response, including against what he called the group's backers in Iran. The Houthis, who control much of northern Yemen including Sanaa and Hodeidah, have repeatedly launched missiles and drones toward Israel and Red Sea shipping lanes in recent months. They say the attacks are in solidarity with Palestinians and will continue until Israel ends its offensive in Gaza and allows unfettered humanitarian access.

### Sri Lanka Goes To Local Polls After 7-Year Gap, First Under Dissanayake Govt



Colombo, (H.S): Sri Lanka on Tuesday held the local government elections, following a seven-year hiatus and the first of its kind conducted after National People's Power (NPP), led by President Anura Kumara Dissanayake, came to power last year.

Out of the total of 341 local bodies, the elections are being conducted for 339 bodies across the island nation, marking a significant milestone in the country's democratic process, according to local media reports. Sri Lanka's ruling party, the NPP, the main opposition Samagi Jana Balawegaya, the United National Party, and the Sri Lanka Podujana Peramuna are contesting the election. Over 65,000 Sri Lankan police officers have been deployed for election duties to maintain law and

order. Local media reports further suggest that a record of 75,589 candidates, representing 49 recognised political parties and 257 independent groups are contesting in this year's elections. Additionally, a total of 17,156,338 registered voters are eligible to cast their ballots at 13,759 polling centres established nationwide.

Dissanayake, as the NPP leader, actively campaigned for the elections, hoping to break the grip of traditional parties at the local levels by taking control of the local bodies, according to local media reports. Last year, he achieved grand success in both parliamentary and presidential elections of the country, and therefore challenge for him in this local election would be whether he will be able to drive home the point that

him. Meanwhile, the main opposition Samagi Jana Balawegaya (SJB) is under fierce pressure to deliver better at this election, as they suffered defeat at the last two national elections.

Another opposition party,

the Sri Lanka Podujana Peramuna, led by Namal Rajapaksa, which was once the dominant political force in the country, also actively campaigned to bag as many votes as possible, Sri Lanka's leading newspaper, Daily Mirror, reported. The Election Commission of Sri Lanka and relevant authorities urged all eligible voters to resort to peaceful and democratic methods while exercising their rights and contributing to the advancement of local governance across the island nation.

### Pakistan's Military Dictatorship And Its Impact On Democracy

News Delhi, (H.S): Pakistan's protracted struggle with democratic governance resembles less a narrative of political maturation and more a cautionary example of institutional domination. Though envisioned as a republican state by its founding leadership in 1947, Pakistan has consistently fallen short in establishing a truly democratic system. The primary actor behind this failure is widely recognised but seldom challenged: the Pakistan military. Over successive decades, it has embedded itself within the core political authority, persistently undermining civilian leadership and weakening democratic institutions from within.

At present, Pakistan functions, at most, as a hybrid regime-a superficial civilian administration concealing a deeply embedded military establishment. Whenever public dissatisfaction with this setup intensifies, the military has repeatedly demonstrated its capacity to rebrand itself as the essential guardian of national security. It habitually relies on familiar narratives-Indian hostility, internal subversion, or foreign plots-frequently amplified through compliant media and affiliated non-state actors, to legitimise its dominant position. This dynamic was

evident when Army Chief General Asim Munir began employing political dog-whistles ahead of the April 22 Pahalgam attack targeting tourists in Jammu and Kashmir, anticipating a forceful Indian reaction that the military elite could exploit to consolidate public support. This militarised approach to governance stands in stark contrast to the political ideals of Muhammad Ali Jinnah, Pakistan's founding father, who envisaged an Islamic republic grounded in democratic principles, institutional probity, and socio-political equality. Significantly, in his address

to the 5th and 6th Ack Ack Regiments of the Pakistan Armyformations previously part of the British Indian Army-on 21st February 1948, Jinnah urged the military to uphold the values of "Islamic democracy, Islamic social justice, and the equality of manhood" within geographical bounds of the newly established state. However, the very institution Jinnah aimed to redirect soon deviated from its intended path. While his landmark address to the Constituent Assembly remains celebrated as a clear expression of his ideological vision for Pakistan, it was largely disregarded by the Pakistan Army, whose gradual incursions into the political sphere steadily undermined the



by Jinnah. This drift towards militarised governance began alarmingly within Pakistan's first decade, thereby derailing the democratic ambitions that had initially driven the post-colonial nation-building endeavour.It was this gradual consolidation of praetorian tendencies-evident in the steady erosion of constitutionalism and civilian authority-that ultimately led to the full-scale military coup of 1958. In this initial constitutional breakdown, President Iskandar Mirza conspired with General Ayub Khan to annul the 1956 Constitution, thereby dismantling the fledgling democratic framework. Ironically, Mirza was soon deposed by the very military machinery he had empowered,

ushering in a prolonged period of authoritarian military rule. This foundational rupture not only entrenched the military's hegemonic role within Pakistan's political system but also triggered a pattern of systemic instability that eventually led to the state's fragmentation with the secession of East Pakistan and the creation of Bangladesh in 1971. Since that time, the military's hold has only strengthened. Over the years, it has progressively extended its influence-not only within the political realm but also deep into the country's economic structures. The regime of General Zia-ul-Haq during the 1980s serves as a defining example. His tenure was characterised not only by the consolidation of military authority but also by a forceful

Islamisation drive that reconfigured Pakistan's societal landscape and further solidified the military's role as an ideological arbiter.By 2020, the Pakistan military's economic empire had evolved into a vast, multi-sector corporate entity, with an estimated value exceeding \$20 billion. Widely recognised for its pervasive presence across the economic landscape, the military's commercial and industrial reach spans the manufacture of basic goodsranging from sewing needles to bottled water-as well as major infrastructural projects, including roadworks and property development. A 2016 submission to the

Pakistani Senate revealed that the armed forces oversee more than 50 business enterprises. encompassing ventures such as Askari Cement, Askari Bank, Fauji Meat, Askari Sugar Mills, shopping centres, and residential housing schemes. These operations are chiefly managed through four institutional bodies: the Fauji Foundation, Bahria Foundation, Shaheen Foundation, and the Army Welfare Trust (AWT). The consolidation and maintenance of this extensive politico-economic apparatus has emerged as a core institutional priority for the military establishment. As a result, the continuation of its hegemonic control over civilian governance is no longer justified merely through conventional security arguments, but is now intrinsically linked to the protection of its substantial material interests and ideological influence-often to the detriment of democratic consolidation and ascendancy.The cumulative impact of this militarised political structure has been the consistent undermining of civilian authority, which has persistently struggled to attain independent legitimacy or institutional continuity within Pakistan's governance system. As a result, any civilian

political figure whose rise threatens the entrenched dominance of the military establishment has routinely been sidelined through coercive or extrajudicial measures. A notable example of this pattern was the judicial execution of Prime Minister Zulfikar Ali Bhutto in 1979-a politically motivated act following his removal in the 1977 military coup-triggered by his escalating popular support and increasing resistance to military oversight. This historical precedent echoes in the state's ongoing punitive campaign against former Prime Minister Imran Khan, whose present imprisonment is broadly viewed as retaliation for his overt challenge to the military's entrenched influence within the political domain. These recurrent patterns of suppression underscore the military's persistent aversion to political independence and its structural compulsion to preserve hegemonic supremacy over democratic institutions. These structural imperatives collectively sustain the Pakistan Army's ongoing opposition to any meaningful process of democratic consolidation, thereby solidifying its authoritarian control over the state machinery. As a result, the system is designed not for democracy but for containment.

The continuation of this civilmilitary imbalance is not incidental; rather, it is systematically upheld through a complex interplay of institutional self-preservation, economic interests, and ideological dominance. Civilian institutions are permitted to operate only insofar as they do not challenge the primacy of the military. This is not governance: it is institutionalised authoritarianism cloaked in a democratic guise. from this cycle demands more than temporary outrage or symbolic acts of opposition. Removing the military from the political sphere requires a far more ambitious approach: a sustained, organised, and credible political movementone capable of confronting both the ideological and material underpinnings of military rule.

#### MP Expects to Procure 85 Lakh Tonnes of Wheat This Rabi Season



Bhopal, (H.S): Madhya Pradesh is poised to surpass its anticipated wheat procurement target, expecting to secure 85 lakh metric tonnes (MT) against the initially projected 80 lakh MT. As of Tuesday, the state has already procured 76 lakh MT from 8.76 lakh registered farmers, according to the Minister for Urban Development.

The procurement process, which includes weighing exclusively from registered farmers, will continue for an additional five days. The state commenced its wheat procurement drive on March 15, offering a price of Rs 2,600 per quintal across its 4,000 designated procurement centres.' Last year, we procured 40 lakh metric tonnes of wheat from 5.85 lakh farmers in Madhya Pradesh," the minister stated. He further noted that updated figures were expected soon, with procurement already reaching 81 lakh MT as of Tuesday.

The government now anticipates achieving a total of 85 lakh MT in this season's yield. Additionally, the minister announced that Rs 16,472 crore has been disbursed to farmers so far in payment for their produce. To streamline operations, the state government registered farmers via SMS notifications and provided the option to enroll from home through a dedicated web or mobile application. Farmers could also register at facility centres located within Gram Panchayats, Janpad Panchayats, and Tehsil offices.If the anticipated volume is fully realised in mandis, farmers in Madhya Pradesh stand to receive a total support price of Rs 19,400 crore, along with an additional bonus of Rs 1,400 crore. The Central Government has also revised the Minimum Support Price (MSP) for wheat, increasing it by Rs 150 per quintal for the Rabi marketing season of 2025-26, bringing it to Rs 2,425 per

However, Madhya Pradesh will offer an elevated procurement price of Rs 2,600 per quintal, which includes an additional financial assistance of Rs 175 per quintal.Madhya Pradesh grows some low-irrigated high-yield varieties like Sharbati and Durum in the low rain fed area of Malwa plateau in districts of Sehore, Ujjain, Narmadapuram (erstwhile Hoshangabad), Harda, Raisen and Dewas. Among all these varieties, Sharbati is the most preferred variety as it contains high protein.

### Moody's Pegs India's GDP Growth At 6.3 Per Cent For 2025

New Delhi, (H.S): Moody's Ratings on Tuesday pegged India's GDP growth at 6.3 per cent for 2025 and expects the economy to pick up momentum in 2026 to record a 6.5 per cent growth rate. Moody's forecast is in line with the IMF outlook, which sees India as the only major economy in the world to record an over 6 per cent growth rate in 2025." Uncertainty surrounding global economic policies is likely to take a toll on consumer, business and financial activity,"

Moody's said in its Global Macro Outlook's May update. The rating agency had earlier projected a 6.5 per cent growth rate for India. Despite a pause and reduction in some tariffs, policy uncertainty and trade tensions, especially between the US and China, are likely to dampen global trade and investment with consequences across the G20 countries, Moody's said. Besides trade uncertainties, rising tensions are likely to weigh down growth. Geopolitical stresses

#### India's 1st Mortgage-Backed Pass-Through Certificates Listed on NSE

Mumbai, (H.S): In a major development for India's housing finance and debt markets, the country's first mortgage-backed Pass-Through Certificates (PTCs) were officially listed on the National Stock Exchange (NSE) on Monday. These PTCs have been structured by RMBS Development Company Limited and are backed by a pool of housing loans originated by LIC Housing Finance Limited. The issue size stood at Rs 1,000 crore, comprising 1,00,000 PTCs with a face value of Rs 1,00,000 each. The offering was fully subscribed, reflecting strong investor interest. This landmark issuance is also the first of its kind in India, where the coupon rate was discovered through the Electronic Book Provider (EBP) platform of the NSE. The final coupon was set



at 7.26 per cent per annum, and the instruments have a tenure of nearly 20 years. The PTCs carry a top-tier AAA(SO) rating from both CRISIL and CARE Ratings, and are issued in dematerialised form, making them tradable on the secondary market. The listing was carried out by M. Nagaraju, Secretary, Department of Financial Services, Ministry of Finance, who marked the occasion by ringing the ceremonial bell.In his remarks at the event, Nagaraju highlighted the crucial role of the housing and housing finance sectors in the broader economic landscape.He noted that housing has deep linkages with other industries, including infrastructure, and emphasised the urgent need to meet the country's growing housing demand to support overall economic growth. He further added that securitisation, through instruments like these PTCs, can serve as a bridge between the housing finance market and the broader debt market.Stressing the importance of Residential Mortgage-Backed Securities (RMBS), Nagaraju said such instruments could be a gamechanger for boosting liquidity and supporting the growth of the housing finance ecosystem in India. The listing ceremony was attended by several top officials from banks, housing finance companies, and other financial institutions, marking a significant step toward deepening the securitisation market and broadening investment opportunities in the country.

### India Poised To Replace Japan as World's 4th-Largest Economy This Year: IMF

New Delhi, (H.S): India is poised to become the world's fourth-largest economy in 2025 with the country's nominal GDP rising to \$4,187.017 billion during the year to surpass Japan's GDP pegged at \$4,186.431 billion, according to the IMF's World Economic Outlook report.

According to the report, India continues to remain the world's fastest growing major economy and the only country expected to clock over 6 per cent growth in the next two years.Japan, on the other hand, is expected to be hard hit by the global trade war with its growth stagnating at 0.6 per cent for 2025 and 2026. The high rate of growth will see India's GDP increasing to \$5,584.476 billion in 2028 as



the third largest economy. The IMF has projected a zero growth rate for Germany in 2025 followed by 0.9 per cent in 2026 as it is expected to be hit the hardest among the European countries due to the ongoing global trade war.

GDP is Germany's projected at \$5,251.928 in 2028. The GDP of the USA, the world's largest economy, has been pegged at \$30507.217 billion for 2025 while that of China, the second biggest, is \$19231.705 billion.The US,

which has triggered the tariff turmoil across the globe, is expected to see its GDP growth slowing to 1.8 per cent this year, which is expected to decline further to 1.7 per cent in 2026, according to the IMF report. Similarly, the Euro Area is forecast to slow to a mere 0.8 per cent growth rate in 2025 before it makes a mild recovery at 1.2 per cent in 2026.

France is predicted to post a 0.6 per cent and 1 per cent growth for the next two years respectively. Spain is expected to do better than the others in 2025 as the only European country to clock a 2.5 per cent growth rate. However, it is seen slowing down to 1.8 per cent in 2026. The UK is expected to post a 1.1 and 1.4 per cent growth respectively for the next two years.

#### UPI QR codes record 91.5 pc surge to 657.9 million, credit card growth slows

Mumbai, (H.S): UPI QR codes have recorded the fastest growth in digital payments infrastructure in the financial year 2024-25, with a 91.5 per cent jump over the previous financial year to 657.9 million, according to the latest RBI data. The surge in UPI OR codes was accompanied by a slowdown in the growth rate of credit card transactions to 7.94 per cent year-on-year, while debit card additions registered a mere 2.7 per cent growth to 991 million. The growth in the number of UPI QR codes has been accelerating with the increasing deployment by platforms like Google Pay, Paytm, and PhonePe. The number of banks going live on UPI continues to



increase, and the total touched 668 in April, which is expected to increase the value of such transactions, according to bank officials. March saw a record Rs 24.77 lakh crore in UPI transactions, marking a 25 per cent increase in value and a 36 per cent increase in volume compared to the previous year.UPI has become the dominant method for digital transactions in India. Nearly four

out of five digital payments in the country were conducted on the Unified Payments Interface (UPI) in the financial year 2024 (FY24), according to the Reserve Bank of India's annual report. UPI's share, compared to the cumulative volume of digital payments in the country, has grown steadily from 73.4 per cent in FY23 to 79.7 per cent in FY24. In FY20, UPI's share as compared to the volume of total digital payments in India was pegged at 36.8 per cent. The RBI is actively promoting digital payments through various initiatives, including the "Har Payment Digital" campaign, which aims to make every person in India aware of digital payments.

#### **India Has 879.59 Metric Tonnes Of Gold,** 511.99 MT Held Domestically: RBI

New Delhi, (H.S): The Reserve Bank of India (RBI) had 879.59 metric tonnes (MT) of gold at the end of March 2025, of which 511.99 metric tonnes were held domestically, the Central Bank informed on Monday. While 348.62 metric tonnes of gold were kept in safe custody with the Bank of England and the Bank for International Settlements (BIS), 18.98 metric tonnes were held in the form of gold deposits.

In value terms (USD), the share of gold in the total foreign exchange reserves increased from 9.32 per cent at end-September 2024 to about 11.70 per cent at end-March 2025, according to the RBI's 'Half Yearly Report on Management of Foreign Exchange

During the half-year period under review, reserves decreased from \$705.78 billion in end-September 2024 to \$630.61 billion at end-January 2025, and were at \$668.33 billion at end-March 2025. During the period between end-December 2023 and end-December 2024, the external



assets increased by \$79.7 billion and external liabilities increased by \$76.1 billion. The foreign currency assets comprise multi-currency assets that are held in multi-asset portfolios as per the existing norms, which conform to the best international practices followed in this regard.

At end-March 2025, out of the total FCA of \$567.56 billion, \$485.53 billion was invested in securities, \$45.68 billion was deposited with other central banks and the BIS and the balance \$36.34 billion comprised deposits with commercial banks overseas. With the objective of exploring new strategies and products in reserve management while diversifying the portfolio, a small portion of the

reserves is being managed by external asset managers, informed the RBI.At the end of December 2024, foreign exchange reserves cover of imports (on a balance of payments basis) stood at 10.5 months (11.8 months at end-September 2024).

The ratio of short-term debt (original maturity) to reserves, which was 19.1 per cent at end-September 2024, increased to 22.0 per cent at end-December 2024. The ratio of volatile capital flows (including cumulative portfolio inflows and outstanding short-term debt) to reserves increased from 67.8 per cent at end-September 2024 to 74.3 per cent at end-December 2024, the Bank informed.

New Delhi. At an ABP event, Gambhir said the national team should not be playing the arch-rivals till crossborder terrorism ends.

Till all this (crossborder terrorism) doesn't stop there should not be anything between India and Pakistan," said Gambhir when asked about the future of Indo-Pak cricket in the current environment. attack on April 22 in south Kashmir's Pahalgam town, 26 people, mostly tourists, were gunned down.Responding to the gruesome incident, India announced several measures against Pakistan, including suspension of the Indus Waters Treaty, shutting down of the only
