India to retaliate if **UK introduces carbon** tax, says official



New Delhi (Agency): India reserves the right to retaliate against the UK if it introduces a carbon tax as United Kingdom may have not agreed to India's request for a country-specific concession or a carve-out for Indian micro, small, and medium enterprises (MSMEs) under the trade deal announced earlier this week as government officials stated on Thursday.

Discussions of potential retaliation, despite the trade agreement, arise amid concerns that the tariff concessions agreed upon could be nullified in certain product categories should the UK implement its version of Carbon Border Adjustment Mechanism (CBAM). This mechanism aims to impose duties on carbon-intensive imports starting from January 1, 2027.

"Both countries have agreed that if the UK introduces CBAM, India reserves the right to retaliate. If India taxes these products domestically, then the industry will not have to pay the tax in the UK. That tax could be utilised to finance India's sustainability initiatives," the official said. UK remained unwilling to grant any concession under CBAM, with the carbon tax being a significant sticking point between the two nations. India initially proposed a carve-out for MSMEs and later suggested a 'rebalancing mechanism' requiring the UK to compensate Indian industries for losses incurred due to the regulation.

This paper reported that a 'rebalancing mechanism' article had been inserted into the 'general exceptions' chapter of the negotiating text between the two countries. This provision would enable India to claim compensation for its losses and ensure the UK does not raise a dispute against India at the World Trade Organization (WTO).

The general exceptions chapter in international trade agreements, such as the General Agreement on Tariffs and Trade (GATT), allows countries to implement measures that might "otherwise violate trade rules," provided they are justified on grounds such as public health or environmental protection, according to the WTO.

The rupee is likely to remain under pressure due to strong US dollar and the continuing military tensions between India and Pakistan. Any further escalation could drive more weakness. However, FII inflows into the stock market may offer some support at lower levels.

The rupee had gained ground last week in the wake of inflows from foreign investors and bullish stock markets.

In April, Fitch had then noted a pickup in Pakistan's reserves accumulation. With elevated debt levels and low reserve buffers, Islamabad had earlier managed to get a bailout package from the IMF in September 2024 with the approval of a \$7-billion loan, following which its economy has shown some early signs of a recovery from the brink of a collapse.



Audit firm hints at insider

Mumbai (Agency): Two former officials of IndusInd Bank were allegedly involved in insider trading during a period when the bank faced accounting lapses in its derivative portfolio, says an audit report by Grant Thornton. On April 29, weeks after IndusInd Bank disclosed accounting lapses and losses of nearly Rs 2,000 crore in its derivatives portfolio that triggered a rout in its shares, the bank's Managing Director & CEO Sumant Kathpalia resigned with immediate effect. IndusInd Bank had earlier announced the resignation of deputy CEO Arun Khurana. "Grant Thornton, which the bank hired to conduct an independent forensic investigation, found as a result of its review of internal accounts and communications that there were indications Kathpalia and Khurana traded in shares of IndusInd "during a period of seeming non-disclosure," wire agency Reuters reported on Thursday, quoting a summary of the findings.

"Considering that employees had knowledge of incorrect accounting and/or its impact but traded in shares of IBL during the period may also require a determination from an insider trading perspective," it said.

Kathpalia and Khurana sold shares worth Rs 157 crore in 2023 and 2024, according to data from the Bombay Stock Exchange (BSE). The data reveals that Kathpalia sold approximately 950,000 shares, valued at Rs 134 crore, between May 24, 2023, and June 25, 2024. During the same period, he purchased 396,000 shares worth Rs 34 crore. Similarly, Khurana sold 550,000 shares for Rs 82 crore over 2023-24, while acquiring 238,000 shares worth Rs 25 crore. Earlier, there were reports in a section of the media that market regulator Sebi did not find insider trading by the two officials, saying all disclosures were in place and there was no wrongdoing. When contacted, Sebi officials did not comment on the issue. "I undertake moral responsibility, given the various acts of commission/ omission that have been brought to my notice. IMF Board should look 'deep within' before bailing out Pakistan: **Foreign Secretary Vikram Misri ahead of key Fund meet**

New Delhi (Agency): A day before the International Monetary Fund (IMF) is set to review the financing facilities extended to Pakistan, India's Foreign Secretary Vikram Misri on Thursday said the Fund's Board should look "deep within" and take into account the facts before generously bailing out the country. He questioned the efficacy of several bailout packages extended to Pakistan over the last three decades and raised questions on its utilisation by the country. Misri said India's Executive Director will put forward its position at the IMF Board meeting on May 9. "We have an executive director at the IMF. Tomorrow there is a meeting of the board of the IMF, and I am sure that our Executive Director will put forward position. India's The decisions of the Board are a different matter, you know, the process through which they are made. But, I think the case with regard to Pakistan should be self-

evident to those people who generously open their pockets to bail out this country...," he said. Misri pointed out that there have been several IMF

bailout programmes sanctioned in the space of the last three decades. "...I think you would also have an idea on how many of those programmes have reached successful conclusions. Probably, not many. So, I think this is a decision that (IMF) Board members have to take by looking deep within themselves and looking at the facts," he said. As per the IMF website, there have been 25 arrangements for Pakistan since it became a member of the IMF in 1950. As of March 31, 2025, the outstanding purchases and loans to Pakistan from the IMF stood at 6.23 billion Special Drawing Rights. The government is also working towards bringing Pakistan back into the 'grey list' of the Financial Action Task Force (FATF), the global money laundering and terror financing watchdog. India is stepping up its ante against Pakistan following the attack on April 22 that killed 26 people in Pahalgam, and is looking at several measures aimed at tightening financial flows to the neighbouring country.

India–UK trade deal text expected in 3 months; No MIP on UK Whisky: Official

New Delhi (Agency): The official text of the India–UK free trade agreement is expected to be released in three months, as the legal scrubbing is currently underway, a government official stated on Thursday, adding that the agreement will be implemented following approval by the UK Parliament, which could take about an year. The official clarified that India has not included a Minimum Import Price (MIP) provision for British alcoholic beverages in the free trade agreement, despite requests from domestic liquor manufacturers. This is significant as India plans to reduce import duties on UK whisky and gin from 150 per cent to 75 per cent, and further to 40 per cent by the tenth year of the deal.

On automobiles, the official clarified that India has incorporated adequate safeguards in the agreement to protect sensitive sectors. Import duties on vehicles will be reduced over a period of 10 to 15 years, with concessions on petrol and diesel engine vehicles

limited to a predefined quota, the official said. The quota for imports of British electric vehicles (EVs) at a concessional customs duty rate is



restricted to a few thousand units. To protect the domestic industry, the import restrictions on diesel and petrol vehicles are linked to engine capacity, and in the case of EVs, to prices, an official clarified.

"For cars, duty will be reduced over a

period of 10 to 15 years, and the volume of imports will be very small. We have not allowed futuristic cars (EVs) or low-cost cars. We have implemented several protection measures," the official said, adding that India's car industry is projected to reach a record 5 million units, and by the time the duty is reduced, it may reach 10 million units per year.

"There is no out-of-quota duty reduction for EVs. The sensitivity related to EVs has been addressed. The out-of-quota duty on internal combustion engine vehicles will be reduced gradually over a longer period, thereby helping our industries absorb the incremental increase of imports from the UK," the official added.

Meanwhile, the Indian alcoholic beverage industry has expressed dissatisfaction with the deal, having advocated for a level playing field through the inclusion of an MIP to curb dumping and under-invoicing by foreign companies.

EDITORIAL **Power and Posture**

The recent meeting between President Donald Trump and Canadian Prime Minister Mark Carney was more than a polite diplomatic encounter ~ it was a vivid display of two clashing worldviews in an increasingly volatile North American partnership. While much of the media spotlight has lingered on Mr Trump's offhand suggestion about annexing Canada, the more consequential moments unfolded in the subtleties of trade, sovereignty, and strategic posture. Mr Trump's rhetoric, though often theatrical, reveals a deeper posture of American transactionalism. His insistence on tariffs ~ 25 per cent across sectors, and specifically targeting key Canadian exports like steel, aluminium, and automobiles ~ signals a worldview that frames allies as economic competitors first, strategic partners second. This isn't just tough talk. It is a policy driven by a zero-sum mindset: if America is to win, someone else must lose.



Unfortunately for Canada, this mindset seems to treat longstanding partnerships as leverage, not legacy. Mr Carney, for his part, handled the moment with compo-

sure and clarity. Rather than rise to provocation, he anchored the conversation in the language of sovereignty and mutual respect. His focus was not on emotional rebuke or political theatre, but on ensuring Canada remains economically self-determined in the face of growing pressure from its largest trading partner.

His tone was deliberate: warm when necessary, firm when it mattered. Canada's challenge now is to navigate this new terrain without capitulating to pressure or provoking escalation. It must balance resilience with diplomacy, ensuring that national interests are protected while leaving room for constructive engagement with a historically vital if increasingly unpredictableally. One of the more revealing aspects of their exchange was Me Trump's assertion that trade deals are not an American priority ~ "They have to sign deals with us. We don't need their market." That line encapsulates a shift in US global posture under Mr Trump's continued influence: a retreat from multilateralism in favour of dominance-based negotiation. While this may play well to a domestic audience, it leaves neighbouring nations navigating a minefield of uncertainty. Canada, with over \$760 billion in annual bilateral trade at stake, cannot afford to misread this moment. Mr Carney's response ~ that negotiations will continue, with "zigs and zags" expected ~ reflects recognition that standing still is not an option. What's being tested is not just economic resilience, but national identity in a rapidly shifting geopolitical landscape. This isn't merely about trade policy or political optics. It's about two competing visions of North America. One seeks to consolidate power through economic coercion and rhetorical overreach. The other asserts that cooperation and sovereignty can ~ and must ~ coexist. In the coming months, the tone and outcomes of US-Canada talks will matter not just for tariffs and exports, but for the broader message they send to the world: Can democracies maintain mutual respect while facing populist pressures? Can smaller powers hold their own with dignity and purpose? For now, Canada has drawn a quiet but resolute line. The test will be whether that line can hold.

They are meant to create fear, confusion, and uncertainty. But they will fail, because India is not a soft target. Her defences are increasingly integrated, technologies are rapidly modernising, and the people are resolute. More than ever, this is the time for national unity and strategic foresight. We must support our security forces, demand international accountability from rogue states, and invest in indigenous defence innovation. Patriotism today means vigilance ~ not only on the battlefield but also in public discourse. We must not allow disinformation or divisive rhetoric to dilute our collective resolve. This is not just about border defence; it is about civilisational integrity. From the snowbound posts of Ladakh to the airfields of Punjab, India's defenders are writing a new chapter of courage under fire. It is our duty as citizens to match their valour with civic strength, strategic clarity, and unwavering national pride. India must also respond on the diplomatic front with equal intensity. While our military safeguards the skies, our foreign policy must isolate and expose aggressors on the global stage. Strategic partnerships, international forums, and intelligence-sharing alliances must be activated to send an unmistakable message: India will not tolerate state-sponsored aggression in any form. The American innovationindustrial complex relies on three pillars: Stable support for research infrastructure within universities and nonprofit institutions funded by

the government, while allowing them to operate independently; an open and competitive ideas marketplace; and tapping into global talent. All three are currently under threat.

The Trump administration views universities as free riders exploiting government largesse by collecting 30 cents in overhead for each dollar going directly to support research. This is contrary to the post-war grand bargain created under the leadership of Vannevar Bush, the first presidential scientific adviser, whereby universities were supposed to nurture scientific talent through stable provision of jobs, laboratory space, research infrastructure, including libraries, and provide seed funding for new projects. The government would support this through overhead payments on grants. Curtailing overheads to 15 per cent jeopardises this equation. The second pillar of this troika balanced creative freedom with accountability through professional oversight. An elaborate infrastructure was put in place in institutions like the National Institutes of Health to ensure that lack of fame or connections did not hold back young researchers, and peer review by other scientists was the only criterion that grant proposals needed to satisfy. The Center for Scientific Research at NIH was always conscious of the tendency of scientific orthodoxy to dominate and

suffocate innovation. It looked for ways to ensure an even playing field. The latest balloon from the administration to downplay the role of scientific review and withholding funds from research powerhouses Harvard and Johns Hopkins to ensure political compliance risks destabilising this hardwon independence. If America forgets that, when ideology or cronyism trumps fair competition, it stifles a vibrant scientific culture. It only has to look at Russia. Russian scientists did not receive a single Nobel Prize for science between 2011 and 2022, during which 61 Americans became Nobel Laureates in scientific disciplines. Beginning with a flight of Jewish scientists from Germany, American science has benefited tremendously from the influx of international scholars. Of the 314 laureates who won

their Nobel Prize while working in the USA, 102 (or 30 per cent) were foreignborn. Compare that to Japan, which counts no foreign-born individuals among its nine Nobel laureates. We would be hard-pressed to find any scientific discipline whose leadership does not include people born outside of the United States. The antiimmigrant sentiment fuelled by the current administration will make America a less attractive place for international students and researchers. The administration claims not to be against international students, but they are welcome only if they hold no political views. This is reminiscent of Great Britain, which until 1829 was more than willing to extend democratic privileges to Irishmen as long as they did not profess Catholic beliefs.

It strikes at the very root of the interpretation of treaties and the surrounding geopolitical environment with India skating on thin ice. It can be argued that the decision to place IWT in 'abeyance' is not a violation but a legal decision under the aegis of customary international law. Yet, on the other hand, the deployment of the diplomatic strategy of keeping IWT in 'abeyance' seems to play in a grey area of the Treaty. Though seemingly innocuous, it brews a recipe for disaster in its wake with potentially serious consequences for both sides.

AMSTERDAM (Agency): The fire that caused significant damage in April to historic buildings in Suriname's capital city was not the only threat facing the nearby Neveh Shalom Synagogue.

As firefighters battled to save the historic city center of Paramaribo - a UNESCO World Heritage site — the synagogue's volunteers were busy scanning thousands of archival documents in an effort to preserve the history of the thousands of Jews who have called the Surinamese capital home since the 1700s.

The blaze was contained before reaching the synagogue, but at the mercy of other threats, including the tropical climate, insects and time, it was a reminder of how fragile the 100,000 historic documents, kept on pages stored in filing cabinets for decades, were and how vital the preservation

project was. The operation to digitize the birth records, land sales and correspondence has been overseen by Dutch academic Rosa de Jong, who had used the archive as part of a PhD study on

how Jewish refugees fled the horrors of World War II to the Caribbean, including the tiny South American country of Suriname.

"I felt that my work comes with an obligation to preserve the past that I'm building my career on," When she finished her academic research, at the University of Amsterdam, last year, De Jong saw an opportunity to return to Suriname and safeguard the files that had been crucial to her work. She raised the financing for cameras, hard drives and travel expenses and returned to Suriname with the aim of making high-quality scans of the hundreds of folios held by the synagogue.

The result is more than 600 gigabytes of data stored on multiple hard drives. One will be

donated to the National Archives of Suriname to be included in their digital collections.



The archived documents show how Suriname was a hub of Jewish life for the Americas. The British who colonized the region gave Jews political and religious autonomy when they first moved to Suriname in 1639 to manage tobacco and sugar cane

When the Dutch took control of the colony, they continued this



practice. When Jewish people were forced out of other places in the Americas, they often fled to Suriname. On Christmas Eve in 1942, more

than 100 Dutch Jewish refugees, fleeing the horrors of the Holocaust, arrived in

Paramaribo.

Liny Pajgin Yollick, then 18, was among them. In an oral history project for the United States Holocaust Memorial Museum, she described the relief she felt when she arrived in Suriname to the sound of a familiar song. "I remember it was morning and

they played Dutch National Anthem for us when we arrived, and everybody was crying. We were very emotional when we heard that because many of us never thought we would ever hear it again," she said.

When the Netherlands was freed from Nazi German occupation three years later, Teroenga, the magazine published for the Jewish congregations in Suriname, ran with the headline "Bevrijding" ("Liberation"). The archive at Neveh Shalom has a

copy of every edition of Teroenga.

Key to De Jong's preservation project has been 78-year-old Lilly Duijm, who was responsible for the archive's folders of documents for more than two decades.

Born in Suriname, when she was 14 she moved to the Netherlands where she eventually became a nurse. But she returned to her homeland in 1973, just before the colony got its independence, and her four children grew up in Paramaribo.

More than anyone, she knows how precious the archive was.

"I told the congregation, as long as the archive is still here, I will not die. Even if I live to be 200 years old," she tearfully told AP. "This is keeping the history of my people."

South Korea's Kim **Moon-soo retains** presidential bid, Han **Duck-soo withdraws**



NEW DELHI: South Korea's conservative opposition has reinstated Kim Moon-soo as its presidential candidate after the withdrawal of rival Han Duck-soo, just weeks before the country's June 3 snap election. The People Power Party (PPP) had earlier attempted to replace Kim, a staunch conservative and former labor minister, with Han, a former prime minister and acting president.

The attempt to replace Kim was amid growing concern over internal which follows the divisions and low poll impeachment of former numbers against liberal frontrunner Lee Jaemyung. According to The Associated Press, the party's emergency committee on Saturday nullified Kim's nomination — which he had secured with 56.3% of the vote in a primary and registered Han as its new candidate. But the last-minute change required ratification via an automated all-party vote. Party spokesperson Shin Dong-wook later confirmed that the vote narrowly rejected the switch. "While we cannot disclose the figures, the vote on switching the candidate was rejected by

a narrow margin," Shin

said.

Kim called the attempt to oust him an "overnight political coup" and was immediately reinstated after the vote. "Now everything will return to its rightful place," he said in a statement.

Han, whose late entry into the race had deepened factional rifts within the PPP, formally ended his bid on Sunday. As reported by Reuters, Han said he "humbly accepts" everything and expressed hope that Kim would succeed in the election,

COLOMBO (Agency): A passenger bus skidded off a cliff in Sri Lanka's teagrowing hill country on Sunday, killing 21 people and injuring at least 14 others, an official said. Geltrú to the village of Calafell, near Tarragona.

The Catalan emergency services onSaturday said that no one was hurt in the fire, but residents in at least five towns were informed via message on their respective mobile phones to stay indoors due to the toxic cloud of chlorine.

Vinuales Alonso, Jorge owner of the industrial property, told local radio station Rac1 that "It is very difficult for chlorine to catch fire, but when it does so it is very hard to put it out,"

Reuters reported. Alonso further said that the cause of the fire in the warehouse could have been a lithium battery. Among the other precautionary measures, trains which were due to be passed from the affected area were halted, roads leading to the region were blocked by the administration and other events which were planned remained cancelled.

Civil Protection spokesperson Joan Ramon Cabello, in a statement to local media said that fire was under control.

OXFORD (Agency): The Food and Drug US Administration is warning Americans about the everincreasing and potentially deadly recreational use of nitrous oxide products. particularly among young people.

Marketed with names like Galaxy Gas and Miami Magic, and often sold in steel cartridges known as

whippets, these products are cheap and readily available at gas stations, convenience stores, smoke shops and retail outlets, major including Walmart. They're also sold online. As

an assistant professor of public health who studies these products, I'm aware of how dangerous they can be. Recreational and continued use of nitrous oxide can cause a wide range of serious health problems, and in some cases, death.

The list of serious side effects from frequent use is long. It includes: cognitive impairment, memory problems, hallucinations, headaches, lightheadedness, mood disturbances, blood clots, limb weakness, trouble walking, peripheral neuropathy, impaired bowel or bladder function, spinal degeneration and cord irreversible brain damage. Vitamin B-12 deficiency is common and can lead to nerve and brain damage. Deaths in the U.S. attributed to abuse of nitrous oxide jumped more than 100% between 2019 and 2023; over a five-year period, emergency department visits rose 32%.

Bob Cowper, first to score triple century **for England Series** Michael Vaughan bats for Virat Kohli to be IND Test cantain for England series on Australian soil, **Passes Away at 84**

MELBOURNE (Agency): Bob Cowper, who scored test cricket's first triple century on Australian soil, has died at the age of 84 due to an undisclosed illness, Cricket Australia said Sunday.

Cowper played 27 test matches for Australia between 1964 and 1968, with a record of 2,061 runs at an average of 46.84, including five centuries, while also taking 36 wickets with his parttime off-spin.

The left-hander was renowned for both his stroke-play and steadiness, particularly during his most famous innings, a 12-hour, 589-ball 307 against England at the Melbourne Cricket Ground in February 1966. The innings was the only test triple century made in Australia in the 20th century, and just the 10th ever scored at that time. It came after he was recalled on his home ground, having been the 12th man in the previous test in Adelaide. Cowper was a force on home soil, and

his batting average of 75. 78 runs in Australia remains the second-highest of all time behind only Donald Bradman. He retired in 1968 and became a stockbroker and later became an ICC match referee. In 2023, he was awarded the Medal of the Order of Australia in recognition for his service to cricket. "We are deeply saddened to hear of the passing of Bob Cowper, who was a hugely respected figure in Australian cricket. Bob was a wonderful batter who will always be remembered for his famous triple century at the MCG, as well as his strong influence in the Australian and Victorian (state) teams of the 1960s," Cricket Australia chairman Mike Baird said. Cricket Australia said Cowper was survived by his wife Dale and daughters Olivia and Sera.

Board of Control for Cricket in India (BCCI) is planning to extend its IPL till May 30 when the tournament resumes after the suspension. The BCCI is contemplating to host the remaining matches in the three venues - Chennai, Bengaluru and Hyderabad from May 16. The new

schedule will be released to the IPL franchise by Sunday night even as few of them have expressed their concern about the availability of their overseas players who have all flown back home.

"As the IPL was suspended for a week, there is a possibility of the IPL final now being played on May 30 instead of May 25 with limited venues. The schedule will be sent to all IPL teams by tonight," source in the BCCI informed.

The BCCI has already asked all the teams, except Punjab Kings, to report to their respective venues by Tuesday so that it can resume the IPL by Friday. The BCCI also has informed the franchises to inform their foreign players about their travel plans.

Most of the overseas players and support staff left for their home on Friday after the BCCI officially suspended the IPL. Now, the franchises are making arrangements to fly them back. With 12 matches remaining, the BCCI at least needs two weeks to



complete the remaining matches as the play-offs and the final at least need 6 days. And given they now have only two weeks to complete the tournament, more double headers are being planned.

"All franchises have been told to inform its team to report to their respective destination by Tuesday," a source in the Indian board confirmed.

IPL chairman Arun Dhumal had told this paper that they are looking at the possibility of starting the suspended IPL 'immediately' after India and Pakistan announced a ceasefire on Saturday.

"Ceasefire has just been announced. We now explore the possibility of resuming and concluding the IPL. If it is possible to conduct it immediately... We need to work out the venue dates and everything, and we would now be speaking to all the stakeholders, including team owners, broadcasters, and everyone involved and find a way as to how to move forward.

Sawant credited the turnaround to the change in compound equipment. "She has the body structure that belongs to this category. She was already an Indian player and we only helped her with pacing and her equipment. I put her with the 'PSE company' (American archery supply company) That was my decision, which was important. She trusted me with it," he explained.

In addition, Sawant felt that invoking the state's icons like Chatrapathi Shivaji had motivated the 24-year-old. "People in Maharashtra look up to him and his spirit. I used to use that to motivate her," he recounted.

The matter is related to controversial and derogatory remarks against senior Congress leaders during the Pahalgam attack. This includes many people including Rahul Gandhi and Robert Vadra.

The party has said that former MP Laxman Singh is accused of making "derogatory remarks" targeting senior party leaders including Rahul Gandhi. The party has termed this remark as unacceptable. According to the party, the MP has crossed all limits. His remarks have caused "serious damage" to the "image and dignity" of the party. On April 25, Laxman Singh had

attacked the party leadership after the Pahalgam terror attack. During a condolence meeting organized to pay tribute to the Pahalgam victims, he had said, Rahul Gandhi and Robert Vadra are naive. The country is suffering the consequences of his immaturity. The party's Disciplinary Action Committee (DAC) member secretary Tariq Anwar had



issued a notice to Singh on May 9. It said that a complaint has been received from Madhya Pradesh Congress chief Jitu Patwari and All India Congress Committee (AICC) general secretary and Madhya Pradesh in-charge Harish Chaudhary regarding your repeated public statements. This has caused serious damage to the image and dignity of the Congress.

The notice said that a reply has been ordered within 10 days from the date of receipt of the notice. Former Lok Sabha member and former MLA Singh is currently in the Congress. He has previously been in the BJP. On April 25, he also targeted Jammu and Kashmir Chief Minister Omar Abdullah, saying that he may be "in cahoots with terrorists".

BRIEF NEWS SC flags violations in Delhi's first private housing project on fragile **Ridge land**

Delhi (Agency): The Supreme Court has issued show cause notices to senior Delhi government officials, the Municipal Corporation of Delhi (MCD) commissioner, and a private developer, seeking explanations for alleged violations of its 1996 directive under the M C Mehta vs Union of India case and going ahead with construction of a housing society in the "morphological ridge" area, an ecologically sensitive zone, in Vasant Kuni.

The 1996 directive has held that ridge land must be safeguarded against encroachment and non-forest use without prior court approval.

A bench comprising Justice Surya Kant and Justice Nongmeikapam Kotiswar Singh, in an order dated May 7, directed that notices be issued to Delhi Principal Secretary (Environment and Forests) Anil Kumar Singh, Deputy Conservator of Forests (West) Amit Gemawat and MCD Commissioner Ashwani Kumar.

Notices were also issued to Rakesh Sharma and Sunita Sharma, partners in RR Texknit LLP, which is building the housing project at Vasant Kunj's morphological ridge area. The action stems from a contempt petition filed by environmental activist Bhavreen Kandhari, who had challenged the permissions granted to the housing project being developed by RR Texknit LLP.

The development had sparked protests from environmentalists and local residents, who argued that it violated longstanding SC orders mandating preservation of the ridge in its "pristine glory".

The case pertains to the protection of Delhi's ridge, an important green area that acts as the city's lung and a key part of the Aravalli Range.

Though not entirely notified under the Indian Forest Act, 1927, the SC, in multiple orders, including the landmark 1996 directive, had held that ridge land must be safeguarded against encroachment and non-forest use without prior court approval. 7 detained in Sambhal for murdering two men and disguising their deaths as accidents to get insurance money

Sambhal: Police in Sambhal detained seven people on Sunday for allegedly murdering two men and arranging deaths as accidents in order to collect insurance money, according to police. The group reportedly arranged the killings of Salim and Aman and framed them as road accidents to fraudulently claim their large insurance premiums. The arrested were named as Vedprakash, Kamal Singh, Nirdesh Kumar, Udaybhan Singh, Premshankar, Sunil Kumar, and Omprakash. ASP Anukriti Sharma stated that Salim was murdered on July 29, 2022, and Aman was slain on November 15, 2023. Both incidents were identified as deaths caused by traffic accidents, prompting authorities to immediately shut files. Later, investigators discovered that, previous to their deaths, Salim had obtained insurance policies totaling Rs 88 lakh, while Aman was insured for a stunning Rs 2.70 crore, according to an officer. The group painstakingly planned and executed two killings, presenting them as accidents. In February, a guy called Shahrukh was arrested, which marked a breakthrough. A cell phone conversation involving Kamal Singh prompted a further investigation, which implicated him in Aman's unexplained death in November 2023. Sharma stated that a case of unexplained fatality as a result of an accident had been recorded at the time.

The investigation found that Aman's maternal uncle, Vedprakash, and his accomplices reportedly murdered him after obtaining insurance policies worth Rs 2.70 crore from various policies in the deceased's name, according to the officer. Vedprakash was the complainant in the accident case, and the ASP stated that about Rs 20 lakh had already been put into an account from the insurance reimbursement.

Delhi (Agency): As the Delhi High Court functions at 60% of its sanctioned strength, the court in an order on April 25, flagged "overflowing dockets" and admitted that it is "unable to decide" appeals "within reasonable period of time". "On account of acute shortage of judges as compared to the general population and the litigation quantum, for a long time, the list of regular matters does not reach till the end of the day of hearing. Rather, many

a time even beyond 5 pm when the courts rise for the day, some of the matters remain unheard, which is extremely painful for the judge," Justice Girish Kathpalia recorded in the order. According to the India Justice Report 2025 by Tata Trusts, which analyses the criminal justice system, Delhi has less than one HC judge for each 10 lakh of people. Notably, the report said that Delhi performed the best in the judge-to-people population with

subordinate court judges per 10 lakh population and less than one (0.6) HC judge per 10 lakh population. The HC in Delhi currently has 36 sitting judges against a sanctioned strength of 60 judges. As per HC's monthly reports - the latest came out in March - new cases instituted in March exceeded the cases disposed of during the month, the maximum increase being seen in criminal cases followed by civil writ petitions. On the 36 criminal side, several judges

Justice Kathpalia dealing with a petition filed by Mukesh Gupta alias Mukesh Kumar Gupta, an accused in a CBI case, who was seeking permission to travel abroad from May 1 to 11 to attend a club assembly of Rotary Club at Almaty in Kazakhstan and Georgia, to maintain social ties and help his business grow. The CBI had, however,

opposed the plea, telling the court that if allowed to leave the country, Gupta "would not return to face sentence, which has been suspended by the predecessor bench while admitting this appeal". It was highlighted that Gupta had been earlier denied permission to travel for leisure trips although the court had granted permission to travel for business.

The court, while recording that "right to even leisure trips to certain extent ought not be declined," recorded

appeals within reasonable was period of time". It noted that Gupta's appeal, filed in 2019, was to be heard as a regular matter. Regular matters for the day are old matters, usually taken up by most courts at Delhi HC after dealing with the fresh matters first, as well as the advance list, which includes matters that have earlier been taken up when it was filed afresh and was thereafter listed on the 'advance list'. Most judges at Delhi HC follow the practice of aiming to complete the new cases listed as well as the advance list first. practice that regular matters will be taken up every Thursday at 3.30 pm.

Reasoning that the "acute shortage of judges" and the quantum of litigation is resulting in the HC unable to reach the list of regular matters for hearing, despite the court sometimes working past its official hours, Justice Kathpalia allowed the accused to travel for the said period, saying, "In such uncertain atmosphere. depriving the applicant/appellant free movement, even if to enjoy leisure trips, cannot be justified." Meanwhile, a PIL has been filed in HC, highlighting a

shortage of judges and urging for expeditiously filling up the vacancies by elevating eligible district judges and advocates from the bar. In his plea, advocate Amit Sahni has sought an urgent judicial intervention.

Air quality monitoring panel targets complete elimination of stubble burning, issues 19-point directives to states adjoining Delhi

Delhi (Agency): A new "Parali Protection Force" to patrol fields once dark and a common fixed price for paddy straw are among the 19-point steps that Haryana, Puniab. and Uttar Pradesh must take to fully eliminate stubble burning this year, according to an order issued by the Commission for Air Quality Management (CAQM).

In the order issued Friday, the Commission — tasked with formulating air pollution control strategies in the National Capital Region (NCR) and adjoining areas - also urged the Delhi and Rajasthan governments to make efforts in tackling stubble burning, a key contributor to the annual winter pollution crisis in the Capital

Punjab, Haryana, and Uttar Pradesh must map every village farm, tag a nodal officer to no more than 50 farmers, junk outdated crop-residue-management (CRM) machines, and finish new procurement by August. The states must also make the CRM machines rent-free for small and marginal through farmers agricultural facilities, said the

Commission.

According to the order, the states need to build an online platform for real-time data on paddy residue generation, create district-level supply-chain plans with storage yards, use straw pellets for cofiring in brick kilns, and pilot a straw-based boiler to supply steam inside industrial units. The Parali Protection Force

made up of police, agriculture, and civic officers — is to "closely monitor, oversee and guard" against stubble burning incidents. In its order, CAQM called for "intensified patrolling by enforcement agencies during lateevening hours", as it reasoned that some farmers resort to burning stubble to avoid detection by satellite fire-monitoring systems.
