Senior IAS officer arrested by ACB in liquor scam case

Ranchi Jharkhand's senior IAS officer and current principal secretary of Panchayati Raj Department Vinay Kumar Choubey was arrested on Tuesday by the state Anti-Corruption Bureau (ACB) in connection with the high-profile liquor scam. The arrest followed a day-long interrogation at the ACB office in Ranchi, marking a dramatic turn in a case that has lingered in the background of state politics and bureaucracy for over two years.

The ACB team arrived at Choubey's residence early in the morning and escorted him to the bureau's office. Sources confirmed that medical personnel were summoned to the ACB headquarters later in the day a clear indicator of impending custodial action. Around 4:30 pm, Choubey was taken to court,

It is being told that after a long discussion, it has been agreed to implement this scheme in MP. This scheme will be implemented by the end of this month. This will save the lives of injured people and will also give encouragement and respect to the citizens.

important The most condition in this scheme is that the seriously injured person has to be taken to the hospital in the 'Golden Hour', so that it can be proved that if he was not taken to the hospital on time, he could have died. If a person injured in a road accident undergoes an operation, he has to remain admitted in the hospital for at least three days, if there is a serious injury to the head or spine, then in that situation the citizen who takes the patient to the hospital will be entitled to this award.

Often people shy away from taking the injured to the hospital to avoid getting caught in the hassle of police and law. In such a situation, due to this scheme, now people will not hesitate to come forward to help. This will help in saving the injured and will also reveal the names of those people who come forward without hesitation to help others.

SC told Waqf Amendments discriminate against Muslims, undermine secularism

New Delhi (Agency): The Waqf (Amendment) Act, 2025 came under intense scrutiny in the Supreme Court on Tuesday, with senior lawyers arguing that the law unfairly targets the Muslim community, imposes discriminatory conditions on Islamic endowments, and threatens the secular character of the Constitution.

A bench comprising Chief Justice BR Gavai and Justice Augustine George Masih heard more than four hours of submissions from senior advocates Kapil Sibal, Rajeev Dhavan, Abhishek Manu Singhvi, CU Singh, and Huzefa Ahmadi.


The Congress President highlighted the International

"The IMF has provided a bailout loan of \$1.4 billion to Pakistan. But nobody supported India's stance. A ceasefire was suddenly declared while our brave Armed Forces were conducting operations against terrorists," Kharge said in his post. He criticised Modi for not addressing US President

Trump's claims of brokering the India-Pakistan ceasefire, suggesting a lack of clarity and transparency in India's foreign policy.



Earlier, Kharge today criticised the Modi government for alleged security lapses that led to the Pahalgam terror attack,

resulting in 26 deaths.

Kharge claimed that the government failed to provide adequate security arrangements for tourists, despite being aware of potential security threats.



Rampur mine of Madhya Pradesh has always been surrounded by controversies. The reason is that two of the mine operator Malhotra & Company's agents Meena and Khan have so much influence that the overloaded trucks of looted sand from UP pass under the nose of the responsible officers from the Mineral Department to the GST Department and the Divisional Transport Department. Action taken on nearly two hundred NR trucks in a month

When Joint Commissioner State Tax Department Santosh Verma was talked to in this regard, he told that the joint team formed includes State Tax Department, Divisional Transport Department, Police Department and Mineral Department and continuous action is taken. During the investigation in the last one month, about two hundred and fifty NR trucks were caught and action was taken. He further told that even after the action, the movement of NR trucks is not being stopped. Whenever the joint team does checking, a large number of NR trucks are caught from Girwan to Banda. Check your mailbox: Trump's new tariff proposition, as India & China try to wrap up deals



New Delhi (Agency): For the Donald Trump administration, whose tariff proposals generally have a half life of less than 10 days, a fresh twist in plans should not really come across as a surprise. But for a majority of countries waiting to know about what tariffs the new Trump administration has in store for them before the 90day pause runs out, Washington DC has a fresh suggestion: just check your mailbox.

Trump's latest plan, while acknowledging that his own self-imposed 90-day deadline to make trade deals with some 180-odd countries is simply too tight to meet, there are hints of a surprising tweak. Since he admittedly does not have time to strike agreements with most countries, Trump's simply going to start tariffing most of these countries without any deliberations at all. "So at a certain point over the next two to three weeks, I think Scott (Bessent) and Howard (Lutnick) will be sending letters out essentially telling people - and we'll be very fair - but we'll be telling people what they will be paying to do business in the United States," Trump said while speaking at a roundtable in the recently-concluded United Arab Emirates trip. Acknowledging there was not enough time to meet with every country that the US had hit with tariffs in early April, Trump said Treasury Secretary Bessent and Commerce Secretary Lutnick would begin their outreach to those nations soon. "I guess you could say they could appeal it, but for the most part I think we're going to be very fair," he said. "But it's not possible to meet the number of people that want to see us." On April 2, the American president levied a 10 per cent tariff on all imports and higher additional tariffs on dozens of countries that had larger trade imbalances with the US. Trump later announced a 90-day pause on those higher tariffs, allowing time for nations to negotiate trade deals.

Subsequently, the US has announced agreements with the United Kingdom and an interim deal with China to lower tariffs, though Trump has signaled that his proposed 10 per cent rate will be a floor for all countries.



New Delhi (Agency): Following India's targeted strikes on terror camps in Pakistan and Pakistan occupied Kashmir on the intervening night of May 6 and May 7, and the subsequent military escalation that ensued between the two countries, social media became a battleground of information warfare. Fake information, deepfake visuals and footage from video games run amok on platforms like X and Instagram. In response, a small team at the Ministry of Electronics and IT (MeitY), which was set up last year during the Lok Sabha polls to flag and takedown electionrelated misinformation on social media platforms, promptly received personnel reinforcement and was asked to step up monitoring and flagging misleading content related to the conflict to be taken down. The monitoring happened round the clock, with people working across shifts. On May 9, two days after the military escalation between India and Pakistan, the IT Ministry expanded its election time content monitoring cell and converted it into a war room for Section 69(A) of the Information Technology Act, the legislation which allows the Central government to issue content blocking orders to social media companies, The group, which included at least 19 people, including those possessing technical know-how across the ministry and the Indian Computer Emergency Response Team (Cert-In), had a clear mandate: to block Pakistani sponsored social media content under section 69A of IT Act. The group flagged for takedown content and accounts spreading misleading information on the Internet - and tens of thousands of social media accounts were blocked in the process. Several websites were also blocked. The group received inputs from various central and state agencies as well, along with its own round-the-clock monitoring of social media. In times of uncertainty, online disinformation campaigns often act as a strategic ploy to capture the narrative war. Such campaigns - which have become routine now on social media platforms that have been unable to curb the sheer number of misleading content on their sites -have been used in previous and ongoing conflicts as well, such as the Israeli strikes on Gaza, and Russia's invasion of Ukraine. During the military escalation between India and Pakistan, the government carried out a coordinated effort to tackle misleading information online, even as many questioned the clamour that was spreading particularly on Indian news channels.

"The fall of Sheikh Hasina's pro-India government in mid-2024 and the rise of an interim administration under Muhammad Yunus have brought a willingness to align with Beijing. Yunus's visit to China in March 2025 yielded \$2.1 billion in new investments and cooperation agreements. China's involvement in sensitive infrastructure projects like Teesta River the development marks a growing strategic footprint - posing a direct challenge to India's influence in the region," said former trade officer and head of GTRI Ajay Srivastava.

EDITORIAL Perilous Currents

In the aftermath of Operation Sindoor and the horrific April 22 attack in Pahalgam, Jammu & Kashmir ~ where 26 civilians, mostly tourists, lost their lives ~ the government's sharpened focus on the Indus river system marks a significant shift in India's strategic posture. As national grief turned into political resolve, Delhi's response has included suspending its participation in the Indus Waters Treaty (IWT) and fast-tracking infrastructure on rivers allocated to Pakistan. But while the impulse to retaliate is understandable, India's move to potentially weaponise water could be a perilous path, both diplomatically and environmentally. The IWT, signed in 1960, has withstood wars, border skirmishes, and diplomatic frost. It has long been viewed as a rare example of pragmatic cooperation between two hostile neighbors. India's decision to re-evaluate the treaty and pursue unilateral hydrological projects ~ like doubling the length of the Ranbir canal on the Chenab ~ may seem like a demonstration of sovereignty and strength. Yet, it raises questions about long-term consequences. First, any significant diversion of Indus waters would take years to implement. Projects of this scale involve complex engineering, significant environmental assessments, and financial investment. Yet the political optics of such plans ~ especially in the wake of Pahalgam ~ can inflame tensions faster than any dam can be built. Islamabad has already declared that such diversions would constitute an act of war, highlighting how water, once a tool for peace, is now emerging as a geopolitical fault line. India must also recognise that any disruption to Indus flows can worsen already dire economic and social conditions in Pakistan, potentially fueling greater instability in the region. Strategic advantage must not come at the cost of regional collapse or humanitarian fallout. Secondly, India's credibility as a responsible upper riparian state is at stake.

If Delhi unilaterally abrogates or sidelines an international agreement, it undermines its moral position in other cross-border water disputes ~ particularly with China, which controls the headwaters of the Brahmaputra and other Himalayan rivers. Encouraging the idea that water treaties are conditional may prove selfdefeating in the long run. Moreover, in a climate-stressed subcontinent, where glacial melt and erratic monsoons already threaten water security, escalatory hydropolitics could be disastrous. Rather than treating water as a finite commodity to be hoarded or denied, the future demands cooperative basin management and resilient infrastructure. That said, Pakistan cannot continue to ignore its responsibilities. and if the threat to agriculture forces it to abandon its support to terrorists, it will be a welcome outcome. The persistence of cross-border terrorism and its denialism over the Pahalgam massacre have severely eroded trust. India's push to assert its treaty rights and develop its own water infrastructure ~ within legal bounds ~ should be seen as a sovereign imperative, not an act of provocation. India must remain clear-eyed. The symbolism of water runs deep in both culture and strategy, but its use as a tool of coercion can trigger cycles of conflict that outlive any single act of terror. The challenge ahead is to uphold strength without sacrificing prudence ~ a balance that defines mature statecraft.

After more than three years of brutal conflict, the promise of peace in Ukraine still hangs precariously in the balance. Diplomatic efforts are once again underway, this time in Istanbul, where representatives from Ukraine, Russia, the United States, and Turkey have met. Yet the absence of se-

Tavigating rush hour might soon feel less chaotic. At dozens of intersections Artificial Intelligence (AI) is now analysing traffic patterns, drawing insights from Google Maps data, and suggesting optimised timings for traffic signals. This type of AI-driven solution aims to reduce frustrating stop-and-go traffic, save fuel and cut emissions. It's a small intervention in a massive system, yet it hints at a larger possibility: Can India potent harness the combination of digital infrastructure, entrepreneurial energy, and rapidly advancing AI to tackle its most complex, systemic challenges? India finds itself in a unique position. Building Digital Public Infrastructure (DPI) from the Aadhaar identity system to the ubiquitous UPI payments network and emerging data-sharing frameworks - has created unprecedented digital rails. Lavered onto this is a vast, young population rapidly embracing digital tools, and a vibrant startup ecosystem teeming with technical talent and ambition. AI represents a technology shift as profound, perhaps, as fire or electricity. An enabler that can accelerate progress across nearly every field, its power demands a bold approach to innovation, pushing boundaries while ensuring safety and equitable benefit. We see this globally with breakthroughs like AlphaFold, which has protein revolutionised prediction, structure dramatically speeding up medical research and drug discovery. In India, this potential is translating into tangible impact, particularly in healthcare. AI algorithms developed by companies like Google and its partner, Verily Life Sciences, help screen for diabetic retinopathy using

simple retina scans. Startups like Niramai are pioneering radiation-free, AI-based breast cancer screening, while others like Oure.ai assist doctors in interpreting medical scans, thereby improving diagnostic accuracy. Agriculture, the livelihood for a vast majority of India's population, is another fertile ground: Startups like CropIn deployAI solutions to provide farmers with actionable insights predicting yields, detecting diseases early, and optimising resource use based on weather and satellite imagery. Farmonaut offers similar capabilities, leveraging satellite data and AI for personalised farm advice. More than efficiency gains, they are improving livelihoods and enhancing food security. AI is also proving vital in managing environmental challenges. Forecasting tools like Flood Hub provide crucial early warnings across large parts of India. Efforts to map air quality street-by-street using mobile sensors, like those undertaken in Bengaluru, provide high-resolution data, essential for understanding pollution sources and informing public health strategies. But can the startup ecosystem, even supercharged by AI, truly solve India's most daunting systemic problems the air quality crisis in its cities, urban traffic gridlock, water scarcity, or the complex logistics of a continent-sized economy? The ecosystem is evolving. Audacious entrepreneurs are already beyond urban moving convenience solutions, and formidable tackling challenges in areas such as launch vehicles space (Skyroot, Agnikul), vital satellite constellations Dhruva Space, (Pixxel. Digantara), advanced robotics (Addverb, CynLR), futuristic

mobility solutions (Sarla, ePlane, Blu-J, Ather), and foundational technologies like gene editing (CrisprBits), semiconductors (Mindgrove), and quantum computing (Qnu Labs).

Skyroot's Vikram-S launch, which opened up private space endeavours, and strides in defence tech (ideaForge, EyeRov), signal this shift. Investment is following, with Nasscom reporting a 78 per cent year-on-year funding jump for India's ~4,000 deeptech startups, reaching \$1.6 billion in 2024, and projections suggesting deep tech could add \$1 trillion to India's GDP by FY30.

However, scaling these promising deep-tech ventures to truly tackle the systemic crises presents immense hurdles beyond clever algorithms. requires It navigating complex policy landscapes - integrating AI insights into urban planning, tackling deeply enmeshed challenges like industrial emissions and agricultural burning alongside technological monitoring and addressing critical ecosystem gaps. These include the need for substantial patient capital willing to weather longer development cycles, bridging the deep-tech talent gap through focused education reform and overcoming challenges. The path forward, therefore, demands concerted symphony of action. In Delhi, Tamil Nadu, West Bengal, Andhra, Kerala, Punjab, wherever there were governments of opposition parties, the governors there were holding back the bills passed by the assembly of the elected governments for many months and years. The work of breaking the opposition parties by taking action under Operation Lotus and ED was being done through the governors. After this decision of the Supreme Court, it will not be possible for the Central Government and BJP to create such pressure. Peace cannot be brokered by those without the mandate to concede or commit. Diplomacy without consequence merely prolongs the illusion of progress. Symbolic meetings and staged summits will not end the war. What is needed is genuine negotiation underpinned by political courage, strategic compromise, and mutual recognition of human suffering. The Istanbul talks, in their current form, risk becoming yet another footnote in a long series of failed efforts if key actors continue to treat peace as a procedural matter rather than a moral imperative. Until the main architects sit face to face and reckon with the weight of their decisions, peace will remain elusive. In diplomacy, timing and presence are everything. And right now, the world is still waiting for both.


India has always extended a hand of friendship across continents, across faiths, across ideologies. From standing by the Ottoman Empire during the Khilafat movement to cooperating with modern Turkey in trade, technology, education and cultural exchanges, India believed in longterm goodwill. But today, it finds itself betrayed by a country it once supported during its most critical moment in history. Turkey, under the authoritarian leadership of President Recep Tayyip Erdo an, has chosen to side with Pakistan not just diplomatically, but militarily, feeding New Delhi's enemies with deadly drones and rhetoric, revealing Ankara's dangerous ambitions to become the ideological capital of a pan-Islamist world order - even at the cost of peace in South Asia. The most recent Indo-Pak tensions, especially after Pakistan's proxy aggressions in Kashmir and elsewhere, have seen Turkey abandon any pretence of neutrality. by Baykar Technologies, whose CEO Selçuk Bayraktar is none other than Erdo an's son-in-law are now in Pakistan's hands. These drones are not for humanitarian use or border surveillance. But India cannot and will not tolerate foreign governments using religion as a tool of geopolitics against it.

Turkey's ambitions to become the new head of the Islamic Ummah come with the price tag of instability and ideological confrontation. Erdo an has found common cause with Pakistan, Qatar, and certain radical outfits, hoping to revive a caliphate that the modern world has long buried. Turkey's betraval is not just strategic, it is civilizational. It is a deliberate choice to side with India's enemies and undermine a centuryold bond. India must now recalibrate its foreign policy with clarity and strength.

We have friends in West Asia - the UAE, Saudi Arabia, Egypt - who have shown greater pragmatism and respect. India must deepen ties with them while sending a clear message to Ankara: betrayal has consequences. In the years to come, Indian policymakers, industrialists, students, and common citizens must remember that partnerships must be rooted in mutual respect and shared values. Turkey under Erdo an has lost both. And until it regains them, India must look elsewhere. The road from Khilafat to today's crisis is a painful reminder that not all historic bonds endure - especially when one side uses them as tools of manipulation. For now, the sun is setting on on India-Turkey ties. Whether it rises again will depend on when, or if, Turkey chooses principles over politics.

Thousands protest after a suspected drone strike kills four children in Pakistan



PESHAWAR (Agency): A suspected drone strike killed four children and wounded five others in Pakistan's restive northwest, prompting thousands of residents to stage a protest by placing the children's bodies on a main road to demand justice, local elders said on Tuesday.

It was unclear who was behind Monday's attack in Mir Ali, which has been a stronghold of Pakistani Taliban, and there was no comment from the army about the incident. "We are not blaming anyone, but we want justice, and the government should tell us who killed our children," local tribal elder Mufti Baitullah said.

He warned that the protest, currently staged at one regional roadblock, could expand if authorities fail to answer. "We will not bury the bodies until we are told who is responsible for killing our innocent children," he said, as people chanted "we want justice." The civilian casualties came amid ongoing military operations against the Pakistani Taliban, which have a strong presence in Mir Ali, a city in the Khyber Pakhtunkhwa province. The Pakistani Taliban, known as Tehreek-e-Taliban Pakistan, are a separate insurgent group from the Afghan Taliban, and they often target troops in the region. Zelensky says Russia 'trying to buy time' to 'continue war'

KYIV (Agency): Ukrainian President Volodymyr Zelensky Tuesday on accused Russia of not seriously engaging in peace talks and of wanting to continue its three-year invasion, despite a US push for a ceasefire.

US President Donald Trump held calls with both Zelensky and Russian leader Vladimin Putin on the war on Monday, and Russian and Ukrainian officials met in Istanbul on Friday for the first direct talks on the conflict in more than three years. But the Istanbul talks failed to yield a truce, and Zelensky accused Putin of sending "empty heads" to the negotiating table. "It is obvious that Russia is trying to buy time in order to continue its war and occupation," Zelensky said in a post on social media. Trump framed his two-hour conversation with Putin on Monday as a breakthrough, as the Republican seeks an elusive deal to end the war that he had promised on the

FRANCE (Agency): Twin Gazan filmmakers Arab and Tarzan Nasser said they never thought the title of their new film "Once Upon A Time in Gaza" would have such heartbreaking resonance.

"Right now, there is nothing left of Gaza," Tarzan said when it premiered on Monday at the Cannes Film Festival.

Since militants from the Palestinian group Hamas attacked Israel on October 7, 2023, Israel's retaliatory offensive in Gaza has devastated large swathes of Palestinian territory, killing tens of thousands of people.

Israel has vowed to "take control of all" the besieged territory of more than two million inhabitants, where United Nations agencies have warned of famine following Israel's implementation of a two-month total blockade

Aid began to trickle into the Gaza Strip on following widespread Monday, condemnation of the siege.

The Nasser brothers, who left Gaza in 2012, said their new film, set in 2007 when Hamas Islamists seized control of the strip, explains the lead-up to the current catastrophic war.

Once Upon A Time in Gaza, which screened in the festival's Un Certain Regard section, follows friends Yahia and Osama as they try to make a little extra cash by selling drugs hidden in falafel sandwiches.







ajesh Khanna witnessed unprecedented success as a leading man in the 1960s and 1970s, but the decline of his career was as abrupt as its ascent Often described as 'India's first superstar', Rajesh Khanna had a famous fall from grace towards the end of his life,

War 2 is the sixth installment in Yash Raj Films' Spy Universe, following Ek Tha Tiger, Tiger Zinda Hai, War, Pathaan, and Tiger 3. The franchise will also expand further with the upcoming Alpha, starring Alia Bhatt and Sharvari.

The 2019 film War, directed by Siddharth Anand and co-starring Tiger Shroff, was a box office blockbuster. Promising to outdo its predecessor, War 2 is touted as a bigger and better sequel. Its action sequences were filmed across six countries — Italy, Spain, Japan, Abu Dhabi, Russia, and Mumbai. There has been speculation if we will see other stars from the YRF spy universe making cameo appearances. However, the makers have been tightlipped about it.

lthough it has been close to two decades since he tragically passed away, Heath Ledger is still widely regarded as one of the finest actors of the 2000s. His performances as the Joker in Christopher Nolan's The Dark Knight (2008) and Ennis Del Mar in Ang Lee's Brokeback Mountain (2005) continue to inspire many. Recently, his former girlfriend Michelle Williams - who

shares a 19-year-old daughter, Matilda Ledger, with him fondly recalled what an incredible person Ledger was. During a chat with her on a recent episode of his Armchair Expert podcast, actorcomedian Dax Shepard spoke about the late thespian, "I feel obligated to say that I knew him a little bit when he was getting sober. I can feel the weight of the world on him in a very special way that kind of



broke my heart. I was very, just so special." very sad, and I thought he was In response, Williams said,

"So special, so special. Thank god there's Matilda." Heath Ledger and Michelle Williams met each other on the set of Brokeback Mountain and started dating soon after. In 2005, they welcomed Matilda. Ledger and Williams were in a relationship for three years. In September 2007, her father, author Larry R Williams, revealed that the two actors had split up. He passed away a

few months later from an accidental overdose. When Shepard described Ledger as "this heart here that's just leaking out of everywhere", Williams added, "Yeah, an incredible sensitivity." E! News quoted her as saying, "We had a baby, but I suppose maybe the good thing about being young is that you don't have so much life experience that you can contextualise things

and spent most of his time alone at home, in the company of alcohol. His close friend, journalist Ali Peter John, wrote extensively about his interactions with the superstar over the years. Rajesh said, "Nahi Ali, sharab abhi nahi, function mein peekar jaana theek nahi hai, woh bhi aurton ke function mein (No Ali, I shouldn't drink now, it's not right to drink before an event, especially one where women will be present)." Rajesh's philosophical spiral continued during the event, as he noticed the adulation he was receiving, the adulation that was missing in his regular life. He leaned over to Peter John and whispered in his ear, "Ali, kya aisa lagta nahi ki main abhi bhi superstar hoon (Ali, doesn't it seem like I am still a superstar)?" The reality hit when he and Peter John returned to Mumbai. The journalist added, "The function was over and we drove back and I could see the revival of a new Rajesh Khanna which lasted till we came back to Mumbai and the reality of his being nowhere and no one hit him in his face when no one at the airport was even willing to offer him a seat and he finally had to sit on his own bag.

'He would be first one to say that he hasn't had a season that he would have liked': **Mitchell Marsh on Rishabh Pant**

New Delhi (Agency): Record IPL signing and Lucknow Super Giants captain Rishabh Pant has had a season to forget with LSG getting knocked out from the playoffs contention by Sunrisers Hyderabad on Monday. Pant, who has scored 134 runs in 12 games, never seemed to find his footing this season, striking at 100 with an average of 12.27. "He would be the first one to say that he hasn't had a season that he would have liked, but I know for myself personally that that's the way cricket goes sometimes," his teammate Mitchell Marsh, who has tallied 443 runs so far with five halfcenturies told reporters after the match vs SRH.

"We know that he's a fantastic player, highly skilled and highly talented, so he will be back, but yeah, hopefully the last two games," he added.

On asked about the positives of the season, the Australian said that the team would focus on that after their two remaining matches.

"I think the time for reflection is probably after the season and for me personally just focus on trying to contribute to winning the next two games for our team and for our franchise. Like I said, the IPL is a

beast of a tournament and the margins are really small. We lost a couple of close games throughout the season that now have come back to bite us, but yeah, it's all about finishing off the season as strong as we possibly can now," he said.

Meanwhile, former India cricketer Aakash Chopra also believes that Pant will need to reassess his approach in T20 cricket after enduring a "nightmare" IPL season. "Success might teach you a few things. Failures, however, truly change your mindset - and often for good. He isn't a regular in the Indian T20 side, so this season was crucial. A chance to make a mark, to build a strong unit," Chopra, a former India opener, told 'JioHotstar'.

"It hasn't gone that way. His own form has been inconsistent another lesson in itself. Does he stick to this approach in T20s or adapt?

"When you're in a bad patch, it feels nothing like works. The nights seem

longer, the days even more so. That's when you learn and bounce back. This has been nightmare. The good thing about nightmares is that you eventually wake up, Chopra

said.

NEW DELHI: The BCCI on Monday termed as "speculative and imaginary" the report which claimed that it has decided to pull out of men's Asia Cup and women's Emerging Teams Asia Cup.

A media report, quoting sources, said that BCCI won't let Indian teams compete in the two Asian Cricket Council (ACC) events at a time when the cricket body is being headed by a Pakistani and just days back the two neighbouring nations were involved in a military conflict. Pakistan's interior minister Mohsin Naqvi, who is also PCB chairman, holds the position of president in the ACC.

Defending champions India are the hosts for the men's Asia Cup, to be played in the T20 format, in September.



BRIEF NEWS Woman killed in UK: Husband still on the run, last spotted at **Gurgaon bank** in March Delhi (Agency): Months

after a 24-year-old Delhi woman was murdered her body found in the boot of a car - in East London, her husband, the main accused in the case, was purportedly spotted in Gurgaon, sources said. The Delhi Police had earlier issued a Look Out Circular (LOC) against the husband, after he was suspected to have arrived in the national capital, and declared him a Proclaimed Offender (PO) on May 1. On March 4, sources confirmed, the accused was purportedly seen withdrawing money from a bank in Gurgaon. An officer, privy to the investigation, said he was wearing a mask at the bank."He withdrew Rs 4.3 lakh from the bank branch via a cheque and left. CCTV footage from the bank showed he was alone. Before this, he had withdrawn Rs 21,000 from another bank on the same day. But we don't have footage, so we cannot confirm if he had gone himself or sent someone in his stead," a source said. As per the latest status report filed by the SHO of the Palam Village police station in the Delhi High Court, where the matter is currently being heard, details of two banks from where the accused withdrew money were mentioned. These details were collected by the police on April 4. The High Court, in an earlier hearing, had asked the police to file an updated status report outlining the steps they have taken to arrest the accused.

Bhopal rape case NCW investigation indicates forced conversion and involvement of criminal network

Bhopal (Agency): A factfinding committee of the National Commission for Women (NCW) claims that the alleged rape and intimidation of girls in a Bhopal college indicates pressure for conversion and the possible involvement of an organized criminal network. The committee has also suggested a statewide investigation into the matter. The case is related to a group of college students who allegedly raped several girl students after drugging them. Not only this, the accused made a video of this

act and used the video to threaten the victims so that the victims would introduce more girls to them.

The NCW investigation committee headed by retired IPS officer Nirmal Kaur, comprising advocate Nirmala Nayak and Under Secretary Ashutosh Pandey, visited Bhopal from May 3 to 5. During this time, they met the victims, their families, police officials and representatives of educational institutions.

The committee also inspected the sites where the victims were allegedly drugged and sexually assaulted. According to the investigation report, the accused lured the girls with expensive gifts and vehicles and made them consume drugs.

accused took objectionable The photographs to intimidate the victims. In some cases, they allegedly pressured the girls to convert to Islam. The committee said that despite severe emotional trauma and social pressure, the victims showed remarkable courage by filing FIRs.

The report also said that although the economic background of the accused was normal, their luxurious lifestyle indicated a possible connection with drug trafficking and organised crime. The committee recommended that a thorough and statewide investigation be conducted into these aspects to find out whether external funding or ideological influence was involved.

Public School (DPS), Dwarka, challenging the students' expulsion last week over alleged nonpayment of fees, even as the school denied allegations of profiteering.

The school, through its counsel, told the court of Justice Sachin Datta that since 2015-16, the school has faced a deficit while paying salaries and meeting expenditure. "How do I operate with a growth deficit of Rs 31 crore over 10 years? Today, there is an outstanding of Rs 1.75 crore... Rs 42 lakh is due from these 31 students." "This whole perception that this is profiteering... These are not the franchise issues... these are all very eminent people who run the DPS Society. To think that these people want profit ...,' the counsel added. The school submitted that it had issued notices to the students that their fees were due. It added that 31 students were expelled over non-payment of fees, and not 32 - as was asserted by the parents - with one of the students taking a transfer. With arguments concluded, the court reserved the application for verdict. On May 16, the HC had orally remarked that it is inclined to stay DPS Dwarka's order expelling 32 students over non-payment of fees.

Gross misuse of SC/ST Act: SC grants bail to lawyer booked for casteist slurs

Delhi (Agency): Calling it a case of "gross misuse" of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, the Supreme Court Tuesday granted bail to a Jharkhand lawyer who was accused by his woman client of hurling casteist slurs.

"This is gross misuse of the SC/STAct," CJI B R Gavai said, presiding over a two-judge bench also comprising Justice AG Masih

The SC had granted lawyer Virendra Singh anticipatory bail in July 2024 noting that "prima facie, we find that no specific role is attributed to the present petitioner in the FIR and there is also a previous litigation pending between the parties". On Tuesday, the counsel for the complainant woman opposed Singh's appeal challenging the Jharkhand HC's December 13, 2023 order dismissing his anticipatory bail plea and sought more time to file a counter affidavit.

But the SC bench said that on April 17 this year the state was already given the last opportunity of four weeks to file its counter affidavit. The bench also noted that Singh had joined the investigation. "... Taking into consideration the fact that pursuant to the interim orders passed by this Court dated 12.07.2024, the petitioner has joined the investigation and cooperated with the investigating agency, we are inclined to make the order dated 12.07.2024 passed by this Court absolute."



Appearing for Singh, Advocate Chayan Sarkar argued that the case is nothing but a fallout between the lawyer and her client, and the fact that the complainant has also filed two more FIRs also shows this is vendetta.

He contended that the woman had lodged a case against Singh and his son when the advocate asked her to pay his fees. Later, Singh was also booked under the SC/ST Act on allegations that he and some other lawyers hurled casteist slurs on the woman and assaulted her on the premises of a Jamshedpur court in February 2022. The woman's counsel had submitted before the HC that the incident had

occurred in full public glare and would therefore constitute an offence under the Act. Dismissing his plea for anticipatory bail, the HC had said, "it is seen that in the FIR also the presence of the appellant is made out and that the appellant was working in tandem with other accused persons...'

Sarkar said that the HC delved into the statements of the complainant and other witnesses, which were nothing but reiteration of the contents of the FIR, but failed to consider that there were no direct allegations against the petitioner. The allegations were principally against some elected members of the district bar association of Jamshedpur.

Fake govt recruitment racket busted. 2 arrested

Delhi (Agency): With the arrest of two persons, Delhi Police on Monday claimed to have busted a fake government recruitment racket, in which the accused allegedly duped people by encouraging them to register on fraudulent websites that carried photographs of ministers and senior government officials.

The main accused, Rashid Choudhury, allegedly ran a cyber scam by using the 'National Rural name Development and Recreation Mission (NRDRM)' to falsely present it as a government body under the Ministry of Development Rural (MoRD), police said. Both Choudhury and his accomplice, Ikbal Hussain (27,) were arrested on Sunday. The matter came to light when the MoRD filed a police complaint in March alleging that two sites under the name NRDRM were fraudulent carrying recruitment advertisements and falsely projecting itself as being a part of the ministry. The site would demand payment from the victims on the pretext of registering them for the recruitment process, said police.
