



SC likely to hear plea on May 5 seeking contempt action against BJP MP Dubey over remarks against CJI

NEW DELHI: The Supreme Court is expected to hear a plea on May 5 demanding initiation of suo motu contempt proceedings against BJP MP Nishikant Dubey for allegedly making derogatory and scandalous remarks against the apex court and the Chief Justice of India. The petition, listed for likely hearing this week, seeks the court's intervention over what it terms an attack on the dignity of the judiciary. It also urges the top court to direct the Union Ministry of Home Affairs to issue an advisory to all state Chief Secretaries to curb hate and provocative speeches by political leaders, especially in relation to the Waqf (Amendment) Act, 2025. Maharashtra stipend for 8L

Ladki beneficiaries cut

MUMBAI: The state govt has reduced the stipend of eight lakh beneficiaries of its flagship Mukhya Mantri Majhi Ladki Bahin Yojana because they were also receiving benefits under another govt scheme, the Namo Shetkari Mahasanman Nidhi (NSMN). The eight lakh women will receive a payout of Rs 500 instead of Rs 1,500 per month because they already receive Rs 1,000 under Namo Shetkari programme. The Ladki Bahin scheme stipulates that its beneficiaries can avail of other govt schemes only if the benefit is capped at Rs 1,500 per month. This is part of state's move to scrutinise beneficiaries of the Ladki Bahin scheme and to restrict the stipend only to those who fit the eligibility criteria. In Oct, state had around 2.63 crore applicants for the scheme. The scrutiny process reduced that figure.

He then Police officials have registered the case under Sections 351(2), 352(I), and 353 of the Indian Penal Code and have commenced their investigation.

The controversial remarks were delivered during a stage performance and were recorded on video, which subsequently spread across social media platforms, triggering significant backlash from Karnataka residents.

The airport is being developed through a public-private partnership

Noida International Airport Ltd (NIAL) at Jewar, in the Gautam Buddha Nagar district of Uttar Pradesh, conducted its first flight validation test on 9 December. According to NIAL officials, the first commercial flight from Noida International Airport is scheduled to take off on 17 April 2025. Indian Prime Minister Narendra Modi had inaugurated the construction of NIAL during a well-attended foundation stone-laying ceremony on 25 November 2021. An IndiGo test flight travelled from Delhi's Indira Gandhi International Airport (IGIA) to NIAL, completing the final security-related analysis for the facility. Officials stated that the flight was conducted under close coordination between the pilots and the air traffic controllers (ATC). There were no passengers on board when the flight landed on the 3.9-kilometre runway shortly after noon. Earlier, the Directorate General of Civil Aviation (DGCA) had granted flight and security approvals. Technically, the airport will now be readied for commercial operations. The Airports Authority of India (AAI) oversaw the exercise, and all data collected will be submitted to the DGCA for review. Supervising personnel included officials from the DGCA, the Ministry of Civil Aviation (MoCA), NIAL, and the Uttar Pradesh Civil Aviation Department. The test assessed systems such as airspace coordination, communication protocols, emergency response readiness, and runway performance. Previous milestones included the successful calibration of the Instrument Landing System (ILS) and the Precision Approach Path Indicator (PAPI) in October 2024.

With the validation flight completed, we are committed to finishing the airport project before the end of April", said Union Minister.

"Today marks a very important occasion in the progress of the airport and definitely whatever support is required from the Ministry of Civil Aviation, we will continuously provide, so that the early operations from the airport can begin," he said. The aim is to complete the validation process by December 15, after which the airport concessionaire will apply for an aerodrome license, a key requirement for commercial operations. This greenfield airport will be the largest in the country. It is located approximately 72 kilometres from Delhi's Indira Gandhi International Airport (IGIA), which, until now, has been the only other international airport in the National Capital Region and is nearing its capacity. Uttar Pradesh, India's most populous state, currently has 15 operational civil airports. The airport is being developed through a public-private partnership (PPP) model. It will be owned by Noida International Airport Ltd (NIAL) and operated by Yamuna International Airport Private Limited (YIAPL), a Special Purpose Vehicle (SPV) of Zurich Airport AG. In June 2022, Tata Projects was awarded the construction tender.

To stand in this house is to be reminded of what is most beautiful about religious faith

To stand in this house is to be reminded of what is most beautiful about religious faith: its ability to give solace and to inspire, its aspiration to these great and lovely heights, in which strength and delicacy are so perfectly conjoined. In addition, to be asked to speak here on this day, the fourth anniversary of the notorious fatwa of the late Imam Khomeini, is a particular honour. When I was an undergraduate at this college, between 1965 and 1968, the years of flower-power and student power, I would have found the notion of delivering an address in King's Chapel pretty far-out, as we used to say; and yet, such are the journeys of one's life that here I stand. I am grateful to the Chapel and the college for extending this invitation, which I take as a gesture of solidarity and support, support not merely for one individual but, much more importantly, for the high moral principles of human rights and human freedoms that the Khomeini edict seeks so brutally to attack. For just as King's Chapel may be taken as a symbol of what is best about religion, so the fatwa has become a symbol of what is worst. It feels all the more appropriate to be speaking here because it was while in my final year of reading history at Cambridge that I came across the story of the socalled satanic verses or temptation of the Prophet Muhammad, and of his rejection of that temptation. That year, I had chosen as one of my special subjects a paper on Muhammad, the rise of



Islam, and the caliphate. So few students chose this option that the lectures were cancelled. The other students switched to different special subjects. However, I was anxious to continue, and Arthur Hibbert, one of the King's history dons, agreed to supervise me. So as it happened I was, I think, the only student in Cambridge who took the paper. The next year, I'm told, it was not offered again. This is the kind of thing that almost leads one to believe in the workings of a hidden hand. The story of the 'satanic verses' can be found, among other places, in the canonical writings of the classical writer al-Tabari. He tells us that on one occasion the Prophet was given verses which seemed to accept the divinity of the three most popular pagan goddesses of Mecca, thus compromising Islam's rigid monotheism. Later he rejected these verses as being a trick of the devil

saying that Satan had appeared to him in the guise of the Archangel Gabriel and spoken 'satanic verses.' Historians have long speculated about this incident, wondering if perhaps the nascent religion had been offered a sort of deal by the pagan authorities of the city, which was flirted with and then refused. I felt the story humanized the Prophet, and, therefore made him more accessible, more easily comprehensible to a modern reader, for whom the presence of doubt in a human mind, and human imperfections in a great man's personality, can only make that mind, that personality, more attractive. Indeed, according to the traditions of the Prophet, even the Archangel Gabriel was understanding about the incident, assuring him that such things had befallen all the prophets, and that he need not worry about what had happened. It seems

that the Archangel Gabriel, and the God in whose name he spoke, was rather more tolerant than some of those who presently affect to speak in the name of God. Khomeini's fatwa itself may be seen as a set of modern satanic verses. In the fatwa, once again, evil takes on the guise of virtue; and the faithful are deceived. It's important to remember what the fatwa is.

One cannot properly call it a sentence, since it far exceeds its author's jurisdiction; since it contravenes fundamental principles of Islamic law; and since it was issued without the faintest pretence of any legal process. (Even Stalin thought it necessary to hold show trials)! It is, in fact, a straightforward terrorist threat, and in the West it has already had very harmful effects. Supreme Court pulls up Centre for missing deadline on establishing cashless medical treatment scheme

NEW Delhi: The Supreme Court on Wednesday slammed the Centre regarding delays in establishing a cashless medical treatment scheme for motor accident victims. The court summoned the road transport ministry secretary for clarification.

Justices Abhay S Oka and Ujjal Bhuyan noted non-compliance with their 8 order."The time granted has expired on 15, 2025. 

IndiGo orders 30 long-haul planes for \$9.5 billion



Delhi: In 2027, IndiGo will fly nonstop between India and remote locations using its own widebody aircraft. The Rahul Bhatia-founded mega budget carrier "has agreed" to order 30 twin-aisle Airbus A350-900s worth over \$9.5 billion at list price and an option for 70 more. Indian travelers will have two domestic airlines, Air India and IndiGo, running medium to ultra long-haul routes on dual aisles (Vistara merges into AI this year), as well as many foreign carriers. IndiGo "agreed to order" 60 Trent XWB engines for 30 A350s. IndiGo evaluated the B787 Dreamliner, but Boeing's ongoing issues persuaded it to stick with Airbus, which has over 1,000 A320 family single aisles on order and is the world's largest A320 operator. Airbus controls India's single aisle market, but troubled Boeing is no longer the only wide body with Indian carriers. Since last year, Airbus has been receiving orders for big birds, starting with AI. IndiGo leased two B777s from Turkish Airlines to run a daily Delhi/Mumbai-Istanbul trip. After that experience, it ordered wide bodies for delivery in 2027, IndiGo's 21st year. Airlines can acquire 70 more A350-900 "at its discretion, for possible future needs under certain conditions," they say. IndiGo had over 10 crore passengers in 2023 on 350 planes.

Who is Sandip, ex-principal of RG Kar MCH Look at his educational

Delhi: Dr. Sandip Ghosh, the former principal of RG Kar Medical College and Hospital in Kolkata, has recently faced intense scrutiny after the tragic rape and murder of a doctor on duty at the institution. He resigned from his position as principal on August 12, three days after the incident. On Sunday, he appeared before the Central Bureau of Investigation (CBI) for the third time, due to an alleged connection to the murder. This situation has led many to question Ghosh's professional qualifications and career trajectory.

Becoming a doctor

Sandip Ghosh's journey began in the small town of Bangaon, West Bengal. He completed his higher secondary education at Bongaon High School in 1989. Pursuing a career in medicine. Ghosh enrolled at RG Kar Medical College, a prestigious institution in Kolkata, where he earned his medical degree in 1994. Ghosh's early career in medicine was marked by steady progression. Ebola-hit Uganda begins vaccination trial: Who

GENEVA: Uganda on Monday started a vaccination trial for the Sudan species of the Ebola virus four days after an outbreak was confirmed, the world health organization announced.

It is the sixth time Uganda has been hit by an outbreak of the Ebola Sudan virus, for which there is no approved vaccine. Of the five other Ebola species, just one has licensed vaccines. The deadliest Ebola epidemic killed more than 11,300 people in west Africa between 2013 and 2016. The UN health agency said it had supported Ugandan health authorities in getting the trial ready in the days following the announcement that a 32-yearold male nurse had died of Ebola in Kampala. "This vaccination trial was initiated with record speed," Who chief Tedros Adhanom Ghebreyesus said on X. He said the trial, launched at a ceremony in Kampala by Uganda's health minister, "demonstrates the importance of investing in R&D for vaccines and treatments and outbreak response preparedness".

'Critical achievement'

This trial marks how good this candidate vaccine is at preventing disease caused by the Sudan Ebola virus. Previous phase 1 and 2 trials had already been conducted to ensure the candidate vaccine's safety and ability to provoke an immune response from those receiving the jab, the Who said. A system was put in place to test candidate vaccines during a previous outbreak of the Ebola Sudan virus in Uganda in 2022, paving the way for a trial during the next outbreak, the Who added. The Who said Friday the first 2,160 doses of the candidate vaccine were already in the capital Kampala as part of the preparations for another outbreak. It said those deemed "at highest risk" were eligible to join the trial.

The doses are being used in a "ring" vaccination scheme where first jabs are given to all contacts of confirmed Ebola patients and contacts of contacts. The Who said the first ring defined Monday involved 40 direct contacts and contacts of contacts of the health worker who died.

A Japan Airlines aircraft collided with a parked Delta Airlines plane while taxiing at Seattle-Tacoma Airport on Wednesday morning, causing damage to both planes but no injuries were reported. The incident took place at 10:17 am when the moving aircraft's wing struck the tail section of the parked Delta aircraft.

Travellers at the airport shared photographs on social media platforms showing the Japan Airlines wing sliced halfway through the Delta aircraft's tail section.

The airport authorities said that the incident caused minimal disruption to regular operations. "There are no injuries reported at this time. Vietnam's restrictive internet law comes into force

A new internet law in Vietnam, Decree 147, gives the government increased control over internet access and content in the name of national security and social order. It mandates tech companies to store user data, verify accounts, and remove deemed illegal content within 24 hours. Critics argue this suppresses free speech and impacts livelihoods. A new internet law that gives the Vietnamese government expanded powers over internet services and people using them is set to officially take effect Wednesday. Decree 147 expands government control over access to information on the internet for reasons of "national security" and "social order."The law requires social media platforms providing services to users in Vietnam to store user data and provide it to authorities on demand. The government issued the decree this November, and it requires organizations to take down anything the authorities consider "illegal content" within 24 hours. Decree 147 has sparked concerns, with researchers and experts tracking the country saying that the law is part of a growing crackdown on civil society. "Because the Vietnamese police treat any criticism of the Communist Party of Vietnam as a national security matter, this decree will provide them with yet another tool to suppress dissent,' said Patricia Gossman, associate Asia director at Human Rights Watch. The decree requires tech giants like Facebook and TikTok among other organizations., to verify user accounts using people's phone numbers or personal identification numbers. It requires companies to store that data. Decree 147 also requires organizations to provide search and content-scanning tools to government authorities upon request. It limits certain functions, like live video streaming.

The code, found within the chatbot's web login page, connects infrastructure to owned by China Mobile and appears to be part of the account creation and login process. The code linking DeepSeek to one of China Mobile was first discovered by Feroot Security, a Canadian cybersecurity company, which shared its findings with news agency The Associated Press (AP). This discovery is said to raise significant national security concerns for US officials, particularly given the increasing use of sen-

Experts warn that this connection could expose personal and proprietary information, representing a potential intelligence goldmine for China. The implications are reportedly considered even greater than those associated with TikTok, as the information shared with AI systems often includes highly personal and sensitive business data. US Federal The Communications Commission unanimously denied China Mobile authority to operate in the United States in 2019, citing "substantial" national security concerns about links between the company and the Chinese state. Feroot Security's findings were reportedly verified by two academic cybersecurity experts who confirmed the presence of China Mobile code DeepSeek's within login system. Elon Musk's Grok AI chatbot app to become available for Android users

The chatbot developed by Elon Musk-owned artificial intelligence (AI) startup xAI, Grok, will soon be available for Android users as a standalone app. The app, which is not yet available for download, has been listed on the Google Play Store, where users can pre-register for it. This follows a brief beta testing period in which some users had access to the app. However, xAI has yet to announce an official release date for the Android app. xAI seems to be preparing to launch an Android version of its AI chatbot a month after releasing Grok's app for iPhones.

An xAI engineer has also confirmed the Android app in a post on social media platform X (earlier Twitter). In the post, the xAI engineer wrote: "Grok Android app is now open for testing in Australia, Canada, India, Philippines, and Saudi Arabia. Visit the Google Play Store to try it. Be among the first 1,000 users and share your feedback." Grok's Play Store listing notes that the app will be free to use, with no sign-in required to access its features. However, users who may want a personalised experience or wish to connect the AI to their X account may also have the option to sign

in. It's important to note that Grok's iPhone app allows users to sign in via their Apple accounts. Similarly, the company may also allow Android users to sign up for the app via their Google accounts. To compare, the web version of the chatbot requires users to be signed in for access. Just like the iPhone app, standalone Grok's Android app is also expected to include features such as text responses, image generation, and real-time information sourced from X. However, it remains unclear whether the Android app will support web search-based queries.
