

# Pak used unsuspecting civilian planes as shield to launch failed drone attack

**NEW DELHI:** India on Friday accused Pakistan of using civilian planes as shield for its unprovoked aerial intrusions and to launch its failed drone and missile attack on Thursday evening with the intention of targeting military infrastructure."Pakistan did not close its civil airspace despite launching a failed unprovoked drone and missile attack on May 7 at 8.30 hours in the evening.

# US gives India a free hand to manage Pakistan espite salutary advice to de-escalate

Salutary advice about deescalating tensions aside, the Trump administration on Thursday indicated the US would give New Delhi a free hand and stay out of any war between India and Pakistan, saying it is "none of our business.'

Hewing to President Trump's line that the US should not get involved in foreign wars and his inclination to let India manage regional affairs, vice-president JD Vance told Fox News that much as the US wanted the situation to deescalate as quickly as possible, it would not be dictating terms.

"What we can do is try to encourage these folks to de-escalate a little bit, but we're not going to get involved in the middle of war that's fundamentally none of our business and



has nothing to do with America's ability to control it," he said, giving New Delhi a wide berth despite Secretary of State Marco Rubio emphasising the need for de-escalation while censoriously putting the onus on Pakistan to "take concrete steps to end any support for terrorist groupsPresident Trump, who clearly has only a vague idea of the complexities involved in the region, has shown a degree of indifference if not disinterest in what previous administrations characterized as a "nuclear flashpoint" and rushed mediators to calm the situation. But the MAGA dislargely pensation is inclined to let the India manage the problem, much to the dismay of Pakistan, which would like some intervention to return the Kashmir issue centerstage and arrest its slide into irrelevancy. The Modi government too

has been clear that it will

not brook any intervention in the punitive measures it is determined to take Pakistan launching yet another brutal carnage in India, while callously insisting it was a false flag operation and it had nothing to do with it. At the same time, it has been caught consorting with globally proscribed terrorists at home. The sight of the Pakistani military literally yoked together with wanted terrorists at the funeral of people who were killed in retaliatory Indian action was seized on by Indian diplomats to convey to western audiences that the world has been far too lenient on Islamabad's nurturing of terrorism.New Delhi also made the case to the global audience on Thursday that it was Pakistan that was escalating the situation with attacks.

## IMF approves \$1 billion disbursement to Pakistan despite India's warning over terror funding

The approval came during a board meeting in Washington, where the IMF also reviewed a proposed \$1.3 billion loan to Pakistan under its Resilience and Sustainability Facility (RSF). India registered a formal protest, citing Pakistan's poor track record with reforms and expressing fears of fund diversion. New Delhi abstained from the vote.

"Rewarding continued the Pak's PMO said, sponsorship of crossborder terrorism sends a dangerous message," the finance ministry said in a statement.

Pakistan's Minister Shehbaz Sharif welcomed the development, describing it as a "defeat of India's highhanded tactics" and a sign of international confidence in Pakistan's economic recovery. "Indian attempts to sabotage the IMF programme have failed,"

accusing India of plotting "a conspiracy to divert attention" through "unilateral aggression."

The new disbursement brings total IMF funding to Pakistan under the EFF to around \$2 billion. The full \$7 billion package, agreed in July last year, is structured over 39 months in seven instalments, contingent on successful reforms including tax restructuring.

### **Fundamental hypocrisy in** global climate politics

In , the UN Climate Action Summit in New York, leaders from industrialised nations delivered impassioned speeches about the urgency of addressing climate change. Yet, behind closed doors, they continued to approve new fossil fuel projects and delay meaningful climate finance commitments. This dichotomy highlights a fundamental hypocrisy in global climate politics: The West often preaches sustainability but falls short in practice, prioritising economic interests over environmental imperatives. As the countdown to the COP29 climate summit in Azerbaijan this continues, the Bonn Climate Change Conference in Germany concluded in a stalemate last week. Nations disagreed on the size and scope of loss and damage financing, representing a significant setback in global climate negotiations. The Bonn talks did not achieve meaningful progress on climate financing, underscoring a persistent issue: industrialised nations, which bear the greatest responsibility for the current climate crisis, resisted calls from Global South countries to compensate those who suffer the most but have contributed the least to greenhouse gas emissions. Over a decade ago, developed nations pledged to mobilise \$100 billion annually by 2020 to support climate action in developing countries. This commitment, formalised under the Copenhagen Accord in 2009 and reiterated in the Paris Agreement, has not been met. The Organization for Economic Co-operation and Development (OECD) reported that climate finance reached only \$79.6 billion in 2019. It was only in 2022 that developed countries provided and mobilised \$115.9 billion in climate finance for developing countries. By the end of COP29, all parties must agree on a "new collective quantified goal" (NCQG) to guide the provision of climate finance, intended to replace the \$100 billion target after 2025. Progress on negotiating the NCQG has been slow. Disagreements persist on almost every aspect of the new target, including the amount of money to be provided, the sources of these funds, the recipients, and the specific forms of financial assistance. Current climate finance is grossly inadequate for the scale of action required. The \$100 billion target for climate finance is laughably insufficient. United Programme (UNEP) Environment Adaptation Gap Report 2021 estimates that the costs of adapting to climate change in developing countries could reach \$140-300 billion per year by 2030, escalating to \$280-500 billion per year by 2050. Furthermore, the Climate Policy Initiative (CPI) Global Landscape of Climate Finance 2021 report highlights that global climate finance flows reached a record \$632 billion in 2019/2020. Despite this record, the funding falls significantly short of the \$4.13 trillion annual investment required by 2030 to meet the Paris Agreement targets, as estimated by the International Energy Agency (IEA) in its Net Zero by 2050 report. Now even these estimates are seen as low. As highlighted by the Independent High-Level

Expert Group on Climate Finance in their 2022 report, emerging markets and developing countries (excluding China) are staring at a financial chasm. These nations must mobilise approximately \$1 trillion annually by 2025, amounting to 4.1 per cent of their GDP—double the 2.2 per cent spent in 2019. Fast forward to 2030, and the figure balloons to a staggering \$2.4 trillion per year, or 6.5 per cent of GDP. This glaring disparity underscores the urgent need to

# Threat from ballistic hypersonic missiles

forerunner in the era of technology-driven warfare. A country like India, with significant geopolitical heft and the potential to emerge as a power of relevance, would sooner or later face a threat from space—a threat that cannot be defended by conventional means. It is therefore important to analyse if India needs to build a space force that is capable of fighting, not so distant, space wars. The Gulf War I is technically considered to be the first space war where the US relied on space satellite intelligence for aerial and ground operations inside Kuwait and Iraq. The satellite navigation systems played a significant role in the navigation of the US Air Force fighter jets. Currently, space prowess is clearly ruling the Russian-Ukraine and Hamas battlescapes. Taiwan is incrementally coming under the space lens of competing powers. The space satellites started playing their crucial role even before the start of the war. India raised the Defence Space Agency in 2019 as a scaled-down version of the space command. The Defence Research and Development Organisation (DRDO) also raised DSP to provide technical and Research and Development (R&D) support. In the last



five years, outer space has emerged as a source of concern, primarily the threat from long-range ballistic and hypersonic missiles. Many Direct Ascent Anti-Satellites (ASAT) experimental missile strikes have been tested, including by India (mission Shakti). Counter-missions are being developed for both offensive and defensive forms of space warfare. Even though the Outer Space Treaty nations debars from weaponising space, the writing on the wall makes it clear that a threat from space is lurking. All the major powers, such as the US, Russia, China, India, France, the European Union, and Japan, are building space military organisations. The US Space Force organises, trains, and equips personnel in order to protect US and allied interests in space and to provide space capabilities to the joint forces. The US Space Force, headquartered

at the Pentagon, employs 8,600 military personnel and 77 spacecraft. The Russian space forces are mandated to inform the higher political leaders and military commanders of missile attacks as soon as possible, ballistic missile defence, and the creation, deployment, maintenance, and control of in-orbit space vehicles, like the Persona reconnaissance satellite. These forces operate the GLONASS global positioning system. The Russian Space Forces include the third Missile-Space Defence Army and a Division for Warning of Missile Attacks. The Chinese People's Liberation Army Strategic Support Force (PLA-SSF) existed from 2015 to 2024 with the army's ability to fight "informatised conflicts". In April of this year, the Strategic Support Force was dissolved and split into three independent arms: the PLA Aerospace Force, the PLA Cyberspace Force, bombers and fighters and the PLA Information Support Force. Like China, Russia views space as a warfighting domain, and they base their warfighting doctrine around the idea achieving supremacy is a precondition for winning a conflict. Russia has fielded a suite of non-kinetic options to create reversible effects on satellite systems in space, including ground-based systems to counter GPS navigation signals, tactical communications, satellite communications, and radars. On the non-kinetic side of this threat continuum, China has operational groundbased jamming systems that are capable of disrupting satellite communications, GPS navigation signals, synthetic aperture radars, missile warning systems, and other satellite systems. Jamming can prevent users from using satellite communication networks, degrade or prevent transmissions of vital missile warning data from space-based sensors to war fighters, and disrupt uplinks and downlinks needed to command and control spacecraft. While analysing the space wars, it is important to study the space-based wars of the past, when the intensity was nominal but gains were asymmetrical. dropped more than 5,000 GPS-guided Joint Direct Attack Munitions during the day and night, in all weather, with shattering effectiveness. Satellites also made it possible to Unmanned Aerial Vehicle (UAV) attacks such as Predator and Global Hawk. US imaging satellites gave commanders an unprecedented view of targets and battlespace. At least seven different types of military satellite systems were used during the Gulf War I. GPS receivers were affixed to tanks, trucks, and aircraft across the theatre. Tank commanders wanted to know the moisture content of the soil in some areas. Tomahawk precision attacks have multiple space based use cases, such as intelligence preparation, target location, command. and control, weather assessment, launch, route

navigation, and damage assessment. Space and cyber domains are the major components of 'stand-off' wars, which is

## Women in Indian Politics: A story that has changed little over the years

India recently concluded its 2024 general elections, which took place in seven phases—from April 19 to June 1—to elect all 543 members of the Lok Sabha (lower house). While the results have taken many by surprise, what has been even more astonishing is the fact that for a country that has rigorously been trying to establish a more progressive front on women's rights and gender equality over the past few years, the

ment has failed to showcase a notable uptick in the representation of women after the latest elections. Making just 13.63 per strength, the 18th Lok Sabha will comprise only 74 women compared to 469 men. This share is not only abysmally skewed but also lower than the 14.4 per cent share of female representation during the 2019 election, where 78 women were elected as MPs. The irony here is that just last year, India during its G20 presidency—brought about a paradigm shift in gender-based policymaking by challenging the status quo and with the innovative idea of women-led development in order to ensure women's

Even at the domestic level, India—after deliberations—finally passed the historic Women's Reservation Bill in , which seeks to reserve one-third of the seats in the Lok Sabha and state legislative assemblies for women. 

#### Small savings program interest rates unchanged April-June quarter

Delhi: For the fifth quarter starting April 1, 2025, the government maintained interest rates on PPF and NSC. The rates of interest on various Small Savings Schemes for the first quarter of FY 2025-26, starting on 1 April 2025 and ending on 30 June 2025, would stay unaltered from those notified for the fourth quarter of a finance ministry notification. The notification states that Sukanya Samriddhi deposits will earn 8.2% interest, while three-year term deposits will earn 7.1%. Popular Public Provident Fund (PPF) and post office savings deposit scheme interest rates remain at 7.1% and 4%, respectively. Kisan Vikas Patra investments mature in 115 months at 7.5%. #### **Govt form the Media Council of India to regulate** print, television, and online media

Parliamentary panel on communications and information technology, led by BJP lawmaker Nishikant Dubey, will recommend that the Union government form the Media Council of India to regulate print, television, and online media, sources said. A senior panelist suggested an umbrella body because the same content occurs across platforms. You work for a paper. The Press Council of India oversees your newspaper articles. No regulation exists for the identical story in the paper's online edition." There is no central regulator for online material, but two groups regulate print and electronic media. The Press Council of India, a statutory quasijudicial autonomous authority established by Parliament, protects press freedom and improves newspaper and news agency standards .Among other major media regulatory reforms, the panel, which addressed fake news extensively will recommend this. In the discussion, Dubey added, "Paid news is rampant. Illiterate and gullible individuals think alike. Without strict regulations, ethical boundaries are crossed. Investigative journalism is discouraged by expensive and lengthy legal fights for journalists and media corporations.

The country is in chaos due to fake news, especially during elections. Media trials of dramatic cases can alter the law." Many TV news channels prioritize sensationalism above genuine iournalism to boost TRPs. TV debates sometimes become shouting contests and mud-slinging instead of healthy conversations. 
