'India is a winner on and off the battlefield': Harbhajan Singh lauds ceasefire, slams terrorism

NEW DELHI: Following the agreement between India and Pakistan on a full and immediate ceasefire effectively ending three days of intense cross-border firing — former India spinner Harbhajan Singh welcomed the move. Harbhajan, who represented India in 103 Tests, 236 ODIs, and 28 T20Is, shared his thoughts in a message posted on X (formerly Twitter).

"War has never ever been good for humanity," Harbhajan said. "India is a peace loving country and has never been the aggressor. But as nation, we would never ever take enemy's aggression lying down. Our biggest endeavour is to end terrorism on our soil. Salute to our defence forces for ensuring that every citizen feels safe," he added. "A big shout out to our political leadership for showing diplomatic prudence which is the need of the hour. On the battlefield or off it, India is winner all the way. #JaiHind #JaiBharat," Harbhajan concluded. The ceasefire agreement was announced by U.S. President Donald Trump on Saturday, who claimed the breakthrough came after American mediation.

"Congratulations to both Countries on using Common Sense and Great Intelligence. Thank you for your attention to this matter!" he

The announcement came just hours after both countries' militaries had carried out strikes on each other's installations, escalating the already tense situation.

NEW DELHI: India on Saturday confirmed that it has reached an agreement with Pakistan to halt all military action across land, air, and sea. The understanding was reached during a call between the Directors General of Military Operations (DGMOs) of both countries earlier in the day.

Foreign secretary Vikram Misri said that Pakistan's DGMO called his Indian counterpart at 15:35 hours, following which both sides agreed to cease all firing and military activities starting from 17:00 hours IST. "Instructions have been given on both sides to give effect to this understanding. They will talk again on the 12th of May at 1200 hours," Misri



The announcement comes amid heightened tensions between the two nucleararmed neighbours.

Until Saturday morning, India had effectively responded to Pakistan's drone and missile attacks on its border states. The Indian defence systems intercepted and destroyed most of the threats, preventing any loss of life or damage to

property. On May 7, India launched a major counterterror operation, codenamed 'Operation Sindoor', in response to a Pakistanbacked terror attack in Jammu and Kashmir's Pahalgam on April 22, which killed 26 people. Any act of terror will ...': How India has changed rules of engagement with Pakistan

Vatika Times NEW DELHI: In a signifi-

cant toughening of its counter-terrorism doctrine, the government on Saturday declared that any future "act of terror" on its soil will be treated as an "act of war" and will be responded to accordingly. A top government official said, "Any future act of terror in India will be considered an act of war against the country and will be responded to accordingly." The statement marks a formal shift in India's rules of engagement, draw-



ing a clear red line for Pakistan-based terror groups. Under international law, an "act of war" implies a hostile action by one state that could justify retaliatory use of force. India's new stance signals a readiness to invoke selfdefence provisions under Article 51 of the

UN Charter. In response to the April 22 Pahalgam attack, launched Operation Sindoor on May 7, targeting nine terror camps inside Pakistan and Pakistanoccupied Kashmir. Pakistan retaliated with artillery shelling and drone attacks, which India claimed caused no significant damage. Indian Army Colonel Sofiya Qureshi dismissed Islamabad's claims of damage to Indian military installations, calling them "completely wrong".

Civil servants are running India's regulatory bodies

Looking back at India's reform story of more than three decades, it is worthwhile to recall that economic liberalisation of the 1990s had a few implicit assumptions of how an economy should function and grow on a sustainable basis. One of those assumptions followed from the government decision to allow the private sector to operate in areas that were hitherto monopolised by state-owned enterprises. Under such liberalisation, it was assumed that while the government would continue to frame policies for areas opened up to the private sector, the regulation or enforcement of those policies would be undertaken by independent regulators through rules framed by them. A classic example of this thinking was India's telecommunications sector that was opened up to the private sector in the early 1990s. This was followed by the setting up of the Telecommunication Regulatory Authority of India or Trai a few years later. Subsequently, the business of basic telephone services, run in large parts of the country by a government department, was hived off to a newly created state-owned enterprise. Something similar, in varying degrees, happened in other areas such as the insurance, airports, and power sectors. In addition, the Competition Commission of India (CCI) was set up to regulate and adjudicate upon issues of market dominance and practices that undermined competition in various sectors. The principle was clear: Let the government frame the policy (and not run a business), while independent regulatory bodies could enforce the policy by framing necessary rules. Another implicit assumption behind such a separation of responsibilities between the government and the regulators was about who should steer those regulatory bodies. To impart autonomy and independence to these institutions and insulate them from government interference, the pool of talent for hiring key personnel was widened. Experts and private-sector professionals in related fields, along with even retired members of the judiciary (though under some pressure as was seen when the legislation for setting up the CCI was framed), were among those the government believed could be hired to head these regulatory institutions. Thus, the first chairperson of the Central Electricity Regulatory Commission was an economist. Trai was set up under the chairmanship of a retired judge and its next chairperson was a former banker. Even the first capital market regulator was a banker in the late 1980s, and the first chairperson of the insurance sector regulator was a former chairman of the Central Board of Direct Taxes. The first fullfledged chairperson of the CCI was a retired Indian Administrative Services (IAS) officer. So, there was a mix of regulatory heads chosen from a pool of experts from both the government and the private sector. In spite of a few civil servants heading these institutions, the idea that continued to be pursued was to insulate regulation from the stranglehold or influence of the political executive. The third significant aspect of regulatio in the early days of economic reforms was the framing of rules for appointing heads of regulatory bodies in a way that effectively ruled out conflicts of interest. Thus, a regulator would usually not be considered for another job in the government system after the completion of his or her term. The idea was that the regulator should be able to act freely and fairly without any expectation of future assignments from the government or the private sector. Indeed, one of the regulators under the law was, until recently, barred from accepting any government job after having served in that regulatory post. These were guardrails to preserve the integrity and independence of regulators. However, the situation with regard to the last two assumptions behind the regulatory framework has changed. significantly in the

Trump believes Zelenskyy will have to give access to critipcal minerals

Despite Ukraine's resistance, Trump believes Zelenskyy will have to give access to critical minerals in return for any future US support. Some in the Trump administration suggest Kyiv should provide Americans with those minerals in return for the US military and financial aid already received by Ukraine. Trump has blamed European leaders for not doing enough to end the Ukraine war. He has also complained for a long time that Europe has lived off the US for too long and it must pay for its security. Europeans have increased their defence budgets but not enough to survive without US support. In the face of changing US policy under Trump, European leaders are working on a plan to guard against a Russian attack. This involves a proposal to deploy tens of thousands of peacekeeping troops in Ukraine. The proposal has the support of Britain and France and is in response to Zelenskyy's request of 100,000 troops. But the idea doesn't have wider support in Europe. Germany, another big power in the continent. Donald Trump has spent only a month in his second term as the US President. However, he has disrupted the international order, weakened the Western alliance and created a sense of insecurity and uncertainty among its members, surprising even some of his supporters. There has been a paradigm shift in US foreign policy under Trump. He is now closer to Moscow than Washington's traditional allies. He has embraced the Kremlin's narrative on

Ukraine and has sidelined US US allies. Although senior members of the Trump administration have denied that the US has abandoned Kyiv and ignored its European allies, Trump himself has not made any serious attempts to pacify Ukrainians and Europeans. His closeness to Russia has been on display since he talked for 90 minutes on the phone with Russian leader Vladimir Putin, in which they agreed to start negotiations to end the Ukraine war, which will mark its third anniversary on Monday. Trump did speak to Zelenskyy soon after that call with Putin, but a nervous Ukrainian President warned that excluding his country from the talks would be "very dangerous". Events after that only made Ukrainians feels sidelined. Trump's Vice President, JD Vance, met European leaders in Munich two days later. But his comment that Europe will not be included in the peace talks only helped fuelled the speculation that they were being left out of the future of Ukraine, which is closer to their homes and in which they have invested a lot of money and effort since the Russian invasion. Vance's meeting with Zelenskyy did not go well either as the Ukrainian leader refused to give access to the country's vast reserves of critical minerals unless he was given security guarantees. That angered Washington. Ending the Russia-Ukraine war was Trump's major campaign promise. But hardly anyone expected him to brazenly take Russia's side and even blame Ukraine for the conflict, which he did. Last Tuesday, a

delegation led by Secretary of State. Marco Rubio met the Russian

delegation headed by Foreign Minister Sergey Lavrov in Saudi Arabia, to discuss peace. Ukraine was not invited. Putin—who had been shunned by the US and its allies since the invasion of Ukraine—was delighted. A frustrated Zelenskyy dismissed the Riyadh talks as worthless. Trump did not like those comments and called the Ukraine President a dictator, even accusing him of starting the war. Zelenskyy said the US President was living in a Russian-made "disinformation space". This infuriated Trump, who does not take kindly to any criticism. The proposal has been dismissed by Russia, which currently has about 600,000 troops in Ukraine. But even

Britain and France, with much smaller armies than Russia, can't send troops to Ukraine without some backup from the United States. And that looks unlikely, for now. Trump's Ukraine envoy, General Keith Kellogg, who visited Kyiv and met Zelenskyy on Thursday, said all options must be open to deal with the outcome of peace talks. But he knows that any decision to provide any US military cover will be made by Trump who looks less inclined to do that.

He described Zelenskyy as "a modestly successful comedian" who "talked the United States of America into spending \$350 Billion, to go into a War that couldn't be won, that never had to start, but a War that he, without the U.S. and 'TRUMP,' will never be able to settle." Trump's behaviour towards Zelenskyy is in stark contrast to Biden's. who had backed Ukraine against Russia with all the possible military and financial aid. President Biden travelled to Ukraine many times since the Russian invasion in February 2022 to display his administration's full support. He also promised NATO membership to Ukraine at a future date. Russia was severely punished for invading Ukraine. The US joined hands with its allies to isolate Moscow. Russia faced tough sanctions and its assets in the West were seized. The International Criminal Court issued an arrest warrant against Putin for alleged war crimes in Ukraine. There were even plans to put Putin and his close allies on Nurembergstyle trials. Until a year ago, Ukraine's leader was talking about even liberating all its territory, including Crimea, which Russia annexed in 2014, with the help of Western military equipment. Ukraine even succeeded in occupying the Russian territory of Kursk, which it had thought would be used as a bargaining chip during negotiations with Moscow. But all that now looks like a distant dream. With Trump back in the White House, Ukraine fears that Russia will be allowed to keep all the occupied territory as part of the deal to end the war. Kyiv is now likely to be denied NATO membership. That could be a promise to Russia to end the war. The US under Trump has now even opposed calling Russia an aggressor in a G-7 statement being prepared to mark the third anniversary of

It is not just Ukraine, America's European allies are also now nervous about the intent of Trump. Since the Second World War, they enjoyed the US security umbrella under NATO. But now they are unsure if the US under Trump will honour Article 5 of the NATO, which is triggered when a member state comes under attack. It implies that an attack on one member is an attack on all. There is even fear in Europe that Donald Trump may sign a deal with the Russian leader Vladimir Putin that will lead to the withdrawal of US forces from Baltic states and effectively kill the NATO alliance. That could be similar to the non-aggression treaty signed by the Soviet Union and Nazi Germany on August 23, 1939, sending shockwaves to other European countries and prompting Hitler and Stalin to annex neighbouring countries. It is another matter that Hitler invaded the Soviet Union two years later, putting an end to the treaty. European members of NATO may call themselves major powers, but they can't match Russia's military might without US support. Even after losing more than a hundred thousand men and lots of military equipment in the Ukraine conflict.

For fifty-two hours one summer in 1893, rain fell across Kashmir. A bear and a panther were found drowned side by side, their ancient hatred forgotten; ponies and cattle climbed into the verandahs of the elegant homes on the right bank of the Jhelum river. Faced with the wall of water, colonial civil servant Walter Roper Lawrence writes, the villagers of Tullamulla ripped the holy flags from their shrines and planted them along the flood plain to warn the waters away. Even nature, they reasoned,

would not dare insult the ancient saints. Everyone wasn't pleased with this deep popular faith—or charlatanism, if one so wished to call it. Kashmir was entering a new period of religious ferment amid messianic claims that the flood had been retribution for the sins of its people, like the Flood of Nuh, which destroyed the idolaters. Armed with ideas from Aligarh and Lahore, Mirwaiz Rasul Shah, the head of Srinagar's Jamia mosque, set about eradicating bid'a, the syncretic folk practices woven through folk Islam. In 1889,

Rasul Shah established a seminary, the Nusratul Islam, at Rajouri Kadal, the first formal school offering both secular and religious education to Kashmir's Muslims. The seminary, today known as the Islamia School, flowered into an educational organisation, the Anjuman-i-Nusratul Islam. "Islam is a sick child that needs its mother's care and sympathy," one student at the Islamia speeches, Mirwaiz Rasul Shah left little doubt about what that was: The deification of saints and veneration of holy

relics were Hindu practices which had corroded Islam from within. Late in the 19th century, scholar Yoginder Sikand writes, the neo-conservative Ahl-e-Hadith began to preach an even more austere new faith based on the laws of Sharia. If they needed medical advice on the inefficacy of an existing treatment for a physical malaise, then the physician may have mistakenly recommended something less effective to them. This is the case with the University Grants Commission's (UGC) response to the parents of Rohith Vemula and Payal Tadvi by proposing the 2025 draft regulations on equity. The draft tapers down the existing regulations of 2012 as it narrows the definition of caste-based discrimination, adopting a non-intersectional approach, and dispensing with commonly recurring situations of discrimination and the effects thereof. The 2025 regulations define discrimination as "unfair, differential, or biased treatment or any such act against any stakeholder on the grounds only of religion, race, caste, sex, place of birth, or any of them". The isolated definition of caste-based discrimination as "only against the members of the scheduled castes and scheduled tribes" excludes the broader ways in which it operates. In contrast, a trader caste Vaish student may be preferred on the assumption that Vaish people are good with money. A priestly caste Brahmin student may be placed in a supervisory role on the assumption that Brahmins are morally upright and trustworthy. As much as this is caste-based discrimination, it would not be addressed in the 2025 draft regulations despite Gujjar being a protected legal category of Backward Classes. The 2025 draft wording "on the grounds only of" has

served as the rationale for non-inter-**The** malaise of casteism took the sectional interpretations. In 1981, lives of Rohith Vemula and Payal the Supreme Court of India ruled that the alleged discrimination against air hostesses was not "on grounds only of" sex because of other factors that also constituted the category of air hostesses. This court ruling has established a nonintersectional approach to reading the given categories—of religion, race, caste, sex, place of birth-in Article 15 of the Constitution. "Or" places a mutual exclusivity in the given categories. It can be caste or sex, it cannot be both. The 2012 regulations facilitate the possibility of intersectional reading by replacing or with and: "based on caste, creed, religion, language, ethnicity, gender and disabilities." The prospects of the words "or any of them" in the 2025 draft could be interpreted as the intersectional operation of given categories.

> It's a distant possibility contingent on the courts making this kind of interpretation. Until then, women and LGBT queer students in the SC and the ST categories will struggle to prove that the discrimination against them is on grounds only of caste, because it could well be because of their gender identity and sexual orientation along with caste. Discrimination can be better understood in the context of its commonly recurring situations. In addition to naming the specificity of students in the SC and the ST categories, the third clause of the 2012 regulation lists eight situations of discrimination that operate squarely within the framework of admissions. Other subclauses further list 17 situations that operate more broadly "on the basis of caste, creed, religion, language, ethnicity, gender and disability". Doing away with all these situations in the 2025 draft regulations shows that the contexts integral to applying anti-discrimination frameworks.

Top court orders CBI probe into Manipur woman's 2013 murder that's still unsolved

Supreme Court on said unresolved crimes tend to erode public trust in institutions, which have been established for maintaining law and order, and ordered a CBI probe into the death of a 25year-old Manipuri woman that has remained unsolved till date, reported.Delhi Police have failed to bring to light the circumstances that led to the death of the woman in her rented house in south Delhi in 2013. She was working in a call centre at Delhi. A bench of Justices J K Maheshwari and Sudhanshu Dhulia passed the order on a plea filed by the family of the deceased seeking probe by CBI as Delhi Police failed to catch the killer and accused the cops of shielding the accused. The bench said, "...Criminal investigation must be both fair and effective. We say nothing on the fairness of the investigation... but the fact that it has been ineffective is self-evident. The kith and kin of the deceased who live far away in Manipur have a logistical problem while approaching authorities in Delhi, yet they have their hope alive, and have shown trust and confidence in this system. We are therefore of the considered view that this case needs to be handed over to CBI for a proper investigation and also to remove any doubts in the minds of the appellants, and to bring the real culprits to justice." The court noted that the woman's death was not a case of suicide as the crime scene had blood spattered on the floor and the bed sheet was completely drenched in blood. "It appears to be a homicidal death and therefore the culprits must be apprehended," the bench added. The family had first approached Delhi HC for a CBI probe.

According to CRISIL, India's current account surplus improved to \$5.7 billion in the fourth quarter of fiscal year 2024, or 0.6% of GDP. Delhi: Air pollution may increase Type 2 diabetes risk. Air pollution, especially PM2.5, is known to cause chronic lung ailments, heart attack, stroke, and cancer, but the diabetes argument is gaining ground. Several research from the US, Europe, and China have shown the association, but a new two-city study from India found that even a 10 g/m3 increase in PM2.5 exposure raises blood sugar. Mumbai-based (Journal of Association of Physicians of India) published an editorial headlined, Pollution: A New Cause

of Type 2 Diabetes?' this

month. Diabetes specialist Dr. V Mohan from Chennai wrote, "We now know that PM2.5 is an endocrine disruptor that affects insulin secretion and also leads

Dr. Mohan and Public Health Foundation of India researchers published the first PM2.5diabetes study a few months ago. 'BMJ Open Diabetes Research & Care' found

between short-, medium-, and long-term PM2.5 exposure. "A 10 increase in monthly average exposure to PM2.5 was associated with a 0.4 mg/dL increase in finger pick blood test and a 0.021 unit increase in HbA1c test," claimed the study. The HbA1c blood test measures blood sugar over three months.

The study followed 12,064 Delhi and Chennai people for seven years. A hybrid satellite-based exposure model and ground data were used to track PM2.5 concentrations daily. At follow-up visits, participants' blood sugar was measured.



Rajasthan's school mergers endanger first-gen students, especially girls.

Delhi: With three decrees in January, the Bhajan Lal Sharma-led BJP administration in Rajasthan set into motion the merging of 449 schools with larger, better-performing schools in their neighborhood. The government claimed low enrollment (fewer than 15 kids per the Rajasthan government policy), distinct schools on the same campus, and schools near to each other as explanations. The idea has generated protests statewide, with parents strongly opposing it, since it threatens to compel youngsters, primarily girls and those from impoverished families, to drop out. The merging of all-girls institutions into co-ed institutes is a critical issue, as seen in last week's rallies in Jodhpur and Bikaner. Many parents worry this shift could endanger their daughters' safety and education. Other issues are the rise in home-to-school distance for many pupils and changes in school medium and culture. Ex-CM Ashok Gehlot and parents have opposed the move. BJP MLA Jethanand Vyas of Bikaner West asked Education Minister Madan Dilawar for an exemption for his district's girls' school. Over 1,400 pupils will fit into 20 classes post-merger. The girls worry that if the merger happens, their parents would stop them from going to school, ruining their dreams. No other all-girls government school exists. I don't know if I can finish school. I just want to study and go to college. "How will we handle a shift?" "I don't know if I can keep studying," she remarked. District education officials know of the issues but said, "No schools are closing; they're merging with better-performing ones." "This move expands educational options for boys and girls, allowing for a broader range of streams." We'll keep girls in school. Modi claimed schools have been told to do this. Rajasthan has 70,233 state schools. 32,598 are primary schools. School consolidation isn't just in Rajasthan. In Madhya Pradesh, Uttar Pradesh, Himachal Pradesh, and Odisha, smaller, low-enrollment institutions are merging with larger ones.

In opposition-ruled states like West Bengal and Tamil Nadu, where governors and state governments have often clashed over vice-chancellor appointments, the new idea might have major ramifications. Some teachers oppose it. A.K. Bhagi, president of Delhi University Teachers' Association (DUTA), stated the 2018 guidelines proposed by industry experts. However, teacher associations and educators opposed it, therefore it dropped. Our position is unchanged.

National Eligibility Test No Longer Required for Assistant Professor

Delhi: The University Commission (UGC) has produced a draft of minimum criteria for hiring and promoting teachers and academic staff in universities and colleges and steps to maintain higher education standards. According to regula-

tions, the UGC recommends eliminating the National Eligibility Test (NET) for assistant professor and promotion positions in higher education. The proposal requires assistant professors to have a postgraduate degree in ME or MTech with at least

55% grades. The UGC-NET test is required for assistant professor eligibility. Additional qualifications for assistant professor include an undergraduate degree (NCrF Level 6) with at least 75% marks, a PG degree (NCrF Level 6.5) with at least 55% marks.



2 BSc papers delayed at DU, one test rescheduled

Delhi: Officials stated a Delhi University Bachelor of Science (BSc) paper was postponed and another was delayed for several hours due to late question paper delivery from the department. Officials say the disruptions affected 170 students at Ramjas, Zakir Husain, Deshbandhu, and Deen Dayal Upadhyaya institutions. A new announcement rescheduled the postponed exam for Sunday, 9:30 am to 12:30 pm. Two 9:30 am "Electronics Instrumentation" and "Mathematical Physics-I," were affected.Question papers weren't provided till 11:30 am."The Electronics Instrumentation exam started late, but students had three hours to finish. The pupils had enough time to finish their papers, an official stated. Students protested the delay, therefore the "Mathematical Physics-I" paper was postponed. "Due to their concerns, the paper was rescheduled for January 5 at the same time," the spokesperson said. The official blamed "confusion" and "lack of coordination" between the department and universities for the interruption. He declined additional comment.

CII paper highlights India's education 'underinvestment' and compares Sweden to China

Delhi: A recent comparative assessment of eight countries' school education systems exposes India's "significant underinvestment" in education. For six years, India's education spending has stuck at 2.7% and 2.9% of GDP, with little increase. To reach global standards, the research recommends raising this to 6%. The Confederation of Indian Industry issued the report last week, titled 'Comparative report of School Education Systems: India, Australia, China, Indonesia, Sweden, while developed nations like Thailand, UK, and USA'. This study examines the education systems of eight developed and rising nations. From 2018 to 2023, the research shows varied education spending allocated higher shares to



patterns per country. India's education. Australia had an at 2.7-2.9 percent of GDP, Sweden (6.7-6.9 percent) and the UK (5.3-5.6 percent) and developing nations like Indonesia (3.7-4.3 percent) and Thailand (4.0-4.3 percent)

Government school enrollment fell 87 lakh in 2023-24

Delhi: Bihar had the largest dip at 28.9 lakh kids in government schools in 2023-24, according to government data. Private schools are seeing a surge in enrollment, reflecting a reverse movement of pupils who went to public schools during the COVID-19 pandemic.

Overall enrollment fell 1.6 crore in 2023-24 from 26.45 crore in 2019-20. The Gross Enrolment Ratio (GER), which assesses the percentage of school-age chil-



dren enrolled at a certain education level, also fell from 94.2 percent to 91 percent. The National Education Policy (NEP) 2020 seeks 100% GER by 2030.

The data shows a major change in school enrollment. During the same year, private school enrollment climbed from 8.4 crore to 9 crore while government school enrollment declined from 13.62 crore to 12.74 crore. This is the first post-pandemic fall in government school enrollment and a rise in private school enrollment. The pandemic drove approximately 40 lakh pupils from private to government

schools in 2020-21, a trend that continues now.

Private schools report lower enrolments. The reduction was attributed to "reverse migration" post-pandemic, with pupils who had attended government schools owing to budgetary restrictions returning to private schools. Some states tried to delete "ghost students" from their records. Enrollment across academic levels has dropped.

Pete Hegseth defiantly said no war plan was discussed though Goldberg insisted that there's much that he did not report on.



The Anti-Corruption Branch charges AAP's Sisodia and Jain with Rs 2,000 cr corruption

Delhi: The Delhi government's Anti-Corruption Branch (ACB) has charged top Aam Aadmi Party (AAP) leaders Manish Sisodia and Satyendar Jain with irregularities in the con-

struction of over 12,000 government school classrooms. The scandal allegedly cost the exchequer Rs 2,000 crore. In the Prevention of



Corruption Act case, BJP leaders Harish Khurana, Kapil Mishra, and Neelkanth Bakshi filed complaints. The trio claimed that 12,748 classrooms were built at 24.86 lakh each room, when they should have been built for Rs 5 lakh. A preliminary investigation by ACB chief Madhur Verma found that the project, which had a set cost and a deadline of June 2016, had major cost overruns and delays. "Not a single work was completed within the prescribed period, and significant deviations and cost escalations were observed," Verma. He added that 34 contractors, most of whom were supposedly AAP-affiliated, won project tenders. Initially awarded for Rs 860.63 crore, contract values climbed 17% to 90%.
