



Diriyah is one of the foremost cultural hubs

This year, the Media Ministry dedicated the Suwaidi Park festival exclusively to India. The 10-day festival saw a celebration of Indian culture, food, music and art. People from all communities streamed into the vast Suwaidi Park to savour a slice of India. The Global Harmony project attempts to present Saudi as an inclusive and harmonious society where people from all backgrounds live and celebrate their own cultures, traditions and festivals. And, it's not some civil society gig. It's a government policy initiative with clear objectives and plans.

That makes it an attempt worth emulating for many countries that are facing social fissures due to their diversity. As Saudi strides into modernity, it is also conscious of its history and heritage. It's encouraging studies and excavations at heritage sites, such as at al Ula, and is promoting its pre-Islamic history too. Nouf Marwaai, a yoga instructor.

and also a consultant with the Saudi government, gave us a presentation on the historical and social similarities between India and Saudi Arabia. In her talk, she went back to 6000 BCE to trace the Almagar Civilisation. Clearly, the new Saudi Arabia projects itself as an old civilisation, and not just as a society defined by the advent of Islam 1,400 years ago. That is now portrayed as only an important event, not the sole marker of the civilisational identity. The Kingdom is also promoting its historical sites. The Diriyah town, just outside Riyadh, is one such heritage site that has a UNESCO tag. It was the home of the Saudi royal family and also served as the capital of the Emirate of Diriyah under the first Saudi dynasty from 1744 to 1818. Today, Diriyah is one of the foremost cultural hubs and the centre of many sports and adventure activities in the Kingdom. Even so, its historical character has been maintained all along. On the one hand, you have mega infrastructural projects, new businesses and modern wave sweeping Saudi, and on the other, there is a renewed focus on its over 1,400-yearold history. Coming back to the India connect: wherever there are Indians, there is music. Indian film music has been a great brand ambassador and unifier across the world. Saudi Arabia is no different. My local support, Abdulwahab al Ghamdi, a young, peppy guy in his late 20s, played Hindi songs for me in the car while we drove around Riyadh. The Media Ministry's Global Harmony project is aimed at enhancing understanding and collaborations between diverse groups that call Saudi home. According to the Saudi Deputy Minister of Media, Dr Khaled Bin Abdulgader al Ghamdi, the Global Harmony project aims to make expats feel more at home. But more than that, it aspires to make local Saudis understand better the various communities that live among them. So, during the Riyadh Season, which starts in September and continues till February-March, you see a host of public cultural and social events to bring communities together. It's a true celebration and appreciation of diversity. Even among the expats, special attention is on Indians, who are the largest expat group in Saudi Arabia. At present, 2.6 million Indians live in the Kingdom, working in the domestic sector as well as private jobs, and running both start-ups as well as big.

Marco Rubio met the Russian delegation headed by Foreign Minister Sergey Lavrov in Saudi Arabia, to discuss peace. Ukraine was not invited. Putin-who had been shunned by the US and its allies since the invasion of Ukraine-was delighted. A frustrated Zelenskyy dismissed the Riyadh talks as worthless. Trump did not like those comments and called the Ukraine President a dictator, even accusing him of starting the war. Zelenskyy said the US President was living in a Russian-made "disinformation space". This infuriated Trump, who does not take kindly to any criticism.

The proposal has been dismissed by Russia, which currently has about 600,000 troops in Ukraine. But even Britain and France, with much smaller armies than Russia, can't send troops to Ukraine without some backup from the United States. And that looks unlikely, for now. Trump's Ukraine envoy, General Keith Kellogg, who visited Kyiv and met Zelenskyy on Thursday, said all options must be open to deal with the outcome of peace talks. But he knows that any decision to provide any US military cover will be made by Trump who looks

less inclined to do that. He described Zelenskyy as "a modestly successful comedian" who "talked the United States of America into spending \$350 Billion, to go into a War that couldn't be won, that never had to start, but a War that he, without the U.S. and 'TRUMP,' will never be able to settle." Trump's behaviour towards Zelenskyy is in stark contrast to Biden's, who had backed Ukraine against Russia with all the possible military and financial



aid. President Biden travelled to Ukraine many times since the Russian invasion in February 2022 to display his administration's full support. He also promised NATO membership to Ukraine at a future date. Russia was severely punished for invading Ukraine. The US joined hands with its allies to isolate Moscow. Russia faced tough sanctions and its assets in the West were seized. The International Criminal Court issued an arrest warrant against Putin for alleged war crimes in Ukraine. There were even plans to put Putin and his close allies on Nurembergstyle trials. Until a year ago, Ukraine's leader was talking about even liberating all its territory, including Crimea, which Russia annexed in 2014, with the help of Western military equipment. Ukraine even succeeded in occupying the Russian territory of Kursk, which it had thought would be used as a bargaining chip during negotiations with Moscow. But all that now looks like a distant dream. With Trump back in the White House, Ukraine fears that Russia will be allowed to keep all the occupied territory as part of the deal to end the war. Kyiv is now likely to be denied NATO membership. That could be a promise to Russia to end the war. The US under Trump has

now even opposed calling Russia an aggressor in a G-7 statement being prepared to mark the third anniversary of the war. The US team removed the phrase from the first draft, which was prepared by Canada, the current holder of the group's presidency. It is not just Ukraine, America's European allies are also now nervous about the intent of Trump. Since the Second World War, they enjoyed the US security umbrella under NATO. But now they are unsure if the US under Trump will honour Article 5 of the NATO, which is triggered when a member state comes under attack. It implies that an attack on one member is an attack on all. There is even fear in Europe that Donald Trump may sign a deal with the Russian leader Vladimir Putin that will lead to the withdrawal of US forces from Baltic states and effectively kill the NATO alliance. That could be similar to the non-aggression treaty signed by the Soviet Union and Nazi Germany on August 23, 1939, sending shockwaves to other European countries and prompting Hitler and Stalin to annex neighbouring countries. It is another matter that Hitler invaded the Soviet Union two years later, putting an end to the treaty. European memmight without US support. Even after losing more than a hundred thousand men and lots of military equipment in the Ukraine conflict, Moscow remains a strong power, mainly because of its nuclear arsenal. So Why Has Trump Changed The Narrative? Trump has always been an admirer of strongmen like Putin. Even during his first term, he developed a rapport with him. He also dislikes Zelenskyy, whom he sees as more of a roadblock in ending the Ukraine conflict. As a former businessman, Trump sees things from the perspective of profitable deals. Western sanctions have hit Russia, but American companies have also suffered business losses, running into billions of dollars. He would like to reverse that. And despite Ukraine's resistance, Trump believes Zelenskyy will have to give access to critical minerals in return for any future US support. Some in the Trump administration suggest should Americans with those minerals in return for the US military and financial aid already received by Ukraine. Trump has blamed European leaders for not doing enough to end the Ukraine war. He has also complained for a long time that Europe has lived off the US for too long and it must pay for its security. Europeans have increased their defence budgets but not enough to survive without US support. In the face of changing US under Trump, European leaders are working on a plan to guard against a Russian attack. This involves a proposal to deploy tens of thousands of peacekeeping troops in Ukraine. The proposal has the support of Britain and France and is in response to Zelenskyy's request of 100,000 troops. But the idea doesn't have wider support in Europe. Germany, another big power in the continent. Donald Trump has spent only a month in his second term as the US President. However, he has disrupted the international order, weakened the Western alliance and created a sense of insecurity and uncertainty among its members, surprising even some of his supporters. There has been a paradigm shift in US foreign policy under Trump. He is now closer to Moscow than Washington's traditional allies. He has embraced the Kremlin's narrative on Ukraine and has sidelined US allies. Although senior members of the Trump administration have denied that the US has abandoned Kyiv and ignored its European allies, Trump himself has not made any serious attempts to pacify Ukrainians and Europeans. His closeness to Russia has been on display since he talked for 90 minutes on the phone with Russian leader Vladimir Putin, in which they agreed to start negotiations to end the Ukraine war, which will mark its third anniversary on Monday. Trump did speak to Zelenskyy soon after that call with Putin, but a nervous Ukrainian President warned that excluding his country from the talks would be "very dangerous". Events after that only made Ukrainians feels sidelined. Trump's Vice President, JD Vance, met European leaders in Munich two days later. But his comment that Europe will not be included in the peace talks only helped fuelled the speculation that they were being left out of the future of Ukraine

This violation and commodification of women's bodies at the Maha Kumbh represents a betrayal three interconnected across spheres. It's not as if Indian women are unfamiliar with such trespasses-that's our daily reality. But the Kumbh videos expose a particularly perverse intersection of faith, trade, and technology. The men who run these channels deserve every second of what's coming to them. But let's focus on the culpability of the men who made their business model viable; the ones who actively sought out and paid for this sexual abuse. In an era where consensual sexual content is freely available, these men chose to pay for videos of women at their most vulnerable. The non-consensual nature of these videos isn't a bug, it's the feature. What drives these buyers isn't desire. It's the intoxication of watching women who never consented to be watched, who never imagined their moments of privacy would be relayed for mass entertainment. One can only imagine what consent means for these men in their daily lives—an unwanted intrusion in a fantasy of total dominance. In Uttar Pradesh, this commodification of abuse has a precedent. An Al Jazeera investigation from 2016 revealed that videos of rape were being sold.



India's large diaspora remitted more than \$100 billion: **UN** report

MUMBAI: India is the origin of the largest number of international migrants - around 18 million, with large diasporas living in UAE, US and Saudi Arabia. It continued its as the top country receiving remittances, but was spectacular with the figure crossing the \$100 mark.

According to the World Migration Report, released in Dhaka today, by UN's International Organization for Migration (IOM): "In , India, Mexico, and China were the top three remittance recipient countries, followed by the Philippines, France and Pakistan." In , India received \$111 billion, the first country to reach and even surpass the \$100 bn mark. In 2020, it had received \$83 billion. Mexico, with inward remittances of \$61 billion was the secondlargest recipient in , in the previous year it had replaced China to occupy the second spot and continued to hold sway. China's inward remittances in were \$51 billion. The contraction of remittance flows to China and its slipping to third spot has been attributed to multiple factors, including demographic shifts that have resulted in the shrinking of the working age population and the country's zero-COVID policy, which prevented people from travelling abroad for work. During , India's other neighboring countries Pakistan (rank 6) saw an inflow of nearly \$30 billion and Bangladesh (rank 8) received \$21 billion.

SC: Can't carry Raj-era bias to tag castes, tribes 'history-sheeters'

NEW DELHI:

Supreme Court had ruled that police cannot carry colonial era biases against persons belonging to certain tribes and schedcastes mechanically brand them in their records as 'bad characters' or 'history-sheeters" and said such archaic mindset violated individuals' right to dignity guaranteed under Article 21 of the Constitution.

After nudging the Delhi Police to amend the format for history-sheeters, which was copied from 90year-old Punjab Police Rules of 1934, to exclude the minor children and wife of a person

from getting included with him as a bad character, a bench of Justices Surya Kant



Vishwanathan Tuesday asked all states to revisit their rules within six regarding months inclusion of a person in police's 'historysheeter/bad character' record and weed out colonial era biases from relevant provisions.After deciding the case from Delhi, the bench resorted to its suo motu jurisdiction and examined the desirability of ensuring that no mechanical entries in 'history sheet' are made of innocent individuals, simply

because they hail from socially, economically and educationally disadvantaged backgrounds, along with those belonging to backward communities, SCs and STs.Referring to certain studies on this aspect and without going into their authenticity, Justice Kant-led bench said these reveal a pattern of an unfair, prejudicial and atrocious mindset as they allege that police diaries are maintained selectively of

individuals belonging

vimukta jatis (denotified tribes that were listed originally under Criminal Tribes Act of 1871, as criminal tribes because of their alleged addiction to committing crimes) reflecting biases of colonial times. Writing the judgment, Justice Kant said, "All state governments are expected to take necessary preventive measures.

to safeguard such communities from being subjected to inexcusable targeting or prejudicial treatment. We must bear in mind that these preconceived notions often render them 'invisible victims' due to prevailing stereotypes associated with their communities, which may often impede their right to live a life.

Government should start new rules to combat fraudulent e-commerce reviews



Consumer affairs secretary Nidhi Khare said the Union government will use an Indian Standards code to combat fake customer reviews and inflated ratings on e-commerce platforms, a global issue, as online shoppers complain more on the national consumer helpline. Online shoppers are heavily influenced by customer reviews and ratings. E-commerce sellers manipulate ratings and add paid reviews to encourage sales. "The presence of fake reviews online jeopardizes the trust-

worthiness and credibility of shopping platforms and can cause consumers to make wrong purchase decisions," said Khare, who led a stakeholders' meeting with Amazon and Flipkart executives. Mordor Intelligence estimates that India's e-commerce market would expand from \$112.93 billion in 2024 to \$299.01 billion in 2029, a 21.5% CAGR. Dramatically raises US tariffs on Chinese EVs and chips

Delhi: US President Joe Biden lambasted Beijing for "cheating" as he raised tariffs on Chinese products such electric vehicles and semiconductors. Beijing strongly opposed the sanctions as Biden sought to appear tough on trade ahead of a rematch with Republican Donald Trump in November's US presidential election. "We're not going to let China flood our market, making it impossible for American automakers to compete fairly," Biden declared in the White House Rose Garden. He said, "We're never going to allow China to unfairly control the market for these cars," before ordering duties. Trump's tariffs have been frequently criticized by Biden. He's been using similar tactics to win over blue-collar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year.

The sanctions targeted \$18 billion in Chinese imports, including batteries, vital minerals, and medical supplies. Biden said China has substantially supported critical sectors, forcing corporations to produce more than the world can consume and flooding the market with unfairly priced commodities. The president's announcement followed a review of tariffs imposed by then-president Trump on \$300 billion in Chinese imports. The Biden administration maintained tariffs.

Order mandating SpiceJet to pay Sun Group's Kalanithi Maran 270 crore overturned by Court

Home loan outstanding rises Rs 10 lakh cr

Delhi: Household debt has skyrocketed in the past two years. According to RBI's 'Sectoral Deployment of Bank Credit' data, housing sector credit grew by about Rs 10 lakh crore in the last two fiscals to a record Rs 27.23 lakh crore in March. Experts credit this to a significant home market recovery following COVID-19. Buyers who delayed buying homes during the pandemic are now buying. Government efforts to provide affordable housing have also driven this increase. An analogy: Imagine a house loan pool. This pool has risen dramatically in the past two years, signaling a homebuying boom. People catching up on delayed purchases and government affordable housing schemes may explain this. While the pool will undoubtedly increase, its rate may slow. Home ownership remained one of the top three goals in 2023, according to the BankBazaar Aspiration Index. Despite rising interest rates, bank loan books exceeded Rs 21 lakh crore as housing loan demand rose. Bankbazaar's average house loan ticket size in 2023 was Rs 28.19 lakh. Metros had an average house loan ticket size of Rs 33.10 lakh and non-metros Rs 22.81 lakh. Existing customers can move to lower home loan rates and prepay a portion of the loan to minimize the strain of rate spikes.

Children under 12 must sit with parents on flights without charge



Delhi: The Directorate General of Civil Aviation (DGCA) has ordered airlines to seat children under 12 with a parent or guardian. This change follows many complaints from consumers, particularly group travelers, who were seated separated from their children after opting out of extra seat selection expenses. Under the new rule, airlines must seat children under 12 with their parents or guardians on the same booking reference. The DGCA stressed the need of recording seating arrangements for compliance. "Airline shall ensure that children upto 12 years are allocated seats with at least one of their parents/guardians, who are travelling on the same PNR and a record of the same shall be maintained," a revised DGCA rule stated. Passengers can opt out of opt-in services including premium seating and meals. Airlines may automatically assign seats before departure if passengers do not pick seats during web check-in."Airline 'opt-in' unbundled services are optional.
