

Vatika Times DELHI: Bharatiya NEW Janata Party pulled up Congress over its recent comments on India-Pakistan issue asking them to refrain from calling it a "ceasefire". The saffron party categorically said that there was "no possibility of third party mediation" in PoK issue after the grand old party announced "Jai Hind" rallies across country demanding Prime Minister Narendra Modi to speak up on US President Donald Trump's role in India-Pakistan truce. "On the issue of mediation, which the Opposition tried to raise, it is being very unequivocally expressed by the Government of India that the issue of Pakistan



communications systems. "If we had built the plane, knowing it was going to a foreign government, we would probably have bugged it," former CIA station chief Thad Troy told Bloomberg, recalling Cold War-era espionage tactics used by adversaries.

Troy said any aircraft provided by a foreign power

could easily be embedded with covert tracking or listening devices, an intelligence threat that's difficult to neutralise. The concern is not hypothetical. He cited how the American embassy in Moscow was once dismantled brick by brick to remove hidden surveillance tools.US senator Mark Warner, chairman

of the Senate Intelligence Committee, echoed those fears, calling Trump's acceptance of the jet incredibly reckless. "A foreign-provided aircraft

presents a host of potential security risks, from surveillance equipment to compromised communications systems," Warner said in a statement to Bloomberg. "Thoroughly inspecting a plane like that for espionage tools or safety concerns would be nearly impossible," he added. The plane, built in 2012,

would need to undergo extensive retrofitting to meet Air Force One standards, including explosionresistant surfaces, secure communications, and aerial refueling capabilities.

US shuts down Pakistani reporter who accused PM of 'not welcoming' ceasefire

The context of other fiscal policy moves the **Modi government**

The budgeted capital expenditure is the same as the revised estimates for 2024-25. The tax cut should be seen in the context of other fiscal policy moves the Modi government has made in the last decade to boost growth. Since 2016, the Indian economy has struggled to sustain rapid growth. From 2016 to 2019, it was in a relentless showdown, with GDP growth falling to 3.9 per cent in 2019-20. The GDP then fell sharply in 2020-21 due to the pandemic. After this sharp decline, high GDP growth numbers created a false sense of complacency, but the compound annual growth rate between 2019-20 and 2024-25 is only 4.8 per cent. The latest GDP estimates suggest that the economy is slowing down again—with growth clocking at 5.4 per cent in the July-September quarter of 2024. Even if we set aside the critiques of GDP estimation in India, growth remains a topic of concern in policy conversations. The government's response to an economic challenge depends on what it considers to be the root cause. The Modi government's actions over the past decade suggest that it seeks to address India's economic growth pangs through fiscal policy. Consequently, fiscal policy has done much of the heavy lifting in the government's growth strategy over the past decade. In the economic slowdown from 2016-17 to 2019-20, the government sought to maintain its expenditure. To do so without increasing the reported fiscal deficit, from 2017-18 to 2019-20, it transformed a significant part of its on-budget expenditure into off-budget expenditure done by public enterprises. It also sharply raised cesses and surcharges on petroleum products, which are not shared with the states. These unusual tactics allowed the government to spend more, and expenditure continued to outpace GDP growth. These tactics also allowed the government to introduce new cash transfer schemes such as PM KISAN and increase allocations to existing schemes. In 2019, in an effort to stimulate investment, the government announced major tax breaks for corporates, especially in manufacturing. At the time, corporate tax collection had been growing rapidly while other taxes were struggling to deliver the budgeted increase. The tax cut led to a sharp reduction in the corporate tax to GDP ratio in the subsequent years. As the pandemic hit, fiscal policy became even more central.

The pandemic allowed the government to suspend its concern for deficits and bring the offbudget expenditure to the Budget in 2020-21. For a few years, revenue expenditure as a percentage of GDP was higher than its pre-pandemic levels. Among other things, this allowed the government to increase subsidies and cash transfers, and introduce production-linked incentives for manufacturing in India. Total subsidies as a percentage of GDP have now gone back to their pre-pandemic levels. The most important change in expenditure since the pandemic has been in its composition. Of the Union government's total expenditure, the share of capital expenditure has increased. Its share rose from 12.5 per cent of total expenditure in 2019-20 to 22.2 per cent in 2023-24.In 2019-20, capital expenditure was 1.67 per cent of GDP. It rose to 3.21 per cent.

in 2023-24, before moderating to 3.14 per cent in 2024-25 (revised estimates). It is again budgeted to be 3.14 per cent of GDP in 2025-26. At the same time, there was a reduction in capital expenditure by public enterprises in these years. If we consider the combined capital expenditure by the Union government and its public enterprises from the pre-pandemic years, there has been a decline.Between 2017-18 and 2019-20, the combined capital expenditure was 4.94 per

Drug smuggling is continuously increasing

Recently, news of school going children taking drugs has come to light in Gujarat. And this matter came to light when parents took two children to the doctors after their strange behaviour and their sleeping at home after tuitions, when the doctors got the urine test of both the children done. Actually, these children used to drink coffee somewhere while returning from tuitions, after which they used to hit the bed and sleep as soon as they came home. These children neither ate food on time, nor studied properly, nor talked to anyone properly, nor listened to anyone in the family. On this, the family members showed them to the doctors and then it was found out that both of them take drugs. Living in a tower of Jhanda Lal Chowk, they were caught stealing bicycles in school uniform and it was revealed that they had started taking drugs, they were stealing to buy drugs. Actually, about a week ago, Gujarat Police arrested 5 people with about 500 kg of cocaine under a joint operation. Earlier in June this year, hybrid ganja and other drugs worth about Rs 3.5 crore were hidden in children's items in Gujarat, which were seized by the police. And before that, more than 3 thousand kg of drugs worth crores were recovered from Gujarat at Adani Port. Similarly, drugs worth crores are recovered every year in Gujarat and apart from arresting a few people, the police or AIIMS department is unable to take any action that can



completely stop it. And today, not only in Gujarat, but in other states as well, the business of drug smuggling is increasing. The question is who is behind this? And the second question is why children, especially those studying in schools, are being made victims of drugs? Till a few years ago, it was seen that only children who pick garbage take drugs? But now the cases of children from well-off families taking drugs and other types of intoxication are increasing. The increase in the number of child patients coming to de-addiction centers is no small matter. In the year 2022, the Modi government of the Center itself told the Supreme Court that 1 crore 58 lakh minor children in the country between the ages of 10 and 17 years are consuming some form of intoxication, most of whom consume a particular type of dangerous intoxication. For example, they are taking drugs etc. The government had also told the court that minor children of this age are consuming many types of intoxicants including

cocaine, hashish, marijuana, alcohol, heroin, LSD, morphine, opium, cannabis. Citing a survey, the Modi government of the Center had told the Supreme Court that among all types of intoxicants, the people of India consume alcohol the most, about 16 crore people, out of which more than 5 crore 7 lakh people are seriously addicted to alcohol. After alcohol, they prefer cannabis and opium intoxication, the population of those who consume them is more than 3 crore 1 lakh, out of which the number of cannabis addicts is about 25 lakh. This matter came to light when a petition was filed in the Supreme Court by an NGO named Bachpan Bachao Andolan and the Supreme Court had sought a reply from the Modi government at the Centre. In this matter, the Modi government at the Centre also provided many other information about drug addicts, but did not take any concrete steps to stop drugs and other types of intoxicants. Anyway, every year on 8 June, National Drug Destruction Day is celebrated on a large scale in India and every year on 26 June, International Day against Drug Abuse and Illicit Trafficking is also celebrated at the international level and on both these occasions, children are the victims. Not only the Central Government, its de-addiction centres, but also the state governments and their de-addiction centres and all the government institutions working in the name of de-addiction spend crores and billions of rupees, but despite this, the number of drug addicts is increasing in India from drug trafficking to drug addiction, in which the most worrying thing is children getting addicted to drugs. While the Dr. Ambedkar International Centre of the Central Government has launched a very ambitious scheme like Nasha Mukt Bharat Abhiyan (NMB A) across the country, whose de-addiction centres are running in every district of the country, despite this, the increasing number of drug addicts, especially children, is not only a matter of concern, but it also seems clear that the gov-

ernment is wasting money on these de-addiction centres. The responsibility of the police is also to stop drug smuggling, but it is also almost a failure in this matter, and even if some honest policemen catch drug smugglers somewhere, then nothing much happens to the drug smugglers. Many times they get released easily on the basis of money or on bail. The of the Department is to stop drug smuggling, but it also seems almost unsuccessful in this. Anyway, drug smuggling is continuously increasing and so is the number of drug users. The Central Government should pay full attention to this and drug smugglers should not be spared under any circumstances. The police should keep a close watch on such gangs outside or around schools, who smuggle drugs and make innocent school children their victims. It is surprising and sad that not only minor boys studying in schools fall prey to these drug smugglers, but minor girls also fall prey to this. Not only the Modi government at the centre, the state governments, the drug department, de-addiction centres, the police, but also the teachers teaching schools and the parents of the children should pay attention to this. Miles away in Kazan, a culturally, politically, and economically significant city in Russia's Tatarstan, an Indian Prime Minister met a Chinese President for the first time in five years this week. Geopolitics is often unpredictable, yet this development was only partially surprising, as it was an anticipated move both countries knew would eventually occur. The last time the two leaders met was at an summit Mamallapuram, in southern

India, in 2019, just months before the countries clashed in the Galwan Valley in eastern Ladakh in 2020. While the

world was grappling with the effects of a once-in-a-century pandemic, China launched a brutal assault on Indian soldiers in Galwan Valley, where 20 Indian troops lost their lives. This incident shattered the 1993 Peace Tranquillity Agreement signed to maintain the status quo and peace at the border. It was also the first time in 45 years that blood had been shed in a China-India border conflict; the last such instance was in 1975, when four Indian soldiers were ambushed at Tulung La in Arunachal Pradesh. The Galwan Valley incident changed a significant reality that India had come to

take for granted—peace at the border with China had become a daily assumption. To be fair, there were frequent Chinese incursions—hundreds, in fact—but at least no lives were lost in resolving the resulting standoffs. Since 2020, relations between India and China had gone into a deep freeze. First came India's diplomatic response with serious condemnation, followed by rallying support from its Indo-Pacific partners, and then a complete halt to economic cooperation, marked by a blanket ban on Chinese investments. In the post-Galwan period, India suspended over 30 dialogue processes

with China, including highlevel discussions such as strategic dialogues between foreign ministers, the annual defence dialogue, meetings of special representatives on the territorial dispute, as well as youth exchanges, media, and think-tank dialogues. Relations reached their lowest point in this century, with the Indian side reiterating on various occasions that ties with China .were far from normal. Fast forward to October 2024, and we see Indian Prime Minister Narendra Modi holding a bilateral meeting with Chinese President Xi Jinping on the sidelines of the BRICS summit in Russia.

Massive and well-synchronised attack by drones

with a message in solidarity with pro-Palestinian university students, amid the ongoing conflict between Israel and Palestinians, in Rafah in the southern Gaza Strip, March 2, 2025. The war in Gaza is due to complete seven months on May 7, marking the longest war in Gaza since Israel's voluntary vacation of Gaza in 2005. Contrary to expectations, borne more out of Israel's enormous military superiority against Hamas as well as past conflicts in Gaza, the conflict has not ended swiftly.

During this time, however, Israeli strikes have flattened Gaza to the ground, making it completely uninhabitable, perhaps for decades. The stench of death and decay overwhelms the thin strip straddling the Mediterranean Sea, with estimates of over 34,500 deaths, including 13,000 children, and over 77,500 injured and maimed for life. Medical aid, food, and water have been severely restricted, and most international aid agencies, including UNRWA as well as WCK (World Central Kitchen), have been targeted and prevented from delivering lifesaving aid.Despite a UN Security Council resolution of March 25 calling for an immediate ceasefire and the unconditional release of hostages, neither of the warring parties has been able to come to a common understanding.

In the midst of it, there was a period of dangerous escalation when an Israeli strike on targeted the Iranian Consulate building in Damascus, Syria, resulting in the deaths of seven members of the Islamic Revolutionary Guard Corps (IRGC), including General Mohammad Reza Zahedi, the senior-most commander in Lebanon and Syria. Outraged by the attack on its 'sovereign territory', Iran retaliated on April 13 with a

massive and well-synchronised A girl walks next to a tent sprayed attack by drones and missiles. While most of the drones were intercept ed mid-air, some of the missiles found their mark and struck the Nevatim Israeli air base in the Negev desert. Nevatim is the air base from which Israel launched its F-35 fighters that attacked the Iranian consulate in Damascus. Despite decades of hostility between Israel and Iran, this was the first time that Iran had launched strikes directly on Israel from its territory. Israel and its allies, though forewarned by Iran of the retaliation, were surprised that Iran had actually called the bluff this time. Israel, under pressure at home, responded with a strike into Iran on April 19, when loud explosions were heard in the vicinity of the city of Isfahan in the early morning hours. It was reported that Iranian air defences had shot down 'three drones' over the skies of the city. Although some media outlets later presented satellite pictures to show that some part of the Air Defence Battery in Isfahan was damaged, neither Iran, Israel, nor the US commented on it. With tit-for-tat strikes into each other's territory, there is a general sense that both countries have called it quits as far as targeting each other directly is concerned. With this threat of escalation over, the focus has shifted back to Gaza and finding means to put an early end to the war. As a part of the effort, US Secretary of State Blinken was in the region recently to hold talks with Arab leaders.

He also stopped over in Israel, meeting PM Netanyahu in an effort to convince him to agree to a ceasefire and also to deter him from launching a ground offensive in Rafah. Whether Blinken was successful in convincing Netanyahu on it or not is a different question all together.



A group of educators is against UGC's plan to hold admissions twice a year

Delhi: The Delhi government's Anti-Corruption Branch (ACB) has charged top Aam Aadmi Party (AAP) leaders Manish Sisodia and Satyendar Jain with irregularities in the con-

struction of over 12,000 governschool classrooms. The scandal allegedly cost the excheq-Rs 2,000 the crore. In Prevention of



Corruption Act case, BJP leaders Harish Khurana, Kapil Mishra, and Neelkanth Bakshi filed complaints. The trio claimed that 12,748 classrooms were built at 24.86 lakh each room, when they should have been built for Rs 5 lakh. A preliminary investigation by ACB chief Madhur Verma found that the project, which had a set cost and a deadline of June 2016, had major cost overruns and delays. "Not a single work was completed within the prescribed period, and significant deviations and cost escalations were observed," Verma. He added that 34 contractors, most of whom were supposedly AAP-affiliated, won project tenders. Initially awarded for Rs 860.63 crore, contract values climbed 17% to 90% due to enhanced material standards. Verma said the increase was 326.25 crore, of which 205.45 crore was due to costlier specifications, or 24% of the award value.

Home loan outstanding rises Rs 10 lakh cr

Delhi: Household debt has skyrocketed in the past two years. According to RBI's 'Sectoral Deployment of Bank Credit data, housing sector credit grew by about Rs 10 lakh crore in the last two fiscals to a record Rs 27.23 lakh crore in March. Experts credit this to a significant home market recovery following COVID-19. Buyers who delayed buying homes during the pandemic are now buying. Government efforts to provide affordable housing have also driven this increase. An analogy: Imagine a house loan pool. This pool has risen dramatically in the past two years, signaling a homebuying boom. People catching up on delayed purchases and government affordable housing schemes may explain this. While the pool will undoubtedly increase, its rate may slow. Home ownership remained one of the top three goals in 2023, according to the BankBazaar Aspiration Index. Despite rising interest rates, bank loan books exceeded Rs 21 lakh crore as housing loan demand rose. Bankbazaar's average house loan ticket size in 2023 was Rs 28.19 lakh. Metros had an average house loan ticket size of Rs 33.10 lakh and non-metros Rs 22.81 lakh. Existing customers can move to lower home loan rates and prepay a portion of the loan to minimize the strain of rate spikes.

Children under 12 must sit with parents on flights without charge

Delhi: The Directorate General of Civil Aviation (DGCA) has ordered airlines to seat children under 12 with a parent or guardian. This change follows many complaints from consumers, particularly group travelers, who were seated separated from their children after opting out of extra seat selection expenses. Under the new rule, airlines must seat children under 12 with their parents or guardians on the same booking reference. The DGCA stressed the need of recording seating arrangements for compliance. "Airline shall ensure that children upto 12 years are allocated seats with at least one of their parents/guardians, who are travelling on the same PNR and a record of the same shall be maintained," a revised DGCA rule stated. Passengers can opt out of opt-in services including premium seating and meals. Airlines may automatically assign seats before departure if passengers do not pick seats during web checkin."Airline 'opt-in' unbundled services are optional. Auto seat assignment is available to passengers who have not selected a seat for web check-in before departure.



Industrial output grows 5.8% in, slows a tad in

New Delhi: The country's industrial output growth slowed marginally in March but manufacturing and electricity sectors remained robust, offsetting the slowdown in mining, while growth for the full fiscal year remained stable, data showed.

Numbers released by National Statistical Office on Friday showed the index of industrial production (IIP) rose an annual 4.9% in March, slightly lower than the downwardly revised 5.6% in Feb but above the 1.9% posted in last year.

For the 2023-24 fiscal year, industrial output growth rose to 5.8% from 5.2% in the previous year.Industrial output grows 5.8% in FY24, slows a tad in MarchThe manufacturing sector rose 5.2% in March, higher than the 1.5% posted in last year, while the electricity sector grew 8.6% compared with a 1.6% contraction in the same month a year earlier. The mining sector grew 1.2%



in March, slower than the 6.8% recorded in last year. The manufacturing expansion was consistent with other data such as the PMI for manufacturing, which had predicted stable expansion for the sector on the back of domestic robust demand.The consumer durables sector grew 9.5% in compared with a contraction of 8% in the year earlier period, while consumer nondurables grew 4.9% during the month compared with a contraction of 1.9% in the year earlier period.

Mumbai ex-cop Sharma gets SC bail in 2006 fake encounter case

New Delhi: Supreme Court granted bail to former Mumbai police officer Pradeep Sharma who was convicted and awarded life imprisonment in a 2006 fake encounter case. A bench of Justices Hrishikesh Roy & Prashant Kumar Mishra passed the order after the counsel for Maharashtra govt said it had no objection to grant of bail to him. While convicting him Bombay HC directed Sharma to surrender to undergo sentence but the apex court had on April 8 permitted him not to do so till the next hearing and issued notice to the state on his appeal against HC order.

The top court admitted Sharma's appeal against the March 19 Bombay HC verdict

Sharma challenged HC order in the 2006 fake encounter of Ramnarayan Gupta, an alleged close aide of gangster Chhota Rajan. HC had upheld the conviction and life sentence imposed on 13 other accused, 12 former policemen and a civilian, in the case. It quashed the 2013 judgement passed by a sessions court acquitting Sharma due to lack of evidence and termed it 'perverse and unsustainable'. On Nov 11, 2006, a police team had picked up Ramnarayan Gupta alias Lakkhan Bhaiya from Vashi, along with his friend Anil Bheda, and killed him in a staged encounter near Versova the same evening.

No bail to DHFL promoters seeking relief for spending half of term in jail

MUMBAI: Institute of Social Sciences scholar, research Ramadas KS, has moved the Bombay High Court against the institute's suspension order. He was suspended for two years from the institute and debarred from entering all the four campuses, in an order passed last month. In his petition, Ramadas has appealed to the court to set aside the inquiry report of the institute's empowered committee and the revocation of the suspension order and restore his entitlements as a student.He said that he was 'unlawfully, arbitrarily and unfairly suspended by the institute' Ramadas has also asked for the withdrawal of the public notice issued by the institute on April 20, two days after the sus-

passed. The public notice, stated the petition, was 'malicious' and 'defamatory' in nature and 'puts his life and academic purthreat'. He also pointed out that his legitimate participation in student life and exercise of his constitutional rights has been deemed as 'antinational' by the institute.The petition also seeks directions to the union ministry of social justice and empowerment to ensure the continuation monthly disbursal of the national fellowship he was entitled to. In his petition, Ramadas mentioned that he did not receive the fellowship amount for April 2024, in pursuance of the suspension order. Ramadas has also set an interim stay on the suspension order and the continuation of the fellowship pending the hearing.

The apparent contradiction between Musk's call for increased immigration and his involvement in past anti-immigrant narratives hasn't gone unnoticed. One X user wrote: "Wild to see this after Musk was promoting racist stuff about Haitians in Springfield." During Trump's campaign, rumors spread online claiming that Haitian immigrants in Springfield, Ohio, were harming and eating pets. Musk, at the time, shared memes supporting the narrative, including an Al-generated image of Trump hugging a duck and kitten, captioned: "Protect our ducks and kittens in Ohio!"The rumor, originating from a Facebook post, alleged that a missing cat was found being prepped for food by a Haitian neigh-

"The administration elaborated on quantum timekeeping advantages, including accurate independent navigation systems reducing GPS dependence, ensuring protection against interference or attacks.



GURUGRAM : A new patient study from healthcare provider Pristyn Care found that 5 out of 10 patients face delays in discharge due to the time taken to process insurance medical the claims. To alleviate the hassle experienced by health insurance policyholders, Insurance Regulatory Development Authority of India (IRDAI) is likely to introduce a 100% cashless hospital network that will include both receiving empanelled and nonempanelled hospitals.The study indicates that over 40% of individuals attribute delays in insurance claim claims in India to hospital administrative processes, while 25% cite a lack of coordination between hospitals insurance providers. The study also found that 6 out of 10 individuals never initiated the health insurance claim process. Among those who did, 34% expressed dissatisfaction with the paperwork, while 40% faced challenges in timely responses from their insurance providers. Roughly 3 out of 10 patients encountered discrepancies between pre-approved and final amounts. Additionally, around 38% of respondents reported that the discharge process took over 8 hours, with hospitals requiring a simitimeframe to claims. The Karnataka Micro-Finance (Prevention of Coercive Actions) Ordinance, 2025, which has already received the cabinet's approval, has suggested up to 10 years in prison and a fine of Rs 5 lakh for MFIs involved in harass-

Delhi: Apple introduced an artificial intelligence-focused iPad Pro and a bigger iPad Air to revitalize its tablet lineup after two years. The firm launched the first redesigned iPad Pro since 2018 at "Let Loose" online. The new model boasts a smaller body, a sharper Ultra Retina XDR screen with OLED technology, and a quicker M4 CPU for AI. The new iPad Air looks like the previous model but has a bigger screen and M2 CPU. Apple claims the 13-inch iPad Pro is the thinnest apple device ever at 5.1 millimeters. The larger model is a quarter-pound lighter than its predecessor, while

the 11-inch weighs under one. It breaks Apple's longest iPad release gap since co-founder Steve Jobs debuted it in 2010. In October 2022, Apple refreshed the iPad Pro with a speedier CPU and a revamped low-end model. Apple wants to get the iPad out of a slump. Apple expected that iPad sales will return this quarter after they fell 17% last guarter and failed analysts' projections. The graphics engine is four times faster and the CPU is 50% faster than the iPad Pro. Apple stated the chip uses second-generation 3-nanometer technology. Main innovation is the neural engine, which the business claims is 60 times faster than its 2017 version. This will assist the iPad Pro perform AI jobs. 
