MUMBAI: Amidst the debate over the timelines set by the SC for governors and the President. Chief Justice of India Bhushan Gavai on Sunday said neither the judiciary nor the executive or the legislature had an upper hand, but rather it is the Constitution of India that is "supreme" and "all the three wings have to work together as per the Constitution.

The statement comes barely days after President Droupadi Murmu sent a 14-point Presidential Reference to SC asking if the court can "impose" timelines and prescribe the conduct of governors and the President when handling state bills sent for assent or reserved for consideration. Centre had accused SC of stepping into executive domain.Justice Gavai, who

took oath as the 52nd CJI last week, was speaking at a felicitation function organised by the Bar Council Maharashtra and Goa. Justice Gavai said, "The basic structure is strong, and all three pillars of the Constitution are equal. And all the organs of the Constitution must reciprocate and give due respect each other," said.Parliament has the power to amend the Constitution, but it cannot touch the "basic structure", he said. The 'basic structure' doctrine holds that certain fundamental features of the Constitution, such as its supremacy, the rule of law, and independence of the judiciary, cannot be amended or abrogated by Parliament through a constitutional

tal right: CJI on bulldozer iusticeThe recent Presidential Reference invoked SC's advisory jurisdiction under Article 143 (1) of the Constitution to determine if timelines can be set.The President's move stemmed from a May 8 judgment by an SC bench of Justices J B Pardiwala and R Mahadevan on a petition by the Tamil Nadu govt challenging the governor's delay in clearing bills passed a second time by the legislature and his move to reserve them for the President's consideration. The reference pointed out that "there are conflicting judgments of the Supreme Court as to whether the assent of the President of India under Article 201 of the

Constitution of India is justiciable or not".In April, while hearing two matters before his elevation as CJI, Justice Gavai had observed, "As it is, we are alleged of encroaching upon the parliamentary and executive functions." The executive had questioned apparent judicial overreach while hearing a matter over violence in West Bengal. In another matter regarding explicit online content, Justice Gavai had orally observed that it was for the Union to frame rules in that regard. "As it is, we are now criticised that we are interfering with the executive's function, the legislative functions," he had said.

## **Former US President Biden diagnosed** with 'aggressive' prostate cancer

Former President Joe Biden, 82, has been diagnosed with prostate cancer after a routine physical exam revealed a nodule. Doctors confirmed the cancer has spread to his bones but is hormone-sensitive, allowing for effective management. Biden and his family are reviewing treatment options, adding to his medical history that includes past skin cancer treatments and public scrutiny over his health. Former US President Joe

Biden diagnosed with 'aggressive' prostate cancer Former US President Joe Biden has been diagnosed with prostate cancer, his office announced on Sunday.His diagnosis follows recent medical checks



that revealed a worrying development. Biden was seen by doctors earlier this week after showing urinary symptoms. A routine physical exam had uncovered a small nodule in his prostate, prompting further tests. By Friday, doctors confirmed the presence of prostate cancer, with cells having already spread to his bones.

"While this represents a more aggressive form of the disease, the cancer appears to be hormonesensitive which allows for effective management," his office said in a statement. "The President and his family are reviewing treatment options with his physi-

Prostate cancers are rated with a Gleason score from 1 to 10, showing how abnormal the cancer cells look compared to healthy ones. Biden's score of 9 means his cancer is very aggressive.

## US Embassy in India issues Permanent Ban on traveling to the United States warning

US Embassy in India has issued a Permanent Ban warning. The American embassy's warning comes via a social media post on Twitter from embassy's official account, US Embassy India. This is the third Twitter post regarding illegal immigration made by the US embassy in India this month so far. It is not clear what exactly is the reason behind these special and frequent warning messages. In a new policy change under the Donald Trump government, all foreign nationals staying in the US for over 30 days are required to register with the Federal government.



Failing to do so, may not only result in deportation but also Visa cancellation and more.

What the warnings by the US Embassy in India say The latest warning from the American embassy reads: "If you remain in the United States beyond your authorised period of stay, you could be deported and could face a permanent ban on traveling to the United States in the future.

Earlier this month in another related post from the US Embassy in India handle reads, "The U.S. government has launched a coordinated interagency effort to combat fraud and end illegal immigration. fraud will face permanent bans from entering the United States. New visa restriction policies apply to individuals and foreign governments who facilitate illegal immigration." Not directly linked to Indians travelling to America, but another post on illegal immigration was shared by the embassy in May beginning. United States is working to reduce border threats at home and abroad in partnership with outmigration and transit countries.

Stressing that India has kept Pakistan "on probation" to ascertain

whether it ceases crossborder terror, defence minister Rajnath Singh had said on Friday, "If Pakistan's behaviour improves, it is fine. But if there is any disturbance, harshest punishment will be given."

"As far as continuation of the break in hostilities is concerned, as decided in the interaction between the DGMOs of May 12, there is no expiry date to it," the Army added, in a brief statement on Sunday.

The two countries have decided to continue their confidence building measures to gradually reduce the high alertness levels between the rival militaries ranged against each other all along the western front.

"This is being done to ensure neither side fires or initiates any aggressive and inimical action," an official said. On May 10, the two sides had also agreed to "consider immediate measures" to ensure troop reduction along the Line of Control as well as the international boundary.

#### Reforms plans at risk if you up tension with India: IMF to Pakistan

New Delhi: Days after clearing fresh assistance despite India's strong opposition, International

Monetary Fund (IMF)

has flagged that heightened tension with its neighbour could increase the "enterprise risk" for Pakistan's agreed reforms, while also cautioning about "reputational risk" due to a perception of fund diversion.Setting out 11 new structural benchmarks reforms under the bailout scheme, the multi-lateral agency



warned "an intensification of political or social tensions" could also impact policy and reform implementation, in what was probably a reference to internal conflicts in Pakistan.India's concern, however, has more to do with the way Pakistan is being provided assistance despite its strong links with terror, as pointed

out by Rajnath Singh last week. He had sounded an alert about possible diversion of funds by Pakistan govt to rebuild terror bases destroyed by Indian forces, and called for a rethink of the IMF assistance. In the midst of Operation Sindoor, at the IMF board meeting on May 9, India had red-flagged disbursement of \$1 billion loan to Pakistan, along with fresh assistance of \$1.4 billion in the name of climate resilience, but the US and European countries backed the proposal and approved

## **Editorial**

### Deep State is the convenient bogeyman of modern politics

Circa 1900: Rudyard Kipling wrote Kim, placing the eponymous hero at the centre of the Great Game of espionage between the British Empire and Russia in the 19th century. The book is set after the Second Anglo-Afghan War, which ended in 1881, but before the Third, likely in the period 1893–98. Kim, short for Kimball O'Hara, is an impoverished Irish orphan who lives on the streets of Lahore and works for Mahbub Ali, a Pashtun horse trader. He later befriends an aged Tibetan lama, accompanies him on his journey along the Grand Trunk Road, learns about the Great Game, and is eventually recruited by Mahbub Ali, who works for the British Secret Service in their quest to extend influence in both Afghanistan and Tibet.Whether or not the Great Game—the expression used by British imperialists to describe the perceived expansion of Russian influence in Afghanistan, Central Asia, and Tibet—actually existed, the fact remains that surveys were undertaken, expeditions mounted, spymasters recruited, and novels written, even as soldiers lost their lives. Taking a cue from Viceroy George Curzon, all pro-establishment papers-from the Civil and Military Gazette of Lahore to The Pioneer of Lucknow, The Statesman of Calcutta (now Kolkata), and The Times of India of Bombay (now Mumbai) concurred that Tsarist Russia posed a real threat to the jewel in Britain's crown. A hundred and twenty years later, historians remain sceptical of Curzon's assertions. Is the hue and cry about the Deep State similar to the Great Game? Whether or not it exists, whether it operates in all countries, and whether the 'deep state' of one country is connected with others through the dark web or entrenched corporate interests remains unclear, as the discourse is more ideological than empirical. Sometimes, those who claim to be part of the deep state ascribe to themselves a larger-thanlife role in state affairs—for example, AS Dulat and Asad Durrani in their 2018 book The Spy Chronicles: RAW, ISI and the Illusion of Peace. Their claim to be arbiters of one of the most tense and difficult relationships in the region has been widely critiqued by reviewers. The term first gained wide currency in the context of Türkiye as derin devlet, which literally translates to "deep state" in English. In Türkiye, it refers to a non-elected military elite dominating elected governments, especially when they attempt to dismantle the secular foundations of the Republic, established by Mustafa Kemal Pasha after the abolition of the caliphate in 1923. In Pakistan, "deep state" refers to a government controlled by powerful military leaders, as documented by Stephen Cohen in The ldea of Pakistan and Ishtiaq Ahmed in Pakistan: The Garrison State. Elected governments in Pakistan have rarely exercised real control over defense and foreign policy.In the US, Democrats and Republicans accuse each other of controlling the 'deep state.' Democrats claim the pro-Republican arms lobby and militaryindustrial complex constitute the deep state, while Republicans argue that Ivy League universities promote 'wokeism' and diversity, equity, and inclusion narratives that, according to Donald Trump, undermine America's greatness. Trump has accused the deep state within the Democratic regime of election interference, citing the Freedom Medal awarded to George Soros as evidence. However, skeptics argue that if the deep state were so powerful, how could Daksh Patel dismantle it simply by firing 'interns and associates' whose tenure is co-terminus with that of President

# Justice Abhay proposed shifting Article 32 cases

ing talk, Supreme Court Justice Abhay Oka posed several persuasive queries about Article 32 of the Constitution, which protects the ability to petition the Supreme Court directly to have one's fundamental rights upheld. With astounding 83,418 cases pending in the highest court, Justice Oka wondered if writ petitions filed under Article 32 need to be filtered. He made reference to the potential use of "rational tests" to choose which circumstances covered by this clause should be considered. Though it is important to thoroughly understand the relevance of this provision before moving further, this is an intriguing concept that is worth investigating.It is helpful to remember Dr. BR Ambedkar's remarks from the December 9, 1948, Constituent Assembly Debate in order to understand the significance of Article 32: "I could not refer to any other article except this one if I were asked to name any particular article in this Constitution as the most important—an article without which this Constitution would be a nullity." It is the essence of the Constitution, its essen-



tial core.It is obvious that Article 32 was highly valued by the Constitution's framers, and with good cause. A right to petition the Supreme Court to uphold the fundamental rights guaranteed by the Constitution is "guaranteed" by this provision. Any proclamation of rights would have been meaningless and empty without meaningful recourse for enforcement. As a result, the Supreme Court of India has more jurisdiction under Article 32 than courts in comparable locations. It gives the court the authority to grant writs as well as any other directives or orders required to successfully uphold basic rights. Suddenly, those writs that had previously been at the mercy of a legislator were an essential part of the framework for upholding fundamental rights.Over the course of the next twenty years,

Supreme Court emphasized the importance of safeguarding and upholding fundamental rights to prevent them from being degraded to the status of "playthings of a special majority" in a number of following constitutional issues. The 1970s then brought about a paradigm shift when the Supreme Court introduced the new process of Public Interest Litigation (PIL) petitions under Article 32. This paradigm change disregarded the idea that the only people who could file a lawsuit in court were those who were directly and personally impacted by executive acts. As a result, this measure gave the poor and disenfranchised access to our nation's top court. But as of June 15, 2023, there were 2,912 writ petitions, 32,761 special leave petitions. and 25,228 appeals awaiting hearing before the Supreme Court as a

result of this as well. In addition, there were almost 60,000 written petitions sent in only the previous year.It is worthwhile to consider the possibility of an Article 32 petition filtration system. If that's the case, how may this appear? It is possible that the Supreme Court will create standards or examination procedures to assess listing petitions, taking into account elements like the precise basic right that was violated, the urgency of the request, and the petitioner's socioeconomic background, or a mix of all three. However, there are many challenges and complexity involved in creating such criteria for Article 32 petitions. Setting priorities differentiating between situations of bonded labor, caste-based discrimination, arrests, housing evictions. , and possible closure of minority educational institutions is a difficult undertaking. Which of these problems is more critical? Is it more important to protect cultural customs than to stop prejudice based on caste, for example? Which basic right is more important, and why? Should petitions under Article 32 pertaining to privacy take precedence over cases alleging wrongful detention? Can such applications be redirected to the higher courts by the Supreme Court? These are difficult questions that should be carefully considered before topic matter or urgency are utilized as filters. Marginalized populations have historically waited at the back of the line to receive justice. Therefore, giving petitioners' socioeconomic backgrounds first priority when publishing Article 32 petitions may hasten marginalized groups' access to justice. Giving preference to one group over another, however, might go against 32 of the Article Constitution, which guarantees everyone the equal enforcement of fundamental rights regardless of social standing. Article 32 is distinct from all other provisions, after Without any restrictions or conditions, it "guarantees" its protection to everyone.

It would be appropriate to adopt criteria or tests for accepting petitions under Article 32 only after addressing constitutional issues pertaining to the hierarchy of fundamental rights.All things considered, the primary difficulty is striking a balance between the enormous backlog and the preservation of justice.

## Climate hypocrisy: West's moral high ground

In 2019, during the UN Climate Action Summit in New York, leaders from industrialised nations delivered impassioned speeches about the urgency of addressing climate change. Yet, behind closed doors, they continued to approve new fossil fuel projects and delay meaningful climate finance commitments. This dichotomy highlights a fundamental hypocrisy in global climate politics: The West often preaches sustainability but falls short in practice, prioritising economic interests over environmental imperatives. As the countsummit in Azerbaijan this November continues, the Bonn Climate Change Conference in Germany concluded in a stalemate last week. Nations disagreed on the size and scope of loss and damage financing, representing a significant setback in global climate negotiations. The Bonn talks did not achieve meaningful progress on climate financing, underscoring a persistent issue: industrialised nations, which bear the greatest responsibility for the current climate crisis, resisted calls from Global South countries to compensate those who suf-

## Health plan for 70+ may cost govt Rs 5k crore



Delhi: Indian estimates imply that providing health coverage to persons 70 and older, regardless of income, will cost the central exchequer Rs 4,000 crore or Rs 5,000 crore more. The government budgeted Rs 7500 for the Ayushman Bharat-PM Jan Aarogya Yojana (AB-PMJAY), which covers 12 crore poor and vulnerable families for Rs 5 lakhs in 2023-24. Expanding the policy to include those over 70 will likely add 3.5 to 4 crore beneficiaries, sources added. Between 5.5 and 6 crore persons in the country are 70 or older. Poor and vulnerable households make up 2 crore of them covered by AB-PMJAY. So, it's estimated that the actual number of beneficiaries to be included in the new plan, a poll promise made by the BJP and mentioned in the

President's address to parliament, will be around 3.5 to 4 crores "The source added that the government was committed to fulfilling its promise and that the union budget 2024-25 may include the expansion of AB-PMJAY to include all senior citizens aged 70 and older. National Health Authority (NHA), which implements AB-PMJAY, is preparing the scheme's growth mechanisms budgetary ramifications. "Including persons 70 and older, regardless of income, is crucial to universal health coverage. An official claimed it will also evaluate the inclusion of the missing middle class. AB-PMJAY is supported 60:40 by the state and the centre. Some states are paying more because they expanded the system to include seniors.

#### Delhi has practically exhausted groundwater

Delhi: While Delhi is facing a water crisis and civic authorities endeavor to boost groundwater availability, the Central Ground Water Board (CGWB) reported that yearly recharge and groundwater for extraction had declined. The analysis anticipated Delhi's net annual groundwater recharge in at 0.38 billion cubic meters (bcm), 0.34 of which was accessible extraction. Alarmingly, most groundwater has been removed. It means 99.1% of groundwater is extracted. The groundwater recharge was 0.41 bcm, with 0.37 bcm available for extraction and 0.36 bcm pulled out. The analysis showed Delhi's groundwater extraction rising from 98.16% in 2022 to 99.13% in 2023 despite a drop in recharging.

While some places have made headway in maintaining safe groundwater levels, Delhi still struggles to properly manage its groundwater resources.

## Govt reduces vehicle threshold to widen NHs to 4, 6 & 8 lanes

**NEW DELHI:** 

Government will undertake the expansion of 25,000 km of two-lane highways to four lanes, involving an investment of Rs 10 lakh crore over the next two years, said road transport minister Nitin Gadkari in the Lok Sabha on Thursday. He also announced the decision to reduce the traffic threshold of NH stretches to qualify for expansion to four, six and eight lanes.

Replying to a question on multi-laning of NHs, Gadkari said two-lane stretches carrying more than 12,000 passenger car units (PCUs) per day will qualify to be expanded to four-lane roads, which was earlier 12,500 PCUs. Four-lane highways that breach the 20,000 PCUs per day limit will qualify for six-laning and those with more than 30,000 will be widened to eight lanes.PCUs is a metric used to measure the impact of different vehicles on traffic flow, converting heterogeneous traffic into a standardised, homogeneous stream for analysis and planning. While a standard passenger car is



typically assigned a PCU value of 1, a heavy truck might have a PCU value of 2-4.

Sources the official decision on the revised eligibility criteria for NH expansion will be out soon for planning of the next phase of highway

development. Gadkari said govt has prepared the detailed project reports (DPRs) of 3,500 km two-lane highways for expansion to four lanes and preparation of DPRs for another 21,500 will start soon. This gains importance considering govt's increased thrust on building wider highways that can meet the projected traffic demand. In the past 11 years, the length of 4lane highways has been increased by 163%.



## Life microinsurance premium in India exceeds Rs 10,000 crore

Delhi: India's life insurance micro-insurance premiums topped Rs 10,000 crore for the first time in FY24, according to industry data. Microinsurance aids low-income people with affordable items. The Insurance Regulatory and Development Authority of India (IRDAI) reported that life insurance's microinsurance segment's new business premium (NBP) rose 23.5% to 10,860.39 crore in FY24. Individual NBP fell 23.78% to Rs 152.57 crore, while group NBP rose 24.61% to Rs 10,707.82 crore. IRDAI reported 102,000 microinsurance agents in FY24. About 19,166 are publicsector life insurers and the rest private.

The research showed that 4.49% of micro-insurance agents are NGOs, 0.25 percent self-help groups, 0.24 percent microfinance institutions,



0.12 percent business correspondents, and others 94.90%. Over 21 lakh people have received life insurance through the Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJ-BY). PMJJBY term life insurance was launched in May 2015. This policy pays Rs 2 lakh to the insured's family in the event of death. The scheme enrolled 21.67 crore by October 20. The total claims were 860,575, totaling Rs 17,211.50. India's insurance market expanded 11% annually to \$130 billion in FY2020-23, outpacing China and Thailand, which grew less than 5%.

## **Adani Group exits** Wilmar JV for \$2bn

Delhi: For \$2 billion, Gautam Adani's Ahmedabad-based

conglomerate is selling Adani Wilmar, its staples business, to Wilmar International of Singapore to raise funds. This fund inflow should meet the group's infrastructure business liquidity needs. Adani



Enterprises and Adani Commodities own 44% of Adani Wilmar, which owns Fortune sunflower oil and Kohinoor basmati rice. Wilmar would buy 31% at Rs 305 per share of the group's 44%, boosting its holding to 75% in Mumbai-listed Adani Wilmar. Wilmar will buy the chunk at \$1.4 billion, down 7.2% from Monday's close. Indian regulations limit promoters' equity to 75% and require public shareholders to own 25%. Along with 12% public ownership, the remaining 13% interest will be offered for sale. This ends the group's 25-year staples presence. Following the transaction, the company will be called AWL, AWL Agri Business, or Fortune Agri Business. The transaction comes one month after US prosecutors accused Gautam Adani of securities and wire fraud for a \$265 million Indian power contract bribery scam, which the group denied. The sale of Adani Wilmar will boost the group's primary infrastructure.

## Kabul claims Pak airstrikes killed 46 civilians in Afghanistan

**ISLAMABAD:** interim Afghan Taliban claimed govt Wednesday that 46 people, mostly women and children, were killed in airstrikes by Pakistani fighter jets on civilians in eastern Afghanistan Tuesday night.

Pakistani security officials said the airstrikes took place in Murgha and Laman areas of Barmal district, in Afghanistan's eastern Paktika province near Pakistan's volatile South Waziristan tribal district, on alleged camps of the banned Tehreek-i-Taliban Pakistan (TTP). This has been the fourth time in the past few years that Pakistan has conducted airstrikes inside Afghanistan, and the second time since

Zapeta-Calil approached the victim silently approached the victim and then ignited her blanket. The woman had layers of clothing which immediately got engulfed in fire. CNN earlier reported that the victim had mobility issues and did not respond to the fire immediately. She sat still as she kept on burning and could only stand up when she was fully burnt. The suspect waved a shirt around her and then came out of the train and watched the victim turning to ashes -- from a bench outside the subway car. Accused claims he has no memory of incidentZapeta-Calil did not enter a plea during his arraignment on Tuesday. He told police he did not know what happened and that he was intoxicated at that moment. He, however, identified himself in the images of the attack. Zapeta is an undocumented migrant from Giatelama who was deported in 2018. But he subsequently returned to the US illegally. His most recent address was listed as a homeless shelter in Brooklyn. and other residents of the shelter identified him.

They said he used to remain intoxicated.

## 12 years after life term, SC acquits Tamil Nadu man of burning wife to death

**NEW DELHI:** Twelve years after being convicted and sentenced to life imprisonment for allegedly burning his wife to death in Tamil Nadu, apex court has acquitted the man after noting that there was inconsistency in dying declaof deceased and also there was no other evidence to prove his culpability.

A bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said that conviction could not happen if there were major contradictions in the dying declaration of the deceased and there was no other substantial evidence against the accused. "If a dying declaration is surrounded by doubt or there are inconsistent dying declarations by the deceased, then courts must look for corroborative evidence to find out which dying declaration is to be believed. This will depend upon the facts of the case



required to act cautiously in such cases. The matter at hand is one such case. In the present case, the deceased had given two statements which are totally different from her subsequent statements including the statement made before judicial magistrate, which has been considered a dying declaration based on which the appellant has been convicted," the bench said.In this case, the deceased, in her first statement did not blame her husband and said she caught fire while cooking but later on told the magistrate that husband had poured kerosene on her and set her on fire.
