

#### **SC** criticizes **OPSC** for refusing to acknowledge mistake made in evaluation of answer sheet



New Delhi, (HS): Supreme Court strongly criticized Odisha Public Service Commission (OPSC). The commission is very stubborn in its attitude, the Supreme Court further added while hearing a matter concerning the Commission. The Supreme Court said that, the OPSC thinks it is very superior and that is why the commission does not admit to making mistakes. The Supreme Court has come down heavily on the OPSC for not admitting mistakes in the OJS answer sheet evaluation process. A three-member bench of the Supreme Court comprising of Justice Surya Kant, Justice Deepankar Dutt and Justice Vijay Bishnoi has challenged the High Court verdict and dismissed the appeal filed by OPSC. According to reports, the High Court had ordered the Commission to pay a compensation of one lakh rupees to OJS-2022 candidate Jyotirmayee Dutta for the error in the evaluation process. Along with this, it had also made strong remarks on OPSC. This was challenged by OPSC in the Supreme Court. The Commission's lawyer had argued for the removal of the negative comment given by the Orissa High Court against the OPSC. The Supreme Court said, the Commission cannot make such a serious mistake in the evaluation of the answer sheet. Such a mistake in the evaluation cannot be ignored. The Commission should be

held responsible for this. Justice Deepankar Das commented, "if you had accepted from the beginning that there was some mistake on our part and we would have investigated it, then this case would have ended there." However, the Supreme Court clarified that the negative comment given by the High Court on the OPSC will not be taken as a precedent for future cases.

# Sindoor has become symbol of valour, says PM Modi

Maintaining that Operation Sindoor has made it bluntly clear that the proxy war by Pakistan through terrorism will no longer be allowed to continue, Prime Minister Narendra Modi on Saturday declared, "The entire nation's firm resolve is that every bullet will be responded with a

history's biggest and most successful anti-terror operation. Our forces destroyed targets hundreds of kilometres into enemy territory, something that Pakistan had never even imagined. Operation Sindoor has made it bluntly clear that proxy war against India via terrorism will no longer continue. We will hit them in their homes, and those aiding the terrorists will have to pay a heavy price," Modi said while addressing the first allwomen gathering in Bhopal. Amid the fluttering of national flags at the mega women empowerment meet, marking the 300th birth anniversary of the legendary 18th-century queen of the Malwa kingdom, Lokmata Devi Ahilyabai Holkar, the PM said, "It's the first resolve of 140 crore Indians, if you fire bullets, then each bullet will be responded



with a bomb by us." "Sindoor (vermillion) is integral to Indian culture. It symbolises women power; it has been worn by Lord Hanuman while being coloured with devotion to Lord Ram. Sindoor is also offered during Shakti Puja. But now, Sindoor has become the symbol of India's bravery." "The Pahalgam attack was also an attack on our rich culture and aimed to divide our society. It also challenged our women power, which ultimately scripted the death and destruction of terrorists and their masters hundreds of kilometres into enemy territory." While

underscoring that Operation Sindoor has also emerged as a symbol of the strength of India's women power, the PM highlighted the role of women officers in the armed forces and female soldiers of the Border Security Force (BSF) in the successful operation. "In Pahalgam, terrorists not only shed the blood of Indians, but also attacked our culture. They tried to divide our society and the biggest thing is that the terrorists have challenged the women power of India," Modi said. "This challenge has become the death knell for the terrorists and

their handlers. Operation Sindoor is the biggest and most successful operation in the history of India against terrorists. While the Pakistan army could not even imagine, our army destroyed the terrorist hideouts," he added.

This time, 75 women have become members of Parliament. Our effort is to increase this number. This is the spirit behind the Nari Shakti Vandan Adhiniyam. Women reservation in Parliament and state assemblies has been achieved now, which had remained pending for a long time," he said. Nari Shakti Vandan Adhiniyam, also known as the Women's Reservation Bill, is a landmark legislation that aims to reserve one-third of the total seats in the Lok Sabha and state legislative assemblies. "This means that the BJP government is empowering our sisters and daughters at every level and in every field," he said. The prime minister also said the world is witnessing the capability of India's daughters in national defence today. "Even for this, the government took many steps in the last decade. From school to the battlefield, the country today has unprecedented faith in the bravery of its

#### Dr Amarendra Nath **Mohanty Appointed Director of Health Services**



Bhubaneswar, (DMC): In a key administrative reshuffle, the Odisha government has appointed Dr Amarendra Nath Mohanty as the new Director of Health Services. The Health & Family Welfare Department issued a notification to this effect on May 30, stating that the appointment takes place with immediate effect.

Dr Mohanty previously served as the Director of the State Institute of Health & Family Welfare (SIHFW). Following his elevation, Dr Dillip Kumar Panda, the current Superintendent of Capital Hospital in Bhubaneswar, will take over as the new Director of SIHFW. Along with these appointments, four senior medical officers in the Odisha Medical & Health Services (OMHS) Cadre have been promoted from the Senior Administrative Grade to the Super Time Pay Grade on an ad-hoc basis. These promotions will remain valid for up to one year, pending recommendations from the Odisha Public Service Commission (OPSC) or until the officers retire, whichever comes earlier. The promoted officers include Dr Mohanty and Dr Panda, along with Dr Sashi Bhusan Patel, Dr Rajashree Pattnaik, and Dr Rupabhanu Mishra. As part of the same reshuffle, Dr Sashi Bhusan Patel, who previously served as the Superintendent of Rourkela Government Hospital, has been appointed as Director-cum-Ex-Officio Special Secretary (Technical) in the Health & Family Welfare Department. The notification signals a strategic move by the state government to strengthen the top leadership within the public health system as Odisha continues to enhance its healthcare delivery and administrative efficiency.

# CM Urges Youth to Say 'No To Tobacco, Yes To Life'

Bhubaneswar. (DMC): Approximately 14 lakh people in India lose their lives every year due to tobacco consumption, accounting for nearly 10% of all deaths in the country. Chief Minister Mohan Charan Majhi emphasized the urgent need for the public, especially the youth, to take serious steps toward breaking free from this menace. He made these remarks during the launch of an awareness campaign on World No Tobacco Day at the Lok Seva Bhawan Convention Hall.

On this occasion, the Minister urged everyone to join the awareness campaign against narcotics, adulterated, and toxic substances, calling for a collective resolve to embrace life over addiction with the slogan, "Say No to Tobacco, Say Yes to Life." He highlighted that the campaign to curb the use and spread of tobacco, toxic liquor, and drugs will run across the state in four phases: from May 31 to June 26, June 26 to August 15, October 2, and December 25 to January 15,

2026, spanning nearly a year. The Chief Minister stressed that awareness is the only way to prevent tobacco-related deaths. Despite knowing its dangers, many people struggle to quit. He noted that saving even one person through awareness can save a life. He called for the government's campaign to reach every household to educate people about the harmful effects



and health risks of tobacco use. Highlighting the severity of tobacco use, the Chief Minister stated that it is the primary cause of oral and lung cancer. He remarked that while death is inevitable, it need not be painful, urging everyone to adopt a healthy lifestyle. He also cautioned against misleading advertisements for tobacco, cigarettes, and narcotics that influence the youth. To curb the spread of narcotics, toxic liquor, and illicit alcohol, the Excise, Home, and Narcotics Control Bureau departments are intensifying joint efforts, with strict action against offenders. The Special Task Force (STF) has been empowered to completely stop the smuggling of

tobacco and other narcotics. The Chief Minister announced that a new Excise Policy will soon be formulated to control all forms of narcotics. During the event, the Chief Minister unveiled the campaign's logo, TV spot, theme song, and informational booklet to raise awareness about the dangers of narcotics and to eliminate the trade of adulterated, toxic, and illicit liquor. Law, Excise, and Public Works Minister Prithviraj Harichandan, who attended the event, stated that addiction leads to death, making it a moral duty to raise awareness. He noted that this is the first time such a widespread awareness campaign has been launched in Odisha, aiming to reach every individual in society.

He called for other departments and civil society to join the effort and announced stricter penalties under the Excise Act. Ekamra-Bhubaneswar MLA Babu Singh expressed the vision of a prosperous and developed Odisha free from addiction, stating that curbing narcotics would also reduce crime. He advocated for strong action against addiction.

The campaign's brand ambassador, Padma Shri awardee and international sand artist Sudarshan Pattnaik, emphasized that it is everyone's responsibility to take this initiative to every household. Excise Department Commissioner and Secretary Guba Poonam Tapas Kumar delivered the welcome address.

# India's Covid Cases Rise to Nearly 3,000, These States are Worst Hit

New Delhi, (HS): India's active coronavirus cases have risen to nearly 3,000, with Kerala fighting the latest resurgence of infections - followed by Maharashtra, and Delhi. Official data shows a quick rise in the cases within four days. While India recorded a total of 1.010 cases by May 26, the official data by the Ministry of Health and Family Welfare shows a total of 2.710 infections as of May 30.

According to the data, Kerala has recorded 1,147 cases, Maharashtra 424, Delhi 294, and Gujarat 223. Tamil Nadu has recorded a total of 148 cases so far, while Karnataka and West Bengal have reported 148 and 116 cases, respectively. Rajasthan has reported 51 cases, Uttar Pradesh 42, Puducherry 25, Haryana 20, Andhra Pradesh 16, Madhya Pradesh 10, Goa seven, and Odisha, Punjab, and Jammu Kashmir four each. Three states - Telangana, Arunachal Pradesh, and Chandigarh have reported three cases each, while Mizoram and Assam have two people detected with the infection each so far.

No active case has been reported from Andaman and Nicobar, Sikkim, and Himachal Pradesh. The official data for Bihar is not yet available. Data suggested at least seven died in recent weeks across India. Two



people who died in Maharashtra (1) and Delhi (1) had other severe ailments along with Covid-19. However, it is not yet clear whether others died due to the infection. All people who died,

except for the one in Punjab, were senior citizens, officials said. However, officials have said that the coronavirus cases are mild in nature and there is no need to Continued P-4


## 7 COVID-19 Cases Reported In **Odisha; Situation Under Control**

Bhubaneswar, (DMC): Odisha has reported a total of seven COVID-19 cases over the past two days, with five cases detected on Friday and two more confirmed on Saturday, according to Commissionercum-Secretary of the Health and Family Welfare Department Aswathy S. Addressing the media, Aswathy S. assured that the situation remains under control and there is no need for public panic. "Several of the

earlier detected cases have already recovered. The current number of active cases is minimal and well-managed," she said. The health department is actively monitoring the situation in coordination with the Union Health Ministry. "We are following all instructions issued by the ministry and have taken adequate measures to ensure preparedness. The state is fully equipped to handle the current caseload," she added. She further

noted that the variant currently in circulation is mild in nature. "According to reports from the Indian Council of Medical Research (ICMR) and the Union Health Ministry, the present variant has low virulence. Therefore, the public need not worry," she emphasized. The official reiterated that Odisha's COVID-19 numbers are within manageable limits and the government remains vigilant.

# The Myth of Singular Heroes

The narrative that Mahatma Gandhi and Jawaharlal Nehru single-handedly brought down the British Empire oversimplifies a complex historical process. While their contributions were significant, portraying them as the sole architects of Indian independence

forces and countless individuals who shaped the empire's decline. This allegory reimagines the fall of the empire as a crumbling fortress, not toppled by two giants but eroded by a multitude of cracks. To credit Gandhi and Nehru alone is to ignore the tapestry of resistance woven by countless hands. Gandhi's nonviolence and Nehru's

diplomacy were vital threads, but so were

the broader

the armed struggles, grassroots movements, and global shifts that pressured the empire. The fall of the British Empire was not the work of two men but the result of a collective storm-local and global, peaceful and militant, planned and spontaneous-that eroded the fortress until it could no longer stand.

The allegory of the crumbling fortress reminds us that history is not shaped by heroes alone but by the interplay of diverse forces. Gandhi and Nehru played pivotal roles, but the fall of the British Empire was a symphony of resistance, with millions as

its orchestra. To focus solely on them is to miss the richness of the struggle and the resilience of those who fought in the shadows. Pratibha

Ray's original Odia novel, Uttarmarga, which was published nearly forty years ago, has now been translated by KanakHota, and it resonates with the above allegory. It serves as a tribute to the courage and sacrifices made by ordinary individuals during the fight for independence. The novel illustrates not only the passion and sacrifices of individuals during the fight for freedom but also their disappointment with a liberation that did not realize their long-held aspirations for equality and prosperity in postcolonial India. The main character, Diganta Keshari, departs from his home to participate in the freedom movement,

dreaming of witnessing the nation transform into the perfect realm-Ram Rajya. However, upon his return to the village two decades after Independence, he faces a different kind of oppression and malevolence inflicted by those he once regarded as kin.

When a destitute young woman is assaulted by a politician, Diganta reaffirms his commitment to seek justice. Ray makes a comparison from the Upanishads and suggests that freedom, achieved through struggle, is sacred, similar to a soul striving for redemption, ultimately transforming into an immortal being after enduring a prolonged period in hell. KanakHota's delightful translation of this cautionary tale acts as a vital reminder that, despite its imperfections, democracy remains the sole system that ensures the rule of law and protects individual liberties. Writes Hota, 'Uttarmarga marks a watershed moment in Ray's oeuvre. In this book, she does not look into the mythical past but walks the reader through the birth of a nation on 15 August 1947 and beyond. She seamlessly mingles autobiographical elements and historical facts such as marches, meetings, promulgations and agreements during the freedom struggle and the Second World War with her fictional narrative. The ideal schoolteacher Parshurama Das, who galvanizes the freedom movement in the

villages, is drawn after her father with the same name. Rama Devi, a freedom fighter from Odisha, leads the Salt March in real time and talks to Ray's fictional characters like SamaPuhana and Sebati. These hypertexts, thus, provide new contexts for the reader to understand the time and events that her book depicts.' Hota, who currently lives in the USA and relocated several years prior, is presently a writer and translator exploring new opportunities in the field. She rightly notes that novels written in the various regional languages of India have not received the level of critical acclaim that they truly deserve. As more literary works from these 'bhasa' languages are translated into English-the most widely spoken global lingua franca-they will ultimately receive the acknowledgment they deserve. As she puts it, it is essential to share our narratives with new audiences who may not yet be acquainted with them.

'Where Freedom Reigns' is a remarkable addition to the anthology of Odia classics that have been translated into English, highlighting its importance in bridging cultural and linguistic gaps.

From his Under-17 days, Rohit Sharma was identified as a promising talent for the future. Endowed with significant natural skill and an appealing style, he made batting appear effortless. Combining the Mumbai approach to batting with innate flair, he entered the Indian team at the age of 20 and quickly made a mark during the first T20 World Cup in South Africa in 2007 and in the triangular series in Australia in 2008.


However, there were also setbacks along his journey. On the day of his Test debut, he suffered an ankle injury in February 2010, which delayed his Test cap until November 2013. Additionally, he was excluded from the Indian squad that celebrated victory in the 50-over World Cup held in India in 2011. Although he began his Test career with centuries in his initial two matches, Rohit faced challenges in maintaining consistency and securing a stable position in the middle order. He revitalized his limited-overs career when he was asked to open in January 2013, and he replicated this success in Tests by becoming a red-ball opener in October 2019

In early 2022, he was appointed as India's captain across all formats, taking over from ViratKohli. He played a crucial role in leading India to the final of the 50over World Cup held at home in November 2023, breaking a long period of drought by winning the T20 World Cup in June 2024 and bringing home the Champions Trophy in March 2025. The prevailing narrative regarding delimitation suggests that southern India successfully managed its population growth through efficient family planning, in contrast to the northern region. Consequently, the argument posits that delimitationanticipated to occur following the Census in 2026-would disadvantage the south for its commendable performance. In this insightful and evidence-based book, "Demography, Representation, Delimitation: The North-South Divide in India,", Ravi K. Mishra, scholar specializing in modern Indian history and Joint Director of the Prime Ministers Museum and Library, challenges this assumption. Mishra's book is a significant and timely contribution to the ongoing discussions surrounding political representation and the allocation of parliamentary seats in India. This work delves into the constitutional requirement for delimitation, which involves redrawing

the notion that the south has effectively controlled its population while the north has failed to do so, arguing that historical data does not support this claim. In fact, all regions of India have experienced significant population growth at

different times. Mishra provides a comprehensive overview of India's demographic history, highlighting how improvements in nutrition, sanitation, and healthcare led to lower mortality rates, followed by a decline in fertility rates,

ultimately resulting in population stabilization-a phenomenon observed worldwide. The book underscores that the timing of these demographic transitions has varied across regions, leading to current disparities in political representation. The ongoing freeze on the increase and redistribution of LokSabha seats has resulted in northern and western states being underrepresented, while southern states enjoy a relatively higher level of representation in Parliament.

Mishra advocates for an increase in the total number of LokSabha seats, suggesting an expansion from the current 543 to 728 or even 791 seats, to ensure that no state loses its representation. The book warns that merely reallocating seats based on outdated population data would not adequately address these disparities. Mishra offers practical recommendations for conducting delimitation once the current freeze concludes, highlighting the importance of honoring the dignity and rights of all regions. He also examines the political and constitutional obstacles to achieving "One Person, One Vote, One Value," while reconciling the interests of



## **CRUT** imposes stricter rules on driver recruitment following fatal bus accidents

Bhubaneswar, (DMC): In response to a series of fatal bus accidents, the Capital Region Urban Transport (CRUT) has announced a stringent overhaul of its driver recruitment and training policies. The move comes just days after a tragic incident at Khandagiri Square, where a pedestrian lost his life after being struck by a CRUT bus, sparking public outrage and vandalism of the vehicle. During a high-level meeting held on Friday, chaired by CRUT's Operations Director N. Thirumala Naik, senior officials expressed deep concern over the rising number of accidents involving the city's public transport buses. Over the past three months, more than five people have reportedly died in

similar incidents. To address the growing public dissatisfaction and ensure commuter safety, the agency has decided to reassess the driving skills of all existing drivers. A key resolution from the meeting includes a ban on the recruitment of drivers with less than five years of professional experience. Additionally, thirdparty agencies will no longer be permitted to appoint drivers arbitrarily. The meeting also emphasized the need to intensify driver training programs and enforce stricter operational protocols across the transport network. CRUT officials stated that the new measures aim to curb reckless driving and restore public trust in the city's transportation system.

He has been booked under Sections 13(2) read with 13(1)(b)/12 of the Prevention of Corruption Act (Amendment, 2018). Vigilance sources also confirmed that Sarangi's wife is under the scanner, with several assets reportedly registered in the names of family members.

LUCKNOW, (H.S): Chief Justice of India Justice B R Gavai on Saturday attributed the country's stability, unity, and strength during various crises to the Indian Constitution, asserting that it was the Constitution that saved India while neighbouring countries witnessed upheavals."Today we see what is the condition of our neighbouring countries. India is making a journey towards development after independence. Whenever there has been a crisis in the country, it has remained united and strong. The credit for this should be given to the Constitution," he said.

Justice Gavai was speaking at a function at the Allahabad High Court to mark the inauguration of a multi-storey complex housing 2,500 chambers for lawyers and a multi-level parking

The event was attended by top legal luminaries including Union Law Minister Arjun Ram Meghwal, Supreme Court judges, Chief Justice of the Allahabad High Court, Uttar Pradesh Chief Minister Yogi Adityanath, and senior state bureaucrats. The CJI said the Constitution, drafted by Dr B R Ambedkar, played a significant role in India's development and growth journey. "When the Constitution was being made and its final draft was presented before the Constituent Assembly, at that time, some people used to say that the



Constitution is too federal while some used to say that it is too unitary. Babasaheb Bhimrao Ambedkar had replied that the Constitution was neither wholly federal nor wholly unitary. But one thing I can tell you is that we have given a Constitution which will keep India united and strong both in times of peace and war," said the CJI. Reflecting on the 75-year journey of the Constitution, Justice Gavai noted that the legislature, executive, and judiciary had significantly contributed to achieving social and economic equality. Stressing the need to ensure justice for even the most marginalised, he said, "It is our fundamental duty to reach out to the last citizen who needs justice. Be it

the legislature, the executive or the judiciary, everyone should reach out to that citizen." Referring to the era of land reforms, Justice Gavai recalled how laws were brought under which land was taken from landlords and given to landless individuals. "These laws were challenged from time to time. Before 1973, the Supreme Court's view was that if there is a conflict between the Directive Principles and the Fundamental Rights, then the Fundamental Rights will prevail," he said.

He added, "In 1973, a decision of 13 judges came that the Parliament has the right to amend the Constitution and for this, it can amend the Fundamental Rights, but it does not have the right to change the basic structure of the Constitution." The Chief Justice of India further said the 13-judge bench had clarified that both the Fundamental Rights and the Directive Principles were the soul of the Constitution. "Both of these are the two wheels of the golden chariot of the Constitution. If you stop one of these wheels, the entire chariot will stop," he said. Underlining the importance of coordination between the Bar and the Bench, the CJI stated that they were "two sides of the same coin". "Unless the Bar and the Bench work in tandem, the chariot of justice cannot move forward," he remarked. He praised the Allahabad High Court for setting an example for the entire country, pointing out how judges had vacated 12 bungalows to facilitate the construction of the new complex for lawyers.

"Today the Allahabad High Court has given a good role model for the whole country in which the judges vacated 12 bungalows for the Bar (for the construction of the complex) and took care of the convenience of their lawyer brothers," he said. Later, in a lighter vein, the CJI referred to the Union Law Minister's speech, in which the minister called UP CM Yogi Adityanath the most powerful and diligent Chief Minister. "The land of Allahabad is that of powerful people. Obviously, Yogiji is powerful," said the CJI.

#### Flash floods and landslides kill 4 people in Mizoram

Aizawl, (H.S): Flash floods and multiple landslide incidents in Mizoram have killed four people in the last 24 hours, as per officials. As per reports of District Disaster Management Authority (DDMA)s of various districts of Mizoram, several landslides have taken place in Aizwal, Lunglei, Champhai,



Kolasib, Serchhip, Lawngtlai, Mamit, Saitual, Khawzawl and Hnahthial districts in last 24 hours causing damaged to several houses, roads, leaving people affected.

As per the DDMA reports, three people of a family died in the flash floods in Champhai district, while another died in Serchhip district. Meanwhile, another person has been trapped in debris, as per the district administration. Mizoram Governor General VK Singh, in a post on X, expressed grief at the death of the people. "I am deeply saddened by the tragic loss of lives and widespread damage caused by the recent heavy rainfall in Mizoram. My heartfelt condolences to the bereaved families and those who have lost their homes and properties. I pray for the speedy recovery of all the injured. As heavy rains persist, I urge everyone, especially those in disaster-prone areas, to remain vigilant and exercise utmost caution," the post read. Monitoring and relief operations are being carried out by the Disaster Management and Rehabilitation Department (DMDR) in areas of widespread damage. LUCKNOW, (H.S): Over 800 individuals, all contacts of Tufail Maqsood, 34, who was arrested by the Uttar Pradesh Anti-Terrorist Squad (ATS) from Varanasi on 21 May on charges of spying for Pakistan, are under the radar of the agency. All the 800 people were added to 19 WhatsApp groups operated by Tufail. Notably, UP ATS had arrested Tufail Maqsood from Varanasi, Mohammad Harun, 45, of Delhi, from Noida on 21 May, and Rampur resident Shahzad Wahab, 35, in the same connection from Moradabad on 18 May. All three are currently in ATS custody for interrogation. The details of all 800 contacts were retrieved from Tufail's phone. An ATS source claimed that Tufail had been operating 19 WhatsApp groups to stay in touch with his modules across seven eastern UP districts, including Varanasi, Jaunpur, Mau, Bhadohi, Mirzapur, Chandauli, and Ghazipur. He was allegedly involved in radicalising them in the name of religion by posting inflammatory speeches of clerics and terror group 'leaders' from across the border. Establishing his links to Gajwa-e-Hind, Tufail used to post content related to "establishing Muslim rule in India before 2047 and bringing Shariat law into force in the country".

# Tiger conservation pioneer Valmik Thapar dies at 73

NEW DELHI, (H.S): India on Saturday lost one of its most passionate and influential wildlife conservationists, Valmik Thapar, who passed away at the age of 73 after battling cancer. A towering figure in tiger conservation, Thapar dedicated more than four decades of his life to protecting India's wild tigers, particularly in Rajasthan's Ranthambore National Park, where he spent extensive time studying and documenting their lives. His deep understanding of tiger behavior and his advocacy played a crucial role in shaping public discourse and policy around wildlife conservation in India. In 1988, Thapar co-founded the Ranthambhore Foundation, a



pioneering NGO that worked on community-based conservation, aiming to bridge the gap between local communities and conservation effortsan approach that was ahead of its time.

Valmik Thapar came from a family deeply rooted in India's intellectual and journalistic tradition. His father, Romesh Thapar, was a noted political commentator, and his mother, Raj Thapar, founded the political journal Seminar. He was the nephew of eminent historian Romila Thapar and cousin of journalist Karan Thapar. Congress leader Jairam Ramesh termed his death a great loss. "Today's Ranthambore, particularly, is a testimony to his deep commitment and indefatigable zeal. He was uncommonly knowledgeable on a variety of issues relating to biodiversity, and not a day passed during my Ministerial tenure without our talking to each other.

# 'Lot of Space Before Nuclear Threshold Is Crossed': Top Military on Op Sindoor

India had launched Operation Sindoor precision strikes on terror bases in Pakistan and Pakistan -occupied Kashmir (PoK), after 26 tourists were shot dead at Pahalgam on April 22.



Speaking to Bloomberg TV on Saturday while atending the Shangri-La Dialogue in Singapore, Anil Chauhan called Pakistan's claims that it shot down six Indian warplanes as "absolutely

incorrect," though he declined to specify how many jets India lost. "Why they were down, what mistakes were made that are important," Chauhan said when asked about the fighter jets. "Numbers

The Bloomberg report recalled that earlier this month, Pakistani Prime Minister Shehbaz Sharif had said that his country shot down six Indian fighter jets, "an assertion", the report noted, "that hasn't been independently verified." "The good part is that we are able to understand the tactical mistake which we made, remedy it, rectify it, and then implement it again after two days and flew our jets again, targeting at long range," Chauhan said. # The Bar is too high but never above the law

New Delhi, (H.S): Ashish Khetan's recent critique of the Supreme Court Bar Association (SCBA) for accepting a Rs 50 crore donation from industrialists raises legitimate concerns about the integrity and independence of legal institutions. However, his argument, though well-intentioned, is based on a misunderstanding of the structure, functioning, and ethos of the Bar Association, and ultimately conflates institutional assistance with institutional compromise. To begin with, it is essential to distinguish between the SCBA and the Supreme Court itself. The SCBA is not a judicial body. It is a professional association comprising advocates who practice before the Supreme Court. Its functions include promoting legal education, providing welfare benefits to its members, and upholding professional standards. It is neither a regulatory body like the Bar Council nor a judicial body like the Supreme Court. Consequently, the decisions it takes to support its members, such as facilitating insurance through donations, do not impact the independence or impartiality of the judiciary.

Khetan's central concern is that by accepting donations from wealthy industrialists-"crumbs off the plate of the filthy rich"-the Bar Association may lose its moral footing or be beholden to such donors. This assumption oversimplifies the realities of funding in

society more broadly. Donations are a common and necessary practice to enable institutions-be they bar associations, universities, hospitals, or NGOs-to meet their objectives. Philanthropy, including corporate social responsibility (CSR) initiatives, is an accepted and encouraged practice under Indian law. Indeed, many industrial contributions to social causes are not only legally sanctioned but statutorily mandated. To equate such support with loss of independence is both speculative and unfair. SCBA office bearers, including Kapil Sibal, have been transparent about the nature of the donations. Sibal's candid acknowledgment that the donors are his personal friends, whom he has represented in court, does not suggest impropriety-it is merely an honest recognition of professional networks. Legal professionals often represent clients across a spectrum, including the government, corporations, NGOs, and individuals. The relationships formed therein do not, and should not, cast a shadow on their integrity or ability to act independently. Moreover, the independence of the Bar is not a function of its sources of funding. It is a function of the conduct, character, and courage of its members. The SCBA comprises advocates from diverse backgrounds and persuasions, who have time and again

demonstrated their willingness to critique governments, stand against executive overreach, and speak out against judicial failings. The presence of a donation does not dilute this spirit. If anything, it enables the Association to better serve its members-especially younger lawyers who benefit from health insurance and welfare measures funded through such generosity. It is important to stress that the SCBA is not a homogeneous or hierarchical body. It cannot be held collectively accountable for the personal ideologies of its individual members, just as a university cannot be judged solely on the views of its alumni. The SCBA has, in the past, vocally defended the independence of the judiciary, condemned assaults on legal norms, and mobilized collective opinion on matters of national importance. Its institutional memory and commitment to democratic values

remain intact. Khetan's article also

suggests that donations from business houses create a perception of guid pro quo. But perceptions must be grounded in fact. If there is evidence of favouritism or compromise, it must be brought to light and acted upon. Until then, insinuations serve only to tarnish without substantiating. In a legal system where integrity is paramount, such allegations require caution, especially when aimed at a collective. The Courts and judges are well trained to ensure that these externalities do not affect their decision. There is also a glaring contradiction in Khetan's stance: would the same critique apply if the donation had come from the government, which remains the largest litigant in the country? Would accepting government grants then imply that the Bar is compromised in its independence from state control? The logic of his critique, if consistently applied, would prohibit all forms of external funding-an unsustainable proposition.

As a constitutional lawyer and member of the SCBA, I can say with conviction for myself and almost for the whole bar that we are not beholden to any donor or industrialist, whether or not they have contributed to the SCBA. Our professional obligations, ethical commitments, and pledge to uphold the Constitution are not so fragile as to be swayed by financial patronage of this kind. The judiciary's challenges today lie elsewhere. They lie in the chronic shortage of judges, the staggering backlog of cases, and the lack of administrative reform. The disillusionment of the common litigant stems from the unaccountability of the executive, the inertia of the police machinery, and the government's delays in implementing court orders. To attribute these systemic issues to a donation received by a professional association is to misdirect public ire and distract from the real problems. Khetan's article, at best, serves as a cautionary note-a reminder that institutions must remain vigilant. On that, we agree. Transparency in accepting and disclosing donations is imperative. Bar associations must remain accountable to their members and to the public. But to suggest that they have already failed this test without evidence is premature and unfair. The Supreme Court Bar Association and its members have a serious culture of pro bono matters. I

can name at least half a dozen senior advocates whom I have instructed to appear in cases concerning bails, bulldozer action, students' expulsion, custodial violence, demolition and riots. This includes even the most senior lawyer like Dr. Abhishek Manu Singhvi, Kapil Sibal, Raju Ramachandran, Chander Uday Singh, Huzefa Ahmadi, Sanjay Hegde and Dr Guruswamy. There is disparity in remuneration amongst legal professionals. This is also because of the unwillingness of the client to remunerate the junior members. The problem of distribution of wealth in India is a problem that is not confined to the legal professional alone.

There are systemic changes that must be brought about - and the process of designation of 'senior advocates' being one of them. However, to conflate these with donations is pushing the limits of logic. The examples of conflict of interest, as mentioned by Khetan are simplistic and do not capture the nuances of professional ethics. A lawyer is engaged by a client, and just as a client may choose to not engage the same advocate for his next matter, a lawyer may also (subject to cab-rank rules) choose to decline the brief. The bar against appearing against a previous client is only when the appearance is marred by legal professional privilege or a relationship with the client. Khetan has mentioned too many subjects in one piece, like in quick-stand, fully reasoned none.

# At Least 26 Civilians Killed in Paramilitary Forces Attacks at Sudan



Khartoum, (HS): At least 26 civilians were killed in attacks by the paramilitary Rapid Support Forces (RSF) on three towns in Sudan's western Kordofan region, the Sudanese government announced. "In recent hours, the RSF militia has committed a series of horrific crimes, deliberately targeting civilian areas and claiming the lives of innocent people," Sudan's Foreign Ministry said in a statement.

"Today (Friday), the militia targeted Al-Daman Hospital in El-Obeid city, killing 16 patients who were receiving treatment and injuring several others," the ministry said, adding, "On Wednesday, the militia also attacked a public market in the town of Al-Khiwai with drones, killing eight civilians." The RSF also targeted a residential area in the town of Al-Dibaibat, South Kordofan, killing two civilians, the statement said. The ministry described the RSF attacks as part of a deliberate and systematic campaign targeting

#### Russian missile strike kills child and injures another

KYIV, (HS): A Russian missile hit a front-line region in Ukraine on Saturday, killing a child and injuring another, a Ukrainian official said as uncertainty remains as to whether Kyiv diplomats will attend a new round of peace talks proposed by Moscow for early next week in Istanbul. Russian troops launched some 109 drones and five missiles across Ukraine overnight and into Saturday, the Ukrainian air force said. Three of the missiles and 42 drones were destroyed by air defenses, while another 30 drones failed to reach their targets without causing damage, it said. A 9-old girl was killed in a strike on the front-line village of Dolynka in the Zaporizhzhia region, and a 16-year-old was injured, Zaporizhzhia's Gov. Ivan Fedorov said. "One house was destroyed. The shockwave from the blast also damaged several other houses, cars, and outbuildings," Fedorov wrote on Telegram. Moscow did not comment on the latest attack. Meanwhile, 14 people were injured after Ukrainian drones struck apartment buildings on Saturday in the Russian town of Rylsk and the village of Artakovo in the western Kursk region, local acting Gov. Alexander Khinshtein said.

Four children were among those injured in the two attacks, which also sparked several fires, he said. On Friday, Andrii Yermak, a top adviser to Ukraine's president said Kyiv was ready to resume direct peace talks with Russia in Istanbul on Monday but that the Kremlin should provide a promised memorandum setting out its position on ending the more than three-year war, before the two delegations sit down to negotiate. Speaking late Friday,

civilians, humanitarian organizations, critical infrastructure, and essential services, with the intent of inflicting maximum civilian harm, Xinhua news agency reported. It accused the RSF of bombing World Food Programme warehouses in El-Fasher, the capital of North Darfur State, on Thursday and setting them ablaze, destroying large quantities of food supplies. Armed clashes between the Sudanese Armed Forces (SAF) and the RSF have intensified across the Kordofan region, which includes North, West, and South Kordofan states.

On Thursday, the RSF claimed control of the towns of Al-Dibaibat in South Kordofan and Al-Khiwai in West Kordofan. The Sudanese army has not yet responded to the claim. Sudan has been engulfed in a brutal conflict between the SAF and the RSF since April 2023. The war has killed tens of thousands and forced millions to flee their homes, both within Sudan and across its borders.

**ABUJA**, (**HS**): The death toll from devastating flooding in a market town in Nigeria's north-central state of Niger rose to at least 151 on Saturday, the local emergency service said, amid efforts to find more victims.

Torrents of predawn rainfall early Thursday unleashed the devastating flood on Mokwa, nearly 380 kilometers (236 miles) west of Abuja and a major trading and transportation hub where northern Nigerian farmers sell beans, onions and other food to traders from the south. The spokesperson for the Niger State emergency service, Ibrahim Audu Husseini, confirmed the updated

fatality count to The Associated Press on Saturday. In addition to the rising death toll, 11 people were injured and more than 3,000 people were displaced, the official added. At least 500 households across three communities were affected by the sudden and intense

hours, leaving roofs barely visible and surviving residents waist-deep in water, trying to salvage what they could and rescue others. Husseini added that two roads were washed away and two bridges collapsed. In a statement on Friday night, President Bola Tinubu expressed condolences and said he had directed the activation of an emergency response to support victims and "accelerate" recovery. He said that security agencies have also been asked to assist in

emergency operations, which remain

underway amid concerns that more bodies could be recovered in remote areas. Communities in northern Nigeria have been experiencing prolonged dry spells worsened by climate change and excessive rainfall that leads to severe flooding during the brief wet season.

# Trump Administration Orders "Extra Vetting" for Anyone Travelling to Harvard

Washington, (HS): Those looking to travel to Harvard University "for any purpose" will go through more extensive vetting. The State Department on Friday has instructed all US embassies and consulates to do the same starting "immediately", per Reuters. Such applicants include but are not limited to prospective students, students, faculty, employees, contractors, guest speakers, and tourists, the cable said. The word 'any" in the cable text is written in bold format and underlined. After the Trump administration tried to ban the Ivy League university from enrolling foreign students, a judge halted the ban. The State Department has said that the vetting measures are being taken to ensure "consular officers can appropriately identify" visa applicants with "histories of anti-Semitic harassment and violence, and to duly consider the visa eligibility under U.S. immigration law," CNN stated in a report citing a diplomatic cable signed by Secretary of State Marco Rubio.

Per the cable, dated May 30th, if an individual seeks to work at, attend or otherwise visit to Harvard, in the prescreening or interviewing process, consular offices have been instructed to refuse the visa "pending review of



their online presence" - which would essentially mean screening of their online presence, including social media. "As in all instances in which an applicant fails to provide certain information on request, consular officers should consider whether the lack of any online presence, or having social media accounts restricted to 'private' or with limited visibility, may be reflective of evasiveness and call into question the applicant's credibility," the cable reportedly said. "If you are not personally and completely satisfied that the applicant, during his time in the United States, will engage in activities consistent with his nonimmigrant visa status, you should refuse the visa...," the cable said.Rubio said recently that he has personally revoked the visas of hundreds, perhaps thousands of people, which include students, since they got involved in activities that go against US foreign

policy.

"If you're coming here to create problems, you're probably going to have a problem," Rubio told reporters on April 7. "We're not going to continue to be stupid enough to let people into our country who are coming here to

#### CPM MP John Brittas cites Salman Khurshid to highlight, slams Pakistan army chief in Jakarta

Jakarta, (HS): Communist Party of India (Marxist) MP John Brittas delivered a strongly worded address in Jakarta, Indonesia, on Friday, where he criticized Pakistan Army Chief General Asim Munir for remarks allegedly suggesting fundamental differences between Hindus and Muslims. Speaking to the Indian diaspora as part of an allparty delegation, Brittas used the platform to underscore India's pluralistic and secular ethos.



Referring to Munir's reported comments, Brittas asked:"Can you ever vouch for that? And Salman Khurshid is here... We are all together. I am from Kerala... I am a Christian. In Kerala, we have three major religions. We coexist in harmony. That is the message of India."Brittas highlighted Kerala's communal harmony as an example of India's inclusive character, contrasting it with Pakistan's record. He went on to reference a past interview with Pakistan's Defence Minister Khawaja Asif, in which Asif allegedly admitted that Pakistan had long supported and harbored terrorist organizations:"Pakistan has been asking for evidence. Khawaja Asif, the defence minister of Pakistan, had said in an interview that they have been indulging in this dirty job of nurturing and harbouring terrorist organisations for three decades..." The remarks signal a pointed critique not just of General Munir, but also of Pakistan's long-standing policies, while simultaneously promoting India's image as a country rooted in religious harmony and democratic values.

# Hungry Palestinians in Gaza block and offload dozens of UN food trucks

TEL AVIV, (HS): Palestinians in the Gaza Strip blocked and offloaded dozens of food trucks, the UN World Food Program said Saturday, as desperation mounts following Israel's monthslong blockade and airstrikes while talks of a ceasefire inch forward. The WFP said that 77 trucks carrying aid, mostly flour, were stopped by hungry people who took the food before the trucks were able to reach their destination.

A nearly three-month Israeli blockade on Gaza has pushed the population to the brink of famine. While the pressure slightly eased in recent days as Israel allowed some aid to enter, organizations say there still isn't nearly enough food getting in. Hamas on Friday said it was reviewing a US proposal for a temporary ceasefire. US President Donald Trump said that negotiators were nearing a deal. A ceasefire would pause the fighting for 60 days, release some of the 58 hostages still held in Gaza in exchange for Palestinian prisoners and much needed food aid and other



assistance, according to Hamas and Egyptian officials who spoke on condition of anonymity because they were not authorized to talk to the media. The WFP said the fear of starvation in Gaza is high despite the food aid that's entering now. "We need to flood communities with food for the next few days to calm anxieties and rebuild the trust with communities that more food is coming," said agency said in a statement. A witness in the southern

city of Khan Younis told The Associated Press the UN convoy was stopped at a makeshift roadblock and offloaded by desperate civilians in their thousands. Most people carried bags of flour on their backs or heads. He said at one point a forklift was used to offload pallets from the stranded trucks. The witness spoke on condition of anonymity because of fear of reprisal. The United Nations said earlier this month that Israeli authorities have forced them to

use unsecured routes within areas controlled by the Israeli military in the eastern areas of Rafah and Khan Younis, where armed gangs are active and trucks were stopped. Israel's military didn't immediately respond to comment.

Attacks, lack of protection hamper

UN distribution: An internal document shared with aid groups about security incidents, seen by the AP, said there were four incidents of facilities being looted in three days at the end of May, not including the convoy on Saturday. The UN says it's been unable to get enough aid in because of fighting. On Friday, UN spokesperson Stephane Dujarric said it only picked up five truckloads of cargo from the Palestinian side of the Kerem Shalom crossing, and the other 60 trucks had to return due to intense hostilities in the area. An Israeli official said his country has offered the UN logistical and operational support but "the UN is not doing their job." Instead, a new US- and Israeli-backed foundation started operations in Gaza this week, distributing food at several sites in a chaotic rollout. Israel says the Gaza Humanitarian Foundation will replace the massive aid operation that the UN and others have carried out throughout the war. It says the new mechanism is necessary, accusing Hamas of siphoning off large amounts of aid. The UN denies that significant diversion takes place. The GHF works with armed contractors, which is says is needed to distribute food safely. Aid groups have accused the foundation of militarizing aid.

Israeli strikes kill at least 60:
Meanwhile Israel is continuing its military campaign across Gaza. The Gaza Health Ministry said that at least 60 people were killed by Israeli strikes in the last 24 hours. It said three people were shot by Israeli gunfire early Saturday morning in the southern city of Rafah. Three other people were killed, parents and a child, when their car was struck in Gaza City. Israeli strikes have killed more than 54,000 Gaza residents, mostly women and children, according to the Gaza Health Ministry.

# Afghanistan welcomes upgraded diplomatic ties with Pakistan

KABUL, (HS): Afghanistan has welcomed the decision to upgrade diplomatic relations with Pakistan, where the Taliban government's foreign minister is due to travel in the coming days, his office said on Saturday. The move signals easing tensions between the neighbouring countries, as relations between the Taliban authorities and Pakistan -already rocky -- have cooled in recent months, fuelled by security concerns and a campaign by Islamabad to expel tens of thousands of Afghans. Pakistan's top diplomat on Friday said the charge d'affaires stationed in Kabul would be elevated to the rank of ambassador, with Kabul later announcing its representative in Islamabad would also be upgraded."This elevation in diplomatic representation between Afghanistan & Pakistan paves the way for enhanced bilateral cooperation in multiple domains," the Aghan foreign ministry said on X. Kabul's Foreign Minister Amir Khan Muttaqi is due to visit Pakistan "in the coming days", ministry spokesman Zia Ahmad Takal told.

# OPEC+ to hike July oil production after Trump urges Saudi to increase output



VIENNA, (HS): Saudi Arabia, Russia and six other key OPEC+ members announced on Saturday a huge increase in crude production for July. They will produce an additional 411,000 barrels a day -- the same target set for May and then June -- according to a statement, which is more than three times greater than the group had previously planned. In recent years the 22-nation group had agreed to daily reductions of 2.2 million barrels with the aim of boosting prices. But in early 2025, leading members of the group known as the "Voluntary Eight", or V8, decided on the gradual output increase and subsequently began to accelerate the pace. The moves have resulted in oil prices plummeting to around \$60 per barrel, the lowest level in four years.

Trump pressure: OPEC+ "struck three times: (the output target for) May was a warning, June a confirmation and July a warning shot", Rystad Energy analyst Jorge Leon told AFP. "The scale of the production increase reflects more than just internal supply dynamics," he

said. "This is a strategic adjustment with geopolitical aims: Saudi Arabia seems to be bowing to Donald Trump's requests." Shortly after taking office, the US president called on Riyadh to ramp up production in order to bring down oil prices, meaning cheaper prices at the pump for American consumers. Saturday's decision comes after a meeting of all OPEC ministers on Wednesday, where the alliance's collective production policy was reaffirmed. The decision is officially justified by "healthy market fundamentals" covering oil reserves and structural demand growth during

coming months. Riyadh 'angry': But markets have met this view with scepticism amid concerns about demand and a trade war launched by the United States. Analysts see several possible motivations for the production hikes, one of them being Saudi Arabia and others penalising members for not keeping to their quotas under the cuts first agreed in 2022. The increase is all the more likely due to "the latest statements of Kazakh Energy

Minister Yerlan Akkenzhenov, who has apparently already informed OPEC that his country will not reduce production," said Thu Lan Nguyen, an analyst at Commerzbank. "Saudi Arabia is angry with Kazakhstan", which is seen as one of the main laggards, and which "produced 300,000 barrels per day more than its quota," said Bjarne Schieldrop,

an analyst at SEB. Analysts meanwhile do not foresee a plunge in oil prices when markets open Monday as the announcement was largely anticipated, instead resulting in a "moderate" reaction. On Friday, the benchmark Brent crude futures price had settled at \$62.61 per barrel, while West Texas Intermediate was at \$60.79.

### 'Doubling tariff on steel, aluminium by US to impact Indian exporters'



New Delhi, (HS): US President Donald Trump's announcement to double tariffs on imported steel and aluminium will impact Indian exporters, as it would hurt their profitability, think tank GTRI said on Saturday. On May 30, Trump announced that he would double the existing 25 per cent tariffs on steel and aluminium imports from June 4. This

hike comes under Section 232 of the US Trade Expansion Act of 1962, a law that allows the president to impose tariffs or other trade restrictions if imports are deemed a threat to national security. Trump originally invoked this provision in 2018 to set the 25 per cent tariff on steel and 10 per cent on aluminium. He raised tariffs on aluminium to 25 per cent in February 2025.

For India, the consequences are direct, the Global Trade Research Initiative (GTRI) said. In 2024-25, India exported USD 4.56 billion worth of iron, steel, and aluminium products to the US, with key categories, including USD 587.5 million in iron and steel, USD 3.1 billion in articles of iron or steel, and USD 860 million in aluminium and related articles. "These exports are now exposed to sharply higher US tariffs, threatening the profitability of Indian producers and exporters," GTRI founder Ajay Srivastava said. India has already issued a formal notice at the World Trade Organisation (WTO) signalling its intention to impose retaliatory tariffs on US goods in response to the earlier steel tariffs. "With Trump now doubling the tariffs, it remains to be seen whether India will carry out the retaliation by increasing tariffs on certain US exports within a month," he said.

# **Indian economy poised to remain** fastest-growing one in FY26: SBI



New Delhi, (HS): The Indian economy is poised to remain the fastest-growing major economy in FY26 by leveraging its sound macroeconomic fundamentals, robust financial sector and commitment towards sustainable growth, according to a State Bank of India (SBI) report. With higher anticipated saving based on latest RBI annual report, the domestic finances will be sufficient to finance the anticipated growth and "we do not expect demand induced pressure on prices in FY26," said Dr Soumya Kanti Ghosh, Group Chief Economic Adviser, SBI

The downside to growth emanate from external and geopolitical factors, Ghosh added. From the expenditure side, the GDP growth of 7.4 per cent in Q4 was supported by strong uptick in the capital formation which registered a 9.4 per cent annual growth. The recovery in capital formation was on account of revival in core sector in Q4 as evident from high frequency indicators. The overall growth in capital formation for FY25 now stands 7.1 per cent. India's economy grew by 7.4 per cent in Q4 FY25 as against 8.4 per cent growth in same quarter last fiscal. Riding on Q4 numbers, the annual FY25 growth is estimated at 6.5 per cent. Almost all sectors exhibited better growth numbers in Q4 FY25. While industry grew by 6.5 per cent, the services sector grew by 7.3 per cent in Q4. Within industry during Q4, construction sector grew by whopping 10.8 per cent (6-quarters high) and manufacturing sector increased by 4.8 per cent. The private consumption maintained its health run in Q4 although there was sequential slow rate of growth in Q4. Overall, the private consumption registered a growth of 7.2 per cent for FY25.

The export demand was healthy for whole year, registering a growth of 6.3 per cent, while the imports contracted for the whole year by 3.7 per cent. According to the SBI report, this growth was front-loaded because of export push amidst US tariffs uncertainty. The highest contraction in imports happened in Q4 at 12.7 per cent was another factor in pulling the overall GDP growth to 7.2 per cent in Q4.

## **Providing Service to Taxpayers Duty of Tax Officials: Sitharaman**



New Delhi, (HS): Union Minister Nirmala Sitharaman on Saturday highlighted that it was the duty of tax department officials to serve taxpayers and they should undertake this task with "transparency and integrity." "To provide service to the taxpayer is our duty. While so serving the taxpayers, transparency and integrity are crucial in earning their trust and confidence. Confident that the Board and the field formations will remain sensitive and responsive," the Finance Minister said in a statement on X social media

platform. Her statement was made in response to a detailed explanation provided by the Central Board of Indirect Taxes and Customs (CBIC) in case of a business entity that had applied for a GST registration. The applicant had complained of a delay in processing the application. However, the CBIC had furnished details to show that the case was pending as the taxpayer had failed to furnish a reply on a specific query regarding the designation of a person who had signed on behalf of the company. Referring to the fact of the case of Vinod Gupta who wrote about GST registration issue on LinkedIn, CBIC said on X: The application was filed this week on 26th May (Monday) which was assigned to Delhi State GST. The Central GST authorities had no role in this matter.

"As per Delhi State GST authorities, the case was processed immediately and a query was raised about the missing designation of the person who has signed the Rent Agreement on behalf of the Company. At this stage the ARN was pending for reply from the taxpayer's side and it was duly informed to the taxpayer," the statement said. The application will be processed by the Delhi GST authorities upon receipt of the pending information, the statement explained. CBIC has also requested the applicant to not circulate wrong information on the social media without knowing the facts.

# Oil, Gas in India Jumped 76 Pc in Last 10 Years

New Delhi, (HS): As much as 76 per cent of the total area in India's sedimentary basin currently being explored for oil and gas has come under active exploration since 2014, Minister of Petroleum and Natural Gas Hardeep Singh Puri has said.

Addressing the CII annual business summit here, the minister said that in the last decade the Government has succeeded in increasing the explored area for oil and gas in India's sedimentary basin from 6 per cent to 10 per cent which would soon reach 15 per cent. "We intend to increase India's oil and gas exploration acreage to 1 million sq km by 2030," he said. The minister further stated that India's rapidly expanding energy economy was in a robust state under the leadership of PM Modi. He pointed out that energy security was now a strategic necessity for India in a volatile global energy landscape being shaped by geopolitical realignments, conflicts, and climate commitments. "The size and magnitude of India's energy sector can be gauged by the fact that in 2024-25, India imported around 242.4 million tonnes of crude oil and spent \$137 billion on the imports, while increasing the number of countries we import

# RBI's monetary policy decision, global trade negotiations to guide markets next week

Mumbai, (HS): Investors will keenly watch the Reserve Bank of India's (RBI) upcoming monetary policy decision for future market guidance. Additionally, market participants will monitor global developments, particularly trade tensions, to navigate the ongoing consolidation phase. India's equity market closed in the red this week. The subdued performance was primarily driven by global trade tensions and anticipation around domestic policy decisions.

Benchmark indices, the Sensex and Nifty, experienced significant swings before closing lower amid uncertainty over U.S. tariff developments and caution ahead of the RBI's policy announcement. Both indices declined over 1%, with the Nifty ending at 24,750.70 and the Sensex at 81,451.01. "Despite encouraging domestic cues, mixed signals from global markets kept investor sentiment on edge. Initially, optimism prevailed following the RBI's record dividend payout and positive updates regarding the monsoon. However, as the week progressed, concerns surrounding rising U.S. bond yields, trade tensions



between the U.S. and the European Union, and the ongoing legal battle over U.S. tariffs weighed on market sentiment, limiting the scope for any meaningful recovery," said Ajit Mishra - SVP, Research, Religare Broking. He added that looking ahead, all eyes will be on the outcome of the RBI's Monetary Policy Committee (MPC) meeting scheduled for June 6. The market is pricing in a 25bps cut, which will improve the outlook for ratesensitive sectors. "The central bank's stance on the rate trajectory, especially amid mixed macroeconomic

signals, will be critical in shaping direction...Globally, developments in the U.S. bond market and any updates regarding ongoing trade negotiations will continue to influence investor sentiment," stated Mishra.

Puneet Singhania, Director at Master Trust Group, said that despite the weekly downturn, both benchmark indices remained comfortably above their key moving averages, signaling resilience in the broader market trend. The PSU Bank index led sectoral performance, surging nearly 4%, buoyed by positive sentiment towards public sector banks.

Vinay Pathak's Balai is a standout character - paternal toward Shanu and Bua, treating them no differently than his own daughter.

# Nair's Stellar 204 Anchors India A's Mammoth 557 Vs England Lions

Canterbury, (HS): Karun Nair's (204) double century, alongside almost-hundreds by Sarfaraz Khan (92) and Dhruv Jurel (94), helped India A set a massive total of 557 in the first innings against England Lions on Day 2 of the unofficial Test at the St Lawrence Ground here on Saturday. For the bowling side, Josh Hull and Zaman Akhter claimed three wickets each. Earlier on day one, India 'A' captain Abhimanyu Easwaran (8) was trapped plumb by left-arm fast bowler Josh Hull. Shortly after, Yashasvi Jaiswal (24) was also on his way to the pavilion while attempting to hoick across the line and was caught behind on the bowling of Eddie Jack.

But from there, India took the fight to the inexperienced English bowlers. Nair took his time to adjust to the conditions and the seaming Duke's ball before showcasing brilliant shots on both sides of the wicket. Nair shared a 181-run third-wicket



partnership with Sarfaraz, who was comfortable in hitting 92 off 119 balls. He also shared a 195run partnership with vicecaptain Dhruv Jurel, who hit 94 off 120 balls, before the wicketkeeper batter fell to pacer Ajeet Singh Dale on day two on Saturday. Nitish Kumar Reddy (5) failed to make an impact as he nicked a short delivery while trying to drive it through off and was Jack's second wicket of the innings. Nair, who resumed from 186 not out, swivel-pulled Eddie Jack through the leg-side to bring up his fourth First-Class double century, which is also his first 200-plus score for India 'A'. It was his fourth double-century in First-Class cricket. He departed soon after as his inside edge, off Zaman Akhter, clipped the ball, and James Rew made no mistake in latching onto it.

# Case filed against Malayalam actor Unni Mukundan over alleged assault on former manager



Mukundan has been booked in a case of alleged assault and verbal abuse following a complaint filed by his former manager, Vipin Kumar. The incident reportedly took place on May 26, with an FIR registered under relevant sections of the Bharatiya Nyaya Sanhita (BNS). Vipin Kumar, who served as Mukundan's manager for six years, alleged that the actor physically attacked him during a meeting in the basement of Mukundan's apartment complex in Kochi. According to Kumar's statement,

the meeting was initiated by Mukundan himself. "I worked as the manager of Unni Mukundan for six years. I filed a case against him on May 26 because he physically assaulted me, verbally abused me, and even issued a life threat," said Vipin Kumar, while speaking.

"He called me to meet that morning. When I arrived, he yelled at me, punched and hit me. Another person had to intervene and stop him," he added. The alleged altercation is said to have stemmed from Mukundan's frustration following the release of his recent film 'Marco', which, according to Kumar, did not receive the attention the actor had expected from top filmmakers in the industry. "After the movie Marco, he was visibly upset that no leading directors were approaching him. He seemed to vent that frustration on me," Kumar added. The complaint mentions that Mukundan not only confronted Kumar at his residence but also used foul language and slapped him in the parking area. Meanwhile, Unni Mukundan also counter filed a

report against Vipin with the DGP. This development follows closely on the heels of Unni Mukundan's resignation as the Treasurer of the Association of Malayalam Movie Artists (AMMA) earlier this year. In a public statement released on January 14 through Instagram, Mukundan cited mental health concerns and increasing professional workload as reasons for stepping down. "After much thought and reflection, I have made the difficult decision to step down from my role as the Treasurer of Mukundan wrote. "My current projects, particularly Marco, have placed significant demands on my time and affected my mental health," he added. Mukundan assured that he would continue in his position until a new treasurer is appointed, to ensure a smooth handover.

His resignation came at a time when AMMA itself was under scrutiny following the mass resignation of its 17-member executive committee, including president Mohanlal, in August 2024.


