Puri: Devotees have started arriving in Odisha's pilgrim town of Puri, which is readying for Debasnana Purnima of the Lords of Shree Jagannath Temple on Wednesday. The ceremonial 'Pahandi' ritual of the sibling deities will begin at around 5 am. Debasnan Purnima is a key festival in the run-up to Rath Yatra. On this day, Lord Jagannath, Balabhadra and Devi Subhadra along with the idol of Lord Sudarshan are escorted from the sanctum sanctorum of the 12th-century shrine to Snana Mandap (bathing altar) in a 'Pahandi (procession).

Bhubaneswar, (DMC) : Senior IPS officer UtkalRanjanSahoo has been appointed as the new Chairman of the Rajasthan Public Service Commission (RPSC). The official notification was issued by Rajasthan Governor HaribhauBagde on Monday. With Sahoo's appointment, the post of Director General of Police (DGP) in Rajasthan has fallen vacant. A new police chief is expected to be named shortly. A 1988-batch IPS officer from Chendipada in Odisha's Angul district, Sahoo is widely regarded for his and integrity clean administrative record. He assumed charge as Rajasthan's DGP on February 11, 2024, and now moves to his new role as the head of the state's top recruiting body. The RPSC had been functioning without a fulltime chairman since August 1, 2024, following the completion of Sanjay Shrotriya's tenure. In the interim, commission member KailashchandMeena had been serving as acting chairman. Sahoo's appointment ends a 10-month-long vacancy at the helm of the RPSC. As per regulations, the chairman can serve until the age of 62. Born on June 20, 1964, Sahoo is currently 61 and is expected to serve until June 2026.

As the NarendraModi-led central government completes 11 years in office, it marks the milestone with a renewed focus on governance and national development, said Odisha Chief Minister Mohan Majhi on Tuesday.

Addressing the media in Bhubaneswar ahead of the completion of one year of BJP government in Odisha, Chief Minister Mohan Majhi acknowledged this moment as historic for India, noting how May 26, 2014-the day NarendraModi first took oath as Prime Minister-has now become a milestone etched in golden letters in Indian political history. Kathmandu: Climate experts have set alarm bells ringing after the recent capture of venomous snakes - including King Cobras close to Mt Everest in Nepal. The experts say that the discovery of these snakes at such a cold and dry location, could mean that temperatures are rising at a much higher rate than anticipated. Over the last month, ten venomous snakes - including nine King Cobras - were found in and around Kathmandu in Nepal. The other snake caught was a Monocled Cobra. All were later released in remote, densely forested areas.

OJEE-2025 results announced Terror chose dharma, we saw their karma: Rajnath

Dehradun, (HS): While the terrorists chose to verify the 'Dharm', or religion, of people before shooting them dead, India hit them back for their 'Karm', or deeds, defence minister Rajnath Singh said at an event in Dehradun on Tuesday. "Terrorists killed people in Pahalgam after verifying their religion; we didn't ask about their 'Dharm', but hit back because of their 'Karm'," Singh said in what was a strong message against those who want to propagate the theory that India's fight against terrorism is related to religion. His statement was in reference to the terror attack in Pahalgam, Jammu and Kashmir, on April 22 that led to the death of 26



persons, mostly tourists from across the country. Survivors recounted how the terrorists actually verified religious identities before shooting non-Muslims men in the head from close range. Footage from the scene of the massacre also showed several victims lying dead with the trousers pulled down. It came to light that the terrorists forced their victims to undress to check if they were circumcised, before killing them. This behaviour led to massive outrage. India reacted to the terror strike after a fortnight, by carrying out precision strikes against nine established terror facilities in Pakistan and Pakistanoccupied Jammu and Kashmir (PoJK) on May 7.

Bhubaneswar, (DMC) : The results of the Odisha Joint Entrance Examination (OJEE-2025) were officially announced today by Sampad Chandra Swain, Minister of Skill Development and Technical Education. Poverty Data

Poverty and inequality estimation in India have been subjects of considerable debate, especially in recent years with the economy experiencing several shocks. The great India poverty debate has, in fact, been marked by significant differences of opinion on the household survey data which forms the basis of estimation, the construction of the poverty lines, and on the trends over the decades. The debate has been particularly heated in the absence of data - the government did not release the consumption expenditure survey data for 2017-18 due to "data quality issues". This led to several studies trying to estimate poverty levels in India by drawing on alternate data sources such as the Periodic Labour Force Surveys and the CMIE data. Recently, the government has attempted to fill the data gap by conducting two rounds of household consumption expenditure surveys for 2022-23 and 2023-24. These surveys now allow for an examination of the trends in poverty over the past decade or so. The decline has been significant.Extreme poverty in India is estimated to have declined from 27.1 per cent in 2011-12 to 5.3 per cent in 2022-23 as per the latest World Bank data reported in this paper. This steep decline has occurred even as the Bank has raised the threshold for measuring extreme poverty to \$3 a day from \$2.15 earlier. To put these figures in perspective - the number of people living in extreme poverty in India fell from 344.47 million to 75.24 million over this period. While there has been some concern over the comparability of the consumption expenditure surveys carried out in 2011-12 and 2022-23 due to changes in the manner in which the recent survey was carried out and its sampling design, this is a steep decline. Moreover, even considering the poverty line for lower-middle income countries of \$4.2 per day (revised upwards from \$3.65), the poverty ratio in India fell from 57.7 per cent in 2011-12 to 23.9 per cent in 2022-23. The decline appears to have continued in the year thereafter. Earlier, Niti Aayog had estimated that multidimensional poverty in India had also registered a steep decline - falling from 55.34 per cent in 2005-06 to 24.85 per cent in 2015-16 to 14.96 per cent in 2019-21. This estimate of poverty was based on 12 indicators and drew on data from the National Family Healthy Surveys.

Alongside these poverty estimates, the World Bank has also estimated that inequality in India, based on measures such as the Gini and Theil indices, did fall between 2011 and 2022. However, these estimates of inequality are based on the household consumption expenditure data, which typically tends to be lower than estimates based on household income. This is not just an academic exercise. The data from the latest rounds of the consumption expenditure surveys as well as the labour force surveys must serve as a valuable input for policy, informing the choices of policymakers.

As the news of attack on various airfields of Pakistan was trickling in, people to their surprise, found on their TV screen in the afternoon of May 10, 2025 that a ceasefire has been agreed between India and Pakistan. Later it was revealed that Pakistan begged for a ceasefire as there was severe damage to its airfields. Analysts in Pakistan had warned it that its precarious financial conditions would not allow the state to hold on to a prolonged war with India. Pakistan became independent

along with India in 1947. Pakistan has a nominal GDP of about USD 374 bn in 2024 with a per capita GDP of USD 1572. The GDP growth rate has been low and in 2019-20 and 2022-23 it had negative growth rates. It had been running high fiscal deficit for several years mainly due to high spending on defence which is growing at a rate of 12% per annum. The foreign exchange reserves of Pakistan remains at a very low level of USD 9-10 billion which is just enough for 1.5 months of imports and its external debt is quite high at USD 122 bn which is equal to three times the annual exports. Their annual external debt servicing liability in 2024 remained at USD 17-18 bn which is more than their forex reserve balance. This means they have to borrow

to repay and service the external debt. It has been borrowing from several Islamic countries in addition to IMF and World Bank to meet its debt payment obligations. The inflation rate in 2023 was about 30% which came down slightly in 2024, but went up to 30% again in 2025 after Operation Sindoor. Pakistan Rupee has experienced significant depreciation against the US dollar, making imports more expensive and contributing to inflationary pressures. Pak Rupee has depreciated from a level of 180 to 280 per dollar in three years. It is reported in the media that most of the beggars in Gulf countries are from Pakistan.

Pakistan's rulers have taken an anti India stance right from the beginning which made it to spend higher amounts on defence and keep the border tension alive to divert attention of people from its real issues like poverty and inflation. It was under military rule from 1958 to 1971 which made the defence establishments an important part of Pakistan's politics. Over time, though the country has been switching on and off between military rule and democracy (Ayub Khan Military rule from 1958 to 1969, Yahya Khan military rule from 1969-71, Zia Ul Haq from 1978-88 and Pervez Musarraf 1999-2008), the military heads have the upper hand in decision making and democratically elected rulers have been subservient to the military as they feel that they owe their chair to the military. That also is apparently correct as five prime ministers of Pakistan have faced imprisonment after their term in office; one prime minister was hanged and another was killed during an election campaign. In 1980s its economy fared well with good agricultural output, workers remittances and US support. But 1990s are considered a lost decade

due to frequent political changes

and lack of continuity in policies. Corruption remained rampant and in 1996 Pakistan was adjudged the second most corrupt nation in the world. It was extracting grant from USA to support terrorist outfits to counter Russia in Afghanistan but using a large part of that money to fund terrorism and create trouble

in India. These terrorist organisations continued to thrive even after Russia left Afghanistan with support from the Pakistan government. The influence of terrorists on government is so much that in the recently conducted Operation Sindoor, after several terror headquarters and camps were destroyed by India, Pakistani Government officials were seen attending the funeral ceremonies of terrorists. Further. the Government also announced monetary grant to rebuild the terrorist infrastructure and payment of compensation to the families of the terrorists. The literacy rate is low at 58 % which is one of the lowest in Asia. Even out of its literate people, the predominant madrassa style of education prepares their students to work in religious institutions. These people are unskilled and not suitable for working in normal economic establishments. A

number of people work in gulf areas in low pay menial jobs which keeps workers remittance at a relatively low level. Lack of skilled manpower affected its productivity. Employment in Government was hardly merit based. Low literacy rate, low skills combined with their unemployability made the youth vulnerable to joining terrorist outfits. It has been heavily relying on diesel/gas for power generation and has been facing power shortage for a long time. This was unfavourable for industrial activity which was one of the reasons for lower FDI inflow, high unemployment rate, lower tax collection and as per recent World Bank report about 45% of population live below poverty line earning less than \$3 per month. Low savings rate of 15% resulting in low domestic capital formation forces it to rely on foreign capital for investment in the country. The uncertain political situation, high security concern and a poor legal system has kept foreign investors away. It has a low tax base and its poor regulatory regime and enforcement of tax laws have added to the woes. The overall national debt of Pakistan has been

doubling every five years since

1999. The debt has been growing

at a rate of 15% while the GDP is growing at 3-4% making the debt unsustainable.

In the recent days, Pakistan is heavily reliant on China for all its needs. China built a number of roads, a port and an airport at Gwador. But these are hardly used due to the uprising in Balochistan. But Pakistan has to service the loans taken from china for building these unproductive infrastructure. China has a track record of taking over ports and airports if the debtor country fails to repay its debt to China. Now that Pakistan is in deep debt and Gwador port is under the risk of being taken over by Balochistan Liberation Army, China is keeping a tight hand on further loan grant to Pakistan. Within the country, there is political instability. The Baochistan Liberation Army has been fighting for independence and since Balochistan region is a mineral rich country, Pakistan will be much poorer without Balochistan. Media reports indicate that Pakistan Government has no control over almost 75 -80% of Balochistan. The situation is so bad that China is proposing to negotiate with the Balochistan Liberation Army to protect its interest in the area. Another region called Khyber Pakhtunkhwa is also partially out of control due to heavy presence of TTP, an arm of Taliban in Pakistan which is Government attacking establishments and army. The POK area is also in turmoil as they are protesting against step motherly treatment by the Pakistan Government. Without Balochistan and Khyber Paktunkhwa, Pakistan's landmass will be reduced to 50% of its present size and it will be deprived of its natural resources and production of dry fruits. But a failed state with nuclear arms in one hand and lack of control on its territory is always a big risk to its neighbours.

On Ananda or Bliss

We have heard the word "Ananda" several times and in fact use it on many occasions. We are so familiar with this word that we fail to realize its true significance! We take the word and its meaning very casually. What is the meaning of this word "Ananda"? Does it mean enjoyment? Does it signify happiness or does it point to pleasure that we very often feel? The enjoyment, happiness and pleasure that we have is transitory, momentary, and ephemeral! They remain for the time being and vanish after the experience is over. They are material pleasures and hence they cannot continue for ever. "Ananda or Bliss" is entirely different! It has nothing to do with the ordinary day to day experiences. It is a kind of indescribable divine elation beyond the comprehension of the common mortal. It cannot be narrated or explained in normal words. One has to experience to realize it. We mistake the usual pleasures and happiness as "Ananda". Is it possible for the ordinary mortal to experience this rare kind of divine experience? It is surely not Impossible but requires spiritual practices and a concerted effort on the part of the aspirant. Any thing, good and great cannot be obtained just like that! "Ananda" or bliss is an inner treasure, won by detachment and discipline" remarks Bhagawan Sri Sri Sathya Sai Baba. The Vedas and the Upanishads call this as Brahmananda- the Ananda of the Brahman! The tapas or penance and the discipline required for the attainment of Ananda is wonderfully brought out in the Bhrigu Valli of the Taittiriya Upanishad. The renowned sage Bhrugu approached his father Varuna with a desire for the knowledge of the Brahman. Pleased with his approach, Varuna instructs him on the six

main gateways to the knowledge of the Brahman. They are food, Prana or soul, eyes, ears, Manas or mind, and speech. He explains to Bhrugu that Brahman is that object by which all the created beings live and thrive on and finally merge into IT during the deluge. Varuna asked his son to "obtain this Brahman through these six gateways. Accordingly, Bhrugu performed tapas and found Annam or food as the Brahman since all living beings grow and thrive on annam alone and merge into the same Annam. But he did not accept it as Brahman as Annam is created by the Brahman and it is ephemeral whereas the Brahman is 'nitya' permanent and everlasting! ' annam brahmeti vyajanath". "Prano brahmeti vyajanath".....Asked by his father to perform penance again, Bhrugu found Prana as the Brahman since as creation, protection and destruction of the universe are dictated by it. But Prana is 'jada'- inert, without awareness while the Brahmin is full of awareness or chaitanya. Hence Prana cannot be equated with the Brahman! Varuna sent him back to do tapas once again and Bhrugu now found that Manas is the very Brahman as through its sankalpa all creation, protection and destruction take place. Once again doubt cropped in him and he could not equate Manas with the Brahman! Rigorous tapas he did again and thought vijnanam or knowledge is the Brahman since everything is done through vijnanam! His doubt did not leave him and he rejected it as the Brahma. Through Vijnanam bodies can be created but not elements like the sky or akasa. So Vijnana cannot be the Brahman! "Vijnanam brahmeti vyajanath". "Anando brahmeti vyajanath".....In this manner sage Bhrugu, the pure souled,

performed penance and found

that Anna, Prana, Manas, and

Vijnana do not fully qualify

themselves to be called the Brahman. At length, through his penance, he recognized the all inherent Ananda or Bliss as the real Brahman! One who performs tapas similarly and rejects Anna, Prana. Manas and Viinana as Brahman is fixed in the Brahman! He becomes the Brahman himself! "Brahmavid brahmaiva bhavathi". This Ananda is thus the inner treasure and a serious attempt has to be made to attain that stage of Divine bliss! Jnanis and great yogis who meditate on the Supreme Reality always and forget everything in the world are those who are entitled to Ananda! There are three dolls made of salt, cloth, and stone respectively. When they are immersed in water, the first, of salt, dissolves completely and loses its form; the second, of cloth, absorbs a large quantity of water but retains its form and the third, of stone, is impervious to water! The first doll represents the man who merges his Self in the universal and all pervading Self and becomes one with it after losing his identity! He is the liberated man! The second doll stands for the Bhaktha or devotee full of true love of God and knowledge! The third doll, of stone, is an example of the worldly man who will not admit even a true particle of true knowledge! Like the ant that tastes the sugar candy and loses itself in enjoying the sweetness, the aspirant loses and merges himself into the Divine! The Jiva merges into the Deva and becomes Deva himself! Sant Kabir Jayanti is celebrated in India at the full moon in the Hindu month of Jyeshtha, between May and June, on the Gregorian Calendar. This year, it falls on June 11. Jayanti means birth anniversary, and Sant Kabir Das was an Indian mystic poet and religious figure who lived in the 15th century. Sant Kabir Jayanti is a special day dedicated to honoring him, his works, and his enduring legacy.

Kabir Saheb was born in 1398 in the city of Varanasi in Uttar Prades on the day of the full moon in the Hindu month Jyeshthah. Raised by a family of weavers, he lived on to become a great mystic poet, persecuted for his work by Muslims and Hindus, who tried to claim him as their own upon his death. Unlike other Gurus and Saints of the time, Kabir lived simply as a weaver. He got married and had children. Kabir's poems are mainly recorded in Hindi. They reveal different aspects of life and call for devotion to God. Kabir was often critical of certain religious practices, causing controversy during his lifetime. In 1495, Sant Kabir was forced into exile when Emperor Sikandar Lodi charged him with the possession of divine powers. He died in Maghar near Gorakhpur in 1518.

Sant Kabir's legacy has done more than survive, it has thrived. Following in his footsteps is the Path of Kabir, a religious community that acclaims him its founder and one of its sages. Known as Panthis, membership of the group burgeoned to about 9.6 million people over the seventeenth and eighteenth centuries. His work was included in a spiritual book entitled "Kabir Bijak" in the 17th century, written down for the first time after being verbally composed. Some of Kabir's verses and teachings were incorporated into religious scriptures. In 1915, Kabir's poetry was translated into English by the famous Bengali polymath, Rabindranath Tagore, reaching a wider audience. Currently, there are two temples dedicated to Kabir located in Benares. One of them is preserved by Hindus, while the other by Muslims.

Kabir is born in Varanasi in the state of Uttar Pradesh. The "Kabir Bijak" spiritual book is released. The religious community, Path of Kabir expands and gains new members all over India. Bengali polymath translates Kabir's poetry into English.

A cooperation agreement has been signed between Russia's space agency Roscosmos and China's National Space Administration (CNSA) recently for this ambitious project. It is likely that the project will not only add a new chapter to the field of scientific research, but also give a new direction to global competition in space exploration. It will be an integral part of the proposed nuclear plant International Lunar Research Station (ILRS). ILRS is a longterm space project being developed in partnership with China and Russia, aimed at building infrastructure necessary to operate continuous scientific activities on the Moon. Since solar energy on the lunar surface is available in limited quantitiesespecially in polar and dark regions, there is nuclear energy being seen as a reliable and permanent energy source. The establishment of nuclear power plant will enable various scientific experiments, data analysis, communication networks and robotic missions permanent energy on the moon. This will not only make the road to future human missions easier but also take concrete steps towards converting the Moon into a long-term scientific centre. The ILRS project is being seen as a direct rival to the US-led Artemis program. Space agencies of 55 countries, including NASA, European

Space Agency, Indian Space

Research Organisation (ISRO)



under the Artemis Program, are working on a plan to set up a space station called 'Gateway' in Chand's orbit by 2027. This station will act as a base for human missions and scientific research on the lunar surface. However, China and Russia will have to face a number of technical challenges to establish a nuclear power plant on the Moon. The harsh environmental conditions of the moon, such as extreme temperatures, vacuum and radiation make this project complicated. Moreover, the safe use of nuclear energy and the process of its transportation into space is also a major challenge. Though space agencies of China and Russia have iron out their technical capabilities in recent years. In such a situation, it is hoped that the project will define the next stage of space exploration over permanent human presence on the moon and the use of its resources.

Bhubaneswar, (DMC): BJD president Naveen Patnaik on Tuesday slammed the BJP government in Odisha, accusing it of focusing only on long speeches and advertisements rather than real development. Addressing party workers during the launch of "Jana Jagaran Abhiyan" at Sankha Bhawan here, Naveen questioned various achievements being claimed by CM Mohan Majhi-led BJP government in Odisha. "They call it a people's government. But where are the people? Long speeches and big advertisements alone cannot bring development," the BJD supremo remarked. Naveen stated that during BJD's tenure, 90% of Odisha's population benefited from Biju Swasthya Kalyan Yojana. "The current Ayushman Bharat scheme fails to provide medicines or free hospital treatment. Thousands, including mothers, the elderly, cancer patients, and children, face harassment," he said.

He further alleged that the health system has collapsed. "Chief District Medical Officer posts are lying vacant in 19 of 30 districts. This is the so-called success of the current government," he said. Naveen further claimed that seventy lakh women were empowered through Mission Shakti under the BJD regime. "Mission Shakti brought glory to the state across India. The present government has weakened this movement within one year. Mission Shakti mothers are being harassed in banks, and they are not getting work in government offices," he said, terming it as the biggest mistake of the current administration."

The mothers will never forgive this," he asserted. 

Man held for Rs 1.08 cr luxury car scam

Bhubaneswar, (DMC): A 32year-old man was arrested by the B h u b a n e s w a r - C u t t a c k Commissionerate Police on Tuesday for allegedly duping a businessman of over Rs 1.08 crore on the false promise of facilitating the purchase of a luxury car at a discounted price.

The accused has been identified as Sambit Panda, a resident of SailashreeVihar under Chandrasekharpur Police Station limits, is the son of retired police officer Bidyut Chandra Panda. At the time of arrest, he was working as a showroom manager at NEXA in Cuttack. According to an official press release, the complainant, Rohit Roshan Mohanty, came into contact with Panda on March 19, 2023. Introducing himself as a freelance

car broker and former Audi Bhubaneswar manager, Panda allegedly convinced Mohanty of his credibility and promised delivery of a high-end car within a month.Trusting his assurances, Mohanty transferred a total of Rs 1,08,50,000 through multiple bank transactions.

However, after receiving the amount, Panda failed to deliver the vehicle and started avoiding communication. When approached for updates, he allegedly resorted to verbal abuse and issued threats. Following a complaint filed through the JMFC, COG-II Court in Bhubaneswar, a case was registered at Infocity Police Station on September 7, 2024 (Case No. 440), under various sections of the Bharatiya Nyaya Sanhita (BNS), including charges of cheating, criminal intimidation, and forgery. The police further stated that Panda used forged documents during the transaction and may have defrauded other persons in a similar manner. His arrest was made on June 10 from the NEXA showroom under Cantonment Police Station limits in Cuttack.

During interrogation, Panda confessed to the crime and reportedly named two accomplices, whose identities are being withheld pending further investigation. Police said the accused caused significant financial and psychological harm to the victim. An investigation is underway to trace the involvement of others and determine whether more victims were targeted by the group.

Two lady engineers in Vigilance net

Bargarh/Jeypore, (DMC): In a significant anti-corruption operation, Odisha Vigilance has nabbed two government engineers in bribery charges. While Susmita Oram, a Junior Engineer (JE) posted at Gaisilet Block in Bargarh district was caught red-handed while accepting a bribe of Rs 8,000, Assistant Engineer (AE) of Lamtaput Block in Koraput district Suchismita Parija was nabbed for allegedly taking a bribe of Rs 8,000.

Oram had joined the government service under DRDA, Bargarh on January 10, 2024, and is working as a JE at Gaisilet Block since January 29, 2024. This was her first posting. Oram was demanding Rs 32,000 from a contractor (complainant) for measurement and clearing of

pending bills related to road improvement work under MGNREGS."The estimated cost of the work was Rs 9,50,000, out of which bills worth Rs 3.15 lakh had already been paid. The JE was demanding a bribe of 10% of the paid bill amount.

She had earlier accepted Rs 24,000 and was caught while taking the remaining Rs 8,000. Finding no other option, the complainant approached the Vigilance authorities, alleging harassment by the JE. Following this, a trap was laid, and Oram was caught while taking the remaining bribe amount. The entire sum was recovered from her exclusive possession and seized. Following the trap, simultaneous searches are underway at two locations linked to Oram from the Disproportionate Assets (DA)

Following the arrest, simultaneous searches are being conducted at three locations linked to her to investigate potential disproportionate assets. A case under Section 7 of the Prevention of Corruption (Amendment) Act, 2018, has been registered at the Koraput Vigilance Police Station (Case No. 22/2025). The investigation is ongoing, and further details are awaited.

Woman tied up, robbed of gold ornaments in Gop

Puri, (DMC): In a shocking incident that has sent shockwaves through the Gop area of Puri district, a lone woman was allegedly tied up and robbed by unidentified miscreants during a late-night burglary at her residence in Kundisa village. The victim, identified as Jhumuri Das, was alone in her house at the time of the incident. According to local sources, two to three armed miscreants allegedly broke into her house by forcibly opening the grill and main door. They then tied her hands and legs before ransacking the house.

The intruders reportedly broke into the almirah and fled with gold and silver ornaments along with more than Rs 10,000 in cash. Jhumuri's family members and children were away at the time of the incident. Her son also lives elsewhere, which made her an easy target for the criminals. Sources say that while the robbers were attempting to break into the house, Jhumuri woke up but was immediately



overpowered and restrained. The next morning, villagers discovered her in a tied-up condition and immediately came to her rescue. She was in a state of shock but reportedly unharmed physically. It is suspected that the miscreants were aware that the woman was alone in the house. Other members either stay in another house or some others outside the state. I was staying alone and pleaded the miscreants to leave me. Then they tied me up and assaulted me. Later, they looted the valuables," alleged Jhumur,i adding that she had seen two miscreants. A local resident said,

The miscreants had broken the locks using machine cutters and looted valuables. Following the incident, the Gop police reached the spot and have launched a detailed investigation. A forensic team is expected to visit the crime scene to gather evidence. Police are scanning CCTV footage from nearby locations and questioning locals to gather leads on the identity of the culprits. The incident has raised concerns over the safety of elderly or lone residents in rural areas, and villagers have urged the local administration to enhance night patrolling and security measures in the region.

Sonam Offered Rs 20 Lakh for Murder, Helped Push Body into Gorge SC Pauses Delhi HC Order **Ousting Medicine System Head**

LUCKNOW, (HS) : Sonam Raghuvanshi had offered Rs 4 lakh to hired killers for the murder of her husband Raja Raghuvanshi, sources said, adding she later raised the amount to Rs 20 lakh. According to top police sources, Sonam helped the other accused in pushing Raghuvanshi's body into a gorge in Meghalaya.

Raja Raghuvanshi's body was found in a gorge near a waterfall in Sohra area (also known as Cherrapunji) of East Khasi Hills district on June 2, days after he reached Meghalaya with his wife Sonam for their honeymoon. The hitmen hired by Sonam first met with the newlywed couple in Bengaluru, from where they took their connecting flight to the northeast, the sources said, adding that since the victim and the accused were from the same city, they got talking. Sonam had allegedly hired killers to get rid of her husband as she reportedly wanted to be with her lover. As per sources, Sonam Raghuvanshi planned the murder with her alleged lover Raj Kushwaha just a few days after her May 11 wedding in Indore. The plan of a one-way ticket to Meghalaya for the honeymoon was her plan, they said. Even though Kushwaha did not travel to Meghalaya, but Shillong Police sources suggest he did the planning behind the scenes and was in touch with Sonam.

SC refuses to reduce lawyer's sentence for abusing woman judge

New Delhi, (HS) : The Supreme Court today rejected a petition by a lawyer convicted of abusing a woman judicial officer in a court in Delhi. The top court refused to reduce the imprisonment sentence to 6 months and said, "Today, the majority of our officers in Delhi are women. They will not be able to function if somebody can get away like this. Think of their state," the bench commented orally. The bench of Justice PK Mishra and Justice Manmohan was hearing a plea against the order of the Delhi High Court, which upheld the conviction of a lawyer who used abusive language towards a woman judge in a challan matter inside the trial court. The lawyer used abusive, vulgar expletives after the judge had adjourned the matter. While hearing the plea, Justice Manmohan verbally remarked, "Just see the inspection report, the language used, we cannot even say in the open court". Justice Manmohan further said that if a stern view is not taken against such behaviour, women judicial officers would not be ensured a safe work environment. On May 23, Sonam and Raja Raghuvanshi went on a trek to a steep peak to see a waterfall, with the hitmen following their trail. At one point, Sonam pretended to be tired and started walking much behind her husband and the killers, the sources said. When they reached a deserted place, Sonam allegedly asked the men to kill her husband. The killers, however, refused to kill him, saying they were tired, as per the sources. Sonam Raghuvanshi then allegedly raised her offer to 20 lakh, they said. According to sources, Sonam also helped the accused in throwing Raja's body into the ditch. As per the preliminary autopsy report, Raja Raghuvanshi was hit twice, once each on the back and front of his head.

The Meghalaya Police knew on June 3, a day after they found the body of Raja Raghuvanshi in the gorge, that his wife was involved in the murder. The Meghalaya Police has claimed that all those involved in the conspiracy to kill the man from Indore - including Raj Kushwaha, Vishal Chauhan and Akash Rajput and Anand Kurmi - have been arrested in the operation that they codenamed 'Operation Honeymoon'. In a dramatic development late Sunday night, Sonam Raghuvanshi - who was missing since May 23 - surrendered before the Nandganj Police Station in Ghazipur district in Uttar Pradesh and was later placed under arrest, according to the Meghalaya police. The sources said, right after the murder, Sonam Raghuvanshi left Meghalaya for Indore, where she met with his alleged lover Raj Kushwaha, the sources said. After staying in a rented room in Indore she travelled to UP with a hired driver, they said. The grieving family of Raja Raghuvanshi has demanded the harshest possible punishment for the accused, including his wife, and her alleged accomplice, saying that only capital punishment would deliver justice for the brutal crime. "Our only demand is that the government ensure all the accused, especially Sonam and those involved with her, are brought to justice and hanged. Sonam has already named those responsible, and action must be taken accordingly," said Raja's brother Vipin Raghuvanshi.

Sonam's father, meanwhile, has defended his daughter, claiming the Meghalaya Police were framing her to cover up their own investigative lapses. The family of Raj Kushwaha has also defended him, insisting he is innocent and has been falsely implicated. According to his family, Kushwaha, the sole breadwinner, had only a professional relationship with Sonam and was incapable of such a crime. Kushwaha's mother, speaking to reporters, said: "My son is innocent. The police are lying. He never had any relationship with Sonam beyond work."

New Delhi, (HS) : The Supreme Court on Tuesday stayed an order setting aside the appointment of the chairperson of National Commission for Indian System of Medicine holding him ineligible for office. A bench of Justices Prashant Kumar Mishra and Manmohan issued notice to National Commission for Indian System of Medicine (NCISMC) and others on the appeal filed by Vaidya Jayant Yeshwant Deopujari.

Deopujari challenged the June 6 order of the Delhi High Court, which allowed two petitions against his appointment as the NCISMC chairperson. The commission's counsel informed the high court that the process of selection and appointment of the chairperson had commenced following which it directed the expeditious completion of the process. The high court also asked for its observations to be taken into account during the selection process. The petitions in the high court were filed by Ved Prakash Tyagi, former president of the erstwhile Central Council for Indian Medicine, and Dr Raghunandan Sharma. The Ministry of Personnel, Public Grievances and Pensions had issued a circular on June 9, 2021 appointing Deopujari as the commission's chairperson. The petitioners alleged that Deopujari could not be appointed as the chairperson of the commission as he does not hold a postgraduate degree, mandated under the National Commission for Indian System of Medicine Act, 2020 (NCISM Act). The high court held Deopujari possessed a PhD degree whereas the requisite degree was MD or any other equivalent master's degree in any discipline of Indian System of Medicine. The PhD degree which was awarded to him by Pune University did not presuppose acquisition of lower qualification (Master's Degree in Ayurveda), it said. "We have no hesitation to hold that the expression 'Post-Graduate Degree' occurring in Section 4(2) of the NCISM Act, 2020 in the context it has been used would mean a Master's Degree (MD) in any discipline of Indian System of Medicine which the respondent does not possess and, therefore, he lacks the requisite qualification for being appointed to the office in question," the high court said. Deopujari, the high court noted, was admitted to the PhD course without undergoing the master's degree course, soon after graduating in Avurveda (BAMS).

deter them from their duty). Delhi's temperature 'feels like' almost 50°C **Beyond Blame: A Collective Collapse, Not a Lone Officer's Failure**

New Delhi, (HS): The Indian Meteorological Department has issued an orange alert over heatwave in Delhi for the next two days amid residents grappling with unbearably high temperatures in the city, with a 'feels-like' temperature reportedly close to 50 degrees Celsius. With all five weather stations recording a surge in temperature, the weather department was warned of a heatwave in Delhi. Based on the warning for Delhi, the IMD has issued an orange alert for June 10 and June 11. This warning comes after the weather department stated that heatwave conditions are expected to prevail over Northwest India for the next four to five days. Delhi recorded its highest maximum temperature of the season at 43.8 degrees Celsius on Tuesday. This reading is 3.6 notches above the season's average as per the IMD.

Despite the temperature nearing 44 degrees Celsius, the real-feel temperature or heat index - stood at 47.1 degrees Celsius. As per the IMD, the temperature in Delhi is expected to breach the 45 degrees Celsius mark in the next few days.

India to face twice as many heatwave days, 43% rise in extreme rainfall

NEW DELHI, (HS): A new study reveals that climate change is expected to cause a 43% increase in the intensity of extreme rainfall events throughout the country, along with a two-fold rise in heatwave days in major Indian cities. It recommends establishing a climate observatory to provide real-time early warnings about extreme weather events to help minimise damage. Conducted by IPE Global and Esri India, the study titled "Weathering the Storm: Managing Monsoons in a Warming Climate" analysed district-level spatial and temporal assessments to develop heat stress scenarios for the years 2030 and 2040. It aimed to establish a connection between climate change and the increased frequency and unpredictability of extreme rainfall and heatwave events. According to the study, major cities in India, including Mumbai, Chennai, Delhi, Hyderabad, Patna, Surat, Bhubaneswar, and Thane, are likely to experience a twofold increase in heatwave days by 2030. These rising heatwave conditions are expected to lead to more erratic and intense rainfall. "Extended heat wave conditions are likely to trigger more frequent, incessant and erratic rainfall events," said Abinash Mohanty of IPE Global, a co-author of the paper. The paper underlines the grim situation of climate change's impact.

Bangaluru, (HS) : The stampede at Bengaluru's Chinnaswamy Stadium is one of the most tragic events I've witnessed in my career as a reporter. I was there at 2 pm, lost in the euphoria with crowds dancing, singing, and waving RCB flags. Though I'm not an IPL fan and didn't watch the final, the atmosphere felt like India had won the World Cup. The joy was infectiousyoung and old, all united.

But by 4 pm, as I walked toward Cubbon Park, the mood turned. The crowd kept swelling. Police presence was minimal and clearly overwhelmed. Traffic was a nightmare; even walking became impossible. People began climbing gates, jumping walls. The guard at Gate 21 told me later, "I ran for my life. If I had stayed, I would've died too." No one foresaw the horror that would follow-11 young lives lost, over 40 injured. I felt ashamed, even complicit, for encouraging the frenzy. Everyone must introspect: the state government, the police, RCB, KSCA, media houses, and yes, the cricketers too, who danced on stage that night, basking in glory they didn't earn. Now, questions are being asked. Was it worth it? Who's to blame?



This isn't India's first stampede, and, sadly, it may not be the last. Legal action has begun-cases filed, some officers suspended. But the political class has emerged unscathed, offering only clichéd "shock and sorrow" statements. The suspension of the Police Commissioner, along with two senior IPS officers and two policemen, has sparked widespread debate. Was it fair, especially when the formal inquiry report is still pending? There seems to be collective failure across the board, yet accountability has been selectively enforced.

Who authorised the celebration on

such short notice? What warnings did the police give? Who made the final call? Until those answers are placed on record, it's hard to isolate blame. Suspending top cops without this clarity sends a demoralising message to the force. One young officer told me, "If the Commissioner can't protect himself, why should we follow orders?" Suspensions and transfers are part of the job, but this scale of action, even after a tragedy, has shaken the ranks. Former officers have joined in the protest. Even ex-Commissioner Bhaskar Rao, now with the BJP, has called for

the suspension to be revoked. Officers are urging the Centre not to ratify the state's suspension order. After all, this move suggests an admission of failure by the government, while shielding its top political figures. The state government's justification-that this was a private event and the Commissioner failed to brief ministers-is inadequate. Full facts must be disclosed before guilt is assigned. If there's clear evidence of negligence, action must followregardless of rank. But punishing selectively, without proof, undermines the institution

One young IPS officer put it bluntly: "Fine, suspend the Commissioner. But then the Chief Minister, Deputy CM, and Home Minister should also step aside until the report is out. Take moral responsibility." This wasn't one person's fault. It was a monumental failure across agencies and leadership. Yes, legal action is essential. But real accountability requires that all responsible parties-including political leaders-share in the consequences, not just the limelight. Until then, this will remain not just a tragedy, but also a disturbing case of scapegoating in the face of collective collapse.

Russia Downs 102 Ukrainian Drones Overnight

Moscow, (H.S): Russia's air defence systems intercepted and destroyed 102 Ukrainian fixedwing unmanned aerial vehicles overnight, the country's Ministry of Defence said on Tuesday via its official Telegram channel. According to the ministry, the drones were neutralised between 9:50 p.m. Moscow time on Monday and 5:50 a.m. on Tuesday, across several regions in western and central Russia.

Meanwhile, Russia launched a massive overnight drone and missile assault on Ukraine from Sunday night to early Monday, deploying 479 unmanned aerial vehicles in what Ukrainian officials called the largest drone attack since the war began over three years ago. According to Ukraine's Air

Force, the barrage - which also included 20 missiles of various types - primarily targeted central and western regions. The attack is part of an intensifying Russian summer offensive, as peace negotiations between the two sides remain deadlocked. Ukrainian air defence systems reportedly intercepted 277

drones and 19 missiles. Ten projectiles managed to hit their targets, injuring at least one civilian. However, these figures have not been independently verified. The aerial bombardment coincided with renewed Russian offensives along eastern and northeastern sectors of the roughly 1,000-kilometre (620mile) front line.

Earlier, on June 8, Russia reported shooting down 131 Ukrainian drones within a 24hour period, including 73 outside of its primary air defence coverage. The Russian Defence Ministry said the drones were intercepted over several regions, including Tula, Bryansk, Kaluga,

Oryol, Belgorod, Kursk, and Moscow, as well as over Crimea. Just days earlier, on June 6, Russian forces carried out another significant overnight attack on Ukraine, involving both drones and missiles. Ukrainian authorities said at least four people were killed and dozens more injured in that strike.All four fatalities occurred in Kyiv, where an additional 20 people were wounded, according to Mayor Vitali Klitschko. Ukraine's emergency services confirmed that three of the victims were first responders.

The National Police reported around 40 injuries nationwide, mainly in Kyiv, Lutsk in the northwest, and Ternopil in the west. They also noted that 38 facilities were damaged, including five apartment buildings and five private homes.Ukraine's Air Force spokesman Yuriy Ihnat said that during the June 6 attack, Russia launched 407 drones, 38 cruise missiles, and six ballistic missiles. Ukrainian forces managed to shoot down about 200 drones and around 30 missiles.



Chinese scientific researcher has been arrested and charged with smuggling biological materials into the United States for use in a University of Michigan laboratory, intensifying a growing agroterrorism investigation involving foreign nationals. Chengxuan Han, a Chinese national, has been accused of smuggling roundworms into the US and making false statements, according to an announcement from the United States Attorney's Office for the Eastern District.

Han is currently pursuing a PhD from the College of Life Science and Technology at Huazhong University of Science and Technology in Wuhan, China. The federal complaint states that in 2024 and 2025, Han shipped four packages from China to individuals affiliated with a laboratory at the University of Michigan. These packages contained concealed biological material. Authorities say Han arrived at Detroit Metropolitan Airport on June 8, 2025, on a J1 visa. During a customs inspection, Han



the packages and denied having sent any biological materials to the United States. Customs and Border Protection (CBP) officers found that Han's electronic devices had been wiped clean three days before her arrival. After the inspection, Han was interviewed by FBI agents. She reportedly admitted to having sent the packages and confirmed that they contained biological materials related to roundworms. Lee Promulgates Special Probes Into Ex-President Yoon, His Wife

Seoul, (H.S): South Korean President Lee Jae-myung on Tuesday promulgated bills mandating special counsel probes into a botched martial law bid by former South Korean President Yoon Suk Yeol and corruption allegations against his wife, former first lady Kim Keon Hee. Lee signed off on three bills in his first legislation since taking office last week, which also calls for a special counsel probe into the drowning death of a Marine during a rescue operation for flood victims in 2023. The bills were approved at a Cabinet meeting earlier in the day.Lee expressed hope that the special counsel investigations will transparently uncover the truths behind the related allegations, according to the presidential office."Lee's enactment of the three special counsel bills, the first since taking office, was intended to meet the public's expectations for addressing insurrection charges and restoring constitutional order, as reflected in the presidential election," presidential spokesperson Kang Yu-jung told reporters.

The probes would add legal pressure on Yoon, who was removed from office in April and is now on trial for charges of leading insurrection and abuse of power related to martial law.One of the bills targeting Yoon mandates a permanent special counsel to investigate 11 charges, including insurrection and military mutiny, over his failed martial law bid in December. The bill, previously vetoed and discarded twice, has been reintroduced with an expanded scope, increasing the number of charges from six to 11. Another bill against the former first lady is aimed at launching a special probe into allegations of stock price manipulation, her acceptance of a luxury bag and interference with the election nomination process, Yonhap news agency reported. The third bill proposes a special counsel probe into alleged interference by the presidential office and the Ministry of National Defence in the military's investigation into the death of a Marine during a search-and-rescue operation in July 2023. The number of prosecutors to be dispatched could reach up to 120 - the largest size ever - and the investigations could extend over a period of 170 days.



China Carefully Assembling Deep-Sea Mining Strategy

China, (H.S): In a world hungry for crucial resources, China may not be poised to start deep-sea mining but it is planting seeds for such operations in a meticulously planned economic and geopolitical strategy. The world's oceans, both international waters and those under national jurisdiction, are rich in minerals and metals, like cobalt, nickel and copper.

These are important for building electric car batteries, for instance, and other technologies as countries try to transition away from fossil fuels.China "is an energy-thirsty country. It will look for resources everywhere," including the deep sea, said Julia Xue of Shanghai Jiao Tong University. But she said China is not particularly anxious over the issue, although recent developments -- one company is itching to be the first to start mining the sea bed -- may put more pressure on Beijing.A Canadian firm, The Metals Company, has filed an application with the United States to begin undersea mining in international waters.Using its American subsidiary, it acted after President Donald Trump,



bypassing international in international waters. The negotiations, signed an executive order in April to speed up the permit-issuing process for such mining in US and international waters. Trump cited an obscure 1980 US law that says American citizens can explore for and recover deep sea minerals in areas beyond the country's jurisdiction. Environmental groups are outraged by Trump's order, arguing that a wild hunt for the potato-sized, metal-containing nodules could harm fragile undersea ecosystems.The Canadian company initially said it would submit its request to the International Seabed Authority (ISA), a body which has jurisdiction over the ocean floor

Metals Company says it ignored this authority because of its slow pace in talks on adopting a mining code that establishes rules for exploiting seabed resources. The United States is not an ISA member.A long-time observer of those talks who spoke on condition of anonymity said China is not particularly worried about who starts mining first." For them it's more about dominance, staying competitive in the game, and giving the impression that you can't mess with us," the observer said.With that goal in mind "they're definitely developing the technology and putting the strategic agreements in place,"

Alex Gilbert, a researcher at the Payne Institute for Public Policy at Colorado School of Mines, told AFP.For instance. China has reached an agreement with the Cook Islands to explore for minerals in that Pacific country's waters. Another tiny Pacific nation, Kiribati, also says it is exploring a deep-sea mining partnership with China. transactions, with nearly 50 per cent classified as small or micropayments, it said. For example, it said, the introduction of DBT and Aadhaar authentication in various welfare schemes have led to the

New Delhi, (H.S): Londonbased Vedanta Resources Ltd (VRL) is targeting an investment grade credit rating on the back of its sustained deleveraging, the proposed demerger at its Indian subsidiary, Vedanta Ltd, and its robust growth, operational efficiencies and strong financial performance. VRL is committed to reducing its total debt from the current USD 5 billion to USD 3 billion by FY27 while strengthening its critical minerals, transition metals, energy and technology portfolio.

A person aware of the matter said that VRL, at a recently held investor conferences in Hong Kong and Singapore, shared that the company is looking for an immediate credit rating upgrade to BB levels by proactively refinancing and prepaying its high-interest cost USD 550 million private credit facility due in August 2026. In the medium term, the company plans to achieve an investment grade rating on the back of its improved debt profile, financial and operational performance. Vedanta highlighted its robust earnings, healthy free cash flows, ongoing growth projects, strengthened balance sheet, and future deleveraging



plans to the investors, the source said. An investment-grade credit rating signifies a company's strong capacity to meet its financial obligations and is considered a safe investment for institutional investors. It also allows a company to borrow money at lower interest rates, attracting a broader range of investors and gaining easier access to global debt markets. At present, VRL has a

credit rating of B+ by S&P, Fitch & Moody's, with S&P giving a 3-notch upgrade to the company in FY25. The investment grade rating is linked to VRL's debt reduction target (to USD 3 billion) by FY27, so they are looking for an investment grade in about two years from now. Sources indicate that VRL is currently working with banks to refinance and pre-pay a USD 550 million private credit facility that will expire in August 2026. It is likely to use a bank loan with single-digit interest rates to refinance the facility, with savings

of 800-900 basis points, resulting in interest cost savings of USD 47 million, said the person quoted above. The company expects to achieve an upgrade to BB levels right after the refinancing and will continue to work towards an Investment Grade credit rating of BBB-, in the medium term, which is considered the first rung of investment grade rated companies. Vedanta Ltd (VEDL), through

its Indian subsidiary, is in the final stages of its demerger process that will result in the creation of four new sector-focused, marketleading entities and will help unlock value for existing shareholders while offering investors an opportunity to invest in pure-play businesses. The company expects the demerger to be completed by September 2025. Over the past three years, the company has been on a path of sustained deleveraging and refinancing. Between March 2022 and March 2025, VRL reduced its net debt from USD 8.9 billion to

USD 5 billion, the lowest in a decade. Vedanta Group's net debt to EBITDA ratio has fallen from 3.3x in FY20 to 2x in FY25, and per VRL's subsidiary's earnings presentation, it is expected to fall further to 1x in the mid-term. In FY25, VRL also refinanced its entire USD 3.1 billion bond portfolio, resulting in a significant reduction in average coupon rate by 250 bps while extending the maturity up to FY34.

This will help in further improving the company's credit profile. In its recent earnings call, VEDL's management opined that a normalised dividend of about 6 per cent yield might contribute USD 800 million receipt at VRL. Together with brand fees, dividend (paid by Vedanta Ltd. to VRL) and operating free cash flows, VRL's overall target of reaching USD 3 billion debt in two years remains intact. In April, the subsidiary VEDL declared its FY25 results, achieving its highest ever annual revenue of USD 17.8 billion and the second highest annual EBIDTA of USD 5.1 billion, with its key businesses, Zinc India and Aluminium, in the top quartile and top decile of the global cost curve.

For many, India is not only a promising market but also an ideal base for manufacturing, R&D, and cocreation of globally competitive solutions.

Several firms indicated active interest in forming joint ventures, scaling operations, and localizing production to serve both Indian and international markets. From cutting-edge cancer therapies and cell sciences to industrial automation, fibre optics, space technologies, and digital security, Swiss companies underscored their alignment with India's developmental priorities and sectoral growth plans. New Delhi, (HS) : Despite not qualifying for the World Test Championship (WTC) 2025 final, Team India will earn almost as much as the winners of the last two editions, New Zealand (2021) and Australia (2025).

Australia will be the first team to have a shot a defending the WTC title. They had beaten India in the final at the same venue two years ago to lay their hands on the maiden WTC title. The winners of the WTC Final, to be played between Australia and South Africa, will take home a purse of \$ 3.6 million, more than double of what New Zealand (2021) and



Australia (2023) earned after winning the previous two finals. The losing finalists, too, will earn more than the earlier top prize money, assured of more than \$ 2.1 million this time. The winners of the previous two editions (New Zealand and Australia) won \$1.6 million each, while the losing finalists (India) got \$ 800,000. "The increase in

prize money exhibits the ICC's efforts to prioritise Test cricket as it looks to build on the momentum of the first three cycles of the nine-team competition," the ICC said.


