Puri (DMC): Lakhs of devotees from across the country and abroad thronged the seaside pilgrim town of Puri in Odisha to witness the annual Rath Yatra of Lord Jagannath and his two siblings on Friday. The devotees burst into ecstasy as many of them pulled forward the three majestic chariots from the 12th-century Jagannath temple in Puri towards Gundicha temple, around 3 km away, amid devotion and fervour.

#### Very big trade deal coming up with India: Trump

New Delhi (HS): US President Donald Trump said America is going to have a "very big" trade deal with India, hinting at significant progress in the negotiation process of a long-awaited bilateral trade agreement between the two countries. "We're having some great deals. We have one coming up, maybe with India, a very big one, where we're going to open up India," Trump said during an event at the White House promoting passage of the GOP's tax and spending cuts legislation on Thursday.

"In the China deal, we're starting to open up China. Things that never really could have happened, and the relationship with every country has been very good," Trump said. The president, however, did not elaborate on the details of the deal signed with China. He said that every country wanted to make a deal and have a part of it, and his administration officials were working overtime, making deals with countries. "You remember a few months ago, the press was saying, 'Do you really have anybody of any interest?' Well, we just signed with China. We have everybody. We're not going to make deals with everybody. Some we're just going to send them a letter and say thank you very much. You're going to pay 25 per cent, 35 per cent, 45 per cent.

#### Evacuated over 4,400 nationals from Iran, Israel so far: MEA

New Delhi (HS): India has evacuated more than 4,400 Indian nationals from Iran and Israel so far in 19 special flights under Operation Sindhu launched on June 18 to bring home its citizens amid the ongoing conflict between the two countries, according to the Ministry of External Affairs. A fresh batch of 173 Indians evacuated from Iran reached Delhi late Thursday night in a flight from Armenian capital Yerevan, the

MEA said in a post on X. At his weekly media briefing a day before, External Affairs Ministry spokesperson RandhirJaiswal, in response to queries on Operation Sindhu, said New Delhi was assessing the situation on the ground and a decision on the future course of action would be taken based on it. Over 3,400 Indian nationals have been evacuated so far in 14 flights from Iran since the start of Operation Sindhu,

according to data shared by him during the briefing. Jaiswal later shared updated evacuee figures in the post on X after the arrival of the flight from Yeravan. "A special evacuation flight from Yerevan, Armenia landed in New Delhi at 22:30 hrs on 26th June, bringing home 173 Indian nationals from Iran," he wrote. "As part of #OperationSindhu, a total of 4415 Indian nationals (3597 from Iran and 818 from Israel) have been

evacuated so far using 19 special evacuation flights including 3 IAF aircraft. 14 OCI card-holders, 9 Nepali nationals, 4 Sri Lankan nationals and 1 Iranian spouse of an Indian national were also evacuated from Iran," he added. On June 24, India said while it remained "deeply concerned about the prospects for overall and sustained regional security and stability", it welcomed reports of a ceasefire between Iran and Israel.

## A déjà vu moment for Indian space odyssey

New Delhi (HS): Call it providence or pure coincidence but June 25 seems to be a day of destiny as regards India from even before it achieved independence. Many spectacular events have unfolded on this very day over the years. On June 25, 1932, India became the sixth team to be granted Test cricket status when it played its first match at Lord's on that historic day. Close to midnight of June 25, 1975, the

then President Fakhruddin Ali Ahmed proclaimed national Emergency citing 'internal disturbance'. It was to mark a watershed event as India's political landscape underwent a dramatic transformation and gave a new democratic dimension.

On June 25, 1983, India rewrote cricketing history by emerging as world champions, when Kapil's Devils upset all calculations and put an end to the



hat-trick quest of West Indies by winning the ODI World Cup in a stunning manner. Now 42 years to the day, June 25, 2025, to be precise, an Indian with the tricolour on his shoulders has put the country's name in a league of extraordinary achievers. A distinguished IAF pilot and astronaut, Lucknow's 39-year-old ShubhanshuShukla scripted history by embarking on a space odyssey along with three others

on Wednesday as part of an ISRO-NASA supported commercial spaceflight by Axiom Space that blasted off for a 14-day sojourn to the International Space Station (ISS) from the Kennedy Space Centre in Florida. Incidentally, Shukla is one of four astronauts picked for ISRO's historic Gaganyaan mission, which marks India's inaugural human space flight endeavour. The lift-off at 12.01

pm on Wednesday (after several eleventh hour heart-breaking postponements) took the clock back by 41 years when Hyderabad's very own Rakesh Sharma became India's first man in space. He spent eight days in orbit as part of the then Soviet Union's Salyut-7 space station in 1984. A day after the take-off, Shukla went a notch higher than Sharma when he achieved the

## **Impressive Strides**

WHO data shows India has taken impressive strides in countering tuberculosis since 2015. The number of reported cases has dropped by 17 per cent and deaths have come down by more than 20 per cent. Even so, the country accounts for more than a fourth of the world's TB burden and nearly 30 per cent of the deaths caused by the disease. India does not appear to be on course to meet its target of eliminating the disease by the end of this year. That's why the government's initiative to use cuttingedge technology, including AI, in its anti-TB programme is a step in the right direction. TB can be tough to detect. The traditional sputum test has major limitations, including inadequate sensitivity, poor performance in some sections of patients, especially children and people living with HIV, and inability to detect antimicrobial resistance. In 2023, the WHO recognised diagnosis as the weakest link in TB care. While the landscape of research has expanded, doctors in large parts of the Global South, including India, continue to rely on the sputum test. The anti-TB programme's plan to widen the diagnostic net by using other samples - such as blood, saliva, or stool - is in line with the WHO's new guideline to «invest in novel diagnostic techniques«. So is the use of genetic material to detect the bacteria. The new initiative seems to have accounted for the longstanding weakness of the Indian healthcare system - the shortage of facilities and trained professionals in rural areas. The use of AI to read microscopy slides and X-rays could be a breakthrough.Until recently, the standard medication course took six to nine months to complete, and treatment for drug-resistant tuberculosis could take up to two years with much lower chances of cure. In the past five years, new drugs have helped reduce the length of therapy. Even then, the regimen is taxing on patients and their caregivers. The defaulting patients then run the risk of contracting the more virulent multidrug-resistant version of the disease and spreading it. A simple test can now measure compliance with the drug regimen - when a patient's saliva is put on the strip, it can tell whether they have taken the medicine in the last 24 hours.

The government would, however, be doing injustice to its initiative by relying solely on technology. State-of-the-art diagnostics should be accompanied by initiatives to improve the nutrition of patients and their access to medicines.



# Jagannath: «Lord of the Universe« Ratha Yatra

Jagannath meaning «Lord of the Universe«, is a deity worshipped by Hindus and Buddhists, mainly in the Indian states of Odisha, Chhattisgarh, West Bengal, Jharkhand, Bihar, Assam, Manipur and Tripura and by Hindus in Bangladesh. Jagannath is considered a form of Vishnu or his avatar Krishna by the Hindus. Jagannath is worshipped as part of a triad on the «Ratnavedi« along with his brother Balabhadra and sister Subhadra. The icon of Jagannath is a carved and decorated wooden stump with large round eyes and with stumps as hands, with the conspicuous absence of The worship legs. procedures, practices, sacraments and rituals of Jagannath do not conform with those of classical Hinduism. It is made of wood, which is an exception common Hindu iconographic deities of metal or stone. The origin and evolution of Jagannath worship, as well as iconography, is unclear and has been subject to intense academic debate.

Jagannath lacks a clear vedic reference and is also not a member of the traditional Dashavatara concept or the classical Hindu pantheon, though in certain Oriya literary creations, Jagannath has been treated as the Ninth avatar, by substituting Jagannath Buddha. considered as a form of the



Hindu God Vishnu, is nonsectarian and has not been associated with any particular denomination of Hinduism in entirety, though there are several common aspects with Vaishnavism, Saivism, Shaktism, Smartism, as well as with Buddhism and Jainism. The oldest and most famous Jagannath deity is established in Puri. The temple of Jagannath in Puri is regarded as one of the Char Dham in India. The most famous festival related to Jagannath is the Ratha yatra, where Jagannath, along with the other two associated deities, comes out of the Garbhagriha of the chief temple. They are transported to the Gundicha Temple located at a distance of nearly 3 kilometres in three massive wooden chariots drawn by devotees. Coinciding with the Rath Yatra festival at Puri, similar processions are organized at Jagannath temples throughout the world.

A significant ritual associated with the Ratha-

Yatra is the "Chhera Pahara, « when the king symbolically sweeps the path of the Rath. This symbolizes that right from the king to the commoner, everyone is responsible for maintaining cleanliness around the place where the yatra is organized. This practice is followed even today and the present Raja Gajapati Divyasingh Dev also follows the tradition. Rath Yatra, Rathotsav, is a common annual festival celebrated in all temples, all across India and the world. It is a festival to unite people from all walks of life to come together to pull the Rath. A truly peoples' festival. Lord Jagannath true to His name not only moves the cosmos, but moves the people to celebrate His Rath Yatra, not just in Puri but also in other parts of the world.  ${f R}$ atha Yatra, the grand and colorful festival of chariots, is held on Asadha Sukla Dwitiya the second day of bright fortnight of Asadha (June-July) every year. Millions of devotees from different parts of the country and abroad witnessed the spectacle of world famous Car festival of Lord Jagannath at Puri. This festival is also known as 'Gundicha Yatra' and 'Ghosha Yatra'. As per the prevailing tradition, Gundicha was the Rani (queen) of Raja Indradyumna, the legendary builder of the first temple. She had initiated this grand festival. Hence, this festival is also known after her name. On this day, the three deities are taken out from the main Temple, placed in three gorgeously decorated chariots and start their journey to Sri Gundicha Temple. The chariots are dragged by thousands of devotees from the Lion's gate of the Jagannath temple to Sri Gundicha Temple which is located at a distance of 3 kilometers. The 3 kilometers Grand Road, known as 'Bada Danda', between Jagannath Temple and Sri Gundicha temple, looked like a sea of humanity as the devotees pumped to have a glimpse of the

deities on the chariots. At Gundicha Temple the deities remain for 7 days and perform their return journey on the 9th day which is known as 'Bahuda Yatra'. The three chariots reach back the main temple in the evening. On the next day, the three deities are attired in costumes of glittering gold ornaments and are worshipped by millions of devotees. This is known as the 'Suna Vesha'. Next day morning, the three deities go back to their original place of the temple. Their arrival into the sanctum sanctorum marks the end of the

festival marks the beginning of the Jagannath. Akshay Tritiya festival is observed on the third day of the bright half of the lunar month of 'Baisakha' of the traditional Hindu calendar. On this auspicious day the carpenters start building the chariots of Lord Jagannath, Balabadra and Subhadra. This day also commences the famous Chandana Yatra. Snana festival is observed on the full-moon day of the month of Jyestha (May-June). This is the bathing festival of the deities. On this day, the three deities move in colorful processions to the Snana Mandapa (Bathing pandal) where the deities are bathed with 108 pitchers of water drawn from a well near the Northern Gate. At the end of Snana Yatra day, the deities are supposed to fall ill (fever) and do not return to their pedestal. They stay away from the public view for a period of 15 days. This period is known as 'Anabasara' or 'Anasara' in local language. After this period, people get the first glimpse of their deities on the day before Rath Yatra, on this day the deities are re-painted and brought to the main platform for the devotees to see and pay homage which is called 'Nava Yauvana Darshan'. This is also known as 'Netrotsava'. Next day, the Ratha Yatra Festival is observed.

More than a religious festival, the Ratha Yatra is an eternal celebration of the divine values of love and compassion, of equality and fraternity. The general public is allowed to pull the chariots irrespective of caste, creed, sect, and religion and gender distinctions. This liberty indicates that the deity is equal for every person on earth and grants equal opportunity to all.

# Rath Yatra rolls through city streets amid devotee frenzy

"Over 17 platoons of police force deployed across key chariot procession points. We coordinated with temple committees to ensure the rituals go smoothly, while also maintaining law and order," said a senior police officer. Barricades have been put up in areas expecting

heavy footfall. Traffic diversions and no-parking zones have been notified near major chariot routes. Quick Response Teams (QRTs), anti-sabotage squads, and CCTV surveillance have also been put in place, police said. BMC has taken up sanitation, drinking water supply, and temporary toilet arrangements. "We want the devotees to have a comfortable and safe darshan experience. Special focus is on cleanliness and hygiene, considering the monsoon," said mayor Sulochana Das. The chariots were pulled amidst colourful processions accompanied by troupes of various folk dance,

music, and sankirtan performers. For many residents, the local Rath Yatra is a cherished spiritual tradition. "I have been pulling the chariot in our locality for over 15 years. It's not just a festival, but an important community gathering," said Soumya Mohanty, a resident of VSS Nagar.

At several temples, the chariot of goddess Subhadra pulled exclusively by women devotees. Volunteers were engaged for crowd management and smooth conduct of the festival across the city. Cultural programmes, bhajan sessions,

and community feasts and prasad distribution were also organised by local committees to add to the festive spirit. Bhubaneswar DCP Jagmohan Meena said Rath Yatra celebrated at 58 places in the city this year with Iskcon and Shrivani Kshetra at KISS being two major locations.

## 'Campa Cola' faces pilgrim fury over billboard

Bhubaneswar (DMC): Just a day before the revered Rath Yatra, controversy erupted in Bhubaneswar and Puri as Campa Cola advertisements placed near the Jagannath temple and Capital City drew sharp condemnation from temple servitors and devotees.

The photo of the hoardingstrategically mounted above a shop close to the temple premises-surfaced on social media, sparking public outrage and triggering the hashtag #BoycottCampa across platforms. Calling the display a violation of religious sanctity, senior servitor Ganeswar Mahasuar stated, "Using Lord Jagannath's image or placing commercial branding in such sacred proximity is not just inappropriate-it deeply insults the faith of millions."Mahasuar



demanded immediate removal of the advertisement, warning that inaction could prompt strict action from the temple administration. He also urged brands to respect spiritual sentiments, especially during critical festivals like Rath Yatra, which draws lakhs of pilgrims to Puri annually. The timing of the incident-coinciding with the spiritual fervour around Rath Yatra-has intensified the backlash. Several cultural and religious organisations have echoed concerns, warning advertisers against trivialising heritage sites for commercial visibility. While Reliance-backed Campa Cola has yet to release a statement, critics continue to mount pressure on the brand,

calling the move a "blatant marketing gimmick." As Rath Yatra festivities gear up, all eyes remain on how authorities, business owners, and the brand itself respond to this emotionally charged controversy." Using the image of Lord Jagannath or associating commercial products like Campa Cola or any other brand with the sanctity of the temple is completely unacceptable.

This is not just a mistake but an insult to the sentiments of millions of Jagannath devotees around the world. We request that the concerned authorities and business establishments remove such hoardings immediately. If not, the temple administration will take strict action against those responsible," Mahasuar said on Thursday. He further added,

"Such acts hurt the faith of devotees. Whoever is behind this display is acting irresponsibly and with disregard for religious sentiment. Through you, I appeal to all not to repeat such mistakes in the future."The controversy has sparked widespread public outrage, with many demanding that the sanctity of religious sites be preserved and kept free from commercial exploitation.

It is worth noting that Campa Cola, the once-iconic Indian soft drink brand recently revived by Reliance Industries, has been facing massive backlash online over hurting the religious sentiments of devotees of Lord Jagannath. Many users on the social media platform X have accused the company of hurting religious sentiments to promote its product.

# Govt hikes cessation benefit for ad-hoc employees



**Bhubaneswar, (DMC):** The Odisha government on Thursday announced a hike in the cessation benefit for its employees appointed on ad hoc basis. Previously, these employees were entitled to a one-time payment of Rs 1.5 lakh upon cessation of service. Chief Minister Mohan CharanMajhi has approved a proposal to increase this amount to Rs 2.5 lakh, a CMO release said.

It further stated that they will receive a one-time cessation benefit of Rs 2.5 lakh upon termination of service. The ad-hoc employees will be entitled to this benefit if they are regularised but have not completed five years of service. Those who have served more than five years in a regular position will receive a minimum gratuity of Rs 2.5 lakh upon retirement. "Additionally, it has been decided that this one-time gratuity amount will increase by 10% every two years. No approval from the Finance Department will be required for this increase, and departments can independently implement the hike every two years," it added.



#### Parliamentary Panel to Grill Boeing, Air India Executives on Ahmedabad Crash



New Delhi, (HS): The Parliamentary Committee on Transport has summoned Boeing executives, Air India representatives, the Civil Aviation Secretary, and DGCA officials for a discussion on air safety issues related to the tragic Boeing Dreamliner crash within seconds of take-off from the

Ahmedabad airport. The meeting is likely to be held in the first week of July. According to sources, "multiple shortcomings" in the aviation sector, with the maintenance of aircraft, are now a matter of huge concern. The committee will also address frequent helicopter accidents that have taken place recently on the Char Dham pilgrim route. Discussion will include the role of the Director General of Civil Aviation (DGCA), aircraft maintenance schedules, and the mental fitness of pilots, sources said. The committee's report will likely be tabled in the next session of Parliament. Before this meeting, the committee is scheduled to hold a consultation in Gangtok to review air and road connectivity to the northeastern states, with the focus on developing tourism. The committee members are expected to travel by an Air India flight to get a first-hand assessment of the airline and its operations. The DGCA had ordered the immediate removal of three senior Air India officials, including a divisional vice president, from all responsibilities related to flight crew scheduling and rostering as part of the first punitive action after the Boeing crash. It has also asked the Tata Group-owned airline to initiate internal disciplinary proceedings against the three officials without further delay. Failure to do so would result in severe action, including the possibility of the airline losing its operating licence. Meanwhile, the Aircraft Accident Investigation Bureau (AAIB) has begun analysing the black box data recovered from the crash site of Air India Flight AI171. "The black boxes were brought from Ahmedabad to Delhi by IAF aircraft with full security on 24 June 2025. The front black box arrived at the AAIB lab in Delhi with the Director General (DG) of AAIB at 1400 hrs on 24 June 2025," according to an official statement on Thursday.

"On the evening of 24 June 2025, the team led by the DG of AAIB, along with technical members from AAIB and the US National Transportation Safety Board (NTSB), began the data extraction process. The Crash Protection Module (CPM) from the front black box was safely retrieved, and on 25 June 2025, the memory module was successfully accessed and its data downloaded at the AAIB lab," the statement said.

## "So-Called Court of Arbitration on Indus Waters Treaty Illegal, Void": India

strongly-worded statement, rejected a 'supplemental award" by an "illegal" Court of Arbitration set up supposedly over the 1960 Indus Waters Treaty. Calling the self-appointed panel unlawful and in "brazen violation" of the treaty itself, India's foreign ministry unequivocally trashed its claims and "concerns". In a five-point statement, India's Ministry of External Affairs said, "Today, the illegal Court of Arbitration, purportedly constituted under the Indus Waters Treaty 1960, albeit in brazen violation of it, has issued what it characterizes as a 'supplemental award' on its competence concerning the Kishenganga and Ratle hydroelectric projects in the Indian Union Territory of Jammu and Kashmir." Making it clear that New Delhi never considered this selfappointed, so-called 'arbiter' to have any locus standi in any of India's matters, the foreign ministry stated that "India has never recognised the existence in law of this so-called Court of Arbitration, and India's position has all along been that the constitution of this so-called arbitral body is in itself a serious breach of the Indus Waters Treaty.'

"Consequently, any proceedings before this forum and any award or decision taken by it are also for that reason illegal and per se void," it added. Blaming Pakistan sqarely for the Indus Waters Treaty being put in "abeyance" after terrorist attacks in India, the foreign



ministry reiterated that "Following the Pahalgam terrorist attack, India has in exercise of its rights as a sovereign nation under international law, placed the Indus Waters Treaty in abeyance, until Pakistan credibly and irrevocably abjures its support for cross-border terrorism. Until such time that the Treaty is in abeyance, India is no longer bound to perform any of its obligations under the Treaty." Calling out the "socalled Court of Arbitration" for acting at the behest of Pakistan and highlighting that the self-appointed panel has "no existence in the eyes of the law", India said, "No Court of Arbitration, much less this illegally constituted arbitral body which has no existence in the eye of law, has the jurisdiction to examine the legality of India's actions in exercise of its rights as

a sovereign," adding that "India, therefore, categorically rejects this socalled supplemental award as it has rejected all prior pronouncements of this body."Labeling Pakistan as the global epicenter for terrorism, India underscored that "This latest charade at Pakistan's behest is yet another desperate attempt by it to escape accountability for its role as the global epicenter of terrorism. Pakistan's resort to this fabricated arbitration mechanism is consistent with its decades-long pattern of deception and manipulation of international forums." India has made it amply clear that the Indus Waters Treaty shall continue to remain in abeyance till Pakistan does not eradicate every shred of terror infrastructure and financing, as well as eliminate every single terrorist on its soil. New Delhi

has also sent a clear message to Pakistan and the global community that any terror activity or terrorist attack in India with links found directly or indirectly to Pakistan will be considered an escalation which merits a military response by India "anywhere in Pakistan". The Indus Waters Treaty being kept in abeyance was one of the first diplomatically-punitive measures taken by India against Pakistan after the Pahalgam terror attack was traced to have Pakistani-links. Prime Minister Narendra Modi has said that "blood and water cannot flow together." India has also repeatedly told Pakistan that "terror and talks cannot happen at the same time" either, leaving Islamabad and Rawalpindi (Pak Army headquarters) with no option but to put an end to its policy of "crossborder terror" in order to get its share of water as per the agreement.

Under the 1960 Indus Waters Treaty, India had, as a gesture of goodwill, graciously agreed to share the waters from the Indus river and its five tributaries - Baes, Sutlej, Ravi, Chenab, and Jhelum - on a mutually agreeable basis. According to the pact, the waters of the three 'western rivers' - Indus, Jhelum, and Chenab are to be released for Pakistan as per agreeable terms, while the entire volume of water from the three 'eastern rivers' - Baes, Sutlej, and Ravi - are for India. There are detailed terms and conditions which allows for building of dams, sharing of data annually, and multiple other factors.

## In Big Win For Trump, US SC Curbs Judges' Powers to Block His Orders



New Delhi, (HS): The US Supreme Court handed President Donald Trump a major victory on Friday by curbing the power of lone federal judges to block executive actions. In a 6-3 ruling stemming from Trump's bid to end birthright citizenship, the court said nationwide injunctions issued by district court judges "likely exceed the equitable authority that Congress has granted to federal courts." The top court did not immediately rule on the constitutionality of Trump's executive order seeking to end automatic citizenship for children born on American soil. But the broader decision on the scope of judicial rulings will remove a big roadblock to Trump's often highly controversial orders and reaffirm the White House's power.


"Federal courts do not exercise general oversight of the Executive Branch; they resolve cases and controversies consistent with the authority Congress has given them," said Justice Amy Coney Barrett, author of the opinion. "When a court concludes that the Executive Branch has acted unlawfully, the answer is not for the court to exceed its power, too," Barrett said in an opinion joined by the other five conservative justices on the court. The three liberal justices dissented. The ruling has far-reaching ramifications for the ability of the judiciary to rein in Trump or future American presidents. The case was ostensibly about Trump's executive order signed on his first day in office ending birthright citizenship. But it

actually focused on whether a single federal district court judge has the right to issue a nationwide block to a presidential decree with a universal injunction while the matter is being challenged in the courts. Trump's birthright citizenship order has been deemed unconstitutional by courts in Maryland, Massachusetts and Washington state, leading the president to make an emergency appeal to the Supreme Court in an effort to get the top court to strike down the use of nationwide injunctions. The issue has become a rallying cry for Trump and his Republican allies, who accuse the judiciary of stymying his agenda against the will of voters. Trump's executive order on birthright citizenship is just one of a number of his agenda items that have been blocked by judges around the country -- both Democratic and Republican appointees - since he took office in January. During oral arguments in the case before the Supreme Court in May, both conservative and liberal justices had expressed concerns about the increasing use of nationwide injunctions by district courts in recent years.

'Nuclear Weapon': Justice Samuel Alito, an archconservative, said nationwide injunctions pose a "practical
problem" because there are hundreds of district court judges
and every one of them is "convinced" they know best.
Solicitor General John Sauer compared nationwide injunctions
to a "nuclear weapon," saying they "disrupt the Constitution's
careful balancing of the separation of powers." The Trump
administration had asked the Supreme Court to restrict the
application of a district court's injunction solely to the parties
who brought the case and the district where the judge presides.
Past presidents have also complained about national
injunctions shackling their agenda, but such orders have sharply
risen under Trump, who has seen more in two months than
Democrat Joe Biden did during his first three years in office.

Trump's executive order on birthright citizenship decrees that children born to parents in the United States illegally or on temporary visas would not automatically become citizens. The three lower courts ruled that to be a violation of the 14th Amendment, which states: "All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States."

Siddharth noted. The court further said, "This Court finds that after live-in-relationship has been legalised by the Apex Court, the Court had fed up such cases. These cases are coming to the Court because the concept of live-in-relationship is against the settled law in the Indian Middle-Class Society." These remarks came while the court was hearing the bail plea of an accused named Shane Alam, who had been booked under various provisions of the Bharatiya

Nyaya Sanhita (BNS) and the Protection of Children from Sexual Offences (POCSO) Act. He was accused of engaging in a physical relationship with the prosecutrix on the false assurance of marriage and later reneging on his commitment. Advocate Madhu Yadav, appearing for the informant, argued that the actions of the accused had ruined her entire life, claiming that no one would now be willing to marry her. Taking note of the argument, the court observed that while the idea of live-in relationships had attracted the younger generation, its consequences were evident in cases like the one before it. However, the bench granted bail to the accused on 24 June this year, considering his continued incarceration since 25 February

## **EU Envoy Hopes Restoration of Democratic Order in Bangladesh**

Dhaka, (H.S): Michael Miller, the European Union's Ambassador to Bangladesh, on Thursday expressed hope that Bangladesh will soon witness the restoration of democratic order through a free, fair, and credible national election. The EU Ambassador made the remarks during his meeting with Bangladesh Nationalist Party (BNP) Standing Committee member Amir Khosru Mahmud Chowdhury at the party chairperson's office in Dhaka.

The meeting was also attended by the BNP Organising Secretary Shama Obaed, local media reported.Addressing reporters after the meeting, Khosru said, like other international partners, the EU is awaiting the formation of an elected government to determine the future course of action."The first thing that was discussed was the election. The election is being held in February, so everyone is relieved and satisfied, and they hope that we will move towards elections soon and the country will return to democratic order. Because they feel comfortable working with an elected government, we have had detailed discussions about



these," Bangladeshi media outlet UNB quoted the BNP leader as saying. Khosru added that during the meeting, the problems and rights of workers in Bangladesh were discussed. He also said that the EU seeks to cooperate with the future Parliament of Bangladesh to ensure that activities can be carried out independently, effectively, and with accountability."

They are thinking about new ways of funding. They want to cooperate with the next government economically and be a development partner of Bangladesh. This is a good sign," Khosru further added. Last week, United Nations High

Commissioner for Human Rights Volker Turk expressed grave concern over recent legislative amendments made under the Muhammad Yunus-led interim government in Bangladesh that allowed the ban of political parties, organisations, and their related activities.

Addressing the 59th session of the Human Rights Council in Geneva, the UN human rights chief urged the interim government to make meaningful advances on reforms to create the environment for free and inclusive elections."I am concerned about recent changes to legislation to allow the banning of political parties and organisations and all

related activities. This unduly restricts the freedoms of association, expression, and assembly. I urge meaningful advances on reforms to create the environment for free and inclusive elections," said Turk.Previously, the Office of the United Nations High Commissioner for Human Rights (OHCHR) presented a fact-finding report on Bangladesh that included suggestions in certain specific domains, such as accountability and justice, police and security, civic space, political system, and economic governance.

According to the report, the UN noted that prohibiting political parties would hinder a genuine transition to multiparty democracy and would essentially disenfranchise a significant portion of the Bangladeshi electorate. Human Rights Watch, a US-based advocacy group, also severely criticised the Yunus regime for attempting to suppress the rights of supporters of former Prime Minister Sheikh Hasina and the Awami League party. The recent legislative initiatives by the interim government risk undermining fundamental freedoms, the rights body emphasised in a statement."On

May 12, the interim government ordered a 'temporary' ban on the Awami League using newly introduced powers under a draconian amendment to the Anti-Terrorism Act. The ban includes, among other actions, meetings, publications, and online speech supporting the party," said HRW."The ban on the Awami League will apply until party leaders have faced trial for abuses committed during their 15-year rule, a process that could last years, thus effectively proscribing the party.

The interim government has prohibited all activities, including any kind of publication, media, online and social media, any kind of campaign, procession, meeting, gathering, conference, etc. by the Bangladesh Awami League, curtailing supporters freedom of speech and association," it further added. Earlier, the UN Secretary-General Antonio Guterres too had called for inclusive elections in Bangladesh, urging the interim government under Yunus "to continue to make every effort" to be inclusive, taking into account the voices of women and youth as well as those of minority and indigenous communities.

# Japan Hangs Serial Killer In First-Ever Execution Since 2022

Tokyo, (H.S): Japan on Friday executed a man convicted of the 2017 serial killing of nine people in Kanagawa Prefecture. The 34-year-old accused Shiraishi Takahiro, dubbed Japan's "Twitter killer," was hanged at the Tokyo Detention House. This was the first execution carried out in Japan since July 2022, and the first under Japanese Prime Minister Shigeru Ishiba's administration, according to media reports. Addressing a press conference on Friday morning, Japan's Justice Minister Keisuke Suzuki stated that he carefully considered the matter before approving the execution order for the death row inmate convicted of killing nine people. "This case, driven by selfish motives such as sexual and financial gratification, resulted in the deaths of nine individuals over two months - a deeply serious incident that has caused shock and anxiety across society.

I understand it is an especially heartbreaking case for both the victims and their families," the Justice Minister told reporters. "The death sentence was finalised following a thorough trial process. After careful and deliberate consideration of all factors, I issued the execution order," Suzuki added. Local media reported that the accused, Shiraishi, was taken into custody in 2017 after the remains of one man and eight women were discovered at his apartment in Zama City, Kanagawa Prefecture, south of Tokyo.

In 2020 Tokyo District Court's Tachikawa branch sentenced Shiraishi to death, calling his acts a "malicious crime in criminal history" for murdering, dismembering, and storing the bodies of the nine people in his apartment. The ruling was later finalised in 2021. According to the court ruling, Shiraishi was found guilty of killing a man and eight women between the ages of 15 and 26 in his apartment after targeting them for expressing suicidal thoughts on social media platforms. The court mentioned that the nine victims did not consent to be killed, and dismissed the defense's claim that Shiraishi was possibly mentally incompetent when the crimes were committed.

#### NATO's Defence Spending Increase Won't Significantly Affect Russia's Security: Lavrov



Moscow, (H.S): The goal to increase the North Atlantic Treaty Organisation's (NATO) military spending will not significantly impact Russia's security, Russian Foreign Minister Sergei Lavrov said Thursday."I don't think it will be significant in any way," Lavrov told a press conference, commenting on the impact of NATO member states' goal to increase defence expenditure to five per cent of gross domestic product by 2035.Leaders of

NATO member concluded a two-day summit on Wednesday with a brief joint declaration committing to raise their defence spending to five per cent of Gross Domestic Product (GDP) annually by 2035. The five-paragraph issued statement Wednesday following the highlevel summit in The Hague outlined that the new spending target will be split between two key categories: 3.5 per cent for core defence and 1.5 per cent

for related areas, including critical infrastructure, networks, and defence industrial capabilities. The plan will undergo a review in 2029, taking into account the strategic environment and revised capability targets, the document added. US President Donald Trump hailed the agreement at a press conference after the summit, asserting that Washington had long carried more than its fair share of the alliance's defence burden.

However, he singled out Spain, criticising Madrid as the only country refusing to meet its full commitment, Xinhua news agency reported. Trump said the United States is negotiating a trade deal with Spain and warned that Madrid could be made to "pay twice as much" through trade measures. Spain has agreed with NATO to limit its military spending to 2.1 per cent of GDP, Spanish Prime Minister Pedro Sanchez announced on Sunday, ahead of the NATO summit.

#### South Korea: Lee Nominates New Chief f Constitutional Court

Seoul, (H.S): South Korean President Lee Jae Myung on Thursday nominated a former Supreme Court justice as the new chief of the Constitutional Court, the presidential office said. Former Supreme Court Justice Kim Sang-hwan was picked to replace then acting court chief Moon Hyung-bae, who retired in April.Lee also tapped Oh Youngjoon, the presiding judge of the Seoul High Court, to join the court's nine-member bench, presidential chief of staff Kang Hoon-sik told reporters."

The nominations mark the new government's first step toward restoring Constitutional Court," Kang said." They aim to end the attempts that had reached a dangerous level to undermine the court, and to further enhance public trust and the independence of its rulings."The top court was in the spotlight as it upheld the impeachment of former President Yoon Suk Yeol in April over his failed martial law bid in December, with some judges facing threats from Yoon's supporters ahead of the ruling.



Kwang-hyun, a lawmaker from the ruling Democratic Party, as commissioner of the National Tax Service.Lim formerly served as Commissioner of the Seoul Regional Tax Service and was elected to the National Assembly last year through a proportional representation seat slot. If appointed, Lim would become the first sitting lawmaker to lead the National Tax Service, Yonhap news agency reported. All such nominees must undergo parliamentary confirmation hearings before they can be formally appointed by the

parliamentary approval to take their posts. Earlier on June 23, Lee Jae Myung named five-term lawmaker Ahn Gyu-back as Defence Minister, the first time in 64 years that a civilian has been nominated for the post.Lee's pick of Ahn is seen as carrying out his election pledge to reform the military, a key promise from his presidential campaign to rebuild a nation fractured by the brief imposition of martial law in December last year under his predecessor, the ousted President Yoon Suk Yeol.The military has come under scrutiny

since Yoon deployed troops to the National Assembly when he declared martial law on December 3, allegedly to block lawmakers attempting to stop his brief imposition of martial law decree. Yoon was removed from office in Aprilover the martial law debacle. Ahn is a veteran politician with the Democratic Party who has mostly served on the defence subcommittee of the National Assembly. If confirmed, he will be the first civilian Defence Minister since 1961, when former President Park Chung-hee seized power through a military coup."

As the first civilian Defence Minister in 64 years, Ahn is expected to lead and oversee the transformation of the military that was mobilised during the martial law period," Kang said in a press briefing.Lee also tapped former Vice Foreign Minister Cho Hyun as South Korea's top diplomat, as he announced his picks for 11 Cabinet positions, including ministers for the environment, science and labour, in the latest nominations since he assumed office June 4.

United Nations: UN Secretary-General Antonio Guterres called out the selective application of the UN Charter, saying it is not an a-la-carte menu."Today, we see assaults on the purposes and principles of the UN Charter like never before: the threat or use of force against sovereign nations;

the violation of international law, including international humanitarian law and international human rights law; the targeting of civilians and civilian infrastructure; the weaponization of food and water; the erosion of human rights," he told a UN General Assembly

event on Thursday to mark the 80th anniversary of the signing of the UN Charter."On and on, we see an all-too-familiar pattern: follow when the charter suits, ignore when it does not," he said. "The Charter of the United Nations is not optional. It is not an a-la-carte menu. It is the

bedrock of international relations. We cannot and must not normalize violations of its most basic principles."The UN Charter is a declaration of hope - and the foundation of international cooperation for a better world," said Guterres."The charter has given us the tools to change

destinies, save lives, and deliver hope to the most desperate corners of the world. And we can draw a direct line from the creation of the United Nations and the prevention of a third world war," he added. Upholding the purposes and principles of the UN Charter is a never-ending mission, said Guterres, stressing the need more than ever to respect and re-commit to international law - in words and deeds, Xinhua news agency reported." On this anniversary, I urge all member states to live up to the spirit and letter of the charter, to the responsibilities it

## Iran's Three Key Nuclear Sites Significantly Damaged in 12-Day Operation: IDF

Tel Aviv, (H.S): The Israel Defense Forces (IDF) on Friday announced that its 12-day military operation against Iran resulted in significant damage to three of the country's main nuclear facilities, Fordow, Natanz, and Isfahan, dealing a major blow to the Iranian regime's nuclear infrastructure. The IDF asserted that Israel launched 'Operation Rising Lion' on June 13 intending to damage the Iranian nuclear and missile projects following the identification of progress in the three programmes whose ultimate goal was to "destroy the State of Israel".

According to the Israeli military, to thwart the future of the program, 11 senior nuclear scientists who were central knowledge centres in the Iranian weapons group were eliminated, and the inactive nuclear reactor at Arak was also attacked to prevent its future use. "The key building blocks of the missile manufacturing industry were attacked. More than 35 sites were attacked, 200 launchers and 50 per cent of all the Iranian regime's launchers were completely



destroyed. In total, more than 1,500 components, 15 enemy aircraft, more than 90 targets 80 surface-to-air missile launchers and 6 airfields were attacked. Hundreds of Iranian military forces were eliminated, dozens of commanders were attacked and more than 30 senior members of the Iranian regime's security apparatus were thwarted," read a statement issued by the IDF.The IDF noted that throughout the operation it created increasing achievement and complete freedom of aerial action in the heart of Iran and fully met the objectives defined for the operation."Throughout the entire operation, high-quality and accurate intelligence, along with operational, technological and aerial capabilities, were evident. And alongside the entire offensive effort, the defence systems operated day and night," the IDF stated.Furthermore, the Israeli military mentioned that creating air superiority in Iranian skies, "the Israeli Air Force carried out 1,500 sorties and about 600 refuellings were made en route to Iran.""In the entire operation, 1,400 strikes were carried out by the fighter formation and 500 by the UAV formation, and the furthest of them was carried out at Mashhad airport, about 2,400

km from Israel, by a fighter jet. In addition, hundreds of interceptions of anti-aircraft missiles and drones were carried out. In total, 99per cent of the drones launched from Iran were intercepted," said the IDF.The Israeli military noted that during the 12-day operation, the Home Front Command, rescue and recovery forces operated in more than 170 locations across the country.

Earlier on Tuesday, Israeli Prime Minister Benjamin Netanyahu confirmed that Israel has accepted a ceasefire proposal with Iran, marking the end of 12 days of intense hostilities between the two regional rivals.In an official statement released by the Prime Minister's Office, Netanyahu declared that Israel had met all strategic goals of its military campaign, dubbed Operation Rising Lion, and even exceeded expectations."Israel had achieved all the objectives of Operation Rising Lion, and even far beyond that. Israel has removed a dual immediate existential threat - both in the nuclear domain and in the ballistic missile domain," the statement read.

agreement to establish the Special Tribunal for the Crime of Aggression against Ukraine. This historic signature reminds us that international law must apply to all - with no exceptions, and with no double standards.

This is a tribunal to judge between victims and aggressors, between impunity and accountability, because without accountability, there can be no lasting peace for Ukraine and Europe as a whole," said Secretary General Berset. The establishment of the Special Tribunal was requested by the Ukrainian authorities on May 13, and endorsed by the annual meeting of the Council of Europe foreign ministers in Luxembourg the following day.

#### Resilient Economy: Total Brand Value of Top 100 Indian Firms Hits \$236.5 Billion

New Delhi, (H.S): Showcasing resilient economy amid robust policies, the collective brand value of the top 100 Indian companies reached \$236.5 billion in 2025 to date, according to a new report. The 'Brand Finance India 100 2025' ranking results remain stable, reflecting a year of steady gains for major Indian brands across sectors.

Tata Group has once again secured its position as India's most valuable brand ranked by becoming the first Indian brand to cross the \$30 billion threshold. Its brand value is up 10 per cent to \$31.6 billion. As the second most valuable Indian brand, Infosys (brand value up 15 per cent to \$16.3 billion) continues to lead in the IT Services sector.HDFC Group (brand value up 37 per cent to \$14.2 billion) is third in the rankings. It has cemented its role as a financial services titan, post-merger with HDFC Ltd.At the fourth place, LIC (brand value up 35 per cent



\$13.6 billion) also demonstrated commendable growth, followed by HCLTech (brand value up 17 per cent to \$8.9 billion), at the eighth position, up one rank from 2024."Larsen & Toubro Group (brand value up 3 per cent to \$7.4 billion) held firm with increased thrust on high-tech manufacturing along with diversification into renewables and semiconductors as the ninth most valuable Indian brand ranked," the report mentioned.Rounding off the top 10, Mahindra Group (brand value up 9 per cent to \$7.2 billion) sustained strong momentum with tech and engineering innovation.

Adani Group emerged as the fastest-growing Indian brand ranked this year, with its brand value up by 82 per cent. The group's growth is attributed to aggressive and integrated infrastructure focus, surge in green energy ambitions, and increased brand equity across key stakeholders, said the report.India's sustainability leadership also gains recognition. Tata Group holds the highest Sustainability Perceptions Value (SPV) among Indian brands ranked, standing at \$4.3 billion while Infosys has the highest positive sustainability gap value at \$115 million.

#### India Flags Off First Consignment of Rose-Scented Litchi from Pathankot to Qatar

significant boost to India's horticultural exports, the Agricultural and Processed Food Products Export Development Authority (APEDA), under the Ministry of Commerce & Industry, Government of India, in collaboration with the Department of Horticulture, Ministry of Agriculture and Farmers Welfare, Government of Punjab, facilitated the flag-off of the first consignment of 1 metric tonne of rose-scented litchi from Pathankot, Punjab to Doha, Qatar on 23rd June 2025.

In addition, 0.5 metric tonne of litchi was also exported to Dubai, UAE from Pathankot, marking a twin export achievement and reinforcing India's potential in global fresh fruit markets. This milestone initiative underscores the excellence of India's horticultural produce and highlights the country's growing agri-export capabilities. It offers immense



opportunities for farming communities by providing international market access for their fresh and high-value produce. The initiative was facilitated by APEDA in association with the Department of Horticulture, Government of Punjab, Lulu Group, and progressive farmer, Shri Prabhat Singh from Sujanpur, who supplied the high-quality produce. According to the National Horticulture Board, Punjab's litchi production for FY 2023-24 stood at 71,490 metric

tonnes, contributing 12.39% to India's total litchi output. During the same period, India exported 639.53 metric tonnes of litchi. The area under cultivation was 4.327 hectares with an average yield of 16,523 kg/ha.The flagged-off consignment, comprising a reefer pallet of premium Pathankot litchis, represents a major step forward for the region's growers. The success of farmers like Shri Prabhat Singh underscores the potential of Pathankot-which benefits from favourable agro-

climatic conditions-as an emerging hub for quality litchi cultivation and exports. Notably, during FY 2024-25 (April-March), India's export of fruits and vegetables reached USD 3.87 billion, registering a 5.67% growth over the previous year. While mangoes, bananas, grapes, and oranges continue to dominate fruit exports, cherries, jamun, and litchis are now increasingly finding their place in international markets.

These efforts reflect the Government of India's commitment to expanding the agri-export basket, empowering farmers, and enhancing the global competitiveness of Indian produce. #### India's GDP Projected to Grow at 6.2 Pc in FY26 with Inflation Around 4 Pc

Mumbai, (H.S): India's GDP is projected to grow at 6.2 per cent in FY26, with CPI inflation around an average 4.0 per cent, a report showed on Friday, adding that it does not expect any further rate cuts from the RBI "unless downside risks to growth materialise".

The Current Account Deficit or CAD (as per cent of GDP) is projected at 1.0 per cent in FY25 and 0.9 per cent in FY26, while the fiscal deficit is estimated at 4.4 per cent, according to a CareEdge Ratings report."The 10-year G-Sec yield is expected to range between 6.0 per cent-6.2 per cent by the end of FY26, and the USD-INR exchange rate is projected to trade between 85 and 87 by the end of FY26," the report mentioned.In the recent MPC, RBI signalled prioritising



growth amid easing inflation concerns. In a significant liquidity measure, the RBI also announced a phased 100 bps CRR cut starting September, which is expected to inject approximately Rs 2.5 lakh crore of durable liquidity into the system by December 2025.For FY26, the RBI retained its GDP growth forecast at 6.5 per cent, while lowering the CPI inflation

projection to 3.7 per cent from 4.0 per cent. Meanwhile, crude oil prices surged sharply in June amid heightened Middle East tensions, touching around \$79 per barrel - the highest since January 2025 - before easing by 14 per cent as tensions subsided. CareEdge Ratings expects Brent to average \$65-70 per barrel in FY26, assuming no further escalation in tensions. These levels do not warrant changes to their FY26 forecasts for India's growth, inflation, fiscal deficit, CAD or the rupee."Nonetheless, the conflict in the Middle East remains a key monitorable, especially as the Strait of Hormuz accounts for over a quarter of global seaborne oil trade," said the

India's diversified crude oil import basket also provides some buffer. Based on quantity imported, Iran's share in India's POL (petroleum, oil and lubricants) imports fell to just 0.1 per cent in FY25 (from 5.2 per cent in FY15). While the Middle East remains a major supplier, its share has declined to 50 per cent from 60 per cent over the past decade. In contrast, imports from other countries like Russia surged to 28.5 per cent in FY25 from just 0.2 per cent in FY15.

#### JSW plans 4,000 crore debt sale to fund Akzo Nobel acquisition deal

New Delhi, (H.S): Indian conglomerate JSW Group is in talks with global lenders to raise about 40 billion rupees (\$468 million) to partly fund its purchase of Akzo Nobel NV's local business, according to people familiar with the matter.

Foreign banks including Barclays Plc, Mitsubishi UFJ Financial Group Inc. and Standard Chartered Bank Plc will arrange the debt, which is expected to be denominated in rupees, said the people, who asked not to be identified because the information is confidential. JSW Group has also reached out to international private credit funds including Ares Management Corp, Cerberus Capital Management Farallon Capital Management though nothing has



been finalized yet, said the people. Morgan Stanley, a bank on the acquistion, will also be involved in the borrowing, two of the people said.

JSW Group agreed to buy up to 75% of Akzo Nobel NV's Indian business in a deal valued at about \$1.6 billion, including debt, as the Indian conglomerate seeks to expand its presence in areas such as paints. A rupee bond deal would be a boon for supply in India's booming local debt market, which year to date

has seen issuance of 6.5 trillion rupees (\$76 billion), up 28.4% from a year ago, according to data compiled by Bloomberg. Acquisition financing has been a bright spot for global lenders in India, particularly private credit funds. In the second half of 2024, private credit deals showed a "strong focus" on such deals, global consulting firm Ernst & Young wrote in a report.

The planned debt could be raised in multiple tranches and levels, and the tenor could be up to three years, said the people. The terms and currency of the deal are not yet final and could still change, they added. Ares and Standard Chartered declined to comment. JSW Group, Barclays, Mitsubishi and other lenders did not immediately respond to requests for comment.

#### SEBI Imposes 25 Lakh Penalty on BSE For Breach of Norms

Mumbai, (H.S): The Securities and Exchange Board of India (SEBI) on Wednesday imposed a penalty of Rs 25 lakh on BSE Ltd for violation of norms related to dissemination of pricesensitive information by corporates, weak supervision of broker trades, and laxity in taking action. The punitive action follows an inspection of the stock exchange carried out between February 2021 and September 2022, after which a show cause notice was issued.

The SEBI investigation revealed that BSE's system architecture allowed its paid clients and internal listing compliance monitoring (LCM) team to access corporate announcements before these were made public through its website. The capital markets regulator observed that the data dissemination process lacked safeguards to ensure simultaneous and equal access to all stakeholders, which is critical to maintaining market integrity and preventing unfair information advantage.It concluded after its probe that the BSE failed to comply with the regulation that mandates stock exchanges to



to all users.It also noted that the BSE did not establish a really simple syndication (RSS) feed, which could have mitigated the risk of unequal access to corporate disclosures. The SEBI also flagged serious shortcomings in BSE's monitoring of client code modifications, which are permitted only in case of genuine errors. The exchange failed to initiate disciplinary action against brokers with frequent modifications and did not adequately monitor 'error accounts', raising concerns over the possibility of misuse and lack of due diligence in trades between unrelated institutional clients. The exchange was found to be merely taking confirmation from brokers with respect to trades transferred to the error account being subsequently liquidated. Inspection of all brokers for error account review was not being done every year, and even when it was done, the BSE was relying on confirmations provided by brokers themselves. The SEBI order points out that, being a firstlevel regulator, the "BSE must have internal controls on how to manage and handle such corporate announcements so as to ensure compliance with its obligations". It said all persons should have unrestricted, transparent and fair

access to information." availability information about listed companies with employees of LCM of the BSE and its paid subscribers before it is available to general investors through its website of the BSE has clearly impaired the concept of impartiality, transparency and fairness of information dissemination from the first-level regulator BSE," the order states."This case involves multiple acts of omissions, laxity and negligence with a certain amount of lethargic approach, which cannot be allowed to be exonerated if the first level regulator having paramount duties of regulation and oversight shows such approach of lax regulation leaving visible scope for misuse of its systems," the order added.

New Delhi, (H.S): The Quality Control Orders (QCOs) have benefitted the micro, small and medium enterprises (MSMEs) by enhancing their products and competitiveness, Commerce Minister Piyush Goyal has said.

The QCO is a critical step in restricting the import of substandard products and ensuring consumer safety, while also enhancing the competitiveness of Indian industry.In a post on X social media platform, Goyal said he held a stakeholder consultation meeting with the MSME sector to discuss the implementation of QCOs. "Appreciated their feedback on making the standard setting process more collaborative, inclusive and easier to comply with. MSMEs acknowledged how the QCOs have benefited their sector by

#### India's Sugar Output To Rise 15 Pc At 35 Million **Tonnes on Favourable Monsoon: Crisil**

New Delhi, (H.S): India's gross sugar production is likely to rise 15 per cent in sugar season 2026 to about 35 million tonnes, aided by above average monsoon, boosting cane acreage and yields in key sugar producing states such as Maharashtra and Karnataka, a Crisil report showed on Friday. The growth is expected to ease tightness in domestic supply and has the potential to boost ethanol diversion and revive exports with appropriate policy support.In fiscal 2026, with improved supplies and potentially higher diversion of sugar for blending ethanol with gasoline, the operating margin of sugar mills is likely to recover to about 9-9.5 per cent. This should support credit profiles of sugar

players, which saw some pressure last fiscal. Over the past two seasons, while the fair and remunerative (FRP) price of sugarcane has risen 11 per cent, ethanol prices have largely remained unchanged.In sugar season 2026, diversion for ethanol is expected to rise to 4 million tonnes (from 3.5 million tonnes in sugar season 2025), supported by high sugar output and the government's 20 per cent blending target (19 per cent average achieved so far), as it offers faster cash-flow churn, the report mentioned. Meanwhile, domestic sugar prices have held steady at Rs 35-38 per kg this season. With output expected to rise, sugar prices are likely to remain range-bound. Exports, at 1

million tonnes in sugar season 2025, can comfortably continue at similar levels in 2026 with high sugar output and opening inventory of 2 months of consumption."Sugar inventory levels at the end of fiscal 2026 are expected to remain at levels similar to last year, limiting the rise in working capital debt despite higher distillery operations," said Poonam Upadhyay, Director, Crisil Ratings. For the upcoming season, key watchpoints for the sector include temporal and spatial distribution of monsoon, its impact on cane yield, timely ethanol price revisions and clarity on export policy amid global sugar price movements, according to the report.

The introduction of limits on the number of lenders and the individual exposure size for projects financed by a consortium would ensure each lender has a higher stake and

hence is more proactive in due diligence, credit appraisal and risk underwriting during the loan tenure. Further, it will enable more efficient decision-making given the lower number of stakeholders and greater alignment of interests.

The new direction brings in a higher base level standard asset provisioning for underconstruction projects set at 1 per cent and a slightly higher 1.25 per cent for under-construction CRE exposures (that compares

with the extant 0.4 per cent to 1.0 per cent), with step-ups linked to DCCO deferment period. This higher base level provisioning will bring in a between differentiation provisioning for underconstruction and operational projects to address the inherently higher risk in the former. It also now guides lenders to step up their provisioning cushion aligned to the number of quarters for which the DCCO has been extended, in case the risk characteristics of a funded project change, the report states.

More stringent conditions on permitted cumulative DCCO deferment to maintain 'Standard' asset classification reduced to up to 3 years for infrastructure projects, irrespective of reason. For non-infrastructure projects, this has been retained at two years. This could pose a challenge for lenders in cases of long-drawn litigation, but allows earlier recognition of stress and adoption of necessary steps to address the same, albeit with higher provisioning, the report added.

### Maa movie review: Kajol's forgets to bring horror in this drama



«Main vahaan baithkar chamatkar ka intezaar nahi kar sakti, « declares Kajol's character towards the climax, as her daughter is abducted by a supernatural force. Fair enough, because frankly, neither can we. We've already spent two hours waiting for any sign of horror in this horror-mythological film. If something doesn't start spooking us soon, we might just call the monster ourselves.

Maa, directed by Vishal Furia of Chhorii fame, kicks off with a girl child's sacrifice in Chandrapur, and then we are immediately transported 40 years later. Ambika (Kajol) is leading a happy life with her husband Shubhankar (Indraneil Sengupta) and daughter Shweta (Kherin Sharma). For some reason, they don't want to visit Chandrapur, Shubhankar's ancestral village. But his father's death forces him to go and visit, and he dies. Ambika and Shweta, grieving, give it a visit after three

months on the insistence of Joydev (Ronit Roy) as they plan on selling off their ancestral house. But Ambika isn't ready for what's waiting. The film pins its ambitions on the story of Goddess Kali and Raktabija, an epic premise no doubt. One drop of the demon's blood, which fell to the Earth, creates a monster that terrorises the village for decades. Sounds great on paper. But the film takes ages to set the mood in the first half. You are neither scared nor sucked into this world. The second half sets things into motion, for a buildup to a climax that should have felt more pacy. And more impactful. There's social commentary buried somewhere in the ritualistic blood, VFX smoke and characters speaking Bengali deliberately in such a heavy accent as though their life depended upon itcoupled with a feminist undertone. It barely lands. The intent is in place though: the idea of a desperate mother becoming

Maa in the climax is executed well, and is frankly the only part where you are hooked. Now if only the entire film had such elevation points.

Now, let's talk about the main attraction- the supernatural entity. It gets a ton of screentime, but unfortunately, Maa's makers mistake screentime for scariness. The creature is supposed to send shivers down your spine; instead, it looks like it escaped from a mid-budget TV serial and got stuck in a CGI filter. Kajol's act as Ambika feels one dimensionalit's the quintessential Kajol you have seen in umpteen films, and her character at no point progresses from being ordinary to awe-inducing. Ronit Roy gets a chance to experiment here, and he fares better. The chemistry between Kajol and her on-screen daughter Kherin isn't as endearing or emotional as it should have been. Also, there was absolutely no scope to add a song in the climax, so it feels a bit out of

To sum it up, Maa has all the right ingredients, from maternal rage to a haunted village. But the makers throw all of it into a cauldron and forget to turn the heat up. It wants to say something powerful about a mother pulling out all stops for her children, but sadly the beating heart is buried underneath the conventional

# ICC introduces new rules stop clock in World Test Championship

Dubai, (HS): The ICC has introduced stop clock in Test cricket to deal with slow over rates while allowing fielding teams to decide which batter should be on strike in case of a deliberate' short-run as part of the playing conditions for 2025-27 World Test Championship cycle.

The new rules have been implemented from the 2025-2027 World Test Championship which got underway with the first of the two Tests between Sri Lanka and Bangladesh in Galle. According to the ICC Test Match Playing Conditions on the governing body's website, the use of the stop clock like in limited-overs cricket has been implemented to eradicate the issue of slow over-rate. The fielding side shall be ready to start each over within 60 seconds of the previous over being completed. An electronic clock will be displayed at the ground



that counts up seconds from zero to 60, the ICC said. The fielding side will thus be given two warnings and in case of a third infraction, the batting side will be awarded with five penalty runs. These warnings will be reset to zero after the completion of 80 overs, the ICC said.

Meanwhile, ESPNcricinfo reported that the ICC no longer mandates the umpires to change the ball once they discover saliva saliva remains in force. The website said fielding teams may deliberately apply saliva on the ball to force a ball-change but the current document available on playing conditions for men's Test cricket does not mention any such change. The ICC also said in case there are instances of referrals being made by both player and the on-field umpire,

a chronological order, effectively as per the order of their occurrence. In such scenarios, the umpire at the bowler's end will disallow all runs to the batting side, return any not out batter to his original end, signal a no-ball or a wide-ball if applicable, make a short-run signal, award five penalty runs to the fielding side and "request their captain to identify which of the two batters will be on strike for the next delivery".
