





Stampede Mars Rath Yatra

Three killed, several injured in stampede near Gundicha temple in Puri in the early hours of Sunday



Puri (DMC) : At least three devotees were killed and over 50 others injured in a stampede near Shree Gundicha Temple at Saradhabali in Odisha's Puri in the early hours of Sunday. The deceased have been identified as Premakanta Mohanty (80), Basanti Sahoo (36) and Prabhati Das (42).

The stampede occurred at around 4.20 pm when a large number of devotees gathered to catch a glimpse of the deities on their respective chariots, which had arrived at Saradhabali from Shree Jagannath Temple on Saturday at around 1:30 pm after the chariot-pulling, left incomplete earlier resumed the



previous morning. According to eyewitnesses, the stampede occurred after two trucks carrying wooden logs tried to enter the already crowded area where palm-log ladders were scattered. There were no adequate police arrangements or officials on-site to manage the swelling number of pilgrims, they alleged.

Puri Collector Siddharth Shankar Swain, however, said that there was a sudden rush of devotees soon after the 'pahada'. "Nine devotees complained of breathlessness and were immediately taken to the hospital. Unfortunately, three of them died, while the rest are currently stable," he said. Law Minister

Prithiviraj Harichandan has announced a high-level inquiry in the incident. "The tragedy involving three deaths has deeply saddened us. We will conduct a thorough investigation, and appropriate action will be taken against those whose negligence led to this unfortunate incident," he said

This is the first time a fatal stampede has occurred outside the Gundicha Temple, locals said. This comes at a time when the BJP-run state government has come in for severe criticism from Opposition the for mismanagement over inordinate delay in pulling the Nandighosha chariot of Lord Jagannath. This apart, around 750 devotees had to be taken to hospital on Friday due to exhaustion and crowd pressure during Rath Yatra. More than 230 devotees were taken to the Infectious Disease Hospital (IDH), while around 520 others were treated at the district headquarters hospital (DHH), officials said. While most were discharged after first aid, one critically ill devotee had to be shifted to the SCB Medical College and Hospital in Cuttack. At least 12 patients are in the

Bhubaneswar, (DMC): Chief Minister Mohan Charan Majhi on Sunday issued an apology for the tragic stampede near Gundicha Temple in Odisha Puri this morning, which resulted in three deaths and multiple injuries. "I and my government seek forgiveness from all Jagannath devotees. We offer our deepest condolences to the families of the deceased and pray to Mahaprabhu Jagannath to give them strength in this time of grief," the CM said in a statement.

This level of negligence is wholly unacceptable. He described the incident as "unforgivable negligence" and promised a thorough investigation into security lapses. "This level of negligence is wholly unacceptable. An immediate investigation into the safety lapses will be conducted and strict action will be taken against those responsible, with exemplary measures put in place to prevent such tragedies in the future," he posted on X. The CM, however, attribute the incident to chaotic rush of devotees eager to catch a glimpse of the sibling deities on the chariots. "Due to the intense eagerness among devotees to have a glimpse of Mahaprabhu at Saradhabali, an unfortunate incident occurred because of the resulting jostling and chaos," he wrote.

The deceased have been identified as Prabhati Das, Basanti Sahu, and Premakanta Mohanty. According to reports, the mishap occurred at around 4:20 AM when an overwhelming crowd of devotees had gathered for darshan of Lord Jagannath and His

Though initial reports claimed that over 50 devotees were injured in the stampede, the district administration officials stated that only six persons sustained injuries in the incident. Eyewitnesses alleged that the situation turned chaotic when two trucks carrying 'charamala' entered an already crowded area, leading to panic and a sudden rush among the devotees. Bike manufacturers to provide two helmets soon **Railway to resume direct recruitment for train controllers**



New Delhi, (HS) : The Ministry of Railways has announced that 60 per cent of vacancies in the train control department will be filled through direct recruitment by the Railway Recruitment Board (RRB),

marking the return of fresh intake into the department after a gap of seven years. According to reforms notified on June 25, the vacancies will now be open to graduate-level candidates, with the remaining 40 per cent to be filled through Limited Departmental Competitive Examinations (LDCE) or meritbased promotions from among eligible employees.

"How this examination will be conducted and what it will be called are some of the issues yet to be decided by the competent authority," said Dilip Kumar, Executive Director, Information and Publicity, Railway Board. Until 2017, the control department used to receive direct recruits via the Railway Traffic Apprentice Exams held by the RRB. However, the system was

95 cr people now benefiting from social security schemes: PM

New Delhi, (HS) : Prime Minister Narendra Modi on Sunday said around 95 crore people are benefiting from one social security scheme or the other, while till 2015, government schemes reached less than 25 crore people. In his monthly Mann Ki Baat radio broadcast, Modi cited an International Labour Organisation (ILO) report which stated that more than 64 per cent of India's

population is getting some form of social protection benefit.

"Presently, most of the populace in India is taking advantage of one social protection benefit or the other and recently a very important report of the International Labour Organisation (ILO) has come out. It has been mentioned in this report that more than 64% of the population of India is now definitely availing some sort of



social protection benefit or the other," Modi said. This is one of the biggest coverages in the world, he said. "Today, around 95 crore people of the country are getting the benefit of some or the other social security scheme; whereas, till 2015, the government schemes were reaching less than 25 crore people," Modi said. From health to social security, the country is moving ahead with the feeling of

saturation in every field, he said. "This is also a great picture of social justice. These successes have instilled a belief that the coming times will be even better; India will become even stronger at every step," Modi said. The prime minister also

hailed as a "remarkable milestone" the World Health Organisation declaring India Trachoma-free and lauded the efforts of healthcare workers for

Sensex Highs

This week has ended on a note of economic optimism, with the Sensex closing at 84,059, its highest level since October 1. The rupee has recovered to 85.5 to the US dollar, after having slid to below 86.9 on June 19. Brent crude prices, too, have softened to about \$67 a barrel, after soaring to \$79-plus at the start of the week. And the southwest monsoon has revived, with all-India average rainfall during June 1-27 being 10.3 per cent higher than the historical normal for this period. That's a turnaround from the situation till June 15, when cumulative rainfall was 31 per cent below normal and 30 out of the country's 36 meteorological subdivisions had registered deficits in excess of 15 per cent. That deficiency is now largely confined to Telangana, Andhra Pradesh, Marathwada-Vidarbha, Chhattisgarh, Bihar and the Northeast region. To be sure, these optimistic cues are less about genuinely positive expectations of the future than relief over the worst apparently being put behind. The ceasefire between Iran and Israel since October 24 was preceded, only a day before, by the former launching missiles at a US air base in Qatar and threatening to block the Strait of Hormuz - through which a fifth of the world's oil and a third of its liquefied natural gas flow. Those tensions have ebbed, for now. So have the uncertainties from the tariff war that US President Donald Trump unleashed in early April; they have seen some de-escalation with his administration claiming to have signed a truce deal with China. There has been a pause on the implementation of Trump's socalled reciprocal tariffs on other countries, including India, as well. But that three-month deadline ends on July 9. Simply put, there is only a temporary reprieve from the trade policy and geopolitical strains that may come back to haunt the global economy.India must keep the focus on the medium term. That would mean ensuring macroeconomic stability (the best defence against short-term global financial market and commodity price volatility, linked to geopolitical events) and ease-of-doingbusiness reforms to leverage its strengths (favourable demographics, a large consumer base and a potential alternative for investors looking at a China-plus-one strategy of diversifying their manufacturing and supply chains).

The Indian economy has so far demonstrated relative resilience, recording the highest growth among the world's major countries amid elevated global uncertainty. But India has to do well relative to not just the world, but to the aspirations of its young population and workforce - both current and those entering over the next couple of decades. Navigating short-run geopolitical uncertainty may be easier than meeting challenges and seizing opportunities beyond the immediate term.

ORANGE ECONOMY: The Supplement for Economic Growth

hough, the term "orange economy" is not a widely accepted academic concept but it's the popular term referring to the "creative economy" in the Latin American and Caribbean region. The term was first introduced in 2013 in an Inter-American Development Bank manual prepared by Felipe Buitrago Restrepo and Ivan Duque Marquez. Being inspired with the ancient Egyptian, Indian, and Native American cultural associations with the colour and concept of orange, they introduced the term 'Orange Economy', which refers to "the group of linked activities through which ideas are transformed into cultural goods and services whose value is determined by intellectual property." Thus, the orange/ creative economic universe includes: i) The Cultural Economy and the Creative industries, which share the Conventional Cultural Industries; and ii) creativity supporting. In other words, it refers to all business rooted in creativity, involving things like art, culture, research, science and technology. That's why in most parts of the world it's also termed as the "Creative Economy". The leaders of the G20 nations have recognized culture and creative industries as drivers of sustainable development and economic resilience, particularly in the wake of the pandemic. United Nations General Assembly also recognized the Creative Economy/

Orange Economy by declaring 2021 as the "International Year of Creative Economy for Sustainable Development, 2021".

Highlighting its economic contribution to the global growth, the United Nations Conference on Trade and Development (UNCTAD) values the global creative economy at over \$2.25 trillion (UNCTAD 2023). According to the UN estimate, the Creative Industries also account for nearly 50 million jobs worldwide out of which about

half are women. These industries employ more people in the age group of 15-29 years than any other sector. The International Finance Corporation (IFC) maintains that creative industry, which is a major component of the creative economy, has an important economic multiplier effect where a spending of \$1 creates \$2.5 of wealth for the economy. Creative Industries represent up to 2%-7% of GDP, depending upon the development stages of the economies and are likely to be an important driver of economic growth as governments increase their focus on this sector. UNCTAD's global survey reveals that the varied economic contributions of the creative economy across different countries, ranging from 0.5% to 7.3% of GDP and the economy employs between 0.5% and 12.5% of the total workforce. The report reveals that while the size of creative economy in United States is estimated at \$50.9 billion, on the other hand in Germany these industries contribute around •100 billion to the national GDP and employ over 1.8 million people. In 2022, the market size of hobbies and creative work in Japan amounted to approximately 7.43 trillion Japanese yen. In addition, the creative economy generates social and cultural capital in the developing block also. In South Africa, the cultural and creative industries contributed 5.6% to the gross domestic product. In Nigeria, the music industry was growing at an annual rate of



13.4%. The Nigerian film industry, known as "Nollywood", employs about one million people and, with over 2,000 films produced per year, was ahead of Hollywood. In Kenya, the entertainment and media sector grew by an average of almost 7% from 2014 to 2018.

Across the world, while creative services exports surged to \$1.4 trillion in 2022, marking a 29% increase since 2017, on the other hand, creative goods exports have registered a 19% increase (\$713 billion) during the same period. It's been found out that the developing countries primarily export creative goods, while developed countries dominate creative services exports. However, developing countries have significantly increased their share from 10% in 2010 to 20% in 2022. The most exported creative services in 2022 were software services (41.3%) and research and development (30.7%), followed by advertising, market research, and architecture (15.5%), audiovisual services (7.9%), information services (4%), and cultural, recreational, and heritage services (0.6%). It's a fact that few countries have a unique history of innovations and creativity that changed the world. India's tryst with creativity and innovation which ranges from the arts to science, from metallurgy to medicine and from astronomy and much more put the country in a unique position in the creative economic sector. Being an economic power house for several centuries, India played a

leadership role in all fields: be it art, culture, music, dance, food, festivals, architecture, or handicrafts. The country has established the fact that there is a close interrelationship between culture and the economy. In that glorious past, our economy was an important factor for our glorious civilization and cultural heritage. The reverse also held true: our cultural content contributed to our strong economy. As the country has taken up the ambitious challenge to become a \$5 trillion economy; fostering a new wave of innovation, especially at the grassroots level is highly essential. Creativity should not only be celebrated but strategically supported to drive economic

development. According to government sources (PIB), today, more and more people are turning their ideas and imaginations into livelihoods. The creative industry in our country is now a \$30 billion sector and employs roughly 8% of the country's workforce. In 2019, creative exports of the country stood at \$121 billion, with services such as IT and design contributing the lion's share. The design segment alone accounted for 87.5% of creative goods exports, followed by traditional arts and crafts at around 9%. Some sources also reveal that the media and entertainment sector of the country alone is worth \$28 billion. The Indian content creators already influence more than \$350-\$400 billion in consumer spending. With nearly

It's also projected that the value of the global market for creative goods in 2030 will reach 10% of global GDP (which was previously estimated to be around \$100 trillion USD in 2023). This would mean a potential market size of \$10 trillion or more. The creative economy/orange economy which encompasses cultural and creative sectors would be a potential market size of \$10 trillion by 2030.

Hence, looking ahead, the orange economy holds immense potential for further innovation and growth. By embracing emerging technologies, promoting cultural exchange, and investing in creative talent. Various countries can scale its creative industries by encouraging collaboration among stakeholders and fostering inclusive growth models which will ensure that the orange economy/creative economy continues to be a driving force for economic sustainability and cultural empowerment. 

Odisha to promote healthier dietary habits among children

Bhubaneswar (DMC): In a move that aims at promoting healthier dietary habits among children, the Odisha government has decided to eliminate the use of refined sugar and limit salt usage in meals served under the PM POSHAN scheme. In a recent directive, district education officers (DEOs) have been asked to ensure jaggery is used, if sweetening is necessary."

Refined sugar must not be used in any form in the preparation of meals under the PM POSHAN. Addition of jaggery should also be limited to less than 5 per cent of the total energy content to prevent excess intake of discretionary calories," the advisory stated. The direction

came following the recommendation by the Indian Council of Medical Research (ICMR) and advisory from the Ministry of Women and Child Development to limit sugar content in packaged foods and beverages, in view of rising health concerns linked to high sugar intake.

The advisory also stipulated that the usage of salt be minimised to encourage healthier eating patterns among children. It has asked for the strict avoidance of foods high in fat, salt, and sugar (HFSS), aligning with the dietary recommendations of the World Health Organization (WHO) and the dietary guidelines for Indians. The state government has

also laid down stringent instructions regarding the preparation of food under the PM POSHAN, which includes hot cooked meals, supplementary nutrition items, and Tithi Bhojan meals served to children. " Sweet recipes should be

limited in all such meal categories, and all ingredients used must be safe and compliant with the Food Safety and Standards Regulations (FSSR), 2011 and its subsequent amendments," the advisory said.Besides, for food items served under the Sishu Vatika initiative (whether hot cooked or as supplementary nutrition) the use of preservatives, artificial colours, flavours, and synthetic additives has been strictly

prohibited. The schools have been instructed that these meals must adhere to the FSSR 2020 regulations, and only approved emulsifiers under the same regulations can be used while preparing the food items. The directive has also prohibited sale of energy drinks within 100 metres of school premises in rural areas and 50 metres in urban localities for the growing health risks associated with the consumption of such drinks. Citing several studies, the

government has warned that energy drinks, due to their high caffeine content, can negatively affect the cardiovascular, neurological, psychological, gastrointestinal, metabolic and renal systems of children.

Govt to appoint 'Sishu Sebikas' Bhubaneswar: The Odisha

government has decided to appoint 'Sishu Sebikas' (childcare assistants) in Sishu Vatikas, a CMO release said on Sunday. Under the National Education Policy, Odisha has already operationalised Sishu Vatikas at government-run primary schools across the state to extend preschool education to children in the 5-6 years age group from the current academic session.

The introduction of Sishu Sebikas is seen as a key step to support teachers in managing younger children more effectively in classrooms. This will allow teachers to focus solely on academic

Orissa HC asks government to relook book selection for college libraries

Cuttack. **(DMC):** А controversy has sparked off over the selection of books for libraries in non-government colleges across Odisha, with allegations of favouritism and procedural lapses prompting legal intervention. The Orissa High Court has

directed the secretary of Higher Education department to consider the Kalinga Publishers and Booksellers Association's grievance in accordance with law within 30 days. The single judge bench of Justice BP Routray also observed that the department may consider halting the supply of the selected books until a final decision is made on the matter.

The directive is expected to temporarily stall the ongoing supply process, and all eyes are now on the Higher Education department's next step. The case has brought to light broader concerns about transparency and fairness in educational procurement practices.

The Kalinga Publishers and Booksellers Association, Cuttack, had challenged the selection process in a writ petition. The association, representing booksellers and publishers across the state, alleged that the designated selection committee responsible for recommending books for college libraries had acted arbitrarily and without due



diligence. According to the petition, out of the hundreds of books approved, nearly 350 titles were exclusively from just five publishers, raising serious concerns of bias and lack of transparency. In their grievance

letter dated June 9, 2025, addressed to the commissionercum-secretary of the Higher Education department, the association called for immediate quashing of the approved book list. Association president Joy

Krishna Mohapatra also demanded a formal inquiry into the matter and stringent action against officials allegedly involved in the irregularities. The representation alleged that majority of the 350 books in the booklist comprise only a few publishers who have formed a group in connivance with government officials.

The booklist provided has the name of the book and name of the author but there is no mention of the name of the publishers. The name of the publishers has been intentionally avoided as most of the books belong to these handful of persons the representation alleged.

"We had reached in front of the Gundicha temple at around 3:31 am. At that time, there were around 50,000 devotees. When the pahuda opened, there was sudden chaos. Some police personnel who were there escaped from the spot. Around 200-300 people had fallen during the chaos. We told police officials, but they did not help. The administration did not help us. We had to carry our relatives who were injured on our own. The truck entered, and it triggered the situation. Due to this, my wife Basanti Sahu of Bhubaneswar (Khordha district) died," said the deceased's husband. He further alleged, "We cried for help, ambulance and asked for water. But police personnel did not offer even a single drop. There was massive crowd at the spot when the stampede occurred." Amidst the allegations, Puri SP Vinit Agrawal claimed that there was deployment of police force at the spot. "We will inform after examining all aspects. There was adequate deployment near the chariots and the Gundicha temple," said Agrawal.

Rethink move to open Angul coal belt for mining: Study

Survey

Bhubaneswar (DMC): A new study has urged that declaring the entire coal belt of Angul district for mining use must be reconsidered.Wildlife Institute of India (WII) researchers S Karthy and GV Gopi carried out the study to understand the status of elephants in coal mine landscape using geospatial methods. A snippet of the report 'Status of Management of Elephants in Coal Mine Landscape of Odisha' cautioned that operating inactive coal mines would result in destruction of about 390 sq km of forest Angul forest division

Employing Maximum Entropy (MaxEnt) approach to determine the suitable elephant landscape in the division, the study found that most of the habitat utilised by the pachyderms in the region fall under the proposed coal blocks. There are already operational coal mines in Angul division which hinder the movement of the elephants. If all the inactive coal mines come into operation, it would lead to destruction of about 390 sq km forest in the protected area," it stated. The report sought construction of adequate overpasses and underpasses in the southern part and stressed the importance of managing habitat outside protected areas and enforcing stringent environmental framework.

The incident took place during a cluster meeting at the Nayapatna anganwadi centre in Oupada block when the supervisor, Agani Jena, asked Nikunjabasini Rath, listed with Sikidia anganwadi centre, to leave the meeting after allegedly



humiliating her in front of her colleagues.Rath, currently battling cancer, was then allegedly forced to stand outside in the scorching sun for over two hours. She claimed that she was made to stand outside in an act of revenge as she did not gift a washing machine during the wedding of Jena's daughter. The situation came to attention after local residents informed it the Anganwadi Workers' Union.

Union's president, Jambubati Mohanty, rushed to the spot and was shocked to see Rath standing in the heat. She immediately arranged for Rath to be moved to a shaded area. The meeting was reportedly attended by 19 Anganwadi workers and

held under the supervision of Jena. Witnesses claim that Jena verbally abused Rath and ordered her out of the meeting.Child development project officer (CDPO) of Oupada block Jayashree Sit said, "An inquiry will be conducted.

If the allegations are found to be true, action will be taken against the cluster supervisor." When contacted by reporters, Jena stated that she had the authority to decide who could attend the meeting and declined to offer further comments.

Internal Feud in Trinamool Surfaces over Kolkata Law College Rape

Kolkata, (HS) : Internal feud in Trinamool Congress has surfaced over the rape of a law college student in Kolkata, with veteran party Lok Sabha member and senior advocate Kalyan Banerjee almost declaring a rebel against the leadership on the issue. The situation took a more serious turn after fellow Trinamool Congress Lok Sabha member Mahua Moitra issued an X message where she subtly targeted Banerjee. This made Banerjee furious even more, and he reacted vehemently.

The controversies started over a comment by Banerjee soon after the rape incident surfaced and three persons accused in the case, all having links with Trinamool Congress's students' wing Trinamool Chhatra Parishad (TMCP), were arrested. Banerjee then made a comment claiming that it would not be possible for government authorities to protect the victim in such cases, where a friend rapes another friend. Trinamool Congress leadership immediately censured him. On Saturday, the party issued a statement claiming that the remarks by Banerjee in the matter were made in his capacity, and the party had unequivocally disassociated itself from his statements and strongly condemned the same. It also said Banerjee's views did not reflect the position of the party in any manner whatsoever, since the party's stance remained resolute in having



zero tolerance for crimes against women. Reacting to the statement issued on the official X handle of Trinamool Congress, Moitra made a comment subtly targeting Banerjee in the matter. "Misogyny in India cuts across party lines. What differentiates @AITCofficial is that we condemn these disgusting comments no matter who makes them," Moitra said in her reaction to the statement from Trinamool Congress

The statement from the party censuring him and the subtle jibe from Moitra made Banerjee furious, and he reacted vehemently on the matter. According to him, what he said was a conscious comment since he could not accept a political colleague raping another colleague.

On CCTV, Kolkata Rape Survivor Dragged Inside College by 2 Accused

Kolkata, (HS) : A footage CCTV showing a Kolkata law student being dragged by two accused from the college gate to inside college premises where she was raped earlier this week has surfaced, sources in the Kolkata Police have told. The 24-year-old

woman of the South Calcutta Law College was allegedly raped by two

senior students and an alumnus of the institute in the guard's room on June 25. The video clip appears to corroborate the survivor's complaint, in which she said that the prime accused, Manojit Mishra, instructed two others to forcibly take her to the guard room. "The CCTV footage confirms the woman's allegations. It shows the movements of the three accused, the security guard, and the victim. We are currently examining the footage," said a police officer. The police suspect that the law college student was gang-raped as she turned down the marriage proposal of the main accused, said a police officer. Four people - Manojit Mishra, Promit Mukherjee, Zaid Ahmed and the college guard - have been arrested so far. It is alleged that Manojit raped the student, while the other two shot videos to blackmail her later. Manojit Mishra is part of the Trinamool's youth wing, but the party has insisted that this won't protect him from the harshest punishment. The issue brought to fore the different voices emanating from the ruling party in the state. MP Kalyan Banerjee's remark on the case has been flagged as victimblaming. "If a friend rapes a friend, how can you ensure security? Will there be police in schools? This was done by students to another student. Who will protect her (victim)?"

First phase of Census to begin on April 1, 2026 with houselisting operations

NEW DELHI, (HS) : The houselisting operations for the forthcoming Census will begin from April 1, 2026, marking the start of the first phase of the decennial exercise, the Registrar General of India has said. In a letter to chief secretaries of states and Union Territories, Census Commissioner and Registrar General of India Mrityunjay Kumar Narayan said the Houselisting Operations and Housing Census shall begin on April 1, 2026.



Before that the appointment of supervisors, enumerators and work distribution among them shall be done with cooperation from states and district administration, it said.

The Census is a two-phase exercise -- in phase one i.e. Houselisting Operation (HLO), the housing conditions, assets and amenities of each household will be collected. Subsequently, in the second phase i.e. Population Enumeration (PE), the demographic, socio-economic, cultural and other details of every person in each household will be collected which is scheduled for February 1, 2027, according to the letter. In the Census, Caste enumeration will also be done, a government statement had said. For Census activities, over 34 lakh enumerators and supervisors and around 1.3 lakh Census functionaries would be deployed. It is the 16th Census till now and the eighth after independence. The forthcoming Census will be conducted through digital means using mobile applications. Provision of self-enumeration would also be made available to the people. The Office of the Registrar General and Census Commissioner had prepared around three dozen questions to be asked to the citizens. The survey will ask households about ownership of items like phones, internet, vehicles (bicycle, scooter, motorcycle, car, jeep, van), and appliances (radio, TV, transistor) among others. The citizens will also be asked about cereal consumption, sources of drinking water and lighting, type and access to latrines, wastewater disposal, bathing and kitchen facilities, fuel used for cooking and LPG/ PNG connection.

Additional questions include the materials used for the floor, walls and roof of the house, its condition, number of residents, number of rooms, presence of married couples, and whether the household head is a female or belongs to a Scheduled Caste or Tribe.

India rejects Pakistan's allegations over Waziristan attack



New Delhi, (HS) : India has strongly rejected Pakistan's attempt to link it to a deadly suicide bombing in the Waziristan region of Khyber Pakhtunkhwa, calling the accusations baseless and unfounded. The attack, which took place on June 28, claimed the lives of at least 13 security personnel and left 24 others injured. In the aftermath, the Pakistan Army released a statement suggesting Indian involvement in the incident. In a sharp response issued late Saturday, India's Ministry of External Affairs (MEA) condemned the allegations. "We have seen the official statement by the Pakistan Army attempting to attribute responsibility for the Waziristan attack to India," the MEA said. "We reject this statement with the contempt it deserves." India reiterated that Pakistan must focus on addressing terrorism within its own borders rather than deflecting blame

DEHRADUN, (HS) : Uttarakhand is grappling with the devastating aftermath of a ferocious cloudburst that struck Baligarh on the Barkot-Yamunotri road last night, triggering widespread destruction. The torrential downpour swept away at least 20 labourers from an under-construction hotel site, with rescue teams managing to save 11.

The fate of the remaining nine remains unknown, as search operations continue amidst challenging conditions. The natural calamity has not only caused significant human loss but also severely impacted critical infrastructure. A crucial 10-meter stretch of the Yamunotri Highway has been completely washed away, effectively cutting off connectivity to the revered pilgrimage site. The situation was equally grim in Kotdwar, where heavy rains on Sunday caused the Paniyali stream to overflow. The surging waters washed away the alternative route connecting the Gabbar Singh Army Camp to the main road, completely severing access. Furthermore, land subsidence on the Kotdwar-Najibabad four-lane highway left vehicles stranded and traffic suspended, with efforts underway to clear the debris using excavators. In response to the escalating crisis and severe rain alert, the state government



has taken the unprecedented step of suspending the Char Dham Yatra for the next 24 hours.

Garhwal Division Commissioner Vinay Shankar Pandey confirmed the decision, stating, "The Char Dham Yatra has been suspended for the next 24 hours following a heavy rain alert. As a precautionary measure, I have given instructions to the police and administration officials to stop the pilgrims in Haridwar, Rishikesh, Srinagar, Rudraprayag, Sonprayag, and Vikasnagar."The mountainous districts of Uttarakhand have been experiencing relentless, heavy rainfall since Saturday night. This has led to a sudden rise in the water levels of major rivers. In Rudraprayag and Chamoli districts, the Mandakini and Alaknanda rivers, which flow through the sacred Badrinath and Kedarnath regions, are now flowing above the danger mark, posing a serious threat to riverside communities. Arpan Yaduvanshi, Commandant of the State Disaster Response Force (SDRF), told the TNIE, "Police in both districts are appealing to people living on river banks to move to safer locations. SDRF units are continuously monitoring potential high-risk areas and have urged pilgrims and others to refrain from approaching the riverbanks." Adding to the state's woes, Chamoli District Disaster Management Officer Nandkishore Joshi reported significant connectivity disruptions due to rain-induced debris and landslides. "Several highways in Chamoli district are obstructed due to debris and landslides." The highway at Kamed Nandprayag is closed, approximately 4-5 km ahead of Paligad, near Silai Band.Deepak Kathet, SHO of Barkot Police Station

told, "We received information about the cloudburst on the Yamunotri Highway. Our team reached the spot and found that some individuals involved in road construction and other works were living in tents. They were swept away by the sudden, powerful flash flood," he explained. Responding to the widespread destruction, Chief Minister Pushkar Singh Dhami personally took charge of the relief efforts. The Chief Minister visited the State Emergency Operations Centre at the Secretariat, where he received updates on the damage from officials in Uttarkashi, Rudraprayag, Chamoli, and other affected districts.

Chief Minister Pushkar Singh Dhami has taken immediate cognizance of the cloudburst incident. He expressed his concern via a tweet, stating that he had received information about some labourers missing in the tragic event. Currently, 15 personnel are actively engaged in rescue work, with approximately 45 more en route. Due to the challenging terrain, heavy machinery cannot reach the site, and teams are conducting rescues manually. The labourers are either trapped in debris, stuck on rocks, or have been swept away into the river. Efforts to locate them are ongoing," he said.

Jaipur Couple Seen Arguing on CCTV, **Found Dead**



Jaipur, (HS) : A married couple was found dead at their home in Jaipur's Muhana in a suspected case of death by suicide. The police said they are looking into all angles, including murder. The bodies were found on Friday. When Dharmendra, the husband, did not turn up at the bank where he was a sales manager and his calls went unanswered, a friend sent a family member to the flat. When the friend opened the door, Dharmendra and his wife Suman were found dead on the floor. The police said they checked CCTV footage of the flat's parking area and saw the couple arguing over something. The footage was of Thursday afternoon, a day before the suspected death by suicide. Suman was seen trying to stop her husband from driving away. After what seemed like an argument, he stopped the car and started talking. She rested her head on his shoulder and held his arms. They came out of the vehicle and walked away, his arm around his wife's shoulder. Another video from the evening of the same day showed the couple entering the apartment together. Suman was seen carrying a bag. This was the last time both were seen alive. "This appears to be a case of death by suicide. If murder is suspected, then we will investigate from that angle as well," police officer Gur Bhupendra said. Indian woman missing in US after arriving for arranged marriage

Congress Troubleshooter in Karnataka Tomorrow Amid Signs of Dissent



Bengaluru, (HS) : Amid growing talks of a major political churn and public criticism from within its own ranks, the Congress's leadership is set to launch the second round of damage control in Karnataka. Senior leader and Congress General Secretary Randeep Singh Surjewala will arrive in Bengaluru tomorrow for a two-day visit aimed at addressing concerns within the party.

Mr Surjewala's visit follows a series of meetings earlier this week, where Chief Minister Siddaramaiah and his deputy DK Shivakumar met with disgruntled Congress MLAs who had levelled allegations against their own government. While BR Patil had spoken about rampant corruption in the housing department, MLA Raju Kage had raised the issue of a collapsed administration, among others. During his visit, Mr Surjewala is expected to hold one-onone meetings with a few of these leaders whose recent public statements have embarrassed the party and raised questions about unity within the

Karnataka Congress. Mr Surjewala is also likely to address the growing chatter around a possible leadership change in the state. He may issue a stern message asking Congress leaders to refrain from making public statements on the matter.

Congress MLA HA Iqbal Hussain alluded to a high possibility of a change in the state's top leadership. "This is something that the high command has in mind," Mr Hussain said. "When the time is right, the high command will give an opportunity to DK Shivakumar. It is likely to happen this year. All leaders are talking about a big political churn. I am telling this straight, not beating around the bush, that in two to three months a decision will come," the Congress MLA said. The remarks by the Congress MLAs over alleged corruption in the housing department and the "complete collapse" of the administration have embarrassed the ruling party, with the opposition BJP and Janata Dal (Secular), or JD(S), using the opportunity to accuse the government of corruption.

New Delhi, (HS) : A 24-year-old Indian woman has gone missing in the United States just days after she arrived there for an arranged marriage, reported. Simran landed in the U.S. on June 20 and was last seen on June 26 in Lindenwold, Camden County. Surveillance footage reportedly showed her looking at her phone and waiting, but she did not appear distressed, officials said. Police note that Simran has no known contacts in the U.S. and speaks limited English. She was carrying an international phone that works only via Wi-Fi, further complicating efforts to trace her.

Shah-Nadda and Kharge to energise party leaders, cadres in Chhattisgarh

Dozens Clash With Police Anti-Government Protests in Serbia 5.3-Magnitude Earthquake Jolts Pakistan's Punjab

Islamabad, (H.S): An earthquake of magnitude 5.3 struck central Pakistan on Sunday, the German Research Centre for Geosciences (GFZ) confirmed. The tremors were felt at approximately 3:54 am Indian Standard Time (IST), with the quake's depth recorded at 10 kilometres, indicating a shallow seismic event. According to the GFZ, the epicentre was located around 149 kilometres west of Multan, a major city in Punjab province.

There were no immediate reports of injuries, fatalities, or significant damage to infrastructure.India's National Centre for Seismology (NCS) also recorded the seismic activity, measuring the quake's magnitude slightly lower at 5.2. The NCS noted that the quake occurred at latitude 30.25°N and longitude 69.82°E, at a greater depth of 150 kilometres, which can sometimes reduce the surface impact of such tremors. The NCS shared the data

on its official X handle, posting: "EQ of M: 5.2, On: 29/06/2025 03:54:02 IST, Lat: 30.25 N, Long: 69.82 E, Depth: 150 Km, Location: Pakistan.

Pakistan frequently experiences seismic activity due to its location on the seismically active boundary between the Indian and Eurasian tectonic plates. This collision zone makes regions such as Balochistan, Gilgit-Baltistan, and Khyber Pakhtunkhwa particularly vulnerable to earthquakes. Though this latest tremor caused no visible damage or loss of life, authorities

typically urge residents in quakeprone zones to remain alert and follow safety guidelines in the event of aftershocks, according to local media reports. In 2015, a 7.5magnitude earthquake in Pakistan and Afghanistan resulted in nearly 400 fatalities due to the difficult terrain that complicated relief efforts.

In 2021, Balochistan province, the largest in Pakistan, was hit by a quake that caused at least 20 deaths and injured more than 10 others, with landslides hindering initial rescue operations in the remote mountainous area of Harnai.

Belgrade, (H.S): Serbian police clashed with more than 140,000 protestors in Belgrade, marking one of the largest demonstrations in recent months against President Aleksandar Vucic's 12year rule. The protestors, many of them students, flooded the capital, demanding early elections and an end to what they called an increasingly repressive populist regime, reports the BBC.

As protestors chanted, "We want elections," police responded with tear gas and stun grenades, leading to dozens of arrests. Scenes of chaos surfaced on social media as security forces tried to disperse the crowds." They wanted to topple Serbia, and they have failed," Vucic wrote on Instagram, accusing the protestors of attempting to "usurp" the country.Meanwhile, the Higher Court in Belgrade confirmed that five individuals



accused of plotting to overthrow the government were detained on Friday.The police minister condemned the violence and affirmed that those responsible would be held accountable. Despite the unrest, President Vucic has repeatedly rejected calls for snap elections. His ruling Progressive Party-led coalition currently controls 156 of the 250

seats in parliament. The ongoing unrest has visibly shaken Vucic's administration, with university closures further aggravating the political tension. Although his second term runs until 2027, the sustained wave of protests has raised questions about his political future. Vucic has maintained strong

ties with both Russia and the European Union, even as Serbia remains a candidate for EU membership. Notably, Serbia has not joined Western sanctions against Moscow following Russia's invasion of Ukraine. Critics continue to accuse Vucic's administration of links to organised crime, corruption, and suppression of dissent allegations the government denies. The current wave of protests began in December last year, triggered by the collapse of Novi Sad railway station's

roof on November 1, which killed 16 people. The tragedy, widely blamed on corruption and poor infrastructure, led to the resignation of Serbia's former Prime Minister and became a lightning rod for public outrage. As Saturday's protests concluded, organisers played a pre-recorded message urging Serbians to "take freedom into your own hands" and giving the crowd the "green light."

In a statement released on Instagram, protest leaders accused the government of choosing repression over dialogue."The authorities had all the mechanisms and all the time to meet the demands and prevent an escalation," the organisers said. "Instead, they opted for violence and repression against the people. Any radicalisation of the situation is their responsibility."

Inhumane Condition At Chittagong Central Jail Sparks Outcry

Dhaka, (H.S): The Chittagong Central Jail of Bangladesh is reportedly housing inmates more than three times its capacity, forcing them to live in overcrowded conditions. In an effort to address the situation, an initiative was undertaken by the local authorities to construct a

As NATO Eyes Indo-Pacific, India Offers Strategic Depth Without Alignment

New Delhi, (H.S): The NATO summit held in The Hague on June 24-25 may be remembered less for its urgent reaffirmations - support for Ukraine, increased defence spending, and condemnation of Iranian strikes - than for a more disciplined, forward-looking pivot: the Indo-Pacific now occupies a central place in NATO's strategic imagination as the Indo-Mediterranean plunges into conflict. This is no small shift. For much of its post-Cold War history, NATO's gaze remained firmly Atlantic.

Even when it extended outward - toward Afghanistan or Libya - it did so from the assumption that security threats radiated outward from Europe. The idea that Asia could shape Euro-Atlantic stability was once considered speculative. That assumption has now collapsed. NATO's engagement with the Indo-Pacific predates the Ukraine war. In the late 2010s and early 2020s, the alliance began quietly deepening ties with democratic Indo-Pacific partners - Japan, Australia, South Korea,

and New Zealand - eventually institutionalising these relationships through the "IP4" format. Yet it was Russia's invasion of Ukraine in 2022 and China's subsequent strategic alignment with Moscow that sharpened the view from Brussels. The 2022 NATO Strategic Concept explicitly stated that China's "coercive policies challenge our interests, security, and values." At The Hague, that posture hardened. China was identified not only as a systemic rival but as a "decisive enabler" of Russia's war machine. Even so, NATO's ambitions

remain limited by design. The alliance does not seek to become an Indo-Pacific bloc. It cannot, and should not, replicate its Euro-Atlantic structure in Asia. Instead, it is seeking what might be called "strategic elasticity" flexible partnerships, practical coordination, and technological interoperability that enhance deterrence without requiring formal alignment. This is where India enters the picture - not as an ally, but as a necessary partner. India remains committed to



strategic autonomy and nonalignment. It is not part of the IP4, nor will it seek NATO membership or treaty-bound commitments. New Delhi has historically resisted bloc politics and retains strong historical ties to Moscow, even as it seeks to diversify its defence posture. But that autonomy should not be mistaken for passivity. In recent years, India has developed a

proactive Indo-Pacific agenda, exemplified by its SAGAR doctrine - Security and Growth for All in the Region - and more recently, the 'Mahasagar' initiative, announced in late 2024. Mahasagar (Sanskrit for "great ocean") signals India's intent to become the principal architect of stability in the Western Indo-Pacific. It combines maritime domain awareness, defence-

industrial cooperation, and blue economy coordination across the Arabian Sea, the Bay of Bengal, and the African littoral.Importantly, it also envisions interoperability with like-minded navies and integration of undersea surveillance and cyber capabilities. While not aimed at any single actor, Mahasagar is a clear strategic counterweight to China's Belt and Road naval encirclement of the Indian Ocean.

India's role in the Ouadrilateral Security Dialogue (Quad) - alongside the United States, Japan, and Australia already positions it as a key player in balancing China's influence. Yet the Quad is not a military alliance. It operates through consensus and capacity building.NATO, on the other hand, brings something complementary to India's toolbox: institutional experience, shared standards, and operational maturity across cyber, AI, and undersea deterrence. Where the Quad offers alignment of vision, NATO offers alignment of capability.There are already

examples of what this looks like in practice. In 2024, India conducted joint exercises with the Italian aircraft carrier Nave Cavour, demonstrating high-level interoperability. It has participated in multilateral operations like Sea Dragon alongside the United States, Japan, Australia, and Canada. NATO, for its part, has established pathways for defence tech integration with partners in the region.

At The Hague, it unveiled new initiatives in cyber defence, counter-disinformation, AI, and dual-use industrial cooperation all areas where India has growing interest and capability.Of course, these engagements will not lead to formal alliance structures. New Delhi will not sign a collective defence pact, nor will it open NATO bases. But this is not what the moment demands. What it demands is pragmatic, modular cooperation - shared exercises, aligned technical standards, and secure communication frameworks that allow both sides to respond jointly to maritime instability, cyber threats, and supply chain vulnerabilities. There

is also a deeper, systemic rationale for engagement. Trade routes through the South China Sea and Taiwan Strait are not abstract concerns for Europe. Nearly 40 per cent of global trade flows through these waters. A limited conflict - say, over Taiwan - would immediately disrupt global supply chains, raise commodity prices, and destabilise energy flows.

Euro-Atlantic security, in other words, is no longer bounded by geography; it is bounded by connectivity. And India, situated at the strategic hinge of East and West, is uniquely positioned to help NATO manage this transition. None of this negates India's longstanding preference for autonomy. In fact, NATO's appeal lies precisely in its ability to work with India without violating that principle. What is emerging is a partnership without alliance - a relationship grounded in complementary interests, not identical identities.Looking ahead, NATO must resist the temptation to replicate its Atlantic formula in the Indo-Pacific.

The notice, issued by the Office of the Commissioner (Audit), Central Tax, Ranchi, on June 27, said the input tax credit was availed in contravention of the provisions of Section 74(1)of the Central Goods and Services

Tata Steel gets show cause notice over input

Tax Act, 2017/State Goods and Services Act, 2017 (CGST/ SGST) read with Section 20 Integrated Goods and Services Tax Act, 2017. The company said it has already paid a GST of Rs 514,19,36,211 in the normal course of business."The above GST amount is proposed to be appropriated in the notice and therefore alleged GST exposure is Rs 493,35,47,131 only," the filing said.

The added that it believes that the notice "has no merits and the company shall make its submissions before the appropriate forum within the given timelines". "There is no impact on financial, operational, or other activities of the company, arising from the said SCN," it added. Under GST norms, enterprises are allowed credits in input tax on purchases meant for outputs, which they can claim in the form of deductions in their tax liabilities.

New Delhi, (H.S): The Ministry of Power on Saturday announced the launch of a task force to conceive the India Energy Stack (IES), an initiative aimed at creating a unified, secure, and interoperable digital public infrastructure (DPI) for the energy sector.

The IES will play a vital role in integrating renewable energy, enhancing DISCOM efficiency, and delivering transparent, reliable, and future-ready power services, an official statement quoted Power Minister Manohar Lal Khattar as saying. There is an urgent need for developing robust DPI in the power sector to manage the country's rising demand, ensure grid stability, and empower consumers. What Aadhaar did for identity and UPI achieved for digital payments, the

India Energy Stack will accomplish for the power sector - unlocking seamless, secure, and consumer-centric energy services for every citizen," he added. As India charts its path to becoming a USD 5 trillion economy and advances towards its net-zero commitments, the power sector faces both unprecedented opportunities and complex challenges, the statement said.

Rapid growth in renewable energy, electric vehicles, and consumer participation in energy markets is transforming the sector, but fragmented systems and a lack of seamless digital integration remain key barriers, it pointed out. To address these issues, the ministry is reimagining the sector's digital foundation through the IES - a

DPI that will provide a standardised, secure, and open platform to manage, monitor, and innovate across the electricity value chain. The IES will offer unique IDs for consumers, assets, and transactions; real-time, consentbased data sharing; open APIs (Application Programming Interface) for seamless system integration; and tools for

consumer empowerment, market access, and innovation. Apart from conceiving the IES, the ministry will undertake a 12month Proof of Concept (PoC) to demonstrate IES through realworld use cases in partnership with selected utilities. This includes piloting the Utility Intelligence Platform (UIP), a modular, analytics-driven application built on IES to support utilities, policymakers and consumers with real-time insights and smarter energy management.

To guide these initiatives, the ministry has constituted a dedicated task force comprising experts from the technology, power sector, and regulatory domains, which will steer the development, pilot implementation and nationwide scale-up of the IES.

Retail Sector Gaining Momentum, Growth Expected to Reach 9-10 Pc Soon: RAI

New Delhi, (H.S): The Indian retail sector, currently valued at \$900 billion, is showing signs of strong recovery and is expected to grow at a faster pace in the coming months, according to the Retailers' Association of India (RAI). The sector, which is currently growing at a rate of 5 per cent, is likely to soon pick up speed and reach a growth rate of 9 to 10 per cent.

RAI's CEO Kumar Rajagopalan said that right after the pandemic, the retail sector had bounced back strongly with a 20 per cent growth rate."However, in the last one year, the growth slowed down to around 5 per cent. Now, with the markets stabilising, consumers spending more, and the right consumer base



in place, the sector is once again showing signs of faster growth," he added.Meanwhile, as per RAI's 62nd Retail Business Survey, retail sales across India grew by 7 per cent in May 2025 compared to the same month the previous year. This marks a

significant improvement after months of moderate growth ranging between 4 to 5 per cent.Region-wise, southern India led the way with a 9 per cent growth in retail sales in May.Western India followed with 7 per cent, while northern and

eastern regions recorded growth of 6 per cent and 4 per cent, respectively, as per the report.Among the different segments, quick service restaurants (QSR) showed the highest growth at 10 per cent.

Consumer durables and electronics, along with furniture, also performed well with an 8 per cent rise each.Rajagopalan said this increase shows that people are now more willing to spend, especially on non-essential or discretionary items.Looking ahead, the RAI CEO expressed optimism about the upcoming festive season.He said that the improving consumer sentiment could further boost retail sales and bring the sector closer to doubledigit growth in the near future.

Indian cement sector reaches 39.6 million metric tonnes in May, up 9 pc

New Delhi, (H.S): The Indian cement sector reached 39.6 million metric tonnes (MT) in May, recorded a strong 9 per cent year-on-year (YoY) growth in volumes, according to a new report.The positive trend continued in the first two months of FY26, with volumes rising 8 per cent YoY to 78.7 million MT, according to the report by ICRA.For FY2025, cement volumes grew by 6.3 per cent YoY, totalling 453.0 million MT.

ICRA projects a further 6-7 per cent growth in FY2026, with volumes expected to reach 480-485 million MT, driven by sustained demand from the housing and infrastructure sectors. Average cement prices saw an 8 per cent YoY increase in May 2025, reaching Rs 360 per bag, while prices for the first two months of FY2026 were up 7 per cent YoY.ICRA anticipates an 80-150 basis points (bps) improvement in operating



margins for its sample set of cement companies, rising to 16.3-17.0 per cent in FY2026.The rating agency maintains a 'Stable' outlook for the Indian cement sector, reflecting confidence in continued demand and favourable cost conditions.

The sector's resilience underscores its critical role in supporting India's infrastructure and housing development. The combined Index of Eight Core Industries (ICI) increased by 0.7 per cent in May compared to the same month last year, according

to the Ministry of Commerce and Industry data. The production of cement, steel, coal, and refinery products recorded positive growth last month. The final growth rate of the Index of Eight Core Industries for February, March and April was observed at 3.4, 4.5 and 1.0 per cent, respectively, said the ministry.

Cement production rose by 9.2 per cent in May. Its cumulative index increased by 7.8 per cent during April to May, 2025-26 over the corresponding period of the previous year.

India's Auto Sector Powers \$5 Trillion Economy Dream With Record Growth in EVs, Exports, Jobs

New Delhi, (H.S): As India moves closer to achieving its \$5 trillion economy dream, the automobile sector is emerging as a strong pillar of growth by contributing around 7.1 per cent to the country's GDP and nearly 49 per cent to its manufacturing GDP.Additionally, it supports over 3.7 crore jobs and accounts for close to 8 per cent of India's total exports.Clearly, the performance of this sector is closely linked to the overall economic growth of the country.

More than just a commercial industry, the auto sector is now seen as a reflection of India's growing power in global manufacturing and innovation.As of the financial year 2024-25, India is the third-largest automobile market in the world by sales and the fourth-largest in terms of production. The country produced over 31 million vehicles across various segments. This included more than 5 million passenger cars, 1 million commercial vehicles, 1 million three-wheelers, and nearly 24 million two-wheelers.In terms of exports, India shipped around 5.7 million vehicles to markets



like Japan, Mexico, Latin America, and Africa. This rapid growth has been supported by government policies aimed at boosting local manufacturing, reducing imports, promoting clean technologies, and making India a key player in global supply chains.

One of the most important schemes has been the Production Linked Incentive (PLI) for the automobile and auto components sector. With a budget of Rs 25,938 crore, this scheme is focused on promoting electric vehicles (EVs), hydrogen vehicles, autonomous systems, and advanced vehicle technologies.By early 2025, this scheme had attracted investment proposals worth over Rs 67,000 crore.It is expected to generate Rs 2.3 lakh crore in additional sales and create 7.5 lakh direct jobs. However, out of the total \$23 billion approved under PLI schemes across all sectors, only US\$1.7 billion has been disbursed so far, raising concerns about slow

implementation. Another major initiative is the FAME-II scheme (Faster Adoption and Manufacturing of Hybrid and Electric Vehicles), launched with a budget of Rs 11,500 crore.It supports the adoption of electric twowheelers, three-wheelers, buses, and taxis. Over 1.3 million EVs have already been supported

under this scheme.Originally

planned to end in March 2024, the scheme has been extended until March 2025 to keep up the EV push.To reduce dependency on imported batteries, the government also launched a PLI scheme for Advanced Chemistry Cell (ACC) Battery Storage with an outlay of Rs 18,100 crore.Three companies are already working on building battery gigafactories under this scheme. This is important because batteries make up more than 40 per cent of the total cost of an EV.

The Vehicle Scrappage Policy is another key effort aimed at removing old and polluting vehicles from Indian roads. This is expected to improve air quality, road safety, and increase the demand for newer, more efficient vehicles.The electric vehicle market in India is steadily growing. In 2024-25, EVs made up over 6 per cent of all vehicles sold, with two-wheelers and three-wheelers leading the trend. In May 2025, electric car sales touched 12,304 units, crossing the 4 per cent mark in market share for the first time - up from 2.57 per cent in May 2024.

Gold, Silver Prices Fall Sharply This Week; Global Trends, Geopolitical Easing Behind Dip

New Delhi, (H.S): There's good news for gold and silver buyers as prices of both precious metals saw a decline this week, bringing gold back below Rs 96,000 per 10 grams and silver under Rs 1.06 lakh per kilogram. According to the India Bullion and Jewellers Association (IBJA), the price of 24-carat gold is now Rs 95,784 per 10 grams, down from Rs 98,691 a week ago - a sharp drop of Rs 2,907.Similarly, the price of 22-carat gold has come down to Rs 87,738 from Rs 90,404 per 10 grams.

For 18-carat gold, the rate has dropped from Rs 74,018 to Rs 71,838 per 10 grams. Silver prices also dipped during the review period, falling by Rs 1,582 to Rs 1,05,193 per kilogram from the previous Rs 1,06,775. Notably, silver had reached an all-time high of Rs 1,09,550 per kg on June 18.The international market has mirrored this trend, with gold on COMEX falling to \$3,300 per ounce from \$3,400 earlier.



Silver has dropped to \$36 per ounce. Experts attribute the decline in precious metal prices to recent global developments, including the easing of tensions between Israel and Iran, signs of global stability, and weakness in the US dollar.Despite this week's drop, gold and silver have seen a strong rally since the beginning of the year.

Since January 1, the price of 24-carat gold has surged from Rs 76,162 to Rs 95,784 per 10 grams - an increase of Rs 19,622 or 25.76 per cent.Similarly, silver prices have jumped Rs

19,176 or 22.29 per cent, from Rs 86,017 to Rs 1,05,193 per kilogram. Meanwhile, in an earlier report this month, experts said that gold prices are expected to rise sharply as fresh geopolitical tensions in the Middle East increase global uncertainty.

According to the report, experts believe gold could trade in the range of \$3,500 to \$3,700 in the coming weeks. Akshay Chinchalkar of Axis Securities said that as long as spot gold remains above \$3,314, it could move higher towards \$3,770.

Actor Shefali Jariwala's death left everyone in the industry shocked. The actor died at the age of 42 after reportedly suffering a cardiac arrest on Friday night. Mika Singh, Sunidhi Chauhan and other celebrities attended her last rites, held on Saturday in Mumbai. Now, Priyanka Chopra has also offered her condolences to Shefali's family. On

Sunday, Priyanka took to Instagram Stories and, sharing

a picture of Shefali, expressed her sorrow over the sudden demise. She wrote, "So shook. She was too young. Sending condolences to Parag and family." For the unversed, Shefali worked with Priyanka, Salman Khan and Akshay Kumar in the movie Mujhse Shaadi Karogi.

Since Shefali's death, several visuals from her final rites at Oshiwara crematorium have surfaced on the internet, showing her mother breaking down and unable to

control her tears, and Shefali's father consoling her while fighting back his own tears as he carried his daughter's mortal remains. A recent video also showed Parag unable to control his emotions as he carried Shefali's ashes to the ocean for asthi visarjan. Recently, Varun Dhawan slammed the media for insensitive coverage of Shefali's death and wrote, "Again, one more passing of a soul being insensitively covered by the media. I just don't understand

why do u have to cover someone's grief. Everyone looks so uncomfortable with this. How is this benefiting anyone? & my request to my friends in the media, this isn't the way someone would want their final journey covered.

On Friday night, 27 June, Shefali was rushed to Bellevue Multispeciality Hospital by her husband, Parag Tyagi, reportedly after suffering a cardiac arrest. After the autopsy, police officials revealed that the cause of death has been 'reserved'.
