PM opens gateways to prosperity for J&K

PM Modi dedicates world's highest railway bridge over Chenab river to J&K Vaishno Devi Institute of Medical Excellence in Katra ■ India's first cable-stayed rail bridge over river Anji inaugurated

Srinagar, (HS): In a major infrastructure milestone for Jammu and Kashmir, Prime Minister Narendra Modi on Friday inaugurated the Chenab Rail Bridge, the world's highest railway arch bridge. The engineering marvel is a key part of the Udhampur-Srinagar-Baramulla Rail Link (USBRL) project and now seamlessly connects the Kashmir Valley to the rest of India via rail. PM Modi's visit today marked several firsts for the region as well: the inauguration of India's first cable-stayed railway bridge, Anji Khad Bridge, and the firstever train service directly linking Kashmir to the mainland.Just weeks after the deadly Pahalgam terror attack, the inauguration of multiple all-weather infrastructure projects in Kashmir served as a strong message from PM Modi, who is visiting the valley for the first time after Operation Sindoor, that

his government remains

committed to the development of

the region. PM Modi is also

scheduled to inaugurate several



developmental projects in Katra worth Rs 46,000 crore in a massive infrastructure push for the state.

Moments after inaugurating the Chenab Bridge, the Prime Minister was seen waving the Tricolour and walking across it with a broad smile. Accompanying him were Railway Minister Ashwini Vaishnaw, Jammu and Kashmir Lieutenant Governor Manoj Sinha, and former Chief Minister Omar Abdullah, as he cut the

ceremonial ribbon. Chenab bridge is the part of the 272 km long USBRL project, constructed worth around Rs 43.780 crore and includes 36 tunnels (spanning 119 km) and 943 bridges. The project establishes all-weather, seamless rail connectivity between the Kashmir Valley and the rest of the country. The Prime Minister also flagged off two Vande Bharat Express trains from Shri Mata Vaishno Devi Katra to Srinagar and back. They will offer a swift,



comfortable, and reliable travel option for residents, tourists, pilgrims among others. He also laid the foundation stone of road widening project from Rafiabad to Kupwara on National Highway-701 and the construction of Shopian bypass road on NH-444 worth over Rs 1,952 crore. He also inaugurated two flyover projects at Sangrama Junction on National Highway-1 in Srinagar and at Bemina Junction on National Highway-44. These projects will ease traffic congestion and enhance traffic flow for the commuters. Prime Minister also laid the foundation stone of Shri Mata

worth over Rs 350 crore. It will be the first medical college in Reasi district contributing substantially to the healthcare infrastructure in the region.

ENGINEERING MARVEL: Built at a cost of Rs 1,486 crore, the Chenab Rail Bridge stands as the world's highest railway bridge and a true feat of engineering. Rising 359 metres above the river, 35 metres taller than the Eiffel Tower and nearly five times the height of the Qutub Minar, the bridge was constructed using 28,660 megatonnes of steel capable of withstanding both sub-zero temperatures and extreme heat. Designed to resist strong earthquakes, the bridge incorporates advanced safety features, including the ability for trains to continue operating at low speed even if a supporting pier is damaged.

FIRST CABLE-STAYED RAIL BRIDGE: The Prime Minister also inaugurated India's first cable-stayed railway bridge at Anji river - Anji Khad Bridge. The Anji Bridge rises 331 metres above the riverbed and spans 725 Continued P-4

Nijukti Mela: CM hands over 1,294 appointment letters



Bhubaneswar, (DMC): Chief Minister Mohan Charan Majhi on Friday handed over 1,294 appointment letters to newly recruited officers and employees under seven departments during a large 'Nijukti Mela at the Railway Auditorium here. The event was also graced by Deputy Chief Ministers KV Singh Deo, Pravati Parida, along with State Ministers. The Chief Minister said his government has started the recruitment process as promised, and at the 9th recruitment fair, appointment letters were given to 1,294 youth. He said the government

is working to fill vacancies and will continue to hire more people in the future.

Speaking mediapersons, Majhi said, "After our government came to power, we have started the recruitment process as promised. It was the 9th recruitment fair today, in which we gave appointment letters to 1,294 youth...As per our manifesto, we are working to fill government vacancies...We will recruit more people in the coming time." School and Mass Education Minister Nityananda Gond said the state

Odisha to tackle wildfires with NDMA funds



Bhubaneswar, (DMC): Odisha, one of the worst forest fireaffected states, will receive funds from the National Disaster Management Authority (NDMA) to fight the menace effectively. Sources in the Forest department said Odisha along with Uttarakhand, Chhattisgarh, Andhra

Pradesh, Telangana, Maharashtra, Madhya Pradesh and a few other states have been identified by the NDMA as highly vulnerable to forest fire incidents. Speaking to media, PCCF and HoFF Suresh Pant said a proposal of Rs 63 crore has already been given to the government for submission to the

NDMA for sanction of funds. "The funds will be utilised for installation of AI camera tower, community engagement and other programmes to deal with forest fire incidents more efficiently in the state from the next season onwards," Pant said. A senior official from the Forest department said NDMA has already identified 17 vulnerable territorial and wildlife divisions including Baliguda, Rayagada, Nabarangpur, Paralakhemundi and Sambalpur for necessary fire preventive measures during forest fire season. "The NDMA authorities have also appreciated our proposal and assured to place funds by June. The proposal is also expected to be approved within a month," he added. However, about 10 pc of the `63 crore fund will be borne by the state government under the state specific scheme.

Cabinet nod to 4 projects for Viksit Odisha Bhubaneswar, (DMC): Odisha Cabinet, chaired by Chief Minister Mohan Charan

Majhi, has approved four projects, marking a significant milestone in the State's economic and infrastructural development. Addressing a presser after

the meeting, Chief Secretary Manoj Ahuja announced that out of the five proposals, four projects received the cabinet's nod. With a combined investment of more than Rs 8000 crore, these initiatives will enhance irrigation, urban infrastructure, biotechnology research, and revenue generation, aligning with Odisha's Viksit Odisha @ 2036 vision. The Chheligada irrigation



project, located in R. Udaygiri block of Gajapati district, will have a 266-meter concrete dam on Badajore river, a tributary of Vansadhara. It includes a central spillway with seven radial gates. The approved tender valued at Rs 151.78 crore sets an

ambitious deadline of 18 months for completion. The project aims to irrigate 6,260 ha across Gajapati and Ganjam districts, improve drinking water supply for Berhampur town, boost fishery and livestock farming, and contribute to groundwater

replenishment. Additionally, it will generate 36 MW of hydroelectric power, strengthening Odisha's energy sector.

The Cabinet has also approved the Mukhyamantri Sahari Bikash Yojana (MSBY) aimed at revamping urban infrastructure and employment opportunities. The scheme will build revenuegenerating infrastructure such as market complexes, vending zones, parks, mini cold storage, and EV charging stations. Under the plan, environmental initiatives with 5000 afforestation projects and rainwater harvesting structures will be taken up. The Rs 6000 crore scheme will run from 2025 to 2030 with Rs 1,100 crore allocation for FY 2025-26.



Child Obesity

A study by the All India Institute of Medical Sciences (AIIMS) has sounded a warning on an escalating health emergency among school children in the national capital. Of nearly 4,000 students in the six-to-19-year age group surveyed across Delhi's public and private schools, 13.4 per cent were found to be obese, and 7.4 per cent were suffering from hypertension. The data draws an even more sobering contrast when viewed through the lens of socioeconomic status - 24 per cent of private-school students were classified as obese, compared to 4.5 per cent in government schools. Students in private schools were also found to be twice as likely to have elevated blood sugar and three times more likely to exhibit metabolic syndrome - a dangerous cluster of conditions that includes hypertension, abnormal cholesterol, and insulin resistance. Left unchecked, these significantly increase the risk of early-onset cardiovascular diseases, musculoskeletal disorders, psychological stress, and Type 2 diabetes. The Comprehensive National Nutrition Survey (2016-18) had already shown that 15.35 per cent of school-age children and 16.18 per cent of adolescents in India are pre-diabetic. Together with the AIIMS study, the implications are troubling. Once grappling with malnutrition, India now faces a dual burden: For urban and affluent children, prosperity has paradoxically become a vector of poor health. Lancet's 2024 Global Burden of Disease Study reported that the number of obese children in India has ballooned from 0.4 million in 1990 to 12.5 million in 2022. This staggering increase is a fallout of rapid urbanisation, the ubiquity of high-calorie, nutrient-poor diet - often involving ultra-processed foods and sugary drinks masquerading as child-friendly and healthy - surging screen time, and diminishing physical activity.

The AIIMS report signals that student health needs equal and immediate attention alongside academics. The CBSE's recent directive to set up sugar boards in affiliated schools to reinforce the dangers of excessive sugar consumption is a welcome move in that direction. Physical education must be made non-negotiable, and junk food driven out of school canteens with the same urgency that was once reserved for tobacco. Parents must re-evaluate lifestyle choices at home. Policy, too, has a vital role. National guidelines on childhood obesity must move from paper to practice. A concerted public-health push that combines regulation, education, and community action to steer children toward healthier futures is vital to stem the crisis. Otherwise, India's demographic dividend stands to carry with it a long and costly health burden.

Food Safety Day



On World Food Safety Day, observed annually on June 7, we are protecting our food at all costs. This day was established by the United Nations to raise awareness about the importance of food etiquette and safety at all stages of the food chain. Before our food gets to our stores, restaurants, and even our mouths, they go through a long chain of distribution managed by people who handle processes like harvesting, processing, storing, distribution and preparation. This is why this holiday is important because in the long chain of food consumption there are several possibilities of food contamination.

Food poisoning is a more common condition than you would imagine, with an estimated 600 million foodborne illnesses recorded annually. Food safety is, therefore, a very important concept as it seeks to ensure our food is handled with utmost care before getting to us. Safe food is a key factor in determining our overall health because whatever we ingest is digested and spread easily to other parts of our body via our bloodstream. Food poisoning is one of the most common conditions caused by food-borne pathogens, and symptoms may include vomiting, aches, and diarrhea.

The good news is, that food poisoning is 100% preventable through the use of food safety mechanisms. These are the techniques used in ensuring our food remains in the best, healthiest shape until we consume them, and includes labeling, hygiene, additives, and preservatives. This, however, is not the easiest thing to achieve due to the number of people involved in the food distribution chain.

Food regulation organizations and agencies make the flow of food safety measures easier to manage and control by setting laws in place. Bodies like the World Health Organization (WHO), the Food and Agriculture Organization of the United Nations (F.A.O.), and the Food and Drug Administration (F.D.A.) were established to govern food safety processes and laws. Although these organizations do their best to ensure our food stays safe, this massive task requires all our attention. The way we handle, process, and distribute food goes a long way toward ensuring safer food and better health worldwide. World Food Safety Day was established by the United Nations to raise awareness of food safety measures and is facilitated by WHO and F.A.O.

The United Nations forms the Food and Agriculture Organization of the United Nations (F.A.O.) on October 16. WHO and F.A.O. come together to form the Codex Alimentarius which sets the guidelines for food safety. The F.D.A. releases the first Food Code to serve as a standard for food sanitation for health jurisdictions, food services, and retail. The U.N. establishes World Food Safety Day, facilitated by WHO and F.A.O.

What is wrong with Odia Cinema?

Odia cinema, commonly referred to as Ollywood, encounters numerous obstacles that have impeded its development acknowledgment, despite a rich heritage that traces back to the inaugural Odia film, Sita Bibaha, released in 1936. For many years, Odia cinema has faced criticism for its tendency to create formulaic films, frequently remaking South Indian or Hindi productions, which lack originality.

Cliched Elements: These films generally adhere to predictable narratives filled with clichéd elements, such as romantic themes characterized by exaggerated performances and outdated dance routines, failing to connect with contemporary viewers. The industry's dependence on imitating other regional cinemas, especially during the early 2000s, resulted in a waning interest from audiences, as these films often lacked cultural significance or relevance to Odia society. Although recent works like Daman (2022) and Pratikshya (2022) indicate a movement towards original and socially pertinent narratives, the industry continues to grapple with the challenge of consistently delivering high-quality and innovative content. The cinema market in Odisha is relatively limited, characterized by insufficient theater infrastructure, especially in rural regions. While critically acclaimed films tend to thrive in urban areas, smaller theaters face challenges in maintaining operations.

OTT Platform: Historically, the audience's inclination towards

unconventional subjects. Although the emergence of OTT platforms and increased access to global and regional content have shifted audience expectations, Odia cinema has been slow to respond to these changing preferences. The scarcity of suitable cinema halls, particularly in culturally important cities like Puri, where Sita Bibaha made its debut, hampers the distribution of Odia films. The deteriorating condition of historic venues such as Laxmi Talkies underscores the neglect of exhibition facilities. Additionally, ineffective public exhibition policies and their enforcement further complicate the situation, hindering films from reaching broader audiences. The Odia film industry is hindered by insufficient financial resources and a lack of governmental support. Producers encounter challenges in achieving profitability due to the absence of subsidies, which are available in other states that support regional cinema. Film policies introduced by the Odisha government, such as those in 2019 and 2025, have frequently proven ineffective due to poor funding and implementation strategies, resulting in a lack of a solid framework for industry growth. The combination of high production costs and low boxoffice revenues discourages investment in more ambitious projects, compelling filmmakers to focus on low-budget, riskaverse productions.

Talent: Fostering Additionally, there is a deficiency of skilled professionals, including directors, writers, and technicians, who are capable of creating films that can compete on a national or international level. Furthermore, excessive interference from producers in the creative process and a limited exposure to global cinema among filmmakers have been identified as significant obstacles to achieving highquality filmmaking. Although institutions such as the Biju Patnaik Film & TV Institute are



present, their effectiveness in fostering talent has been relatively minimal when compared to similar institutions in states like Bengal or Kerala. In Odisha, cinema is frequently perceived as a trivial art form by the semi-feudal society and the English-speaking middle class, lacking the academic and cultural esteem it holds in regions like Bengal or Kerala. This societal perception hinders substantial investment and involvement with the medium. The industry has faced challenges in preserving its ties to Odia cultural identity, with numerous films failing to embody the state's rich literary and artistic legacy, including the works of Gopinath Mohanty or Manoj Das. Generally, Odia films have perpetuated patriarchal stereotypes, especially in their depiction of women, confining their roles to traditional or submissive figures. This has estranged audiences who are in search of more progressive storylines. The representation of marginalized communities, including individuals with disabilities, has frequently been inadequate or based on stereotypes, neglecting to address current social issues with the necessary sensitivity. While early Odia cinema was heavily influenced by mythology and literature, the industry has largely shifted away from adapting the state's abundant literary heritage, which could offer engaging and

authentic narratives.

Literary Adaptations: Films such as 'Matira Manisha' and 'Malajahna' achieved success through literary adaptations, yet such instances have become increasingly uncommon, partly due to commercial pressures and audience tastes. Ineffective marketing strategies and distribution channels have hindered the visibility of Odia films, both within Odisha and in wider markets. Even films that receive critical acclaim often struggle to attract national or international recognition because of these limitations. The industry's dependence on holiday releases for major films further constrains its capacity to maintain a steady presence in theaters. The 1970s and 1980s are regarded as the pinnacle of Odia cinema, marked by socially significant films from directors such as Prashanta Nanda and Mohammad Mohsin, which achieved both critical acclaim and commercial success. However, the industry faced a downturn in the 1990s and 2000s, primarily due to an influx of subpar remakes and a decline in audience confidence. Additionally, events like the devastating super cyclone of 1999, which severely impacted infrastructure, including Kalinga Studio, further hindered the industry's progress.

Post-Covid Films: Nevertheless, there are cinema, especially in the post-COVID era. Films such as Daman (2022), Pratikshya (2022), and Pushkara (2023) have focused on original narratives rooted in Odisha, garnering both critical praise and commercial viability. The revival of literature-inspired films and a rise in professionalism, exemplified by actors auditioning for roles, suggest a transition towards a cinema that prioritizes quality. Discussions on social media indicate an increasing sense of optimism among audiences, highlighting the need to support theaters and promote contentdriven films similar to those in Malayalam cinema. Initiatives such as designating April 28 as Odia Cinema Day are proposed to enhance cultural pride and visibility within the industry. To tackle these challenges, the industry could prioritize the implementation of an effective film policy that includes subsidies, infrastructure development, and a dedicated fund, to the extent of Rs 50 crore. Additionally, it is essential to strengthen film institutes and provide filmmakers with exposure to international cinema. Leveraging Odisha's literary heritage can help in crafting authentic and relatable narratives.

Cinema Halls: Furthermore, expanding the audience base through improved marketing strategies, OTT releases, and culturally relevant content is crucial. Revitalizing and establishing cinema halls, particularly in rural regions, will also aid in broadening the reach. As a final point, although Odia cinema faces systemic challenges such as a deficiency in originality, inadequate infrastructure, and a lack of support, recent achievements and an increasing focus on quality indicate a possibility for rejuvenation. With dedicated efforts from filmmakers, audiences, and governmental bodies, Odia cinema has the potential to restore its cultural importance and national recognition.



Govt accelerates drainage fixes in Twin Cities

Bhubaneswar (DMC): The Odisha government has initiated urgent steps to address persistent waterlogging problems in Bhubaneswar and Cuttack, Housing and Urban Development Minister Krushna Chandra Mahapatra announced on Friday.

Speaking to reporters in Bhubaneswar, Mahapatra acknowledged drainage blockages at several locations and assured that the entire department is actively working to resolve the issue. "There are blockages at several places, and the entire department is engaged to set it right," he said. Chief Minister Mohan Charan Majhi is personally monitoring the situation through regular reviews, Mahapatra added. While longterm infrastructural solutions will take time to implement,



immediate temporary measures are being undertaken to mitigate the impact of heavy rainfall. At vulnerable points such as the area near the ISKCON temple, hume pipes are being installed to expedite water discharge. In addition, efforts are underway to cover open drains with concrete slabs. "Most of the open drains have already been covered, and the rest will be completed

shortly," the minister stated. Cleaning of drainage systems in both Bhubaneswar and Cuttack is being carried out in an accelerated manner to ensure unobstructed flow and minimize flooding risks during monsoon rains. "These steps are part of our broader commitment to improving urban infrastructure and ensuring better living conditions in the twin cities," Mahapatra affirmed.

Odisha to impose curbs for Rath Yatra amid Covid surge Bhubaneswar (DMC): With seven new cases being detected in

Bhubaneswar (DMC): With Covid-19 cases recording a surge in Odisha, the State government has issued special advisory for devotees for the upcoming Rath Yatra in Puri as lakhs of people are set to visit the pilgrim town to witness the grand event.

As part of efforts to contain further spread of infection, the Health and Family Welfare Department has advised the devotees to take precautionary measures while visiting Puri during the annual car festival. Those having symptoms of Covid-19 have been advised to refrain from visiting Puri during Rath Yatra of Lord Jagannath and siblings this time. Elderly people and those having comorbidities have been advised not to participate in the festival this year. People participating in the



Rath Yatra should use masks and adopt proper hand sanitisation, Director of Health Services Amarendra Nath Mohanty told reporters.

He said steps are being taken to again operationalise the ICUs set up during the last Covid-19 pandemic at Puri ahead of the festival. Arrangements have also been made to provide additional beds at the District Headquarters

Hospital (DHH) in Puri, while more doctors have been deployed at the hospital. Adequate health staff as well as equipment are also being provided at the DHH. Senior officials of the department visited the hospital and inspected the arrangements ahead of the annual Rath Yatra.

It may be noted that the Covid-19 tally in Odisha this season touched 30 on Friday with

seven new cases being detected in the last 24 hours. Public Health Director Nilakantha Mishra said the situation is under control in the state which has an active caseload of 23 with seven patients having recovered from the infection. None of those infected are serious. The ICMR has also urged people with comorbidities and elderly persons to remain alert and follow Covidappropriate behaviour in view of the gradual uptick in cases.

Bhubaneswar, Cuttack and Khurda are among the places where the cases have been detected so far. Meanwhile, the Centre has asked states and Union territories to ramp up healthcare preparedness and ensure availability of oxygen, ventilators, and essential medicines at hospitals.

OHPC inks pact with WAPCOS for sustainable energy

Bhubaneswar (DMC): In line with India's commitment to transition to sustainable energy, the Odisha government has signed an agreement between Odisha Hydro Power Corporation Ltd. (OHPC) and WAPCOS Ltd.

for project management consultancy services for the 600 MW Upper Indravati Pumped Storage Project (UIPSP). The project, located at Mukhiguda, aims to provide a huge energy storage system that pumps water from a lower reservoir to an upper reservoir during surplus power availability and releases it to generate power during peak demand periods. This will help



balance generation and demand, ensuring power system stability. The UIPSP will have an underground powerhouse with four reversible-type Francis hydroelectric units, each with a capacity of 150 MW, totalling 600 MW. The project will operate in both pumping and

generating modes, circulating water between the two reservoirs. Deputy Chief Minister Kanak Vardhan Singh Deo said, "This collaboration marks a crucial step in advancing Odisha's energy sector while ensuring efficiency and sustainability." The project is part of India's broader goal to

achieve 500 GW of installed capacity from non-fossil sources by 2030. The proposed PSP will have an underground powerhouse located near the lower reservoir, equipped with four vertical-axis reversible-type Francis Hydroelectric units having capacity of 150 MW each and will operate in pumping as well as generating mode in different times of a day in cycle by circulating water between above two reservoirs.

The agreement was signed in the presence of senior officials from the Water Resources, Energy, OHPC and WAPCOS departments. DC-cum-ACS Anu Garg and Principal Secretary, Energy Vishal Kumar Dev were also present.

Junior teachers protest over job regularisation

Bhubaneswar (DMC): Hundreds of junior school teachers from across Odisha gathered in the state capital on Friday to stage a protest demanding the regularisation of their jobs and the abolition of the contractual appointment system.

Assembling at Mahatma Gandhi Marg, the teachers held banners and placards decrying the current contractual employment policy in government-run primary schools. They called for immediate action from the state government to address their concerns. "We receive a monthly salary of just Rs 16,000, which is not sufficient to support our families," said one protesting



teacher. In several BJP-ruled states, junior teachers are paid significantly better," said protestor, also pointing out the lack of social security benefits for contractual staff. Another teacher emphasized the need for parity, stating, "We are demanding equal pay for equal work. Our jobs must be regularized, and the practice of hiring junior

teachers on a contractual basis must end." According to protestors, nearly 16,000 junior teachers are currently serving under contractual terms in government primary schools throughout Odisha. They warned that the agitation would intensify if the government failed to respond to their demands promptly.

Debrigarh "The Land of Indian Bisons"

Sambalpur, (DMC): Authorities of Hirakud Wildlife Division have published the Census data of Indian Bison (Gaur) or "Gayala" in Odiya of Debrigarh Wildlife Sanctuary conducted from 11th May'2025 to 13th May'2025 (3 days). The total number of Indian Bisons is 788 numbers including 315 juveniles (less than 2 year old) & including 128 newborns (less than 3months).

Juneniles are 40% of total population (315 out of 788). For the first time Census of Indian Bisons was conducted at Debrigarh during winter'2024 on 12th & 13th November and number of Bisons was found to be 659. Within 6 months gap around 129 number has increased. Last time 52 herds were recorded, this census reported 60 herds due to increase in population, herds keep dividing with female adults leading the herd and guiding other sub-adults &



parts of India, Summer marks the breeding season for Indian Bisons. To determine the peak breeding season, peak Calving season & further understanding of population dynamics of Indian Bisons, during Monsoon & Winter this year there will be monthly survey count of the number of new- borns in population. This will strengthen conservation of this Schedule-1 species in this landscape as Debrigarh displays healthy density of Indian Bisons in comparison to other habitats in India. Debrigarh is termed as " The Land of Indian Bisons" due

Eco Sensitive Zone on edges of Hirakud Wetland. Bisons can migrate long distances too, but in Debrigarh they are seen to display seasonal movement of 5 to 15 kilometers per day keeping their territory mostly constant. In Safari Zone total 145 Indian Bisons are residing in 6 herds. Last year 118 numbers in 5 herds used to move in this belt. Bisons are mostly Territorial animals, intelligent & majestic. Indian Bison (Gaur) is under "Vulnerable " vulnerable means high risk of extinction) category & therefore is a Schedule-1 species under Wildlife Protection Act'1972.

Bengaluru, (HS): Police have arrested Nikhil Sosale, the marketing and revenue head of Royal Challengers Bengaluru (RCB) at Diageo India, in connection with the stampede that occurred outside M. Chinnaswamy Stadium on Wednesday, June 4. The incident took place during the team's IPL victory celebrations. According to India Today, Sosale was detained at Bengaluru airport while attempting to board a flight to Mumbai. In addition, three employees of DNA Entertainment Networks Pvt. Ltd.-the company responsible for organizing the eventhave also been taken into custody. The arrests follow a directive issued by Karnataka Chief Minister Siddaramaiah, who ordered action against key officials of RCB, DNA Entertainment, and the Karnataka State Cricket Association (KSCA). An FIR had been filed earlier, invoking multiple charges, including culpable homicide not amounting to murder. In a major administrative shake-up, CM Siddaramaiah also suspended Bengaluru Police Commissioner B Dayananda and several senior police officials over their handling of the event and ensuing chaos.

J&K CM Makes Passionate Appeal for Statehood Restoration

KATRA, (HS) : Chief Minister Omar Abdullah on Friday raked up the issue of restoration of statehood to Jammu and Kashmir at the flagging off of the maiden train to Kashmir by Prime Minister Narendra Modi in this pilgrim town."There are four persons on this stage who were present at the inauguration of the Katra railway station (in 2014). The erstwhile state was reorganised into the Union territories of



Jammu and Kashmir and Ladakh following the abrogation of Article 370 in August 2019. Abdullah said many people have dreamt of seeing a train chugging into Kashmir. "Even the British had dreamt of connecting Kashmir by train but they did not succeed. Their plan was to bring rail from Uri, along

the banks of Jhelum, to connect with the country. What the British could not achieve has happened at your (Modi's) hands and Kashmir has been connected to the rest of the country," he added. Abdullah paid rich tributes to former Prime Minister Atal Bihari Vajpayee for declaring the train to Kashmir a project of national importance. "It will be a grave mistake if I do not thank former PM Vajpayee. This project was undoubtedly started in 1983-84.... but it was completed only after Vajpayee declared it a project of national importance and made provisions in the budget," he said. "I must also pay my gratitude to Atal Bihari Vajpayee, who declared the rail link to the Valley a national priority project and made financial allocations for it," CM Omar said.

Hearing a petition challenging the conduct of the exam in two shifts, the Supreme Court has ruled to conduct the exam in a single shift. The Supreme Court on Friday directed the NBT to ensure that the NEET PG 2025 exam is conducted in a single shift and not in two shifts. The court has directed to make arrangements for conducting the exam in a single shift. The exam will be conducted in CBT mode on June 15. Earlier, a schedule for conducting the exam in two shifts was published. The exam result slip will be released on June 2 for candidates appearing for the NEET PG exam. The result slip will not be published on the official website. The National Board of Medical Examinations will send the result slip to the registered email ID of the candidates, which the candidates can download. It is worth mentioning here that the admit card will be released about four days before the exam date. Seven Naxalites surrender in Chhattisgarh's Dantewada district

DANTEWADA, (HS): Seven Naxalites, two of them carrying cash rewards on their heads, surrendered in Dantewada district of Chhattisgarh on Friday, a police official said. The cadres turned themselves in before police and CRPF officials citing disappointment at the growing differences within the outlawed CPI (Maoist), the harsh forest life and the movement's hollow ideology, he said. The surrendered cadres also said they were impressed by the police's rehabilitation drive 'Lon Varratu' in the district and the state government's new surrender and rehabilitation policy, the official added.

The official identified the surrendered cadres as Juglu alias Sundum Kowasi (23), Dasha alias Burku Podiam (26), Bhoja Ram Madvi (48), Lakhma

alias Suti (26), Ratu alias Othe Kowasi (25), Sukhram Podiyam (25) and Pandru Ram Podiyam (45). "Juglu and Dasha carried a bounty of Rs 50,000 each. The surrendered Naxalites were involved in incidents like damaging roads, cutting trees, putting up Naxalite banners, posters and pamphlets during 'bandh' called by Maoists. They were provided assistance of Rs 50,000 each post surrender and will be further rehabilitated as per the government's policy," the official said. With this, a total of 991 Naxalites, including 238 carrying rewards, have so far quit violence in the district under the 'Lon Varratu' (term coined in local Gondi dialect which means return to your

home/village) campaign launched in June

Siddaramaiah's Political Secretary Removed, Karnataka Intel Head Transferred

Bengaluru, (HS): In another major move a day after it suspended the Bengaluru police commissioner and some other key police officials in the wake of the stampede in the city, the Karnataka government has sacked Chief Minister Siddaramaiah's political secretary K Govindaraj and transferred the head of the intelligence department, Hemant Nimbalkar. Sources told NDTV that Mr Govindaraj lost his job because, during a key meeting at the Chief Minister's house on Wednesday morning - hours before the stampede he had pushed for the celebrations of the victory of the Royal Challengers Bengaluru to be allowed despite the police commissioner refusing to agree to three events and stating that a victory parade could not be given a go-ahead. Mr Govindaraj then persuaded the police commissioner to allow two events - at the state legislature complex, which is called the Vidhana Soudha, and the Chinnaswamy Stadium.

11 people, including a 14-year-old



girl, died and 47 were injured in the stampede on Wednesday afternoon which occurred when lakhs of fans gathered to catch a glimpse of players from the Royal Challengers Bengaluru after they won the Indian Premier League. The team and the fans had waited 18 years for the moment, but the celebrations turned tragic when a huge crowd gathered outside the

Chinnaswamy Stadium and a rumour of free entry reportedly triggered a stampede. On Thursday, Chief Minister Siddaramaiah announced the decision to immediately suspend Bengaluru Police Commissioner B Dayananda, Assistant Commissioner of Police C Balakrishna, Deputy Commissioner of Police (Central Division) Shekhar H Tekkannavar, Additional Commissioner of Police Vikash Kumar Vikash and Circle Police Inspector of Cubbon Park Police station A K Girish. "It is found that there has been, on the face of it, substantial dereliction of duty by these officers," the suspension order had said.

After the suspensions, the opposition BJP and the Janata Dal (Secular) accused the Chief Minister of using the police officers as scapegoats to deflect responsibility from the state government. Mr Siddaramaiah, however, dismissed the allegation and accused the opposition of playing politics over the issue. "They are speaking for the sake of politics. I don't want to do politics in this matter. Those responsible prima facie, who have not fulfilled their responsibility properly, have been suspended," he was quoted as saying by news agency PTI on Friday. The suspension of Mr Siddaramaiah's secretary K Govindaraj and state intelligence department chief Hemant Nimbalkar followed soon after.

Suspended ASI **Among 4 Held** In Samastipur

Patna, (HS): In a joint operation conducted by the Special Task Force (STF) and Samastipur police in Bihar, four individuals, including a suspended Assistant Sub-Inspector (ASI) of police, were arrested after intense firing from both sides on Friday. The joint team also recovered a large cache of firearms and ammunition from their possession. This is considered a significant achievement of the Bihar STF and Samastipur police. The main accused, suspended ASI Saroj Singh, also known as Nimki Singh, was apprehended from his residence in Sultanpur Ganga Diara Village, under the jurisdiction of Mohiuddin Nagar police station.

Patori range Sub-Divisional Police Officer (SDPO) confirmed the incident. During the raid, authorities seized over 450 live cartridges and modern firearms, from Saroj Singh premises.Police suspect that the ASI allegedly has a strong connection with the local arms smugglers. According to an official, the raid triggered resistance from Saroj Singh and his local supporters, resulting in a tense standoff. They fired several rounds on the joint forces after they saw them approaching.STF personnel, supported by the local police, were forced to retaliate to maintain control, creating panic in the village during the operation. The STF and Samastipur police have not yet disclosed the nature of the seized weapons but have confirmed that a detailed investigation is underway. The arrested individuals are currently being interrogated, and further legal proceedings are expected to follow.

Actor Jeetendra sells Andheri plot for Rs 855 crore



Mumbai, (HS): Veteran Bollywood actor Jeetendra and his family-owned firms -- Pantheon Buildcon Private Limited and Tusshar Infra Developers Private Limited -- have sold a land parcel in Andheri, Mumbai, for Rs 855 crore, according to property registration documents reviewed by Square Yards on the website of the Inspector General of Registration (IGR). The transaction was registered in May 2025. The land parcel, along with the built-up area, was bought by NTT Global Data Centers & Cloud

Infrastructure India Private Limited, formerly known as Netmagic IT Services Private Limited. NTT, a Japanese tech conglomerate, is India's largest data center provider and a prominent IT services company. It specializes in a range of services including public and private cloud solutions, hosting, data management, application development, threat monitoring, content delivery networks, and testing services and serves customers globally.

According to property registration documents from the IGR, reviewed by Square Yards, the transaction comprised two contiguous land parcels spanning a total area of 9,664.68 sq. m. (~0.96 hectares or ~2.39 acres). The site currently houses Balaji IT Park, and includes three constructed buildings with a cumulative built-up area of 45,572.14 sq. m. (4,90,534 sq. ft.). The deal incurred a stamp duty of Rs. 8.69 crore and registration charges amounting to Rs. 30,000. The transaction, which is believed to be one of the largest real estate deals involving a Bollywood family, comes at a time when global tech giants are looking to expand their data center network in India. Jeetendra is a prominent figure in Hindi cinema, having acted in over 200 films across a career spanning more than six decades. His daughter, Ekta Kapoor, is a well-known producer and director in Hindi television and film, currently serving as Joint Managing Director and Creative Head of Balaji Telefilms Limited. His son, Tusshar Kapoor, is also active in the entertainment industry as an actor and producer.

Rising COVID-19 cases in India trigger spike in spam messages from hospitals

NEW DELHI, (HS): Are you receiving messages or calls from hospitals or labs to get yourself tested if you are unwell as COVID-19 cases are increasing in the country? If yes, you are among the hundreds of people in the country who are inundated with unsolicited spam messages. A latest nationwide survey has said that ever since COVID-19 cases have been increasing in India, nearly one in five people are receiving promotional communication from hospitals and labs where they took the COVID-19 vaccines or tests during the earlier surges.

In fact, under the recently released Draft Digital Personal Data Protection Rules, 2025, even if a customer has shared their contact details, the retailer, the diagnostic clinic or any other entity must keep them secure. They cannot use it for making spam calls or sending promotion messages unless explicit permission has been granted. However, the LocalCircles survey found that in many cases, a person who once used the services of a diagnostic clinic or hospital is inundated with spam messages and calls. The survey, conducted among 18,000 people in 301 districts, found that 18% of people claimed that they are receiving



promotional communication from third parties/labs/hospitals where they got COVID-19 tests done during the earlier COVID-19 surges in the country. Also, as many as 17% indicated that they are receiving promotional communication from the hospitals and labs where they received the COVID-19 vaccine and from third parties. According to Sachin Taparia, founder of LocalCircles, they conducted the survey after receiving hundreds of messages from people complaining that they were getting unsolicited calls and messages from labs and hospitals they had visited earlier. So they asked the surveyors whether they had observed that data shared by them with private entities for getting a COVID test done between 2021 and 2023 is now being used to sell other health-related products and services to them. As many as 18% accepted that they get such pesky calls and messages.

Next, they asked people whether they have observed that data shared by them with private entities for getting a vaccine dose between 2021 and 2023 is now being used to sell other healthrelated products and services to them. The response from 17 per cent was a big yes. Taparia said that with the Digital Personal Data Protection

(DPDP) Rules, 2025, which is still to be finalised, consumers continue to bear the harassment or block calls from unwanted numbers. The other options before them are to approach an adjudicating officer under section 46 of the IT Act to file for compensation or file a civil suit for breach of privacy or confidence. "Based on our survey findings, it is safe to conclude that data of some citizens have been compromised by hospitals/ labs while compiling patient data during the COVID test or administering the vaccine or booster dose," he added. "This unethical practice appears to be a clear misuse of information. The government needs to not only protect citizens' data given to its agencies with specific purposes but also ensure that private entities safeguard the same and do not use it for any commercial purpose themselves or through third parties, as made clear through the survey. Hopefully, DPDP Rules will soon plug this misuse of citizens' data," he further

Australian PM: Not To Compromise Biosecurity Laws in Tariff Negotiations With US

Canberra, (H.S): Australian Prime Minister Anthony Albanese said on Friday that his government will not loosen biosecurity laws as it considers lifting a restriction on imports of US beef.

The Australian Broadcasting Corporation (ABC) and Nine Entertainment newspapers reported on Friday that Albanese's Labor Party government could use the import ban on some beef slaughtered in the US as a bargaining chip in negotiations for an exemption from US tariffs.Responding to the reports, Albanese said that his government would not negotiate on biosecurity but would be open to a solution that would not compromise food safety, Xinhua news agency reported."We'll



never loosen any rules regarding our biosecurity," he told ABC radio. Australia lifted a blanket ban on US beef imports, which had been in place since 2003, in 2019 but import restrictions on beef products from Canadian and Mexican cattle slaughtered in the US remain in place. The US administration in March identified biosecurity laws relating to beef imports as a trade

grievance with Australia ahead of unveiling the 'Liberation Day' tariffs.The ABC and Nine Entertainment both reported that Australian officials believe that biosecurity laws could be tweaked to allow US beef into Australia without risking safety.

It comes ahead of an expected meeting between Albanese and US President Donald Trump on the sidelines of the upcoming G7 Leaders' Summit in Canada. Health Minister Mark Butler, a member of Albanese's cabinet, told Seven Network television on Friday that the beef import restrictions have been under review for "some time.""This will be a decision taken on its merits, not for convenience, not to get a deal. We'll be taking a decision in the national interest in this area," he said.

Dubai's Next Big Project Could Top Burj Khalifa: Emirates Chief Tim Clark

Dubai, (H.S): In a conversation with Piers Morgan, Emirates President Sir Tim Clark hinted that Dubais next act could eclipse even the Burj Khalifa. "I daresay there are other things that are going to come along that are bigger and more beautiful than Burj Khalifa we dont know," he said.

In a conversation with British media personality Piers Morgan, Emirates' President Sir Tim Clark hinted that Dubai's next act could eclipse even the Burj Khalifa. His comments come during a conversation about Dubai's growth from a regional trading post to a global hub. Clark threw light



on the strategy of Dubai rules to build a diverse economy that is not dependent on limited fossil fuel resources. He focussed on how critical mass was created across various sectors, such as media, tech, aviation, hospitality, and banking. He added, "Somebody

had to think that this really - If I am going to make it work, not only must I put the place on the map geographically with some iconic things, but I've also got to make the city come into a critical mass where it is going to develop wealth for the government, but it must

work for all the citizens of Dubai as well." Clark described Dubai's rapid development as being "on steroids" from the early 90s. He admitted that he could never anticipate the magnitude of Dubai's future success. He explained that the ruler's vision played a critical role in channeling wealth directly into the city's development and ensuring its benefits reached the citizens. "What the ruler said no, we

must put our money in this city and use that money to develop this city - that was part of the model", he said.Clark said that Dubai's ambition has not been accidental and has been a part of the city's operating DNA. He added that the growth was "guided and steered", so that it did not become "a sprawling and undirected metropolis.

Mexico Rejects US Top Court Ruling on Lawsuit Against Gun Companies



Mexico City, (H.S): The Mexican government said that it strongly disagrees with a US Supreme Court ruling to dismiss its lawsuit against eight US gun companies for their alleged role in trafficking illegal arms into Mexico. The Ministry of Foreign Affairs strongly expresses its disagreement with the decision issued by the Supreme Court of the United States, the government said in a statement, reiterating that

Mexico "will continue to do everything in its power to curb illicit arms trafficking" by exhausting all available legal and diplomatic remedies, Xinhua news agency reported. Earlier in the day, the US top court spared the American gun companies from a lawsuit by Mexico's government accusing them of aiding illegal firearms trafficking to drug cartels and fueling gun violence in Mexico.In August 2021, Mexico filed a lawsuit against eight US gun manufacturers and distributors in a federal court in Boston, Massachusetts, seeking to hold them legally accountable for the flow of weapons that fuels violence and strengthens criminal rings that threaten the safety of Mexicans. Thursday's court ruling does not affect the course of a second lawsuit filed in 2022 in a court in Tucson, Arizona against five gun dealers, the ministry said.

This second case is ongoing and is in the evidencegathering stage."Mexico has presented solid arguments demonstrating the harm that gun manufacturing companies cause to our country, and will continue its fight against arms trafficking and hold accountable those who allow the flow of weapons to continue fueling violence," the ministry said.

US Army Aims To Produce 3D-Printed Skin To Help Treat Soldiers

US, (H.S): The US Army is exploring the technology of bioprinting, which involves 3D printing human tissues using living cells, proteins and nutrients as raw materials, to treat the wounds of soldiers and save their lives, the official site of the US Department of Defence said.

The US Army Combat Capabilities Development Command Chemical Biological Center (DEVCOM CBC) has collaborated with the University of Hawaii System on two initiatives in order to leverage biomaterials and advanced manufacturing. The project is under a cooperative research and development agreement (CRADA) and two initial joint work statements (JWS), according to the US Army.From organ-on-a-chip scientific tools



capabilities, the two organisations would work on various life-saving initiatives to support the United States Indo-Pacific Command (USINDOPACOM), which is headquartered in Hawaii.Dr Jason Barnhill,

who is an associate research professor at the John A Burns School of Medicine (JABSOM). at the University of Hawaii at Manoa, will work with Priscilla bioengineering researcher, to develop organ models for assessing various compounds under the first

As quoted in the official report, Sam Shomaker, dean of the University of Hawaii at Manoa JABSOM, said, "We are incredibly proud that Dr. Barnhill and Priscilla Lee are representing the University of Hawaii at Manoa and DEVCOM CBC with these efforts that have the potential to save the lives of our frontline Soldiers and civilians across the world." "By helping to introduce innovative biofabrication technology to even more remote areas, JABSOM is assisting in the mission across the Pacific and globally," Shomaker added.

The official report mentions that Lee's focus is on bioprinting cell culture models with an aim to understand immune responses and develop next-generation biomaterials for various uses. The project aims to enhance the current in vitro organ models with the help of bioprinting. The researchers believe that the bioprinting technology would help soldiers in treatments for burns, exposure to poisonous gases, antibiotic-resistant bacteria and more such threats.

Germany Backs NATO Military Expansion While Battling Troop Shortage

Berlin, (H.S): German Defence Minister Boris Pistorius said on Thursday that Germany supports NATO's large-scale military expansion plan, which is expected to be approved during the alliance's defence ministers' meeting in Brussels. However, the country is currently grappling with a significant shortage of troops. To meet the ncreased defence requirements under the plan, the German Bundeswehr will need to add 60.000 active-duty soldiers, Pistorius told the media ahead of the meeting.

"Given Germany's size and economic strength, we will shoulder a significant part of NATO's military build-up," he said. "As the alliance's traditional second-largest military force, we are continuing in that role." NATO Secretary-General Mark Rutte emphasised Wednesday that the alliance needs "more resources, troops, and capabilities" to fully implement collective defence



strategies and respond to any threat. He highlighted air and missile defence, long-range weapons systems, logistics, and large land force formations as top

Germany However, continues to face a persistent shortage of military personnel. Despite intensified recruitment efforts, the Bundeswehr saw a further decline in troop numbers last year, while the average age of soldiers continued to rise. According to the defence ministry, the total number of military personnel stood at approximately 181,000 by the end of 2024. Previously, Pistorius outlined a goal of expanding Germany's total military force to around 460,000, including 203,000 active-duty troops, 60,000 current reservists, and an additional 200,000 new reservists.

He has since announced plans to "establish and fully equip new large military formations."To support this expansion, German Frank-Walter President Steinmeier signed a constitutional

amendment in March to relax the country's so-called "debt brake," allowing greater government borrowing for defense and infrastructure investment. The move aims to bolster Germany's role in European security, Xinhua news agency reported.On the question of reinstating compulsory military service, Pistorius acknowledged that sufficient training accommodation capacity.

As a result, the country will maintain its voluntary military service system in the near term while gradually expanding capabilities. At the end of this month, NATO member states are expected to finalize new defence spending targets at a summit in The Hague. NATO chief Rutte has suggested members allocate 3.5 per cent of their gross domestic product to direct defence expenditure, and an additional 1.5 per cent for broader securityrelated spending by 2032.

Displacement, cholera drive up humanitarian needs in Sudan: UN

United Nations, (H.S): Conflictrelated displacement of people and the spread of cholera continue to increase humanitarian needs across Sudan, according to UN spokesman.Nearly 9,700 people in Khartoum state alone were recently displaced due to conflict, said Stephane Dujarric, spokesman for UN Secretary-General Antonio Guterres, citing figures from the International Organization for Migration

In South Kordofan, more than 9,000 people fled Dibebat town in Al Quoz locality last week due to intense clashes. The situation remains very volatile, he said, quoting the IOM on Wednesday. At the same time, about 600 people were displaced from Abu Shouk camp and El Fasher town in North Darfur state just last week, he said. On the cholera outbreak, the spokesman said daily cases are steadily increasing in River Nile state in the north although they are falling in Khartoum state, Xinhua news agency reported.In the past two



weeks alone, health authorities in River Nile state have reported more than 180 cumulative cases and four deaths. And of the total cases, 55 were reported to have arrived from other states, underscoring the cross-regional spread of the disease, said Dujarric.

Humanitarian partners warn that continued displacement, damaged infrastructure, and limited access to safe water are accelerating transmission, he said. Meanwhile, thousands of displaced people are now returning to Blue Nile state and need urgent assistance. They lack food, clean

water, health care, shelter and education, he said. Humanitarian organisations are working hard to meet the growing needs of people in Sudan. But insecurity, access constraints and critical funding shortfalls continue to undermine the response, said the spokesman."

Once again, we call for an immediate cessation of unimpeded hostilities. humanitarian access across borders and conflict lines, the protection of civilians, as well as increased funding so we can scale up," he said.

Indian Delegation Calls on US Vice President Vance, Has 'Excellent Meeting'

Washington, (H.S): The All-Party Parliamentary Delegation led by Shashi Tharoor on Thursday had an "excellent meeting" with the United States Vice President J.D. Vance in Washington, briefing him about Operation Sindoor, terrorism faced by India and regional security.'

All Parliamentary Delegation led by Dr. Shashi Tharoor called on Vice President J D Vance this morning. The conversation focused on strengthening the India-US partnership including cooperation in counterterrorism domain," the Embassy of India in the United States posted on X."Excellent meeting with Vice President J D Vance today in Washington D.C. with our delegation. Top Bankers Hail RBI's Big Bang Measures To Boost Financial Inclusion

New Delhi: Top bankers on Friday hailed the Reserve Bank's decision to reduce repo rate by 50 basis points to 5.50 per cent and cash reserve ratio (CRR) by 100 basis points in four tranches, saying the policy move is expected to provide the necessary drive for credit expansion in priority sectors which will enhance the financial inclusion.Besides this, the revision in CPI inflation to 3.7 per cent for FY26 also shows the RBI's confidence in inflation being aligned with its 4 per cent target."The decision in CRR cut, which is expected to release Rs 2.5 lakh crore in primary liquidity, will ease credit conditions in the banking system. This overall policy reflects a wellcalibrated and thoughtful approach with the GDP projected at 6.5 per cent in FY26 and a steady quarterly trend," said Ajay Kumar Srivastava, MD and CEO, Indian Overseas Bank.The pickup in non-gold imports and a 14 per cent



increase in gross FDI also indicate robust domestic demand and global investor confidence in India's structural strength. These steps, said bankers, will ensure the durability of the nascent resurgence in the domestic demand led by private spending."

The key learning from the policy is that the central bank is not leaving any stones unturned to ensure price stability, at the same time doing everything it takes to support growth," said Vinod Francis, General Manager, Chief Financial Officer, South Indian Bank.With tariff uncertainty casting a long shadow over external demand (exports), the RBI's sharp focus on supporting domestic demand and enhancing the lending power of the banking sector underpins its policy path during the current easing cycle by addressing key concerns on both demand and

supply sides, he mentioned. The MPC has surprised markets with a big bang set of measures. This clearly comes from the perspective of frontloading actions to enable

support to growth, considering the lag effects of transmission." At the same time, the shift of stance to neutral has meant that the policy rates may possibly level off at 5.50 per cent in the current cycle. However, this would remain a moving target with incremental data points likely to shape the outcome," according to Rajeev Radhakrishna, CIO, Fixed Income, SBI Mutual Fund.

Indranil Pan, Chief Economist, YES BANK, said the RBI now focuses on the transmission mechanism, which has been slow to start with and is still not significantly visible for the credit markets. The significant CRR reduction would ensure a lowering of the cost of funds for the banking system, thereby ensuring transmission of the 100 bps repo rate reduction."Going ahead, we still think there is a chance for a last 25 bps cut, but the timing of the same remains uncertain," Pan added.

ICEA, IT Ministry Urge States To Make India A Component Manufacturing Hub

New Delhi, (H.S): States should work together and leverage Centre's scheme for encouraging domestic manufacturing of electronic components to make India a global hub of components manufacturing, the India Cellular and Electronics Association (ICEA) said on Friday. Various states such as Tamil Nadu, Assam, Uttar Pradesh and Andhra Pradesh are coming up with their own policy for encouraging components manufacturing in their respective

In an industry event in Andhra Pradesh, Sushil Pal, Joint Secretary, MeitY, emphasised the government's commitment to fostering domestic electronics manufacturing through a hybrid scheme which offers Capex support and turnover linked incentive for components manufacturing. He appealed that states have to play a proactive role in this mission of making India a component manufacturing



powerhouse for the world. Bhaskar Katamneni, Secretary, IT & EC, state government, unveiled the draft Electronics Component Manufacturing Policy (ECMP) at the event to encourage manufacturing of electronics components in the state."We are not only promoting ease of doing business but also enabling the 'Speed of Doing Business'. Andhra Pradesh is crafting a more competitive and agile policy framework compared to the national landscape," said Katamneni. He said that the Andhra Pradesh-ECMP will be notified in the next 10

SEBI Freezes Mehul Choksi's Bank Accounts & Investments To Recover 2.1 Crore

Mumbai, (H.S): The Securities and Exchange Board of India (SEBI) has ordered the attachment of absconding businessman Mehul Choksi's bank accounts, mutual funds, and shares in an effort to recover Rs 2.1 crore. The amount is related to a penalty imposed on him for violating insider trading rules in the shares of Gitanjali Gems.Choksi, who was the Chairman and Managing Director of Gitanjali Gems, is accused of sharing unpublished price-sensitive information (UPSI) with an associate. Rakesh Girdharlal Gajera.Based on that information, Gajera sold off his entire 5.75 per cent stake in the company in December 2017, allegedly to avoid losses before details of fraudulent activities involving the company became public.In January 2022, the SEBI fined Choksi Rs 1.5 crore and banned him from trading in the securities market for one year. However, Choksi did not pay the fine, prompting the SEBI to issue a demand notice on May 15,



2025. When he failed to respond or make the payment within the 15-day deadline, the market regulator proceeded with the attachment of his assets. The total dues now stand at Rs 2.1 crore, including Rs 60 lakh in interest. In its notice dated June 4, the SEBI directed all banks, depositories like CDSL and NSDL, and mutual fund houses to freeze Choksi's accounts. While no money can be withdrawn, credits are still allowed. The market regulator has also instructed banks to seize any

lockers in his name. The market regulator explained that the action was necessary because there is a strong possibility that Choksi may try to move or hide his assets, which could delay or prevent the recovery process." Whereas no amount has been paid by the defaulter and there is sufficient reason to believe that the defaulter may dispose of the amounts/proceeds in the bank accounts held with your bank and realisation of the amount due under the recovery certificate

would in consequence be delayed or obstructed," the market regulator stated. Choksi, who is also the maternal uncle of Nirav Modi, has been facing legal action in connection with the Punjab National Bank (PNB) fraud case involving over Rs 14,000 crore. Both Choksi and Modi fled India in early 2018 when the scam came to light. Choksi had been living in Antigua since 2018 but was arrested in Belgium in April this year after Indian authorities requested his extradition.

Sandeep Reddy Vanga also addressed the situation publicly. Without naming Deepika directly, he shared a post on X (formerly Twitter), saying, "When I narrate a story to an actor, I place 100% faith. There is an unsaid NDA (NonDisclosure Agreement) between us. But by doing this, You've 'DISCLOSED' the person that you are...Putting down a Younger actor and ousting my story? The film starts off on a funny note, helped along by Shreyas Talpade's presence. But it lacks the energy you'd expect for the kind of boisterous ride you've signed up for- until Akshay walks in, Ace Ventura style. His comic timing immediately lifts the film, but I can't say the same for the other characters. Team India Departs for England; Gill to Lead in Five-Test Series

Mumbai, (HS): The Indian cricket team left for England from Mumbai Airport on Friday for a five-match Test series, which is part of the 2025-27 ICC World Test Championship cycle. The series will be held from June to August 2025, with matches scheduled at Headingley in Leeds, Edgbaston in Birmingham, Lord's and The Oval in London, and Old Trafford in Manchester. This will be India's first bilateral Test series since both Rohit Sharma and Virat Kohli announced their retirement from Test cricket earlier this month. The team is undergoing a transition, with Shubman Gill taking over as captain and R Ashwin, Rohit Sharma, and Virat Kohli stepping away from the longest format. India has not won a Test series in England since 2007. To prepare, several Indian players had already arrived earlier to represent India A in warm-up matches against the England Lions. The rest of the touring party is scheduled to arrive in the UK on Friday.

Meanwhile, ahead of the Test series, India 'A' are currently

playing a three-match unofficial Test series against the England Lions. The first match ended in a draw, while the second unofficial Test is set to begin on Friday, June 6, at the County Ground in Northampton. On Thursday, England announced their squad for the opening Test at Headingley. The English side has seen several changes since their 4-1 Test series defeat in India last year. Veteran pacer James Anderson has retired, and players like Jonny Bairstow, Ben Foakes, and Ollie Robinson have been dropped.
