### Govt to ban sale of non-veg food, liquor near Puri temple



Bhubaneswar, (DMC): To elevate Puri's status as a major pilgrim destination, Odisha Law Minister Prithiviraj Harichandan on Sunday announced a complete ban on sale of liquor within a 2km radius of Shree Jagannath Temple. "There will be no liquor shops or bars within this area," he told reporters.

The Minister further stated

that sale of all non-vegetarian food items will also be prohibited along the Bada Danda, the main road leading to the 12th-century shrine. # NDA to form govt in TN, says Shah



New Delhi, (HS): Union Home Minister Amit Shah on Sunday asserted that the NDA would form government in Tamil Nadu and targeted the DMK government by firing fresh "corruption" salvos, including the Rs 4,600 crore sand mining scam. Speaking at a Bharatiya Janata Party Karyakarta Sammelan in Madurai, calling it the "city of Parivartan", Shah rallied BJP volunteers towards dislodging the DMK from power.

Chief Minister M K Stalin claimed that Shah cannot defeat the DMK and he is correct in a sense, he said, adding, "It is not Shah who will defeat the DMK, it is the people of Tamil Nadu who will bring about that change." Shah said that his extensive electoral experience gives him insight into public sentiment, and expressed firm belief that Tamil Nadu voters will oust the DMK government this time. Shah accused the DMK of harming the poor, women, and children. He said, "With the alleged ?39,775?crore TASMAC scam alone, we could have built at least two classrooms in every primary school in Tamil Nadu." He further referenced ongoing Enforcement Directorate searches tied to the ?1,000?crore liquor sale scam at TASMAC, Tamil Nadu's state run alcohol retailer. He lashed out at the DMK for "crossing all limits of corruption," claiming the ?4,600?crore sand mining scandal has deeply hurt vulnerable communities. Shah also targeted a central ?450?crore nutrition kit initiative, alleging it was awarded to a private contractor and mired in graft. He challenged Stalin to publicly account for the DMK's 2021 election promises, accusing the government of fulfilling less than 60% of its manifesto commitments. Shah added that

# State reports 7 new Covid cases

Bhubaneswar, (DMC): Odisha continues to witness a slow but steady resurgence of COVID-19 cases. According to the latest bulletin released by the Directorate of Public Health, seven new COVID-19 positive cases have been identified in Odisha, taking the total cumulative count to 45 on

Out of the total 45 confirmed cases, 33 are currently active, and health officials are closely monitoring their condition. Patients are being treated in isolation wards across designated hospitals, and no reports of severe illness have been issued so far. The state has recorded 12 recoveries to date. Public health authorities emphasized that while recovery numbers are growing, continued vigilance and timely medical intervention remain crucial. Dr. Nilakantha



Mishra, the Director of Public Health, provided these updates and reiterated the need for public cooperation. He urged citizens to follow basic COVID-appropriate

behavior such as mask usage, hand hygiene, and avoiding crowded spaces. Earlier, the Centre had issued an advisory asking states to ensure the

availability of oxygen supply, isolation beds, ventilators, and critical medicines to combat any potential escalation.

## Census 2027

In the recent past, the Centre has taken several steps to fill the gaps in data availability in the country. For instance, it has conducted two rounds of household consumption expenditure surveys for 2022-23 and 2023-24 which provide granular data on household spending patterns, and also allow for the estimation of poverty and inequality in the country. The government has also announced that the revamped sample design of the labour force surveys will allow for the generation of monthly estimates of key labour market indicators, which will aid policymaking. On Wednesday, it took another step, announcing the dates for the much delayed Census. This is a welcome development. The Census 2021 had been postponed due to the Covid-19 pandemic and has not been conducted since. This had meant that the last Census conducted provided estimates of India's population as of March 2011. Considering that timely and accurate data forms the basis of policy making, the continuing absence of the Census data has only hindered policymaking in the country.

The Census 2027 will be conducted in two phases. As per a report in this paper, the household listing phase is likely to begin by March-April 2026, while the enumeration exercise will take place over 21 days in February 2027. As per the Ministry of Home Affairs, "the reference date for population Census-2027 will be 00:00 hours of the first day of March, 2027". For the UT of Ladakh and the non-synchronous snow-bound areas of Jammu and Kashmir, Himachal Pradesh and Uttarakhand, the reference date will be 00.00 hours of the first day of October, 2026. Alongside, the exercise will also involve the enumeration of castes. This will be the first time since 1931 that the Census will gather detailed data on caste beyond Scheduled Castes and Scheduled Tribes. But, the announcement of the Census has also raised questions on the possibility of delimitation - the process of reconfiguring the Lok Sabha and state assembly seats - and the implementation of 33 per cent reservation for women in Parliament.In addition to providing population estimates, the Census also collects data on several household socio-economic indicators. This provides vital information on the changes in the country over the decades. Alongside, the Census data is also used in various surveys, and by both government agencies and private entities in the formulation of policies and strategies. It thus serves an invaluable purpose, aiding policy making in India.

You can't replace his grumpy, nearly incomprehensible charm, and it's why the Donald has been in more movies (200+) than any Disney character. So, let's celebrate on June 9 - National

And his accomplishments don't stop there. He co-hosted the Oscars in 1958 with a little help from Bob Hope, Jack Lemmon, and Jimmy Stewart. Oh, and they named an asteroid after him in 1995. If that doesn't convince you he's a force of nature, know that he has a star on the Hollywood Walk of Fame. We're not sure how he left webbed foot prints in front of the Chinese Theater, but we'll gladly roll with it. Well, what do you give to a duck that has it all? His own holiday! The world was introduced to Disney's beloved character Donald Duck on June 9, 1934. More or less starting off as a comic-book character, he remains the most published non-superhero ever. Such is his popularity that Donald Duck is a national hero in Finland! The character is a pop culture icon in Finland, much like Hello Kitty is in Japan. Donning his signature blue sailor suit with no pants, Donald Duck has appeared in more short films and feature films than any other Disney character. It is the diverse nature of his character that has allowed him to be featured in a plethora of roles, from an army officer and a teacher, to an uncle to three ducklings. Walt Disney conjured up the idea for Donald Duck to introduce an edgier character to balance out the goody-goody jolly Mickey Mouse. During the experimental phase of Donald's character creation, Disney read about Australian cricketer Donald Bradman, who had made headlines after getting

Another defining feature of Donald Duck is his voice. Clarence Nash, the original voice actor for Donald, created a distinct voice achieved by 'buccal speech,' a form of vocalization that utilizes the inner cheek to create sound instead of the larynx. Nash first discovered this while trying to mimic his pet goat. In the 1940s, Donald Duck overtook Mickey Mouse with over 128 independent short animations. This was truly the decade of the Donald, as he soared to popularity faster than any other Disney figure. During World War II, despite having to halt most of its production, Disney represented its stance by using Donald Duck in several American propaganda films. One of these animations earned Disney an Academy Award for 'Best Short Film.'

Other than his success in films, Donald also got his own comic in the '40s that branched into an entire series of independent Donald Duck comics, which are circulated and enjoyed by adults and children until today. The Donald in the comics - who lives in the town of Duckburg and is a loving uncle to nephews Huey, Dewey, and Louie - is much more mild-mannered, and has better-articulated speech and emotions than the original Donald.

# INDIA RISING: A Bird's Eye View

As far as India is concerned, it has remained as a prominent and influential example in the broader discussions about development economics since the early 1960s. As a large and rapidly developing country, the country became a central focus for researchers, policymakers and those seeking to understand the complexities of economic growth. The country faced numerous challenges, including poverty, inequality, and the need to modernize its agricultural sector. At the same time, India also possessed significant strengths, including its large workforce, natural resources, and a growing middle class.

The country has made significant progress over a span of three-quarters of a century since its independence. From a primarily agrarian economy (in which agriculture contributes 56% of the GDP), the world's largest democracy has transformed into a predominantly services sector economy. Now the services sector contributes to over 50% of the country's GDP, while the share of agriculture stands at less than 20%. The nation has also strengthened its physical and social infrastructure over the last 75 years; that has resulted in life expectancy increasing to 69.4 years from 32.15 years, and maternal and infant mortality rates improving to 1.036 from 20.7 and 308 from 1.339 respectively. The country's

types of investors; resource seekers, efficiency seekers and especially market seekers. For the market seekers, the scale and emerging consumption patterns that India could offer over the next quarter of the century are immense. With a large domestic consumption base, seventhhighest final consumption expenditure in the world, where private consumption and government consumption makes up over 70% of the GDP, and per capita income poised to grow at rapid rates; there are potential opportunities for market seekers. As per the World Economic Forum's report on the "Future of Consumption", India will add around 140 million middle-income and 21 million high-income households by 2030, where the upper middle-income and highincome households will drive 61% of the consumption in 2030. The median age of the Indian population is projected to be 31 in 2030 compared to 42 in China and 40 in the US, thereby making India a country with the largest working-age population in the world and by 2030, 90 million new households will be headed by millennial. This group is a demographic cohort (often called Generation Y) encompassing people born between 1981 and 1996. This generation is known for being tech-savvy, having grown up with the rise of the internet. They are often characterized as progressive, socially connected, and highly educated. These digital natives will have a vastly different approach to consumption and expectations regarding service delivery by both the Government and private sectors.

Both the Government of India (GOI) and India Inc. could aspire to achieve the economic and social outcomes for a developed India by 2047 by de-stressing the economic and social fault lines and reimagining the future of a



committed India. To harvest the gains from the economy, India will need to unlock the following key focus areas that demand both investments and policy interventions: Skills unlock, Education unlocks, Healthcare services unlock, Gender unlocks, Logistics unlock, Manufacturing unlocks and Regulatory unlock. Though, debates around India's demographic dividend are common but concentrated efforts are needed to upskill millions of our working-age youth nationwide to make them industry ready and future fit for the new sets of jobs that are being created owing to the disruption of existing business models. Skilling India is an urgent imperative and this goal may be achieved through close cooperation between private, public and civil society organizations. A "future-fit India requires significant financial resources from the Government. The tax-to-GDP ratio (which has inched up to around 12%) for India needs to be streamlined and in the years to come, progressive formalization and digitalization of the Indian economy are likely to continue to provide buoyancy in the tax revenues. The Government should have adequate resources to finance India's journey towards becoming a developed country.

The Government could also consider unlocking the logistics jam through infrastructure projects having cash flows and securitizing those future cash flows instead of funding such projects from its annual budget. This could help the Government undertake more infrastructure projects without negatively impacting the budget deficits, much to the satisfaction of sovereign ratings agencies that frown upon higher deficits.

The Indian economy, with its natural shock absorbers, has strong fundamentals built over 75 years and is highly resilient, as has been proved time and again. It owes its financial markets resilience to the growth of domestic institutional investors (DIIs) that stepped in when foreign institutional investors (FIIs) began exiting with the US Fed taper. It owes its tax revenue resilience to the increasing digitalization and formalization of the economy. India's energy resilience emanates from the growth of renewable and ethanol in the energy mix. And last but not the least; its demand resilience arises from the large consumer base responsible for making India's medium- and long-term economic outlook very strong. The consumer and retail market

could approach \$6 trillion and financial services will be the most active sector in the world, home to an estimated 300 billion transactions. There will be an estimated 600 million students in India in 2047 and some 1.5 billion Internet users (both representing the world's largest markets of these respective sectors). And in the auto industry it's estimated that 75% of new passenger vehicle sales will be electric. The country will be home to potentially half a billion electric vehicles. As India looks over the horizon to 2047 (its 100th year of independence) there appear to be several reasons for optimism. Various projections indicate that India is on course to become the second-largest global economy by 2047 in terms of purchasing power parity and its spending power is projected to grow from just 3% of a US consumer today to 24% by 2050. In the coming twenty-five years per capita income of the country could exceed \$26,000 (almost 13 times the current level). This is both possible and plausible in USD terms and not on purchasing power parity (PPP) terms.

Hope is not a strategy and potential is not the same as performance. There is much reason for strong optimism about the 2047 outlook for India today, but nothing is guaranteed. We cannot control the future, but business leaders and the government can build the muscles necessary and conditions to thrive whatever the future may bring. The state of the global economy in 2050 will partly depend on how quickly and effectively India implements the reforms and required structural changes. Given the right policies, the country could reach high-income status by 2047. Otherwise, it risks remaining a middle-income country plagued by low productivity and sluggish growth.

#### From Allies to Adversaries? **India-U.S. Ties Under Pressure**

India faces big hurdles in its rise as a global power. On 22 April 2025, a terror attack in Pahalgam, Jammu and Kashmir, killed 26 people, mostly tourists, revealing Pakistan's role in supporting militants. India fought back with OperationSindoor on 7 May, hitting nine terror bases in Pakistan and its controlled Kashmir, showing its strength. But trouble grows as U.S.-India ties weaken, with President Trump pushing Apple to cut back in India. Conversely, Pakistan's 26 April deal with World Liberty Financial (WLF), a crypto firm tied to Trump's family, aims to make it a crypto hub, threatening India's digital lead and security.

Pakistan's crypto boom poses serious concerns for India. The rise of untraceable digital money—akin to Hamas's "Bitcoin shakers" tactic—could potentially fund terrorism, especially given Pakistan's weak financial regulations until 2022. Moreover, Indian traders trying to evade the 30% crypto tax might resort to using Pakistanbased platforms, increasing the risk of data leaks that could aid espionage or hostile actions. The growth of Pakistan's crypto sector might also divert investment away from India's digital economy and enable Pakistan to bypass global financial norms, thereby strengthening its covert operations. Additionally, Trump's involvement in the deal and his mediation offer following the Pahalgam incident suggest a possible U.S. tilt towards Pakistan, which could undermine India's global standing. Ties with the U.S. are souring indeed. India's buying of Russian oil and



choosing French jets over American ones have upset our relations. Despite India's \$118 young population. billion trade with the U.S. in How can common Indians 2023-24—marked by a \$32 billion surplus—there is a looming risk of economic retaliation or sanctions. Meanwhile, Indian H-1B visa holders, who make up a significant share of the U.S. tech workforce, are facing job losses, which could affect remittances back home. Conversely, India's push to internationalize the rupee through platforms like UPI is also facing headwinds, as Russian oil transactions continue to be settled in U.S. dollars. What is India doing?India is fighting back with its strength. The "Make in India" plan boosts defence production, with homegrown missiles and airdefence system successfully stopping Pakistani and Chinese drones in Operation Sindoor. Conversely, smart industrial hubs, like in Aurangabad, make setting up factories easier, improving business. Partnerships with Taiwan and Japan is building India's chip industry, reducing reliance on the U.S. Further, India's huge middle-class market Jai Hind! retains companies like Apple here, despite U.S. pressure. But India's

are currently lagging behind China, to make the most of its

contribute?Commoncitizens can actively participate in India's growth story by resolving to buy local goods, such as phones and clothes, in support of the "Make in India" drive. They can consider facilitating training or mentoring young people to build a skilled Indian workforce. They can continue using UPI for daily payments strengthening India's financial freedom. Conversely, to stop crypto risks, they can use only FIU-India-approved platforms like WazirX, report suspicious transactions to cybercrime.gov.in, and warn others about risky platforms, especially those tied to Pakistan. Pushing for strict crypto rules in public forums and checking RBI updates will protect India's money. With these simple steps, every Indian can help fight terrorism, stand up to the U.S. pressure, and block Pakistan's crypto plans, building a strong, resilient, and self-reliant India.

# New buildings for Lok Seva Bhawan, Assembly on cards

Bhubaneswar, (DMC): In a major push towards modernizing state infrastructure, the Odisha Government has announced ambitious plans to construct new buildings for Lok Seva Bhawan and the Odisha Legislative Assembly under a modern architectural framework.

The existing structures, which have long stood as administrative landmarks in the Capital City, are now under review for redesign and possible transformation, informed Public Works Department (PWD) Minister Prithviraj Harichandan on Sunday. Speaking to reporters, the Minister said, 'We are evaluating how to reshape the existing buildings of Lok Seva Bhawan and Vidhan Sabha to align with the evolving needs of governance and aesthetics. A fresh structural blueprint is under consideration." As part of the state's long-term infrastructure vision, a world-class Odisha Mandap-a massive multiconvention centre-will also be developed in Bhubaneswar. A suitable location for the Odisha Mandap has already been identified in Chandrasekharpur, a prominent and accessible locality in the city.

Designed to global standards, the Odisha Mandap will include a state-of-the-art boardroom and a main convention hall with a seating capacity of over 10,000 people. It aims to host large-scale summits, cultural programs, and international events, placing Odisha on the global map for mega gatherings and diplomacy." New projects will be undertaken by the Odisha government, including Odisha Mandap, which will be a world-class



convention centre. Land has been identified at Chandrasekharpur, and preliminary discussions have been made," said Harichandan. The Minister further informed that the Odisha Mandap will be a multi-mode conventional centre with a seating capacity for 10,000 people, along with hotel accommodation in one premises. A preliminary concept has been

developed, and we want to take it further. Similarly, a lot of projects are in concept stage, and if execution and construction take time, it will create problems. Hence, we are trying to adopt measures to minimise the cost of construction of buildings, which will boost the industry sector here in Odisha, said the Minister. Additionally, the Minister revealed plans to

construct disaster-resilient buildings across the state to enhance preparedness against natural calamities. All proposed buildings will be completed within a stipulated timeline, he assured. To optimize costs while ensuring durability, the government is exploring innovative construction technologies.

Discussions have already

been held with the Indian Buildings Congress (IBC) on adopting modern, cost-effective methods in public construction. Moreover, the government plans to provide specialized training to newly recruited engineers to ensure they are equipped with the skills needed for executing these advanced projects. These initiatives mark transformative step in Odisha's infrastructure journey, combining modern engineering with functional governance.

#### Bhubaneswar to get guest houses for all dists

In an effort to address the accommodation challenges encountered by the visitors in the Capital City, the Odisha government plans to offer dedicated guest houses in Bhubaneswar for each district across the state. As per sources, each facility, set to comprise 100 rooms, will cater to individuals visiting the capital for healthcare services, educational objectives, or to engage with government offices, thereby providing accommodation without financial strain.

With many individuals across various districts of the state travelling to Bhubaneswar seeking various services, the high cost of hotels and other lodging options often presents a significant hurdle. In a bid to alleviate this, designated guest house facilities will be introduced, allowing guests to conduct their activities conveniently. The initiative will see the creation of as many as 3,000 rooms for all 30 districts.

Each guest house will bear the name of its respective district, fostering a sense of belonging and regional representation."The State government is planning to construct guest houses for each district in Bhubaneswar so that the visitors of these districts will get an opportunity to stay at those guest houses when they come to the state capital for various works.

It has been proposed that each guest house will have 100 rooms and there will be a total of 3,000 rooms for 30 guest houses," said Revenue Minister Suresh Pujari."The fees for the visitors for staying at the guest houses will be decided later," he added.

## Rs 200 cr plan to transform iconic Nicco Park

Bhubaneswar (DMC): The iconic Nicco Park in Bhubaneswar is all set to transform into a world-class tourism destination as the Odisha government has drawn up an ambitious Rs 200 crore redevelopment plan. Sources said that Chief Minister Mohan Charan Majhi has also reviewed the redevelopment proposal. As per reports, the state government plans to revamp Nicco Park with modern facilities.

The upgraded park will have entertainment areas, an Ayurvedic garden, better lighting, cycling tracks, and food courts. The Bhubaneswar Development Authority (BDA) has been given the task of overseeing the entire redevelopment. Sources said that efforts are being made to end the current partnership between the public and private sectors, and



give full control of the park to the Bhubaneswar Development Authority (BDA) before the project starts. The BDA is now working on figuring out the shareholdings of all involved parties to decide on compensation and ownership details. It is worth mentioning that Nicco Park was developed in 1996 through a partnership between the Bhubaneswar Development

Authority (BDA), which held 49%, and the Nicco Group, which owned 51%. The construction started in 1997 on a 24-acre land near the state secretariat. However, the park was badly damaged during the 1999 super cyclone. While the Nicco Group took loans from IPICOL to repair it, the park never fully bounced back and continued to lose money. Over time, neglect led to poor

maintenance, and less visitor's footfall.Later in 2007, the BDA handed over the park's operations to a private company, Sun Tech City Private Limited. The park was renamed BDA City Centre, but problems continued. Pollution from Drain No. 10, illegal encroachments, and dirty water in the boating pond made the place unattractive.

Many of the amusement rides stopped working because of poor maintenance. Cyclone Fani in 2019 caused even more damage, leaving the park unused and in bad condition. A senior BDA official said that all private companies will be removed before the revamp. They are checking the documents to figure out each company's share, and talks are happening, especially with the Nicco Group, which will be the first to leave.

Bhubaneswar (DMC): Odisha Works Minister Prithiviraj Harichandan on Sunday announced that Bhubaneswar will have an underground metro system instead of the previously proposed elevated system. The minister stated that the state government is moving ahead with plans for a fully underground metro in Bhubaneswar."No new route has been decided yet for the metro project.

The Housing and Urban Development Department is responsible for preparing the route plan. Once it's ready, work on the underground metro will begin," the minister said while speaking to reporters. He also explained that the plan for an elevated metro has been canceled to protect the city's beauty. "An elevated metro would affect the look of Bhubaneswar. To keep the city's charm intact, we are

planning a fully underground metro," the minister added. The department, along with the Survey Department, will soon start the survey for the underground metro route. After the surveys are done, the government will make a final decision on approving the project. The Minister

highlighted the state's risk of cyclones and emphasized the need to build disaster-resistant buildings in different areas. He also mentioned that the government is closely overseeing the progress of all ongoing and future infrastructure projects to ensure they are completed on time.

# Odisha to set up semiconductor CoE to boost tech ecosystem

Bhubaneswar, (DMC): In a strategic move to emerge as a key player in India's growing semiconductor ecosystem, the Odisha government has proposed the establishment of a Centre of Excellence (CoE) in Semiconductors at the International Institute of Information Technology (IIIT), Bhubaneswar.

The proposed centre, to be backed by the State's Electronics and Information Technology (E&IT) Department, will focus on strengthening Odisha's capabilities in semiconductor research, development, manufacturing, and industryready skill development. The initiative aligns with the Odisha

government's broader vision of advancing its electronics manufacturing ecosystem, particularly following a surge in interest from domestic and global investors in the sector. The decision comes after Odisha Chief Minister Mohan Charan Majhi instructed the department to collaborate with IIIT Bhubaneswar for anchoring the proposed CoE.

The institute was selected based on its existing infrastructure, technical orientation, and academic strength, which make it well-suited to host such a high-impact initiative. The Centre of Excellence will serve as a hub for advanced training, hands-on



capacity building, and cuttingedge R&D in semiconductor technologies. It will also play a critical role in bridging the current talent gap by producing skilled professionals to meet the industry's growing demand. As part of the academic expansion, IIIT Bhubaneswar has been tasked with submitting a detailed proposal outlining a structured academic framework for the centre by June 30. The Odisha government has also advised the institute to introduce postgraduate diploma and certificate programmes in advanced semiconductor engineering,

starting from the 2026-27 academic year. The Centre of Excellence will complement Odisha's existing efforts under the Odisha Chip (O-Chip) initiative, aimed at supporting the fabless semiconductor ecosystem.

The state has already

The state has already introduced a Semiconductor Manufacturing and Fabless Policy and recently released operational guidelines for capital investment subsidies and project facilitation. With dedicated financial and administrative support, the state aims to create a robust ecosystem that not only attracts investment but also transforms Odisha into a training and innovation powerhouse in the semiconductor space.

#### 3 workers die due to electrocution in Balasore

incident in Balasore district, three workers lost their lives on Sunday allegedly after coming in contact with a live wire during an ongoing construction work at Gagandhuli village of Jhinkiria panchayat under Simulia police limits. The mishap occurred when the live wire snapped and fell during the plastering of a septic tank. According to sources, a fatal electrocution incident under Simulia police limits claimed the lives of three workers who were involved in plastering the septic tank when the live wire reportedly broke and fell on them, causing the three deaths. The victim persons were not professional electricians but daily-wage workers hired for the work. The three deceased have been identified as Babaji Majhi, Bapi Majhi, and Narahari Behera. One of the workers died on the spot due to the electric shock, while the other two were critically injured and later succumbed to their injuries in a hospital in Bhadrak.On being informed, local police reached the spot and initiated a probe into



the matter." A temporary electric connection was given to light the tank's interior, following which the workers were found to be unconscious. The two injured were rescued and taken to Bhadrak district headquarters hospital (DHH), where doctors declared them dead while undergoing treatment," some locals expressed. "We are yet to ascertain the exact cause of their death, whether the three died due to electrocution or suffocation. The actual reason can only be established after a post-mortem report comes in," said inspectorin-charge (IIC) Suchendra Mahalik.A case has been registered in this connection and a probe initiated, Mahalik added.Earlier on June 3, four sanitation workers had died allegedly due to asphyxiation while they were cleaning a septic tank in Nabarangpur district.

approaching from the Konark side will head to the Saradhabali Open Ground Parking via Baidas Nagar, Toshali Sands Chhaka, Grid Station Chhaka, Balighat Chhak, Sidhhamahaveer Chhak,

and Matiapada Chhak. After this parking zone is filled, vehicles will be redirected to Talabania Parking and ITI Parking via Grid Station Chhak and Shudan Chhak. The return route will remain the same.

## Tensions flare in Manipur as Meitei leader's arrest prompts curfew, internet ban

IMPHAL, (HS): A day after violent protests erupted in Manipur over the arrest of Kanan Singh, leader of Meitei outfit Arambai Tenggol, the situation remained tense on Sunday with the administration imposing prohibitory orders and suspending internet services in five Imphal valley districts, police

Four other members of the group were also picked up, reportedly for questioning. When security forces went to take Singh into custody on Saturday night, they faced resistance from Arambai Tenggol members. As a preventive measure, prohibitory orders have been clamped in Imphal West, Imphal East, Thoubal, Bishnupur and Kakching districts, while internet and mobile data services, including VSAT and VPN facilities, have been suspended in these valley areas.

No official reason has been given for the arrest. Without mentioning any name, the Central Bureau of Investigation (CBI) said it arrested an Arambai Tenggol member at the Imphal Airport on Sunday. "He was involved in various criminal activities related to Manipur violence in 2023. The information related to his arrest has been



given to his family members," the federal agency said in a statement. The statement further stated that the CBI is investigating Manipur violence cases as per the direction of the Supreme Court. The trial of the cases has been shifted to Guwahati in view of the law and order situation in Manipur."The said arrested member of Arambai Tenggol has been brought from Imphal to Guwahati, and he will be produced before the competent court for police remand. Investigation

is underway," the statement added. A delegation of MLAs from various parties met Governor Ajay Kumar Bhalla at the Raj Bhavan on Sunday.Later, the Raj Bhavan in a statement said that during a discussion, the MLAs apprised the Governor of the current law and order situation in the state and requested his intervention to help find an amicable solution. Protesters torched tyres and old furniture on roads in Kwakeithel and

Uripok, demanding the release of the Meitei leader. They clashed with security forces at different places in the state cap ital on Saturday night. A mob also set a bus on fire at Khurai Lamlong in Imphal East district. Security forces fired several rounds of tear gas shells to disperse the protesters in front of Kangla Gate, nearly 200 metres away from the Raj Bhavan here. Security has been strengthened along the roads leading to the Raj Bhavan with additional deployment of central forces. In view of the protests in the restive northeastern state, an order issued by the district magistrate of Imphal West stated that the "superintendent of police in Imphal West... has reported serious breach to peace, disturbance to public tranquillity, riot or affray in the area, and grave danger to human lives and properties due to unlawful activities of anti-social elements.'

The district administration banned the assembly of five or more people and the carrying of sticks, stones, firearms, or sharp weapons under sub-section 2 of Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS). Similar preventive measures were clamped in Thoubal and Kakching districts, the police said.

#### **Operation Sindoor: Pakistan** embarrassed yet again

New Delhi, (HS): Pakistan has been going around with a satellite images from March this year to showcase the so-called 'damage' it caused to the Indian Air Force (IAF) base at Adampur in Punjab during Operation Sindoor that took place on May 7-10.

Shehbaz Sharif and his publicity team were left red in the face yet again after geo-intelligence expert Damien Symon fact-checked the images that claimed to show a severely damaged IAF Su-30 MKI aircraft and clarified that it was actually a Mig-29 undergoing



maintenance in March. The dark patch that Pakistan tried to pass off as indication of damage to the aircraft, is nothing but soot near the engine test pad that is routine during such maintenance, Symon has said. Pakistan has been fuming after 11 of its air bases were hit by Indian missiles during Operation Sindoor. It has been making a concerted effort to spread misinformation regarding strikes on Indian military infrastructure ever since. Air Force Station Adampur is of particular interest to Pakistan for several reasons. This base - India's second largest - is barely 100 km from the International Border, played a key role during the 1965 War. It is now home to Mig-29 and Su-30 MKI squadrons and also has advanced radars and surveillance systems. Most importantly, the first S-400 missile defence battery was set up at Adampur in 2022. This missile defence battery, part of India's Sudarshan Chakra air defence system, intercepted Pakistani missiles aimed at Indian targets during Operation Sindoor. Earlier, Pakistan claimed that its missiles from a Chinesemade JF-17 fighter jet destroyed the Russian-made S-400 air defence system at Adampur. This claim was debunked when Prime Minister NarendraModi travelled to Adampur on May 13, barely three days after the conflict ended, waving at the jawans, with an MiG-29 jet and a very much intact S-400 system visible in the background. While at Adampur, PM Modi sent a strong message to Pakistan, asserting that India had just paused its offensive on terror camps and its military sites.

## **India witnesses sharp decline of poverty**



New Delhi, (HS): The extreme poverty rate in India has witnessed a sharp decline from 27.1% in 2011-12 to 5.3% in 2922-23. This is as per latest World Bank estimates. What this effectively means is that 269 million people rose above the international poverty line over the last 11 years. The report states that the number of people living in extreme poverty dropped from 344.47 million to 75.24 million, based on the \$3.00 per day poverty line (in 2021 PPP terms).

The five states of Uttar Pradesh, Maharashtra, Bihar, West Bengal, and Madhya Pradesh - had the highest number of poor in 2011-12. Together, they contributed to nearly two-thirds of the poverty reduction by 2022-23. The World further to 15.5 per cent in 2022-23.

Bank also reports that rural extreme poverty in India fell from 18.4 per cent to 2.8 per cent, while urban extreme poverty dropped from 10.7 per cent to 1.1 per cent over the same period. Using the earlier \$2.15 per day poverty line (based on 2017 prices), the extreme poverty rate fell from 16.2 per cent in 2011-12 to 2.3 per cent in 2022. In absolute numbers, the population living below this line decreased from 205.93 million to 33.66 million.

The World Bank data also progress multidimensional poverty. The Multidimensional Poverty Index (MPI) was at 53.8 per cent in 2005-06. It fell to 16.4 per cent in 2019-21 and

## NIA arrests 3 insurgents for deadly 2024 attack on security forces in strife-torn Manipur

**NEW DELHI, (HS):** The National Investigation Agency (NIA) has arrested three insurgents in a case related to a deadly attack on security forces that killed two police commandos and injured several others in ethnic violence-hit Manipur last year, officials said on Sunday.

The three men, along with their associates, planned, conspired and executed the attack on an Indian Reserve Battalion (IRB) post and security forces at Moreh in Tengnoupal district on January 17, 2024, they said. Among the arrested accused is

Thangminlen Mate, a resident of Tengnoupal district and member of the Kuki Inpi Tengnoupal (KIT) insurgent group, an official statement said. He played a key role in orchestrating and carrying out the attack, it said. "He was apprehended on May 19, 2025, from Silchar, Assam, and produced before the NIA court in Guwahati, which remanded him to custody until May 28. He is currently lodged in Guwahati Central Jail under judicial custody," the statement issued by the probe agency said. The other accused, Kamginthang Gangte, a member of the Kuki National

Army (KNA), and Hentinthang Kipgen alias Thangneo Kipgen, associated with the village volunteers' group in Churachandpur district, were arrested from Imphal on June 6, the statement

"They were presented before the duty magistrate, who granted a transit remand until June 9 for their transfer to the NIA special court in Guwahati. The duo was part of the team that executed the deadly attack," it added. More than 260 people have been killed and thousands rendered homeless in the violence between the Imphal valley-

based Meiteis and adjoining hills-based Kuki-Zo groups since May 2023. The Centre imposed President's Rule in Manipur on February 13 this year after Chief Minister N Biren Singh resigned. The violence started after a 'Tribal Solidarity March' was organised in the hill districts to protest against the Meitei community's demand for Scheduled Tribe status. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal valley. Tribal Nagas and Kukis constitute a little over 40 per cent and reside in the hill districts.

## Complaint against Karnataka CM filed

Bengaluru, (HS): The Karnataka government may have taken stern action after the deadly stampede outside Chinnaswamy Stadium on June 4, but many are still questioning the role of the Congress leadership in the hurriedlyorganised IPL victory celebrations for Royal Challengers Bengaluru (RCB). Having lifted the trophy around midnight on June 3 after beating Punjab Kings in the final at Ahmedabad, RCB returned to Bengaluru to a rapturous welcome the next afternoon. Tens of thousands lined up the streets to greet ViratKohli

and the other players, who were first felicitated at the VidhanaSoudha complex and then taken to Chinnaswamy Stadium. As the uncontrollable crowd desperately tried to get inside the stadium, which has a capacity of 35,000, a stampede ensued near one of the gates, leaving 11 young people dead and dozens injured

Even as the Opposition BJP intensified its attack on the Congress leadership in Karnataka over the deadly stampede, a formal complaint was submitted

ThaawarchandGehlot on Saturday against chief minister Siddaramaiah over alleged negligence. The Complainant Girish Kumar, a resident of Kottigepalya in Bengaluru, alleged that the CM had personally invited the public to participate in the celebrations of RCB's maiden IPL triumph after a wait of 28 vears. Questioning the state government's decision to host a grand reception for a private cricket franchise like RCB, the complainant claimed that IPL is a commercial venture driven by profit motives rather than national pride.

#### **Tourist Couple's Last** 12 Hours In Meghalaya Village

Guwahati/Shillong, (HS): The 12 hours that a couple from Madhya Pradesh's Indore spent at Nongriat village in Meghalaya's East Khasi Hills during their visit to the popular doubledecker living root bridge have now been accounted for, according to investigators who spoke with the locals and took their statements. Newly wed couple Raja Raghuvanshi and his wife Sonam visited some areas during their honeymoon in Meghalaya before they went missing on May 23. While Raja Raghuvanshi's body was found in a gorge on June 2, a search is still on for his wife. Teams from the police and even the National Disaster Response Force (NDRF) are searching for Sonam, whose family said they believe she must have been kidnapped and have not lost hope of finding her. The couple checked into a guesthouse in Meghalaya's capital Shillong on May 21. The next day they hired a scooty and rode to the popular tourist hotspot Sohra (Cherrapunji). After reaching Mawlakhiat village in East Khasi Hills, they kept the scooty at a parking spot run by the local

#### Philippines offers Indian nationals visa-free travel

New Delhi, (HS): The Philippines announced on Saturday that Indian nationals can now visit the country without a visa for tourism purposes. Beginning June 8, Indian passport holders can enter the Philippines without a visa for up to 14 days, reported Reuters. To qualify for visa-free entry, Indians must have a passport valid for at least six months beyond the date of arrival, confirmed hotel bookings, proof of sufficient funds for the duration of their stay, and a return or onward travel ticket.

The visa-free arrangement is aimed at boosting tourism arrivals from India, which rose 12% in 2024 to nearly 80,000, according to data from Filipino Department of Tourism. There is still enough scope for growth vis-à-vis the world's biggest market, as Indian arrivals to the Philippines remain a small portion of the more than 5 million people who travelled to the southeast Asian country last year. For travel-happy Indians, Philippines provides another exciting hassle-free, cost-effective destination. Thailand, Malaysia, Qatar, Kenya, Sri Lanka, Jamaica are among countries which already offer visa-free travel to Indian nationals. Air India recently announced launch of non-stop flights between Delhi and Manila, starting October 1, 2025. The airline will operate five weekly flights, offering Business, Premium Economy, and Economy cabins. Air India will be the only airline providing direct connectivity between India and the Philippines, further facilitating travel and strengthening ties between the two nations.

## Preparations in full swing for Indian Astronaut's blast off

Florida, (HS): Three days ahead Indian astronaut GpCaptShubhanshuShukla's scheduled departure to the International Space Station (ISS), the Dragon spacecraft was rolled out to the launch pad integrated atop the SpaceX reusable Falcon-9 rocket at the Kennedy Space Centre in Florida, USA, on Saturday.

The Ax-4 mission will be launched on Tuesday. GpCaptShukla will pilot the spacecraft to the ISS on a 14-day mission. There will be three other astronauts on board. The Indian Air Force (IAF) test pilot has been trained for the mission by SpaceX and Axiom Space. He will be responsible for supervising the launch and docking operations of the vehicle, which is completely autonomous and does not require human intervention. The launch has assumed greater significance after the ugly spat between US president Donald Trump and SpaceX chief Elon Musk. The two were the best of friends till recently.

Ahead of the launch, GpCapt urged India to pray for success of the mission."I carry not just technical equipment but the hopes and dreams of over a billion Indians. I will be conducting seven scientific experiments that could contribute significantly to our understanding of microgravity and pave the way for future space research. In many ways, I see myself as a bridge between Earth and space, and I'm proud to carry artefacts designed by the National Institute of Design, symbolising India's creativity and innovation," Shukla said during a media briefing. "Even stars are attainable, Jai Hind," he said.

She started her professional journey working with Professor TG Sitharam, former professor at IISc Bangalore and former director at IIT Guwahati. Professor TG Sitharam currently serves as Chairman of the All India Council for Technical Education. Madhavi, later, independently served as a rock engineering specialist to Northern Railways through Afcons Limited as a consultant where she focused on one of

the most critical aspects of the bridge ensuring slope stability and designing geotechnical safety systems for the foundations. Her role is quite instrumental as the bridge lies in the Lower Himalayan region. One of the most tectonically active regions, the Lower Himalaya is a geologically complex zone with the terrain consisting of steep, fractured rock slopes. The loose soil makes it prone to frequent seismic

The water has a high erosive force. The narrow valleys increase the risk of landslides and slope failure. Thus, constructing a structure of this scale, with a 359-metre-high steel arch, on such terrain required extensive geotechnical planning. Madhavi's work involved detailed analysis of slope conditions. It also involved designing stabilisation techniques like rock anchors, bolts, and retaining systems. It ensures the foundation could resist both gravity and environmental stress.

## Trump Vows To 'Crush Rioters' in Los Angeles: Governor & Mayor Can't Do Their Jobs

Los Angeles, (H.S): US President Donald Trump has vowed to "crush rioters" in Los Angeles following days of unrest sparked by federal immigration raids. However, California Governor Gavin Newsom has fiercely condemned the federal government's takeover of the California National Guard and the deployment of 2,000 troops to the city, calling it a political stunt designed to provoke violence."

If Governor Gavin Newscum, of California, and Mayor Karen Bass, of Los Angeles, can't do their jobs, which everyone knows they can't, then the Federal Government will step in and solve the problem, RIOTS & LOOTERS, the way it should be solved!!!" Trump wrote.The federal government has since moved to deploy 2,000 National Guard troops to Los Angeles and has effectively taken operational control of the California National Guard, a decision Governor Gavin Newsom called dangerous and politically motivated. In a



sharply worded response posted on X, Newsom said: "The federal government is taking over the California National Guard and deploying 2,000 soldiers in Los Angeles - not because there is a shortage of law enforcement, but because they want a spectacle. Don't give them one. Never use violence.

Speak out peacefully." Earlier, Newsom posted a warning that the move would only worsen tensions on the ground: "The federal government is moving to take over the California National Guard and

deploy 2,000 soldiers. That move is purposefully inflammatory and will only escalate tensions. LA authorities are able to access law enforcement assistance at a moment's notice. We are in close coordination with the city and county, and there is currently no unmet need.

The Guard has been admirably serving LA throughout recovery. This is the wrong mission and will erode public trust."He also criticised recent federal immigration operations, claiming they are being carried out recklessly:"As the federal

government conducts chaotic immigration sweeps across the country, the state is deploying additional CHP to maintain safety on Los Angeles highways to keep the peace. It's not their job to assist in federal immigration enforcement. The federal government is sowing chaos so they can have an excuse to escalate.

That is not the way any

civilised country behaves."The protests began in response to large-scale immigration raids targeting undocumented residents in several Los Angeles neighbourhoods. Civil rights groups and immigrant advocates have condemned the operations as racially charged and unnecessarily aggressive. Dozens of demonstrators have been arrested, and multiple reports of injuries have emerged after confrontations with federal agents. Local officials maintain that there is no shortage of law enforcement support in the city and that federal involvement is not only unnecessary but inflammatory.

#### Colombian Presidential Candidate Shot in Head at Rally, Teenager Arrested

Bogota, (H.S): Colombian senator and 2026 presidential candidate Miguel Uribe was shot during a campaign event in Bogota, authorities have confirmed. The 39-year-old senator, a prominent member of the conservative opposition Democratic Centre party, was reportedly shot in the back while addressing supporters at a public park in the Fontibon neighbourhood of the capital on Saturday.

According to local media reports, the incident occurred while Uribe was delivering a speech when "armed subjects shot him in the back."A video circulating on social media captures the moment gunshots rang out, interrupting his address. In other images, Uribe appears slumped against the hood of a white car, visibly wounded and smeared with blood, as people rush to support him. Authorities said at least one bullet struck the senator in the neck or head. He was immediately transported to a nearby hospital, where he



remains in serious condition. As of now, there has been no official update on his current medical status. Colombia's Defence Minister Pedro Sanchez announced that a 15-year-old boy has been arrested in connection with the shooting. Sanchez also indicated that investigations are ongoing to determine if others were involved in the attack.

The minister confirmed that he had visited the hospital where Uribe is being treated. The Colombian presidency strongly condemned the incident, releasing a statement that "categorically and forcefully" rejected the violent attack and called for a comprehensive investigation into the circumstances surrounding the shooting. Uribe is a well-known political figure in

prominent family with historical ties to the country's Liberal Party. His father was a businessman and union leader, while his mother, journalist Diana Turbay, was kidnapped in 1990 by an armed group under the control of notorious drug lord Pablo Escobar. She was tragically killed during a rescue operation.

His party, the Democratic

Centre, which former Colombian President Alvaro Uribe founded, described the attack as serious but refrained from releasing any additional information on the senator's condition.Leftist President Gustavo Petro expressed his sympathy toward Uribe's family in a message posted on X, writing, "I don't know how to ease your pain. It is the pain of a mother lost and of a homeland."Colombia has long been mired in violence fueled by conflicts involving leftist guerrillas, criminal factions descended from paramilitary groups and state forces.

#### Iran Blames 'Sabotage' For Unexplained Uranium Traces, Disputes UN Watchdog's



Tehran, (H.S): Iran has found new evidence suggesting "sabotage" was behind the presence of unexplained uranium traces at several of its sites, pushing back against a critical report from the UN's nuclear watchdog.

The statement from Iran's Atomic Energy Organization (AEOI) was a direct response to a recent International Atomic Energy Agency (IAEA) report, which concluded Tehran had failed to provide credible

explanations for the man-made uranium traces found at three undeclared locations, Xinhua news agency reported.In that report, IAEA Director General Rafael Grossi accused Iran of providing "less than satisfactory" cooperation.

In its rebuttal, the AEOI said its security authorities had "discovered more clues... confirming that acts of sabotage or hostile actions" were responsible for the nuclear contamination. The organisation

asserted it had made "utmost efforts" to identify the source of the material. Tehran also argued that the IAEA report itself contained no proof that its "peaceful" nuclear program had been diverted for military objectives. It added that there was "no credible evidence" that the outstanding issues carried any proliferation risk. According to the IAEA report, Iran had previously conducted undeclared nuclear activities at three sites that have been under investigation for an extended period.

The agency also reported a sharp increase in Iran's stockpile of uranium enriched to 60 per cent, a level that, while below weapons-grade, theoretically brings Iran closer to the capacity to develop a nuclear weapon. This dispute is unfolding as Iran and the United States are engaged in indirect talks, mediated by Oman, focused on the future of Tehran's nuclear program and the potential lifting of US sanctions.

### In Pakistan You Get Rewarded For Promoting Terrorism: Shashi Tharoor

Washington, (H.S): Congress leader Shashi Tharoor has sharply criticised Pakistan for its treatment of Dr. Shakil Afridi, the physician who helped the US locate and eliminate Al-Qaeda leader Osama bin Laden responding to a post by US Congressman Brad Sherman who urged a visiting Pakistan to press for Dr. Afridi's release. Taking to socila media platform X, Sherman wrote,"

a safe house near an army camp in a cantonment city!) but also arrested and punished the brave doctor who identified his location for the Americans. In Pakistan you are rewarded for promoting terrorism and persecuted for exposing terrorists!

"Dr Shakil Afridi is a Pakistani doctor who helped the US Central Intelligence Agency (CIA) in the hunt for al-Qaeda leader Osama Bin Laden. Afridi served as the senior health official of Khyber Pakhtunkhwa Province. In 2008,

he was abducted by Mangal Bagh, a bus driver turned commander of a Pakistani militant group, Lashkar-e-Islam. The Indian delegation in the US also paid homage to Mahatma Gandhi at his statue opposite the Indian Embassy in Washington, continuing a tradition observed in all the countries visited."

Once again, as in all the countries the delegation visited, we were able to pay homage to Mahatma Gandhi at his statue opposite the Embassy in

Washington DC," Tharoor posted.He further noted, "It is striking how many world capitals are adorned with statues or busts of the Mahatma, the 20th century's greatest apostle of peace, nonviolence, and human freedom."Earlier the delegation held a significant meeting with US Deputy Secretary of State Christopher Landau. The Indian Embassy in Washington shared the update on social media platform X, stating:

The Indian Delegation briefed him on the atrocities of the Pahalgam terror attack and Operation Sindoor," the embassy posted. Earlier on Thursday, the Delegation had an "excellent meeting" with United States Vice President J.D. Vance in Washington, briefing him about Operation Sindoor, terrorism faced by India and regional security.

## Russia Accuses Ukraine of Postponing Prisoner Swap

Moscow, (H.S): Russia on Saturday accused Ukraine of indefinitely delaying a planned exchange of prisoners and the handover of fallen soldiers' bodies. Russia has handed over the first list of 640 prisoners to Ukraine and begun transferring bodies of dead Ukrainian soldiers, but Ukrainian negotiators did not arrive at the exchange site, Russian Presidential Aide Vladimir Medinsky said in a telegram post.

He called on Ukraine to "strictly adhere to the schedule and all agreements reached, and to immediately begin the exchange." Kiev did not immediately respond to the accusation, Xinhua news agency reported. Earlier on June 2, Russia and Ukraine had agreed to another major prisoner exchange in their latest round of direct talks in Istanbul, head of the Russian Delegation Vladimir Medinsky said.Medinsky said that the deal will include an "all-



for-all" exchange of seriously ill and wounded prisoners, as well as soldiers under the age of 25. He noted that no fewer than 1,000 prisoners are expected to participate in the exchange from each side, calling the agreement a "humanitarian gesture."

Ukrainian President Volodymyr Zelensky also said that a prisoner exchange under a "500-for-500" formula would take place this weekend. The official also said Moscow would return Ukraine 6,000 bodies of fallen soldiers next week."We specifically proposed a ceasefire for 2 to 3 days along certain sections of the front line," he told at a briefing following the talks, adding that Russian military specialists would work with those from Ukraine.

so commanders can retrieve the bodies of fallen soldiers. During the talks, which lasted over an hour, the two sides solved several "practical problems," according to Medinsky. He said that Moscow and Kiev agreed to

set up permanent medical commissions that would regularly compile lists of seriously wounded soldiers and facilitate their exchange.He confirmed that Russia passed its two-part memorandum to the Ukrainian side, which outlines the steps towards lasting peace and a ceasefire.Medinsky said Ukraine handed Moscow a list of 339 children, who have been separated from their parents due to the ongoing conflict, noting that Moscow would carefully look into each one of these cases.

He said that Russia had recently returned 101 children and 22 children have returned from the Ukrainian side.Russian and Ukrainian delegations held their second round of direct talks in Istanbul on Monday, following their initial meeting earlier in May. The sides agreed on a major prisoner swap, and to exchange draft memorandums outlining potential terms for a future peace treaty during talks.

## Another Shocker From Pakistan: Sharif Govt Gives 500 Per Cent Salary Hike To NA Speaker, Senate Chairman



Islamabad, (H.S): The government led by Pakistan Prime Minister Shehbaz Sharif has approved a massive 500 per cent salary increase for the Speaker of the National Assembly and the Chairman of the Senate (Upper House), local media reported on Saturday. The move comes at a time when Pakistan's economy is crippled by unending political chaos and huge unrest in the provinces of Balochistan and Khyber Pakhtunkhwa, formerly known as the North West Frontier Province (NWFP)."

National Assembly Speaker Ayaz Sadiq and Senate Chairman Yousuf Raza Gillani will now receive a monthly salary of PKR 1.3 million. Previously, both high-ranking parliamentary officials were drawing a salary of PKR 205,000 per month," ARY News reported. The massive increase, the report mentioned citing a notification released by the Ministry of Parliamentary Affairs, will come into effect from January 1, 2025. Earlier, the Sharif government had approved a PKR 519,000 monthly salary increase for Members of the National Assembly (MNAs) and Senators. In March, the Sharif-led Pakistani government, which had initially made tall claims about launching austerity drives and cutting down on expenditures, had approved a staggering 188 per cent increase in the salaries of cabinet ministers, ministers of state and advisors.

The developments have been severely criticised by the citizens of the country who remain burdened with high taxations, job loss, inflation, high fuel cost, high electricity price, and a plethora of other problems. Pakistan's economy has for long been surviving on loans received from the International Monetary Fund (IMF) with Sharif advising people to tighten their expenditures while asserting that

it is only a recovery phase. However, the back-to-back hikes in salaries of ministers, advisors, MNAs, Senators and now the National Assembly Speaker and Chairman of the Senate, have raised a serious question about the government's intentions. Sharif, at the same time, continues to increase the number of his federal cabinet which stands at 51 members currently. The initial number of federal cabinet members stood at 21, which was increased to 43 later."

First, they claim about the need for austerity, belt-tightening and what not... Then they claim that they would not pack their cabinet with ministers and advisors and later do the opposite. Skinning us all with taxes, job losses, inflation and blatantly towering up the number of cabinet members plus giving them massive salary hikes is just not done," a local resident in Islamabad had told IANS a few weeks ago.

### Israel: It Killed Palestinian Mujahideen Brigades Chief in Gaza

Jerusalem, (H.S): The Israeli military said that its forces had killed at least two senior members of the Palestinian Mujahideen Movement in strikes in Gaza City, including a commander accused of involvement in the deadly October 7 attack on Israel.

The Israel Defense Forces (IDF) and the Shin Bet security agency said in a joint statement that As'ad Abu Sharaiya, head of the Mujahideen Brigades - the armed wing of the Palestinian Mujahideen Movement - was killed in a joint operation. They accused Abu Sharaiya of playing "a key role" in the Hamas-led assault in 2023 and being



"directly involved in the abduction, detention, and killing of Israeli hostages."In a separate strike, Mahmoud Muhammad Hamid Kuhail, another militant said to have participated in the

October 2023 assault, was also killed. There was no immediate comment from Palestinian militant groups on the deaths, Xinhua news agency reported. Separately, the IDF and the

Israel Security Agency (ISA) announced on Saturday they had recovered the body of a Thai national, Nattapong Pinta, 36, who was abducted alive by the Mujahideen Brigades during the October 7 attack. His body was recovered in a joint operation in Rafah, southern Gaza Strip, on Friday.

Meanwhile, Hamas' armed wing, the al-Qassam Brigades, claimed Israeli forces were besieging a site in Gaza where an Israeli hostage, identified by spokesperson Abu Obeida as Matan Zangauker, is believed to be held. Abu Obeida warned that "the enemy will not be able to recover him alive."

# Women Are Now Key Drivers of Progress in India: FM Nirmala Sitharaman

New Delhi. (H.S): Finance Minister Nirmala Sitharaman on Sunday highlighted that in the last 11 years, women have emerged as key drivers of progress in the country, with the Narendra Modi government launching various schemes to empower Nari Shakti.

Highlighting "11 years of Sashakt Nari", the Finance Minister said that under the PM Jan Dhan Yojna, the world's largest financial inclusion scheme, 55.7 per cent of accounts were held by women, which reflected their empowerment at the grassroots level. She further pointed out that women now account for 68 per cent of the MUDRA loan beneficiaries nationwide. These loans have enabled lakhs of women to become entrepreneurs and pursue their dreams independently. Apart from this, 74 per cent of



those getting benefits under the Start-Up India entrepreneurs scheme are also women. Besides, 73 per cent of houses under the PMAY (Gramin) scheme for the poor are owned by women, she said.

The Finance Minister also mentioned that 10 crore LPG connections have been given to poor women under the Ujjwala Yojana. These have come as a big boon for them, making their life easier with accompanying health

They have been freed from the harmful smoke of wood and other fuels, such as cow dung, that were used for cooking earlier. The Jan Dhan scheme has been a huge success in financial inclusion, as the average bank balance per account in March 2015 was Rs 1,065, which has now increased to Rs 4,352. Around 80 per cent of the accounts are active, she added. As many as 66.6 per cent of Jan Dhan accounts have been opened in rural and semi-urban areas, and 29.56 crore (55.7 per cent) belong to women account holders. These accounts are used on a large scale.

People are also depositing money in them. However, this scheme allows zero balance accounts, and only 8.4 per cent of the accounts have zero balance. When the Modi government first came to power about 10 years ago, it set a target of providing financial and banking services to every citizen. For this, zero balance bank accounts were opened in the banks for the poorest of the poor under 'Pradhanmantri Jan Dhan Yojana' launched on August 28, 2014.

#### Nifty, Bank Nifty's Technical Charts Signal Bullish Momentum Ahead

Mumbai, (H.S): Indian equity benchmarks Nifty and Bank Nifty closed the week on a positive note, showing signs of bullish momentum as both indices stayed above key support levels. The outlook for the coming sessions remains sideways to bullish, with analysts recommending a 'buy on dips' strategy, according to the latest weekly report by Choice Broking.

The Nifty index ended the week at 25,003.05, up by 1.02 per cent. On the weekly chart, a strong bullish candle has formed with small wicks, indicating that buyers are active at lower levels. The index managed to close above the crucial 25,000 mark, suggesting growing strength and a possible upside in the near term. According to Choice Broking, Nifty is currently trading above all major exponential moving averages - the 20-day, 50-

day, and 200-day - reflecting a strong uptrend. The Relative 56, Strength Index (RSI) is at 60.94, which further supports bullish sentiment. A sustained move above 25,100 could trigger fresh buying, with potential targets dips

The key support levels are marked at 25,000 and 24,800, where buyers are expected to emerge. On the other hand, call option data shows resistance around 25,100 and 25,300, aligning with technical resistance zones. Meanwhile, Bank Nifty posted an even stronger weekly gain, closing at 56,578.40, up by 1.49 per cent. The index is trading near record highs and has shown

25,700 in the coming weeks.

# Inflation Data, US Tariffs & Global Economic Factors To Drive Market Direction Next Week

Mumbai, (H.S): The coming week is expected to be pivotal for the Indian stock markets as key economic triggers line up, including domestic inflation data, updates on US tariffs, and global economic indicators. The government will release India's inflation data on June 12, a crucial factor that significantly influences overall economic sentiment and market behaviour.

In April, retail inflation stood at 3.16 per cent. Any deviation from expectations in the upcoming data could sway market trends. On the global front, any developments regarding US trade tariffs will also be closely watched, as they

have the potential to impact global trade flows and investor sentiment. Last week, the Indian stock markets saw a strong rebound after two weeks of declines. The Nifty gained 252 points or 1.02 per cent to close at 25,003.05, while the Sensex rose 737.98 points or 0.91 per cent to end at 82,188.99.

The rally was led by banking stocks, with the Nifty Bank index climbing over 1.5 per cent to close at 56,578.40, also touching a new all-time high of 56,695 during the week. Among sectoral indices, the Nifty Realty index surged 9.5 per cent between June 2 and 6, while the media and IT

sectors ended in the red.On the institutional side, foreign institutional investors (FIIs) remained net sellers, offloading equities worth Rs 3,565 crore during the week.In contrast, domestic institutional investors (DIIs) infused Rs 25,513 crore into the cash segment, reflecting strong domestic confidence.

Puneet Singhania, Director at Master Trust Group, noted that the Nifty has managed to close above the 25,000 level after two weeks of weakness and is now trading above both its 21-day and 55-day moving averages. According to him, the index has support near 24,700, while on the upside, 25,250 and 25,600 are key resistance levels to watch.

#### PNB, Bank Of India, UCO Bank Slash Lending Rates after RBI Repo Cut

Mumbai, (H.S): Several major banks, including Punjab National Bank (PNB), Bank of India and UCO Bank, have slashed their lending rates following the Reserve Bank of India's (RBI) recent decision to cut the reporate by 50 basis points.

The rate cut is part of the RBI's strategy to stimulate economic growth by making borrowing more affordable for both consumers and businesses. Punjab National Bank was among the first to pass on the benefit, lowering its repo-linked lending rate from 8.85 per cent to 8.35 per cent. However, the bank kept its base rate and marginal cost of lending rate (MCLR) unchanged. Bank of India followed with a similar reduction, cutting its repobased lending rate from 8.85 per



cent to 8.35 per cent, as per its stock exchange filing.UCO Bank took a different route, trimming its MCLR by 10 basis points across all loan tenures.

The changes, effective from June 10, will make various types of loans - including home and personal loans - slightly more affordable. The bank reduced its overnight MCLR from 8.25 per cent to 8.15 per cent, the onemonth MCLR from 8.45 per cent

to 8.35 per cent, and the three-month MCLR from 8.6 per cent to 8.5 per cent. The six-month and one-year MCLRs were lowered to 8.8 per cent and 9 per cent, respectively.

Bank of Baroda also announced a 50 basis point reduction in its repo-linked lending rates for select loan tenures, adding to the list of banks easing borrowing costs. These rate cuts come in response to the RBI's move, announced by the Monetary Policy Committee led by Governor Sanjay Malhotra, to lower the repo rate - a key policy rate at which the RBI lends money to commercial banks. The objective behind the rate cut is to energise the economy by encouraging spending and investment through cheaper loans

In addition to the repo rate cut, the RBI also reduced the Cash Reserve Ratio (CRR) by 100 basis points, from 4 per cent to 3 per cent. This reduction will be rolled out in four phases and is expected to inject Rs 2.5 lakh crore of liquidity into the banking system. The CRR is the portion of bank deposits that must be maintained with the RBI, and lowering it allows banks to lend more.

#### Will 500 Currency Notes Be Discontinued Next Year? Here's What Govt Said

New Delhi, (H.S): A viral YouTube video recently claimed that Rs 500 currency notes will stop being used from March next year. However, the Central government has dismissed these claims. In a post on X, the Press Information Bureau (PIB) clarified that the Reserve Bank of India (RBI) has made no such announcement, and Rs 500 notes will continue to be valid for transactions.

A video posted on the YouTube channel 'CAPITAL TV' has created confusion by claiming that Rs 500 notes will be discontinued by March 2026. Clearing the air, the Press Information Bureau (PIB) shared a fact-check post on X, saying: "A YouTube video on the YT Channel 'CAPITAL TV' (capitaltvind) falsely claims that the RBI will discontinue the circulation of Rs 500 notes by March 2026. RBI has made NO



such announcement. Rs 500 notes have NOT been discontinued and remain legal tender." The fact-check was issued after a YouTube video claimed that the government plans to phase out Rs 500 notes from March next year, similar to the withdrawal of Rs 2000 notes. The 12-minute video, which has already garnered over 5 lakh views is also being widely circulated on other social media platforms. However,

authorities have denied the claims made in the video and advised people to be cautious about such misleading content. "Don't fall for such misinformation. Always verify news from official sources before believing or sharing it," the PIB added in its post.

The Rs 500 notes currently in circulation were introduced after the 2016 demonetisation. These notes are stone grey in colour, measure 66mm by 150mm, and

feature the Red Fort as part of the 'Indian heritage site' theme. Like all Indian currency notes, the Rs 500 note displays its value in 17 languages, including English, Hindi, Bengali, Tamil, Telugu, and more. On November 8, 2016, Prime Minister Narendra Modi announced the demonetisation of the old Rs 500 notes to tackle corruption and curb the spread of fake currency.

Just two days later, new Rs 500 notes were introduced, along with a new Rs 2,000 note. However, in May 2023, the Rs 2,000 notes were withdrawn from circulation, although they still remain legal tender. The RBI has announced that the Rs 20 notes with the new governor's signature will remain the same in design as the current series. It also assured the public that all previously issued Rs 20 notes will continue to be valid and remain legal tender across the country.

#### Tata Steel looks to begin construction of EAF project in UK in July

UK, (H.S): Homegrown Tata Steel is expecting to start the construction of its low-carbon EAF-based steel making project in the UK from July 2025 and commence operations by 2027, top company officials said. The company has received necessary approvals for its USD 1.5 billion project at Port Talbot, Tata Steel CEO & MD T V Narendran, and ED & CFO Koushik Chatterjee said in the company's annual report for FY2024-25.

"We are now transitioning to decarbonised and state-of-the-art EAF-based steelmaking by FY2027-28, supported by 500 million pounds in the UK Government funding," the management said. They said that planning approval has been received for the EAF (electric arc furnace) project at Port Talbot and the construction is expected to commence in July 2025. The operations in the UK have been

servicing its customers from its and Netherlands operations. "We have exited from steelmaking through the end-oflife heavy end assets in Port Talbot, and moved to a downstream model using imported substrate from India, the Netherlands and other external sources," an official said. Speaking further on the UK plan, the officials said the structural transition is also accompanied by a significant focus on cost rationalisation as

the company plans to bring down its fixed costs further from 762 million pounds in FY2024-25 to 540 million pounds in the coming year. The reductions are based on optimising substrate costs, modernising IT infrastructure, rationalising downstream operations and eliminating corporate overheads. As part of its efforts to reduce carbon emissions, the company is transitioning from the blast furnace route to the low-emission electric arc furnace process, which will utilise the locally available scrap.

# FSSAI directs food business operators not use '100 percent' claims in food labelling & promotions, issues advisory

New Delhi, (H.S): The Food Safety and Standards Authority of India (FSSAI) has raised a red flag over the increasing use of the phrase "100%" in food-related branding, warning that it may deceive consumers. In a recent advisory, the country's top food safety body instructed all Food Business Operators (FBOs) to avoid using the term on product packaging, labels, or advertisements. According to FSSAI, the phrase lacks a clear definition in existing guidelines and can easily be misinterpreted, leading to unrealistic consumer expectations.

The advisory, issued recently, noted a growing trend in the indiscriminate use of "100%" claims, prompting the regulator to act in the interest of transparent and honest food labelling. As per the Food Safety and Standards (Advertising and Claims) Regulations, 2018, the term "100%" is not defined or referenced in any manner under the FSS Act, 2006, or the Rules and Regulations made there under.

Furthermore, the Sub-regulation 10(7) of the aforementioned regulations strictly prohibits any advertisement or claim that undermines other manufacturers or influences consumer perception in a misleading manner and as per Sub-regulation 4(1) it shall be ensured that the Claims must be truthful, unambiguous, meaningful, not misleading and help consumers to comprehend the information provided.

The use of the term "100%"-whether in isolation or combined with other descriptors-is likely to create a false impression of absolute purity or superiority. This could mislead consumers into believing that other comparable products in the market are inferior or noncompliant with regulatory standards. In view of these concerns, all FBOs have been advised to not use the term "100%" on food product labels, packaging, and any form of promotional content.

New Delhi, (H.S): In a move aimed at promoting transparency and consumer trust in the digital marketplace, the Central Consumer Protection Authority (CCPA) has issued a comprehensive advisory to all ecommerce platforms, urging them

(CCPA) has issued a comprehensive advisory to all ecommerce platforms, urging them to actively identify and eliminate deceptive practices known as "dark patterns." Dark patterns refer to manipulative design tactics used in websites and apps to mislead users into making unintended choices-such as forced subscriptions, hidden charges, or tricking consumers into sharing more data than necessary.

These tactics undermine fair trade practices and often erode consumer confidence. To address this, the CCPA has instructed online shopping platforms to undertake a thorough self-audit within three months of receiving the advisory. The purpose of this audit is to detect and remove any such misleading interface designs or marketing strategies from their platforms. In addition, the regulatory body has encouraged platforms to issue voluntary selfdeclarations stating that they do not engage in dark patterns. These

declarations are expected to promote accountability and foster a more ethical digital commerce environment. Officials from the CCPA emphasized that these measures are crucial for building a transparent and trustworthy digital economy. By eliminating dark patterns, e-commerce players can not only comply with consumer rights norms but also ensure long-term customer loyalty.

The advisory marks another

step by the government to strengthen consumer protection laws in the era of booming online commerce. Further monitoring and action may follow based on the response and compliance from the industry. CCPA has also issued notices to e-commerce platforms in some cases that have been found violating the Guidelines for Prevention and Regulation of Dark Patterns. All e-commerce platforms are therefore, advised to refrain from deploying deceptive design interfaces that mislead consumers or manipulate their decisionmaking. The Authority has been keeping a close watch on the violation of the Guidelines issued



for Prevention and Regulation of Dark Patterns. Instances of Dark Patterns have been noticed on E-Commerce platforms. The Department of Consumers Affairs, Government of India constituted a Joint Working Group (JWG) comprises of representatives from concerned Ministries, regulators, Voluntary Consumer Organisations and NLUs. The mandate of this JWG is examine and undertake measures to identify violations of Dark

Patterns on e-commerce platforms and share the information with the Department of Consumer Affairs on regular intervals. The JWG shall also suggest appropriate awareness programmes for creating awareness amongst the consumers. As part of the Government's broader strategy and ongoing efforts to strengthen consumer protection in the digital era and curb unfair practices in ecommerce and online services,

Department of Consumer Affairs, Government of India had notified the Guidelines for Prevention and Regulation of Dark Patterns in 2023 and specified 13 dark patterns, namely: False urgency, Basket Sneaking, Confirm shaming, forced action, Subscription trap, Interface Interference, Bait and switch, Drip Pricing, Disguised Advertisements and Nagging, Trick Wording, Saas Billing and Rogue Malwares.

# Rhea says she lost acting work after Sushant Singh Rajput death case

Rhea Chakraborty discussed the impact of Sushant Singh Rajput's death case on her and her brother Showik, including career setbacks.

Actor Rhea Chakraborty, who was accused of abetment to suicide following the death of her then-boyfriend Sushant Singh Rajput, has opened up about the lasting impact the case had on her and her brother, Showik Chakraborty. In an interview with CNBC TV18, Rhea shared how both their careers came to a halt and how they struggled to

rebuild their lives after the

Rhea and Showik were arrested by the Narcotics Control Bureau (NCB) in a drugs-related investigation linked to Sushant's death in 2020. Reflecting on that time, Rhea said, "When we went through the tragedy that we went through, we both lost our careers. I stopped getting any acting work, and Showik, who had scored 96 percentile in CAT and secured admission into a prestigious university, was arrested before he could begin. By

the time he came out, he had lost the first trimester-and with it, his MBA plans and future planning." She added that finding a job for Showik in the corporate world became next to impossible due to the media storm surrounding them. "Getting a job for Showik afterwards in any corporate setup was very difficult. No one wanted to hire someone who had so much media scandal around them. For a while, we weren't sure where our lives were going. Like, what's next? We had our healing processes.'

During that phase of uncertainty, the siblings decided to channel their energy into building something of their own. That's how Chapter 2 Drip, a clothing brand aimed at giving people a voice and helping them feel seen, was born.

# India win 6 gold on day 2 Taiwan Open athletics

New Delhi, (HS): The Indian contingent won as many as six gold medals, including double podium finishes in women's 800m final and long jump competition, on the second and final day of Taiwan Open international championship here on Sunday.

Three-time national champion Vithya Ramraj, Rohit Yadav, Pooja, Krishan Kumar and Annu Rani won the gold medal in their respective events in an impressive outing by the Indian contingent. Also winning gold was the team of Santosh T, Vishal TK, Dharamveer Chaudhary, and Manu TS, the quartet finishing on top of the podium in the men's 4x400m event with a championship record of 3:05.58s to sign off the country's



successful campaign on a positive note. Yashas Palaksha rallied to win silver in the men's 400m hurdles with a personal best timing of 42.22s, the result giving a big boost to his confidence after missing out on the 2025 Asian Championships. Vithya clocked

56.53s to strike gold in the

women's 400m hurdles event, her third best time of the year helping the athlete to gain some useful ranking points for the upcoming World Championships. The athlete from Tamil Nadu competes in 400 metres hurdles, 400 metres and 4×400 metres relay. Before this, she had

clocked 56.04s in the Federation Cup final and 56.46s in the Asian Championship final. Rohit could not breach the 75m mark in the men's javelin throw competition but a best throw of 74.42m was enough for him to claim gold in the event. Taipei's Huang Shih-Feng won silver with a throw of 74.04m, while his compatriot Cheng Chao-Tsun was third with an effort of 73.95m.

Pooja won the women's 800m final with a championship record time of 2:02.79s to edge past compatriot Twinkle Chaudhary, who clocked 2:06.96s to clinch silver. Krishan Kumar then came back from behind to win the top prize in the men's 800m final with a time of 1:48.46s, which is also a new championship record.

## Thug Life box office collection over 60 cr. on day 3



Mani Ratnam and Kamal Haasan's first film in 38 years, Thug Life, is not performing as expected. After lukewarm reviews and a sudden dip in collections on Friday, the film steadied itself on Saturday. As per Sacnilk, it has collected 62.50 crore worldwide in three days.

The trade website reports that Thug Life collected 30.40 crore net and 35.40 crore gross in India in three days. It made 26.70 crore overseas, taking its total

collection to 62.50 crore. The film opened to 15.5 crore in India and dipped on Saturday with a 7.15 crore collection. It showed slight improvement on Saturday and made 7.75 crore. Despite criticism, Shankar's Kamal-starrer Indian 2 collected 8.55 crore out of its 81.9 crore in Karnataka. Thug Life has been banned in the state following a language row in which Kamal refused to apologise. The film seems to be faring well overseas, too, and it remains to be seen how it does on Sunday.
