"Rao was questioned on Friday about the data in the retrieved hard disks, as deciphered by the forensic team," the official said. The questioning of Praneeth Rao comes two days after the grilling of former Special Intelligence Branch (SIB) chief T Prabhakar Rao, the prime accused in the case, that came to light in

Israel said - Continuous attacks on Iran for 40 hours 150 targets including gas refinery hit; Iran said - our air defense system is active

Tehran / Tel Aviv (Agency): Continuous Israeli attacks on Iran have been going on for the last 40 hours. Israel has claimed that it has hit more than 150 targets including Pars gas refinery in Iran. Iran's Bandar Abbas port was also attacked late on Saturday night. Iran claimed that the air defense system is active at this port.

So far 138 Iranians have been killed in the three-day war, while more than 350 are injured. These include 9 nuclear scientists and more than 20 Iranian commanders.

CBI arrests 2 for deceiving NEET aspirants by posing as middlemen

New Delhi (Agency), The CBI arrested two men from Maharashtra for allegedly deceiving NEET UG 2025 aspirants and their families by claiming they could manipulate scores, and charging ₹90 lakh per candidate, officials said on Saturday.

Sandeep Shah and Salim Patel, residents of Solapur and Navi Mumbai. respectively, allegedly hoodwinked candidates by posing as middlemen with access to non-existent officials of the National Testing Agency. The CBI is on the trail of a third suspect, who is absconding, understood to be the mastermind of the scam.

They allegedly demanded up to ₹90 lakh per candidate. later reducing the amount to ₹87.5 lakh during negotiations for ensuring ranks in the merit, the police said

New Delhi (Agency): Two days after an Air India plane crash in Ahmedabad claimed over 260 lives, Yoga guru Baba Ramdev on Saturday suspected a possible 'foreign conspiracy', alleging the involvement of a Turkish maintenance agency whose contract with Indian airports was terminated last month.

New Delhi (Agency): The DNA tests were being carried out as the bodies of victims from the Air India plane crash were charred beyond recognition or damaged upon impact.

Gujarat home minister Harsh Sanghvi on Saturday confirmed that 19 victims of the Air India flight AI171 crash in Ahmedabad on June 12 had been identified through DNA testing.

The DNA tests were being carried out as the bodies of victims from the plane crash were charred beyond recognition or damaged upon impact.

In a post on X Sanghvi said, "Update as of 9:00 PM- 19 DNA samples have been matched so far, confirming the identities of victims. State Forensic Science Laboratory (FSL) unit team and National Forensic Sciences University (NFSU) team are working through the night to match more DNA samples.3

During a press conference earlier in the day, Dr Rajnish Patel, professor of surgery at the government-run B J Medical College, stated that the mortal remains of one of the victims was handed over to their kin on Saturday. That the bodies of two more

victims would also be handed over by the end of the day. The bodies of eight victims, who were identified by their relatives and did not need DNA profiling, have already been handed over to their families by the hospital.

The B J Medical College's mess was heavily impacted by the Air India flight which crashed into the densely populated Meghaninagar area of Ahmedabad.

Patel assured the families of the victims that the civil hospital would contact the kin as soon as a DNA match was found, and urged them to not rush to the hospital.

The victims included 241 of the 242 passengers and crew members on board the London-bound flight. One passenger miraculously survived. Doctors on Saturday said around 270 bodies have been brought to the hospital from the air crash site so far.

As many as 230 teams were formed to coordinate with the families and the kin of 11 foreign nationals who died in the tragedy were also contacted.

The sole survivor, Vishwas Kumar Ramesh, is stable, recovering well and absolutely out of danger,

New Delhi (Agency): India's headline retail inflation rate may have fallen below 3 per cent for the first time in just over six years in May 2025, with food prices again expected to drive down the overall trajectory even though vegetables became somewhat more expensive last month compared to April 2025. Inflation based on the Consumer Price Index (CPI), data for which will be released by the statistics ministry at 1600 IST on Thursday, was already at a multi-year low of 3.16 per cent in April 2025.

In May 2025, while some vegetables became dearer potato and tomato prices rose 3 per cent and 10 per cent, respectively, from the previous month according to data from the Department of Consumer Affairs - prices of cereals and pulses cooled. The net effect, according to economists, was a decline in prices of essentials. Bank of Baroda's Essential Commodities Index, for instance, declined 0.6 per cent year-on-year last month - the first time the index has fallen since January 2019.

"We expect CPI in May 2025 to come in at 2.7 per cent," Dipanwita Mazumdar, an economist at Bank of Baroda, said. The last time CPI inflation came in below 3 per cent was way back in April 2019, when it stood at 2.99 per cent. Other economists see CPI inflation broadly around 3 per cent. While the headline inflation rate is seen falling for the seventh month in a row in May 2025, core inflation - which measures the year-on-year price change for non-food-nonfuel items in the CPI basket - is seen edging up to around 4.2 per cent. Core inflation, seen as an indicator of underlying demand pressures, has gradually risen since the middle of 2024, when it stood at 3.1 per cent. HDFC Bank says it has commenced legal action against Lilavati Trust over loan default issue



Mumbai (Agency): HDFC Bank on Wednesday said it "has commenced the process of taking legal action permissible under law to vindicate its position" over allegations of a loan default by Lilavati Kirtilal Mehta Medical Trust (LKMM), which runs a leading medical institution. "We are concerned about all our stakeholders and are on the verge of taking strong legal actions as per expert advice, against those who are initiating these baseless allegations with malafide and ulterior motives or involved in propagating the same," an HDFC Bank spokesperson said in a statement.

"Despite repeated public claims and legal accusations, Sashidhar Jagdishan or HDFC Bank has never produced a single official loan ledger or agreement in court regarding its supposed transaction with LKMM Trust. Even more concerning, various documents from the bank reflect widely inconsistent loan amounts for instance, Rs 4.8 crore was cited initially, Rs 450 crore in another filing, and now Rs 65.22 crore which are just three examples of many of the company in question," LKMM alleged in a statement, "The allegations and insinuations made by the trustees are devoid of any iota of truth whatsoever. Neither the bank nor its CEO have engaged in any activity that is illegal, unethical or improper," HDFC Bank spokesperson said. "We are fully compliant with the laws of the land and follow the highest standards of governance and ethics. The content, timing and manner of allegations demonstrate the devious objective of preventing the Bank from carrying out its legal mandate of recovery and enforcement," the bank spokesperson said.

The Trust had last week called for the suspension and prosecution of HDFC Bank MD and CEO Sashidhar Jagdishan, accusing him of involvement in a series of financial frauds concerning the Trust.

"Despite all the noise, not a single official loan ledger has been presented in court of LKMM trust or Prashant Mehta," said Prashant Mehta, Permanent Trustee of LKMM. 

EDITORIAL Mandate and Mayhem

The recent events unfolding in Los Angeles reflect a deeper fracture in America's national psyche ~ a divide between a democratically endorsed mandate for strict illegal immigration control and the lived realities of immigrantheavy cities. The violent protests that erupted in response to mass immigration raids underscore the complexity of balancing electoral promises with humane governance. It cannot be ignored that the American electorate, in giving President Donald Trump a second term, did so on a platform that placed sealing the southern border and deporting undocumented immigrants at its core. These issues resonated strongly in states far from the immigrant enclaves of California or New York. Many voters, concerned about security, jobs, and social order, chose the course with clear intent. To that extent, the administration is fulfill - ing its mandate by scaling up Immigration and Cust - oms Enforcement (ICE) operations to record levels, aiming for an ambitious 3,000 daily arrests. On the oth - er hand, the chaotic scenes in Los Angeles reveal the human cost and social volatility that such a strategy produces when applied bluntly in cities whose very identity is shaped by waves of immigration, including the undocumented. Los Angeles, a sanctuary city by policy and sentiment, was always going to resist these federal incursions.

The decision to deploy 4,700 troops ~ including Marines and National Guard ~ has only deepened the sense of siege felt by immigrant communities, legal and undocumented alike. ICE agents, many of whom were reportedly attacked during operations, are performing their lawful duty. Their task is to enforce immigration laws that were reaffirmed by the electoral process. They face not only physical risk but also the vilification that comes with being the face of an unpopular policy in certain regions. It is equally true, however, that among those targeted are individuals with no violent criminal background ~ workers, families, asylum seekers ~ people who have woven themselves into the social and economic fabric of the city. This clash was inevitable. A government determined to deliver on its promises confronts local governance determined to shield its vulnerable residents. Neither side can yield without betraying its principles or constituents. At its heart, the crisis is not merely about deportation numbers but about the unresolved debate over what America wants to be ~ a fortress against unregulated entry or a haven of opportunity with manageable borders. Without this national conversation, raids and protests will remain ritual responses to deeper uncertainties. For now, the federal government's firmness may reassure its political base, but the images from Los Angeles ~ of burning cars, angry crowds, and fearful families ~ risk alienating moderates and intensifying cultural divides. Both the law and compassion have their place. Only when they are reconciled can this cycle of action and reaction end. The coming weeks will test whether America can enforce its laws without breaking its soul.

Affordable childcare, flexible working arrangements, generous parental leave, and reduced education costs are no longer luxuries ~ they are survival strategies. Only by making family life compatible with modern economic realities can nations hope to reverse this slide. The fertility decline is not simply a problem of birth rates ~ it is a reflection of un resolved social and economic contradictions. If these are not addressed with courage and creativity, the true crisis will not be in falling numbers, but in the erosion of human hopes and aspirations for family itself.

Coercive measures were seldom applied during the Cold War period, because of liberal use of veto by the United States or the Soviet Union. Post-Cold War, till recently, USA was the only superpower left, so it rampaged unhindered through Iraq, erstwhile Yugoslavia, Afghanistan, Yemen, Libya, Syria ~ to mention only some of its misadventures. Former US President Barack Obama succinctly observed: "In the middle of the Cold War, the chances of reaching any consensus had been slim, which is why the UN had stood idle as Soviet tanks rolled into Hungary or US planes dropped napalm on the Vietnamese countryside.

Even after the Cold War, divisions within the Security Council continued to hamstring the UN's ability to tackle problems. Its member states lacked either the means or the collective will to reconstruct failing states like Somalia, or prevent an ethnic slaughter in places like Sri Lanka" (A Promised Land, 2020). In its early days the UN actively promoted decolonisation, hand holding the eighty colonies that gained independence in the aftermath of WWII. The UN, through its agencies like the

programmes and funds like UNDP and UNICEF actively supported the newly independent countries, helping them tide over food shortages, droughts, medical emergencies, etc.

All countries, developed and undeveloped, are immensely benefited by UN agencies like ILO, ICAO, UNESCO, WHO, UPU, IMF, World Bank etc. as also UN sponsorship of nuclear arms control treaties and envi-

ronmental initiatives. However, now with the Russian invasion of Ukraine in its fortieth month and the Israeli invasion of Gaza in its twentieth, the failure of the UN to stop hostilities in either case highlights its increasing irrelevance. The ongoing war in Ukraine began in February 2014 when Russia occupied and annexed Crimea from Ukraine and then occupied eastern Donbas region in 2018, followed by a fullblown invasion of Ukraine in February 2022. The Ukraine war has resulted in a refugee crisis for both Russia and Ukraine, as also a million dead and injured on the Russian side and 700,000 dead and injured on the Ukraine side ~ all for a gain of around 113,000 sq.km. of Ukrainian territory by Russia.

The Security Council has been unable to act ~ deadlocked by the veto power of Russia. True, the UN General Assembly has debated and condemned the Russian role in the war, but unlike the Security Council, its resolutions are not binding on member states. In the UN session called to mark the third anniversary of the Russian invasion of Ukraine, the US twice sided with Russia. Firstly, the US opposed a European-drafted resolution in demned Mos cow's actions and supported Ukraine's territorial integrity. Then, the US sponsored a resolution in the Security Council, which called for an end to the war but contained no criticism of Russia. The ongoing invasion of Gaza strip by Israel since October 2023, has resulted in an unprecedented tragedy; according to official figures of the Gaza Health Ministry, as of 4 June 2025, almost 57,000 people (55,223 Palestinians and



1,706 Israelis) have been killed. The dead include 180 journalists and media workers, 120 academics, and over 224 humanitarian aid workers, which include 179 employees of UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA).

Scholars have estimated that 80 percent of Palestinians killed were civilians. A study by the Office of the United Nations High Commissioner for Human Rights (UNOHCHR), which verified fatalities from three independent sources, found that seventy per cent of the Palestinians killed in residential buildings were women and children. The Gaza war has led to extreme famine conditions in Gaza Strip, resulting from Israeli airstrikes and the

Strip, which includes restrictions on humanitarian aid. More than two million Gazans ~ about 95 per cent of Gaza's population ~ have been displaced, and are categorized as facing acute or catastrophic food insecurity. There are currently no functioning hospitals in Gaza. After the end of the two month ceasefire with Hamas on 18 March, Israel resumed attacks on Gaza.

The dangerous impasse in the UN, is part of a larger problem of incompatibility of 20th century multilateralism and 21st century geopolitics, and quest of a global balance of power, between a West on the defensive, rampant authoritarian powers, and an emerging South, demanding its place at the high table. The world over the UN is perceived to have failed in its objectives ~ even in the US ~ which has strengthened its hegemony through the UN; a Disengaging Entirely from the United Nations Debacle (DEFUND) Act was introduced, in the US Congress in 2023. However, the failure is mostly of the Security Council, which is extrapolated to the entire UN. Four detainees have escaped from an immigration detention center in Newark, New Jersey, DHS says

NEW DELHI: Four detainees broke through a wall and escaped from a federal immigration detention center in Newark, New Jersey, amid reports of disorder breaking out there, according to a US senator and the Department of Homeland Security.

Sen. Andy Kim, a Democrat from New Jersey, spoke Friday outside the Delaney Hall detention center. He said he was told detainees managed to break through an interior wall that led to an exterior one and from there were able to escape to a parking lot. More "law enforcement partners" have been brought in to find the missing detainees, according to an emailed statement attributed to a senior DHS official whom the department did not identify. The statement also didn't specify which law enforcement agencies

are involved.

The development comes amid President Donald Trump's illegal crackdown on immigration and a day ahead of major protests against his policies planned across the country. DHS identified the escapees as two Colombian men who were arrested on burglary and other charges, and two Hondurans, Franklin Norberto Bautista-Reyes and Joel Enrique Sandoval-Lopez, who were arrested on aggravated assault and other charges. A court records search did not turn up

attorney information for them. Newark's mayor cited reports of a possible uprising and escape after disorder broke out at the facility Thursday night and protesters outside the center locked arms and pushed against barricades as vehicles passed

through gates. Much is still unclear about what unfolded there. GEO Group, the company that owns and operates the detention facility for the federal government, said in a statement that there's "no widespread unrest" at the facility.

Immigration and Customs Enforcement opened a 1,000-bed facility there this year under a 15year, \$1 billion contract as part of Trump's immigration crackdown. Photos and video from outside the facility Thursday showed protesters pushing against the gates as word spread that detainees inside were

upset about delayed meals. Amy Torres, executive director of New Jersey Alliance for Immigrant Justice, said some officers pepper sprayed, tackled and dragged protesters away from the facility. She said some

protesters had minor injuries. Mustafa Cetin, an attorney for a client who's been detained in

The Brazilian man had been detained in front of their New Jersey home in late May. He had crossed the U.S.-Mexico border and requested asylum in the early 2000s and was issued a deportation order in 2005.

Kimberly, a U.S. citizen, said they have been seeking a legal way for him to remain in the country since they married three years ago. They have a 1-yearold child. She said she feels powerless. "There's nothing really I can do. Government doesn't seem to be on our side. Police enforcement isn't on our side," she said. "They're not giving us answers. They're not even letting us know that something happened inside that facility." Kim, the senator, said he heard about problems related to food and an odor in the water. Kim added that it seems as if there will be "major movements" of detainees out of the facility soon. He said he was seeking "full confirmation" about that. DHS, which oversees ICE, didn't immediately respond to a message seeking comment.

CAIRO (Agency): Pro-Palestinian activists seeking to march to Gaza with the stated aim of breaking Israel's blockade on the territory were stopped Friday in both Libya and Egypt, organisers said.

"They are being held in the heat and not allowed to move," the statement said, adding that another "15 are being held at hotels".



The executive order, titled Advancing Artificial Intelligence Education for American Youth, signals that advancing AI literacy is now an official national priority. This raises a series of important questions: What exactly is AI literacy, who needs it, and how do you go about building it thoughtfully and responsibly? The implications of AI literacy, or lack thereof, are far-reaching.

They extend beyond national ambitions to remain a global leader in this technological revolution -- or even prepare an -- AIskilled workforce, as the executive order states. Without basic literacy, citizens and consumers are not well equipped to understand the algorithmic platforms and decisions that affect so many domains of their lives: government services, privacy, lending, health care, news recommendations and more.

And the lack of AI literacy risks ceding important aspects of society's future to a handful of multinational companies.

How, then, can institutions help people understand and use or resist AI as individuals, workers, parents, innovators, job seekers, students, employers and citizens? We are a policy scientist and two educational researchers who study AI literacy, and we explore these issues in our research. What AI literacy is and isn't At its foundation, AI literacy includes a mix of knowledge, skills and attitudes that are technical, social and ethical in nature. According to one prominent definition, AI

literacy refers to a set of competencies that enables individuals to critically evaluate AI technologies; communicate and

Vibe coding, or using AI to write software code, might be fun and important, but restricting the definition of literacy to the newest trend or the latest need of employers won't cover the bases in the long term. And while a single master definition may not be needed, or even desirable, too much variation makes it tricky to decide on organizational, educational or policy strategies. Who needs AI literacy? Everyone, including the employees and students using it, and the citizens grappling with its growing impacts.

Every sector and sphere of society is now involved with AI, even if this isn't always easy for people to see.

Exactly how much literacy everyone needs and how to get there is a much tougher question. Are a few quick HR training sessions enough, or do we need to embed AI across K-12 curricula and deliver university micro-credentials and hands-on workshops? There is much that researchers don't know, which leads to the need to measure AI literacy and the effectiveness of different training approaches.

Measuring AI literacy While there is a growing and bipartisan consensus that AI literacy matters, there's much less consensus on how to actually understand people's AI literacy levels.

Researchers have focused on different aspects, such as technical or ethical skills, or on different populations for example, business managers and students or even on subdomains like generative AI.

A recent review study identified more than a dozen questionnaires designed to measure AI literacy, the vast majority of which rely on self-reported responses to questions and statements such as -- I feel confident about using AI.

There's also a lack of testing to see whether these questionnaires work well for people from different cultural backgrounds.



Sensational **Suruchi Singh** nails third successive ISSF World Cup gold



MUNICH (Agency): The sensational Suruchi Singh dominated a quality field to win her third straight individual ISSF World Cup gold medal in a thrilling women's 10m air pistol final here on Friday, reaffirming her position as Indian shooting's latest golden girl.

The 19-year-old shot 241.9 in the eight-woman final to leave France's Paris Olympic silver medallist Jedrzejewski Camille (241.7) 0.2 behind in second place.

China's Yao Qianxuan (221.7) bagged the bronze medal. National champion Suruchi had earlier won the event in the year's first two World Cup stages in Buenos Aires and Lima as well. Buenos Aires was in fact her tournament debut and she has now won gold in all three of her first ISSF World Cup stages.

MCC outlaws 'bunny hop' boundary catches, new rule to come into effect this month

England.

LONDON(Agency): Boundary catches involving 'bunny hops', or multiple airborne touches outside the rope, have been deemed illegal by the Marylebone Cricket Club, with the new ruling set to be integrated

into ICC's playing conditions this month and the MCC's laws from October next vear

Spectacular catches like the ones pulled off by Michael Neser during BBL 2023 and Tom Banton, with Matt Renshaw's help in 2020, will not be considered legal once the updated rule comes into force. According to an

MCC note circulated to member boards by the ICC, while the existing law "led to some spectacular" fielding efforts, it also allowed "some unusual-looking catches that, to the majority of the cricketing public, feel unfair".

Describing Neser's catch for Brisbane Heat to dismiss Jordan Silk, the MCC said the fielder "bunny hopped" before completing the catch inside the boundary.

While the act complied with the law at the time, the note added it "felt like the fielder had - quite literally - gone too far". Both instances

triggered widespread debate. prompting the ICC and MCC to review Law 19.5.2, which was last updated in 2010. As part of its revision, the MCC clarified that any fielder making a second

boundary must land inside the field of play, or else a boundary will be awarded. "MCC has devised a new wording where the 'bunny hop' wholly beyond the boundary is removed, but these catches where the

fielder pushes the ball up from inside the boundary, steps outside and then dives back in to catch the ball, are permitted," the note said.



Bhopal (Agency): In Gwalior district's Dabra City police station, an incident of unnatural act by three people with a Dalit youth has come to light. The victim has lodged a complaint in the city police station in this regard. On this complaint, the police have registered a case and arrested two accused. One accused is still absconding. The victim has accused Kallu Zaheer alias Kallu Rappan and Aashiq Khan, Ashfaq Khan of the same locality.

The victim told the police that the accused took him to their house and beat him with a belt there. The accused took off the victim's clothes and did unnatural act with him and also made a video of it.

The city police station in-charge said that the accused kept exploiting the victim by threatening to make the video viral. The victim told this to his neighbor, after which both of them reached the police station. The police took immediate action on the complaint and arrested Kallu Rappan and Aashiq. The third accused Ashfaq Khan is absconding. A case has been registered against the three accused in the city police station under section 377. The absconding accused is being searched and will be arrested soon. The victim has told that all the three accused were drunk at the time of the incident. The accused were harassing him for several days. He also told his family about this incident, but due to not being able to tell openly, the family members could not understand anything.

The three accused called the victim to the house on some pretext and then started taking off his clothes. When the victim protested against the incident, the three accused beat him up fiercely. Then all three of them misbehaved with him one by one. After the incident, the accused also made a video of him and then beat him again with belts. The accused threatened that if he told anyone, they would make the video viral. This would ruin his reputation. The accused repeatedly called him by threatening to make the video viral and kept misbehaving with him. Troubled by the accused, the victim told his ordeal to the neighbor. Delhi (Agency): The continuous operations of the security forces have broken the back of the Naxalites. The remaining Naxal commanders are not able to contact each other. They fear that any attempt to contact can lead them to the hands of the security forces. This is because the security forces are continuously breaking the Naxalites' Chakravyuha through technical and human intelligence. An officer said that now we are running the operation keeping in mind all the possibilities of Naxalites hiding in the forests. Tunnels are being searched. There are such inputs that on the lines of the long tunnel caught in March, Naxalites have made more tunnels, where they can be hiding or there can be a stock of weapons. The officer said, Naxalites are suffering serious losses due to the operation and they are completely on the backfoot. Their biggest struggle is how to coordinate among themselves and execute the new strategy. There is complete confusion among the Naxal cadre about whether to hold peace talks or fight the security forces. - Only four

or five active members left in the Politburo It is known that in the last few years in the Naxal organization, 14 Naxalites of the Politburo have either been caught or killed. Due to this, now only four or five active members are left in the Politburo. Now Muppalla Lakshman Rao alias Ganapathy, Mallojula Venugopal alias Abhay, Thippiri Tirupati alias Devji and Misir Besra are left in the Politburo. There is no clear information about Ganapathy either. Among the other active commanders, the security forces are keeping a close watch on Hidma. The members of the Central Committee are also very few. Ten to twelve members of the Politburo and the Central Committee are said to be alive. Their physical activity is also very low now. The biggest helplessness of the Naxalites is that they have neither been able to prepare new leadership nor are new recruitments being done according to their strategy. The leadership structure has completely disintegrated. Officials say that the leadership structure of the Naxalites has now completely disintegrated.
