

Operation Sindoor was launched in the early hours of May 7 against several terror-infrastructure sites in Pakistan and Pakistan-occupied Kashmir (PoK) in retaliation for the Pahalgam attack, in which 26 people, mostly tourists, were killed. During a military press conference here on May 11, Director General of Naval Operations (DGNO) Vice Admiral A N Pramod had said the Indian Navy's carrier battle group, submarines and aviation assets were immediately deployed at sea with full combat readiness in the aftermath of the Pahalgam attack. The naval forces remained forward deployed in the northern Arabian sea in a "dissuasive and deterrent" posture, with full readiness to strike select targets at sea and on land, including Karachi, at a "time of our choosing", the DGNO had said. The vice admiral had addressed the press conference along with his counterparts from the Army and Air Force. Defence Minister Rajnath Singh said on Monday that Operation Sindoor achieved all its objectives and succeeded in "injecting fear" in the minds

police arrest alumnus, 2 others

Kolkata (UNI): A first-year student of a law college in south Kolkata was allegedly "gangraped" inside the institution by an alumnus and two senior students of the institution, a police officer said on Friday. All three accused were arrested and produced before a court which remanded them to police custody for four days. The process of the victim's submission of a confidential statement before a judicial magistrate was also under way, police said. Taking suo motu cognizance of the incident that occurred on the evening of June 25, the National Women's Commission asked the Kolkata Police to file a detailed action taken report within three days.

The incident at the South Calcutta Law Col-

lege triggered the horrific memories of the rape and murder of an intern inside the city's RG Kar Medical College in August last year which created a major political dust-up across the state.

The prime accused in the recent incident is a former student of the institute and, ironically, a practising criminal lawyer at the Alipore Police and Sessions Court, college sources said.

The two other accused are bona fide students of the college and senior to the victim, police

College authorities stated that the main accused was also engaged as a temporary nonteaching staff at the institution for a renewable contractual period of 45 days.

Student 'gang-raped' at Kolkata college; | CJI Gavai breaks down while reminiscing about his parents' struggle

Nagpur (Agency): In an emotional moment. Chief Justice of India Bhushan Ramkrishna Gavai on Friday candidly shared personal anecdotes, revealing a side rarely seen by the public as he recounted the struggles of his parents in raising him. With visible emotion in his eyes and voice choked, the Chief Justice shared how his father's aspirations shaped his own path. "I wanted to be an architect," he said, "but my father had different dreams for me. He always wanted me to become a lawyer, a dream he could not fulfil himself," the CJI

said. Gavai, who was sworn in as 52nd Chief Justice of India last month, was speaking at an event organised by the Nagpur district court bar association to honour his ascent to the highest judicial position in the country. However, it was his personal reflections that resonated most with the audience.

Gavai got emotional briefly while speaking about his parents and the influence they had on his life. "My father gave himself to the service of Ambedkar. He wanted to be an advocate himself.

"Some people walk around holding a copy of the Constitution, but their hearts say something else. Has the Congress ever apologised for the Emergency?" he asked.

Jaishankar and Delhi BJP president Virendra Sachdeva jointly inaugurated the session organised to mark the 50th anni-

versary of Emergency.

The event was organised by the legacy and impact of the Emergency. Recalling his own experience as a young man during the Emergency, Jaishankar said, "Freedom should never be taken lightly. That period saw night raids, arrests without explanation, suppression of speech, and a general climate of fear." He emphasised that it was the duty of those who witnessed that period to educate future generations about how the Constitution and democracy were subverted.

He pointed out that between 1975 and 1977, five constitutional Amendments and 48 Ordinances were pushed through, three of which had far-reaching

Family offices diversifying into global equities, private equity: Report



Mumbai (Agency): While 25 per cent of Indian family offices set up by business houses continue to prioritize wealth preservation, many are now actively diversifying beyond traditional assets into global equities, real estate, private equity, venture capital, and alternative investments, says a report on family offices Allocations are increasingly moving into global equities, real estate, private equity, venture capital, and other alternatives, says the EY-Julius Baer report. While preserving wealth remains foundational, families are actively diversifying beyond traditional assets.

With over 300 family offices now operating in India, up from just 45 in 2018, the ecosystem is becoming more structured, globally focused, and purpose-driven, it said. Family offices are going global as ultra-high-net-worth individuals (UHNIs) expand across borders, with Liberalised Remittance Scheme (LRS) remittances rising from \$18.8 billion in 2019–20 to \$31.7 billion in 2023–24. A family office is a private wealth management advisory firm established to manage the financial, investment, and personal affairs of an UHNI family. It acts like a fullservice financial command centre for the family, offering customized solutions that go far beyond what traditional banks or wealth managers provide.

There is a growing focus on formalising governance and succession planning among family offices, it said. "While 59 per cent of families have put wills or constitutions in place, and 19 per cent have adopted structures like trusts or LLPs, a significant number still lack a comprehensive succession plan - highlighting the need for greater preparedness," it said. It said private markets are yet to see wider adoption among family offices. As many as 57 per cent of family offices allocate less than 10 per cent of their portfolios to private equity or venture capital, often citing limited access or as a cautious approach.

India seizes 39 containers with Pakistani-origin goods routed via UAE

New Delhi (Agency): The anti-smuggling arm of the Finance Ministry, the Directorate of Revenue Intelligence (DRI), has seized 39 containers carrying 1,115 metric tonnes of goods worth around Rs 9 crore, of Pakistani origin, that were being routed to India via the UAE in the backdrop of the Pahalgam terror attacks, the government said in a statement on Thursday.

April net FDI inflows at 35-month high, spend on foreign studies down 21%



New Delhi (Agency): India received net Foreign Direct Investment (FDI) of \$3.95 billion in April, the most in 35 months and more than double from a year ago, data released by the Reserve Bank of India (RBI) on Wednesday showed, while spending on foreign studies under the central bank's Liberalised Remittance Scheme (LRS) was down year-on-year for the ninth month in a row. The surge in foreign investments in the first month of the current fiscal came after March had seen net outflows of \$438 million, with six of the last nine months of 2024-25 seeing outflows on a net basis.

On a gross basis, FDI inflows in April stood at \$8.80 billion – the highest in 39 months – and up 23 per cent year-on-year. Net FDI is calculated after adjusting for investments that are repatriated by foreign companies and overseas investments made by Indian companies. Investments in manufacturing and business services made up nearly half the gross FDI inflow figure in April, RBI economists said in the central bank's monthly State of the Economy article, also published Wednesday.

The increase in April follows a particularly difficult year for India, with 2024-25 seeing net FDI inflows of just \$2.29 billion, down 77 per cent from \$10.13 billion in 2023-24. According to RBI economists, the increase in repatriation in 2024-25 "is a sign of a mature market where foreign investors can enter and exit smoothly".

On a gross basis, FDI inflows into India in 2024-25 were up 14 per cent at \$81.04 billion, which the RBI said was indicative of India remaining an attractive investment

Earlier this month on June 16, the World Bank had warned that FDI into developing countries had fallen to \$435 billion in 2023 – the lowest in nearly 20 years – due to rising trade and investment barriers. According to M. Ayhan Kose, the World Bank Group's Deputy Chief Economist, the sharp drop in FDI for developing countries "should sound alarm bells". Reversing the trend, Kose had said, was "essential for job creation, sustained growth, and achieving broader development goals".

To be sure, foreign investors continued to repatriate money in April, although the number more than halved from a year ago to \$1.67 billion, the RBI data showed. Even compared to March, the figure was down 36 per cent.

New Delhi (Agency): When Qatar announced a sudden closure of its airspace Monday evening, shortly before Iran launched a volley of missiles at the US military base—Al Udeid Air Base in Qatar—over 90 Qatar Airways flights with more than 20,000 passengers were on their way to its hub Doha, and had to be diverted to airports in various countries, including 15 to India, the airline's chief executive Badr Mohammed Al Meer said in a letter to passengers,

across Saudi Arabia, 18 into Turkey, 15 into India, 13 into Oman, and 5 into the United Emirates. The remaining aircraft were rerouted to major hubs including London, Barcelona, and others across Europe, Asia, and the Middle East," wrote Al Meer, terming the Qatari airspace closure as "unexpected and unprecedented".

"At around 18:00 local time on Monday, 23 June, an unexpected and unprecedented closure of Qatari airspace forced Qatar Airways to suspend global operations with immediate effect. Shortly after, airspace was also closed in Bahrain, the UAE, and Kuwait. Hamad International Airport (Doha), one of the world's busiest and most connected global hubs, was brought to a standstill, with almost 100 aircraft en route to Doha, several already on approach to our runways, and others lining up for departure," he

reopened shortly after midnight on Tuesday, the diverted aircraft began returning to Doha over the course of several hours. As a result, the number of passengers in transit at the Doha airport ballooned to over 22,000 by 5 am (Qatar time). "As an airline, our business continuity plans were activated, and our teams coordinated on hard resource planning, catering, ground transport, hotel accommodation, and realalignment time with passenger movements, immigration, customs, and every airport stakeholder. Over 4,600 customers were provided hotel accommodation, using

approximately 3,200 rooms across Doha. Many of these passengers received onward boarding passes for their rescheduled flights before even leaving the terminalallowing for a smoother reentry once our operations resumed," the Oatar Airways CEO said

Meanwhile at the Doha airport, Qatar Airways group teams got busy rebooking journeys, and even manually rebuilding complex travel itineraries—some involving other airlines, and even expired visas. The airline also decided to increase capacity to destinations with "high volumes of displaced passengers".

"Contact centre resources were scaled up to cope with global demand. We quickly established a flexible travel policy, allowing passengers who had not yet started their journeys to make changes or refund their bookings without fees. Across our global stations, ground handlers and partners moved quickly, supported by live coordination between our airport and airline operations control centres," Al Meer

On Tuesday, Qatar Airways operated a total of 390 flights integrity of its flight schedule. Around 20,000 passengers from its disrupted flights were cleared within 24 hours, with more than 11,000 resuming their journeys on the morning of June 24, while the remainder departed through the evening that day and the morning of June 25. According to Al Meer, after that, there were no passengers from diverted flights that were still stranded.

"Within just 18 hours, our scheduled operations had resumed. Wave by wave, the system began to stabilise. By the end of Tuesday, more than 58,000 passengers had departed Doha-moved not by chance, but by a coordinated effort from across the Qatar Airways Group to fulfil our responsibility during this unprecedented disruption," Al Meer said.

The airline's operations stabilised further on June 25 with the operation of 578 flights.

Uncertain Truce

When US President Donald Trump ordered strikes on Iran's nuclear facilities some days ago, the world braced for the worst Many feared the dawn of a wider West Asia war, dragging in the United States more deeply than at any time in recent years. Yet, in a surprising and delicate turn of events, the gamble that looked so dangerous is beginning to yield results ~ for now. After initial violations, a ceasefire appears to be taking shape between Iran and Israel, bringing a sudden pause to what Mr Trump called the "12 Day War." This could mark the beginning of de-escalation in a region that seemed poised for another cycle of violence. Whether this moment signals a genuine shift towards peace or merely a temporary cooling-off period remains uncertain. Iran's retaliation for the US airstrikes ~ missiles aimed at an American base in Qatar ~ seems designed more to save face than to escalate. The attack caused no casu-



alties or damage, and advance notice to Qatar suggests Tehran was careful not to provoke a harsher US response. On the other hand, Israel's decision to halt strikes after Iran's public ultimatum deadline quietly passed indicates that even its leadership is willing to step back from the brink, at least temporarily, not the least because a wider conflict may have drawn in other countries. Mr Trump, for his part, has declared the episode a strategic victory. By

combining overwhelming military force with swift diplomatic backchannels ~ reportedly involving Qatari mediators ~ the White House hopes to frame this as a demonstration of American resolve that forced both Iran and Israel towards restraint The President's social media posts project confidence, suggesting Iran's response was weak and predictable and that peace could now be pursued in earnest. Sceptics, however, will caution that this delicate outcome could unravel swiftly.

The ceasefire is informal, untested, and born of mutual exhaustion rather than trust. Both Iran and Israel remain deeply suspicious of one another's intentions. Any small provocation, miscommunication, or rogue action could reignite hostilities overnight. Furthermore, hardliners on both sides may yet seek to sabotage this fragile pause for their own political gain. For Mr Trump, the domestic implications are just as significant. If the ceasefire holds, he can claim to have delivered a high-risk foreign policy success ~ pressuring Iran without dragging the US into a costly new war. This would bolster his narrative as a leader who strikes hard but avoids prolonged entanglements. But if this momentary calm collapses, the backlash ~ both political and military ~ could be severe. In the end, this uneasy pause is not a peace deal. It is an improvised arrangement between bitter enemies, brokered under the shadow of overwhelming force. The days ahead will reveal whether it holds or slips into renewed conflict. For now, Mr Trump's bullying gamble stands as a precarious success. Whether it matures into a lasting diplomatic success ~ or simply delays the inevitable clash ~ remains the region's most urgent question.

Hand on the tap

The recent declaration by India that the Indus Waters Treaty (IWT) will "never be restored" in its original form marks a watershed moment in South Asia's fraught geopolitical landscape. While this decision reflects India's rightful outrage over decades of crossborder terrorism emanating from Pakistan, the path ahead demands not just resolve but strategic foresight. The IWT, signed in 1960, long served as a rare pillar of stability in otherwise hostile India-Pakistan relations. But its foundational assumption ~ that watersharing could be kept separate from war, terror, and conflict ~ has been shattered. The killing of 26 civilians in Kashmir by terrorists allegedly backed by Pakistan was the final blow. Prime Minister Narendra Modi's words ~ "water and blood cannot flow together" ~encapsulate the national mood. Yet simply abrogating



the treaty or unilaterally diverting river flows could invite complex international challenges. Pakistan has already signalled plans to take this matter to global fora, citing international con-

ventions on shared watercourses. While the IWT itself contains no clear provision for unilateral withdrawal, international legal opinion often tilts against disrupting lifeline resources to downstream nations, regardless of provocation. But this does not mean India must remain shackled by an out-dated arrangement that

ignores the grim reality of state-sponsored terror. A more effective and pragmatic approach lies in transforming the treaty itself into a tool of strategic deterrence. India should now actively seek the treaty's renegotiation ~ pressing for the inclusion of explicit clauses that allow for the temporary suspension or permanent abrogation of water sharing in response to any proven acts of cross-border terrorism. Such a move would not only align with India's sovereign right to defend itself but would also stand on firm diplomatic and moral ground. Terrorism is globally recognised as a grave threat to peace; if Pakistan can sponsor or tolerate terror attacks against India, then it cannot reasonably expect guaranteed water flows in perpetuity. Making this link official through treaty revision would also blunt Pakistan's legal case in international platforms, while signalling to other nations that India stands for a rulesbased, terror-free global order. Parallel to this diplomatic effort, India must accelerate its construction of dams, reservoirs, and canal networks to exercise actual control over the Indus system's waters. This infrastructure build-up will ensure that when the time comes ~ whether for negotiation or for enforcement ~ India possesses the real ability to divert or store waters as policy demands. By blending hard infrastructure with legal preparation and diplomatic clarity, India can turn the Indus Waters Treaty from a liability into an instrument of national security. This middle path serves both justice and strategy, sending Pakistan ~ and the world ~ a clear message: terror will come at a cost, and India will no longer underwrite its neighbour's water security at the expense of its own people's safety.

The same year the United States signed "Safe Third Country Agreements" with Guatemala, Honduras, and El Salvador, requiring migrants on their way to the US to apply for protections in those countries first. It effectively banned most migrants arriving at the US border from requesting asylum.

Fortress Europe too is witnessing a large influx of immigrants and refugees who too are affected by regimes of conditional inclusion and citizenship. Immigrant, a good citizen must contribute economically through hard work. Otherwise, they are "job stealers, benefit scroungers, girlfriend thieves, and criminals." Only when they "win an Olympic medal, treat you at your local hospital, or rescue a child from the side of a building do they become good."

Immigrants have to negotiate with "precarious legality and differential inclusion in their new homes. Europe's history of slavery and colonialism haunts it. Of course, there is occasional talk of the "new deal" and "partnership of equals." However, given the enormity of the crisis in Africa, from where the largest number of refugees seek shelter, such policies, even if implemented in right earnest, can at best scratch the surface. Noises have been made by some EU leaders that they need to confront their colonial past. French President Emmanuel Macron said on one occasion that France "must look history in the face" and recognise the share of suffering that it inflicted on the Rwandan people during the 1994 Rwandan genocide. Spanish Prime Minister Felipe Gonzalez has extolled the contribution of migrants to Spain's economy, social system and its wealth and development.

The rise of the farright in Europe is due to its vilification campaign against migrants. Immigrants are seen as threats to European peace, to European security, and also to European civilization. Climate migrants pose added problems. Water scarcity, forest fires, soil infertility, land degradation and floods, combined with other socio-economic factors like poverty and in-

equality will further aggravate the situation. Exporting borders that some developed countries have resorted to will come to naught when a sizable number of people flood international borders.

How Nato summit shows Europe and US no longer have a common enemy

NEW DELHI: Mark Rutte had an unenviable task at the Hague summit this week. The Nato secretary-general had to work with diverging American and European views of current security threats. After Rutte made extraordinary efforts at highly deferential, overt flattery of Donald Trump to secure crucial outcomes for the alliance, he seems to have succeeded for now. But what this meeting and the run-up has made increasingly clear is that the US and Europe no longer perceive themselves as having a single common enemy. Nato was established in 1949 as a defensive alliance against the acknowledged threat from the USSR. This defined the alliance through the cold war until the dissolution of the Soviet Union in 1991. Since Russia invaded Ukraine and annexed Crimea in 2014, Nato has focused on Moscow as the major threat to

international peace. But the mention of international law and increasingly bellicose China is demanding more attention from the US.

There are some symbolic moves that signal how things are changing. Every Nato summit declaration since the Russian invasion of Ukraine in 2022 has used the same form of words: "We adhere to international law and to the purposes and principles of the Charter of the United Nations and are committed to upholding the rules-based international order." The declaration published during the Hague summit on June 25 conspicuously does not mention either. Indeed, in a departure from recent declarations, the five paragraphs of the Hague summit declaration are brutally short and focused entirely on portraying the alliance solely in terms of military capability and economic investment to sustain that. No

In 2018, Trump suggested that this should be increased to 4 or 5% but this was dismissed as unreasonable. Now, in a decision which indicates increasing concern about both Russia as a threat and US support, Nato members (except for Spain) have agreed to increase spending to 5% of GDP on defence over the next 10

At the same time, they are increasingly feeling that Russia is more of a threat on their doorsteps. Iran's top diplomat says talks with US 'complicated' by American strike on nuclear sites

DUBAI (Agency): Iran's top diplomat said the possibility of new negotiations with the United States on his country's nuclear program has been "complicated" by the American attack on three of the sites, which he conceded caused "serious damage."

The US was one of the parties to the 2015 nuclear deal in which Iran agreed to limits on its uranium enrichment program in exchange for sanctions relief and other benefits.

That deal unraveled after US President Donald Trump pulled the US out unilaterally during his first term. Trump has suggested he is interested in new talks with Iran, and said that the two sides would meet next week.

In an interview on Iranian state television broadcast late Thursday, Foreign Minister Abbas Araghchi left open the possibility that his country would again enter talks on its nuclear program, but suggested it would not be anytime soon.

"No agreement has been made for resuming the negotiations," he said. "No time has been set, no promise has been made, and we haven't even talked about restarting the talks."

helped inspire 'Stockholm syndrome' theory dies: Report

Swedish criminal who



NEW DELHI: Clark Olofsson, who is one of the two criminals involved in the kidnapping and bank robbery during the year 1973 in Swedish capital, which gave rise to the expression "Stockholm syndrome," has died at the age of 78 following a lengthy illness, the BBC reports quoting his family.

During the six-day siege, Olofsson's hostages not only began to sympathise with him and his accomplice, but defended their actions while growing hostile to the police outside. The incident lends its name to a theorised psychological condition whereby kidnap victims develop affections for their captor.

According to the report, the notorious bank siege was instigated by one Jan-Erik Olsson. After seizing three women and a man hostage, he demanded Olofsson, who he had previously befriended in prison, be brought to the

bank from jail. Swedish authorities agreed to his demand, and Olofsson, a repeated offender who spent much of his life in prison, entered the bank, which was surrounded by police.

Years later, in an interview with the Aftonbladet newspaper, he claimed he was asked to work as an inside man to keep the captives safe in exchange for a reduced sentence, but accused officials of not honouring the agreement.

Olofsson persuaded one of the hostages, Kristin Enmark, to speak to the Swedish prime minister on the phone on behalf of the robbers.

She begged to be allowed to leave the bank in a getaway car with the kidnappers, telling him: "I fully trust Clark and the robber... They haven't done a thing to us."

She went on: "On the contrary, they have been very nice... Believe it or not but we've had a really nice time here." Over the course of several phone calls, Enmark (23) said she feared her captors would be harmed by police and repeatedly defended their actions.

The hostage situation ended after six days when police officers broke through the roof and used tear gas to

How Zohran Mamdani's 'joyous' ground game helped him topple Andrew **Cuomo in NYC's primary**



NEW YORK (Agency): On Tuesday night, shortly before polls closed in New York's Democratic mayoral primary, and less than an hour until the first signs of his seismic upset over Andrew Cuomo, Zohran Mamdani was in a Brooklyn park,

searching for a ride.

"He said he'd met some kids in the park who still hadn't voted, so he sent his personal driver to get them to a poll site before it closed," recalled Charlie Dulik, a campaign volunteer and tenant organizer, who said he approached Mamdani in the park to say hello.

Instead, Mamdani climbed into Dulik's 2007 Toyota Highlander, drawing cheers from passing pedestrians and cyclists as he made his last-minute pitch to voters while hanging from the car's sunroof, according to the volunteer. "He just kept saying, 'It's razor thin," Dulik added.

While the results are not yet finalized, Mamdani's likely primary victory has jolted the Democratic establishment, leaving many astonished that a 33-year-old democratic socialist outmaneuvered the better-funded and more experienced

Those close to the Mamdani campaign are less surprised. They credit a seemingly omnipresent candidate devoted to speaking directly to New Yorkers, along with a sprawling field operation that helped amplify his affordability-centered platform to new voters.

As Mamdani prepares for the November general election, they say they intend to return to that playbook once again.

"From the very beginning, he was very clear that our ground game was going to be the backbone of this entire campaign," said

Jason Halal, a lead field canvasser for Mamdani. "There was never any lack of urgency, and we got that from the top down."

Hong Kong opposition party League of Social Democrats to disband amid Beijing's crackdown

HONG KONG (Agency): Hong Kong's League of Social Democrats, one of the last remaining opposition parties after a five-year political crackdown by Beijing, said on Friday that it will disband. The party was founded in 2006 and was considered the radical faction in Hong Kong's prodemocracy camp. It was known for its boisterous street-level campaigning, often spearheaded by the now-jailed activist "Long Hair" Leung Kwok-hung.

"Next year marks the 20th anniversary of the League of Social Democrats. However, we will not survive to see that day and will announce our disbandment," the LSD said in a message to reporters, adding that more details will be announced Sunday.

It consistently called for greater democracy in Hong Kong and advocated for grassroots causes, criticising social and economic inequalities in a city with one of the world's largest wealth gaps. "When the system

Ecuador reveals how notorious gang leader 'Fito' hid in his hometown for 18 months after jailbreak

QUITO (Agency): Ever since Ecuador's most leader notorious gang vanished from his prison cell in January 2024, authorities have been searching the world, offering a \$1 million reward for information leading to the capture of Adolfo Macías, alias "Fito." It turned out the country's most wanted man was hiding out at a family member's mansion in his own Ecuadorian hometown. security forces recaptured the kingpin Wednesday at an underground bunker beneath a marble-walled house in the

port city of Manta, some 260 locate Macías and the hiding kilometers (161 miles) place where he spent his final southwest of the capital of weeks as a fugitive.

Authorities had issued an international arrest warrant for Macías, who was serving a 34-year prison sentence for

crime and murder in a Guayaquil prison before his shock escape.

Macías is also wanted by the United States on accusations of trafficking drugs and smuggling weapons.

A month ago, authorities closed in on the drug trafficker's family, arresting several of his relatives, seizing their assets and raiding their businesses.

Interior Minister John Reimberg described the crackdown on Macías' family as a "psychological operation" crucial to security

drug trafficking, organized forces' efforts to locate the notorious leader of Ecuador's "Los Choneros" gang. "It contributes to a person's conflict, their loss of control," Reimberg said in a press conference Thursday. But what put Ecuadorian intelligence on his trail was the unusual behavior of a municipal transit official in Manta, who stopped showing up to work several months ago. Surveilling the official led intelligence services to Macías' inner circle, according to Víctor Ordóñez, a national police commander.



Maa movie review: Kajol's well-intentioned

film keeps first half loose, second half muddled

Smashing patriarchy is a task that films need to keep taking up, and Kajol has the heft

But the 12-year-old's constant curiosity coupled with a tragic incident leads the mother and daughter to travel to their ancestral haveli in Chandrapur in the Bengal countryside, where time seems to have come to a stand-still. Joydev (Ronit Roy), the man holding things in place all these years, is at hand to welcome the duo in. As soon as they step in, of course, unease starts rising: what is the old family retainer (Dibyendu Bhattacharya), now unable to speak, hiding? Flashbacks tell us of the bloody doings which took place in the

involving the killing of newborn baby girls: now that Ambika is back, will their stories, and the ones who mysteriously go missing in the present, come out for airing?

The production design with its saturated colours make 'Maa' a vivid experience. The forest just behind the haveli, whose gnarled trees hide old bones, the faded faces of the women who have suffered at the hands of the 'daitya' (demon) called Raktbeej, the miasma of fear which the village wears like a shroud, all have presence. The high-decibel bustle of the Kali Puja with the dancers in traditional white-and-red, even if familiar, never fails to rouse.

This is a film which is clearly wellintentioned. Smashing patriarchy is a task that films need to keep taking up, and Kajol has the heft to get the job done. Amid Diljit Dosanjh-Sardaar Ji 3 controversy, Neeru Bajwa deletes film's promotional material from social media; producer declares 40% loss

he Diljit Dosanjh and Neeru Bajwa-starrer Sardaar Ji 3, has been embroiled in a controversy for featuring Pakistani actor Hania Aamir in a supporting role. Since the Pahalgam attack in April, Indian cine bodies have issued a blanket ban on Pakistani artistes working in India, and have banned the releases of their projects. Amid all this, the decision to release Sardaar Ji 3 has not gone down well with Indian cine bodies, and many

of Diljit's fans in India. The film's other leading star, Neeru Bajwa, who is one of the most popular actors in the Punjabi film industry, has now deleted all the promotional material of the film from her social media accounts. Diljit came under fire for promoting the film, and going ahead with its planned release in overseas markets.





Jabalpur (Agency): Jabalpur High Court in Madhya Pradesh has recently given such a punishment in a case, after knowing about which everyone is praising it. Actually, the court has given this unique punishment to the police station in-charge of Satna district for ignoring a rape case and not serving the notice. During this, the court has punished the police station in-charge to plant 1 thousand fruit plants of the same category like mango, guava, jamun, mahua from his own income in Chitrakoot between July 1 and August 31, 2025 and take care of it himself. This unique punishment of

planting one thousand fruit trees to

Satna district's Kotwali police station in-charge Ravindra Dwivedi has been given by the bench of Justice Vivek Agarwal and Justice Avnindra Kumar Singh of Jabalpur High Court. Along with this, the court has also asked the TI to submit a report with the photo and GPS location of the plants to the court. Along with this, the court has also directed the police station in-charge to take care of the plants for the next one year. The court has also asked the Satna Superintendent of Police to inspect the entire process and submit a report on the due date. The next hearing of the case will be held on September 16, about three months later.



The matter is such that in the year 2021, the district court sentenced the accused Ram Avtar Chaudhary in the case of rape of a minor. The accused had filed an appeal against this sentence in the Jabalpur High Court, on which the court issued a notice to the victim on 30 September 2024 and asked the police to serve the notice. But this notice was not served on time by the station in-charge. After which the court considered it as serious negligence and expressed displeasure and gave this unique punishment to the station incharge. During the hearing of the case, Satna police station incharge Ravindra Trivedi admitted his mistake in the High Court and

apologized and said that he was ready to pay the punishment given by the court as well as the fine of Rs 5,000 imposed by the Inspector General of Police.

According to the instructions

issued by Jabalpur High Court, the police station in-charge will have to plant 1000 fruit trees in Chitrakoot area. Also, these plants should also be purchased by the police station in-charge from his own income. Also, the responsibility of taking care of them will also be his own. Along with this, the court told the Satna SP that he will prepare a report about the planted trees, and submit an inspection report to the court along with an affidavit.

Delhi (Agency): The AATS team of South West District Police of Delhi has arrested a Bangladeshi national living illegally in India for the last 15 years on 24 June. The accused had kept the Aadhar card and driving license of one of his acquaintances with him to stay in India. He himself was a Bangladeshi citizen, but he had got the identity documents of India made. With the help of these documents, the accused was also working in different areas of Delhi. At present, the police has handed him over to FRRO to send him to Bangladesh. After which the process of deporting him has

DCP Amit Goyal said that the team of AATS in-charge Inspector Ram Kumar under the leadership of ACP Operation Vijay Kumar is working to collect data of foreign citizens living in the district. While collecting the data, the police team came to that Bangladeshi citizens are present in Vasant Kunj area. He claimed to be a citizen of West Bengal and also showed the police his Aadhaar card and driving license of India.
