

Govt targeting 2034 to hold 1st 'one nation, one election'

Vatika Times NEW DELHI: As the govt is expecting to hold the first countrywide simultaneous polls by 2034 after passage of the constitutional amendment bill for 'one nation, one election', all state assemblies to be elected after 2029 will be for a shorter duration to align their tenure with the 2034 general

elections. Head of the joint parliamentary committee (JPC) on the 'one nation, one election' bill (The Constitution (129th Amendment) 2024) Choudhary explained to TOI that after 2027, the assembly due to be elected in 2032 may have a tenure of only two years to ensure the synchronisation of the next elections in Uttar Pradesh-India's largest state electorally -with the Lok Sabha polls which may be held in 2034. The Constitution (129th



Amendment) 2024, and the Union **Territories** (Amendment Bill), 2024, have provisions for simultaneous elections to the Lok Sabha and state assemblies. constitution amendment bill, the President may issue a notification on the date of the first sitting of Lok Sabha after a general election, in all probability the one to be held in 2029, to spell when the next general elections will be due. The terms of all state assemblies constituted after this date will expire with the end of that Lok Sabha's fiveyear term. If Lok Sabha or a state assembly is regard. The President

dissolved earlier than its five-year term, an election for it will be held for a term equal to the remainder of the five-year term. This will synchronise its next election with the simultaneous elections cycle. Even in states. where polls will be due, elections for assemblies will be held only to align with the

Lok Sabha polls. However, the bill states that if the Election Commission is of the opinion that election to a state assembly cannot be held along with the rest of the country, it may make a recommendation to the President in this may issue an order to conduct an election for that assembly at a later

Guard at Ranthambore Fort temple loses life in tiger attack, 3rd kill in 2 months

JAIPUR: A 70-year-old guard of Jain temple inside Ranthambore Fort was killed in a tiger attack Monday, marking the third human kill in the state's most popular tiger reserve within two months. The death triggered an emergency response, with National Tiger Conservation Authority (NTCA) approving a pending proposal to urgently relocate the sub-adult cubs of tigress Arrowhead (T-84), allegedly behind a series of attacks on humans in Ranthambore, including the latest one.

The victim was identified as Radheshyam Mali from Sherpur village. Around 4.30am, he went out to relieve himself outside the temple premises when the tiger pounced on him and dragged him away, officials said.

Tensions escalated as Mali's kin and locals staged a protest outside the forest department at the fort later in the day, demanding Rs 50 lakh compensation, a govt job for a family member, and 10 bighas of land. Negotiations between the authorities and the protesters remained inconclusive till late evening.

Last month, Arrowhead's cub Kankati killed a seven-year-old boy. A week later, she killed a 40-year-old forest guard.

Apologise publicly in 24 hours or face strike: Goa doctors to health minister

Vatika Times PANAJI: In unprecedented show of strength, over 600 doctors, consultants, interns of Goa Medical College staged a protest on the campus on Monday demanding public apology from health minister Vishwajit Rane at the same casualty department abusing and threat-Rudresh Kuttikar and gave the minister a 24-

Vatika Times **NEW DELHI:** Cracking the whip, the National Medical Commission (NMC) has said that students who admission in MBBS course in 2024-25 but whose names are missing from its portal may not be eligible for registration to practise medicine.

The National Medical Commission - the apex body for regulating medical education in the country - issued the warning through a public notice after failing to receive the names and basic details of all students admitted to MBBS course in 2024-25 in medical colleges across

the country. India has approximately lakh MBBS seats. According to NMC, despite issuance of several circulars and public notices over the last eight months, details of only 1,15,250 students admitted for 2024-25 academic year have been received from medical colleges and uploaded on its portal. "Some of the colleges did not upload details of students admitted to MBBS course and some colleges uploaded incomplete data," it said. In the public notice, a

copy of which is with, NMC stated that only students whose details have been uploaded.

Trump's flip-flop to China's aggression—What's bringing **India and Australia closer**

The recent visit of Australian Deputy Prime Minister and Defence Minister Richard Marles to New Delhi has provided a significant boost to the burgeoning ties between India and Australia. This diplomatic outreach underscores Australia's unwavering support for India in its battle against terrorism in all its manifestations. Notably, Marles' visit comes shortly after the Albanese administration's re-election, marking an early and decisive engagement with India at a time of heightened global uncertainty. Reflecting on the trajectory of India-Australia relations, it is remarkable how far the partnership has come in a relatively short period. Just a decade ago, Australia was not a prominent feature in India's strategic considerations. However, shifting geopolitical dynamics have brought the two nations closer. The year 2025 marks the fifth anniversary of the elevation of the bilateral ties from a strategic partnership to a comprehensive strategic partnership, placing Australia among a select group of countries with which India maintains a 360-degree engagement framework. This enhanced partnership encompasses multiple overlapping mechanisms, including the 2+2 dialogue for high-level coordination on defence and foreign affairs, intergovernmental consultations, and a Free Trade Agreement. These initiatives reflect a shared commitment to deepening cooperation across various sectors, from security to trade and technology. At the heart of this evolving relationship lies a mutual recognition of the importance of defence and security collaboration. During Marles' visit, both nations welcomed the signing of the Australia-India Joint Research Project and agreed to intensify and diversify defence industry collaboration. The upcoming third India-Australia 2+2 Ministerial Dialogue later this year is expected to further advance defence science and technology cooperation, enhancing interoperability and common addressing security challenges. Beyond bilateral engagements, both countries are active participants in the Quadrilateral Security Dialogue (Quad), an informal grouping that includes the United States and Japan. The Quad aims to promote a free, open, and inclusive Indo-Pacific, serving as a counterbalance to China's growing influence. The inclusion of Australia in the Malabar naval exercises, alongside India, Japan, and the US, has further built interoperability and trust. The Quad stands as the most prominent example of the plurilateral cooperation linking the United States and India with two of their closest strategic partners. Yet, America's current relationship with India has lost the sheen it was expected to have. While Washington has not formally withdrawn from key security alliances like NATO or informal groupings such as the Quad, the Trump administration's flippy-floppy foreign policy toward its allies and partners has irked all. Trump's semi-betrayal of Europe on Ukraine has unsettled allies around the globe including Australia and New Zealand, both formal defence partners of the US. As the US-China rivalry develops, regional states are scrambling to protect their interests. There is little clarity on how Western powers might respond to a potential Chinese military takeover of Taiwan. A direct military confrontation between the US and China remains improbable, a reality acknowledged both overtly and implicitly by voices within and outside the US government. For Indo-Pacific nations caught in the geopolitical crossfire-reliant on China for trade and the US for security—investing in their own strategic resilience appears to be the most prudent path forward. Global military spending surged by 9.4 per cent in 2024—the steepest increase since the Cold War—driven by the return of attritional warfare and China's growing

Why is the government silent on the fake fertilizer manufacturers?

The way raids have started on fake fertilizer factories in Rajasthan and they are being sealed is commendable. They will get the harshest punishment. Actually, fake DAP fertiliz-



er and many other types of fertilizers were made in these factories and the surprising thing is that they were not made from animal bones, but from marble dust i.e. ground marble, which makes the fields barren when it falls on them. It is said that along with marble dust, such dangerous chemicals were being used in these fertilizers, which makes the land barren. It is worth understanding that the farmers who feed the people of the country and do not step back from their farming dharma even after getting low MSP and neither sell their food grains by adulterating them, are being cheated openly. In Rajasthan too, farmers were being cheated in these fertilizer factories, which was caught by the farmers themselves. In fact, three trailers were being unloaded on the road

Will Nepal Really See A Return Of The Monarchy?

A huge crowd headed towards Prime Minister KP Sharma Oli's Baluwatar residence from downtown in Kathmandu, chanting slogans in favour of the restoration of the Hindu monarchy, which was abolished in 2008. The crowd, led by former Home Minister Kamal Thapa, tried to break the police cordon.This was on June 1. The police responded to protesters with batons. As they continued to push, the security forces fired tear gas shells to prevent the crowd from entering the premier's residence. Subsequently, as the crowd dispersed, police arrested Thapa. Most strikingly, he was dragged to a police van

with his hands and legs tied, before being taken into custody. Hours later, Thapa and the other arrestees released.Clashes of this kind have become the norm in Nepal of late. Thapa, a leader of the Rastriya Prajatantra Party (RPP) Nepal, was the Home Minister during the 2006 popular uprising that flared across the country. Those protests ended the centuries-old constitutional monarchy. Back then, dismayed by the direct rule of the then King Gyanendra Shah, tens of thousands of people had taken to the streets for nearly a month demanding the abolishment of the centuries-old Hindu monarchy. The government, led by the King's men, had ordered the police to open fire at the protesters. More than two dozen demonstrators were killed, scores of them injured, and thousands of others were detained. Now, nearly two decades later, monarchists like Thapa have taken to the streets, followed by their supporters. The then rulers, who suppressed the people's movement under the guidance of King Gyanendra, are now the protesters. The roles have reversed in less than two decades. Yet, protests continued. The nationwide uprising forced the King to abandon the Royal Palace, ending a 239year-old tradition. And thus,

Nepal was declared a Republic. India, China, the US and other influential countries endorsed the political shift. The King's residence, known as Narayanhiti Royal Palace, was subsequently converted into a museum. This time, backed by the frustrated populace, pro-royal forces are hitting the streets, vowing to bring back the King to the Narayanhiti Royal Palace. To amplify their demands, smaller parties, academicians and wellwishers have joined the movement for the restoration of a constitutional monarchy. The royal family itself has been backing the protesters, hosting lunch for leaders and defending their campaign in press state.

Woman Dies in Fire Under **Suspicious Circumstances**

and a son Adarsh (12). Anil alleged that his sister had been mentally harassed for several years and was not allowed to communicate with her maternal family by her in-laws. He said he received a call on Monday morning informing him that Sarbjit Kaur had suffered burn injuries and had been admitted to the hospital. However, when he reached Adesh Medical College and Hospital in Shahabad, he found his sister's body already lying there. Her body was severely burnt.When he tried to laws, they allegedly evaded the questions and failed to provide clear answers. Anil further stated that Rakesh claimed the fire was caused by an inverter blast, but questioned why only his sister was burned while no one else in the house sustained even a scratch. He suspects that his sister was deliberately set on fire as part of a conspiracy. uation. Indian students must apply for a "D Study visa" to study in Ireland. This visa is for students studying in Ireland for longer than 90 days. All N1 two-wheelers, light commercial vehicles (LCVs), and light goods vehicles (LGVs) (weighing up to 3.5 tons) are now in violation of the new



The number of drivers booked for offenses has surpassed 27,000 as of May 2025. Police are cracking down on licence plates that don't follow the rules, such as those with unique typefaces, colors, religious symbols, or community or caste statements. In 2024, a total of 17,795 infractions were documented, with 3,171 notifications and 14,624 challans. May 2025 alone saw 27,202 instances, a significant increase from the previous year's total of 23,417 challans and 3,785 notifications. Criminals frequently use this loophole to avoid being caught and prosecuted, according to the police. As Karnataka exploits SC/ST cash for "guarantees," BJP, Congress object



Delhi: The Karnataka government's intention to use SCPTSP funding for the five guarantee projects announced before the 2023 assembly elections is expected to cause a stir. Congress' ally Dalit Sangharsh Samiti (DSS) will protest while BJP appeals to the judiciary. Senior government sources said "diversion" of SCPTSP funds is not new and has been done by past governments, but BJP's court case and DSS' "uprising" threat could hurt Congress in upcoming zilla and taluk panchayat elections. Last

week, CM Siddaramaiah said his government has allocated Rs 39,121 crore for SCPTSP, Rs 3,900 crore more than in the previous year due to a rise in budget size and a decision to allocate 24.1% of the budget to SC and ST communities. However, using Rs 14,283 crore of the budget for the five guarantee schemes has caused political unrest. BJP calls it "misappropriation." "BJP is contemplating approaching the court since the decision to re-route SCPTSP funds meant exclusively for the welfare of these

underprivileged communities is being misappropriated," said the MLC. "Redirecting funds by claiming they're being used on SC and ST communities implies that they're getting money while other communities get extra benefits. Giving with one hand and taking with the other." DSS is upset. DSS factions that supported Congress in the assembly and Lok Sabha polls withdrew their support Saturday, Congress is not working "wholeheartedly" for SC & ST populations.

Next round of India-Asean trade agreement review talks in November

NEW DELHI: The next round of talks for the ongoing review meeting of the India-Asean free trade agreement in goods will be held in November, an official statement said on Saturday. The third round of the negotiations was concluded on August 1 in Jakarta, Indonesia.

Eight sub-committees have been constituted under the India-Asean Free Trade Agreement Joint Committee for under taking negotiations on different areas related to the review of the pact.

"The next meeting of the AITIGA (Asean-India Trade in Goods Agreement) Joint Committee will be held in India from 19-22 November 2024," the Commerce Ministry said.In September 2022, both sides tasked the AITIGA Joint Committee to undertake the review to make the agreement more trade-facilitative and mutually beneficial.

During the third round of negotiations in Jakarta, Indonesia, all eight Sub- Sub-Committees dealing with national treatment and market access, rules of origin, standards, technical regulations, customs procedures and trade facilitation held substantive discussions. "The review of AITIGA, signed in 2009, will help create further opportunities for businesses on both sides to enhance the level of India-Asean trade," the ministry said. Asean is an important trade partner of India with about 11 per cent share in India's global trade.

India's exports to the 10-nation bloc Asean were USD 41.2 billion in 2023-24, while imports aggregated at USD 80 billion in the last fiscal.

Both sides are aiming to conclude the review in 2025. The review of the AITIGA was a long-standing demand of Indian businesses. India is asking for a review of the agreement to eliminate barriers and misuse of the trade pact.
