'Narrative based on falsehood': Sitharaman calls Mamata's 'mic off' claim 'unfortunate'

NEW DELHI: Finance Nirmala minister Sitharaman fended off West Bengal CM Mamata Banerjee's charge that her mic was muted during the Niti Aayog meeting that took place in the national capital on Saturday.

Rebuffing the TMC supremo's allegation that her "microphone was switched off after five minutes", the Union minister called the charge "completely false".

"CM Mamata Banerjee attended the Niti Aayog meeting. We all heard her. Every CM was given the allotted time and that was displayed on the screen which was present before every table...She said in the media that her mic was put off.

She also criticised the

In kharif season, water levels at 2 Pakistan key dams near 'dead levels

decrease in the flow volume of western rivers - Indus, Jhelum and Chenab - from India has left Pakistan discharging more water than what it's receiving to sustain its drinking water and irrigation needs. While this appears normal during the pre-monsoon season, the situation may turn grim in the coming weeks as regular desilting and flushing of dams by India in Jammu & Kashmir to increase its own storage capacity will further lessen the water flow to the other side.

The daily water situation report, released by Pakistan's Indus River System (İRSA), Authority shows that the country on Wednesday had to discharge 11,180 cusecs more water than the inflow.

Its collective outflow,



monitoring stations 1,43,600 cusecs on (Tarbela on Indus, the same day last Mangla on Jhelum, Marala on Chenab and Nowshera on Kabul river), stood at 2,52,791 cusecs compared to the inflow of 2.41.611 cusecs. More outflow than inflow will eventually lead to a further drop in water availability in two key provinces -Punjab and Sindh which depend on waters from the Indus system.

Wednesday, On Pakistan's Punjab province, where kharif farming has received begun, 1,14,600 cusecs of year - a decline of

Pakistan is still nearly a month away from getting monsoon rains, but water storage in its two key dams - Mangla on river Jhelum and Tarbela on Indus has already reached close to their respective 'dead levels' (there are no outlets to drain water from western rivers of the the reservoirs by gravity below the level).

RBI defers exchange-traded currency derivatives rules

MUMBAI: RBI has deferred the implementation of its rules on exchange-traded currency derivatives by a month, resulting in traders scrambling to square off their positions. RBI's circular, which was scheduled to come into effect on April 5, said that only traders with an underlying forex exposure can trade currency Exchange-traded currency derivatives, like futures contracts, help companies hedge against currency risk.For instance, an Indian exporter expecting payment in US dollars in three months.s can use currency futures to mitigate potential losses from adverse exchange rate movements. By entering a futures contract to sell US dollars at a predetermined rate, the exporter locks in a viable exchange rate.

The market for exchange-traded currency derivatives has been thriving for a decade because of positions taken by investors with a view on the currency. However, RBI said that its recent circular only reiterates its existing position. "The regulatory framework for exchange-traded currency derivatives remained consistent over the years, and there is no change in RBI's policy approach," it said. The circular, issued on Jan 5, retained most of the earlier regulations, including a requirement that trades over \$100 million would require proof of exposure. This requirement of proof for higher value trades was being interpreted by participants to mean that those who did not have any exposure could participate in lower value transactions. However, the Jan 5 circular carried a footnote requiring exchanges to ask clients to trade only against exposures.

Canada busts drug racket financing anti-India activities

NEW DELHI: Project Pelican, a major investigation conducted by Peel Regional Police, has busted a big narcoterror network based out of Canada and individuals suspected to be Khalistan sympathisers. While the operation led to the largest ever drug seizure there with 479 kg of cocaine valued at \$47.9 million, nine individuals including seven Indian-origin men settled in Canada have been arrested.

The investigation has revealed that the network exploited commercial trucking routes from the US to Canada, with ties to Mexican cartels and US-based distributors, the Peel

The proceeds from drug trafficking were being used to finance anti-India activities, including protests and referendums besides funding for weapons, sources Intelligence sources pointed towards an ISIbacked plan where Khalistani groups in Canada are being funded to traffick high value Mexican cocaine. The ISI has also been been found pushing Afghangrown heroin.

Halal certification is turning into a scam. It's creating a Muslim-only economy

Halal is the latest Islamic fad. The internet is buzzing with content on Halal living, Halal dating, and even Halal sex. Halal certification is a booming global industry created by New Islam. A religion that has so far been proudly political is becoming brazenly commercial too. And why not, when catchphrases like "Islam is the complete way of life"—making detailed prescriptions for politics, economy, and every imaginable aspect of life-go unchallenged?In an ongoing Supreme Court case, Solicitor General Tushar Mehta submitted that while nobody had any objection to Halal certification for meat, nowadays even cement, iron rods, and bottled water were being certified as Halal. Since such certification comes at a cost—charged by private agencies in the Halal certification business—even customers who have no interest in such labels are being made to pay higher prices for the commodities thus certified. Halal certification preys on the naïveté of the newly prosperous Muslim masses. The Indian economy has been steadily growing, and Muslims have shared in this prosperity as much as anyone else. But this upward mobility has to be matched by enhanced selfesteem and social respectability, which, for a Muslim, still comes through overt piety and demonstrative religiosity. The Halal industry sows such fervour and reaps a good harvest from it. In the process, not entirely unwittingly, it also fosters a narrow and rigid religious attitude among Muslims—one that leads, inevitably, to radicalisation. The growth of the Indian economy has placed unprecedented purchasing power in Muslim hands too. And though the Halal certification business is aimed at tapping into the vast and growing Muslim market, it is bound to have and unforeseen insidious consequences. For one, it will result in economic separatism, creating a Muslim-only parallel economy. In effect, it will lead to the systemic economic boycott of other communities. Stray calls to boycott Muslim street vendors, which keep circulating on social media, are a red herring compared to the harm the Halal market is insinuating into the political economy. Its normalisation and mainstreaming will have far-reaching consequences for inter-community relations—even greater than what Muslim Personal Law or vote bank politics have had so far.If a non-Muslim were to buy and sell in the Halal market, he would have to comply with the terms prescribed by Sharia, as interpreted by the agents of Halal certification. In such a market, they would be second-class citizens. Dhimmis. We would have the economic version of an Islamic state. Having suffered from the Two-Nation Theory, are we now sleepwalking into a Two-Economy reality? The path is nearly charted as a parallel economy develops around Islamic banking, Halal stocks, Halal mutual funds, Halal investments, and Halal travels. This trend will eventually lead to demands for the Halal certification of India itself as a country fit for Muslims. Then for the Constitution as a document that doesn't conflict with Sharia. And, as has already been happening informally, Halal certification for political parties—determining whether it is right for a Muslim to vote for some of them. One wonders, why should the religious lens be used to look at everything from iron rods and cement to electric wires and batteries? How will someone who looks at iron and cement through an Islamic filter see people of other religions? An outlook like this, even if genuinely Islamic, would have no place in the modern world.But as I will show in the latter part of this article, this isn't even Islamic. It has no precedence in history or theological feet to stand on. It's pop Islam-faux piety, driven by pseudo-Islamic power theology that seeks to paint the world in garish

Deep State is the convenient bogeyman of modern politics. It's entered India too

Circa 1900: Rudyard Kipling wrote Kim, placing the eponymous hero at the centre of the Great Game of espionage between the British Empire and Russia in the 19th century. The book is set after the Second Anglo-Afghan War, which ended in 1881, but before the Third, likely in the period 1893–98. Kim, short for Kimball O'Hara, is an impoverished Irish orphan who lives on the streets of Lahore and works for Mahbub Ali, a Pashtun horse trader. He later befriends an aged Tibetan lama, accompanies him on his journey along the Grand Trunk Road, learns about the Great Game, and is eventually recruited by Mahbub Ali, who works for the British Secret Service in their quest to extend influence in both Afghanistan Tibet.Whether or not the Great Game—the expression used by British imperialists to describe the perceived expansion of Russian influence in Afghanistan, Central Asia, and Tibet—actually existed, the fact remains that surveys were undertaken, expeditions mounted, spymasters recruited, and novels written, even as soldiers lost their lives. Taking a cue from Viceroy George Curzon, pro-establishment papers—from the Civil and Military Gazette of Lahore to The Pioneer of Lucknow, The Statesman of Calcutta (now Kolkata), and The Times of India of Bombay (now Mumbai)—concurred that Tsarist Russia posed a real threat to the jewel in Britain's crown. A hundred



and twenty years later, historians remain sceptical of Curzon's assertions.Is the hue and cry about the Deep State similar to the Great Game? Whether or not it exists, whether it operates in all countries, and whether the 'deep state' of one country is connected with others through the dark web or entrenched corporate interests remains unclear, as the discourse is more ideological than empirical. Sometimes, those who claim to be part of the deep state ascribe to themselves a larger-than-life role in state affairs—for example, AS Dulat and Asad Durrani in their 2018 book The Spy Chronicles: RAW, ISI and the Illusion of Peace. Their claim to be arbiters of one of the most tense and difficult relationships in the region has been widely critiqued by reviewers. The term first gained wide currency in the context of Türkiye as derin devlet, which literally translates to "deep state" in English. In Türkiye, it refers to a non-elected military elite dominating elected governments, especially when they attempt to dismantle the secular foundations of the Republic, established by

Mustafa Kemal Pasha after the abolition of the caliphate in 1923. In Pakistan, "deep state" refers to a government controlled by powerful military leaders, as documented by Stephen Cohen in The Idea of Pakistan and Ishtiaq Ahmed in Pakistan: The Garrison State. Elected governments in Pakistan have rarely exercised real control over defense and foreign policy.In the US, Democrats and Republicans accuse each other of controlling the 'deep state.' Democrats claim the pro-Republican arms lobby and military-industrial complex constitute the deep state, while Republicans argue that Ivy League universities promote 'wokeism' and diversity, equity, and inclusion narratives that, according to Donald Trump, undermine America's greatness. Trump has accused the deep state within the Democratic regime of election interference, citing the Freedom Medal awarded to George Soros as evidence. However, skeptics argue that if the deep state were so powerful, how could Daksh Patel dismantle it simply by firing 'interns and associates'

with that of President Biden? Ultimately, the deep state serves as a convenient scapegoat for anything that goes wrong or for political parties losing popular support.If Republicans and Democrats are battling it out in Washington, India faces a similar scenario, with Left liberals and Right nationalists accusing each other of leveraging the 'deep state' to gain or retain power. Publications like The Caravan and Organiser Weekly lead these respective narratives. Left liberals claim the RSS is India's deep state, while Right nationalists accuse the Ford Foundation and George Open Foundations of attempting to discredit the democratically elected Modi government. Left liberals find support in the speeches of Leader of Opposition Rahul Gandhi, while Right nationalists, led by Vice President Dhankhar, minister Kiren Rijiju, and BJP spokespersons like Sambit Patra, vehemently counter these claims.In a pre-budget article for The Indian Express, economist Surjit Bhalla, a former member of the PM's Economic Advisory Council, alleged that India's deep state comprises "major industrialists, senior IAS babus, and their friendly influencers in the media", slowing down economic growth. This claim was firmly repudiated, point by point, by Vivek Kaul in Newslaundry, who questioned the logic behind such allegations. Kaul argued that neither the

not religious fanatics. In fact, they professed the sort of secular socialism which evolved into the crony socialism-cumauthoritarianism seen in many countries ruled by similarly inclined people and parties. Even India and the Congress Party of the mid-1970s were not unlike Syria during that same period. The difference, of course, is that the Emergency in India marked the apogee and also the end of authoritarianism. India never degenerated into a single-party rule which appears to be the main cause of the rise of the Islamist factions all over West Asia today. Ironically, authoritarian secularism (and in Syria's case, also minority rule by the Shia

Alawite tribe of the Assads) has led to the ascent of doctrinaire Sunni Islam and power being captured by its adherents. As the news channels broke the news of the fall of Assad's government in Syria, I saw London's Oxford Street become an impromptu victory procession of cars with young men honking, shouting and hanging out of windows brandishing their homeland's distinctive opposition flag. It continued for well over an hour without any of London's uniformed finest visible. Maybe the Metropolitan Police were just relieved it was not yet another fraught pro-Gaza demonstration. But having lived in Syria during the regime

of this just-ousted socialist dictator's father, I had mixed feelings. How would those fashionably puffer-jacket-clad Syrians cheering in London fare under the country's new rulers whose roots are in the Salafijihadist school although they profess to have "moved" to a more accommodating position? Do Syrians not know what's happening Afghanistan, whose Taliban rulers mouthed similar lines and then recanted? When my father was India's ambassador to Syria, the then President Hafez al-Assad ordered the Hama massacre in 1982, triggered by a long-brewing uprising in that city 200km north of Damascus by the Muslim.

Tax cuts won't fix low growth. Govt must look beyond fiscal policy

to cut personal income tax. As finance minister Nirmala Sitharaman said in her speech, it is meant to boost demand in the economy. However, the government doesn't expect a higher-than-usual increase in other non-debt receipts and has budgeted a decline in the deficit. The budgeted capital expenditure is the same as the revised estimates for 2024-25. The tax cut should be seen in the context of other fiscal policy moves the Modi government has made in the last decade to boost growth. Since 2016, the Indian economy has struggled to sustain rapid growth. From 2016 to 2019, it was in a relentless showdown, with GDP growth falling to 3.9 per cent in 2019-20. The GDP then fell sharply to the 2020-21 due pandemic. After this sharp decline, high GDP growth numbers created a false sense of complacency, but the compound annual growth rate between 2019-20 and 2024-25 is only 4.8 per cent. The latest GDP estimates suggest that the economy is slowing down again—with growth clocking at 5.4 per cent in the July-September quarter of 2024. Even if we set aside the critiques of GDP estimation in India, growth remains a topic of concern in policy conversations. The government's response to an economic challenge depends on what it considers to be the root cause. The Modi government's actions over the past decade suggest that it seeks to address India's economic growth pangs through fiscal policy. Consequently, fiscal policy has done much of the heavy lifting in the government's growth strategy over the past decade. In the economic slowdown from 2016-17 to 2019-20, the government sought to maintain its expenditure. To do so without increasing the reported fiscal

deficit, from 2017-18 to 2019-20. it **The Modi** government's main move transformed a significant part of its in the Union Budget 2025 has been on-budget expenditure into offbudget expenditure done by public enterprises. It also sharply raised cesses and surcharges on petroleum products, which are not shared with the states. These unusual tactics allowed the government to spend more, and expenditure continued to outpace GDP growth. These tactics also allowed the government to introduce new cash transfer schemes such as PM KISAN and increase allocations to existing schemes.In 2019, in an effort to stimulate investment, the government announced major tax breaks for corporates, especially in manufacturing. At the time, corporate tax collection had been growing rapidly while other taxes were struggling to deliver the budgeted increase. The tax cut led to a sharp reduction in the corporate tax to GDP ratio in the subsequent years. As the pandemic hit, fiscal policy became even more

> The pandemic allowed the government to suspend its concern for deficits and bring the off-budget expenditure to the Budget in 2020-21. For a few years, revenue expenditure as a percentage of GDP was higher than its pre-pandemic levels. Among other things, this allowed the government to increase subsidies and cash transfers, and introduce production-linked incentives for manufacturing in India. Total subsidies as a percentage of GDP have now gone back to their prepandemic levels. The most important change in expenditure since the pandemic has been in its composition. 
Youth Take Pledge to Eradicate Superstition and Blind Faith

Govt drafts comprehensive action plan to strengthen Uttar Pradesh

Lucknow

Under the guidance of Chief Minister Yogi Adityanath, a comprehensive plan has been prepared to expand and strengthen Uttar Pollution Pradesh Control Board (UPPCB) in order to bolster pollution control and environmental protection across the state. The proposal is currently under review at the administrative level and, once approved, is expected to bring transformative changes in environmental governance in the state. To further strengthen UPPCB's financial base, the fee structure for applications will be revised, and a techenabled portal will be launched to simplify and bring greater transparency to its operations.It is worth mentioning here that in light of Uttar Pradesh's rapid industrialisation and urbanisation under CM Yogi's leadership, pollution levels have also gone up in the state. To address the issue, a plan has been drafted to make UPPCB more effective by expanding state. As per the proposal, regional offices of the Board will be established in all divisional headquarters and key industrial districts, while district-level offices will be opened in the remaining districts. decentralisation aims to ensure better local monitoring and management of pollution.Additionally, dedicated cells will be set up to manage different types of waste-solid waste, liquid waste (STP and CETP), hazardous waste, e-waste, and biomedical waste—making waste management more structured and efficient.To encourage environmental research and development, a dedicated cell will be created within UPPCB to work on innovative technologies and solutions for pollution control. Industrial units will be able to upload their compliance reports directly through the portal. Automated e-alerts will notify them of consent renewals and report submission deadlines. Post-inspection reports will be uploaded instantly, and AI will be used to cross-verify compliance reports.The initiative marks a major step towards transforming environmental management in Pradesh. Once approved and implemented, it will significantly improve environmental protection, promote industrial compliance.



Despite US student visa interview freeze, these 5 countries offer easier processes

Delhi: Student visa applicants have been hampered by US embassies canceling interviews due to the Trump administration's social media profile screening process. Some countries simplify student visas. Five countries offer faster visa approvals and postgraduation jobs to international students: Germany is a popular destination for overseas students since its public universities forgo tuition. Student visas are also simplified. Applicants must show they can afford €11,904 per academic year to support themselves. Visas are easy to get after a German institution's admission letter. Students must show admittance, health insurance, and finances. Germany permits students to work part-time and gives them 18 months to find work after graduation.

Indian students must apply for a "D Study visa" to study in Ireland. This visa is for students studying in Ireland for longer than 90 days. The process comprises applying online through AVATS, providing papers, paying the visa fee, and maybe biometrics. Most Irish applications are handled in four to eight weeks. Part-time work is allowed, and postgraduates have two years to find work. France has a surprisingly easy non-EU student visa process.





Computerized EWS lottery determines school entrance.

Delhi: The Delhi High Court

ruled that schools must follow the Directorate of Education (DoE)'s computerized draw of lots for economically weaker section (EWS) admissions. Justice C Hari Shankar noted that the computerized draw of lots is based on the class strength communicated by the schools, and if a school does not have enough general students, it must apply to the DoE to reduce the number of EWS students. A pupil seeking admission to a private school's pre-primary class after a successful DoE computerized draw of lots petitioned the court. The school denied admission to the petitioner because the actual number of general category admissions was less than what was communicated to the DoE, and it had already admitted 25% of the actual number under the EWS category per legal mandate. " Once a school communicates the number of general category and EWS seats available with it for being filled in an ensuing academic year.

Odisha's FY25 budget is Rs 2.65 lakh crore

Delhi: The Odisha government submitted a Rs 2.65 lakh crore -25 budget focused on agriculture and irrigation in the state parliament. Chief Minister Mohan Majhi, who also holds the finance portfolio, presented the BJP government's maiden budget and proposed an outlay of Rs 33,919 crore for agriculture, 36% more than the previous year.He said program cost was estimated at Rs 1.55 lakh crore, administrative expense at Rs 97,725 crore, and Disaster Risk Management Funds at Rs 3,900 crore.The "Samrudha Krushak Yojana" for farmers received Rs 5.000 crore from the chief minister. He also proposed a Rs 1,935 crore state budget initiative for farmers called 'CM Kisan'.

Majhi called the paper a "people's budget" and stated the government consulted stakeholders.

Electronic papers acceptable as court evidence

Delhi: Text, voice, and video messages contain what? Post July 1, "digital documents" are admissible as primary evidence, not simply emojis, PPTs, PDFs, group conversations, forwards, or tete-a-tete. The last one is a rewrite of the 1872 Indian Evidence Act and an acknowledgment of digital information's importance today. The 2023 Bharatiya Sakshya Adhiniyam defines and interprets evidence. It states that "an electronic or digital record" can be "admissible" in a case under certain conditions, taking into account technical improvements and the widespread use of digital communication. Senior counsel Amit Manchanda said protections must be addressed first to prevent misuse given the uncharted field of artificial intelligence and new software to manipulate words, photos, and digital content on a recipient's device. Advocate Mohit Bhardwaj called Section 57 BSA's "singularly significant" inclusion because it makes digital data, including messages, primary evidence "without much ado," until disputed.For disputed digital records, the new rule mandates a certificate proving authenticity from a specific computer or device.

. Thus, under Section 61 of BNS, the court cannot deny the acceptance of an electronic or digital document given specified conditions under Section 63. Any print or copy of an electronic record is admissible "without further proof" or production of the original content if the device (say, a phone) was "used regularly" by the person with "lawful control" of its usage. Texts could be evidence under the old Indian Evidence Act.

with a Section 65B certificate. On July 2, Delhi High Court stated that "WhatsApp conversations cannot be read as evidence without a proper certificate as mandated under the Indian Evidence Act, 1872". The new Acts apply exclusively to lawsuits filed after July 1. It simplifies police and prosecuting agencies' digital record presentation, according to NDPS lawyer Taraq Sayed. They can "extract" these without a cyber forensic professional in several ways. The data can be downloaded by Bluetooth or scanning, he claimed.

No farm relief

Delhi: With the government reeling under an enormous debt of Rs 7.9 lakh crore and the state's struggling farmers taking their own lives, Mahayuti government's Rs 11 crore gift for India's T-20 champion squad has drawn criticism from Congress's Vijay Wadettiwar, the head of Maharashtra's opposition. "In just four months, at least 1,068 farmers committed suicide, but they get no assistance." The Maharashtra government gave wealthy cricket players an unjustified gift in order to further its own agenda, according to Wadettiwar. "We should support players but within our means and must give due weightage considering the broader picture.
