Vatika Times **NEW DELHI:** The multi-party parliamentary delegation led by Congress MP Shashi Tharoor on late Sunday concluded its high-level visit to the United States, wrapping up the final leg of a diplomatic mission aimed at building international consensus on India's counter-terrorism stance following the April 22 terror attack in Pahalgam, which left 26 people dead. Taking to X as he wrapped up the US visit, Tharoor wrote: "If you are born a hundred times, you will do it a hundred times. I will love my country with all my heart... A Watan. The whole world now knows the truth. We are lovers of non-violence, but only until someone tests that... Jai Hind!" On the final day of

the tour, the delegation paid tribute to Mahatma Gandhi's statue in Washington. Tharoor

The group, which arrived in Washington on June 3 after stops in Guyana, Panama, Colombia, and Brazil, met with several kev American leaders including US Vice President JD Vance, Deputy Secretary of State Christopher Landau, senior members of Congress, policy experts, and members of the Indian-American community.

Describing the meeting with Vance as "an excellent meeting," Tharoor said the Vice President was "warm and welcoming and receptive," and "expressed complete understanding, first of all, outrage of what happened in Pahalgam and support and respect for India's restrained response in Operation Sindoor." A US State Department spokesperson said Landau "reaffirmed the United States' strong support of India in the fight against terrorism and the strategic partnership between the two countries."

Addressing the Centre on Foreign Relations, Tharoor had said India's actions were targeted at terror infrastructure, not civilians. "We're not interested in attacking Pakistani civilians, ordinary people. This is about India versus terrorism... If you're not prepared to shut down the safe havens or arrest terrorist leaders, then I'm afraid this is the only way we can deal with it," he said. Referring to Pakistan's military, he added, "In India, the state has an army. In Pakistan, the army has a state," accusing Islamabad of manipulating public opinion through conflict. Tharoor dismissed claims of Pakistani success during the brief hostilities that followed, saying, "Two videos came out on social media, both turned out to be from other conflicts in other years, nothing to do with this one.'

No need of slum-dwellers' nod for Dharavi project, says CEO

MUMBAI: Responding to queries on the resistance to the Dharavi redeveloment project from a section of slum-dwellers, its CEO, S V R Srinivas, told TOI that more than 50% of the residents have already consented to the project. But more significantly, he revealed that the project did not require public consent in the first place because the developer had been appointed by the state govt.

"Under the SRA rules, the building society appoints the developer. For that, 50% consent is required. But here, the govt has appointed the developer. In this case, there is no need for consent," said Srinivas in an exclusive interview to.

The project is being implemented by Nav Bharat Mega Developers Pvt Ltd, an SPV in which the Adani Group holds 80% stake and the govt 20%. The land on which Dharavi stands is owned by the govt and the BMC. Srinivas said around 1 lakh slum-dwellers had responded to the house-to-house survey and just around 20,000 remained to be surveyed. So even if the 50% consent parameter was applied, it had already been crossed, he said. Participation in the door-to-door survey on eligibility for rehabilitation translated into consent, he clarified. "They have given their documents voluntarily. There is a line in the survey which says they are willing to participate in the redevelopment. So, when they sign, it is consent," said Srinivas. Although consent is not required for the project, the govt had made multiple efforts to get residents to respond to the survey and agree to the project, he emphasised. "We don't want to ride roughshod on anybody. We have already given four opportunities. We put it in the newspaper and then we also put it on their doors," he said. Srinivas said that the survey was still ongoing but roughly 5 lakh eligible tenements would need to be given free space within Dharavi and 5 lakh ineligible tenements would have to move out to subsidised.

Smaller centres leave metros behind in hiring pace: Report

NEW DELHI: Small cities and towns witnessed a sharp surge in hiring more than double the pace seen in metros - driven by robust growth in the BFSI, manufacturing, retail, and IT sectors. This trend marks a significant shift towards decentralised economic growth, underscoring the rapid rise of tier-2 cities emerging talent hubs, with opportunities now expanding beyond traditional urban centres. Job openings in tier-2 cities rose nearly 42%, compared to a 19% increase in tier-1 cities, according to the Randstad Talent Insights Report 2025 shared exclusively with TOI.

The first edition of the report, drawn from data in the sixmonth period - Sept

The court was also informed that third parties were unfairly benefiting commercially from the sale of merchandise featuring his pictures and voice for ringtones. Most alarming was the online circulation of fake pornographic images and videos of the actor with other actresses. Notably, in its order, the Delhi High Court stated that satirical writing and genuine criticism would be safeguarded and not construed as violations of personality rights. While the word 'Jhakaas' can be used by people, they cannot exploit it commercially in the manner Anil Kapoor does. Similarly, it can be used for satire, criticism or parody, but not for monetary gains. In the Jackie Shroff case as well, the court declined to order the removal of a video titled 'Jackie Shroff is Savage, Jackie Shroff Thug Life', posted on a YouTube channel named 'Thugesh'. The court deemed the video a form of artistic expression and said imposing restrictions would have significant consequences. In the Anil Kapoor case, the court established the protection of personality rights in the realm of AI and deepfakes. However, this hasn't deterred the illegal use of celebrities' personal attributes for financial gains. Regarding the existing laws, advocate Naik says: "I feel the current laws and the jurisprudence that we got from the Delhi High Court in matters of Mr. Bachchan or Mr. Kapoor are good references. I personally feel the time has come for us to protect personality rights. like the one provided by the Copyright Act." However, the challenge lies in taking tangible action to identify infringers, notify them, and ensure compliance. Jackie Shroff's case marks the first instance of a court restraining an unlicensed Chatbot. "There is a need for updated legislation or legal interpretations to address these emerging issues and provide stronger protections for celebrities' persona in the digital age. Additionally, enforcement mechanisms may need to be strengthened to effectively combat the misuse of Al-generated content," observes Masodi. In the online world, cybercriminals exploit AI for nefarious purposes to make money while jeopardising people's reputations. Celebrities are taking the lead, and the courts are establishing principles and precedents. Being vigilant to preempt damage is

The Delhi High Court recently issued an order safeguarding the personality and publicity rights of film actor Jackie Shroff, restraining several social media accounts, AI Chatbots, and e-commerce websites from exploiting the actor's name, voice, or image for commercial purposes without his consent. Shroff petitioned the court against the unauthorised use of his name and persona, seeking protection against various individuals and entities utilising and misusing his identity without permission. The proliferation of Al-generated deepfake videos has exacerbated concerns for celebrities. Jackie Shroff's isn't the first instance of a film star resorting to legal action to protect their personality rights. Over the past two years, the Delhi High Court has issued interim orders to prevent the unauthorised use of Amitabh Bachchan and Anil Kapoor's name, image, and voice. The question arises: why are some celebrities turning to courts for the protection of their personality rights, while others refrain? "Where there is demonstrable misuse, people are approaching. Personality right is a facet of publicity right," says advocate Ameet Naik.

On October 7, 1950, the communist troops advanced in eastern Tibet, and after smashing the ill-trained and ill-equipped Tibetan army, Chamdo, the capital of Kham Province, fell to the invaders. On November 7, Sardar Patel, the deputy prime minister, despite his poor health, sent a long letter to the prime minister about the implications of the Chinese invasion of Tibet for India's northern border. Five days later, the dying Sardar (who passed away on December 15) constituted this committee to examine the possibility of Chinese communist troops occupying the areas south of the McMahon Line or elsewhere on the Indo-Tibet border and "to consider the feasibility or advancing outposts of the Assam Rifles in order to forestall such ingress".

esides Maj Himmatsinghji, deputy minister of defense (chairman), it included Lt Gen Kulwant Singh, K Zakaria, head of the Ministry of External Affairs' historical division, SN Haksar, joint secretary also from MEA, Group Captain MS Chaturvedi from the Indian Air Force, and Waryam Singh, deputy director of the Intelligence Bureau. After discussing at great length the advisability of pushing forward a post to Tawang, it was decided to go ahead. It was also decided to send troops to Nelang (then written



Nilang) and Jadung (then Jadhang), two tiny villages south of the Tsangchok-la, the pass marking the watershed in the area, in the Chamoli district.

The Role of Jairamdas **Daulatram**

One man was central in the setting up of Maj Khathing's expedition to Tawang; it was Jairamdas Daulatram, the governor of Assam. It is sad that his role has been more or less forgotten today. On December 10, 1950, he managed to get the concurrence of the Ministry of External Affairs headed by Nehru; a Joint Secretary concurred with the Committee, "We cannot agree to a unilateral occupation of Tawang by the communists." The ball then started rolling, and preparations for the expedition began. Maj Khathing received detailed instructions from Nari Rustomji, the advisor to the governor, on behalf of Daulatram himself.

Precise tasks were given to the young and bold officer. The first task was to occupy Tawang. Khathing was asked to explain to the local population and Tibetan officials that he was "doing no more than is being done by the administration in other parts of Indian territory;" in 1914,

Tibet had agreed to the McMahon Line, north of Tawang being the boundary. The major was ordered to "treat any Tibetan or other officials you may meet with courtesy, but nevertheless let them understand that jurisdiction in the area vests in you and not in them." He was directed to submit detailed reports about the Tibetan 'influence' in the area and the nature of taxes collected. He was further told to abolish all existing taxes and substitute them with lighter taxes to be paid to the Political Officer, representing the Indian gov-

Fortunately, due to Khathing's intelligence and diplomatic skills, this would not be necessary, and

74 years later, he was still considered by the Monpas as their liberator. Khathing was also asked to keep daily wireless telegraphic contact with Daulatram after crossing the Se-La pass. It is what Khathing did, and his dispatches and cables still make fascinating reading. Finally, Daulatram asked Khathing to "conduct [the] operation with tact, firmness, and discretion".

The logistics of the expedition were not easy; for example, the question of porters and loads was difficult to coordinate. One can imagine having as many as 200 troops and 600 porters to feed.

Andhra Pradesh's cyanide killers: Women behind series of gruesome murders in state

VIJAYAWADA: In a chilling case reminiscent of Kerala's notorious Koodathayi murders, three women from Tenali in Guntur district of Andhra Pradesh have been arrested for a series of killings using cyanide, targeting vulnerable people over the past two years. Police have so far identified three victims but suspect there could be more.The accused, identified Munagappa Rajani (40), Mudiyala Venkateswari alias Bujji (32), and Gontu Ramanamma

(60), all residents of Tenali, have so far admitted to killing three with cyanidelaced drinks and food to rob them of gold and money. Police said they would get to know if there were other victims once their interrogation is over.



The Food Safety and Standards Authority of India (FSSAI) issued an order aimed at curbing what it sees as deceptive promotions, particularly on social media platforms, that tout A2 butter, curd or ghee as superior products, a person aware of the matter said, asking not to be named. It has come to the notice of FSSAI that several food business operators are selling/marketing milk and milk products such as ghee, butter, curd etc in the name of A1 & A2 under FSSAI licence number and/or registration certificate", the order stated. The regulator explained that the A1 and A2 distinction in milk is related to differences in protein structure, specifically beta-casein. Consequently, the FSSAI deemed A2 claims on milk fat products as misleading and not in compliance with the Food Safety and Standards Act of 2006 and associated



Delhi: In response to rising fears of quack medicine and unlicensed practitioners in the nation's capital, the Delhi Medical Council (DMC) has notified the Delhi high court of various methods by which residents can confirm the legitimacy of their physicians. These include scanning QR codes on displayed certificates and making use of the online verification tools that the DMC provides on its website.In December 2023, counsel Sachin Jain petitioned the court, bringing up the issue.

Delhi: Car drivers are the top traffic violators in Delhi this year, according to Delhi Police. Between January 1 and May 15, 14,11,801 drivers were cited for traffic violations, topping the list. Despite the huge number of two-wheelers on Delhi's roadways, automobile drivers broke 211.4% more traffic laws than business vans or cars. The report reached Delhi Police headquarters.
