Congress top brass raps state unit for Bengaluru stampede

Vatika Times NEW DELHI/BENGALU-

RU: The much-anticipated meeting on Tuesday between the Congress high command, Siddaramaiah and DCM DK Shivakumar to discuss alleged lapses that led to the stampede outside cricket stadium resulted in putting up a united front with the party leadership backing its govt. However, the main takeaway from the meeting was that a fresh caste enumeration would be taken up in the state.

The meeting, attended by AICC president Mallikarjun Kharge, leader of opposition Rahul Gandhi, AICC general secretaries Randeep Singh Surjewala and KC Venugopal, saw the high command accepting the action taken by the govt in the aftermath of the tragedy.

"The CM and PCC chief briefed the leadership about the incident and



the action taken post incident. Certainly, we are concerned about every human life. Anyway, the govt has constituted a judicial inquiry to look into the entire incident. During the inquiry, the party did not want to involve itself in the nitty-gritty of the issue," said Venugopal after the meeting. It is said the govt may use the opportunity to push for a cabinet reshuffle and a possible expansion. Portfolio reshuffle may happen

Aashada Venugopal, however, added that the party has asked the govt to be more people-friendly in this regard.

generally, the "But party clearly viewed that there needs to be a pro-people attitude on this issue (from the govt)," said the AICC general secretary.

"If things go as planned, the CM may consider a cabinet expansion with the inclusion of one or two ministers and reshuffle the portfolios to suggest political accountability," said one govt officer, hinting it may happen before the onset of inauspicious month of Aashada in mid-June. However, DK

According to Congress insiders, the situation is too volatile for an inclusion process, with at least 8 to 10 serious aspirants waiting for their turn, and any decision to add only 1 or 2 persons would create unrest. The next day, Raj allegedly met three childhood friends Rajput, Vishal Singh Chauhan, and Anand Kurmi — at a restaurant in Indore's Super Corridor, where the killing was planned.

The trio left Indore on a train to Guwahati via New Delhi, reached Shillong on May 21, and allegedly shadowed the couple using a rental car. Sonam sent live locations, lured Raia to isolated spots for photos, and waited for the right moment, police alleged.

"They tried to push him off a cliff in a forest first, but it didn't work out," said an officer in Indore. "Instead, the attackers used machete bought in Guwahati.

Trade breakthrough: US, China agree on 'framework' to ease trade tensions





The United States and China have agreed on a framework to move forward on trade, marking a potential turning point in the prolonged 'trade war' between the two nations. The announcement came after two days of talks at London's Lancaster House.

"We have reached a framework to implement the Geneva consensus." said US Commerce Secretary Howard Lutnick. While the plan still requires approval from both presidents, Lutnick expressed confidence that issues such as rare earth exports would be resolved. "Once the presidents approve it, we will then seek to implement it," he said.

US Trade Representative Jamieson Greer said the US was moving "as quickly as we can," adding: "We feel positive about engaging with the Chinese.""I think the talks are going really, really well," Lutnick told reporters during the discussions, which lasted nearly 20 hours. "Everybody's got their head down working closely."Talks resumed in London after President Donald Trump and President Xi Jinping spoke by phone last week, attempting to put relations back on track. Trump said he wants to "open up China" to US products, warning.

Techie-lover stabs mom of two to death in Bengaluru hotel



In another step forward, India to host vice minister for talks



Vatika Times **NEW DELHI** Chinese vice foreign minister Sun Weidong is likely to travel to India this week for what will be the second high-level bilateral visit from either side this year, following foreign secretary Vikram Misri's visit to Beijing in January during which Sun and Misri had agreed to a slew of measures aimed at normalizing ties.

The 2-day visit by Sun will be the latest reinforcement of the improvement in bilateral ties resulting from the completion of the troop disengagement process in eastern Ladakh, after almost 5

years of a military standoff that wrecked the relationship. This was quickly followed by a meeting of PM Narendra Modi and President Xi Jinping in Russia in October and the resumption of the Special Representatives' (SR) Talks on the Boundary Question 2 months later.ToI has learnt that Sun will arrive in India on Thursday for a 2-day visit that will likely see him calling on NSA Ajit Doval, apart from holding talks under the foreign secretary-vice minister mechanism. Doval is also likely to host the Chinese Special Representative, Wang Yi.

Post-Cold War era and **Great Power competition**

Post-World War II saw the emergence of two power blocks: the US-led North Atlantic Treaty Organisation (NATO), formed in 1949, and the Soviet Union-led Warsaw Pact, formed in 1955. NATO was meant to defend against the spread of Soviet-led communism. The Warsaw Pact was to counter NATO. The resultant Cold War saw huge military buildups and competition in the space and nuclear fields. At its peak between 1975 and 1985, the US and Soviet Union had a nuclear weapons stockpile of nearly 60,000 warheads. The collapse and breakup of the Soviet Union in 1991 brought an end to the Cold War. The period saw arms control treaties and a significant reduction of nuclear weapons, and stockpiles between the two are now around 6,000 each. The period also saw the folding up of the Warsaw Pact, but a significant increase in NATO, which, as of date, has 32 members. The world became unipolar, with the US dominating the security scene. This was also the period when the world concentrated on the War against Terror. West Asia became the area of focus. By 2007, Russia had begun to consolidate its power under President Putin. China had started rising as an economic and military power. China unilaterally usurped nearly three million sq. km of the South China Sea (SCS), and became aggressive for Taiwan unification. The Quad was formed with the US, Japan, Australia and India to thwart China's expansionist designs in the Indo-Pacific. Meanwhile in Europe, Ukraine was showing interest in joining NATO. This would have brought the alliance on the Russian doorstep. This was unacceptable to Russia. Initially to secure its Black Sea fleet, Russia arranged to annex Crimea in 2014. With Ukraine still not relenting on NATO, Russia invaded Ukraine in February 2022. Effectively that brought an end to the post-Cold War era.

Post-Cold War Era Begins

Despite massive NATO support to Ukraine, Russia continues to hold nearly 20 percent Ukrainian territory. The American and European public opinion shows war fatigue, and are not keen to pump more money or weapons. Hamas in Gaza, Hezbollah in Lebanon, Houthis in Yemen and several militias in Syria and Iraq are part of Iran funded and backed "Axis of Resistance". Now, they have a new backer: Russia, Developments in West Asia (Gaza war and Houthis) have also complicated the US' desire to focus more on the Indo-Pacific. Russia has secured lifelines for its economy and defence enterprises, while navigating to retain its military influence outside of Europe. In spite of economic sanctions, Russia has once again emerged as a power to contend with. Russia supports legacy multilateral institutions, along with China. It is strengthening BRICS, and is pushing for the de-dollarisation of international finance. Russia and China want to prevent the US and its allies from writing international rules. Russia has recalibrated its entire foreign policy to fit the needs of a long struggle. Russia has already expanded its trade and political relations with non-Western countries. The pillars of Russia's global foreign policy are selfpreservation and global de-compartmentalisation. China has not only emerged as an economic power that is peddling influence around the world through Belt and Road and other economic initiatives, but has also become a significant military and Space power that wants to initially exert influence in Western Pacific and Indian Oceans, and later across the globe. China has also been modernising and expanding its nuclear arsenal. It is not willing to sit with the US and Russia to discuss arms control or evolve new treaties. The antagonism

India and the Greater Indo-Pacific: Balancing geopolitical equations

Looking at the complex geopolitical and geoeconomic challenges the Indo-Pacific region is currently grappling it is necessary that there is a need to broaden the geopolitical concept of the Indo-Pacific to the Greater Indo-Pacific. The Greater Indo-Pacific can rebalance the global geopolitics and geoeconomics while checkmating China's hegemonic role. India, being the Centre of Indo-Pacific geopolitics, can play a central role in the formation of Greater Indo-Pacific.

Introduction

The recent war between Israel and Hamas, as well as Russia and Ukraine war along with the Red Sea crisis demonstrates that some of these crises are having an impact on the geopolitics of the Indo-Pacific. Along with these wars, the rise of China is also posing a substantial challenge to the Greater Indo-Pacific encompassing major countries of the "Eurasian Heartland" in the phraseology of Halford Mackinder, like India, the US, Japan, South East Asian countries, South Korea, Philippines, Saudi Arabia, UAE, Israel, Egypt, France, Germany, Italy, Greece, Russia and Kazakhstan. Though the idea appears to be entirely imaginary, understanding the present geopolitical complexities is necessary to consider the Greater Indo-Pacific concept. Both the US and Russia should



learn from Israel's and Saudi Arabia's relations. Improved relations between Moscow and Washington can enhance peace and security in West Asia, the Mediterranean and Indo-Pacific regions as well also in the post-Soviet space. Bringing these above-mentioned regions into a Greater Indo-Pacific framework can give impetus to peace and security in the region as well as enhance economic cooperation. A Greater Indo-Pacific can also provide a necessary challenge to China's hegemonic geopolitics. In this context, India can play a vital role in giving the necessary leadership to Greater Indo-Pacific. The prolonged crisis in the "heartland" in the form of a war between Russia and Ukraine, as well as the onset of the war between Israel and Hamas and its spiral impact in the form of the Red Sea crisis, is providing a new

kind of geopolitical equation in the global map. One thing is sure: phrases like alliances and block politics (though not in an ideological framework) and issues relating to armament and disarmament are currently gaining broader importance in geopolitical discourses. The two wars, as discussed above, demonstrate the significance of the metaphor of "Eurasia" as coined by British geopolitical thinker Halford J Mackinder in his classic work Democratic Ideals and Reality published in 1919, where he eulogised the concept of "World Island" and also "Heartland" in the lexicon of geopolitics. The reason for discussing the metaphor of "Eurasia" or "Heartland" in the present strategic polemics on the Indo-Pacific is to highlight how these two trajectories can be relevant in the context of the geopolitics of the region. Though Mackinder has not

talked about the concept of Indo-Pacific, his article titled Geographical Pivot of History, published in 1904, discussed the concept of "Outer Crescent" and Crescent", where much of the Indo-Pacific comes under the ambit. For instance, India is in the inner crescent of Eurasia and Japan and the United States are in the outer crescent as per Mackinder. Highlighting the strategic significance of both "Inner Crescent" and "Outer Crescent", Mackinder, in his book Democratic Ideals and Reality, suggested that "The actual balance of political power at any given time is, of course, the product, on the one hand, of geographical conditions, both economic and strategic, and, on the other hand, of the relative number, virility, equipment, and organization of the competing peoples" (p.192). Similarly, German geopolitical analyst Karl Haushofer in his seminal work Geopolitics of the Pacific Ocean, published in 1924, outlined the strategic significance of this region in the global geopolitics. Describing the strategic significance of this region, Haushofer describes this region as a "giant space is expanding before our eyes." He further highlights that this region "awaits the dawn of the Pacific age, the successor to the ageing Atlantic, the over-age Mediterranean and the European era." (as quoted in Weigert, H. W. (1942). Reviewed work(s): geopolitik des pazifischen ozeans by Karl Haushofer (Review: Haushofer and the Pacific). Foreign Affair_, 20(4), 732-742). Similarly, Nocolas J Spykman in his classic work Geography of Peace, outlines the concept of Rimland where countries like Japan, India, South Korea and Saudi Arabia, located to adjacent Heartland can play a greater role. In this context, he highlights Rimland's logic, which contrasts the Mackinder approach. Spykman stated, "Whoever rules the Rimland commands Eurasia, and whoever rules Eurasia commands the world." The necessity for delving into some of the issues relating to theoretical polemics of Indo-Pacific, as highlighted in the above works of both Mackinder, Haushofer and Spykman is to trace out the significance of the concept of Indo-Pacific, which is gaining much importance in the present-day geopolitical analysis. One may recall here that Indian scholar Kalidas Nag, in his work Greater India, explains India's role in global geopolitics. In the same book, Nag highlights that "India, through the hands of Ashoka, showered her blessings of peace and progress over this symbolic union of Asia, Africa and Europe with the ties of Internationalism"(p.127). Five countries offer faster visa approvals and post-graduation jobs to international students: Germany is a popular destination for overseas students since its public universities forgo tuition. Student visas are also simplified. Applicants must show they can afford €11,904 per academic year to support themselves. Visas are easy to get after a German institution's admission letter. Students must show admittance, health insurance, finances. Germany permits students to work

part-time and gives

them 18 months to



find work after grad-Indian students must apply for a "D Study visa" to study in Ireland. This visa is for students studying in Ireland for longer than 90 days. The process comprises applying through online providing AVATS, papers, paying the visa fee, and maybe biometrics. Most Irish applications are handled in four to eight weeks. Partwork allowed, and postgraduates have two

years to find work.

France has a surpris-

ingly easy non-EU student process.. admission, academic programs require applications, financial support, and health insurance documentation. The average visa processing time is 15-30 days. KODERMA: On the out**skirts of** Jharkhand's town, defunct iron factory stands abandoned and corroded, greeting visitors at the entrance of Hirodih, a dusty and sleepy settlement of four villages next to a forgotten legacy. Thousands of residents Hirodih swing between hope and despair every election, as their demand to revive the plant, once owned by Tibetan spiritual leader and Nobel Prize winner, the Dalai Lama, getting them promises and assurances from candidates seeking votes every time, only to be forgotten after the

After the Buddhist monk crossed into India from Tibet in the 1950s, he set up this plant, spread over 350 acres of land bought from the villagers for Rs 4 crore in 1960, and named it Gayday Iron & Steel Company. The only venture owned by the Tibetan spiritual leader, the factory was a major avenue for employment in the region. But, more than four decades since its closure, hopes of its revival have only diminished due to half-baked attempts, failed promis-

es and administrative apathy, turning Koderma into a migration-prone region.Jung Bahadur Singh, who is now in his late 70s, was among the first employees of this factory. He continued to be on the rolls even when the factory's ownership kept changing hands, but the jobs continued to shrink owing to a lack of proper patronage to run the factory. The septuagenarian lives in Gamarwad village, one of the four villages where people voluntarily gave up their lands for the factory, hoping it would usher in prosperity.

Addressing a crowd in Amethi, Shah attacked Congress for referring to Amethi and Rae Bareli as their "family seats". "Did Sonia Gandhi, Rahul Gandhi, or Priyanka turn up in Amethi or Rae-Bareli when the Covid pandemic struck," Shah asked as people shouted "No". Shah also asked the people to choose between Modi and Rahul. He said that after losing from Amethi, Rahul fled to Wayanad and is now back in Rae Bareli. "I have been in Rae Bareli for three days and can say with confidence that he (Rahul) is losing from there also," he said. Centre advises CBSE on biannual board logistics

Delhi: Officials said the Union ministry of education has ordered the CBSE to create a plan for twice-yearly board exams and will confer with stakeholders next

month. The new national curriculum framework (NCF) unveiled last year suggested pupils take board exams twice a year. In



February, union education minister Dharmendra Pradhan stated the scheme would likely start in 2025-26. A senior education ministry source said CBSE has been urged to figure out how to organize the academic calendar to allow another round of board exams without affecting undergraduate admissions."The ministry and board will consult CBSE school principals and stakeholders on this. The person, who requested anonymity, indicated that other NEP 2020 implementation difficulties will be examined. A second official claimed scheduling is the board's biggest issue. 

No personal coaches, media embargo under NRAI's Olympic shooting guidelines

Delhi: To prepare its players for the quadrennial spectacle, the National Rifle Association of India has imposed severe conditions on Paris Olympic shooters, including a "media blackout" and no personal coaches at the national camp. In its "national team protocol", the federation informs shooters that parents cannot "stay" or "visit" their wards at camps and that Pierre Beauchamp, the High Performance Director (HPD), must make an exception. According to the NRAI's "NRAI Olympic Team Undertaking and SOP for Paris Olympic Games - Pistol/Rifle Teams" letter to Olympic-bound shooters, the goal is to "ensure the clarity of the training and readiness plan for Olympic Games Paris by the shooters and the National Team Coaches and Sport Science support." "It is essential to have effective organization, discipline, planned and dedicated training programmes for the best performance of shooters participating as National Team India at the Paris Olympic Games," the note states. The letter states that only NRAI-approved personal coaches and sport science consultants with signed SOPs can assist the "National Training team for the concerned shooter(s) in assisting and/or discussing with the National Training Team under the leadership of the HPD and the chief coach (rifle and pistol)." Personal coaches without NRAI approval are prohibited. "The NRAI National Team program of the Olympic Games does not allow personal trainers, physiotherapists, nutritionists, or psychologists."
