# Indian in Space: A 41-year wait that won't repeat

#### **Vatika Times NEW DELHI:**

After a 41-year gap, India celebrates Group Captain Shubhanshu Shukla as its second astronaut, following Rakesh Sharma's 1984 mission. Shukla's flight signifies India's growing ambition in space exploration, closely tied to the Gaganyaan program. ISRO is developing indigenous technologies for crew safety and astronaut training, aiming for self-reliance in future missions.

When Wing Commander (retd) Rakesh Sharma soared into space aboard a Soviet spacecraft in April 1984, Group Captain Shubhanshu Shukla wasn't even born. It would be another year-and-a-half before he entered the world — by which time Sharma's feat had already become part of the national consciousness, a story told in classrooms and remembered with pride.

Now, 41 years later, Shukla has followed in his footsteps, becoming only the second Indian to travel to space. The long gap between the two milestones tells a story of shift-



ing priorities, geopolitical turns, and the slow grind of building independent capability. But while it took over four decades for India to send another one of its own beyond the atmosphere, the next journey will not take as long. Unlike Sharma, who flew as

part of a Soviet mission when India lacked its own programme, Shukla's spaceflight is tied closely to India's growing ambitions in human space exploration.

Though Ax-4 is still international in nature, it comes at a time when the country's own human spaceflight programme — Gaganyaan is beginning to take concrete shape.

The Indian Space Research Organisation (Isro) has already developed

technologies for crew safety, including a successful test of the crew escape system and a high-altitude abort demonstration. The first uncrewed Gaganyaan mission is planned for later this year, and more such missions will follow to test systems rigorously before humans are sent aboard.

Unlike the past, when India depended on partnerships for crewed missions, the current roadmap envisages a self-reliant human spaceflight capability. Isro's Gaganyaan is designed to carry a crew to an orbit of 400km and return them safely after a mission duration of up to seven days. Final decisions on how many crew members would go and for how many days

will come later.

The spacecraft

will launch atop a modified version of the LVM3 rocket, which has already demonstrated its reliability in placing payloads in space. Training of astronauts will also become largely homegrown. While Sharma trained in the Soviet Union and Shukla trained partly in the US for this mission India now has a dedicated astronaut training facility in Bengaluru, which will be enhanced in the coming years. This will allow future Indian astronauts to be selected, trained, and flown from home soil.

The broader goal extends beyond low-Earth orbit. Over the next two decades, India aims to build longterm human presence capabilities, develop space station modules, and implement lunar crewed missions.

But those are plans for the future. What's certain for now is that with institutional structures, flighttested hardware, and committed investment, India's return to space with its own people aboard will no longer be an event separated by generations.

Shukla's spaceflight marks the end of a long silence. The next Indian in space, it appears, won't have to wait four decades.

#### Is the hue and cry about the Deep State similar to the Great Game?

Circa 1900: Rudyard Kipling wrote Kim, placing the eponymous hero at the centre of the Great Game of espionage between the British Empire and Russia in the 19th century. The book is set after the Second Anglo-Afghan War, which ended in 1881, but before the Third, likely in the period 1893–98. Kim, short for Kimball O'Hara, is an impoverished Irish orphan who lives on the streets of Lahore and works for Mahbub Ali, a Pashtun horse trader. He later befriends an aged Tibetan lama, accompanies him on his journey along the Grand Trunk Road, learns about the Great Game, and is eventually recruited by Mahbub Ali, who works for the British Secret Service in their quest to extend influence in both Afghanistan and Tibet.Whether or not the Great Game—the expression used by British imperialists to describe the perceived expansion of Russian influence in Afghanistan, Central Asia, and Tibet—actually existed, the fact remains that surveys were undertaken, expeditions mounted, spymasters recruited, and novels written, even as soldiers lost their lives. Taking a cue from Viceroy George Curzon, all pro-establishment papers—from the Civil and Military Gazette of Lahore to The Pioneer of Lucknow, The Statesman of Calcutta (now Kolkata), and The Times of India of Bombay (now Mumbai) concurred that Tsarist Russia posed a real threat to the jewel in Britain's crown. A hundred and twenty years later, historians remain sceptical of Curzon's assertions.Is the hue and cry about the Deep State similar to the Great Game Whether or not it exists, whether it operates in all countries, and whether the 'deep state' of one country is connected with others through the dark web or entrenched corporate interests remains unclear, as the discourse is more ideological than empirical. Sometimes, those who claim to be part of the deep state ascribe to themselves a larger-than-life role in state affairs—for example, AS Dulat and Asad Durrani in their 2018 book The Spy Chronicles: RAW, ISI and the Illusion of Peace. Their claim to be arbiters of one of the most tense and difficult relationships in the region has been widely critiqued by reviewers. The term first gained wide currency in the context of Türkiye as derin devlet, which literally translates to "deep state" in English. In Türkiye, it refers to a non-elected military elite dominating elected governments, especially when they attempt to dismantle the secular foundations of the Republic, established by Mustafa Kemal Pasha after the abolition of the caliphate in 1923. In Pakistan, "deep state" refers to a government controlled by powerful military leaders, as documented by Stephen Cohen in The Idea of Pakistan and Ishtiag Ahmed in Pakistan: The Garrison State. Elected governments in Pakistan have rarely exercised real control over defense and foreign policy.In the US, Democrats and Republicans accuse each other of controlling the 'deep state.' Democrats claim the pro-Republican arms lobby and military-industrial complex constitute the deep state, while Republicans argue that Ivy League universities promote 'wokeism' and diversity, equity, and inclusion narratives that, according to Donald Trump, undermine America's greatness. Trump has accused the deep state within the Democratic regime of election interference, citing the Freedom Medal awarded to George Soros as evidence. However, skeptics argue that if the deep state were so powerful, how could Daksh Patel dismantle it simply by firing 'interns and , associates' whose tenure is co-terminus with that of President Biden Ultimately, the deep state serves as a convenient scape-goat for anything that goes

# Language has mystical powers

**Power** is in the words. Language has mystical powers. I enjoy playing with words. Those words are hot. You can be moved to tears by words. You can find humor in words. Moreover, there are few things that can convey the planet and all its inhabitants as vividly and comprehensively as words. During the 2009 austerity drive of the Congress-led UPA administration, Tharoor embroiled in controversy for his response to a query regarding flying "cattle class" to Kerala. His statement, "Absolutely, in cattle class out of solidarity with all our holy cows!" caused a political storm following his response. Tharoor, an accomplished writer of numerous best-selling books on Indian society and politics, was forced to clarify that he did not want to offend economy class passengers after the Congress party swiftly censured him. After 16 years, Tharoor is now again in trouble for comments he made in an interview. In response to a Malayalam report that he had claimed, "We have many leaders, but many feel that there are no ordinary workers," Tharoor clarified that he had really said, "several workers feel there is an absence of a leader in Kerala's Congress." "You should not think that I have no option to spend my time. I have options," Tharoor added earlier in the interview. I have speeches, books, and invitations to speak all around the globe. Some saw his comments as a covert signal to the highest levels of Congress that he was thinking about other political paths. Amidst the upcoming Assembly elections in the state next year,



Tharoor is now facing accusations of "crossing the line" from the top leaders of the Congress's faction-ridden Kerala unit, putting him in the center of a maelstrom. Because of this, Shashi Tharoor has been named this week's ThePrint Newsmaker. Actually, Tharoor's essay praising the new industrial policies of the Left-led Kerala government had already been a hot topic before the interview controversy erupted. Tharoor had stated that, during the course of 18 months last year, Kerala's startup ecosystem was valued at an astounding \$1.7 billion, which is five times higher than the worldwide average for the same time period. While the fact that this change has started happening under an LDF government run by communists is shocking, it is not totally unexpected. "The path to growth and prosperity for their people lies in capitalism, entrepreneurship, and initiative, not in red flags, strikes, and agitations," he said in the post, comparing the Communists

in Kerala to their West Bengali counterparts at the turn of the century. While he disagrees that the state's industrial climate has changed generally, Tharoor defended himself by saying that "when something good emerges, even if only in one area, it is petty not to acknowledge it" in response to attacks from Kerala Congress officials over the piece. Tharoor, a former UN diplomat, has had a tumultuous political career with the Congress since his 2009 victory in the Lok Sabha elections

Thiruvananthapuram constituency. Mostly because he had a habit of saying things that went against the party line. However, he consistently gets himself into problems by more than simply his words. In 2009, as the UPA was implementing its austerity measures, Tharoor and then-External Affairs Minister SM Krishna came under fire from the government for allegedly residing in a five-star hotel in Delhi while their official quarters were still being prepared. Tharoor lost his position in the Manmohan Singh government's council of ministers in 2010 due to the scandal surrounding the sweat equity provided to Sunanda Pushkar, his then-girlfriend and laterwife, by a consortium that owned the Kochi club of the Indian Premier League. His ordination as a junior minister was renewed in 2012. Tharoor was thrust into his gravest professional crisis in January 2014, when Pushkar was discovered dead in a luxurious Delhi hotel.

He was initially charged with murder by the Delhi Police, but in 2021, a local court found him not guilty. Tharoor disproved the idea that he was merely an elite figure without popular support by obtaining substantial electoral support despite dealing with several challenges. "I was a supporter of the Swatantra Party when I was a student because of its social liberalism and freemarket economic views. After it fell apart, I couldn't find a way to express my ideas within the party system. I stayed outside of politics until the post-liberalization era produced a Congress that was drastically different from the statist Congress I had opposed in the 1970s and early 1980s," Tharoor wrote. In the book, Tharoor criticises almost every member of the Gandhi family, including Indira, Rajiv, and Sonia. In his analysis of Indira, he concluded that while she was adept at gaining and keeping power, she was utterly unable to use it for greater good. Aside from the catchy campaign slogans, she lacked a genuine platform or vision. To Indira Gandhi, he referred to Sanjay in the book. He described Sonia as "a builder's daughter from Turino.

Swamy had written to the Election Commission about it and informed Nadda about it in a letter dated 6 February 2024. Within two weeks, the BJP national convention amended the party constitution, authorising the parliamentary board to make decisions about the president – including the term and extension - in emergencies. Incidentally, the party never officially announced the decision. Going by this reported amendment, the parliamentary board had the power to give another extension to Nadda beyond 30 June. Only that nobody seems.

# Illicit Foreign Funding: Secret Weapon Advancing a Radical Islamist Agenda in UK

Prior to the UK general elections, a media investigation revealed that five of the six major British political parties had taken illicit foreign funds. To minimise excessive foreign influence, British legislation compels parties to refund unlawful donations within 30 days and disclose any failures to the Electoral Commission. Only people on the electoral roll can make donations, with a minimum limit of £500. However, the Bureau of Investigative Journalism discovered that the Conservative Party, Reform UK, Liberal Democrats, Green Party, and Scottish National Party failed to prevent or identify these donations, which were made through an assortment of modest payments totalling more than £500 from a foreign source. As per the report, only the Labour Party successfully blocked such unlawful donations. Election law expert Gavin Millar criticised the self-policing method as ineffective and illogical because it relies on beneficiaries to enforce the law. Concerns had grown in the run-up to the 2024 UK general election about foreign players funding political non-governmental organisations (NGOs). Despite precise laws deliberate to prevent excessive foreign influence, some NGOs with significant influence in UK politics have evidently received large amounts of funding from international sources. These contributions, which are frequently routed through intricate channels to avoid detection, undermine the integrity of the democratic process and threaten to influence election results in favour of foreign interests. The current legal system, which relies mainly on self-policing, is

deeply inadequate, allowing foreign funders to have hidden power over British politics. Several controversial groups in the British community receive funding from ambiguous sources, which they utilise to spread their propaganda and operations throughout the country. One prominent example is the Muslim Council of Britain (MCB), an umbrella group that represents over 500 interconnected mosques and Muslim organisations. MCB has a notorious history of sponsoring and supporting extremist actions, prompting consecutive British administrations to adopt a "non-engagement" stance with the organisation since 2009. Notably, the MCB backed a declaration in Istanbul calling for jihad in reaction to Israel's activities in Gaza and backing Hamas attacks on foreign forces, possibly involving British

Another outfit of concern is the Hizb ut-Tahrir, which is secretively operational in the UK despite being banned in many countries due to its disruptive ideology and links to terrorist acts.

Hizb ut-Tahrir has been accused of radicalising young Muslims and pushing for the formation of a global caliphate through non-democratic means. Its financing roots are opaque, leading to suspicions of foreign financial aid intended to destabilise communities. Islamic Relief Worldwide, headquartered in the United Kingdom, has been accused of supporting terrorist entities, especially Hamas. The organisation denies these allegations. However, both Israel and the United Arab Emirates have blacklisted Islamic Relief Worldwide over concerns about the misuse of charitable.




# Union Minister Prof. S.P. Singh Baghel Pays Reverent Visit to Maa Bhadrakali Shaktipeeth in Kurukshetra

# Google under CCI investigation over gaming firm

Delhi: India's Google regulatory issues are growing. In 2022, the Competition Commission of India (CCI) fined the US tech giant for abuse of dominant position in its Play Store and Android mobile device ecosystem. Now, the fairplay regulator is investigating a complaint filed by gaming company WinZO. CCI directed its investigation arm to investigate and report within 60 days after finding a prima facie case. "Based on the facts and circumstances of the case, the commission believes Google is in violation and justifies further inquiry. The CCI bench, chaired by Rayneet Kaur and members, ordered the director general to investigate. A Google spokesman declined to comment. WinZO, an online gaming company, claimed that Google's Play

Store prohibits Real

restrictive policy, all apps offering real money games of skill are only available for download from their website (a process called sideloading)," it told CCI. On Android devices, using this process to reach WinZO displays a disclaimer/warning, tarnishing its image. WinZO stated warnings are without validity and "completely illegal" and cost the company. It also claimed Google displays another "baseless warning" when users pay for skillbased games. "Such payment warnings are arbitrary as Google has not set any criteria for displaying them," WinZO complained to

#### **Private Equity and Venture** Capital investments surge 156% year-on-year in November

**NEW DELHI:** Private Equity and Venture Capitalist funds invested \$4 billion in November, according to a joint report by IVCA and EY released on Wednesday.

This shows a 156 per cent year-on-year increase while a 15 per cent decline from the previous month. The month recorded 87 transactions, up 47 per cent from 59 deals in November 2023. "While 2024 had started off on a strong note, geopolitical tensions, uncertainty over US elections outcome, and inflation weighed on the markets, as did the bid-ask spread between seller expectations and buyer valuations," EY's Vivek Soni said. He further said that pure-play PE/VC investments showed significant growth, reaching \$3.5 billion in November, representing a 297 per cent rise from \$873 million in November 2023, and a 27 per cent increase from \$2.7 billion in October 2024, Soni noted.

Investment in real estate and infrastructure decreased by 20 per cent compared to the previous year, settling at \$566 million in November 2024.

The largest investment category was buyouts at \$1.6 billion, with start-up investments following at \$1.1 billion. By sector, industrial products led investments at \$1 billion, whilst financial services and e-commerce followed with \$723 million and \$550 million respectively. November saw 15 exits valued at \$3.7 billion.

#### **News Avatar Can Be Rajghat Power Plant's Entertainment Hub**

Delhi: Gaming zones, nighttime entertainment, water leisure, and retail will replace turbines, coal conveyor belts, and soot-lined chimneys. Delhi Development Authority will turn the Rajghat thermal power station, which closed years ago, into a unique recreational destination. The agency is employing an expert to turn the power plant's ruins into an entertainment hotspot in a public-private collaboration. Besides a 5D museum of thermal power plant operations, the new complex will contain shops, food and beverage, gaming, nightlife, children's activities, and water-based amusement. The proposed museum will offer a 5D experience of a coal power station, which is rare for the public. The proposal document states that the site would be open 24/7. Industrial buildings like turbines, coal conveyor belts, clarifiers, a 160-metre chimney, and cooling towers make up the power plant. DDA stated that the project would follow Delhi's Master Plan. All such facilities must be operated and maintained by the applicant according to DDA indicators and criteria. "Besides mandatory components, DDA will provide sufficient flexibility to the concessionaire to incorporate various uses within the project to generate revenues," says the bid form. ## 'EC covering up voter list fraud': TMC's fresh charge

**NEW Trinamool Congress** (TMC) leader Saket Gokhale on Tuesday countered the Commission of India (ECI)'s claims, accusing the poll body of "covering up" the alleged voter list fraud instead of accepting it.

The Rajya Sabha MP claimed the ECI was attempting to brazen out the irregularities instead of accepting "their blunder on the duplicate voter ID fraud issue".

Referring to the parts of ECI's handbook for electoral registration officers, Gokhale alleged that the poll body's clarification was "false", "contradicted which their own rules and guidelines. The TMC leader, in point-bypoint rebuttal to the ECI, voiced concern over duplication of Voter IDs, or EPIC. The EPIC (Electors Photo



Identity Card) number is a unique identification number assigned to every registered voter in India by the ECI. It is printed on the Voter ID card and serves as proof of identity during elections.

Gokhle, in a post on X, questioned the ECI's claim that EPIC with the same numbers were issued to multiple voters due to certain states using the same alphanumeric series.

Citing the poll body's handbook, the TMC leader said Functional Unique Serial Number (FUSN) are different for every assembly constituency and that it was impossible for voters in two different constituencies, even in the same state, to have the same first three letters in their EPIC.

"EPIC card numbers are an alphanumeric sequence of 3 letters & 7 digits. The ECI handbook CLEARLY states that the 3 letters, known as a Functional Unique Serial Number (FUSN) are different for EVERY Assembly constituency. Therefore, it is IMPOSSIBLE for voters in 2 different assembly constituencies (even in the same state) to have the SAME first 3 letters on their EPIC.

While 'kalpvas', the monthlong stay of devotees on the Sangam, begins on Monday, the first of the three 'amrit snan', the holy dip by nagas, seers, and akharas, will occur. Over 4 crore people are scheduled to visit in the first two days. The other 'amrit snan' days are'mauni amavasya' on Jan 29 and 'basant panchami' on Feb 3. Jan 29, the most auspicious day, is scheduled to see around 5 crore holy bathers. On February 12, 'maghi purnima' will conclude 'kalpvas' The largest religious festival ever has been made possible by renovating over 10,000 acres around the Sangam and adding eight permanent ghats to the temporary ones. Over 1.6 lakh tents have been set up to house devotees in the mela region, which is now the state's 76th district and a no-vehicle zone till Tuesday. DM, Maha Kumbh Mela, Vijay Kiran Anand, said devotees will receive flowers on main snan days per the CM's orders. The 'amrit snan' begins at 6.15am with the seers of Shri Panchayati Akhara Mahanirvani and Sri Panchayathi Atal Akhara taking a holy dip at Sangam. Eleven more akharas will follow until 4.20pm. Their scheduling is such that one akhara would reach the Sangam nose, which has been extended by 2 hectares to accommodate 2 lakh more devotees, after the preceding group leaves. Railways would run 10,100 regular and 3,134 special trains to serve pilgrims during Mela for two months. UPSRTC will deploy nearly 7,000 buses, including 350 fair-specific shuttle buses. Pilgrims can easily reach Prayagraj from UP and beyond via this large bus network.

Delhi: Winter has ended early in north India and Delhi is set to be among the three warmest in the last 15 years. So, does the early conclusion of winter indicate a long and scorching summer ahead? Contrary to the general view, data from past years shows that a warm Feb doesn't necessarily lead to a searing summer in north India. Analysed monthly average maximum temperatures in north India since 1971 and picked the 10 warmest months of Feb during this period. In five of these years, the corresponding months of April were indeed warmer or significantly warmer

other five, April temperatures were either close to normal (four years) or below normal (one These two months were chosen for the analysis because Feb is the last month of winter in north India, while April marks the beginning of full-blown summer conditions in the region. March is usually a month of transition."There is no direct one-to-one relationship between temperatures in Feb and April. This year, however, we have a weak La Nina that's not expected to influence temperatures," Mohapatra said.
