Pahalgam horror caught on cam: Zipliner inadvertently records terror attack

NEW DELHI: A video has surfaced from Jammu and Kashmir's Pahalgam, captured during the terror attack on April 22 that left 26 people dead. The footage shows a tourist ziplining across the scenic valley, smiling and recording his experience, seemingly unaware of the violence unfolding below. However, in the video the operator can be heard saying, "Allahu Akbar" before pushing the man on the zip line. Gunshots can be heard in the background of the video, even as Bhatt continues his ride across the landscape. At the same time, terrorists opened fire on a group of tourists at the popular Baisaran meadow, turning a day of leisure into a scene of tragedy. has not verified the video independently. The terrorist incident occurred in the Baisaran meadow of Pahalgam area, situated near the popular tourist destination in Jammu and Kashmir. This attack stands as one of the most severe incidents in the region since the 2019 Pulwama incident, which claimed the lives of 40 Central Reserve Police Force (CRPF).

Haryana Government constitutes Seventh State Finance

The Haryana Government has constituted the Seventh State Finance Commission to review and recommend the distribution of financial resources between the State, Panchayati Raj Institutions (PRIs) and Urban Local Bodies. Former Chief Secretary of Haryana, Shri Sanjeev Kaushal has been appointed as the Chairman of the Commission, while IAS officer Shri Anshaj Singh

will be its Member Secretary. Other members will be appointed later. A notification in this regard has been issued by Chief Secretary Shri Anurag Rastogi. The Commission will recommend principles for distribution of taxes, duties, cesses and net proceeds of taxes between the State Government and Zila Parishads, Panchayat Samitis and Gram Panchayats. It will also state which taxes and duties may be assigned to or collected by the

Panchayati Raj Institutions. Apart from this, the Commission will also recommend on grants to be given to PRIs from the Consolidated Fund of the State and measures to improve their financial position. Similarly, the commission will also make suggestions regarding urban local bodies, including distribution of taxes and levies between municipalities and the state government, identifying taxes assignable to municipalities.

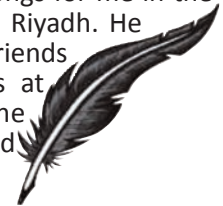
It aspires to make local Saudis understand better

The presence of women in the workforce has also meant increased intermingling of genders and rewriting of many social norms and gender behaviours. A big focus of Vision 2030 is also the cultural and social integration of all those living and working in Saudi Arabia. The Media Ministry's Global Harmony project is aimed at enhancing understanding and collaborations between diverse groups that call Saudi home. According to the Saudi Deputy Minister of Media, Dr Khaled Bin Abdulqader al Ghamdi, the Global Harmony project aims to make expats feel more at home. But more than that, it aspires to make local Saudis understand better the various communities that live among them. So, during the Riyadh Season, which starts in September and continues till February-March, you see a host of public cultural and social events to bring communities together. It's a true celebration and appreciation of diversity. Even among the expats, special attention is on Indians, who are the largest expat group in Saudi Arabia. At present, 2.6 million Indians live in the Kingdom, working in the domestic sector as well as private jobs, and running both start-ups as well as big companies. Recognising the role of India, Dr Khaled calls the community "an integral part of the Saudi story". This year, the Media Ministry dedicated the Suwaidi Park festival exclusively to India. The 10-day festival saw a celebration of Indian culture, food, music and art. People from all communities streamed into the vast Suwaidi Park to savour a slice of India. The Global Harmony project attempts to present Saudi as an inclusive and harmonious society where people from all backgrounds live and celebrate their own cultures, traditions and festivals. And, it's not some civil society gig. It's a government policy initiative with clear objectives and plans.

That makes it an attempt worth emulating for many countries that are facing social fissures due to their diversity. As Saudi strides into modernity, it is also conscious of its history and heritage. It's encouraging studies and excavations at heritage sites, such as at al Ula, and is promoting its pre-Islamic history too. Nouf Marwaai, a yoga instructor .

and also a consultant with the Saudi government, gave us a presentation on the historical and social similarities between India and Saudi Arabia. In her talk, she went back to 6000 BCE to trace the Almagar Civilisation. Clearly, the new Saudi Arabia projects itself as an old civilisation, and not just as a society defined by the advent of Islam 1,400 years ago. That is now portrayed as only an important event, not the sole marker of the civilisational identity. The Kingdom is also promoting its historical sites. The Diriyah town, just outside Riyadh, is one such heritage site that has a UNESCO tag. It was the home of the Saudi royal family and also served as the capital of the Emirate of Diriyah under the first Saudi dynasty from 1744 to 1818. Today, Diriyah is one of the foremost cultural hubs and the centre of many sports and adventure activities in the Kingdom. Even so, its historical character has been maintained all along. On the one hand, you have mega infrastructural projects, new businesses and modern wave sweeping Saudi, and on the other, there is a renewed focus on its over 1,400-year-old history. Coming back to the India connect: wherever there are Indians, there is music. Indian film music has been a great brand ambassador and unifier across the world. Saudi Arabia is no different. My local support, Abdulwahab al Ghamdi, a young, peppy guy in his late 20s, played Hindi songs for me in the car while we drove around Riyadh. He told me that he and his friends dance to Punjabi numbers at their parties. And how he loved Shah Rukh Khan and Indian film music.



Muslims want waqf reforms too. It’s not an issue for political acrimony

For waqf administration. In fact, some Islamic nations do not have waqf institutions at all. It is rather unfortunate that acrimonious divisions within the parliamentary committee marred the tabling of the report in Parliament. While a certain degree of politicisation is natural in a parliamentary democracy during any law-making exercise, the underlying values of non-partisan deliberation, consensus-building, and effective communication between ruling and Opposition parties are essential for advancing the national interest. As such, these values must inform the

future parliamentary course of action on the waqf reforms. **Data** from the Centralised Public Grievance Redress and Monitoring System (CPGRAMS) from April 2022 to March 2023 further reveals that out of 566 complaints received, 194 related to illegal encroachment and transfer of waqf land, while 93 were against waqf officials and mutawallis. Moreover, an appraisal of the functioning of waqf tribunals reveals that 40,951 cases are currently pending, of which 9,942 have been filed by Muslims themselves against institutions managing waqfs. In addition, there are inordinate delays in

the disposal of cases, and there’s no provision for judicial oversight of tribunal decisions. Over the years, a number of issues pertaining to mismanagement have come to the fore—delays in registration of waqf properties, waqf boards fetching rents below market value, rampant encroachments on waqf land, denial of inheritance rights of widows, non-completion of surveys by survey commissioners, and slow progress in digitisation of waqf property records. Many such issues have been extensively reported in the media from time to time. The proposed reforms also contemplate representa-

tion for underrepresented and deprived Muslim groups, including women and Pasmandas. The idea is to make state waqf boards and the Central Waqf Council more diverse and inclusive. Not only will such a measure lead to sociological diversity and gender balance within these institutions, it could also reshape the political interaction of the Muslims with the BJP. Further, the proposal to include non-Muslim members who bring technical expertise in waqf administration should not trigger anxiety within the community, provided such representation does not erode the community’s primacy .

A frustrated Zelenskyy dismissed the Riyadh talks

Marco Rubio met the Russian delegation headed by Foreign Minister Sergey Lavrov in Saudi Arabia, to discuss peace. Ukraine was not invited. Putin—who had been shunned by the US and its allies since the invasion of Ukraine—was delighted. A frustrated Zelenskyy dismissed the Riyadh talks as worthless. Trump did not like those comments and called the Ukraine President a dictator, even accusing him of starting the war. Zelenskyy said the US President was living in a Russian-made “disinformation space”. This infuriated Trump, who does not take kindly to any criticism. The proposal has been dismissed by Russia, which currently has about 600,000 troops in Ukraine. But even Britain and France, with much smaller armies than Russia, can’t send troops to Ukraine without some backup from the United States. And that looks unlikely, for now. Trump’s Ukraine envoy, General Keith Kellogg, who visited Kyiv and met Zelenskyy on Thursday, said all options must be open to deal with the outcome of peace talks. But he knows that any decision to provide any US military cover will be made by Trump who looks less inclined to do that. He described Zelenskyy as “a modestly successful comedian” who “talked the United States of America into spending \$350 Billion, to go into a War that couldn’t be won, that never had to start, but a War that he, without the U.S. and ‘TRUMP,’ will never be able to settle.” Trump’s behaviour towards Zelenskyy is in stark contrast to Biden’s, who had backed Ukraine against Russia with all the possible military and financial



aid. President Biden travelled to Ukraine many times since the Russian invasion in February 2022 to display his administration’s full support. He also promised NATO membership to Ukraine at a future date. Russia was severely punished for invading Ukraine. The US joined hands with its allies to isolate Moscow. Russia faced tough sanctions and its assets in the West were seized. The International Criminal Court issued an arrest warrant against Putin for alleged war crimes in Ukraine. There were even plans to put Putin and his close allies on Nuremberg-style trials. Until a year ago, Ukraine’s leader was talking about even liberating all its territory, including Crimea, which Russia annexed in 2014, with the help of Western military equipment. Ukraine even succeeded in occupying the Russian territory of Kursk, which it had thought would be used as a bargaining chip during negotiations with Moscow. But all that now looks like a distant dream. With Trump back in the White House, Ukraine fears that Russia will be allowed to keep all the occupied territory as part of the deal to end the war. Kyiv is now likely to be denied NATO membership. That could be a promise to Russia to end the war. The US under Trump has

now even opposed calling Russia an aggressor in a G-7 statement being prepared to mark the third anniversary of the war. The US team removed the phrase from the first draft, which was prepared by Canada, the current holder of the group’s presidency. It is not just Ukraine, America’s European allies are also now nervous about the intent of Trump. Since the Second World War, they enjoyed the US security umbrella under NATO. But now they are unsure if the US under Trump will honour Article 5 of the NATO, which is triggered when a member state comes under attack. It implies that an attack on one member is an attack on all. There is even fear in Europe that Donald Trump may sign a deal with the Russian leader Vladimir Putin that will lead to the withdrawal of US forces from Baltic states and effectively kill the NATO alliance. That could be similar to the non-aggression treaty signed by the Soviet Union and Nazi Germany on August 23, 1939, sending shockwaves to other European countries and prompting Hitler and Stalin to annex neighbouring countries. It is another matter that Hitler invaded the Soviet Union two years later, putting an end to the treaty. European members of NATO may call them-

selves major powers, but they can’t match Russia’s military might without US support. Even after losing more than a hundred thousand men and lots of military equipment in the Ukraine conflict, Moscow remains a strong power, mainly because of its nuclear arsenal. So Why Has Trump Changed The Narrative? Trump has always been an admirer of strongmen like Putin. Even during his first term, he developed a rapport with him. He also dislikes Zelenskyy, whom he sees as more of a roadblock in ending the Ukraine conflict. As a former businessman, Trump sees things from the perspective of profitable deals. Western sanctions have hit Russia, but American companies have also suffered business losses, running into billions of dollars. He would like to reverse that. And despite Ukraine’s resistance, Trump believes Zelenskyy will have to give access to critical minerals in return for any future US support. Some in the Trump administration suggest Kyiv should provide Americans with those minerals in return for the US military and financial aid already received by Ukraine. Trump has blamed European leaders for not doing enough to end the Ukraine war. He has also complained for a long time that Europe has lived off the US for too long and it must pay for its security. Europeans have increased their defence budgets but not enough to survive without US support. In the face of changing US policy under Trump, European leaders are working on a plan to guard against a Russian attack. This involves a proposal to deploy tens of thousands of peacekeeping troops in Ukraine. The proposal has the support of

Britain and France and is in response to Zelenskyy’s request of 100,000 troops. But the idea doesn’t have wider support in Europe. Germany, another big power in the continent. Donald Trump has spent only a month in his second term as the US President. However, he has disrupted the international order, weakened the Western alliance and created a sense of insecurity and uncertainty among its members, surprising even some of his supporters. There has been a paradigm shift in US foreign policy under Trump. He is now closer to Moscow than Washington’s traditional allies. He has embraced the Kremlin’s narrative on Ukraine and has sidelined US allies. Although senior members of the Trump administration have denied that the US has abandoned Kyiv and ignored its European allies, Trump himself has not made any serious attempts to pacify Ukrainians and Europeans. His closeness to Russia has been on display since he talked for 90 minutes on the phone with Russian leader Vladimir Putin, in which they agreed to start negotiations to end the Ukraine war, which will mark its third anniversary on Monday. Trump did speak to Zelenskyy soon after that call with Putin, but a nervous Ukrainian President warned that excluding his country from the talks would be “very dangerous”. Events after that only made Ukrainians feels sidelined. Trump’s Vice President, JD Vance, met European leaders in Munich two days later. But his comment that Europe will not be included in the peace talks only helped fuelled the speculation that they were being left out of the future of Ukraine

Will Bihar Pay Attention This Time?

In this context, many questioned whether Modi was in Bihar trying to test the ideological limits of the BJP. "Those who believe in jungle raj hate our heritage and our faith," he said, slamming the opposition for "abusing" the current Maha Kumbh of Unity. He stressed that more individuals had bathed at the Kumbh than lived in Europe. Anyone who finds fault with the Ram temple will seize the chance to criticize the Maha Kumbh. He made it clear that someone who disrespects the Maha Kumbh would never be forgiven in Bihar. Lalu Prasad Yadav caused a stir last week when he criticized the Maha Kumbh Mela, claiming that it was "meaningless" and placing the responsibility on the Railways for the 18 lives lost in the stampede. The people who disagreed with Maha Kumbh weren't limited to him either. In addition, Akhilesh Yadav, leader of the Samajwadi Party (SP), offered Yogi Adityanath and himself a book based on a Harvard University research on Kumbh Mela management that they had commissioned in 2013. The oppo-

sition has brought up the problems of the January 29 stampede, the filthy water, and the enormous number of worshippers at the Mela on multiple occasions. Mamata Banerjee, chief minister of West Bengal, used the moniker "Mrityu Kumbh" to emphasize the gravity of the events. Despite the Opposition's nasty campaign, devoted Hindus were unconvinced. In spite of all the negative feedback, a staggering 62 crore people made the journey to the Sangam to take a sacred dip, proving once and for all the spiritual importance of Maha Kumbh. Leading the criticism of the Ganga holy plunge was Congress President Mallikarjun Kharge, who said it was "not good enough to remove poverty." By sending his family to the Sangam for a holy plunge, Karnataka Deputy Chief Minister D.K. Shivakumar set an example for believing Congress lawmakers. Seen on X alongside him were digvijaya Singh, abhishek Singhvi, and Sachin Pilot, all prominent figures in the Congress party. Members of the Gandhi family have a long history of participating in the Kumbh Mela.

Anywhere between Rs 800 and Rs 2,000, depending on the quality of violation. Indian women have been failed, yet again, by a new trinity: The holy, the unholy, and the algorithm. Last week, 13 FIRs were lodged against 140 social media accounts for posting objectionable videos of women, including those of female devotees taking a dip at the Kumbh. The bathing videos came to light during a separate investigation by the Ahmedabad Cyber Crime Police into videos sourced from a Rajkot hospital’s gynaecology department. The investigation revealed that the three accused—Prajwal Taili, Praj Patil, and Chandraprakash Phoolchand—ran at least 22 Telegram channels where they sold clips of women, recorded and traded without their consent. The three men, a YouTuber from Prayagraj and two NEET aspirants from Maharashtra, ran their enterprise under an innocuous name “Megha Demos Group”. The channels, with labels like “CCTV Injection Group”, “Labor Room Injection Group”, and “Ganga River Open Bathing Group”, turned these transgressions into a menu of options. “Disturbingly, some content featured covert recordings from hospital labour rooms, medical examinations, and public areas like bus stands, marriage halls, and par-

lours,” cyber crime officers told The Times of India. This lucrative venture raked in Rs 8 lakh a year. To the credit of UP Police, their social media monitoring team has moved swiftly, and identified 15 more accounts across Facebook, YouTube, and Instagram participating in this ecosystem of exploitation. The state government has now banned cameras at bathing ghats, deploying CRPF and state police personnel to enforce this prohibition. In 2019 too, the Allahabad High Court had banned the publishing of photos and videos of women at the Kumbh Mela: “The court said no pictures of women bathing or taking a holy dip should be shared. It also warned that action would be taken if the order was broken. This rule applies to both print and visual media.” This violation and commodification of women’s bodies at the Maha Kumbh represents a betrayal across three interconnected spheres. It’s not as if Indian women are unfamiliar with such trespasses—that’s our daily reality. But the Kumbh videos expose a particularly perverse intersection of faith, trade, and technology. First, there is the sacred:

In a space of spiritual liberation, the crowd provides both cover and target for predators. Elaborate systems. at Indian temples and other places of worship prevent photography to protect idols and deities. Those regulations don’t extend to the bodies of women who show up at these sites. Then comes the betrayal by the profane, a carefully constructed marketplace where every assault is catalogued, priced, and traded. What’s most chilling about the Kumbh videos is the clinical efficiency of their distribution. The “Megha Demos Group” operated with the precision of a tech startup, complete with a freemium business model.

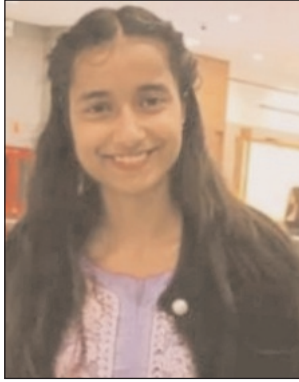

Rural Mushroom Processing Units Face Major GST Crisis Over HSN Code Dispute

Jasbir Singh Duggal Kurukshetra: The Directorate General of GST Intelligence (DGGI), under the Ministry of Finance, has issued Show Cause Notices worth ?105 crore to several mushroom processing units across North India. The notices cite misclassification of HSN codes, particularly between HSN 0711 (vegetables preserved temporarily, not ready for immediate consumption) and HSN 2003 (vegetables prepared or preserved for immediate consumption). At the core of this dispute lies the canned button mushroom, a key product in the sector. According to a comprehensive report by NIFTEM, canned mushrooms are not immediately consumable and



thus fall under HSN 0711, which attracted 5% GST until December 31, 2018, and 0% thereafter. However, authorities are now seeking to reclassify them under HSN 2003, which carries a higher GST rate, resulting in retrospective tax demands over the past seven years. Industry stakeholders have strongly opposed

this move, terming it technically flawed and financially disastrous. They warn that reclassification would render imported mushrooms cheaper than domestic produce, harming Indian farmers and processors. The mushroom sector plays a vital role in rural livelihoods, especially during peak harvest times when it helps reduce

spoilage and provides income stability to farmers. For example, in the last financial year, association members purchased 4,000 tons of mushrooms directly from farmers, along with similar volumes of sweet corn and baby corn, showcasing the sector’s critical role in strengthening the agri-supply chain.

Indian Current Account Surplus After Last Quarter Deficit

According to CRISIL, India’s current account surplus improved to \$5.7 billion in the fourth quarter of fiscal year 2025, or 0.6% of GDP. This is a considerable improvement from the \$8.7 billion deficit (1.0%) in the third quarter and the \$1.3 billion deficit (0.2%) in the fourth quarter of the previous fiscal year. The current account balance improved due to a shrinking merchandise trade deficit, an enhanced services trade surplus, and rising remittances. Financial flows improved quarterly and annually, resulting in a \$30.8 billion foreign exchange reserve accretion in the fourth quarter, the biggest in ten quarters. India’s foreign reserves reached \$652.9 billion on June 24. From the third quarter’s 1.0% deficit, India’s current account surplus rose to 0.6% of GDP in the fourth quarter. The trade deficit fell to 0.9% of GDP from 2.7% the quarter.

Delhi : A new treaty finalized by members of the World Intellectual Property Organization (WIPO) requires patent applicants to reveal the nation of origin or the source of genetic resources if the claimed invention is derived from those materials or related traditional knowledge. One of the main demands of the developing world, led by India, is the treaty that will offer extra protection for Indian genetic resources and traditional knowledge, including yoga, siddhi, and ayurveda. The agreement was finalized by the Geneva-based agency that is in charge

of developing regulations pertaining to patents and trademarks. This will force some nations to revise their domestic laws. Rather than trying to register patents to take advantage of the immense traditional knowledge and genetic resources, India has asked that the world's largest corporations give credit to these resources. Even while there is protection against misappropriation in India and other nations without disclosure requirements, the disclosure standards will offer protection internationally. Currently, there are dis-

closure requirements in 35 countries, the majority of which are voluntary and lack the necessary legal framework to be implemented successfully. For the first time, the knowledge and wisdom that have long underpinned economies, civilizations, and cultures will be recognized by the WIPO treaty on intellectual property, genetic resources, and related traditional knowledge. These resources are now part of the global intellectual property system. "As a source of traditional knowledge and wisdom and a reservoir of biodiversity, India has championed.

Rs 91,000/10gram: Gold hits historic high ahead of wedding season

NASHIK: The price of yellow metal breached a historic mark - Rs 91,000 per 10 gm - ahead of the wedding season. Traders in Nashik and Jalgaon in Maharashtra anticipate further price escalation in the coming days. Jalgaon continues to attract buyers from across Maharashtra,

Gujarat, and MP due to its reputation for ensuring gold purity and exceptional craftsmanship. Sushil Bafana, a Jalgaon-based jeweller, said: "The market rate for 10gm gold on Saturday was Rs 91,052, including tax. On Friday, it was 91,600. The market price is responding

to international developments, including the US action on trade. Even today, many people consider gold the best investment option." The fierce competition amongst Jalgaon jewellers benefits customers, ensuring high-quality products at competitive prices.

Redeveloping railway stations opens Rs 30,000 cr in business opportunities

Delhi: EPC companies are expecting Rs 30,000 crore in business from contracts to redevelop/revamp railway stations in the next two years. The Railways have sanctioned 1,318 station redevelopment/revamps, which Icria Ratings estimates will provide Rs 30,000 crore in commercial potential for EPC firms over the next two years. The government previously planned most station renovation projects as public-private partnerships, accounting for 12% of the national asset monetisation pipeline target. However, due to pricing restrictions, real estate development market risks, and a lack of PPP experience in railways, the government reallocated station redevelopment work to the EPC mode in December 2022 and increased the budgetary allocation by more than seven times from Rs 2,159 crore in FY23 to Rs 15,511 crore in FY25. Railway station rehabilitation offers EPC businesses Rs 30,000 crore in business potential due to intense competition in traditional segments like roads and buildings, according to Vinay Kumar G of the agency. In the past two years, station redevelopment project awards have seen modest competition, with maximum discounts of up to 18% and a median discount of up to 4%, similar to other railway EPC projects with a median discount of up to 5%. UP has the most stations being redeveloped at 149, followed by Maharashtra at 126, Bengal at 94, Gujarat at 87, Bihar at 86, Rajasthan at 82, and MP at 80. Foundation stones have been set for 553 stations, and nearly Rs 20,000 crore has been given for station redevelopment.

Over 1.6 crore Jio subscribers leave in four months

Delhi: At Reliance Jio Infocomm Ltd., India's largest telecom operator, approximately 1.65 crore subscribers have dropped in the past four months. Reliance Jio lost 37.6 lakh mobile users in October, 79 lakh in September, 40 lakh in August, and 7.58 lakh in July.

District Courts receive instructions to facilitate smooth case

Delhi: Delhi High Court directed the national capital's district courts to follow a number of guidelines to guarantee that video conference equipment functions properly during court sessions.

The Delhi High Court's Acting Chief Justice Manmohan issued the following directives. The video conference must remain active throughout court hours. At the court end, the video will be turned on. According to the office order of June 5, 2023, it will be made sure that the video conference at the court's end won't be kept silent unless the court orders otherwise. According to the office order of June 5, 2023, it will be made sure that the



video conference is not locked and that litigants, counsel, and members of the public can all attend without difficulty, unless the court orders differently. Each Court is required to make certain that the item number is visible throughout the video conference.

Every court must make sure that, in accordance with Office Order of June 5, 2023, a message appears on

the video conferencing screen when the court retires, is not in session, is on leave, or when instructions are given to restrict the proceedings. According to the ruling, the Principal District & Sessions Judges are required to provide a report on the video conference to the Registrar General's office of this Court using the stipulated format.

Led by senior leaders including AICC Bihar in-charge Krishna Allavaru, state Congress chief Akhilesh Prasad Singh, and Kanhaiya Kumar, the march began in West Champaran's Bhitiharwa, the site of Mahatma Gandhi's historic ashram. Youth

and student volunteers of the party are set to cover multiple districts before reaching Patna. 'No jobs, no future?' Speaking at the launch, Congress leader Kanhaiya Kumar took a sharp dig at the ruling NDA in Bihar, blaming it for failed employment policies. "Every exam gets leaked or stuck in court battles. Even those who manage to get jobs, like government teachers, are denied pension benefits their seniors enjoyed," he said. Accusing the government of using communal politics as a distrac-

tion, Kumar added, "When a government fails to provide education, healthcare, and jobs, it fuels division in society." Studies show polluted air increases Type 2 diabetes risk

Delhi: Air pollution may increase Type 2 diabetes risk. Air pollution, especially PM2.5, is known to cause chronic lung ailments, heart attack, stroke, and cancer, but the diabetes argument is gaining ground. Several research from the US, Europe, and China have shown the association, but a new two-city study from India found that even a 10 g/m3 increase in PM2.5 exposure raises blood sugar. Mumbai-based JAPI (Journal of Association of Physicians of India) published an editorial headlined, 'Air Pollution: A New Cause of Type 2 Diabetes?' this month. Diabetes specialist Dr. V Mohan from Chennai wrote, "We now know that PM2.5 is an endocrine disruptor that affects insulin secretion and also leads to insulin resistant." Due to summer, the air quality index has been low in recent weeks, but air pollution is becoming one of urban India's largest problems, killing 20,000 in Mumbai and 50,000 in Delhi annually. Dr. Mohan and Public Health Foundation of India researchers published the first PM2.5-diabetes study a few months ago. 'BMJ Open Diabetes Research & Care' found links between short-, medium-, and long-term PM2.5 exposure. "A 10 g/m3 increase in monthly average exposure to PM2.5 was associated with a 0.4 mg/dL increase in finger pick blood test and a 0.021 unit increase in HbA1c test," claimed the study. The HbA1c blood test measures blood sugar over three months. The study followed 12,064 Delhi and Chennai people for seven years. A hybrid satellite-based exposure model and ground data were used to track PM2.5 concentrations daily. At follow-up visits, participants' blood sugar was measured. It found that 10 g/m3 of average annual PM2.5 exposure raised Type 2 diabetes risk by

TN should appeal SC ruling on domicile quota

Delhi: A day after the Supreme Court banned domicile-based reservation in specialized and higher education including PG medical courses, MK Stalin's Tamil Nadu government declared it would file a review petition to vindicate its rights and uphold social justice. Health minister Ma Subramanian said the SC order would affect the state's 69% reservation and quotas for in-service applicants in government medical colleges and minorities in self-financing medical colleges. He said that the order would violate state rights. The Union government receives 15% of undergraduate medical seats and 50% of postgraduate medical and super speciality seats through the state quota each year. "All super spe-



cialty seats were lost. "TN gave government doctors a quota for super speciality courses after a court battle," he told reporters. He stated the Centre takes seats unfilled due to a lack of candidates. He said states invest fully in PG and super speciality medical education but share 50% of all-India quota seats. "Now, the judgment deprives us of all seats," Subramanian told reporters. According to him, the verdict will have a major impact on 2025-26 admissions but not 2024.

Exam centers to get CCTVs from NIOS to reduce malpractices

Delhi: To ensure transparent and seamless assessments, the Board of Secondary Education (BSE) will use AI-powered CCTV cameras and web-casting of the annual High School Certificate (HSC) exam 2024. Pauses, violations of rules, such as logistical issues in storing or distributing ques-

tion papers, cheating, malpractice, invigilator incompetence, or cell phone use in HSC exam centers, can now be identified quickly. The board has strategically placed AI-supported CCTV cameras and web-casting for real-time test hall surveillance. Advanced features in

these cameras can detect strange behavior in the medical room. "The annual matric examination 2024 will be completely hi-tech and technology-enabled to make the process transparent and error-free," stated BSE secretary Nihar Ranjan Mohanty.

India's servers will host DeepSeek's AI models for security

Delhi: The Indian government said it will host Chinese start-up DeepSeek's AI models on its computers to monitor security and safety. The country increased its efforts to give computers to entrepreneurs and researchers to accelerate the development of localized AI 'foundational models' or tech solutions to offset US and Chinese AI developments. IT and electronics minister Ashwini Vaishnaw said the government is buying 18,693 GPUs to provide "affordable compute" to large and growing IT enterprises and AI researchers. Foundation models are AI solutions educated on large datasets to fulfill several tasks. The models are adaptable and can be cus-



tomized for special uses. Vaishnaw noted that DeepSeek was constructed with 2,000 GPUs, therefore the Rs 10,372 crore IndiaAI mission's high-tech GPUs are enough to power India's AI quest. He dismissed concerns about India being late in its AI quest, saying it has US assis-

tance as a valued partner. We are punctual. Computer access is most vital. This is now accessible. We are fit. Getting the computer facility was crucial to the goal." He added India is optimistic Nvidia will provide GPUs regularly despite US government limitations on some countries.

"I'm reiterating that we are seen as a trusted country, we're seen as a country which respects IP rights, (and) we're seen as a country which understands the technological development prospects and all the points related to that." DeepSeek's recent popularity hasn't concerned the government. The good news is that DeepSeek is open source and we will soon host it on Indian servers like we did Llama. Everything open source can be hosted on our servers to ensure data privacy. He said we'll do that soon. Vaishnaw claimed preparations have begun. "The team has worked out the details on how many servers are required, how much capacity is required."

Kerala cuts minority scholarships due to financial difficulties

Delhi: Kerala's government has cut minority community scholarships by 50%, putting thousands of students' education at risk, citing the financial crisis. Nine of the 11 minority welfare scholarship programs originally allotted Rs 13.6 crore are affected by the decision. The Government says the plan size reduction is a priority, but the disproportionate cut to minority student educational support raises questions about governmental priorities and social justice. Twitter shares The Prof Joseph Mundassery Scholarship, which received Rs 5.2 crore this



year, suffered most. It has saved Muslim, Sikh, Jain, and Parsi high-achieving children by paying Rs 10,000 to those who scored A-Plus in all SSLC subjects and Rs 15,000 to those who scored 80% in upper secondary or 75% in vocational higher secondary. It ensured that bright students from underprivileged backgrounds were not forced to drop

out due to financial constraints by prioritizing BPL students and providing provisions to economically weaker APL students. The crucial APJ Abdul Kalam Scholarship for minority students has also been cut in half. Those admitted to government-approved colleges on merit, with priority for BPL families, receive the Rs 6,000 grant.

The government of Maharashtra says it would not pay for eggs for the midday meal

Delhi: The opposition vehemently criticized the decision, as Maharashtra became the latest BJP-ruled state to ban eggs from midday meals for students in grades 1 through 8. The school education department changed the list of foods served during midday meals in a government resolution this week, eliminating the inclusion of sugar and eggs. Rather, it instructed schools to serve nachni sattu or "egg pulao" as optional meals. Nonetheless, it stated that these things, as well as sugar for desserts, had to be organized by the general public without the need for further government support. The state has changed the list to adhere to the meal items prescribed by the Center, accord-



ing to an official who defended the action. While some states use their own resources to offer eggs, the federal government, which provides 60% of the funding for midday meals, does not include them in its list. Goa and Madhya Pradesh recently banned eggs due to criticism from some groups. Aaditya Thackeray, a Sena (UBT) MLA, criticized the move and questioned why the government chose to substitute rice kheer and nachni sattu for eggs and sugar.

Adani cancels \$533mn US port loan in Sri Lanka

Delhi: After US securities and wire fraud allegations, Gautam Adani's Adani Ports and Special Economic Zone withdrew from a finance deal with a US agency for a Sri Lankan port terminal project and used its own resources. After the US indictment, American loans are harder to get. The US International Development Finance Corporation (IDFC) agreed to lend \$553 million to Sri Lanka. 's

IIT Kharagpur teachers petition governors. Restore HoD positions

Delhi: The IIT Kharagpur Teachers' Association (IITTA) urged the institute's board of governors to expunge show-cause notices issued to 86 faculty members, restore their administrative positions, and protect the association's office bearers from arbitrary or retaliatory actions amid the faculty-administration dispute. In September, the IIT Kharagpur teachers' association accused director Virendra Kumar Tewari of "nepotism" and "arbitrary faculty recruitment" in a letter to the Union Ministry of Education, sparking a confrontation. They wanted an academically qualified, inclusive governance-experienced successor. When the administration sent show-cause notices to IITTA office bearers and disciplined them for not answering within seven days, tensions rose. Show cause notices were sent to 86 academic members who signed a petition supporting the IITTA, worsening the situation. The IITTA said several of the 86 academic department heads were replaced. The administration also said people who answered or apologized would not be punished. After an unusual general body meeting the IITTA approached the board of governors. They worry the administration may act fast and deny office bearers a fair hearing, further undermining trust.



What is CBP Home App, launched a week ago, that helped Ranjani Srinivasan flee to Canada?

Ranjani Srinivasan's self-deportation became an advertisement for the newly launched CBP Home app. Secretary of Homeland Security Kristi Noem announced the launch of the CBP Home App on March 10 and on March 11, Indian PhD student Ranjani Srinivasan applied for self-deportation and fled to Canada when ICE agents visited her in her Columbia University accommodation. Her student visa was revoked on allegations of supporting Hamas though she claimed she was not an activist and was not part of any protest group. But as the university informed her that they canceled her enrolment after her student visa was revoked, she found it safe to leave the country on her own.

What is the CBP Home App?
Not a new application, but an overhaul of CBP One and for the oppo-

site reason. CBP One was formerly used to process asylum claims at the southern border. CBP Home was launched for self-deportation. Those who want to leave the country can fill out a form on the app along with their photo in an 'Intent to Depart' statement to the government. The individual will have to provide biographical information, current phone number and also whether he or she has enough money to depart and a valid and unexpired passport. Individuals with no legal status in the US can leave the country and then return again in the future legally through self-deportation. Otherwise, the Trump administration had warned, that they would be caught, deported which will never allow them to return.

Ranjani Srinivasan was not in the US illegally. She came to the US from India as part of

the Fulbright program in 2016 and started her doctoral; program at Columbia University in 2020. She said she was in the fifth year of an urban planning doctoral program at the Graduate School of Architecture, Planning and Preservation, and was supposed to graduate in May. On March 5, her student visa was revoked which made her lose legality on US soil.

"I'm just surprised that I'm a person of interest," she said. "I'm kind of a rando, like, absolute random," she said to NYT from Canada.

Pak minister defends military trial of civilians

ISLAMABAD: A Pakistani minister on Wednesday defended the military trial of civilians, saying that such courts were competent to deal with the cases related to attacks on army facilities. Information minister Attaullah Tarar also urged the opposition Pakistan Tehreek-e-Insaf (PTI) led by Imran to refrain from politicising or disputing the issue of military trials. So, when attacks on military assets occur, the Military Act is enforced," he said while addressing a press conference. Tarar criticised Khan's party for using military courts as a political

tool, aiming to create controversy around them. He clarified that military courts only handle cases involving attacks on defence establishments, citing incidents such as the attack on the Corps Commander's House in Lahore. The minister also criticised the PTI for changing its stance regarding trials of civilians in the military courts, recalling that during Khan's tenure, military court trials were praised. "The statements praising the military courts from PTI's leadership are still available on social media.

Rice shipment from India, first for Yunus government, to arrive today

DHAKA: Bangladesh is set to receive its first consignment of rice imported from India since the formation of the new interim govt even as it looks to be drawing closer to Pakistan than to its immediate neighbour India, which stood beside Bangladesh in 1971 through shared sacrifices. Bangladesh had witnessed ships coming from Karachi twice in recent days. On Nov 13, for the first time since independence, a container-carrying ship sailing directly from Karachi had docked at Chhattogram (Chittagong). This time the ship "MV Tanais Dream", carrying 24,690 metric tonnes of parboiled rice imported from India under the open tender agreement, will arrive at Chaudhagram port at 5.30am on Thursday. This is also the first consignment of parboiled rice



imported from India under the Nov 11 agreement. The unloading of the rice will start soon after samples of the rice are collected and after physical examination, said a senior Bangladesh food ministry official. Talking to diplomatic correspondents in Dhaka recently, Indian high commissioner to Bangladesh Pranay Verma had said he was optimistic about Dhaka-Delhi relationship, despite changes happening around. "But until then, it will be unrelenting," he added. He further continued that "this is about stopping the shooting at assets ... in that critical waterway, to reopen freedom of navigation,



which is a core national interest of the United States, and Iran has been enabling the Houthis for far too long," adding, "They better back off." Earlier on Saturday, Trump announced on Truth Social: "Today, I have ordered the United States Military to launch decisive and powerful Military action against the Houthi terrorists in Yemen. They have waged an unrelenting campaign of piracy, violence, and terrorism against American, and other, ships, aircraft, and drones. To all Houthi terrorists, YOUR TIME IS UP, AND YOUR

ATTACKS MUST STOP, STARTING TODAY. IF THEY DON'T, HELL WILL RAIN DOWN UPON YOU LIKE NOTHING YOU HAVE EVER SEEN BEFORE!" White House national security advisor Mike Waltz further confirmed that the US carried out successful strikes targeting Houthi leadership and infrastructure. "We hit the Houthi leadership, killing several of their key leaders last night — their infrastructure, the missiles. Elon Musk reacts to Democratic Party's favorability dropping to a record low: 'Public is wise'

Elon Musk who once prided in calling himself a Democrat before he turned towards Donald Trump ahead of the election and is now a crucial part of the government reacted to the latest poll which revealed that the Democratic party's favorability rating stands at a record low. In a video shared on X by Congress on, Congress MP from Rae Bareilly said the country's wealth was being concentrated in the hands of a few close to the Prime Minister, while unemployment and rising prices continued to affect millions. "The idea of India is being attacked today. It is being attacked by the ideology of the BJP. The wealth of India is being snatched from the mil-



lions of Indians and being handed over to a few business people, who are close to the Prime Minister and the BJP. Unemployment is spreading. Prices are rising. And this is what the fight is about," LoP in Lok Sabha said. "The fight is about two different ideas of India. The fight is not between two political formations. The fight is to defend the idea of India,"

Gandhi added in the video. the BJP attacked Rahul Gandhi for reportedly spending more time abroad than in his constituency. BJP leader and former Union minister Ravi questioned Gandhi's visit to Vietnam, alleging that he needed to explain his "extraordinary fondness" for the country. "Where is Rahul Gandhi? I heard he has gone to Vietnam," Prasad said.

Seven-year jail term or Rs 10 lakh fine for using forged passport

NEW DELHI: Anyone caught using a forged passport or visa to enter, stay, or leave India could face up to seven years in jail and a fine of up to Rs 10 lakh under the proposed Immigration and Foreigners Bill, 2025. The bill, introduced in the Lok Sabha on 11 March, aimed to streamline immigration laws while tightening control over illegal migration. The legislation, drafted by the Union home ministry, mandated that hotels, universities, hospitals, and other institutions report foreign nationals to authorities to help track overstayers. Airlines and ships arriving in India will also be required to provide advance passenger and crew details at designated ports or places. Under the proposed law,



knowingly using or supplying fraudulent travel documents will attract a minimum sentence of two years, which could extend to seven years, along with a fine ranging from Rs 1 lakh to Rs 10 lakh. Foreigners who enter India without valid travel documents could face up to five years in prison and a fine of up

to Rs 5 lakh. The bill granted the Centre the authority to regulate premises frequented by foreigners. Property owners could be instructed to shut down, impose specific conditions, or deny entry to certain categories of visitors. **Replacing outdated laws** The Immigration and Foreigners Bill, 2025, seeks to

consolidate and replace four existing laws, the Passport (Entry into India) Act, 1920, the Registration of Foreigners Act, 1955, which regulates acquisition and termination of Indian citizenship as well as acquisition and registration of foreigners as Overseas Citizens of India (OCI). Foreigners Act, 1939, the Foreigners Act, 1946, and the Immigration (Carriers' Liability) Act, 2000. The government said that the new legislation simplified and modernised immigration procedures while maintaining national security. An official said, "The Bill will help in tackling the problem of illegal migration into India and facilitate tracking of movement of overstaying foreigners."

After paper leak, RRB moves to computer-based job exams

NEW DELHI: The railway ministry on Wednesday roped in the Railway Recruitment Board (RRB) to conduct all departmental promotion examinations through a centralised computer-based test. This comes a day after CBI arrested 26 officials of the East Central Railway for allegedly leaking papers of a departmental examination and seized Rs 1.2 crore cash during raids. "All zonal railways will make a calendar for the examination. All the examinations will be conducted on the basis of a calendar only," the



ministry said. It added RRB has been given the responsibility after considering its experience of transparent, fair and highly appreciated examinations conducted in recent years. As per the railways, since 2015, more than 7.7 crore candidates have appeared in exams through com-

puter-based tests without any paper leakage, impersonation, remote log-in and use of spy devices. It said the fair examination has been made possible due to selection of exam-conducting agencies through open tender with the criteria of 'quality and cost based selection.'

Online submission of certificates and documents at the preliminary stage



Delhi: The Union Public Service Commission (UPSC)'s CSE 2025 requires online submission of certificates and documents at the preliminary stage of the exam, which includes submitting the necessary information and supporting documents for various claims, such as date of birth, category (SC/ST/OBC/EWS/PwBD/Ex-Servicemen), educational qualification, and Service preferences, with the Online A. Examination candi-

date will be canceled if the registration and online application form lack the relevant information/documents. "All of these changes should be explicitly stated in the notification, or the exam-conducting authority can create an educational video for specially abled candidates," he says. They appear puzzled and unable to complete the Prelims application form (due February 11, 2025). Candidates must also write about their interests, hobbies,

achievements, and NCC Scout participation in the Prelims, which were previously announced after the Mains. "The goal is to get the best candidate profile information before the Prelims," Kottaram explains (IRS) officers were recruited under PwBD reservation advantages. US intelligence chief Tulsi Gabbard arrives in India to attend key Delhi meet

NEW DELHI: US Director of National Intelligence (DNI) Tulsi Gabbard arrived in India on Sunday as part of her multi-nation trip to the Indo-Pacific regions. Gabbard will attend a high-level conference chaired by National Security Advisor Ajit Doval, focusing on strengthening intelligence-sharing mechanisms to tackle terrorism and transnational crimes. The event, set to take place in the national capital, will bring together intelligence chiefs also from Australia, Germany, New Zealand, and other key partner nations to enhance global security cooperation. Tulsi Gabbard's visit to India comes after

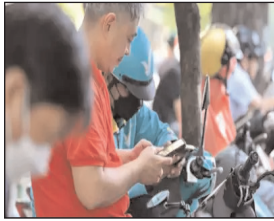


Prime Minister Narendra Modi's trip to the United States in February. During his visit, PM Modi met with Gabbard and described her as a strong advocate for India-US relations. Gabbard, in turn, expressed her gratitude for the opportunity to welcome Modi and emphasized her commitment to further strengthening ties between the two nations. This marked PM Modi's first visit to the US since Donald

Trump began his second term as President. During the trip, Modi met Trump at the White House, where they exchanged a warm embrace in their first official meeting since Trump took office as the 47th President on January 20. Modi was among the earliest world leaders to visit the US after Trump's inauguration and was invited within just three weeks of the new administration taking charge.

Vietnam's restrictive internet law comes into force

A new internet law in Vietnam, Decree 147, gives the government increased control over internet access and content in the name of national security and social order. It mandates tech companies to store user data, verify accounts, and remove deemed illegal content within 24 hours. Critics argue this suppresses free speech and impacts livelihoods. A new internet law that gives the Vietnamese government expanded powers over internet services and people using them is set to officially take effect Wednesday. Decree 147 expands government control over access to information on the internet for reasons of "national security" and "social order." The law requires social media platforms providing services to users in Vietnam to store user data and provide it to authorities on demand. The government issued the decree this November, and it requires organizations to take down anything the authorities consider "illegal content" within 24 hours. Decree 147 has sparked concerns, with researchers and experts tracking the country saying that the law is part of a growing crackdown on civil society. "Because the Vietnamese police treat any criticism of the Communist Party of Vietnam as a national security matter, this decree will provide them with yet another tool to suppress dissent," said Patricia Gossman, associate Asia director at Human Rights Watch. The decree requires tech giants like Facebook and TikTok among other organizations, to verify user accounts using people's phone numbers or personal identification numbers.



Bodies of 2 J&K brothers found a month after they went missing



SRINAGAR: The decomposed bodies of two Kashmiri brothers reported missing since Feb 13 along with a third person were found three days apart in a river in J&K's Kulgam district, around 70km south of Srinagar. Ahmad Bajad's putrefied corpse was discovered on Sunday at Vishaw, close to where his brother Riyaz's body had been found on March 13, police said. There is still no trace of Mukhtar Ahmad Awan of Partapora village, a relative of the brothers who had accompanied them to a wedding in the Mir Bazar area of

the same district the day all three went missing. The trio worked in a brick kiln. Investigators said the brothers may have died by suicide, based on forensic expert Dr Azia Manzoor Bhat's conclusion that the state of Riyaz's body indicated he drowned. Bhat told reporters in Kulgam that the case "doesn't look homicidal in nature". PDP member Talib Hussain, who was at the site when Showkat's body was found, accused police of baton-charging mourners when they questioned how investigators arrived at suicide as the cause of death.

"How did they drown in a river when the water level was so low?" Hussain said. "We demand a judicial probe into the case." Tribal villagers carried Showkat's body to the highway and staged a demonstration. DIG (South Kashmir) Javid Iqbal Matoo said he would investigate allegations of police harassment, but insisted that there was no indication yet of foul play in the deaths. "There are no torture signs on the bodies. Investigators are looking at all possibilities." NDRF and SDRF teams are scouring the area for the third missing person.

‘Leader has to take responsibility’: Congress slams PM Modi’s remarks on 2002 Gujarat riots

NEW DELHI: Congress leaders have strongly criticised Prime Minister Narendra Modi's remarks on the 2002 Gujarat riots during his interview with American podcaster Lex Fridman, accusing him of deflecting responsibility. During the podcast, Fridman asked PM Modi about the riots, describing them as one of the most challenging periods in India's modern history, leading to over 1,000 deaths. PM Modi, in response, placed the events in the context of a series of terrorist attacks in India and abroad, including the 1999 Kandahar hijacking, the 2001 Parliament attack, and the 9/11 attacks in the US. He argued that Gujarat had a long history of communal riots and claimed that

after 2002, the state had remained peaceful for over two decades. Targeting PM Modi, Congress leader Danish Ali said that Prime Minister's comments were an attempt to justify the riots, which he claimed reflected the failure of the then-Atal Bihari Vajpayee-led central government in handling law and order. "The way the PM has tried to justify the Godhra riots shows the failure of the Vajpayee government regarding law and order in the country. The way he talked about the Kandahar hijacking, the Parliament attack, and more, this is, in a way, a condemnation of the Vajpayee government," Ali said. Former Uttarakhnd chief minister and senior Congress leader Harish Rawat

also criticised Modi, referring to Vajpayee's well-known remark urging Modi to follow "rajdharm" (duty of governance). "When the Godhra incident happened and riots broke out, the scenes were gory. Finally, the PM had to ask to uphold 'rajdharm.' If anything is wrong, the leader has to take responsibility—it will always be with a leader. These words of Atalji will keep on echoing in his ears," Rawat said. In the podcast, PM Modi also pointed out that India's Supreme Court had twice upheld that he had no involvement in the riots. He dismissed allegations against him as politically motivated, saying that his government had prioritised peace and development over "appeasement politics."

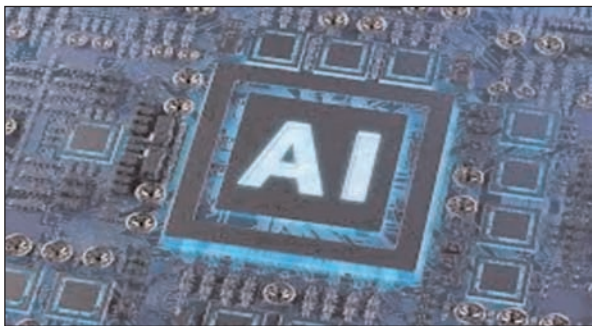


Bank staff, 3 others use idle IDs to siphon Rs 12 crore from 2 accounts, held

BENGALURU: Karnataka police have arrested an Axis Bank relationship manager in Rajkot and three others in an interstate cybercrime and financial fraud after the four allegedly embezzled over Rs 12 crore from Bengaluru-based Dreamplug Paytech Solutions Pvt Ltd, the operator of Cred, a rewards-based credit card payment platform. The accused include relationship manager Vaibhav Pithadiya (29), a banking agent from Surat Parmar Neha Ben Vipulbhai (26), an insurance agent and Vaibhav's colleague Shailesh (29), and a commission agent from Rajkot Shubham (26). The arrests were made following a complaint by Dreamplug executive Narasimha Vasanth Sastry. The fraud came to light on Nov 12 when Dreamplug executives identified suspicious transactions in their company accounts. Investigations revealed that Rs 12.2 crore was siphoned off from two Axis Bank accounts over 14 days between Oct 29 and Nov 11. The accused gained unauthorised access to Dreamplug's accounts by manipulating key details. They submitted forged documents, including fake signatures and board resolutions, to request changes to the registered mobile number and email ID linked to the accounts. These changes, approved by Axis Bank despite discrepancies, allowed the fraudsters to intercept OTPs and initiate 37 fraudulent transactions. Dreamplug said the fraudulent activity was facilitated by requests submitted at Axis Bank branches in Ankleshwar (July 22) and Abrama in Surat (Oct 12).

India’s own GPU could arrive in 3-5 years, 18,000 AI servers to go live soon says

India is gearing up to make a significant breakthrough in high-end computing by developing its own Graphics Processing Unit (GPU) within the next three to five years, while also working on an indigenous foundational Artificial Intelligence (AI) platform expected to be ready in just 10 months. Union Minister for Electronics and Information Technology Ashwini Vaishnaw made these announcements during the Budget Roundtable 2025, organized by India Today and Business



Today. In a major step towards AI development, the government will roll out 18,000 high-end GPU-based computing facilities in the coming days, making advanced computing power accessible to researchers, startups, and academic institutions. This move is crucial for reducing India's

reliance on foreign chip manufacturers, particularly Nvidia, which currently dominates over 80% of the global GPU market. With AI becoming a critical driver of global innovation, India's efforts to develop self-sufficient semiconductor and AI ecosystems

mark a pivotal shift. This article explores India's GPU development strategy, AI advancements, computing infrastructure expansion, and the broader impact of these initiatives on the country's technological future. Developing an advanced, high-performance GPU requires cutting-edge research, skilled engineering, and robust semiconductor manufacturing capabilities. According to Vaishnaw, India is considering multiple approaches to achieve this goal, including leveraging

Ayodhya's Ram Janmabhoomi Trust paid Rs 400 crore tax in last 5 years, says secretary Champat Rai

NEW DELHI: The Shri Ram Janmabhoomi Teerth Kshetra Trust has paid around Rs 400 crore in taxes to the government over the past five years, trust secretary Champat Rai said on Sunday. He said that the amount was paid between February 5, 2020, and February 5, 2025. Of the total amount, Rs 270 crore was paid as Goods and Services Tax (GST), while Rs 130 crore was paid under other tax categories, he said. Rai mentioned that Ayodhya has seen a significant rise in the number of devotees



and tourists, leading to more employment opportunities for locals. He added that during the Maha Kumbh, 1.26 crore devotees visited Ayodhya. In the last year, Ayodhya recorded 16 crore visitors, with 5 crore visiting the Ram temple. The Shri Ram

Janmabhoomi Teerth Kshetra Trust was formed in 2020 to oversee the construction of the Ram Mandir in Ayodhya, following the Supreme Court's verdict in 2019 that paved the way for the temple's construction. The consecration (Pran Pratistha) of the Ram

Mandir took place on January 22, 2024, with Prime Minister Narendra Modi leading the rituals. The event was attended by religious leaders, political figures, and dignitaries from across India. The temple, built at the site believed to be the birthplace of Lord Ram, has since become a major religious and cultural landmark, drawing millions of devotees. The trust's financial records are regularly audited by officials from the Comptroller and Auditor General (CAG), Rai said.

Use of ‘roo’ in budget logo conveys TN’s resolve in upholding its language policy: Stalin

CHENNAI: Tamil Nadu chief minister M K Stalin defended the use of the Tamil letter 'roo' to denote the rupee in the state government's budget logo, saying it was done to convey TN's commitment to its language policy. "We wanted to demonstrate our resolve in upholding Tamil Nadu's language policy. That's all. But those who dislike Tamil made this a big controversy," Stalin said in a video message on Sunday. Taking a dig at Union finance minister Nirmala Sitharaman, Stalin pointed out that despite TN sending "hundreds of requests" for financial

aid, she remained silent. However, she chose to speak up when a Tamil letter was used in the state govt's budget logo. Stalin said even in some of her posts, 'roo' had been used. "But when we do the same, it becomes a problem for them," Stalin said, hitting out at BJP leaders. He also pointed out that the use of 'Rs' instead of the rupee symbol was a common practice. "In any case, our budget as well as Tamil have become a huge hit," he said. Stalin dismissed opposition criticism of the budget, stating it had won widespread praise and detractors

were opposing it for political reasons.

"Those who criticise the budget should read the newspapers and understand its significance," he said. On criticism about mounting debt, Stalin said Tamil Nadu's debt ratio remained within permissible limits. He said the govt had slowed the rate of debt accumulation and was ensuring that borrowed funds were spent judiciously. "What matters is where we invest the borrowed money, and we are doing it wisely," he said. On the efforts that went into the preparation of the budget this year.

In move to decongest Ring Road, NHAI to build elevated corridor between INA and Mandela Marg

NEW DELHI: Finally, with BJP in power, both in Delhi and the Centre, the Union government is speeding up action on major decongestion projects in the national capital. The National Highways Authority of India (NHAI) will build the elevated corridor between INA and Nelson Mandela Marg in Vasant Kunj, a project that was conceived more than four years ago to decongest the Ring Road. Sources said the project would be funded by Delhi govt and urban affairs ministry, and the modalities will be worked out soon. The NHAI will build a tunnel between Nelson Mandela Marg to Shiv Murti interchange, which will provide seamless connectivity to Indira Gandhi

International Airport (IGIA). The corridor will mean, traffic coming from east and south Delhi can travel non-stop to the airport. The proposed elevated corridor (14-km) passing through the newly redeveloped govt residential and commercial complexes along the Ring Road was cleared by the Unified Traffic and Transportation Infrastructure (Planning and Engineering) Centre (UTTIEC) in July 2021. As per the earlier proposal, the central public works department (CPWD) was tasked to prepare the detailed project report (DPR) and execute it. But the project never got approval of the Public Investment Board, a mandatory process

before any proposal is placed before the cabinet for its nod. Sources said matters relating to decongestion of roads in Delhi was discussed at a meeting in the PMO early this month where top road transport and highway ministry officials suggested that NHAI could construct the project considering its expertise in execution of such major road projects. Following the meeting in PMO, Union road transport secretary, V Umashankar held a meeting attended by officials from NHAI, Delhi govt and National Buildings Construction Corporation (NBCC), the agency redeveloping the govt residential and commercial complexes. Sources told that the NHAI will pre-

pare the DPR and base it on the one prepared by CPWD. "As per earlier estimate, the project would have cost around Rs 4,500 crore. The project may have some components of tunnels considering the ground situation. We will arrive at a cost after the final DPR. The govt is serious about expediting the project, which has been stuck for at least four years," said a senior official. Some estimates by the Delhi PWD suggest that around 1.3 lakh vehicles pass through the AIIMS crossing every day, and nearly 3.3 vehicles ply between Bhikaji Cama Place and Lajpat Nagar flyovers daily. Officials said any more delay in taking up the project would cause more crisis as traffic.

Bihar traffic cop shoots dead reveller in 'self-defence'

SASARAM: A police officer opened fire on a group of revellers, purportedly in self-defence, killing a 32-year-old man and injuring two others in Sasaram in Bihar's Rohtas district on Friday night, reports. Police identified the victim as Rana Om Prakash Singh. His elder brother, Rana Rahul Ranjan, registered an FIR alleging that Om Prakash was shot dead for refusing to bribe the cops. The incident, according to cops, occurred after four men arrived near railway station in an inebriated state. A scuffle broke out between them and a patrolling unit. Traffic DSP Md Adil Bilal witnessed the fight and intervened. During confrontation, one of the youths reportedly fired an air gun.
