### Children brave river water to reach school in Gajapati

Berhampur (DMC): In a show of extraordinary grit and determination, ten students from Sanasahi village under Mohana block in Gajapati district undertake a perilous journey each day, wading through the turbulent Gadapur river to attend school at Badasahi.

Their daily 1.5-km trudge across the river is not just a commute, but a testament to the spirit of learning amidst adversity. The arduous journey is not limited to children alone. Residents from more than a dozen villages, including Kumbharpada, Ramsing, Gurimera, Betagonda, Bamudipada, Chidangapanka, Gurujhuli, Lutipadar, Balibandha, Gangudipanka, and Rajakhama, are forced to cross



the same watery expanse for basic needs like healthcare, marketing, and transport. Villagers claim that despite repeated pleas for a bridge, their voices have echoed unheard for years.However, a glimmer of hope has emerged. Transport Minister Bibhuti Bhushan Jena has recently assured the longawaited construction of a bridge over the Gadapur river, promising respite from the agonising hardship. Until then, the river remains both a path and a peril-a silent witness to the

indomitable courage of Gajapati's children, who are scripting a saga of resilience. Deputy CM tours Balasore Deputy Chief Minister Pravati Parida on Thursday conducted an aerial survey of floodaffected six blocks in Odisha's Balasore district where Subarnarekha river has begun receding after breaching its banks. I surveyed the flood-affected

areas in Bhograi, Baliapal, Jaleswar, Basta, Remuna and Balasore Sadar. A total of 154 villages across these six blocks and 8 wards of Jaleshwar Municipality have been affected. Steps have been taken to relocate people to safe places and provide them food," Parida posted on X.

# **Banking System**

The banking system in India is in sound financial health. Banks have over the years built up sufficient capital and liquidity buffers and their asset quality has been improving further. This has been detailed in the RBI's latest Financial Stability Report. Gross NPAs (nonperforming assets) have fallen to 2.3 per cent as of March 2025, down from 2.8 per cent the year before. Alongside, the capital position of banks has strengthened — the capital to risk-weighted assets ratio has risen to a high of 17.3 per cent as of March 2025 - and their provision coverage ratio also remains healthy. In the recent past, one area of concern has been the sharp rise in household debt. Household debt was estimated to have surged from 36.6 per cent of GDP in June 2021 to 42.9 per cent as of June 2024. The latest report pegs it at 41.9 per cent in December 2024. In comparison, the ratio averaged around 33 per cent between 2015 and 2019. While the current levels of debt may well be lower when compared to other emerging market economies, it is concerning that households have been taking on more loans for consumption, and not investment purposes. In fact, non-housing retail loans have grown at a faster pace than housing, business and agricultural loans. These loans now account for 54.9 per cent of all household debt and 25.7 per cent of disposable income as of last year as per the report. Within retail credit, unsecured lending, which forms a quarter of retail loans, has seen weakness. As per the central bank, new slippages in this category account for a significant share of slippages in all retail loans, with the private banks appearing to fare worse. Public sector banks are also seeing possible signs of stress building up. Stress is also evident in the microfinance segment — loans 31-180 days past due have risen to 6.2 per cent. These areas warrant closer monitoring. The banking system, however, remains well capitalised. The central bank routinely conducts stress tests to gauge the strength of banks.

In the current uncertain global economic environment, these tests perform a critical function. The tests conducted by the RBI accounted for various adverse scenarios - from "heightened geopolitical risks and escalation of global financial market volatility" to "a synchronised sharp growth slowdown in key global economies". They revealed that even if economic conditions take a turn for the worse, no bank would fall short of the regulatory minimum capital ratios. This is a welcome result.

# **Global SDG Report 2025: Progress, challenges & the India Perspective**



The 10th SDG report released by the UN Sustainable Development Solutions Network in June 2025 has brought encouraging news for India. The report reveals India's improvement in the global Sustainable Development Goals (SDG) Index, scoring 67 points, marking a significant jump from the 109th position last year to the 99th this year. The SDG Index evaluates comprehensive progress toward achieving the 17 SDGs adopted by UN member states in 2015, where a score of 100 indicates full achievement.

**India's Performance in World** SDG index --

India's entry into the top 100 highlights commendable progress, especially in areas such as poverty reduction, healthcare, and clean energy access. This upward shift is a reflection of ongoing developmental efforts despite global geopolitical tensions. India, despite its vast population and complex development challenges, has outperformed several regional neighbours. It has fared better than Bangladesh (114th) and Pakistan (140th), indicating relatively stronger institutional and infrastructural performance. However, the report also highlights serious concerns. Despite being the fifth-largest economy with stable foreign

exchange reserves, and strong growth, India is grappling with rising income and wealth inequality. This growing disparity threatens to offset the gains made in other development areas. A recent IMF report places India 136th in per capita income, with an average of \$2,880, underlining the urgent need for policy intervention to address inequality and achieve the goal of a Developed India by 2047. **Global Slowdown in SDG** 

#### Progress----

Globally, the SDG outlook remains grim. The report by SDSN notes that only 17% of the SDG targets are on track, signalling a significant slowdown. The progress of several countries has been hampered by ongoing conflicts, climate change, and economic inequality. For instance ,Wars in Ukraine, Gaza, Sudan, and other regions have triggered the largest displacement crisis on record, with over 120 million people forcibly displaced, severely undermining progress on SDG 16 (Peace, Justice, and Strong Institutions).

Another major barrier to progress is the huge climate finance gap. According to United Nations Framework Convention on Climate Change (UNFCCC )estimates, developing nations require \$6 trillion by 2030 to meet their climate commitments. The lack of adequate financial support, especially in the Global South, poses a serious challenge to achieving SDG 13 (Climate Action). The situation has worsened due to the withdrawal of the USA from the Paris Climate Agreement and the World Health Organisation, which has placed it at the bottom (193rd) in the SDG commitment index.

#### **Overall Performance of** nations in the World SDG index ---

The report finds that most countries have made tangible progress in three major SDG goals: SDG 9: Improved access



to basic services like mobile broadband and the internet, SDG 7: Better access to electricity under affordable and clean energy, SDG 3: Decline in under-5 and neonatal mortality rates, and improvements in gender equality indicators.Conversely, there has been no improvement in five targets. critical areas namely Obesity, Press freedom, Sustainable nitrogen management, Biodiversity loss, and Corruption Perception IndexThese areas remain persistent challenges for many nations and have not

witnessed the progress necessary to meet the 2030 targets.

Multilateralism, and the need for Reforms-----

The report also evaluates countries' commitment to multilateralism and global financial reforms. It calls for urgent reforms of international institutions like the UN, World Bank, and IMF to align them more closely with the SDG agenda.Promoting SDG-based trade agreements, expanding the use of green bonds, and adopting mixed finance models (publicprivate partnerships) can facilitate crucial funding. Furthermore, offering debt relief to poorer nations by international financial institutions and redirecting fossil fuel subsidies to sectors like clean energy and healthcare can significantly accelerate SDG implementation.

Sustainable Agriculture and Food Security..... A strong push for sustainable agriculture is vital. Emphasis must

be laid on improving soil health, reducing carbon emissions, and tackling food wastage. With nearly 30% of global food production wasted currently, better storage and transportation facilities can help achieve SDG 2 (Zero Hunger) and climate-related

#### **Grassroots Participation**

..... The success of the SDGs depends not only on global cooperation but also on local action. Local governments and communities must take the initiative by implementing district-level SDG action plans and by ensuring adequate funding and transparent and close monitoring, and community participation in planning. There is an inherent need for accountability processes for failure to meet the targets at each layer which may prove effective for inclusive growth and sustained development

#### The Evolution of SDG initiatives .....

The idea of sustainable development-meeting present needs without compromising the ability of future generations-was first articulated in 1987. This gave rise to the Millennium Development Goals (MDGs), which aimed to address basic development challenges by 2015. Although progress was made, it was uneven and limited in scope.Hence there was a need for a broader, more integrated framework, with the adoption of the SDGs in 2015, by 193

countries. The four core principles which form the bedrock of SDGs include Universality (Goals apply to all countries, rich and poor) Interlinkage (Progress in one goal supports others), Inclusivity(No one should be left behind, especially the most vulnerable and Collective Responsibility implying that Governments, businesses, civil society, and individuals must collaborate in the development journey. Similarly, at the global level, it is the shared responsibility of all 193 nations.

As the 2030 deadline approaches, the challenges of meeting the SDG agenda are mounting. Climate threats, ongoing conflicts, income disparity, and the impact of the COVID-19 pandemic derailed the progress in poverty reduction (SDG 1), healthcare (SDG 3), education (SDG 4), and clean energy investment (SDG 7). Least Developed and Landlocked Developing Countries have suffered nearly 7% of global disaster-related economic losses between 2015 and 2022, exacerbating poverty and further delaying SDG gains.The 2025 World Sustainable Development Summit (WSDS) will be held under the theme "Partnerships for Accelerating Sustainable Development and Climate Solutions".

This theme emphasises the critical role of collaboration and collective action in achieving sustainable development and climate goals. Achieving the Sustainable Development Goals (SDGs) is not just a development task-it is a moral duty. It needs urgent global cooperation, new ways to fund implementation, local-level action, and the support of each one. We all have a role to play-by conserving resources and standing up for fairness. The 2025 BRICS (Brazil, Russia, India, China, South Africa) summit will be held in Rio de Janeiro, Brazil on July 5th to 8th. This will be the seventeenth annual summit, with Brazil taking the role of host as part of the rotating presidency among the BRICS nations. Brazil's focus for the summit is 'Strengthening Global South Cooperation'. With the US stepping back or having a more cautious approach amidst complex international conflicts, BRICS seeks to promote a multipolar world order. By emphasizing cooperation

among emerging nations, the summit can serve as a counterweight to Western influence, especially in regions like the Middle East where conflicts like Israel-Iran escalate. The summit's agenda will likely include discussions on reshaping international institutions, addressing global security challenges, and finding ways to support peace and stability. In this geopolitical climate, BRICS' unified stance can influence global diplomacy and offer an alternative voice to Western-led narratives. The recent 12-day war between Iran and Israel has

Despite initial U.S. airstrikes on Iranian nuclear facilities, President Donald Trump's administration ultimately brokered a ceasefire under pressure from both sides. However, the U.S. response was marked by hesitation, internal contradictions, and limited strategic gains-prompting global observers to question Washington's reliability as a security guarantor.This perceived retreat has created a vacuum in global leadership-one that BRICS is uniquely positioned to fill. Why BRICS Matters Now?

BRICS, now expanded to include 10 members (Brazil, Russia, India, China, South Africa, Iran, Egypt, UAE, Ethiopia, and Indonesia), represents: 45% of the world's population. Over 30% of global GDP.30% of global oil production.With Iran now a member, BRICS gains strategic depth in West Asia and direct stakes in regional stability. The bloc's diversity-spanning continents, religions, and political systems-offers a counterbalance to Westerndominated alliances like NATO and the G7.

Strategic Imperatives for BRICS Empowerment: Institutional Strengthening -Expand the New Development Bank (NDB) to fund infrastructure, climate resilience, and digital connectivity across the Global South. Operationalize the BRICS Contingent Reserve Arrangement to shield members from financial shocks. Geopolitical Mediation -Position BRICS as a neutral mediator in regional conflicts, including West Asia and

Africa.Launch a BRICS Peace and Security Council to coordinate diplomatic responses and crisis management. Currency and Trade Sovereignty: Accelerate efforts to de-dollarize trade, using local currencies or a BRICS digital currency. Promote a BRICS Payment System as an alternative to SWIFT, reducing vulnerability to Western sanctions. Narrative Leadership :Champion a multipolar world order rooted in sovereignty, nonintervention, and equitable development.Use platforms like the UN and G20 to advocate for Global South priorities-from climate justice to food security.

Here are the key challenges it faces in asserting power on the world stage: Internal Diversity and Strategic Divides - BRICS is a mosaic of

political systems, economic models, and geopolitical interests. For example: India and China have unresolved border tensions and compete for regional influence. Russia and Brazil differ sharply on global alignments and democratic norms. This diversity makes it difficult to present a unified front on major global issues. Economic Asymmetries: China dominates the bloc economically, accounting for over 70% of BRICS GDP. This creates: Dependency concerns among smaller members. Resistance to replacing U.S. hegemony with Chinese dominance, especially in currency matters. Institutional Weakness - Unlike NATO or the EU, BRICS lacks: A permanent

mechanisms. Clear membership criteria or expansion strategy, risking fragmentation. Currency and Financial Limitations:Efforts to de-dollarize trade face hurdles: The Chinese yuan is not yet a strong reserve currency. Many BRICS members still rely heavily on U.S. and EU trade. Global Perception and Legitimacy: Western powers often view BRICS as an anti-

secretariat or enforcement

offer a constructive alternative to the current order? Or will it be seen as a coalition of convenience with authoritarian leanings? Expansion Risks -With 10 members and more aspiring to join, BRICS risks: Diluting consensus-based decisionmaking. Becoming a loose network rather than a cohesive force. External Pressures- U.S. sanctions on Russia, tensions with China, and instability in West Asia all affect BRICS' ability to act cohesively. The bloc must navigate: Geopolitical rivalries without becoming a proxy battleground. Global skepticism about its long-term coherence.

In short, BRICS has the numbers and ambition-but unless it resolves its internal contradictions and builds stronger institutions, its power may remain more symbolic than structural. If this is not done, the US will take advantage of it. As everyone knows, the US is not happy with BRICS. He tries his best to make BRICS weak. Trump has talked about ending BRICS as much as he is in power.

In particular, it was discussed in the last meeting of BRICS that a new currency will be implemented at the global level. That is, there was talk of a challenge to the US dollar, which angered the US and threatened to increase tariffs. So this is an opportunity for the BRICS countries to put aside all the internal conflicts and come to a consensus so that pressure can be put on the US.



### June has ended, yet farmers face a crisis..... Paddy sales, fake tokens, rain-related compensation, and crop insurance are urgent issues

Bargarh, (DMC): The Rabi season has drawn to a close, and as we step into the new Kharif season, the anticipation surrounding the resolution of paddy sale issues is palpable. Today, the Sanjukta Krushak Sangathan is set to meet with District Magistrate Shri Aditya Goyal to present an apparent four-point demand. Among their requests, they are expected to advocate for the prompt resolution of problems related to paddy sales, the crackdown on fake tokens, appropriate compensation for rain-related damages, and attention to crop insurance matters. With Rs 7,55,44,855 earmarked for rainrelated compensation across various regions-including Bheden, Attabira, Bargarh, Jharbandh, Bhatli, Sohela, and

Paikamal-the government's firsttime assessment of damages and allocation of an input subsidy brings hope. However, as many farmers from different blocks have reportedly been denied compensation due to rushed decisions, there is a strong call for a reevaluation to ensure rightful compensation is delivered. Moreover, PETA is poised to push crop insurance assessments to be completed within 10 days, with compensation ideally following within 15 days. Yet, the silence on updates thus far may lead to mounting pressure for swift action. Addressing reported farming losses is urgent; compensation is expected to be disbursed promptly. Farmers are counting on receiving payments in their accounts within 48 hours



of selling their paddy, but delays extending beyond three days have raised significant concerns. The plight of 4,000 to 5,000 farmers who are yet to receive payments, leaving substantial quantities of paddy unaccounted

for in markets, underscores the critical need for solutions to ensure fair selling prices and support farmers in meeting their immediate needs. Additionally, the organisation is preparing to file a complaint regarding the sale of

paddy from Chhattisgarh using fraudulent paddy cards in several areas, such as Satalma, Sarasara, Ghess, Adgaon, Pahadsrigida, and Panimora societies. This may ignite a demand for immediate and decisive action in response. There is hope that the Chief Minister will adopt a more farmer-centric approach to manage the Pradhan Mantri Fasal Bima Yojana. The upcoming meeting will include the organisation's advisor, Ramesh Mohapatra, along with dedicated members such as Tapan Mishra, Karan Sahu, Prashant Sahu, Ekadasia Sahu, Lokanath Das, Brundaban Sahu, Vijan Padhi, and Suresh Nikenti. All of them are keen to see progress and resolutions that will positively impact the farming community.

#### **118 Million Women Consumers In India Enter India's Sugar Industry Has Surged To Rs Credit Mainstream For 1st Time In 10 Years** 1.3 Lakh Crore Mark: Pralhad Joshi



Mumbai, (H.S): At least 118 million women consumers in India have entered the credit mainstream for the first time in the last 10 years, unlocking opportunities that were previously unavailable to them, according to a report on Thursday.

Over 714 million individuals have gained access to formal credit, positively impacting households across the country over the past two decades, said the report by TransUnion CIBIL, released at a conference here.Retail delinquencies (balance-level, at 90 days or more past due) have also improved by 130 bps in the last 10 years, the findings showed. As India's credit growth reaches new segments and geographies, the focus is shifting towards enabling access to financial services supported by data-driven insights, transparency, and informed risk management." Credit reporting systems today operate as a key element in the national financial architecture, encouraging greater credit access, supporting financial inclusion, enabling effective supervision, and enhancing financial stability," Reserve Bank of India (RBI) Deputy Governor

M. Rajeshwar Rao said. At the heart of a sustainable credit landscape lies an empowered consumer, which is enabled when we have a financially aware and literate customer, he said."While regulations mandate transparency and awareness, the responsibility needs to be fulfilled by all of us. The TMP, headed by former royal scion Pradyot Bikram Manikva Debbarma. contested the 2023 Assembly

polls separately but in March last year, after signing a tripartite agreement with the Centre and the Tripura government, joined the BJP-IPFT coalition government, adding a new twist to Tripura politics. The IPFT currently has one minister, Sukla Charan Noatia, in the council of the ministry. The BJP-IPFT alliance had retained power in Tripura by winning 33 seats in the 60-member Assembly.

The BJP alone secured 32 seats while the IPFT managed one seat in the 2023 Assembly polls.The TMP, which contested the Assembly elections in 2023 for the first time, won 13 seats of the 42 seats it contested, emerging as the second largest party after the BJP.The TMP and the IPFT are both tribal based parties.

The CPI (M) won 11 seats in the last Assembly elections (2023) while the Congress got three. The CPI (M)-led Left

# **10 ISRO Technologies Transferred To Indian Firms, Says IN-SPACe**



The tripartite Technology Transfer Agreements (TTAs) were signed between NewSpace India Limited (NSIL), the six companies, and IN-SPACe at the IN-SPACe headquarters in Ahmedabad.The technology transfers will give private players the opportunity to access the developed technologies available with ISRO, enabling them to use space-related technology for commercial applications in space as well as other sectors. The technologies that foster satellite launch, ground

station infrastructure, and geospatial applications are expected to deepen industry participation, enable indigenisation, and reduce dependency on foreign technologies."The transfer of these technologies marks yet another significant step towards empowering the private sector to harness and commercialise space

technologies. ISRO has a flourishing repository of R&D in space technologies, and it is time we leverage that to the optimum to strengthen India's space industrial ecosystem, and in that, industry-led innovation will play a key role," said Dr. Pawan Goenka, Chairman, IN-SPACe.Two advanced inertial sensors - the Laser Gyroscope and the Ceramic Servo Accelerometer - developed by ISRO's Inertial Systems Unit,

for potential use in satellite launch vehicles have been transferred to Hyderabad-based Zetatek Technologies. The company has over 25 years of expertise in Inertial Navigation System (INS) testing, calibration, and QA/QT equipment.

Three technologies related to ground station operations - S/X/ Ka tri-band dual circular polarised monopulse feed, triaxis antenna control servo system, and Ku/C/L and S Band Cassegrain feed - have been transferred to Avantel and Jisnu Communications, Hyderabadbased companies specialising in end-to-end communications solutions for space and defence platforms. These technologies, currently sourced from foreign vendors, will enable self-reliance in critical ground station infrastructure. Further, two

geospatial models developed by SAC/ISRO for pest forewarning and semi-physical crop yield estimation were transferred to Ahmedabad-based Amnex Info Technologies, to be deployed in agricultural decision-making and crop protection.A compact, multiparameter, portable bathymetry system developed by NRSC/ ISRO has been transferred to Jalkruti Water Solutions, Ahmedabad, to enable UAV-based integration for water resource monitoring.

Further, VSSC/ISRO's ceramic-based flame-proof coating technology - originally developed for launch vehicle applications - has been acquired by Ramdev Chemicals, Ahmedabad, for wider industrial applications." With this transfer, we are taking a pivotal step toward building indigenous capabilities within India. ISRO, IN-SPACe and NSIL will collaboratively provide comprehensive handholding support to all the industry players to ensure successful absorption of the technology," said Rajeev Jyoti, Director, Technical Directorate, IN-SPACe.

### **ED Raids Across Multiple Cities In Delhi Jal Board** STP Scam Case; Rs 41 Lakh In Cash Seized

New Delhi: The Enforcement Directorate (ED) conducted extensive search operations across multiple cities, including Delhi, Ahmedabad, Mumbai, and Hyderabad on July 3, in connection with a corruption case linked to the Delhi Jal Board's (DJB) sewage treatment projects. The probe stems from an FIR lodged by the Anti-Corruption Branch (ACB) of the Delhi Government against M/s Euroteck Environmental Pvt Ltd and others under various sections of the Indian Penal Code and Prevention of Corruption Act.

The case pertains to alleged irregularities in the awarding of contracts worth Rs 1,943 crore for the augmentation and upgradation of 10 Sewage Treatment Plants (STPs) in the national Capital.The four key tenders - related to STPs at Pappankalan, Nilothi, Najafgarh, Keshopur, Coronation Pillar, Narela, Rohini, and Kondli - were awarded in October 2022 to three Joint Venture (JV) firms. According to the FIR, only three JVs participated in all four tenders, each securing one or two

contracts through apparent mutual arrangement. Investigators suspect collusion among the JVs to manipulate the bidding process. The ACB alleges that the tendering process was deliberately made restrictive notably through the imposition of the Integrated Fixed-film Activated Sludge technology requirement - limiting the number of eligible bidders.

Moreover, the estimated cost of the projects was inflated from Rs 1,546 crore to Rs 1,943 crore without proper justification or revised project reports,

allegedly causing a significant loss to public funds. ED's findings corroborated the FIR, revealing that all three JVs submitted identical experience certificates from a Taiwanese project, which were accepted by the DJB without verification.

After securing the tenders, the JVs subcontracted the entire work Euroteck to Environmental Pvt Ltd, the original accused in the FIR. During the searches, ED officials seized Rs 41 lakh in cash, along with several incriminating documents and digital evidence.

Information Bureau, Intelligence sharing by India's Narcotics Control Bureau (NCB) led to the US Drug Enforcement Administration (USDEA) arresting a key player in an international drug trafficking network."Joel Hall, a major reshipper based in Alabama, was arrested following a coordinated operation, leading to the seizure of more than 17,000 tablets of controlled medication," the bureau said.An Indian-American, who was the network's key money launderer, is awaiting indictment, it said.

EAM Jaishankar came here to participate in the Quad Ministerial meeting, on Tuesday, with US Secretary of State Marco Rubio, and Foreign Ministers Penny Wong of Australia and Takeshi Iwaya of Japan.He is meeting key US officials to discuss issues of importance to the two countries. Other officials he met in bilateral settings were Rubio, US Defence Secretary Pete Hegseth, and Energy Secretary Chris Wright.

# 4 Dead, 38 Missing After Ship Sinks in Indonesia, Prez Subianto Orders Immediate Rescue

Jakarta, (H.S): Four people have been confirmed dead, 38 are missing, and 23 others survived after a passenger ship sank in the Bali Strait of Indonesia early on Thursday, a senior official from the East Java Search and Rescue Office, Tholeb Vatelehan, said on Thursday.

The wooden vessel, KM Tunu Pratama Jaya, was travelling from Ketapang seaport in Banyuwangi Regency, East Java, to Gilimanuk seaport in Jembrana Regency on Bali Island when it went down, according to the official."As many as 23 people survived the incident, four were dead, and 38 others remained missing," Vatelehan told Xinhua news agency via phone.

Indonesian President Prabowo Subianto has ordered the National Search and Rescue Agency (Basarnas) to



immediately rescue the passengers and crew of the interisland ferry.Teddy Indra Wijaya, cabinet secretary, stated that the President issued the directive directly from Saudi Arabia, where he is performing the Umrah pilgrimage and undertaking an official visit."

From the Holy Land, he immediately instructed Basarnas and related agencies to initiate an emergency response and rescue the passengers and crew as quickly as possible," Teddy said on Thursday. The President emphasised that victim rescue must be the top priority in the emergency operation, Teddy added.

Search and rescue operations have since been launched from both Bali Island and East Java, as the incident occurred near the maritime boundary between the two regions.I Nyoman Sidakarya, head of the Bali Search and Rescue Office, confirmed the joint efforts.

The Banyuwangi Search and Rescue Office deployed more than 20 personnel, along with a rigid inflatable boat and one additional vessel to assist in the operation, Vatelehan said." Strong winds, large waves, and powerful currents are currently hampering the rescue efforts," he added.

## Emergency Response to Flooding Activated For China's Qinghai Norway Launches First National Strategy For Radiation Protection, Nuclear Safety

**Beijing, (H.S):** China's Ministry of Water Resources on Thursday activated a Level-IV emergency response to flooding in the northwest Qinghai Province amid a new round of heavy rainfall.According to forecasts, heavy rainfall is expected in eastern and southern Qinghai from Thursday to Saturday.

As a result, significant rises in water levels are anticipated in the upper main stream and tributaries of the Yellow River in the province, with some small and medium-sized rivers in heavily affected areas potentially experiencing floods exceeding warning levels.Local authorities have been urged to enhance flood monitoring and early warning, ensure effective flood control for rivers, and protect people's lives and property.Based on 24-hour rainfall forecasts, the ministry



has issued alerts for 10 other provincial-level regions, including Hebei, Liaoning and Hainan, urging them to take precautions and prepare for heavy rainfall.A Level-IV emergency response to flooding is currently in effect in the three provincial-level regions of Chongqing, Sichuan and Gansu, Xinhua news agency Prefecture of Guizhou Province, where large numbers of residents have been evacuated, and significant damage has occurred. Rongjiang County, widely known as the birthplace of the Village Super League, or Cun Chao, is beginning postdisaster recovery after being hit by two severe floods in less than a week.

Since June 24, back-to-back floods had inundated large parts of the county, with the Cun Chao stadium, which is situated in a low-lying urban area, submerged twice within five days. The emergency funds were also announced to support the affected areas in restoring daily life and economic activity as soon as possible, the ministry added. Meanwhile, six people had died due to severe flooding in Rongjiang County in southwest China's Guizhou Province. **Oslo, (H.S):** Norway has introduced its first-ever national strategy for radiation protection and nuclear safety, a move aimed at strengthening the country's health preparedness and security amid rising global tensions, Norwegian authorities announced.

The new strategy defines international Norway's obligations in the areas of radiation protection, nuclear safety, and emergency preparedness, reports Xinhua news agency, citing the Norwegian government's press release. It also addresses the shortcomings identified by the International Atomic Energy Agency (IAEA) during its review of Norway's radiation safety systems in 2019." I am very pleased that we are now putting in place the country's first national strategy in this area. It helps to increase health



preparedness and security in our country," said Jan Christian Vestre, Minister of Health and Care Services. Foreign Minister Espen Barth Eide emphasised the growing relevance of nuclear safety issues. "Tensions in the world have increased, and issues related to radiation protection and nuclear safety have not been more important." He added that Norway intends to play an active role in international cooperation on these matters. The national strategy commits Norway to maintaining a high level of radiation protection to safeguard

human health and the environment. It sets out 10 key goals, including ensuring independent regulatory oversight, strengthening safety regulations, adopting a life-cycle approach to radiation-related activities, and minimising the risk of radiation and nuclear incidents. Norway also aims to improve patient safety in the medical use of radiation, enhance the management of radiation sources beyond governmental control, and ensure all radiation-related activities in the country prioritise safety as the highest concern.

### NBFCs Can't Charge Prepayment Penalties On Floating Rate Loans to MSEs; New RBI Rule Applicable From...



New Delhi, (H.S): The Reserve Bank of India has directed banks and other lenders not to charge pre-payment penalties on all floating-rate loans and advances, including for business purposes, availed by individuals and micro and small enterprises (MSEs). RBI's direction will applicable to all loans and advances sanctioned or renewed on or after January 1, 2026. Reserve Bank in its directive has mentioned that certain REs have been found to include restrictive clauses in loan contracts/ agreements to deter

borrowers from switching over to another lender, either for availing lower rates of interest or better terms of service. RBI said that these Directions shall apply to all commercial banks (excluding payments banks), co-operative banks, NBFCs and All India Financial Institutions. The central bank added that for all loans granted for purposes other than business to individuals, with or without co-obligants, an RE shall not levy pre-payment charges;(ii) For all loans granted for business purpose to individuals and MSEs,

with or without co-obligant(s):(a) A commercial bank (excluding Small Finance bank, Regional Rural bank and Local Area bank), a Tier 4 Primary (Urban) Cooperative bank, an NBFC-UL, and an All India Financial Institution shall not levy any prepayment charges. A Small Finance bank, a Regional Rural bank, a Tier 3 Primary (Urban) Cooperative bank, State Cooperative bank, Central Cooperative bank and an NBFC-ML shall not levy any prepayment charges on loans with sanctioned amount/ limit up to Rs 50 lakh.

In case of cash credit/ overdraft facilities, no pre-payment charges shall be applicable if the borrower intimates the RE of his/ her/ its intention not to renew the facility before the period as stipulated in the loan agreement, provided that the facility gets closed on the due date. An RE shall not levy any charges where pre-payment is effected at the instance of the RE, RBI added. India's Real GDP Growth Projected To

## **Corporate Profits In India Grew Nearly 3x Faster Than GDP Between FY20-25**

New Delhi, (H.S): Mumbai: India Inc has shown remarkable financial strength over the last five years, with corporate profits growing nearly three times faster than the country's GDP between FY20 and FY25, a new report said on Thursday. The profit-to-GDP ratio has risen significantly to 6.9 per cent - reflecting strong earnings performance despite economic challenges, according to the data compiled by Ionic Wealth (Angel One).

The report, titled 'India Inc. FY25: Decoding Earnings Trends & Path Ahead', highlights that FY25 was a resilient year for Indian companies.Revenue of Nifty 500 firms grew by 6.8 per cent year-on-year (YoY), while EBITDA rose by 10.4 per cent and profit after tax (PAT) increased by 5.6 per cent. Notably, mid-cap and small-cap



companies outshined large-cap firms in terms of profit growth, recording 22 per cent and 17 per cent PAT growth respectively, compared to just 3 per cent for large caps. Sector-wise, BFSI (banking, financial services and insurance) emerged as a major driver of profitability, with its share of total profits nearly doubling since the pandemic. Auto, capital goods, and consumer durables also posted healthy earnings growth. Consumer durables led with a

massive 57 per cent PAT growth in FY25, followed by healthcare at 36 per cent and capital goods at 26 per cent, as per the report. Companies also benefited from margin improvements in sectors such as cement, chemicals, metals, and auto, helped by easing inflation and better input cost management. The report also points to a significant jump in capital expenditure plans. India Inc. aims to nearly double its capex to Rs 72.25 lakh crore during FY26-30, with a majority

of the investment expected to be self-funded.Around 80 per cent of this capex is focused on upgrading existing operations and generating new income, with sectors like power, green energy, telecom, auto, and cement leading the next wave of investments.

Looking ahead to FY26, the outlook varies by sector. Banks and NBFCs may see loan growth stabilise as interest rates are expected to ease in the second half of the year. The IT sector is likely to witness a recovery, driven by costoptimisation deals and demand from BFSI clients.Pharma growth will be supported by expansion in chronic therapies and hospital networks, while the FMCG sector is expected to benefit from improving rural demand and a good monsoon, the report said.

New Delhi, (PIB): NITI Aayog released its report "Chemical Industry: Powering India's Participation in Global Value Chains". This report offers an extensive analysis of India's chemical sector, highlighting both opportunities and challenges, and outlining a pathway for positioning India as a key player in global chemical markets. The global chemical industry is undergoing a major transformation, driven by shifting supply chains, demand for specialty and green chemicals, and heightened focus on innovation and sustainability.

India's chemical sector, while significant in size and GDP contribution, remains fragmented and constrained by infrastructure gaps, regulatory inefficiencies, and low R&D intensity. India's 3.5% share in global chemical value chains and its chemical trade deficit at USD 31 billion in 2023, underscores its high dependence on imported feedstock and specialty chemicals. However, with targeted reforms encompassing a comprehensive range of fiscal and non-fiscal interventions will

enable India to have a USD 1 trillion chemical sector and achieve 12% GVC share by 2040, thus becoming a global chemical powerhouse.India's chemical sector faces several structural challenges that constrain its global competitiveness. A key issue is the country's heavy reliance on imported feedstock, which contributed to a USD 31 billion trade deficit in 2023, stemming from limited domestic backward integration.

Infrastructure gaps, outdated industrial clusters, and high logistics costs have created a cost disadvantage compared to global peers. Compounding this, India's low investment in R&D, with only 0.7% of investment against the global average of 2.3%, hampers indigenous innovation in high-value chemicals. Regulatory delays, especially in environmental clearances, further stifle industrial agility. Additionally, the sector is hampered by a 30% shortfall in skilled professionals, particularly in emerging areas such as green chemistry, nanotechnology, and process safety.NITI Aayog's report outlines several strategic

fiscal and non-fiscal interventions aimed at enhancing India's global competitiveness in the chemical sector. These initiatives listed below aim to transform aspirations into actionable progress: Establishment of empowered committee at the Central level along with creation of a Chemical Fund under the empowered committee with a budgetary outlay for shared infrastructure development, VGF, etc.

Administrative body at the chemical hub level, which will handle the overall management of the hubComposition of a Chemical Committee for ports to advise on and address infrastructural gaps in chemical trading at ports. Incentivize incremental production of chemical based on import bill, export potential, single source country dependence, end-market criticality etc. The scheme proposes for incentives on incremental sales to selected participants for a fixed number of years. Disbursement of R&D funds to drive innovation with enhanced collaboration between industry and academia through

creation of an interface agency in collaboration with DCPC and DST. Acquiring access to specific technologies available outside India through fostering MNC partnerships. Fast-track environmental clearance with transparency and accountability - Simplify and fast-track EC clearance process through setting up an audit committee under DPIIT to monitor timelines and compliance and publish periodic reports and give more autonomy to EAC.

Targeted FTA negotiations: Moving forward, India could negotiate FTAs that incorporate specific provisions for the chemicals industry. This can include incorporating industry focused protections such as tariff quotas or selective duty exemptions on critical raw materials and petrochemical feedstocks. 6.2 Awareness and effective utilization of FTAs: Raising FTA awareness, simplifying procedures, and easing origin proofs can help more exporters access benefits and competitiveness.1 boost Expansion of ITIs and specialized training institutes: The expansion

is essential to meet the growing demand for skilled labor.2 Upgrading faculty and teacher training: The effectiveness of vocational training programme is directly linked to the quality of instruction.Industry-academia partnership: These collaborations can introduce industry relevant courses in core areas like petrochemicals, polymer science, and industrial safety. The vision for 2030 is for India to become a global chemical manufacturing powerhouse with a 5%-6% share of the global chemical value chain.

The sector aims to double its current production levels and reduce the trade deficit significantly from USD 31 billion in 2023 to reach a Net Zero trade balance in Chemicals. The initiative will generate an additional export of USD 35-40 billion generating around 7 lakh skilled jobs. This growth will be supported by the development of world-class chemical clusters, advanced technology adoption, streamlined regulatory processes, and a highly skilled workforce, positioning India among the top global leaders in the chemical industry.

#### Sensex, Nifty End Lower Amid Consolidation, **Investors Await India-US Trade Deal**

Mumbai, (H.S): The Indian stock markets ended lower on Thursday after a day of cautious trading, as late selling pressure erased earlier gains. Investors remained watchful amid hopes of a possible trade agreement between the US and India. The Sensex touched an intra-day high of 83,850 in early trade but eventually closed 170.22 points or 0.2 per cent lower at 83,239.7. Similarly, the Nifty also slipped by 48.1 points or 0.19 per cent, settling at 25,405.3 by the end of the session.Markets traded volatile on the weekly expiry day and ended marginally lower, continuing the ongoing consolidation phase, said Ajit Mishra of Religare Broking Limited.After an initial uptick, the Nifty oscillated sharply in both directions while remaining within Wednesday's trading range, ultimately closing at 25,405.30."However, the overall trend remains bullish and is expected to stay intact unless the index decisively breaks below the 25,200-mark. On the upside, the 25,650-25,750 zone is likely to act as an immediate hurdle," Mishra mentioned.

On the Sensex, Kotak Mahindra Bank, Bajaj Finserv, Bajaj Finance, Trent, and State Bank of India were among the top losers. On the other hand, Maruti Suzuki India, Infosys, NTPC, Asian Paints, Hindustan Unilever, and Eternal were among the top gainers - helping limit the downside. Broader markets showed subdued trends. The Nifty Midcap100 index managed to hold on to slight gains and closed flat with a positive bias. Following suit, the Nifty Smallcap100 index ended the day 0.26 per cent higher.In contrast, the Nifty Smallcap100 index ended the day 0.26 per cent lower. Among sectoral indices, the Nifty PSU Bank index was the biggest loser, falling 0.89 per cent due to selling pressure in stocks like Punjab National Bank, Union Bank of India, UCO Bank, and Central Bank of India.Other sectors such as metals, realty, banking, and financial services also ended lower. However, some pockets of the market saw buying interest. Sectors like media, auto, pharma, healthcare, consumer durables, oil & gas, and FMCG managed to close in the green. Market experts said that investors are likely to remain cautious in the coming sessions, keeping a close eye on global trade developments, FII activity and key economic cues.

# 2nd Test: Shubman Gill Hits Unbeaten 265 As India Go Past 550, Take Control On Day 2

Birmingham, (HS) : Skipper Shubman Gill continued to dominate by hitting an unbeaten 265 - going past 250 for the first time in Tests - as England bowlers' toil continued with India reaching 564/7 in 141 overs at tea on Day Two of second Test of the Anderson-Tendulkar Trophy at Edgbaston here on Thursday. It was another session of relentless run-making by India as they made 145 runs in 31 overs, with Gill treating a sunny Edgbaston crowd to a masterful display of batsmanship, as he brought up his maiden double-century in Tests. He also got great support from Washington Sundar, who made 41 and was his able partner in a 144-run stand for the seventh wicket. Gill now holds the record for the highest score by an Indian batter on English soil and the highest score by an Indian captain in the longer format. It would be interesting to see if Gill, who has been hard to dislodge by England's bowlers, reaches the rare triple century mark in Tests. Gill's great handling of

Harmanpreet Singh-led Indian team outclassed Malaysia 4-3 in the final to claim a record fourth title. Pakistan recently participated in the FIH Nations Cup in Malaysia, where it finished runners-up to New Zealand, who qualified for the FIH Pro League 2026-27 season.

### Top Shooters Back In India Reckoning Post Dehradun Rifle/Pistol Trials

New Delhi, (HS) : Olympians Anjum Moudgil (also world championship silver medalist) and Saurabh Chaudhary and world championship bronze medallist Mehuli Ghosh, are back in reckoning for team India spots after the conclusion of the National Selection Trials 3&4 for Rifle and Pistol shooters, at the Trishul Shooting Range in Dehradun. The National Rifle Association of India (NRAI) has released the full domestic rankings list for Group A (eligible for India selection) shooters on their website, after the final match was played out on Monday (June 30, 2025). Double Olympian Anjum, one of India's finest woman rifle shooters ever, missed out on the first half of the international season comprising three World Cup stages, but is back in reckoning in women's 50m rifle 3 positions (3P), having displaced

fellow Paris Olympian Shriyanka Sadangi in the top three. World record holder Sift Kaur Samra remains the top-ranked 3P women's shooter in India with an average of 593.38, followed by Ashi Chouksey (592.25) and Anjum (591.68). Sriyanka (589.90), Mehuli (588.58), and Surabhi Bharadwaj Rapole (588.08) complete the top six of this highly competitive field. Former Asian Games and Youth Olympics champion Saurabh Chaudhary is back as India's No.1 in the men's 10m air pistol with a top-ranked average of 583.93, followed by Aditya Malra (582.75) and Anmol Jain (582.33). Amit Sharma (582), Nishant Rawat (582), and Samrat Rana (581.45) took fourth, fifth, and sixth ranks, respectively.



Among the rifle shooters, Asian Championship 2024 gold medallist Mehuli Ghosh returns to the No. 1 spot in the domestic rankings of 10m Air Rifle Women with an average of 633.65, followed closely by Elavenil Valarivan (633.28) and Ananya Naidu (632.83). Rising names Arya Rajesh Borse (632.25), Ramita (632.05), and Sonam Uttam Maskar (631.60) also feature in the top six rankings. In the 10m Air Pistol Women, Suruchi continues to dominate the national circuit. With an average score of 588.25, she sits firmly at the top, enjoying a nearly 10point lead over her nearest competitor, Palak (578.38). Paris Olympic double bronze medalist Manu Bhaker and Surbhi Rao both average 578, with Surbhi taking fourth due to a lower drop score. Rhythm Sangwan (577.88) and Esha Singh (577.83)

follow closely at fifth and sixth, respectively. World No. 2 Manu, who skipped T3 and T4 rounds, continues to lead the 25m Sports Pistol Women India rankings with an average score of 588.65. Simranpreet Kaur Brar (583.75), Esha Singh (583.50), Rahi Sarnobat (582.28), Abhidnya Patil (580.43), and Divya T.S. (580.38) round up the top six. Anish Bhanwala, fresh off wins in Trials 3 & 4, holds on to the No.1 spot in 25m Rapid Fire Pistol Men with an average of 581.25. He is followed by Neeraj Kumar (578.75) and Adarsh Singh (578.55). The next three spots are held by Bhavesh Shekhawat (576.63), Pradeep Singh Shekhawat (576.30), and Mandeep Singh (576.00).
