Canadian who drove over Fauja Singh arrested

Chandigarh: Police have arrested a Canada-based man who allegedly drove his SUV over Fauja Singh. killing the world's oldest marathoner. Officials said the accused had returned home in Punjab just three weeks ago

Senior Superintendent of Police (SSP), Jalandhar Rural, Harvinder Singh, told a press conference that Amritpal Singh Dhillon (26) was arrested on Tuesday night and his vehicle has also been seized. Dhillon, a native of Kar-

tarpur, had gone to Canada on a tourist visa but got a work permit there, which is valid till 2027, the officer said, adding that the accused came to India late last month.

He was nabbed from his Kartarpur home.

The SSP told reporters that Dhillon was driving his SUV fast as he was in a hurry for some work. "He got scared after hitting Fauja Singh, and that is why he did not stop his car at the spot," Singh said.

The accused also told police that he had got one of the tyres of the car changed on the day of the incident.

accused revealed that his car was moving at a high speed when it hit Fauia Singh, who was crossing the road. The SSP said it was Dhillon's responsibility to stop the vehicle at the time of the accident and should have taken Fauja Singh to a hospital.

Dhillon had allegedly hit Fauja Singh (114) on the highway in the veteran runner's native village of Bias in Punjab's Jalandhar district, Fauja Singh was walking down the Jalandhar-Pathankot highway when the incident oc -

curred, and he succumbed to injuries on Monday evening. According to villagers,

Singh was tossed five to seven feet in the air after being hit by the vehicle.

size or price. The CDS also said that during Operation Sindoor, Pakistan used unarmed drones and loiter muni-

tions on May 10. But "none of them could actually inflict any damage to Indian military or civilian infrastructure", he said.

"Most of them were neutralised through a combination of kinetic and nonkinetic means. Some of them could be recovered in almost intact conditions," Gen Chauhan said.

# **Protests turn ugly, Oppn demands probe**

Bhubaneswar: Several BJD workers and leaders. including two former ministers, were injured in a scuffle with police personnel here on Wednesday during a party's protest over the death of a college student, who set herself on fire in Odisha's Balasore district.

The BJD's demonstration turned violent near the Lower PMG Square when its workers and leaders breached a barricade to march towards the state secretariat, Lok Seva Bhavan, and clashed with the police personnel, an officer said.

The police used water cannons and fired tear gas shells to disperse the agitating BJD workers, he said.

"BJD workers were later arrested and taken away from the agitation site, the officer said.

Among the injured persons were former ministers Pranab Prakash Das and Priti Ranjan Gharai.

Gharai was initially taken to Capital Hospital here and later shifted to the ICU of the Utkal Hospital, Bhubaneswar, a party functionary said.

Das was taken to a private hospital, he said.

The BJD held the protest, demanding a judicial inquiry into the death of the college student, who set herself on fire over alleged denial of justice in a sexual harassment incident.

#### Normal life hit

Markets were shut, schools and colleges were closed, and vehicles largely remained off the roads as a bandh, called by the opposition BJD, was underway in Odisha's Balasore district over the death of a college student.

The second-year B.Ed student of Fakir Mohan (Autonomous) College died at AIIMS-Bhubaneswar on

Monday night after fight ing for her life for three days.

She had set herself on fire on the campus on Saturday over alleged inaction against a professor who allegedly sexually harassed her.

The bandh began at 6 am and would continue till 2 pm.

Armed with party flags, hundreds of BJD members blocked major roads of the district by burning tyres. The traffic on the na-

tional highway passing through the district is also being regulated in view of the protests, police said.

Apart from Balasore town, BJD workers were holding demonstrations in places like Jaleswar, Basta, Soro, Baliapal and Bhograi since morning.

"People are very angry over the denial of justice to the student who ultimately set herself on fire and died," said BJD leader Debi Prasad Mishra.

"The party will continue the agitation across the state till the BJP government announces a judicial probe into the incident," he said. The protestors were also

demanding the resignation of Higher Education Minister Suryabanshi Suraj and Chief Minister Mohan Charan Majhi, accusing them of failing to provide justice to the 20-year-old student. The principal of the col-

lege and the accused professor have been arrested by the police.

### Conversion Law SC seeks UP govt response

New Delhi: The Supreme Court on Wednesday sought Uttar Pradesh government's response on a plea against certain provisions of the 2024 amended UP law on unlawful religious conversion.

A bench of Justices Vikram Nath and Sandeep Mehta issued notice to the state asking for its response.

It tagged the plea for hearing with other pending petitions raising similar issues.

The top court was hearing a plea filed by academician Roop Rekha Verma, who hails from Lucknow. and others against the amended law.

The petitioners have called certain provisions of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Act amended in 2024 "vague and overly broad", arguing their ambiguity infringed upon free speech and religious propagation.

The state's counsel on Wednesday said similar pleas challenging the law were pending before the bench headed by the Chief Justice of India.

The counsel for the petitioners pointed out the plea was only challenging the law's amendments in 2024.

The top court had agreed to examine the plea on May

The plea, filed through advocate Purnima Krishna, argues the law infringes upon Articles 14 (equality before the law), 19 (freedom of speech and expression), 21 (right to life and personal liberty), and 25 (freedom of religion) of the Constitution.

Sections 2 and 3 of the Act, it claimed, were "vague, overly broad, and lack clear standards" which made it difficult to determine what constituted an offense.

"This ambiguity infringes upon free speech and religious propagation, enabling arbitrary enforcement and discriminatory application. Penal laws

must be precise; vague provisions violate constitutional principles by granting excessive discretion to authorities, failing to provide reasonable notice, and risking wrongful prosecution of innocent individuals," the plea said.

This ambiguity opens the door to arbitrary enforcement and discriminatory practices, especially against individuals seeking to practice or propagate their faith, it added.

The plea said penal laws must be defined with precision to prevent misuse by authorities and avoid the wrongful prosecution of innocent citizens.

The amendment's "kev concern" was said to be the expansion of the category of persons authorised to file complaints without incorporating procedural safeguard.

# **Navyug School Organizes Teacher Training on New Education Policy 2020**

Kurukshetra: A special training session for teachers was organized today at Navyug Senior Secondary School, Mohan Nagar focusing on the New Education Policy (NEP) 2020.

On this occasion, resource person Mrs. Preeti Mishra provided an in-depth explanation of the NEP 2020 and highlighted its key features. She informed the attendees that the NEP 2020, announced by the Government of India on July 29, 2020, marks the first major revision in India's education policy since 1986. The policy is based on the recommendations of a committee headed by renowned space scientist Dr. K. Kasturirangan.



She stated that the National Education Policy is structured into 27 chapters across 4 parts and aims to achieve a 100% Gross Enrollment Ratio by 2030. It also sets a target of 6% of GDP as public expenditure of

on education. Furthermore, the name of the Ministry of Human Resource Development has been changed to the Ministry of Education.

The policy emphasizes the use the mother tongue or

medium of instruction up to Grade 5, with continued encouragement until Grade 8 and beyond. A unified regulatory body named the Indian Higher Education Council has been proposed for overseeing higher education institutions across the country.

Key reforms discussed included the replacement of the traditional 10+2 structure with a new 5+3+3+4 format. This includes three years of pre-primary education followed by 12 years of schooling, beginning with foundational classes 1-2, preparatory classes 3-5, middle school classes 6-8, and secondary stage classes 9-12. Notably, vocational education with internships will begin from Class 6, and subject selec-

Over the past several years, Wockhardt's US generics business has been incurring losses, it said. In FY 2025 alone, the generics business incurred a loss of nearly US \$ 8 million, it said. "Following a comprehensive strategic review, the company has concluded that continuing in this segment would detract from its broader innovation agenda," the company said in an exchange filing.

Accordingly, Wockhardt has filed for voluntary liquidation under Chapter 7 of the US Bankruptcy Code for its US step-down subsidiaries, Morton Grove Pharmaceuticals Inc and Wockhardt USA LLC, both incorporated in Delaware which are wholly owned subsidiaries of Wockhardt Bio AG. This decision, effective July 11, 2025, enables a clean and structured exit from a legacy segment and unlocks management bandwidth and capital for high-impact areas, the company said.

Wockhardt is undertaking significant strategic realignment of its US business in line with its long-term vision to build a differentiated, innovation-driven pharmaceutical enterprise, it said.

This strategic reset aligns with Wockhardt's sharpened focus on building a future-ready business anchored in two key pillars: New antibiotic drug discovery - where

# IPO boom: 162 companies eye Rs 2.4 lakh crore in record fundraising drive

Mumbai (Agency): Driven Electronics India — a fully strong by economic fundamentals and rising interest from retail investors, India's IPO market is heading for a busy second half of 2025. Nearly 162 companiesincluding big names like LG Electronics and Tata Capital Ltd—are preparing to hit the crore through public offerings. Experts say this fundraising spree is unlike anything the capital market has seen before and comes at a time when stock markets have stabilised and geopolitical tensions in the Middle East have eased. As of the end of June 2025, 71 companies had secured approval from the Securities and Exchange Board of India (SEBI) to launch their IPOs, with plans to collectively raise around Rs 1.14 lakh crore, according to data from Prime Database. Among them, LG

owned subsidiary of South Korea's LG Electronics and a key player in home appliances and consumer electronics — is eyeing a Rs 15,000 crore offering. Several companies are lining up for IPOs as India's primary market continues its strong markets, collectively aiming momentum. # EDITORIAL **Cockpit Confusion**

The tragedy of Air India flight 171 has, in its aftermath, thrown up far more questions than answers. In an era of rigorous aviation standards, redundant systems, and near-flawless fail-safes, how a modern aircraft like the Boeing 787-8 could crash within seconds of take-off ~ in clear weather and with no warning from the crew ~ demands urgent clarity. What makes this disaster chilling is the apparent cause unearthed in the preliminary probe: both fuel control switches were in the "cutoff" position, a setting meant to shut down engines after landing. Their simultaneous de-activation shortly after lift-off led to an immediate loss of thrust and triggered the aircraft's descent into an Ahmedabad medical students' canteen. While the switches were returned to the "run" position and engine relight procedures automatically initiated, the aircraft had neither the time nor the altitude to recover. These switches are not vulner-



able to casual or accidental engagement. They are protected by physical locks and guard brackets. It would require deliberate ~ and most likely coordinated ~ movement to deactivate both. The cockpit voice recorder captures

one pilot asking the other why the cut-off was initiated. The response: a denial. But in the absence of speaker identification, the statement only deepens the ambiguity. Was it human error? Sabotage? Systemic failure? None of these possibilities can yet be ruled out. Investigators are not suggesting foul play, but they are clearly unnerved by the implication that someone in the cockpit may have, however improbable that may seem in light of the time available, manually initiated the cut-off. That possibility alone ~ if confirmed ~ would shift the investigati - on from mechanical to psychological territory. In this case, silence is not just an absence of data ~ it is the loudest clue we have. But this finding should not become the red herring that diverts attention from the possibility of equipment malfunction.

The fact that the cockpit voice recorder still lacks voice attribution points to a deeper gap in post-crash protocols. In high-stakes scenarios, swift and confident identification of speakers should be standard. Without it, critical seconds of decision-making remain anonymous, stalling accountability and hindering systemic reforms that could prevent future tragedies. To complicate matters, an advisory issued some years ago by a major aviation regulator had flagged potential inconsistencies in similar fuel switch installations. The aircraft model involved in this crash shares that switch design. Yet, because the advisory was not classified as a mandatory directive, the recommended inspections were never carried out. Mechanical failure has not been confirmed, but it also hasn't been ruled out. Neither fuel contamination nor engine design flaws have been substantiated. The Ram Air Turbine deployment confirms total engine loss, but not its cause. Without cockpit video footage a long-standing demand from some investigators ~ determining who did what remains speculative. This tragedy demands two immediate responses: the global standardisation of cockpit video recordings and a thorough re-examination of safetycritical components, however minor they may seem. Families deserve answers, not ambiguities. And in aviation, silence even in a few unaccounted-for seconds ~ can be fatal.

hat was witnessed in Srinagar on Monday is very surprising. Jammu and Kashmir Chief Minister Omar Abdullah was first put under house arrest for celebrating Martyrs' Day. Even after this, when he forcibly left his house to celebrate Martyrs' Day, the security personnel tried to stop him. He did not listen and wanted to go to the graveyard with the ministers and read the Fateha in the name of the martyrs who died in 1931. He was stopped on the way. The security personnel manhandled the Chief Minister. Even after this, he did not stop, he left for the graveyard on a scooter. He was again stopped on the way. Walking about 1 km, he reached the Naqshband Sahib graveyard. The door of the graveyard was closed, security personnel were standing there. He jumped over the wall and entered the graveyard. There he read the Fateha in the memory of the martyrs. After that he came out. Chief Minister Omar Abdullah posted photos and videos of the treatment meted out to him on social media. The Chief Minister has alleged that it was completely wrong for the Lieutenant Governor Manoj Sinha to stop the celebration of Shaheedi Diwas. For the last several decades, people used to go to read Fateha on Shaheed Diwas. It is our right to read Fateha in the memory of the deceased elders and martyrs. I am an elected Chief Minister. The way the Chief Minister and ministers were manhandled by the security personnel in my own state on the orders of the Lieutenant Governor, it seems that we are not independent. I am the elected Chief Minister of a slave state. The power of Jammu and Kashmir is in the hands of the Central Government and the Lieutenant Governor.

The attempted assassination of Donald Trump at a campaign rally in Pennsylvania's Butler County on 13 July 2024 was one of the most jarring events in modern American politics. Twelve months later, Americans are being asked to accept a conclusion that many find unsatisfying: that the shooter, a young man named Thomas Crooks, acted entirely alone and without political or ideological motive. The FBI, after exhaustive investigations, found no credible links to



any domestic or foreign conspiracy, including early suspicions that Iran may have been involved. According to the official narrative, this was not an act of terrorism, nor even a partisan hit ~ just a personal act of violence by a troubled individual. But the public's reaction tells a different story. Scepticism has bloomed across the ideological spectrum. In online com-

ment sections and private conversations alike, questions swirl ~ not only about the assailant's motives but about the integrity of the investigation itself. Was Crooks a pawn? Were there warnings missed or downplayed? Could there have been political considerations in shaping the story? It would be naive to expect a crime of this magnitude to be free of conspiracy theories.

They follow political violence as reliably as candlelight follows a vigil. But the official narrative ~ suggesting that an isolated, ideology-free individual targeted one of the most polarising figures in modern American history ~ strains credulity. Not because it's impossible, but because it's unanchored from any plausible human context. Who was Thomas Crooks, really? Why Mr Trump, and why then? The longer such suspicions are left unanswered, the easier it becomes for lies to harden into "alternate truths." And in an election season, that erosion of trust could prove more damaging than bullets ever could. What's worse is that the vacuum of credible answers is being filled not just by extremists but by average citizens. Comment sections and social media are flooded with speculation: Was it a false flag? A botched warning? A story half-told for reasons of national security? In democracies, such speculation grows when people feel that truth is being rationed. This is not just about Mr Trump. It is ab - out how fragile democratic cohesion has become. For decades, Americans trusted that even in moments of crisis, a baseline of transparency and professionalism would prevail. That is no longer the case. When facts emerge slowly or feel incomplete, people rush to fill in the blanks themselves ~ and often, destructively. If the lone-wolf theory is true, then it must be reinforced by greater clarity, not mere assertion. If there are classified angles, the public must be told why those secrets exist. In either case, democracy demands more than reassurance. It demands proof without which the assassination bid remains an unsolved riddle.

Uncertainty in **Indian football** 'scares' players, clubs caught in limbo

New Delhi (Agency): When the news first broke that the pre-season training was delayed by a fortnight, Sunil Chhetri 'smiled'. It meant he got more time 'to get in shape' after a lengthy vacation. "That 'fortnight' has now changed to 'indefinitely' and that smile's been wiped out," the Bengaluru FC talisman shared. And now, he is 'very concerned' about the 'current situation in Indian football'. The 'situation' Chhetri referred to in his lengthy social media post was about the Indian Super League (ISL).

The future top flight of the men's game – and the centrepiece of the Indian football season - is up in the air after the upcoming season was put 'on hold' due to a dispute over an agreement between the All India Football Federation (AIFF) and the Football Sport Development Limited, the joint venture that runs the ISL Chhetri admitted that 'everybody is scared'. "I've received a flurry of texts from players, staff members, physios, masseurs - not just from my club, but from other clubs as well. Everybody in the Indian football ecosystem is worried, hurt, scared about the uncertainty we are faced with," he wrote. Indeed, at a time when clubs would have been finalising their player signings and coach appointments and the fans would wait in anticipation for the league schedule, the common phrases whistling about in the pre-season debates are courtroom jargon like "verdict" and "order". "The deeper we go in the decade, the greater the risk without considering more dramatic measures, such as playing in the winter months and/or cooler latitudes," said Prof. Piers Forster, director of the Priestley Centre for Climate Futures in Leeds, England. "I'm getting increasingly worried that we are only one heatwave away from a sporting tragedy and I would like to see governing bodies lean into the climate and health science."

Tournament soccer in June and July is a tradition going back to the first World Cup in 1930.

Since then, the three-month period of June, July and August globally has warmed by 1.05 degrees Celsius (1.89 degrees Fahrenheit), according to the U.S. National Oceanic and Atmospheric Administration. Meanwhile, European summer temperatures have increased by 1.81 degrees C. The rate of warming has accelerated since the 1990's.

next year. Extreme heat could become an even bigger challenge at the following World Cup in 2030, which will be cohosted by Spain, Portugal and Morocco. Games are scheduled to be played in afternoons and early evenings from mid-June to mid-July. All three countries have already seen temperatures rise above 40 degrees C (well above 100 Fahrenheit) this summer.

FIFA downplayed the heat risk in its in-house evaluation of the 2030 World Cup bid, saying "weather conditions are difficult to predict with the current development in global and local climate, but are unlikely to affect the health of players or other participants."

The physical effects of playing 90 minutes of soccer in direct sunshine during the hottest part of the day can be severe and potentially result in hyperthermia - abnormally high body temperatures.

"When players experience hyperthermia, they also experience an increase in cardiovascular strain," said Julien Périard of the University of Canberra

"If core temperature increases excessively, exertional heat illness can occur," leading to muscle cramping, heat exhaustion, and even life-threatening heat stroke, he said. Many sports events held in the summer adjust their start times to early morning or late night to minimize the risk heat-related illness, including marathons at the Olympics or track world championships. Morning kickoffs, however, are rare in soccer, where World Cup match schedules are often set with European TV audiences in mind.

It would be hard for FIFA to avoid day-time World Cup kickoffs given the packed match schedule as the number of participating teams increases from 32 to 48 in 2026. Heat mainly becomes an issue when the World Cup is held in the Northern

Hemisphere, because June and July are winter months in the Southern Hemisphere.

FIFA has stuck to its traditional June-July schedule for the men's World Cup except in 2022 when it moved the tournament to November-December to avoid the summer heat in Qatar. Something similar is expected when neighboring Saudi Arabia hosts the tournament in 2034.

# With Epstein conspiracy theories, Trump faces a crisis of his own making

NEW YORK (Agency): As his supporters erupt over the Justice Department's failure to release much-hyped records in Jeffrey Epstein's sex trafficking investigation, US President Donald Trump's strategy has been to downplay the issue. "I don't understand what the interest or what the fascination is," he told reporters Tuesday. His problem? That nothing-tosee-here approach doesn't work for those who've learned from him they must not give up until the government's deepest, darkest secrets are exposed.

Last week, the Justice Department and the FBI abruptly walked back the notion there's an Epstein client list of elites who participated in the wealthy New York financier's trafficking of underage girls. Trump quickly defended Attorney General Pam Bondi and chided a reporter for daring to ask about the documents. The online reaction was swift, with followers calling the Republican president "out of touch" and demanding transparency.

Trump's comments to reporters Tuesday while returning to Washington from a brief Pittsburgh trip were just the latest in a days-long campaign to quell the uproar. He called the Epstein case "pretty boring" and said "the credible information has been given."

"I don't understand why the Jeffrey Epstein case would be of interest to anybody." he said. Over the weekend, Trump used

his Truth Social platform to attempt to call supporters off the Epstein trail amid reports of infighting between Bondi and FBI Deputy Director Dan Bongino over the issue.

He suggested the turmoil was undermining his administration -- "all over a guy who never dies, Jeffrey Epstein." That did little to mollify Trump's supporters, who

urged him to release the files or risk losing his base. The political crisis is especially

challenging for Trump because it's one of his own making. The president has spent years stoking dark theories and embracing QAnon-tinged propaganda that casts him as the only savior who can demolish the "deep state." Now that he's running the federal

government, the community he helped build is coming back to haunt him. It's demanding answers he either isn't able to or doesn't want to provide. Asked Tuesday whether Bondi

had told him his name was in the Epstein files, Trump said no. He praised her handling of the case and said she should release "whatever she thinks is credible.'

But he also claimed there were credibility issues with the documents, suggesting without citing evidence they were "made up" by former FBI Director

Presidents Barack Obama and Joe Biden, both Democrats. Bondi declined to discuss the

Far-right commentator Jack Posobiec said at Turning Point USA's Student Action Summit on Saturday he wouldn't rest "until we go full Jan. 6 committee on the Jeffrey Epstein files." Trump's weekend post called on supporters to focus on investigating Democrats and arresting criminals rather than "spending month after month looking at nothing but the same old, Radical Left inspired Documents on Jeffrey Epstein." His first-term national security adviser, retired Lt. Gen. Michael Flynn, pleaded with him to reconsider. "@realdonaldtrump please understand the EPSTEIN AFFAIR is not going away," Flynn wrote.

Other Trump allies continue to

push for answers, among them far-right activist Laura Loomer, who has called for Bondi to resign. She told Politico's Playbook newsletter on Sunday a special counsel should be appointed to investigate the handling of the files on Epstein, who was found dead in his federal jail cell in 2019 weeks after he was arrested.

House Speaker Mike Johnson told right-wing influencer Benny Johnson in an interview released Tuesday that he is "for transparency," and wants Bondi to "put everything out there and let the people decide."

He said the Justice Department needs to focus on crime and other priorities, including elections and investigating ActBlue, the Democrats' top fundraising platform.

# Pentagon ends deployment of 2,000 National Guard troops in Los Angeles

LOS ANGELES (Agency): The Pentagon said on Tuesday it is ending the deployment of 2,000 National Guard troops in Los Angeles, accounting for nearly half of the soldiers sent to the city to deal with protests over the Trump administration's immigration crackdown.

Roughly 4,000 National Guard soldiers and 700 Marines have been in the city since early June. It wasn't immediately clear what prompted the 60-day deployment to end suddenly, nor was it immediately clear how long the rest of the troops would stay in the region.

In late June, the top military commander in charge of

troops deployed to LA had asked Defense Secretary Pete Hegseth for 200 of them to be returned to wildfire fighting duty amid warnings from California Gov. Gavin Newsom that the Guard was understaffed as California entered peak wildfire season. The end of the deployment comes a week after federal authorities and National Guard troops arrived at MacArthur Park with guns

and horses in an operation that ended abruptly. Although the US

Alberta calls upon **Canadian federal** government to designate Lawrence Bishnoi gang as 'terrorist group'



CHANDIGARH (Agency): After British Columbia (BC), now Alberta is the second province in Canada that has called upon the Canadian federal government to designate the Lawrence Bishnoi gang as a terrorist group, as it is being accused of carrying out 'targeted killings' in the country.

In a joint statement issued on July 14, Alberta Premier Danielle Smith and Minister for Public Safety and Emergency Services Mike Ellis stated, "The Lawrence Bishnoi Gang is a transnational criminal network responsible for violence, extortion, drug trafficking and targeted killings, including here in Canada. Its reach is global, and its intent is criminal and violent."

"We stand with B.C. Premier David Eby and other officials across Canada in calling for immediate federal action. The federal government must use every tool available to dismantle this network and keep Canadians safe," they added.

"We know that gang activity knows no boundaries and respects no borders, and Alberta wants to send a clear message: you are not welcome here. Formally designating the Bishnoi Gang as a terrorist entity will

DAMASCUS (Agency): Clashes raged in the southern Syrian city of Sweida on Wednesday after a ceasefire between government forces and Druze armed groups collapsed and Israel threatened to escalate its involvement in support of the Druze religious minority. Syria's Defense Ministry blamed militias in Sweida for violating a ceasefire agreement that had been reached Tuesday, causing Syrian army soldiers to return fire and continue military operations in the Druze-majority province. "Military forces continue to respond to the source of fire inside the city of Sweida, while adhering to rules of engagement to protect residents, prevent harm, and ensure the safe return of those who left the city back to their homes." the statement said. A rebel offensive led by Islamist insurgent groups ousted Syria's longtime despotic leader, Bashar Assad, in December, bringing an end to a nearly 14year civil war. Since then, the country's new rulers have struggled to consolidate control over the territory. The primarily Sunni Muslim leaders have faced suspicion from religious and ethnic minorities.

The fears of minorities increased after clashes between government forces and pro-Assad armed groups in March spiraled into sectarian revenge attacks in which hundreds of civilians from the Alawite religious minority, to which Assad belongs, were killed. The latest escalation in Syria began with tit-for-tat kidnappings and attacks between local Sunni Bedouin tribes and Druze armed factions in the southern province, a center of the Druze community.

Government forces that intervened to

restore order have also clashed with the Druze, while reports have surfaced of members of the security forces carrying out extrajudicial killings, looting and burning civilian homes. No official casualty figures have been released since Monday, when the Syrian Interior Ministry said 30 people had been killed. The UK-based war monitor Syrian Observatory for Human Rights said more than 250 people had been killed as of Wednesday morning, including four children, five women and 138 soldiers and security forces. The observatory said at least 21 people were killed in "field executions." Israel has launched a series of airstrikes on convoys of government forces since the clashes erupted, saying that it is

acting to protect the Druze. The Druze religious sect began as a 10thcentury offshoot of Ismailism, a branch of Shiite Islam. More than half the roughly 1 million Druze worldwide live in Syria. Most of the other Druze live in Lebanon and Israel, including in the Golan Heights, which Israel captured from Syria in the 1967 Mideast War and annexed in 1981.

In Israel, the Druze are seen as a loval minority and often serve in the military. In Syria, the Druze have been divided over how to deal with the country's new leaders, with some advocating for integrating into the new system while others have remained suspicious of the authorities in Damascus and pushed for an autonomous Druze region. On Wednesday, Israeli Defense Minister Israel Katz said in a statement that the Israeli army "will continue to attack regime forces until they withdraw from the area — and will also soon raise the bar of responses against the regime if the message is not understood."

The attacks left one woman dead and wounded more than two dozen people across multiple regions, while a missile attack cut power and water in Ukrainian President Volodymyr Zelensky's home city of Kryvyi Rig, according to authorities.

The bombardment came two days after US President Trump threatened to impose severe sanctions against the country unless it reached a peace settlement within 50 days to end its three-year war on Ukraine.

Ukrainian and Russian officials last met for direct peace talks more than a month ago, and no further meetings have been scheduled despite the Kremlin saying it is open for more talks.

Russia fired at least 400 drones at Ukraine between

late Tuesday and early Wednesday, as well as an Iskander ballistic missile launched from the annexed Crimean peninsula, the Ukrainian air force said. Overnight drone attacks on

the central Ukrainian city of Vinnytsia left eight wounded, while three were wounded in an attack on the northeastern Ukrainian citv of Kharkiv, local authorities said. Russian attacks on the

city of Kryvyi Rig wounded at least 15 people, destroyed an industrial building and disrupted power and water supplies, according to local officials. A 17-year-old boy was among those injured, the city's mayor Oleksandr Vilkul said on Telegram. "He

was wounded in the abdominal cavity. He was immediately taken to the in serious hospital, condition. Now doctors are fighting for his life," Vilkul wrote.

Russia has stepped up its summer campaign against Ukraine in recent weeks as Washington-mediated ceasefire talks stall.

# **Drone attacks on oil fields in Iraq's Kurdish region shut down another facility**

BAGHDAD Drones targeted oil fields in Iraq's semi-autonomous northern Kurdish region on Wednesday, the latest in a series of attacks in recent days that have put several oil facilities out of commission. No group has claimed responsibility for the attacks, which have exacerbated tensions between the central government in Baghdad and Kurdish authorities.
